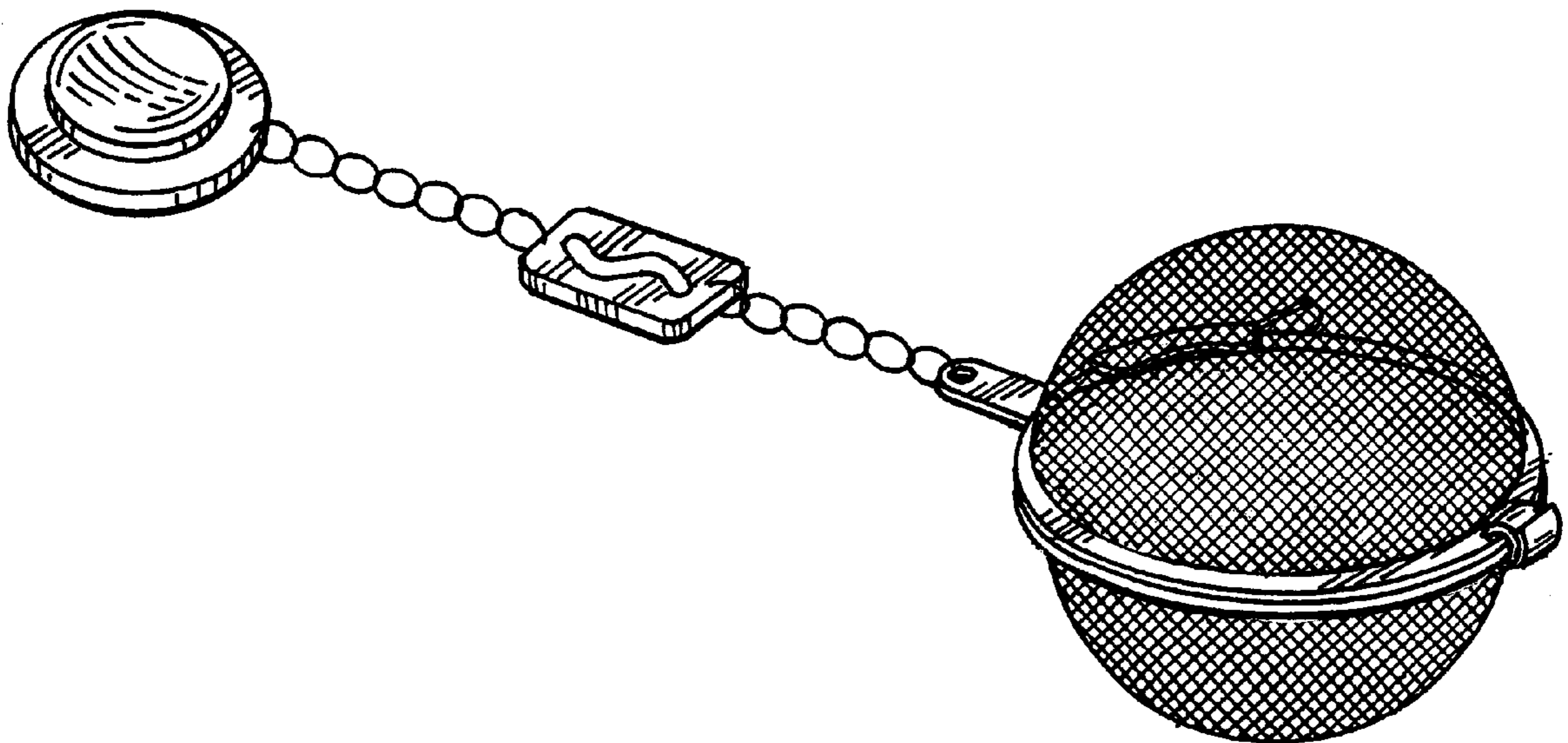
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the tea ball of the invention;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a side elevational view thereof, the opposite side
of which is an identical mirror image; and,

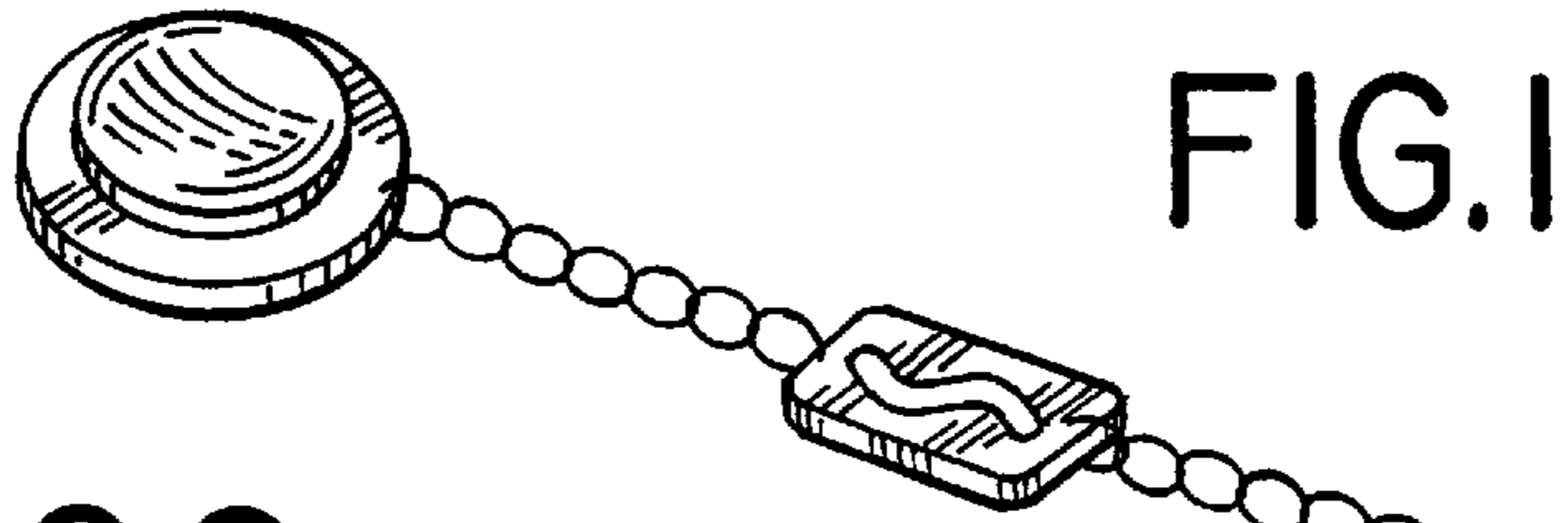

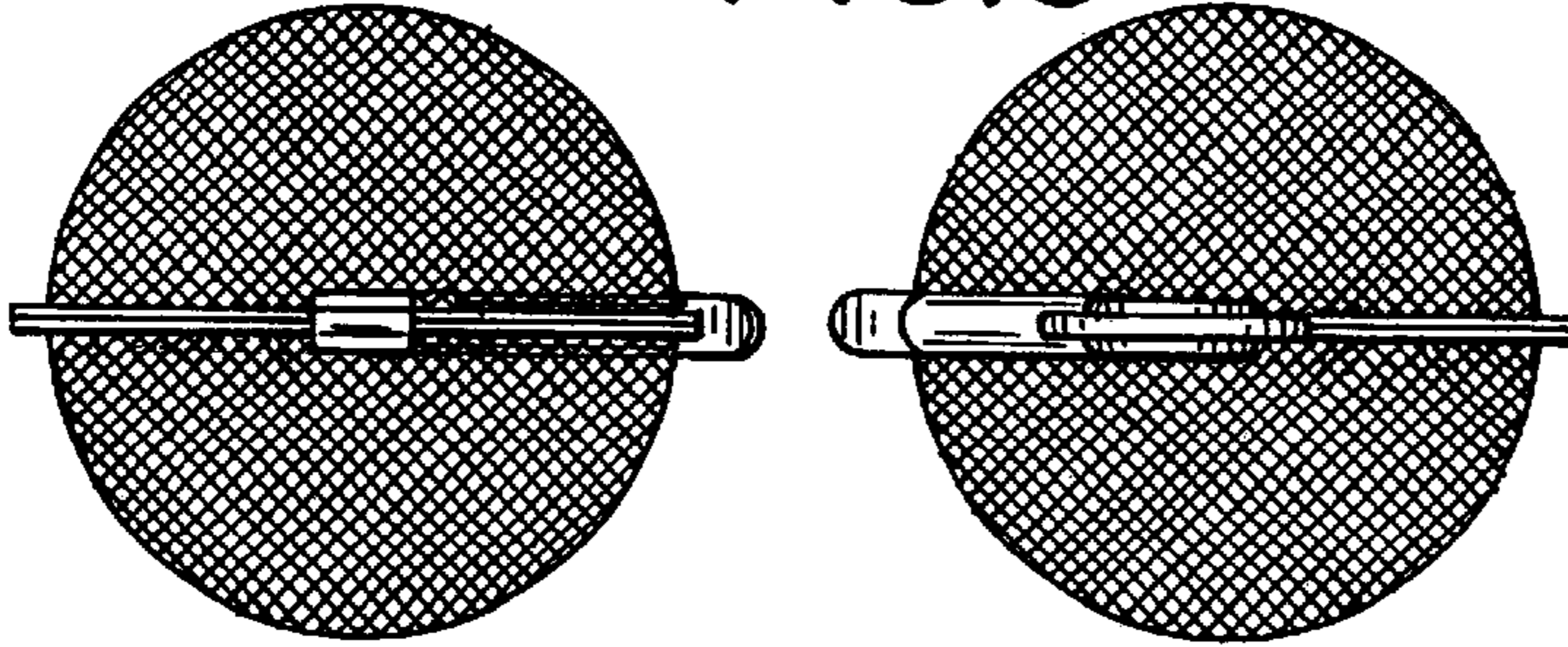

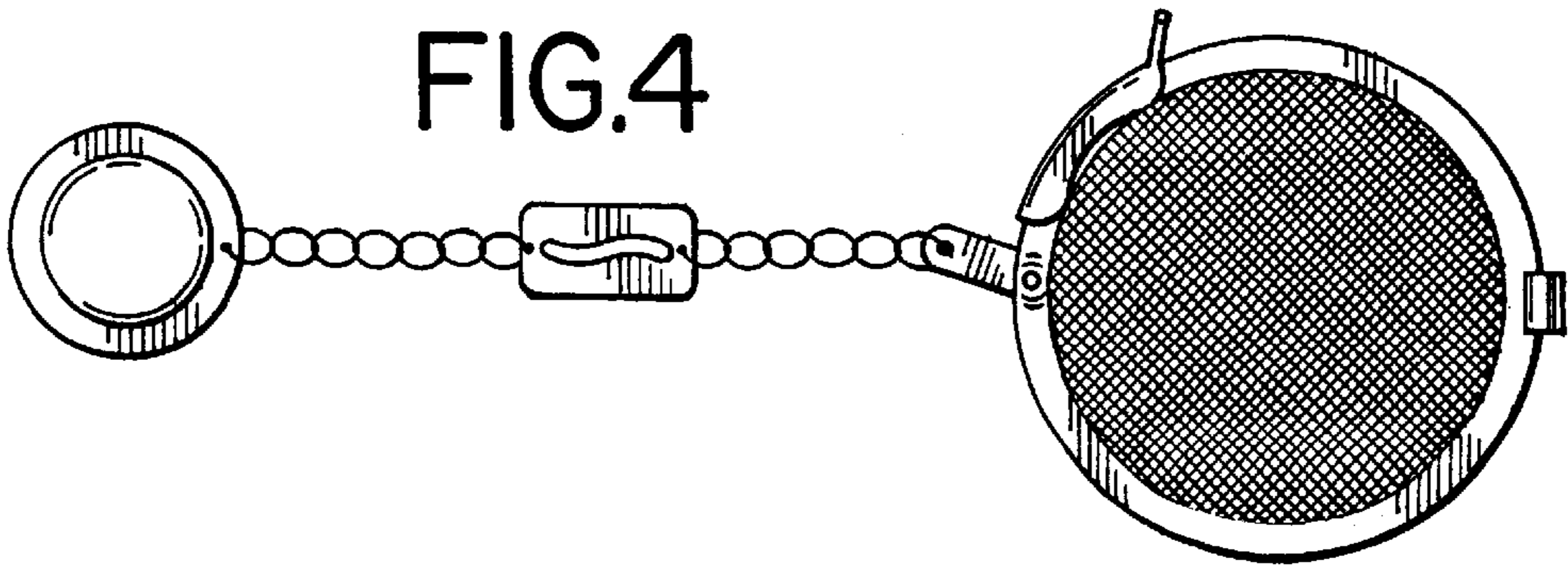

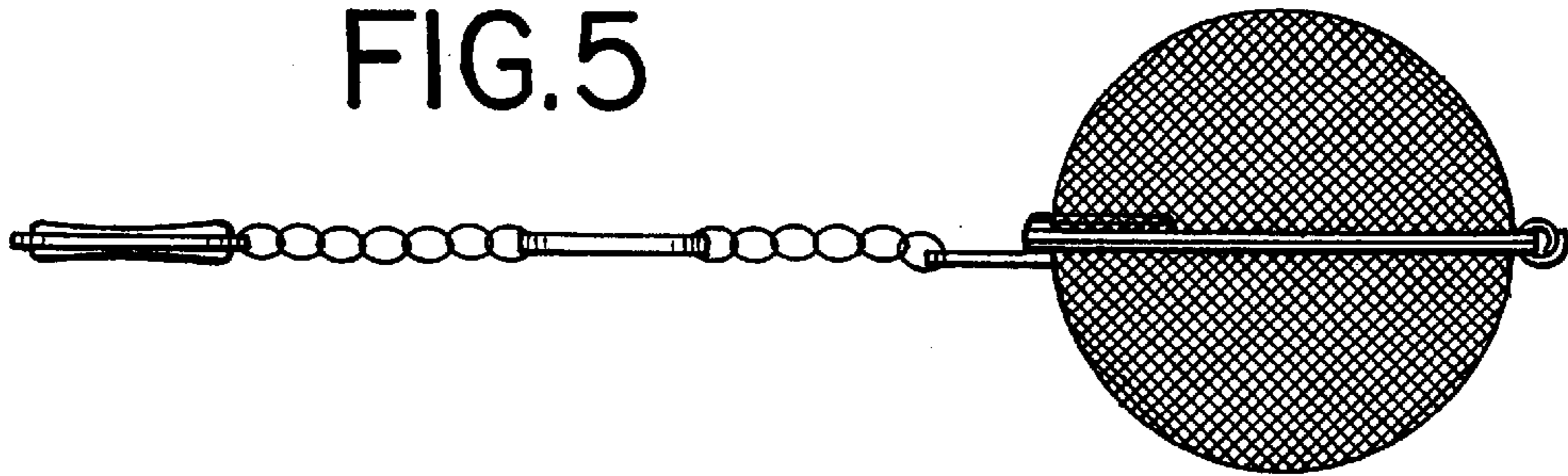
