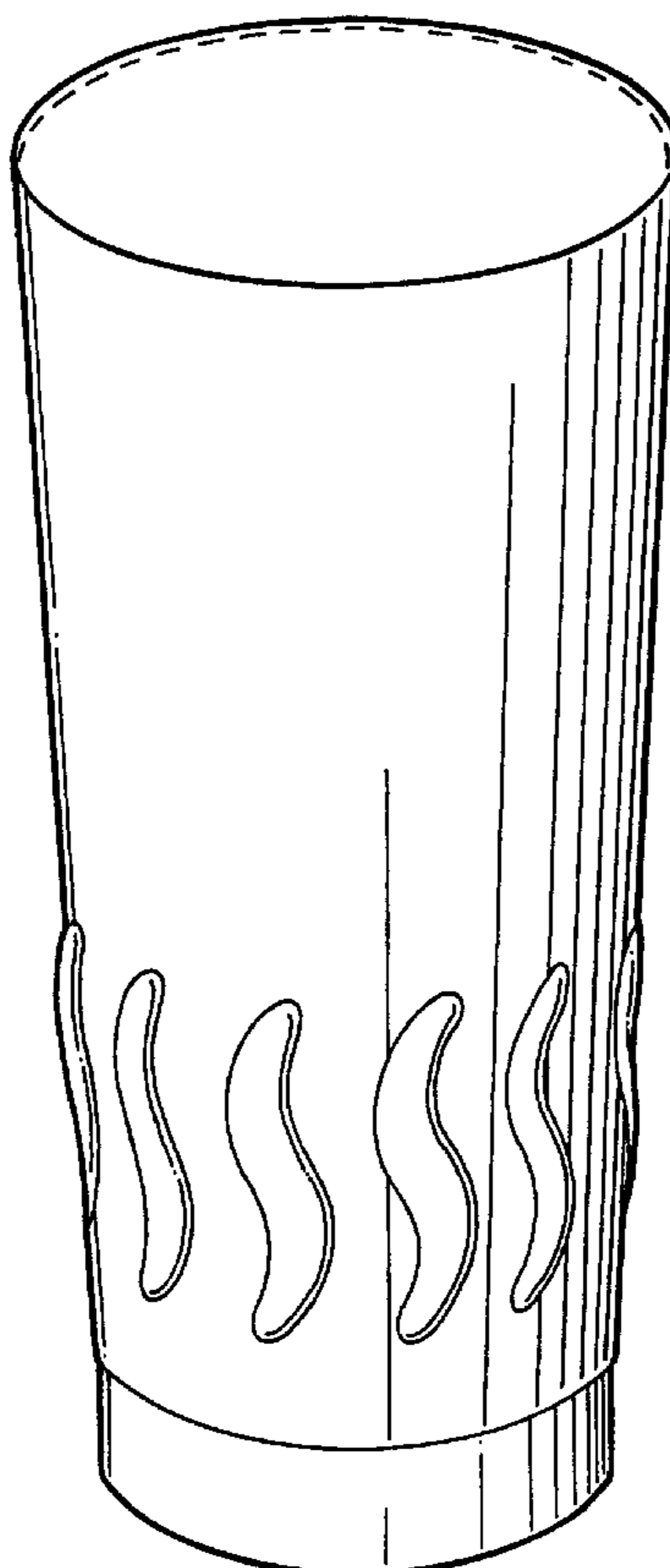
(57) **CLAIM**

I claim the ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a beverage container, showing my new design;
 FIG. 2 is a side view thereof;
 FIG. 3 is an enlarged top view thereof;
 FIG. 4 is an enlarged bottom view thereof;
 FIG. 5 is a top front perspective view showing a second embodiment of my new design;
 FIG. 6 is a side cross-sectional view thereof taken along line 6—6 of FIG. 7; and,
 FIG. 7 is an enlarged top view thereof.
 The broken lines in FIGS. 1, 3, and 5 are for illustrative purposes only and form no part of the claimed design.

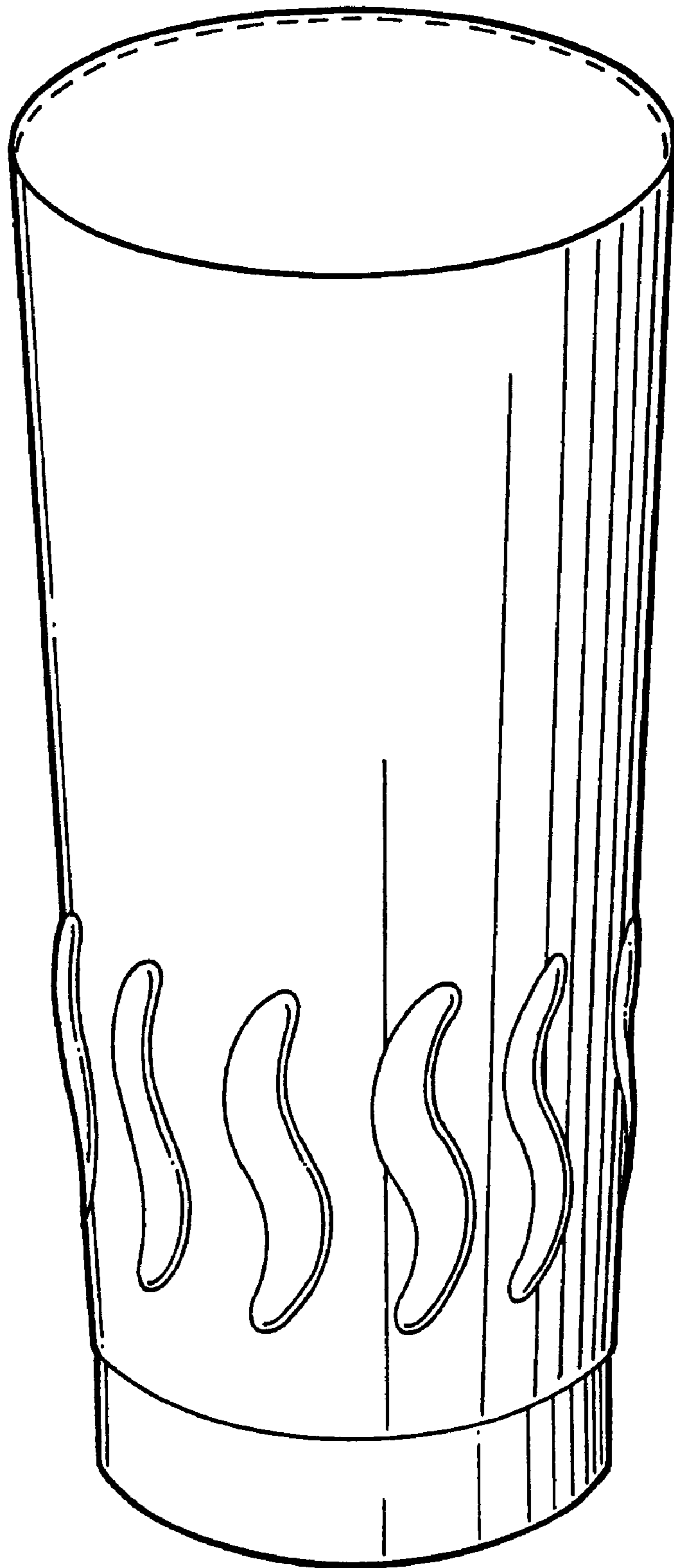

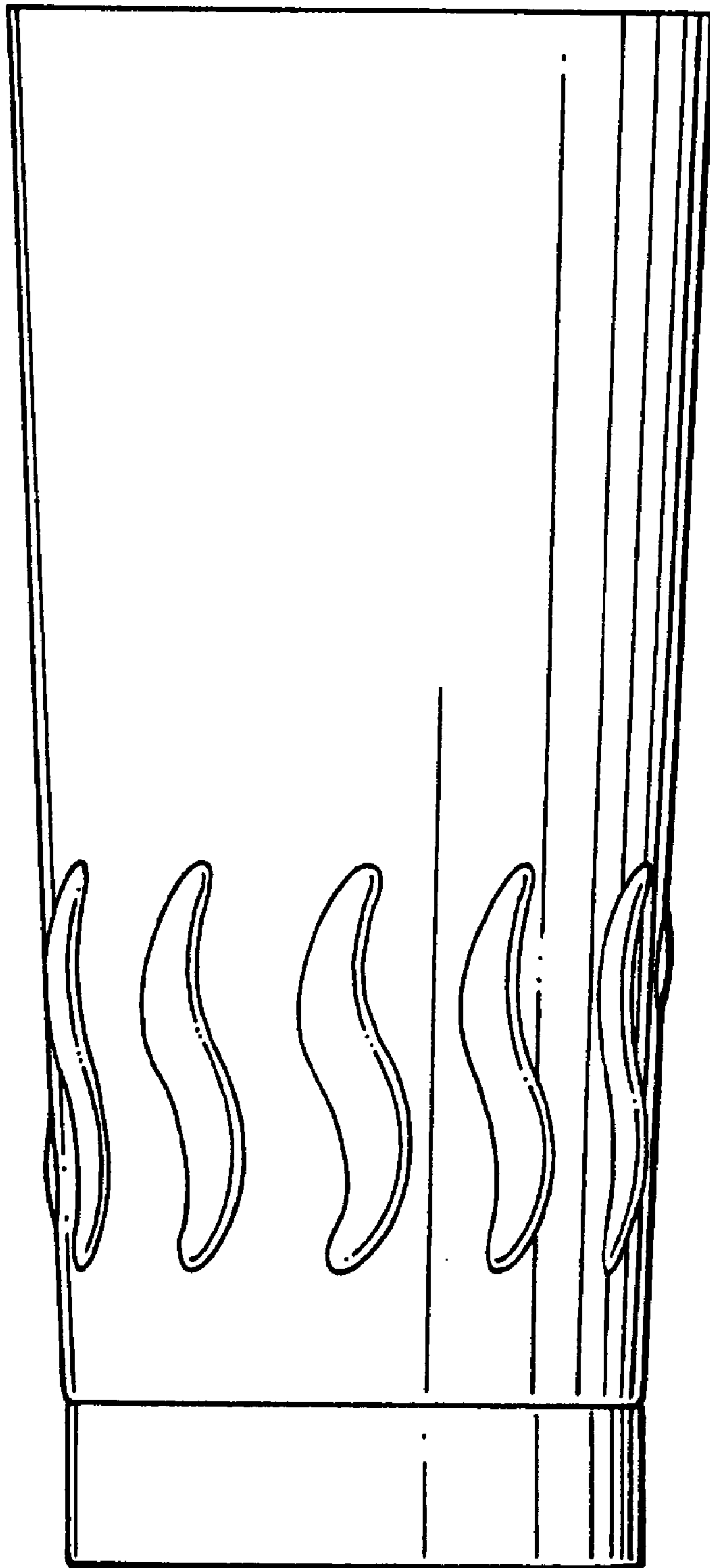

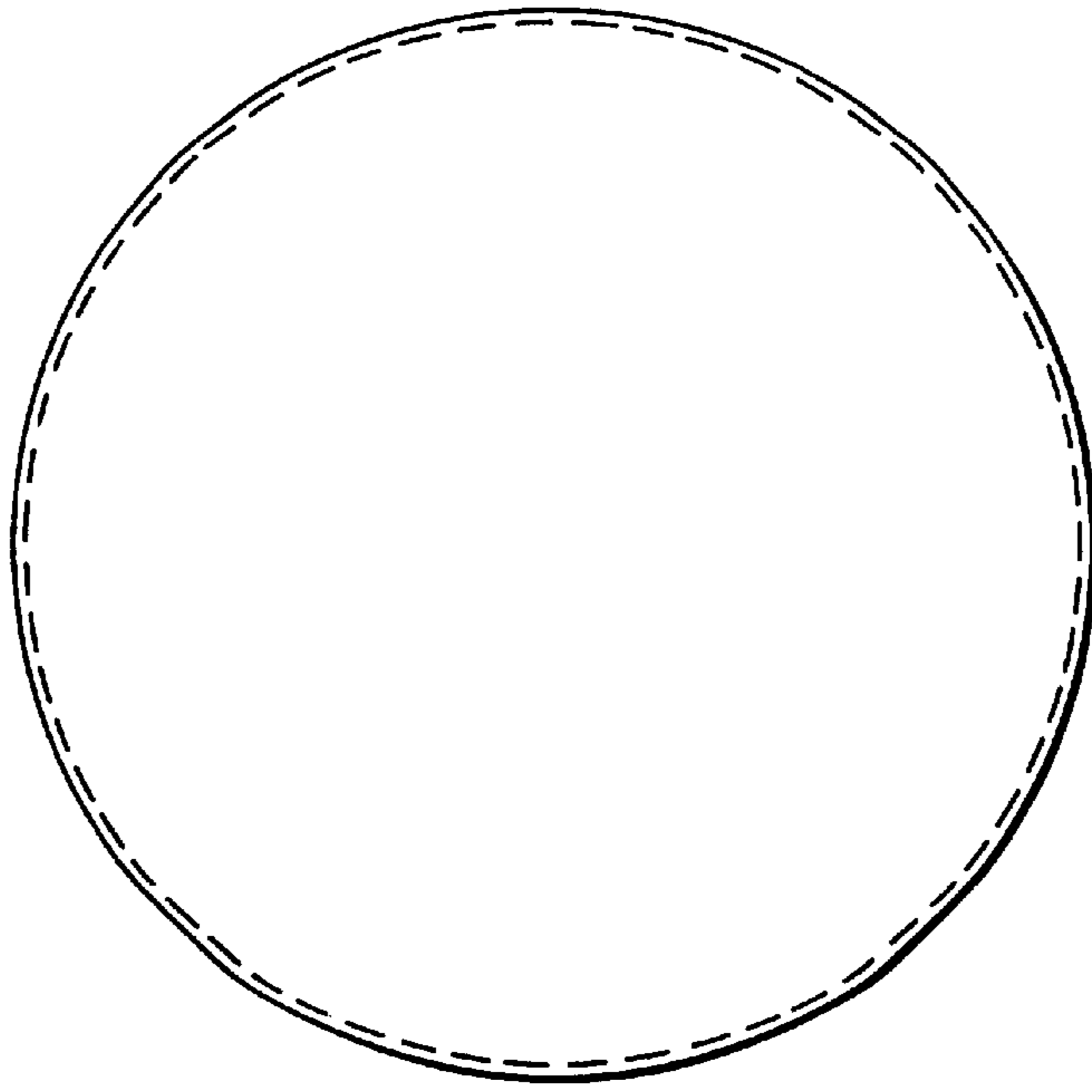

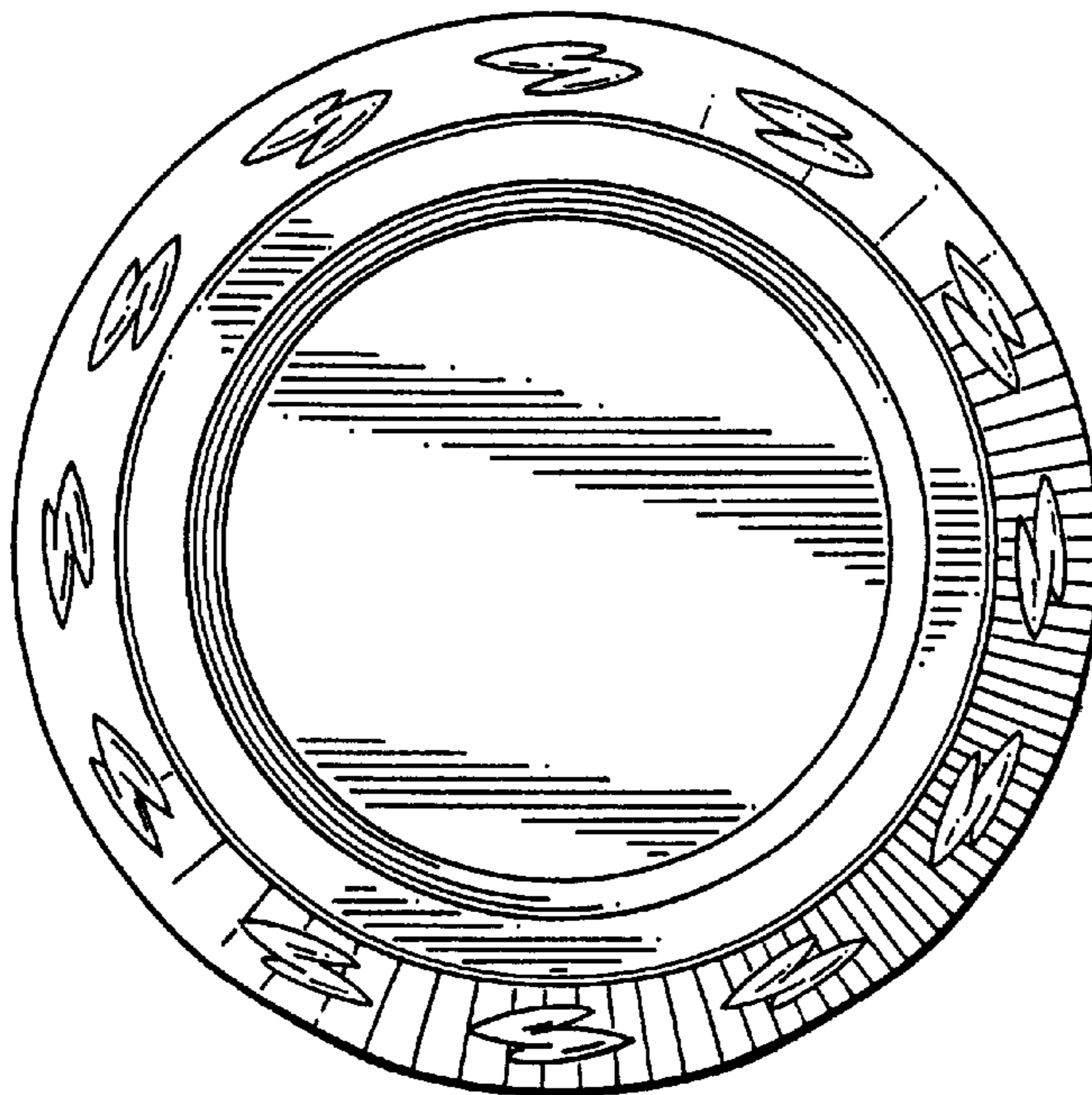

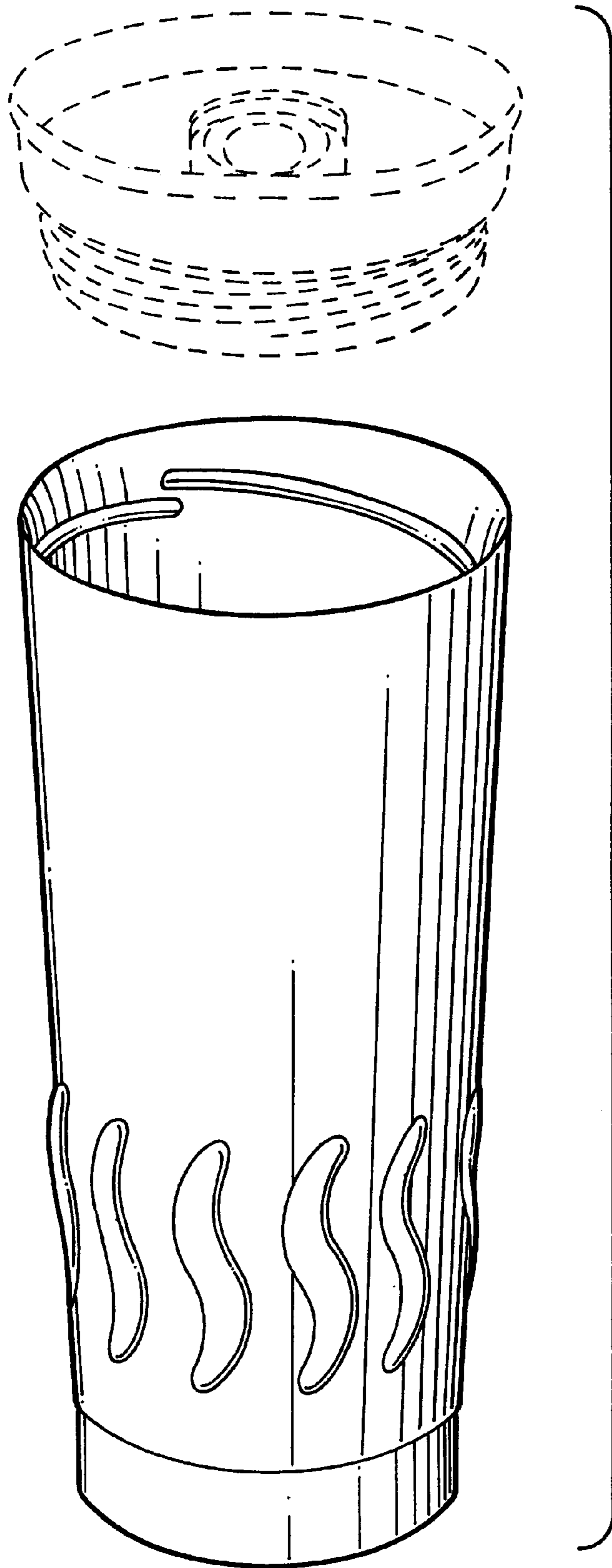

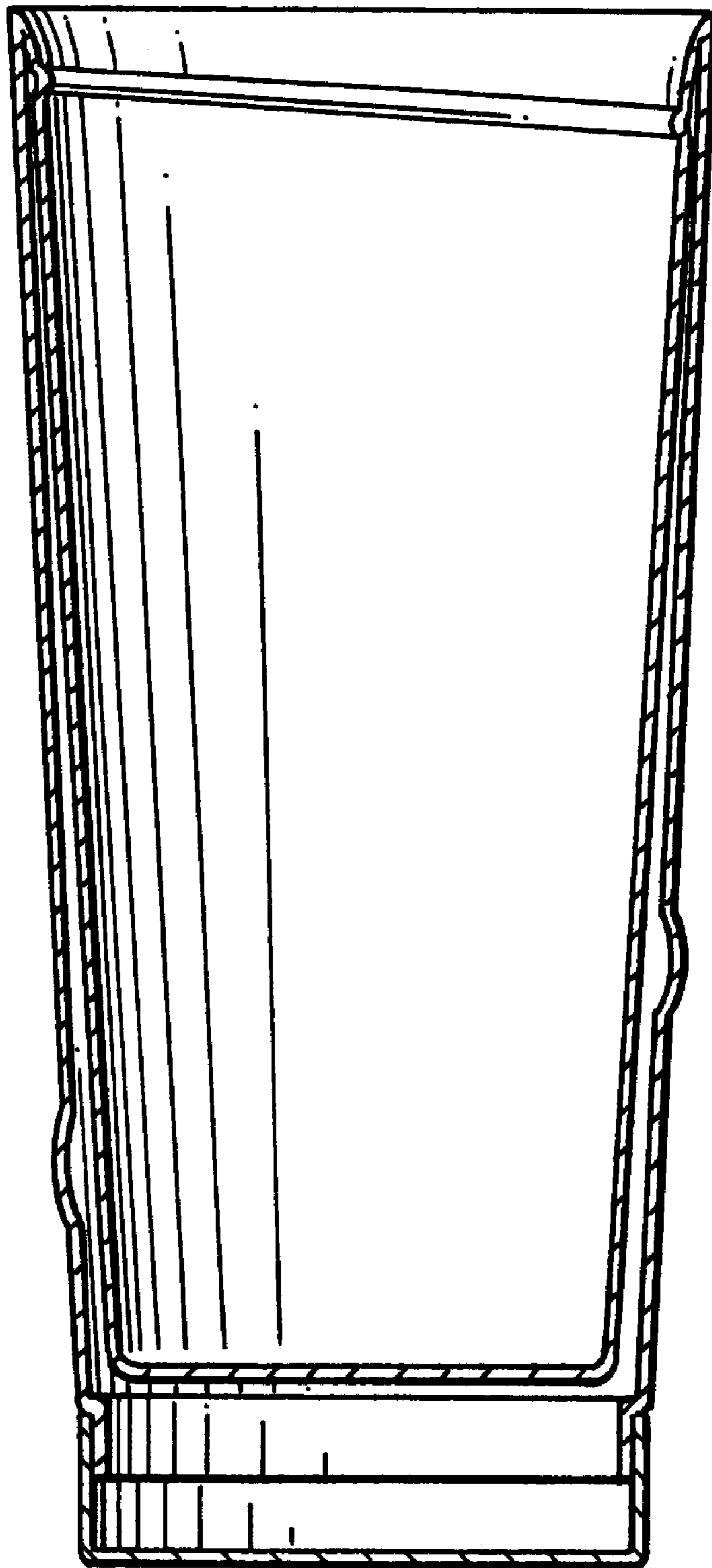

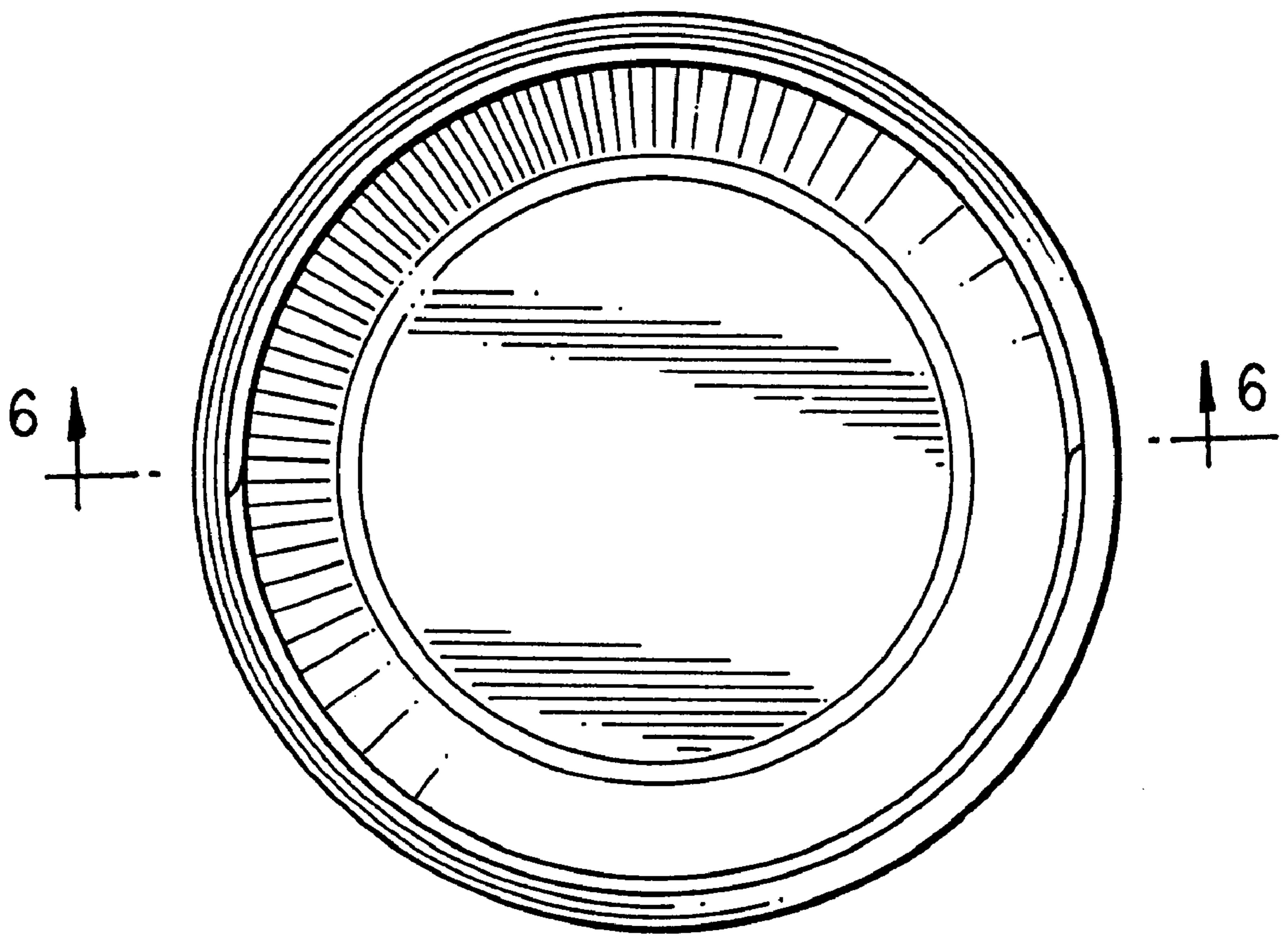
