The ornamental design for a ring with ornamental writing, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a ring with ornamental writing showing my new design;

FIG. 2 is a view of one side thereof;

FIG. 3 is a view of the opposite side thereof;

FIG. 4 is a top view thereof, the bottom view being identical;

FIG. 5 is a perspective view of a second embodiment of FIG. 1; and,

FIG. 6 is a perspective view of a third embodiment of FIG. 1.

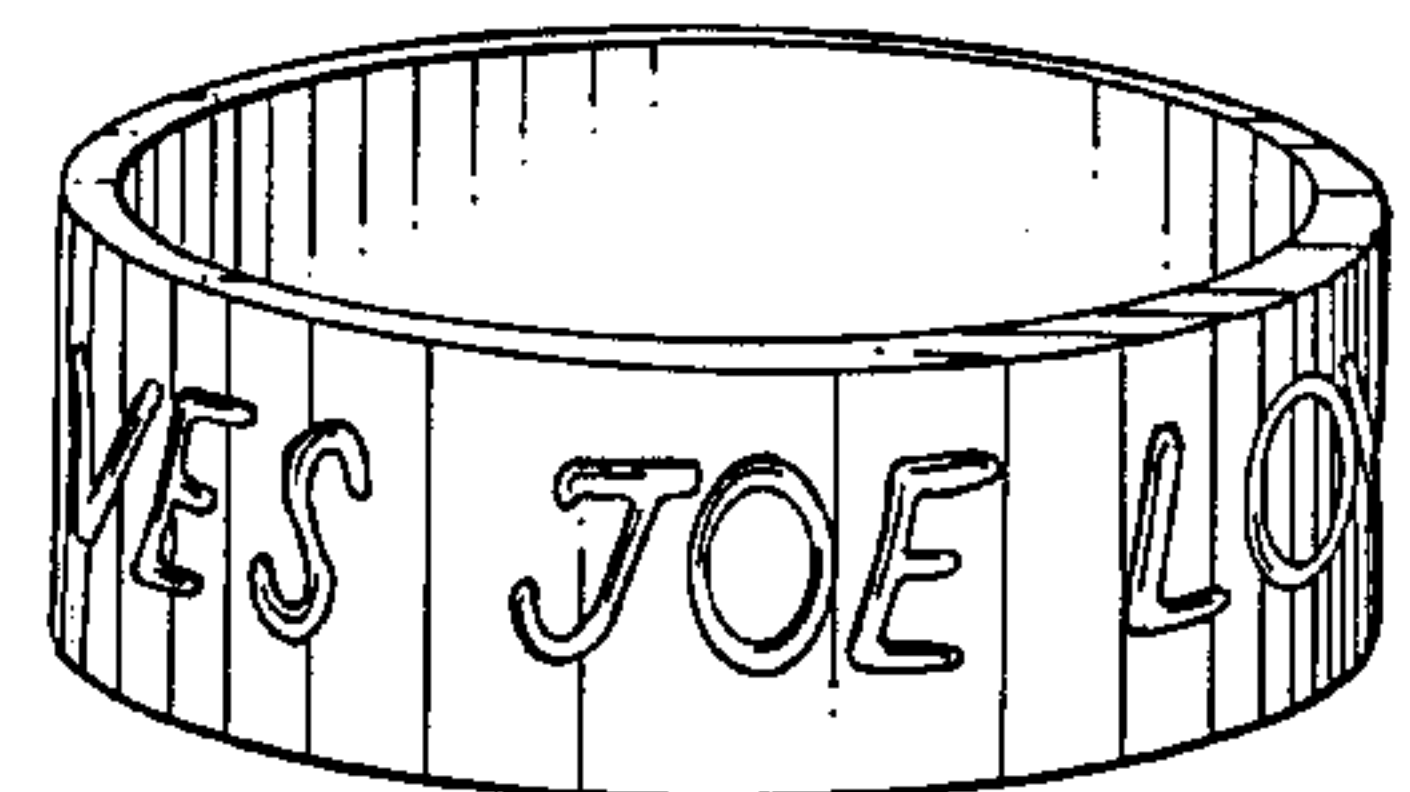
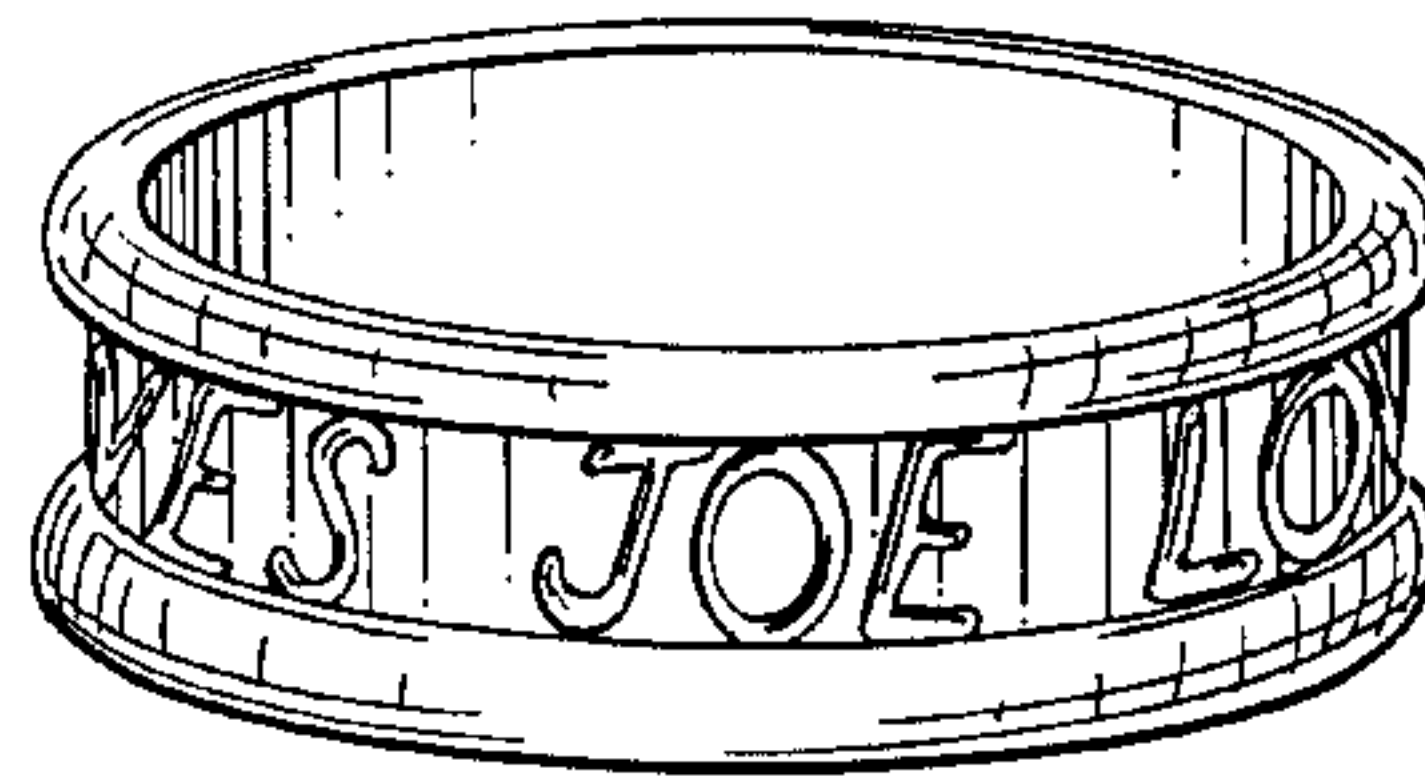
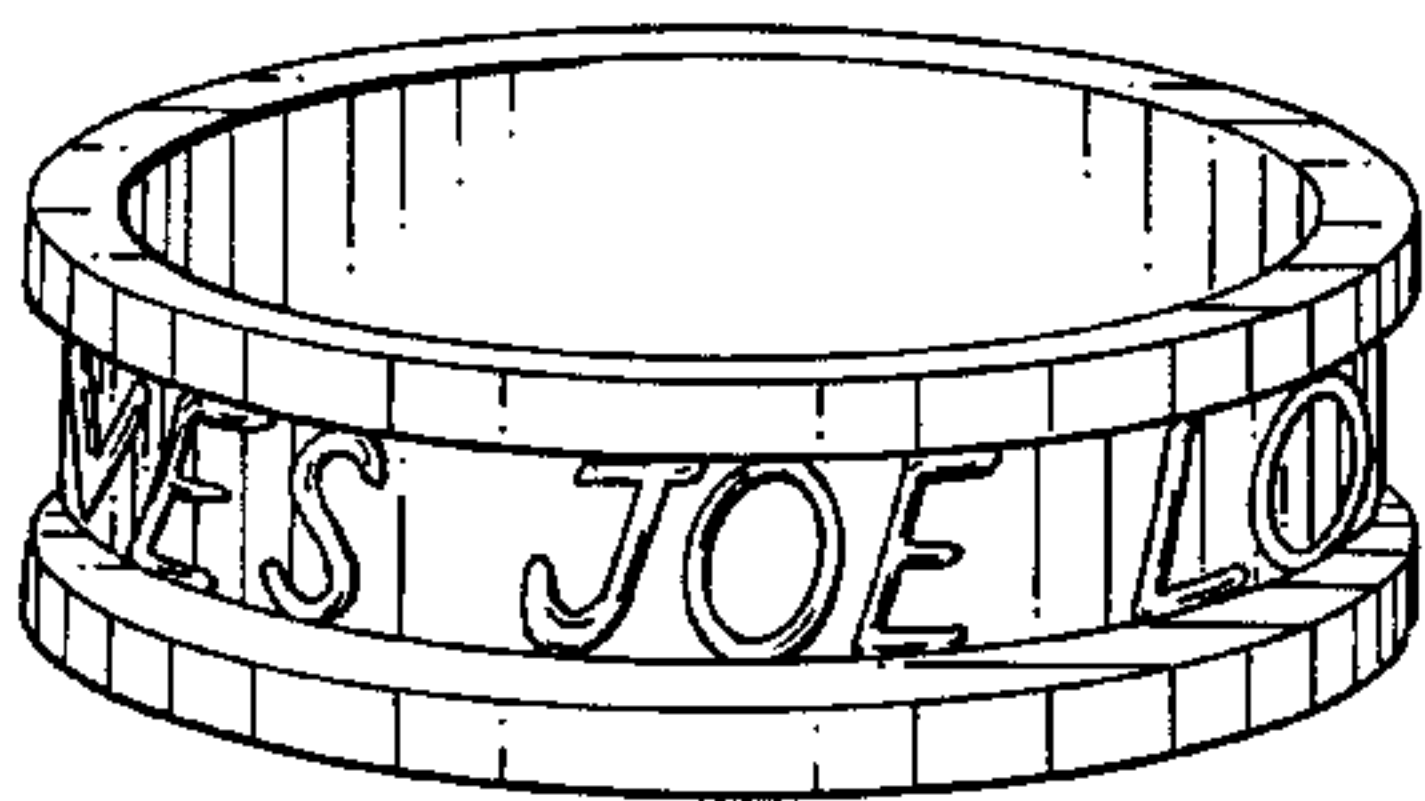

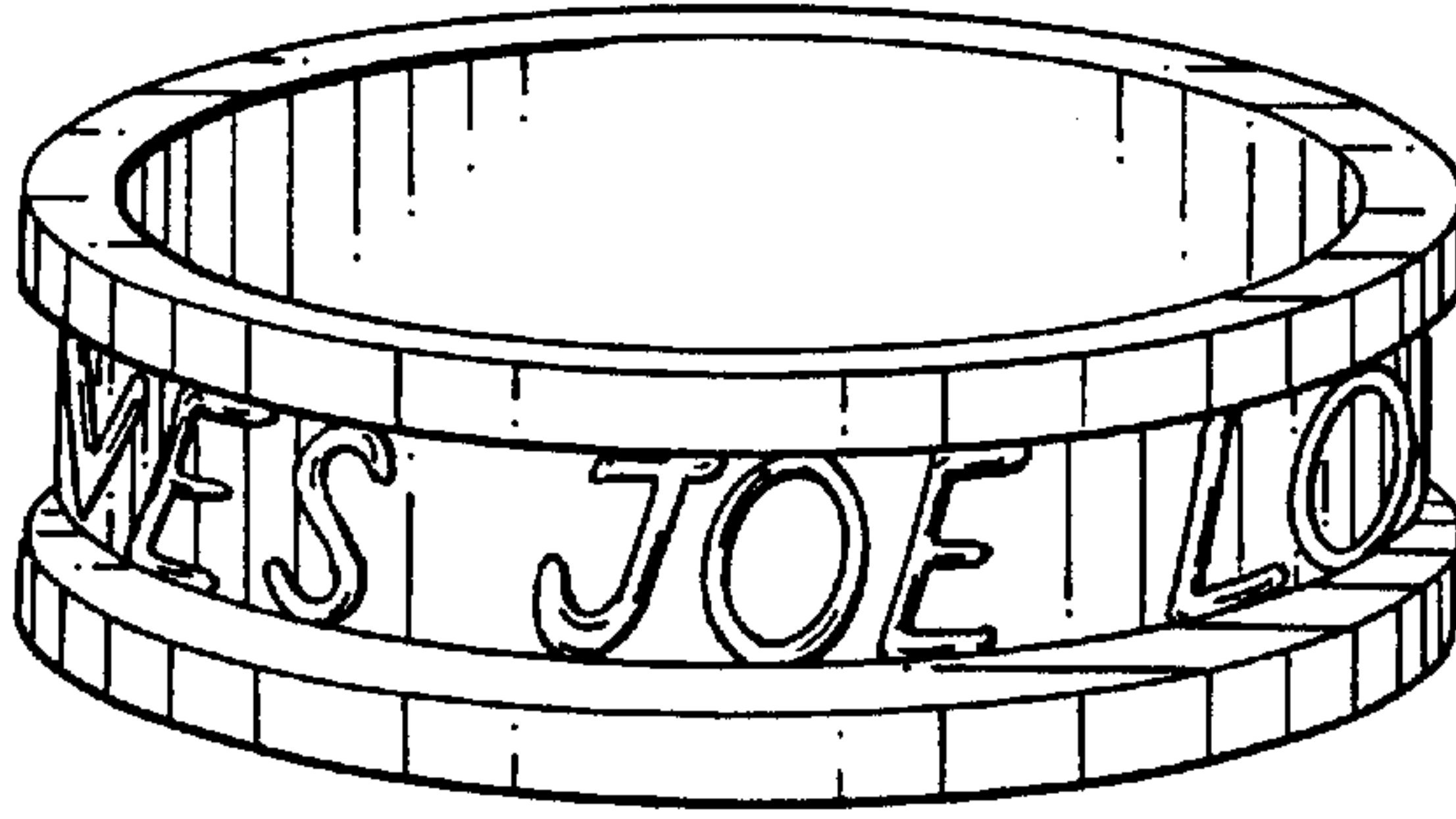

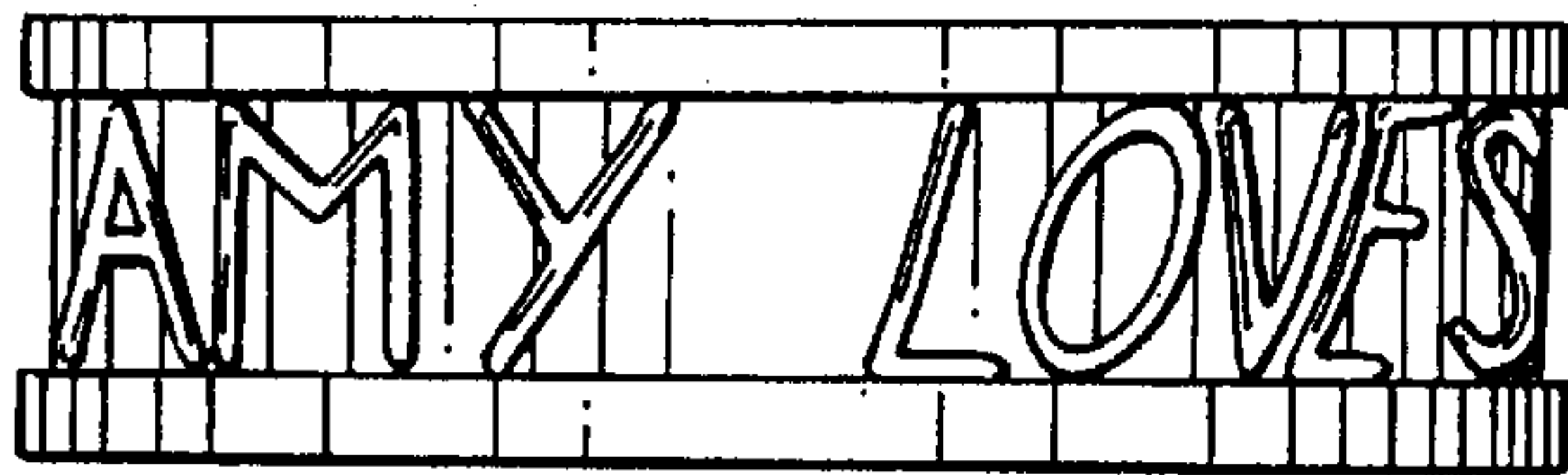

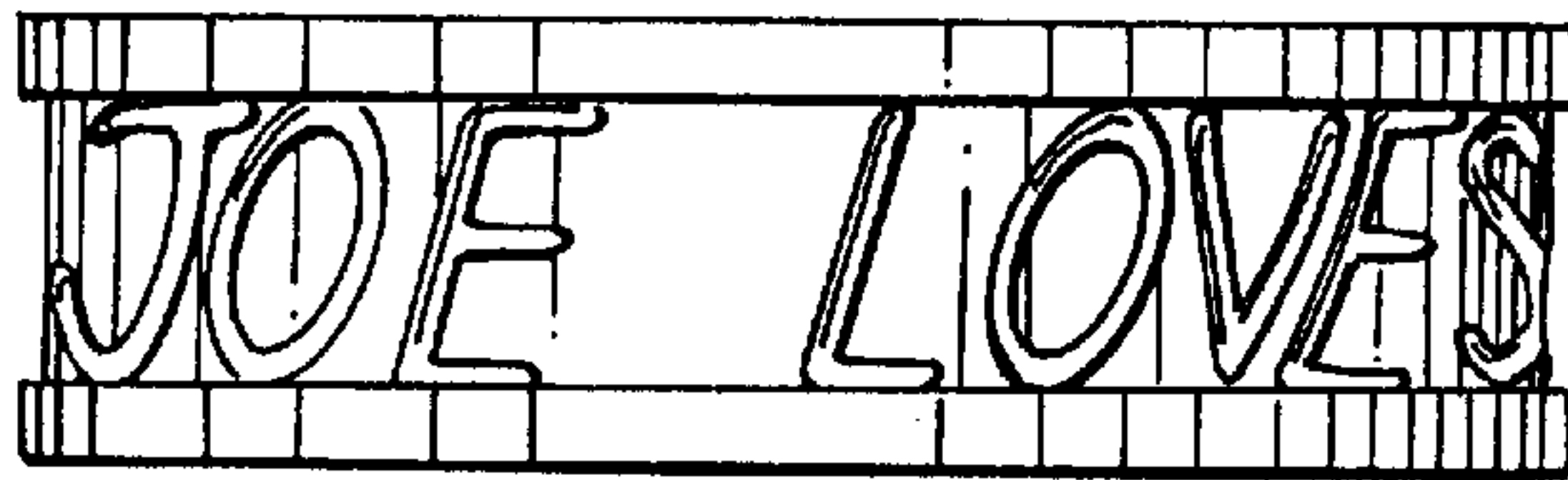
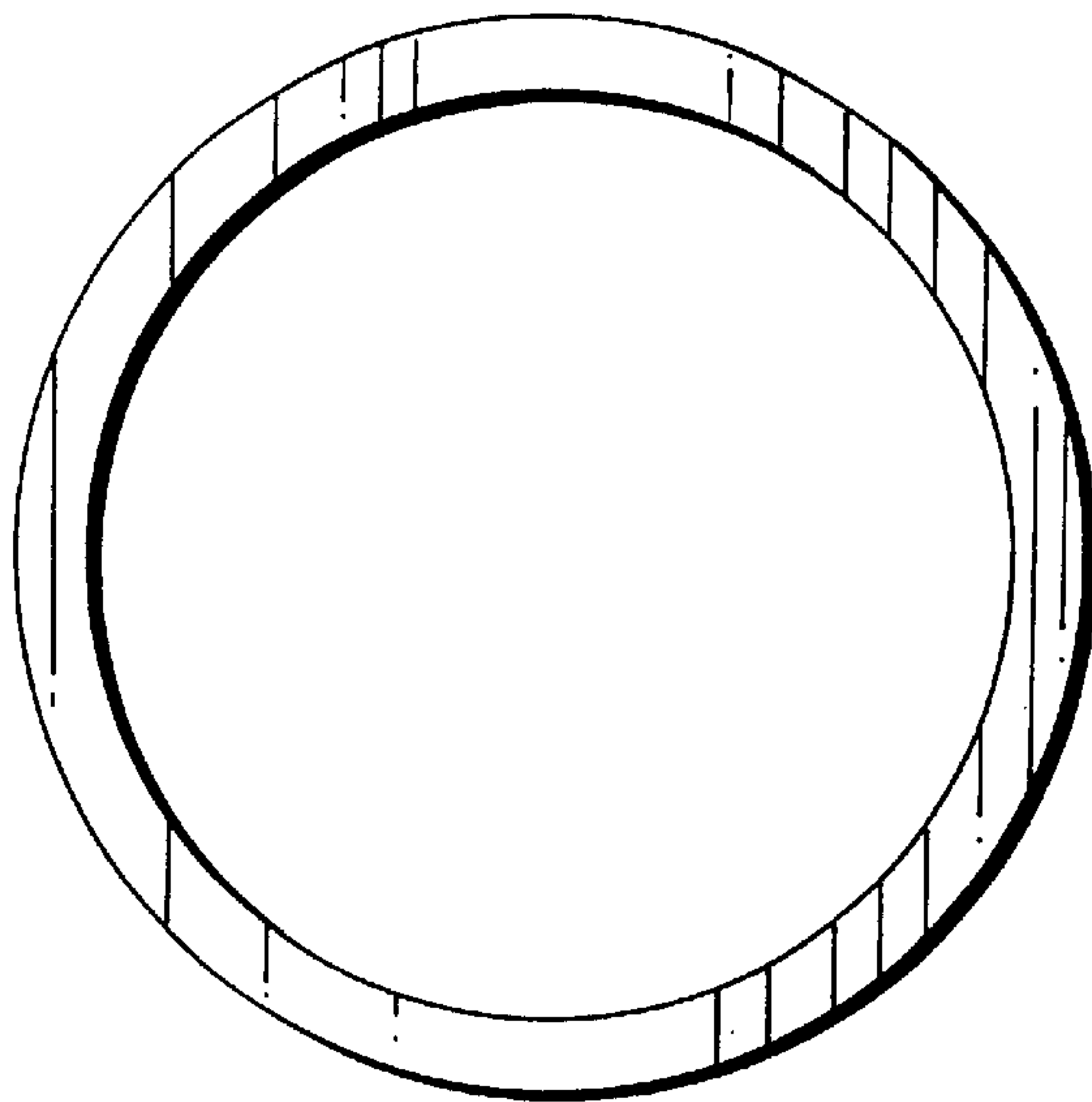

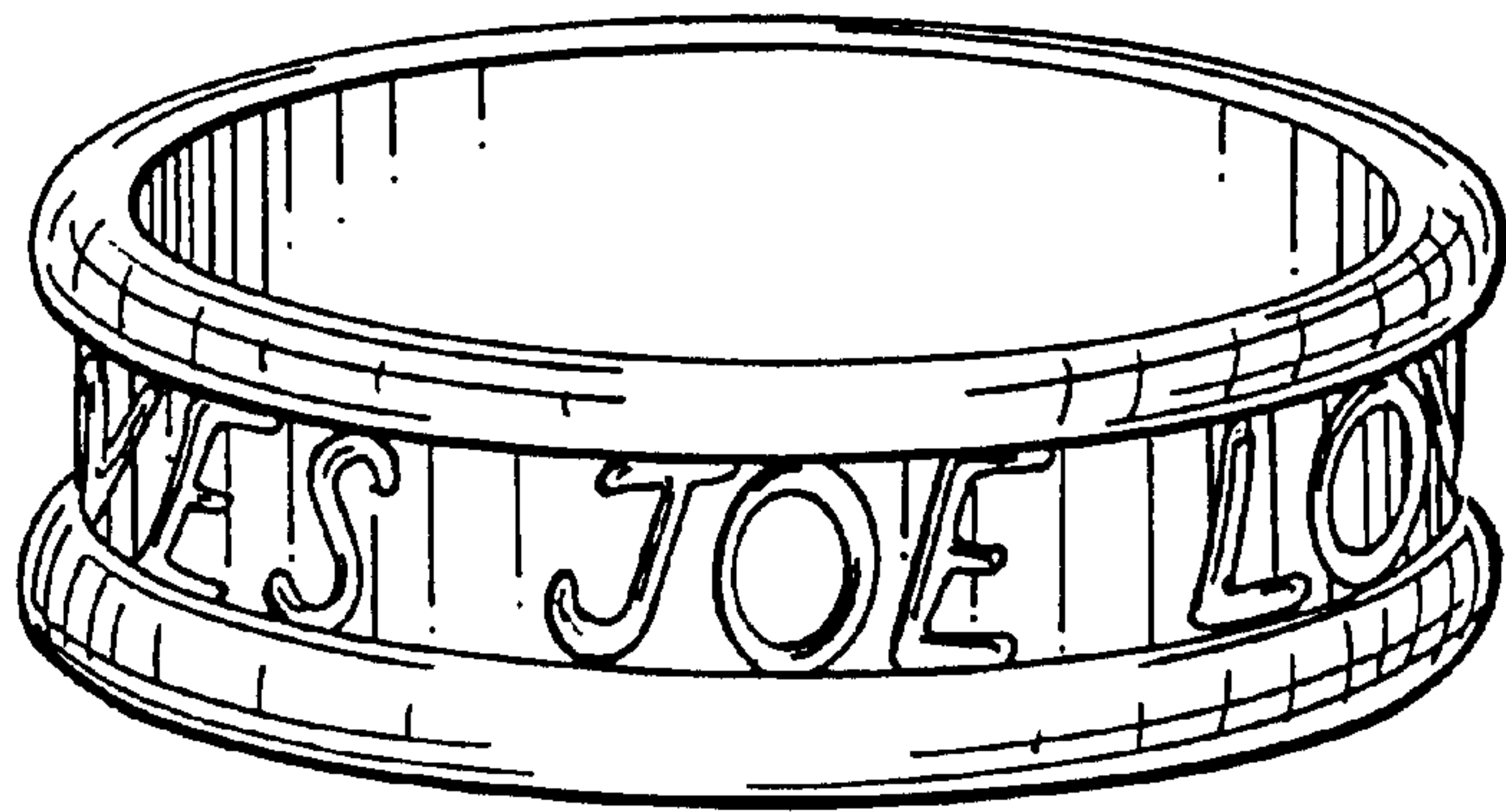

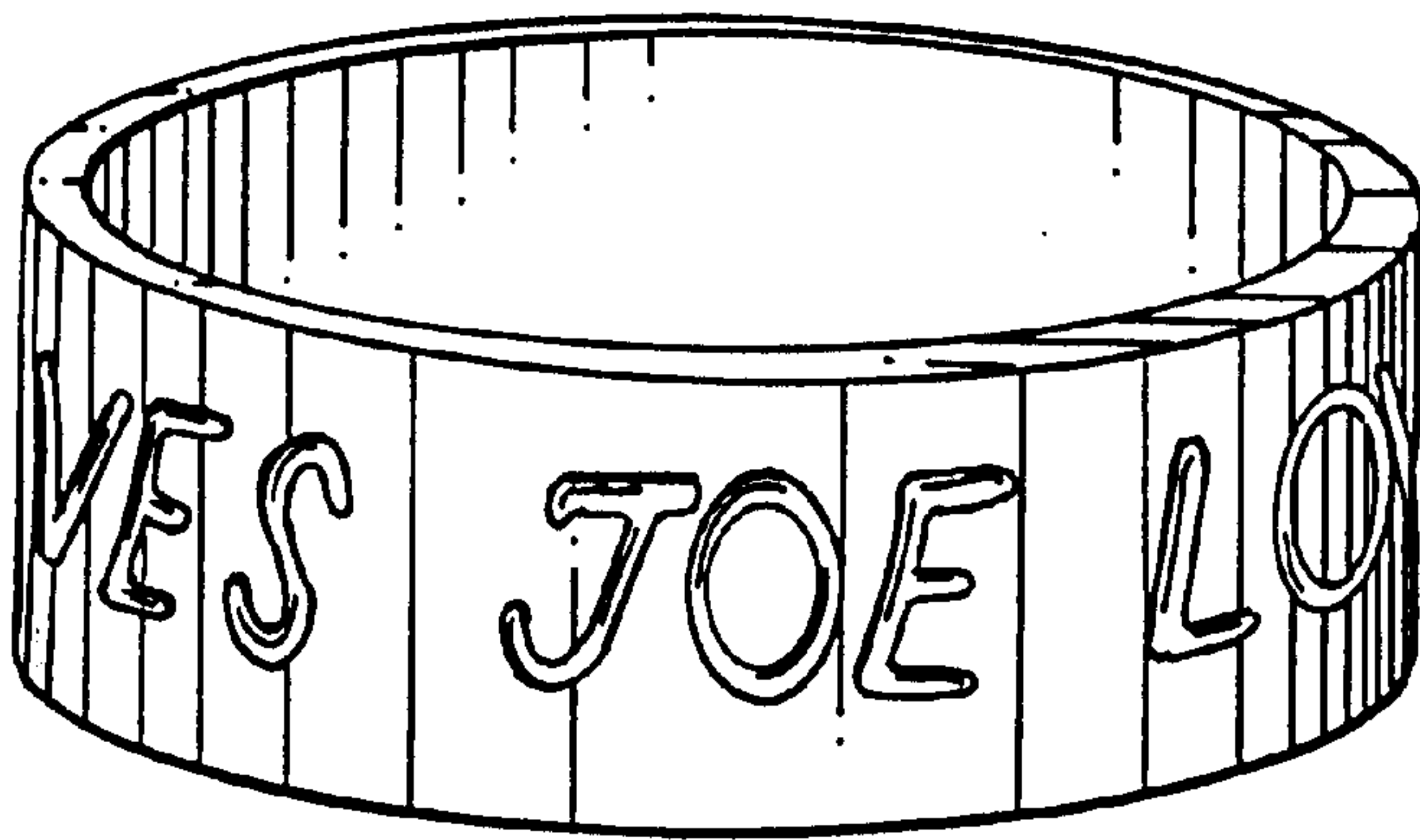
