(57) **CLAIM**

The ornamental design for a caliper insert for motorcycles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment showing my new and ornamental design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is an opposite side view thereof;
 FIG. 6 is an end view thereof, the opposite end being a mirror-image;
 FIG. 7 is a sectional view taken along line 7—7 in FIG. 2;
 FIG. 8 is a perspective view of a second embodiment for a caliper insert for motorcycles showing my new and ornamental design,
 FIG. 9 is a top plan view thereof;
 FIG. 10 is a bottom plan view thereof;
 FIG. 11 is a front view thereof;
 FIG. 12 is a rear view thereof;
 FIG. 13 is an end view thereof, the opposite end being a mirror-image; and,
 FIG. 14 is a sectional view taken along line 14—14 in FIG. 9.

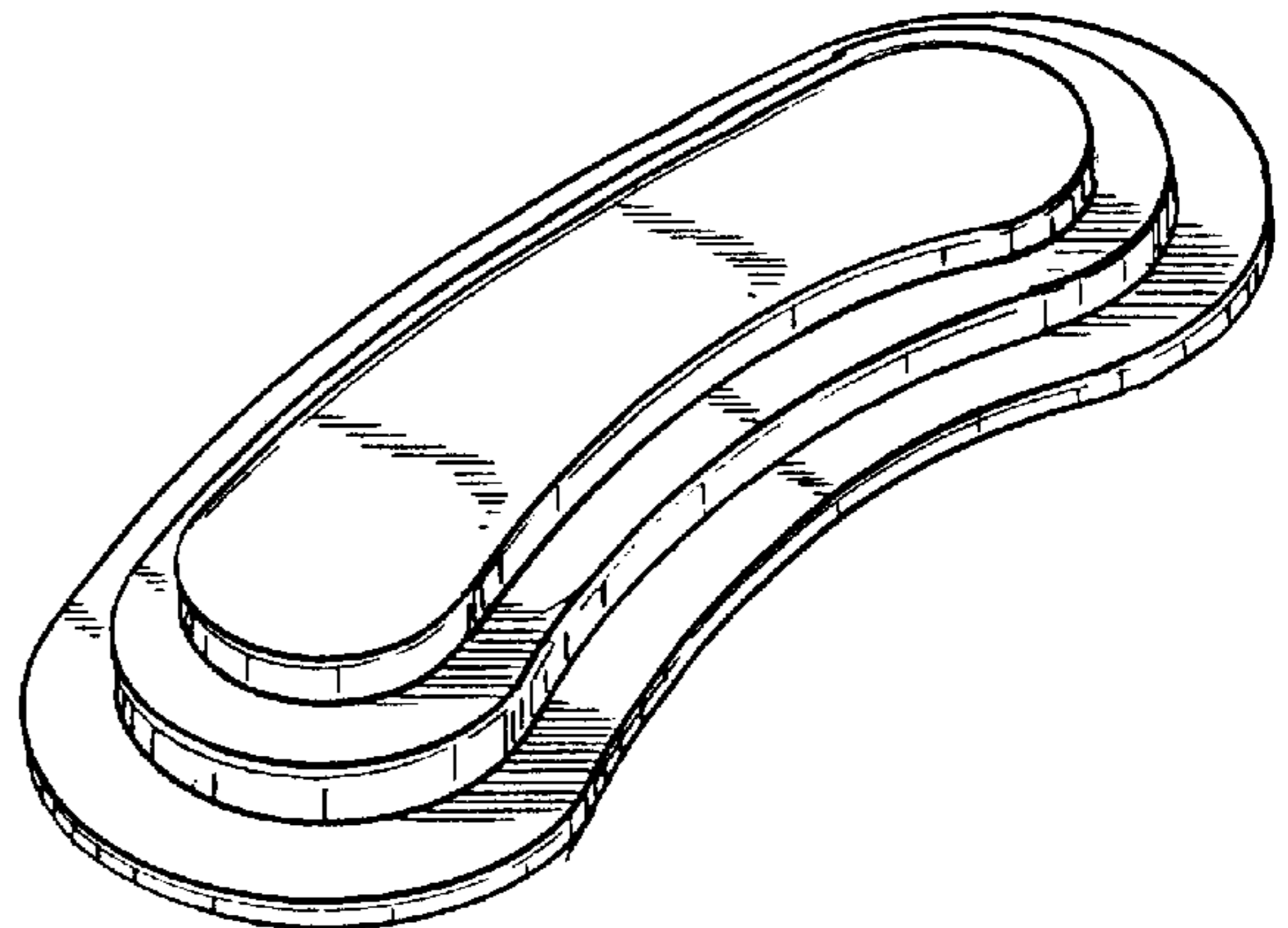
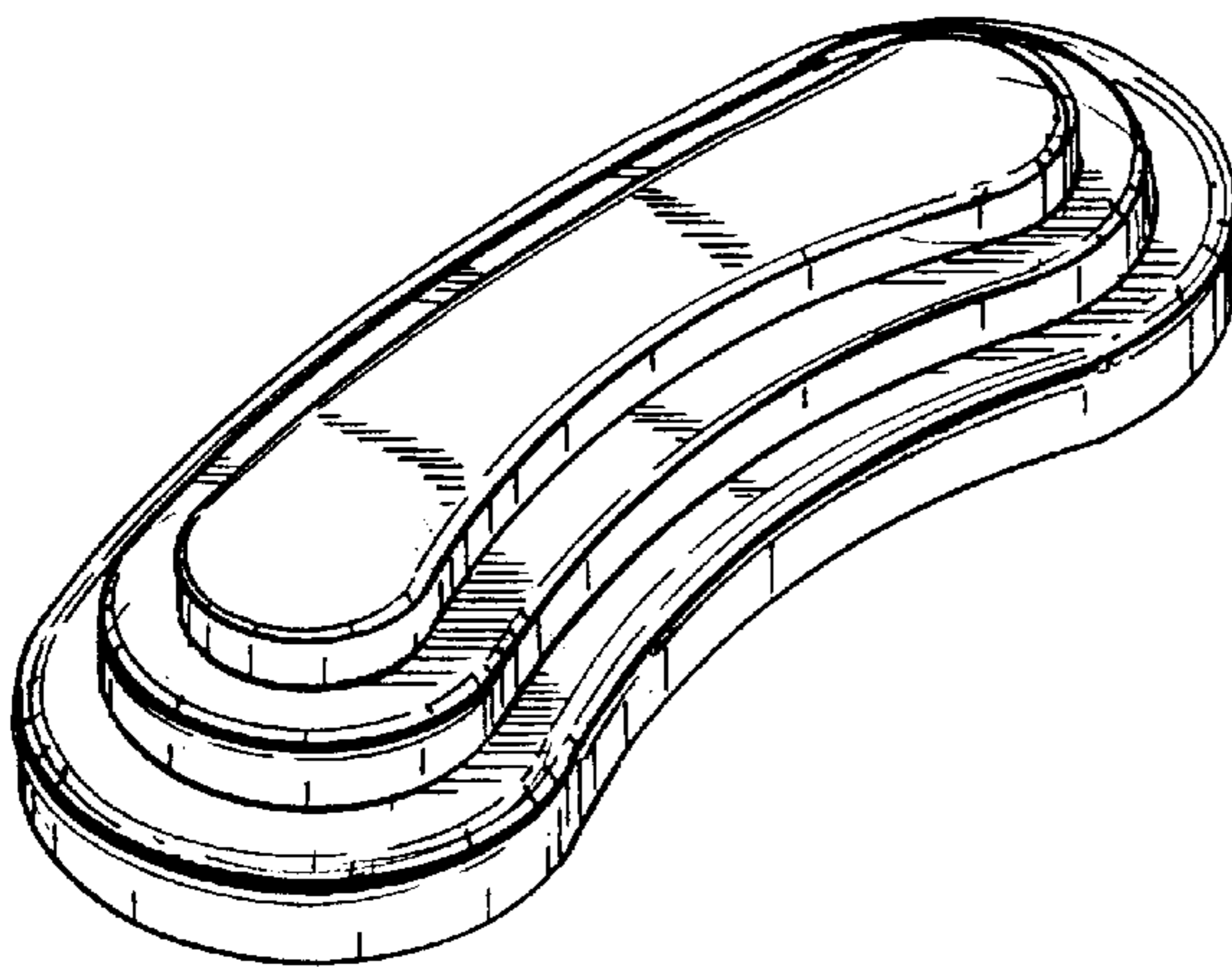

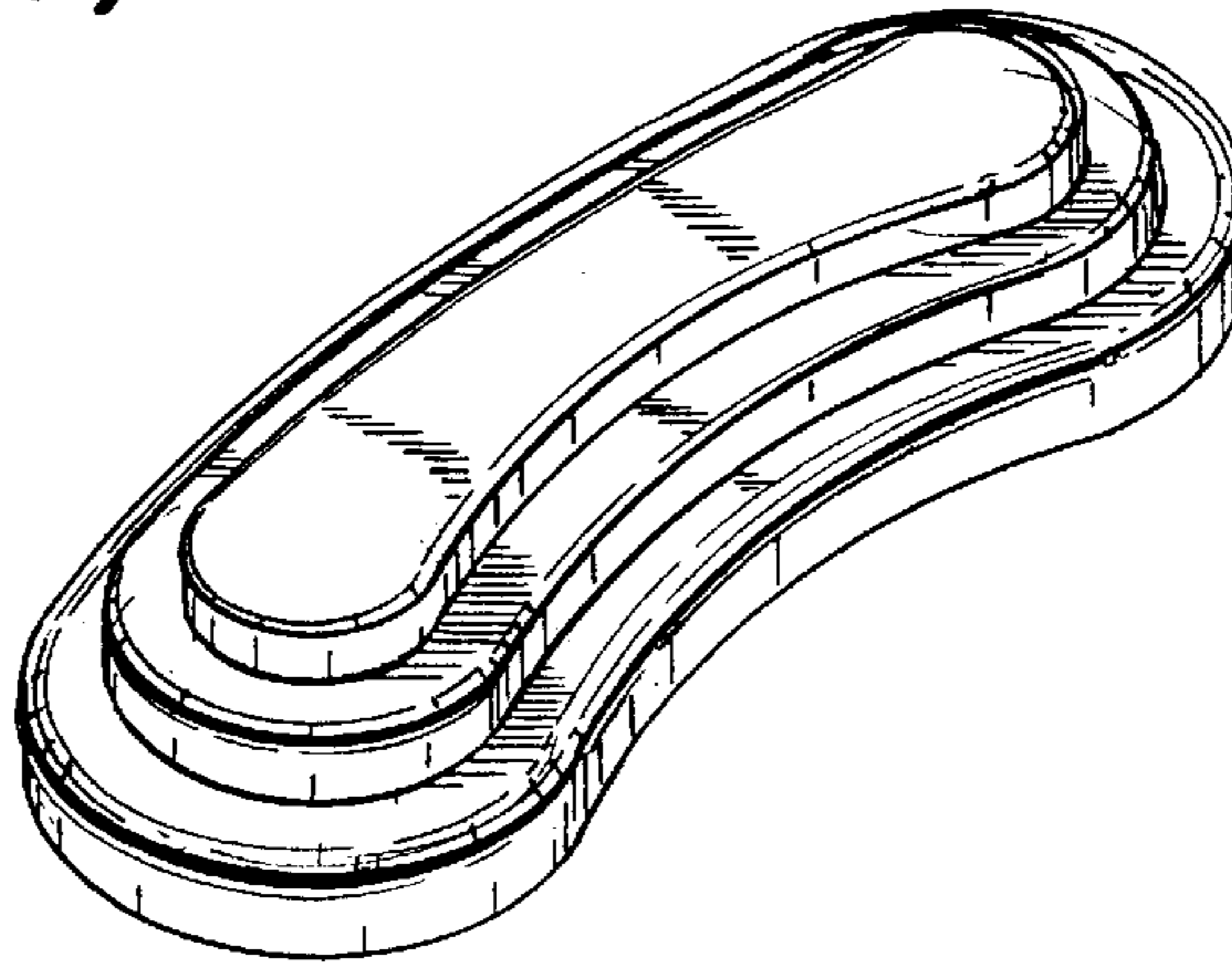

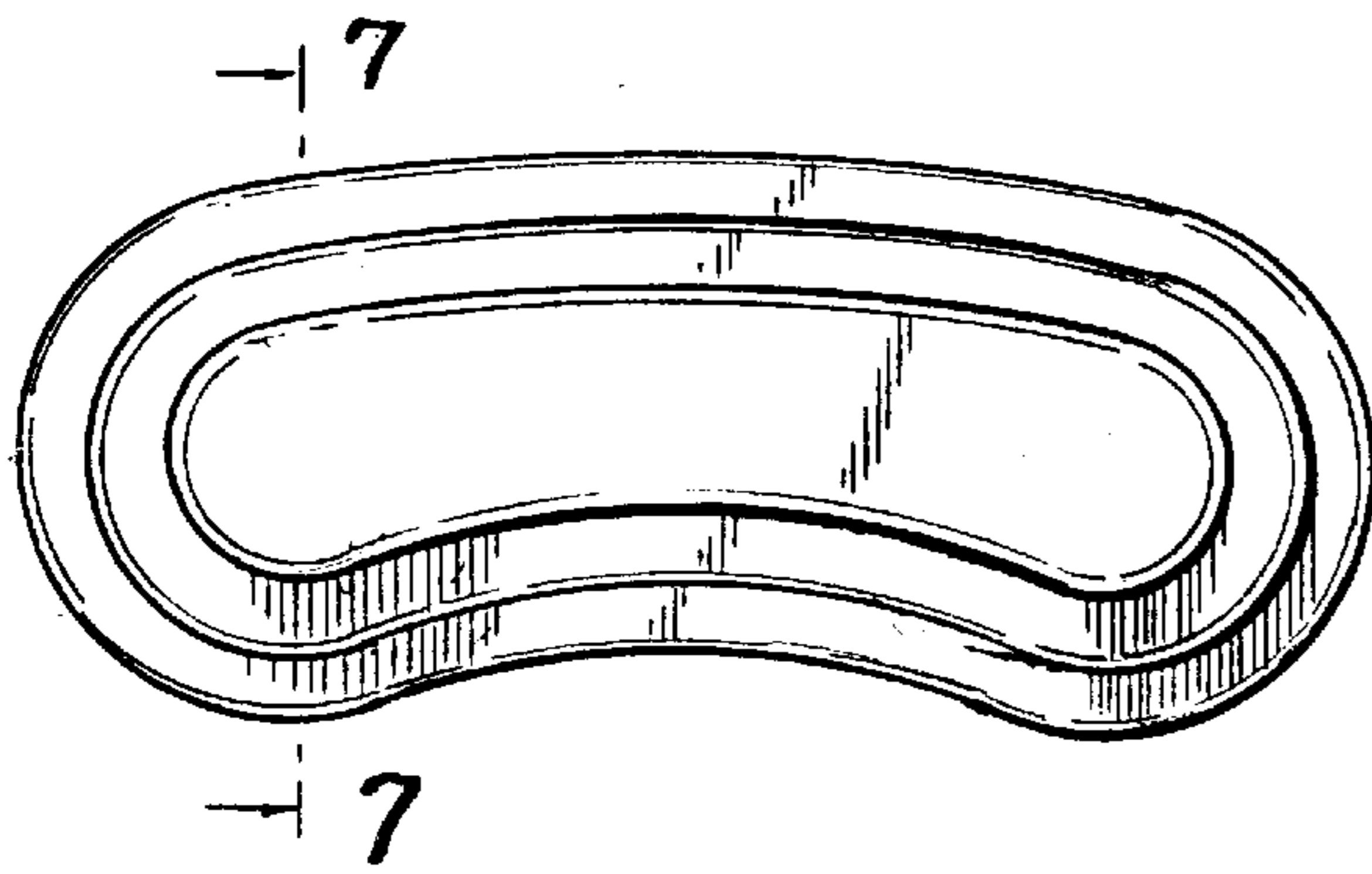

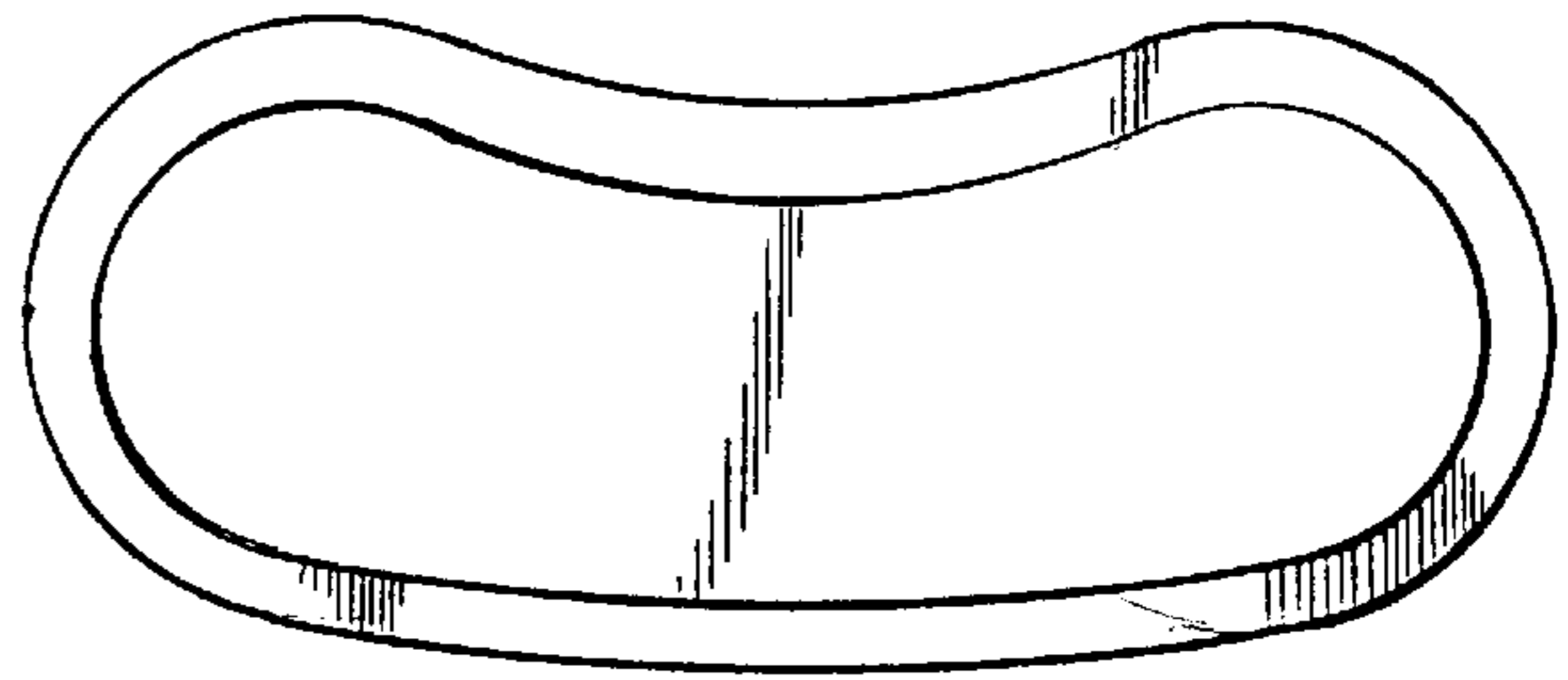

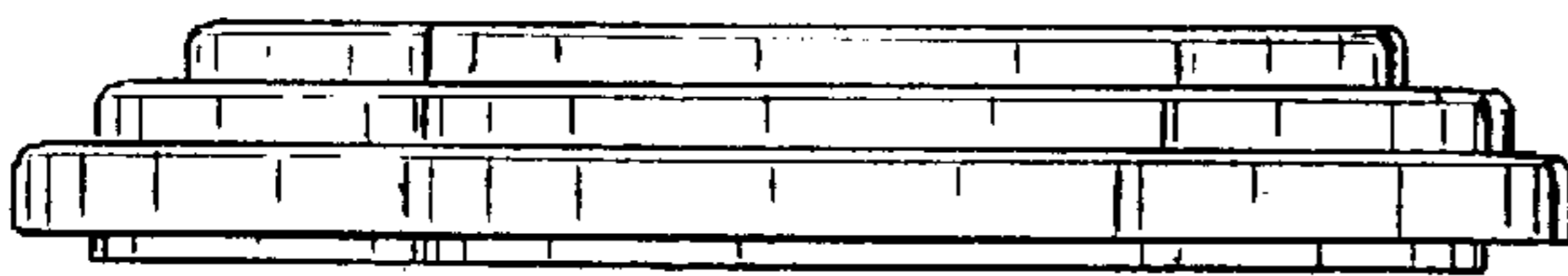

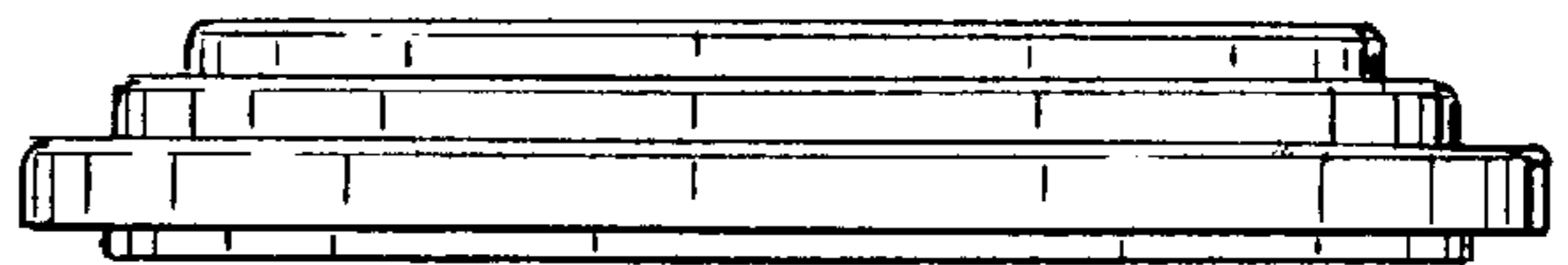

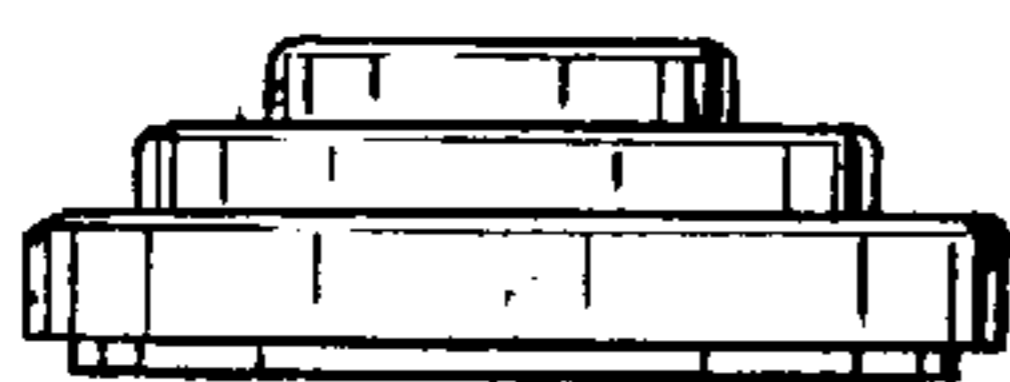

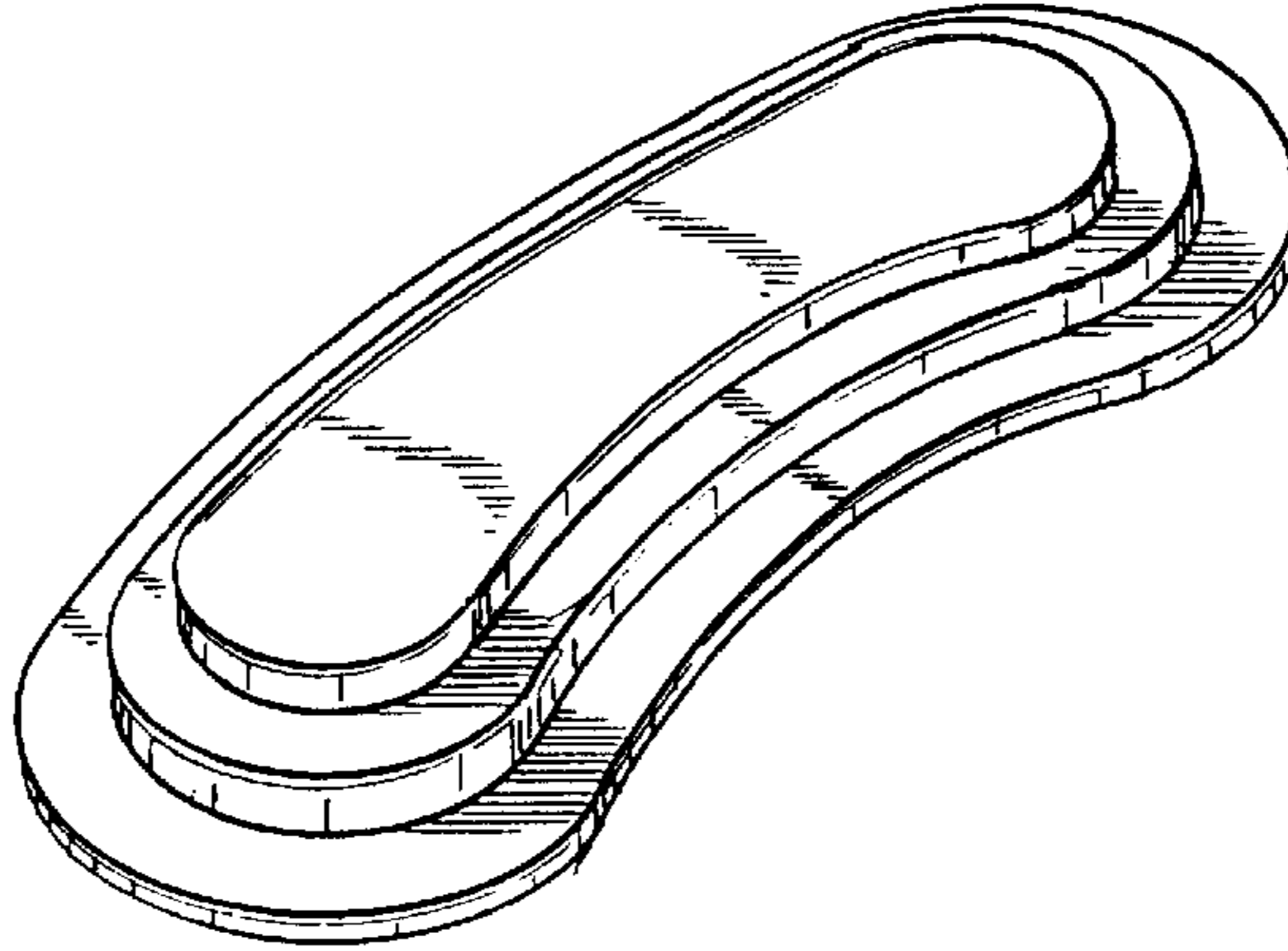

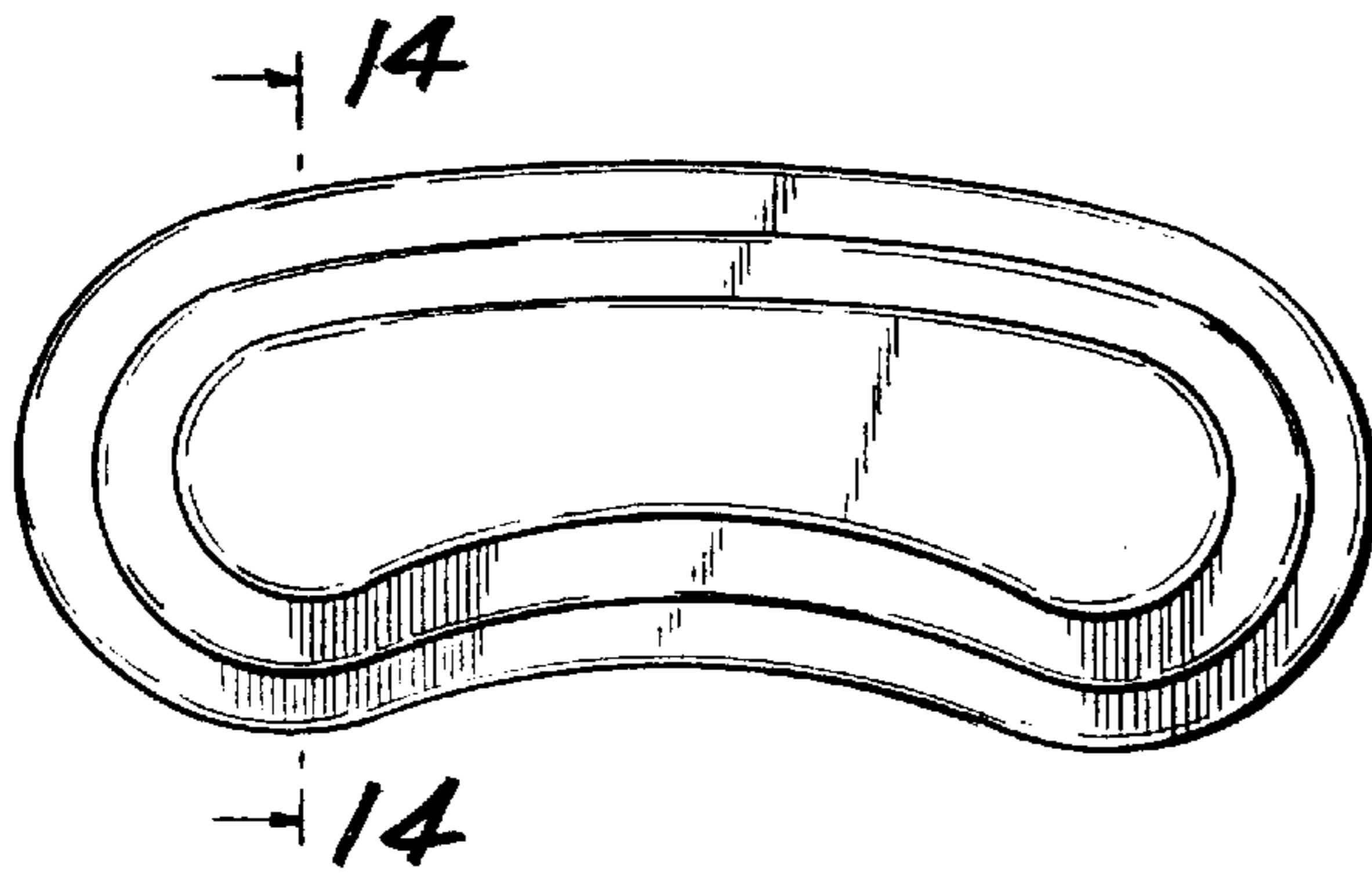

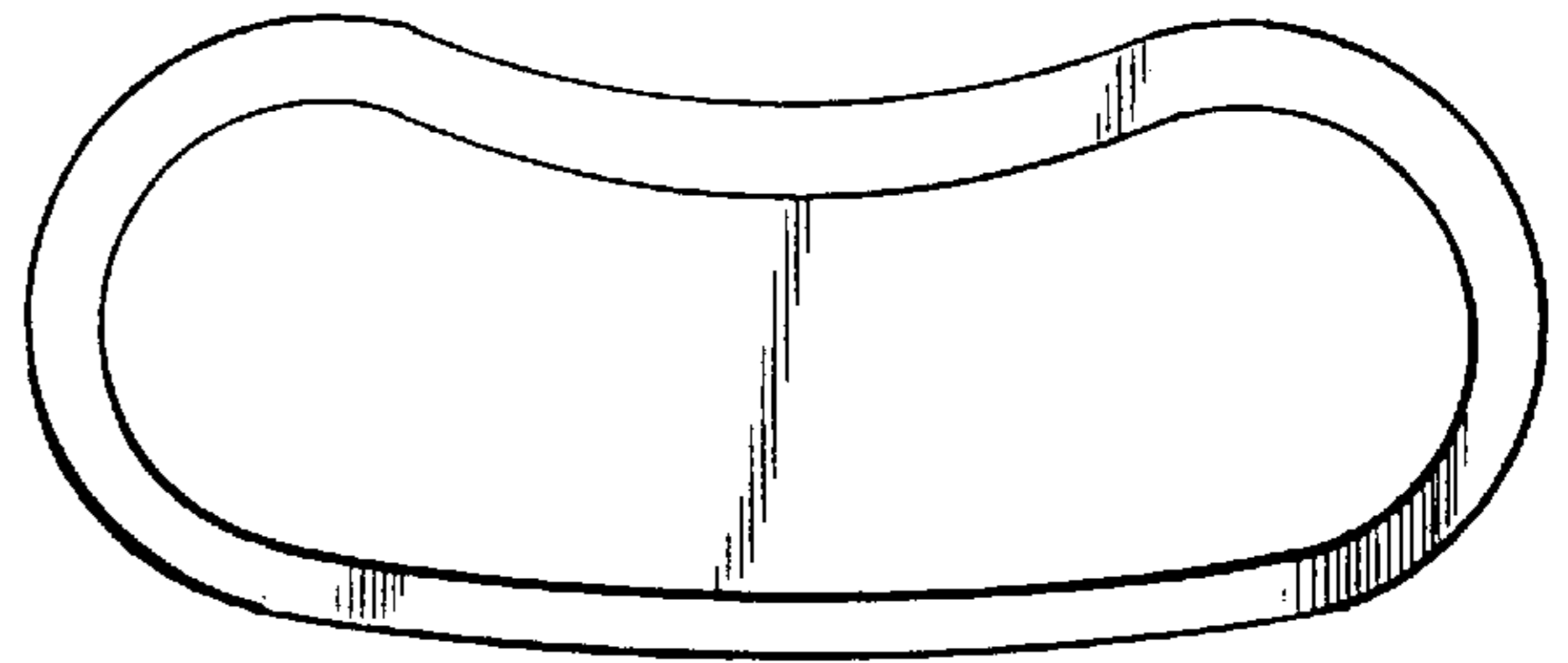

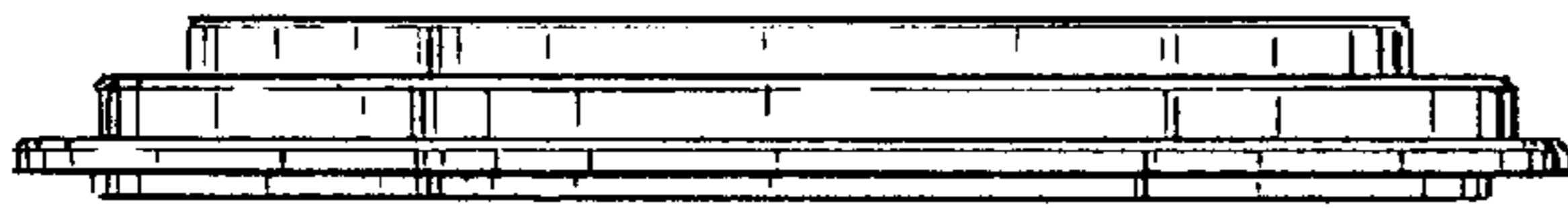

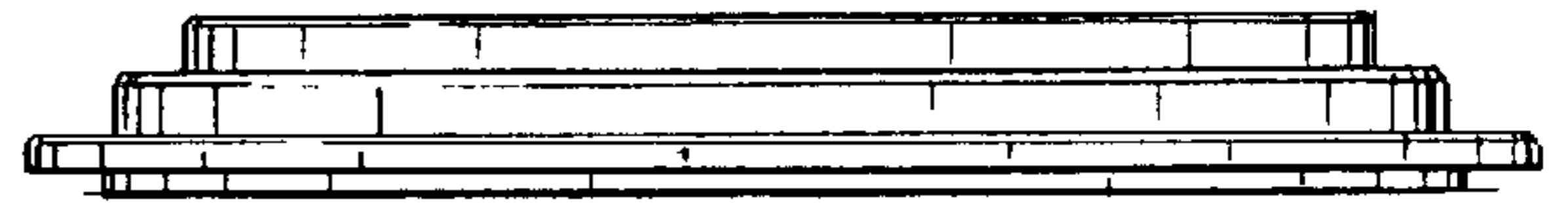

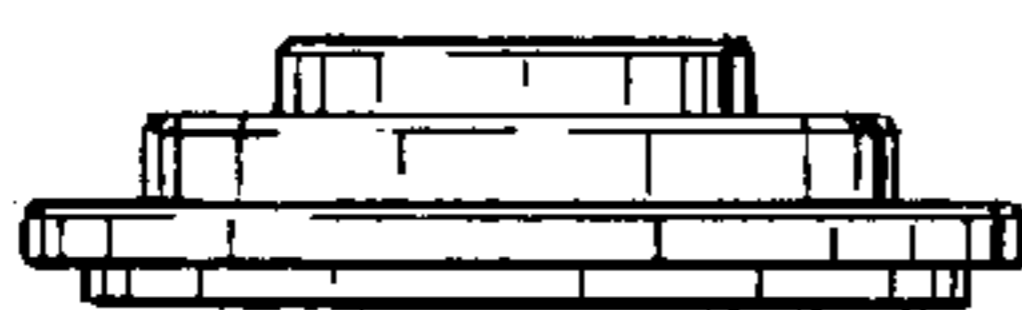
