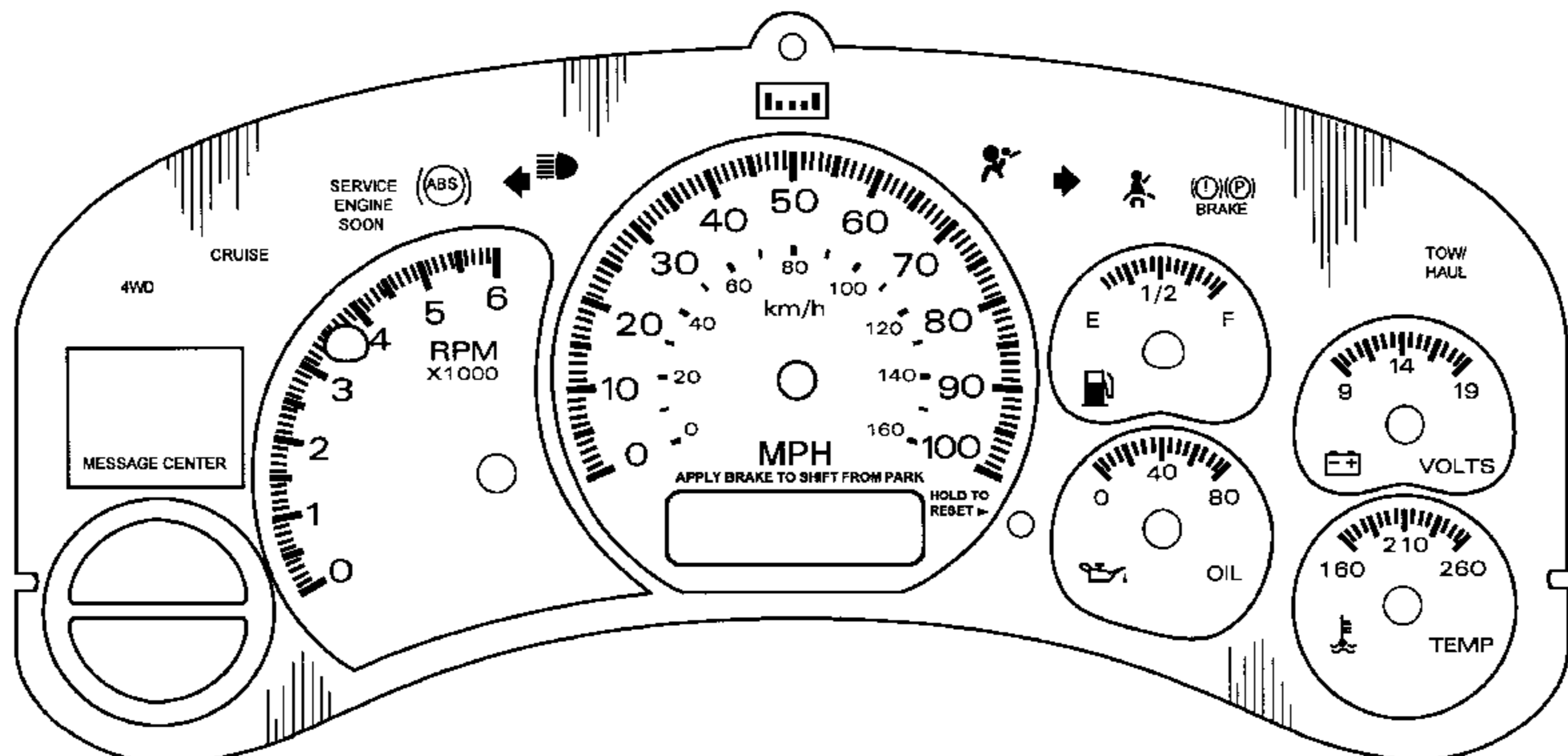
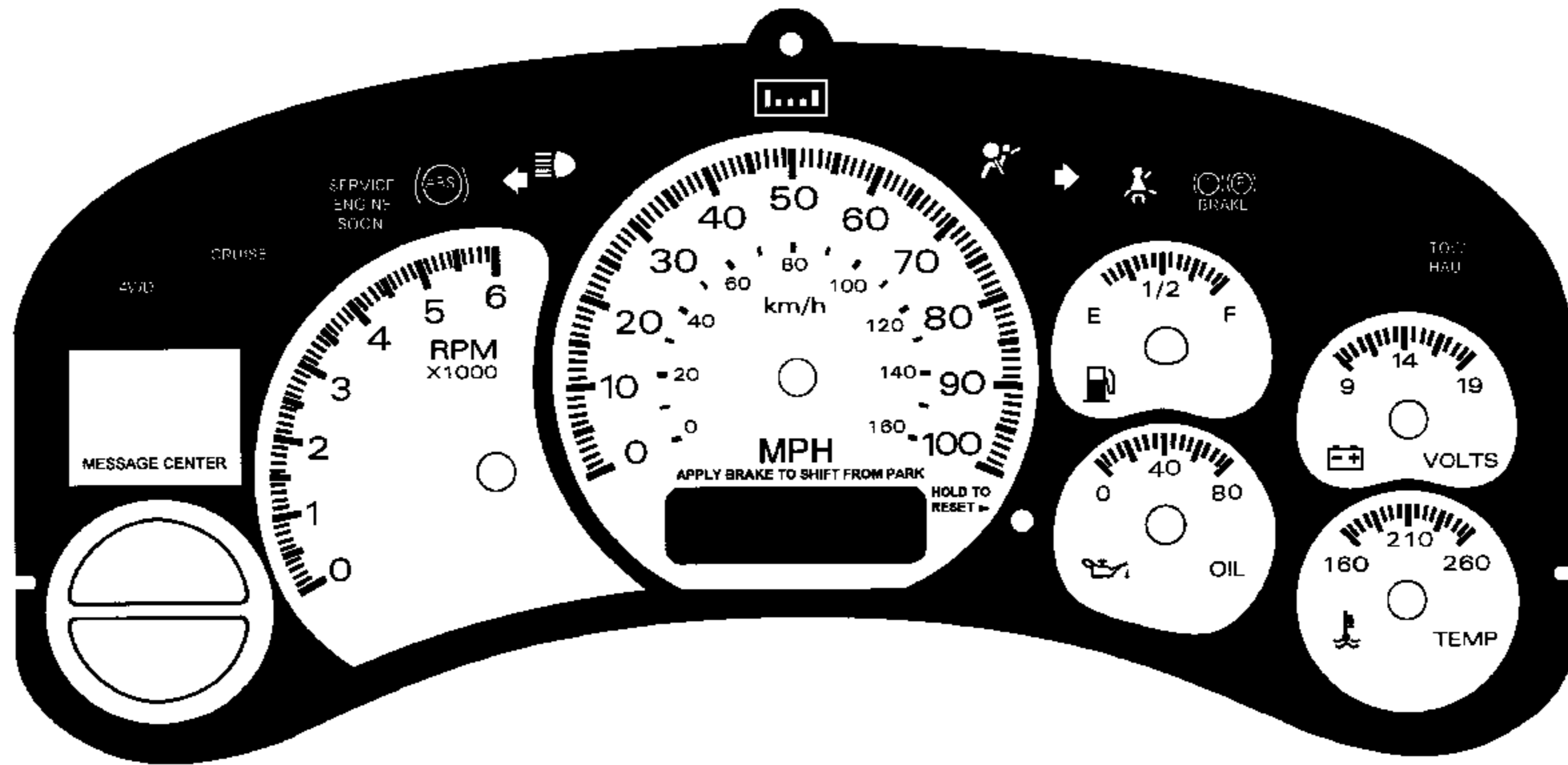
The ornamental design for a gage face dial mask for vehicle, as shown.

DESCRIPTION

FIG. 1 is a front elevation view of a gage face dial mask for vehicle showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a rear elevation view thereof;
 FIG. 5 is a left side elevation view thereof;
 FIG. 6 is a right side elevation view thereof;
 FIG. 7 is a front elevation view of a second embodiment;
 FIG. 8 is a top plan view of the embodiment of FIG. 7;
 FIG. 9 is a bottom plan view of the embodiment of FIG. 7;
 FIG. 10 is a rear elevation view of the embodiment of FIG. 7;
 FIG. 11 is a left side elevation view of the embodiment of FIG. 7; and,
 FIG. 12 is a right side elevation view of the embodiment of FIG. 7.

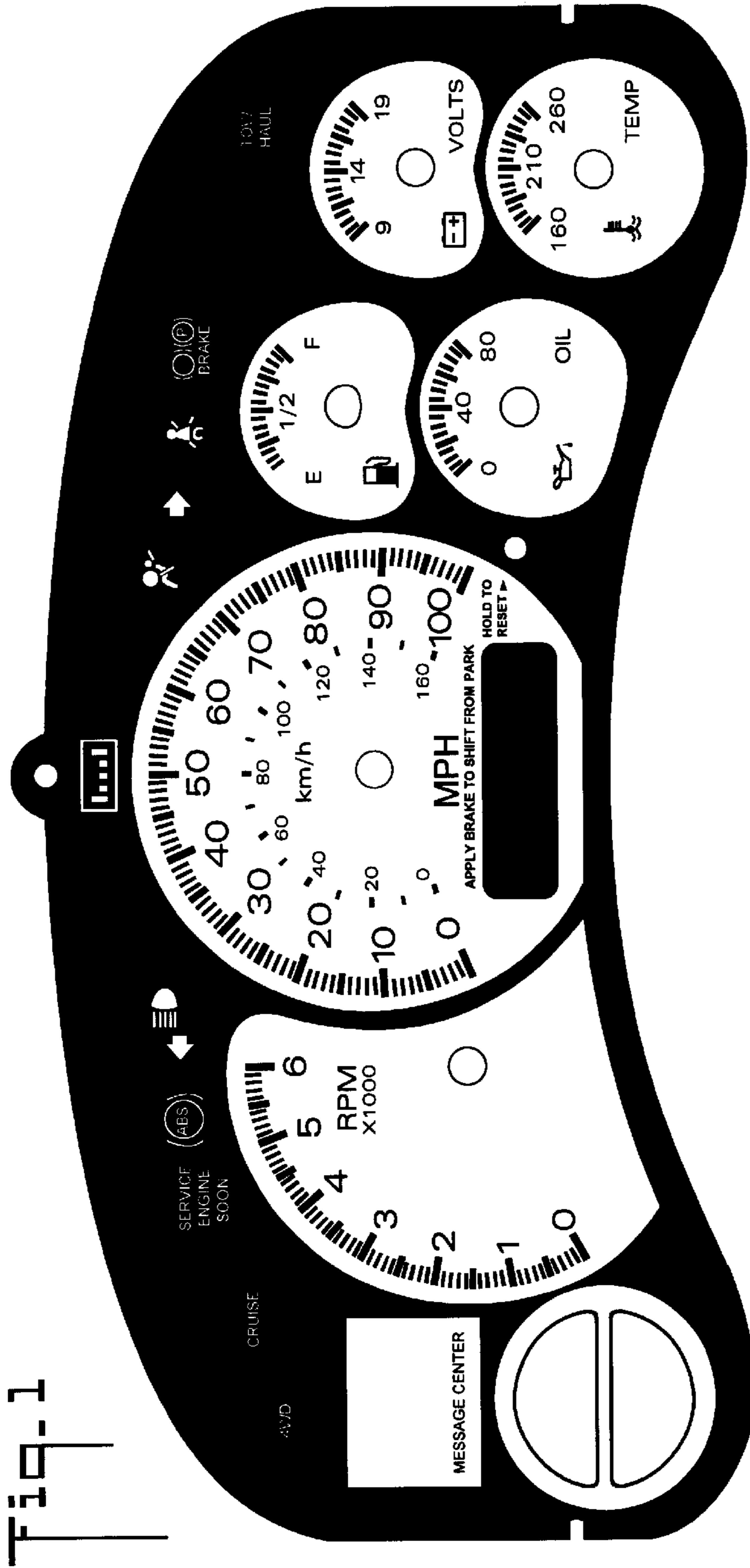

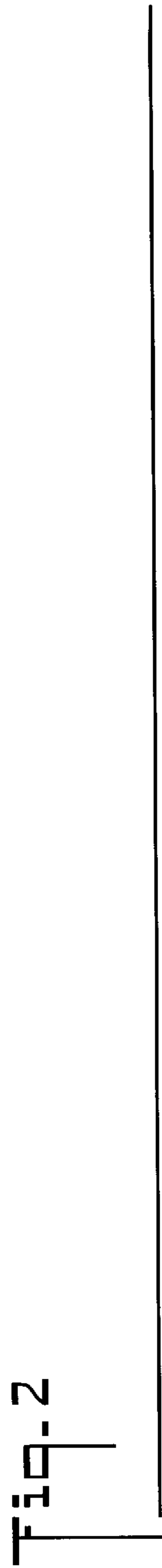

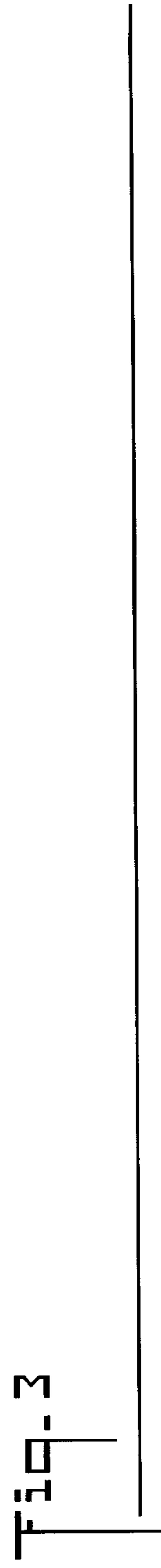
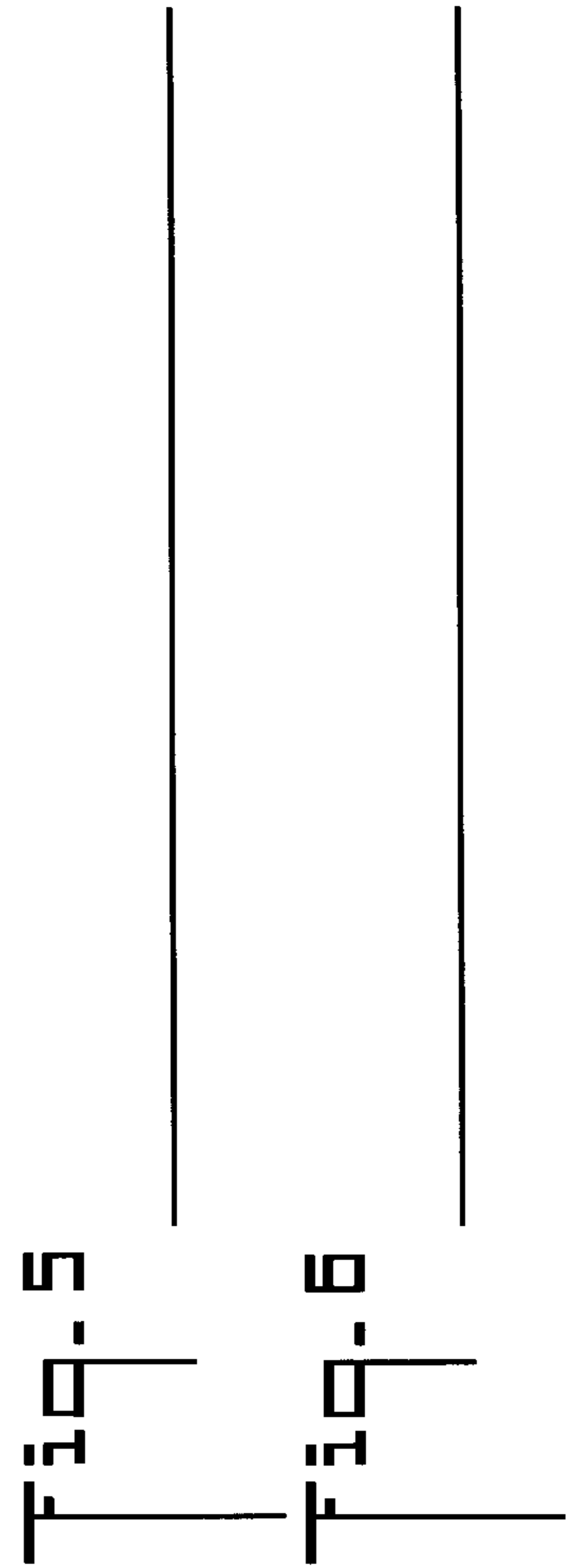
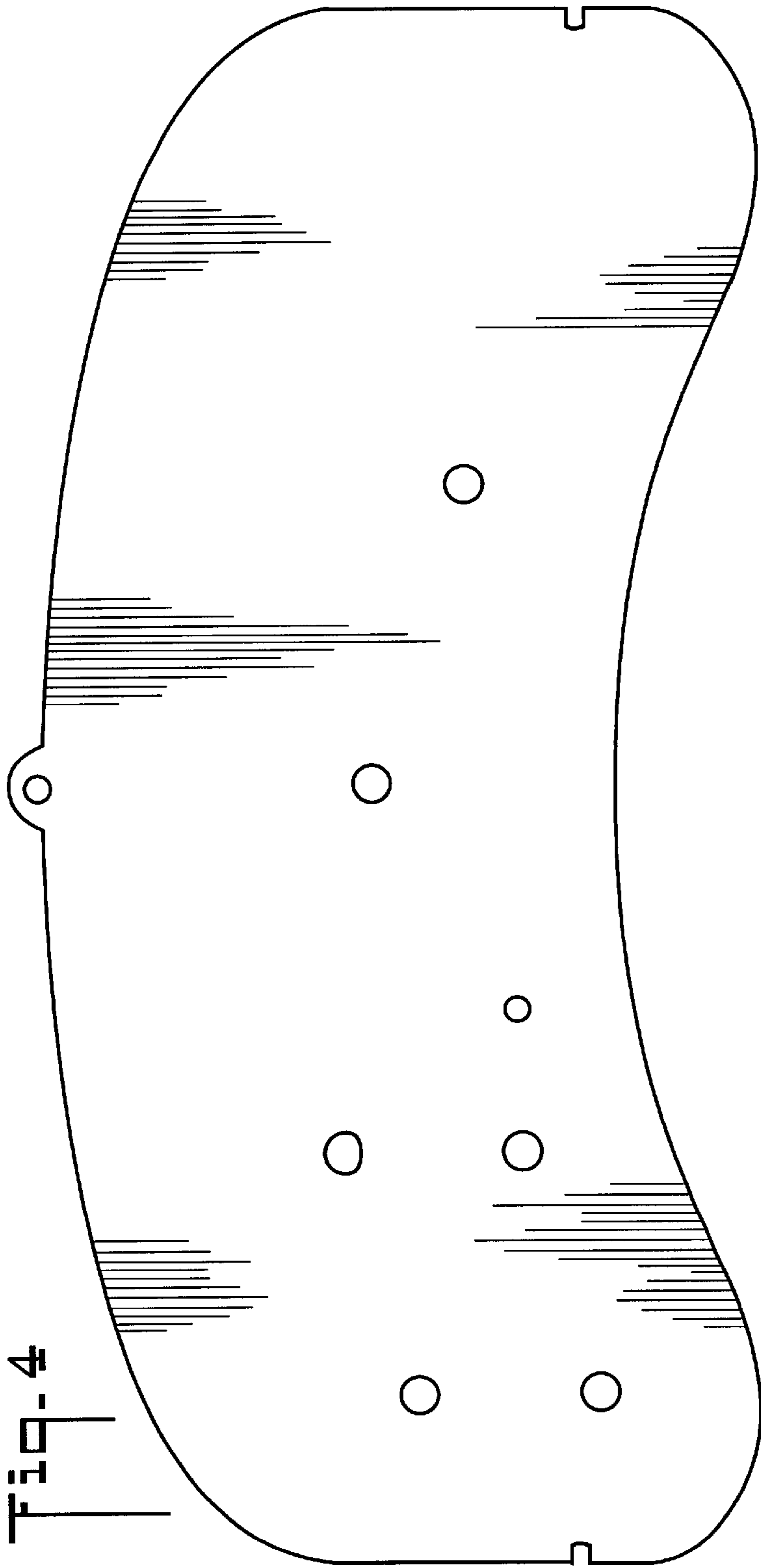

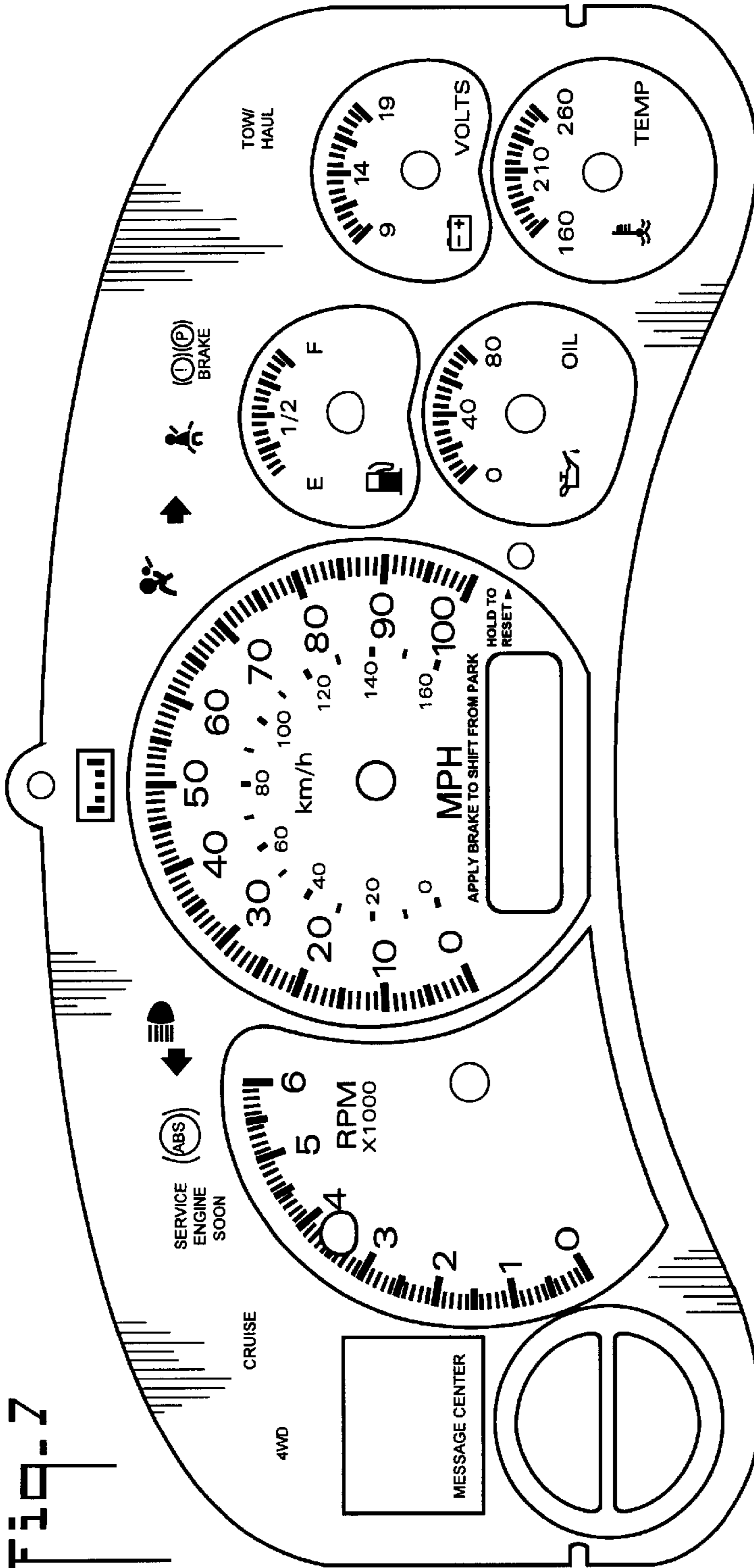

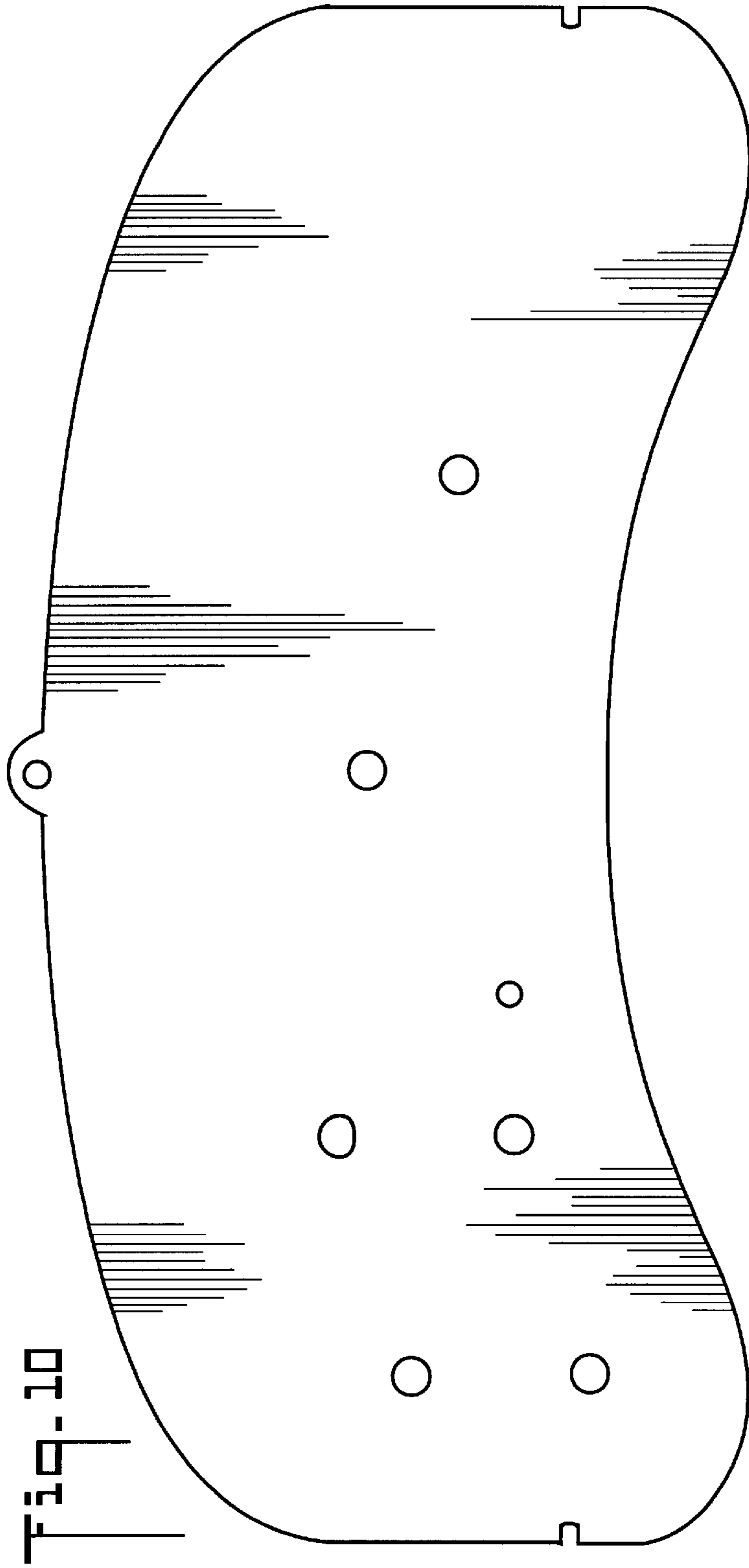

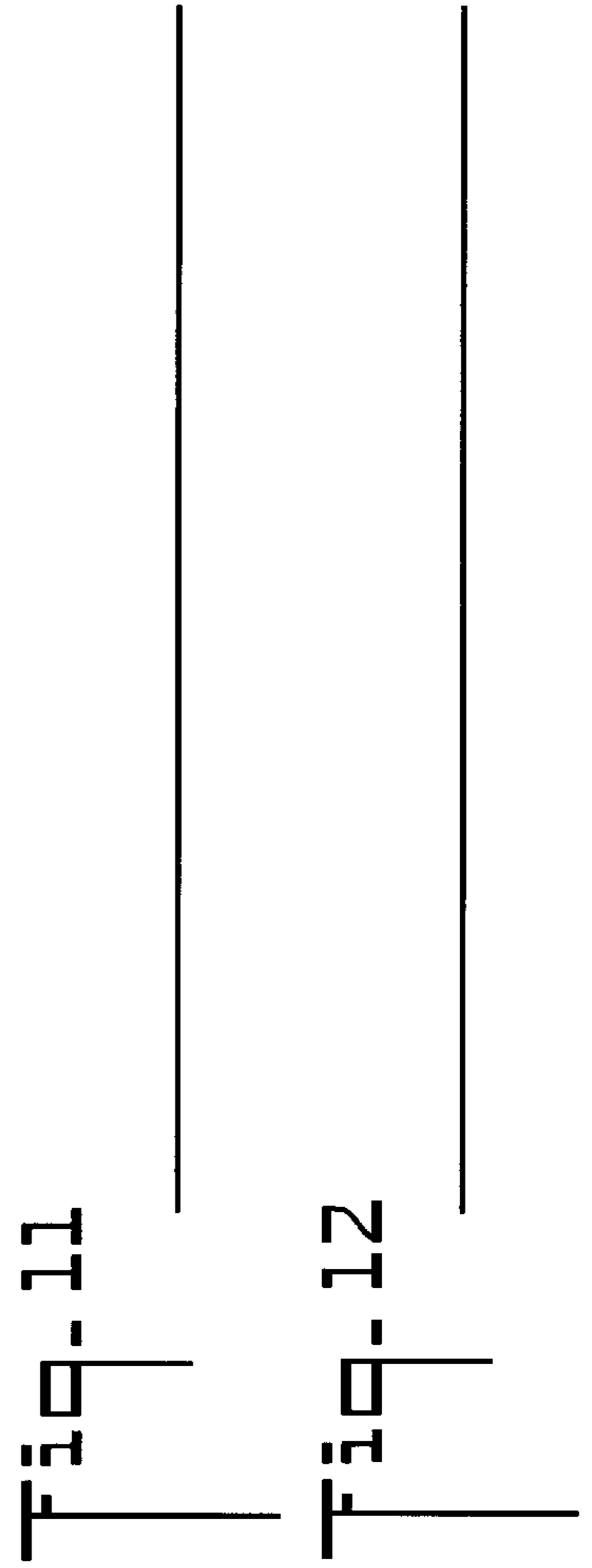
