FIG. 8 is a front view showing the hula-hoop according to my design, comprising seven members; and,

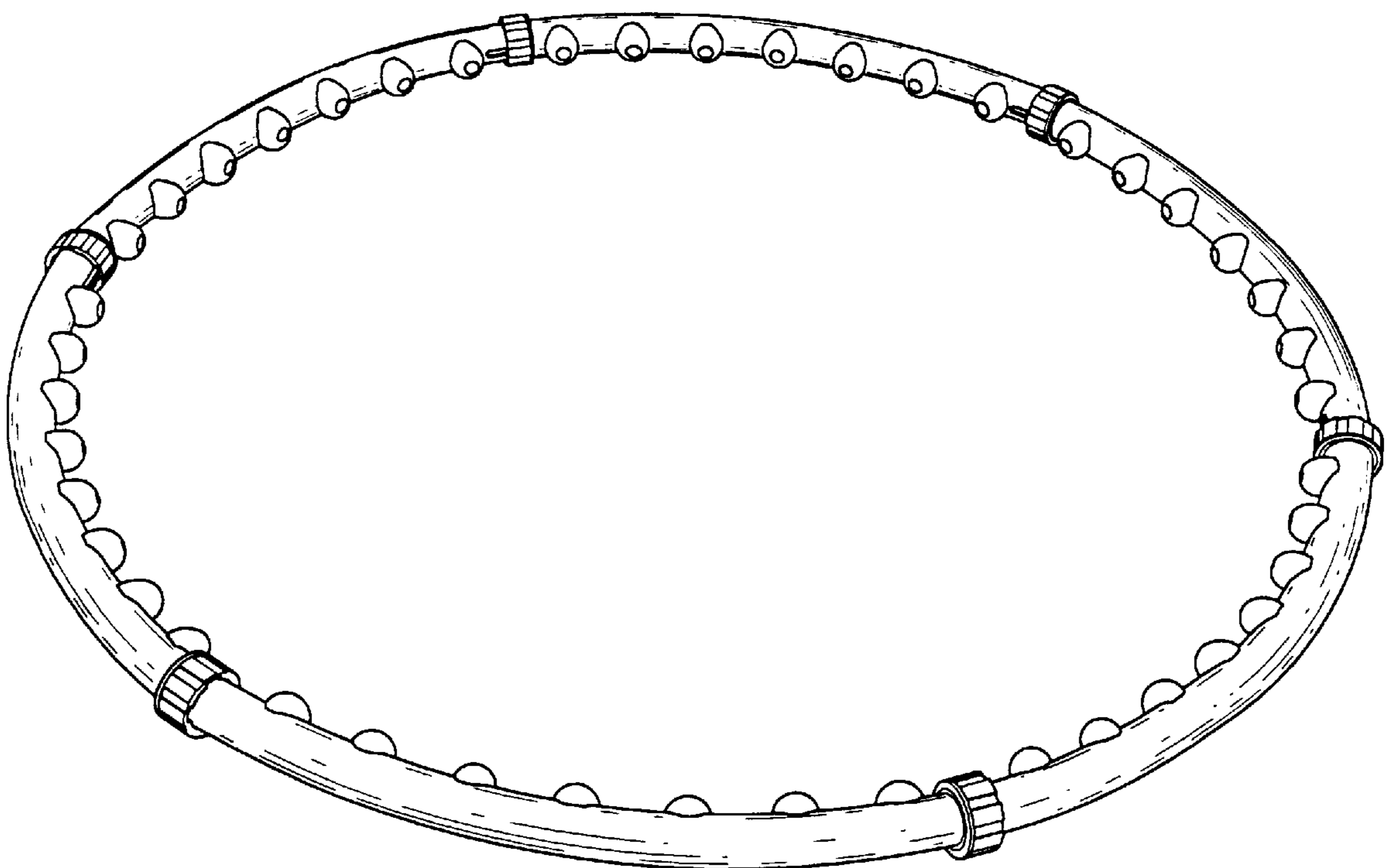
FIG. 9 is a front view showing the hula-hoop according to my design, comprising eight members.

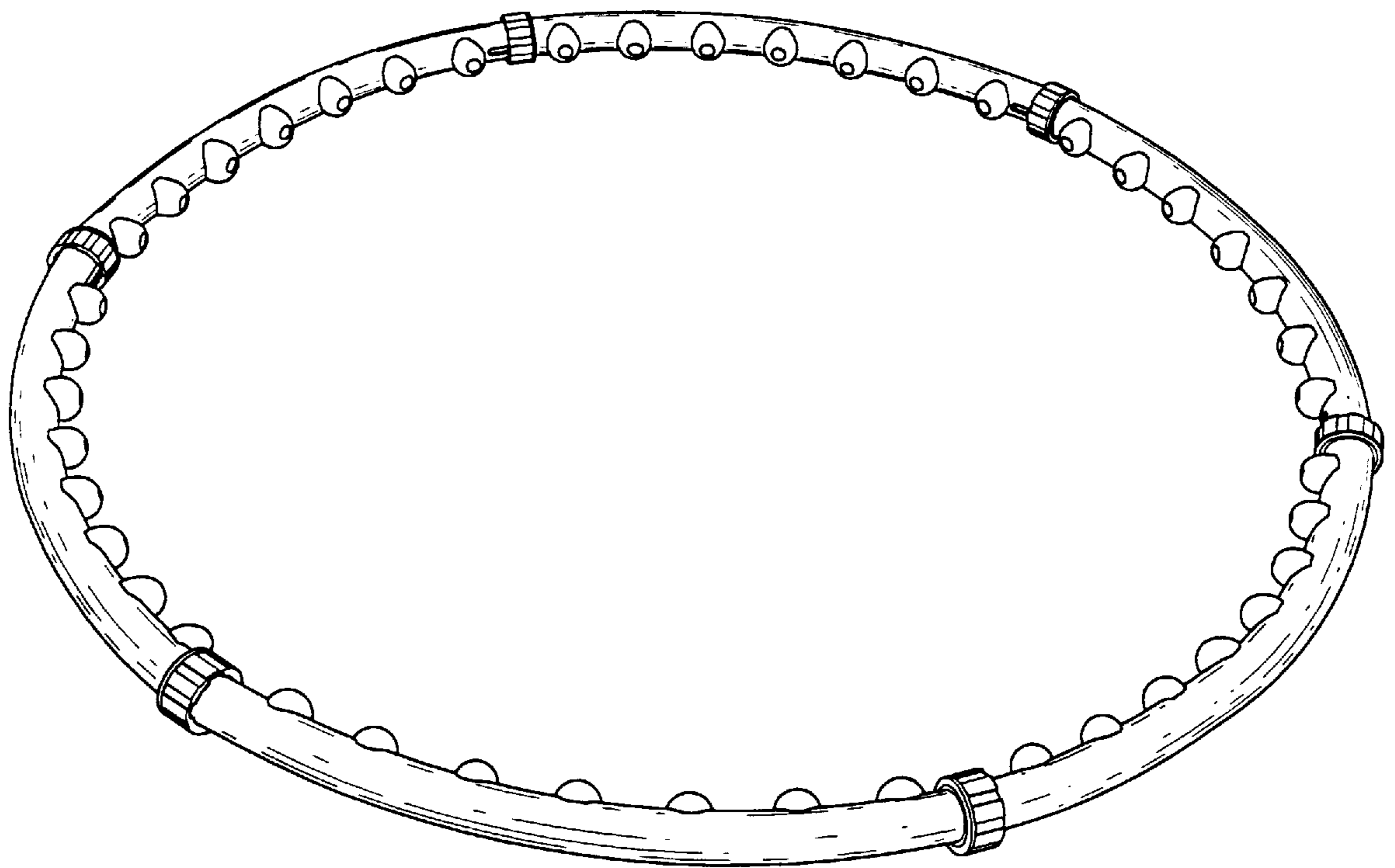

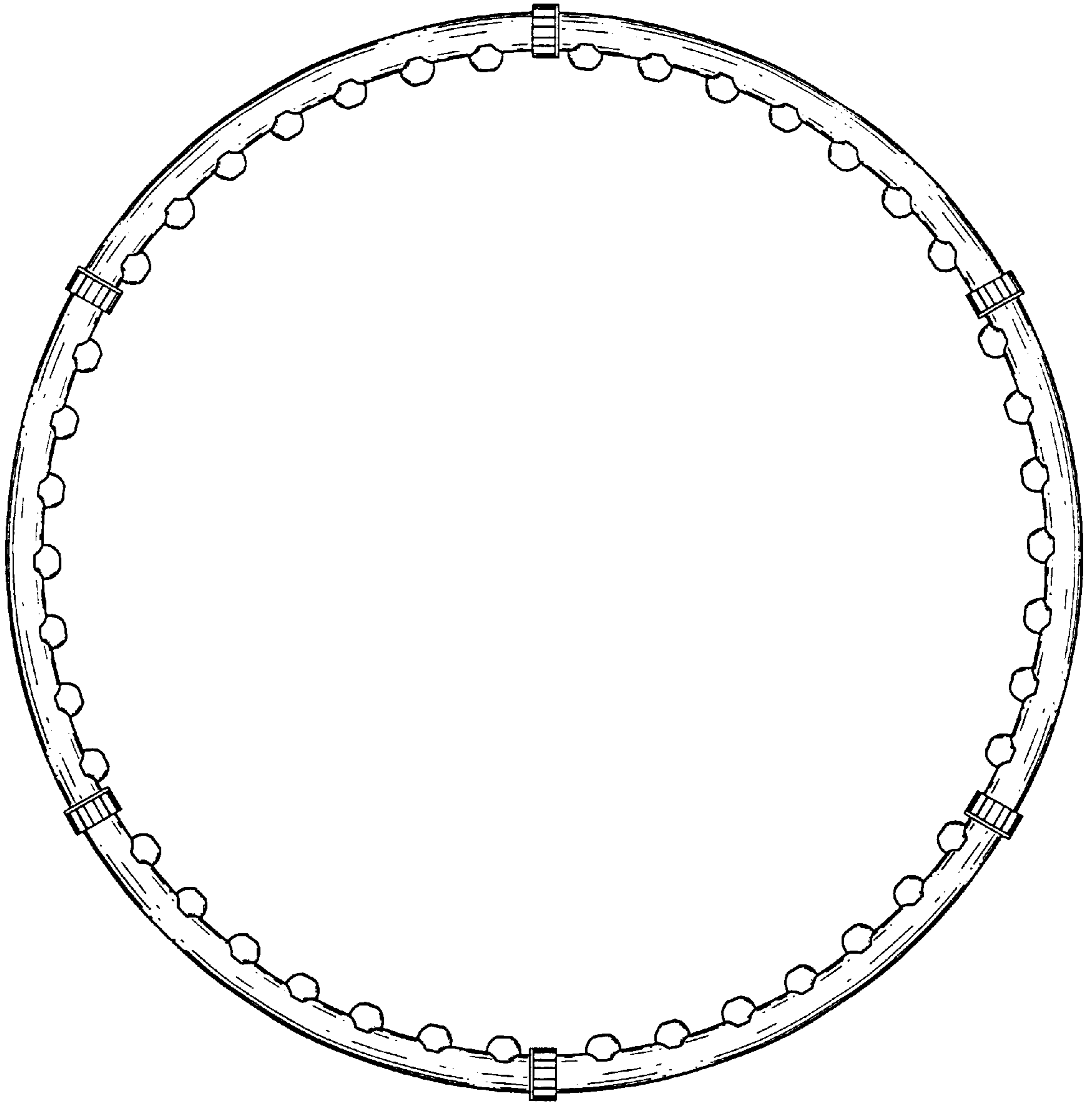

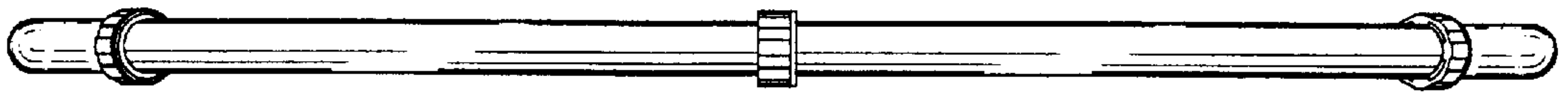

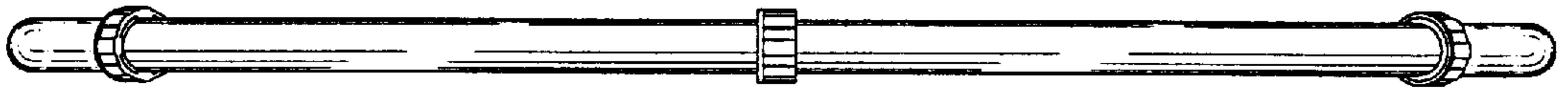

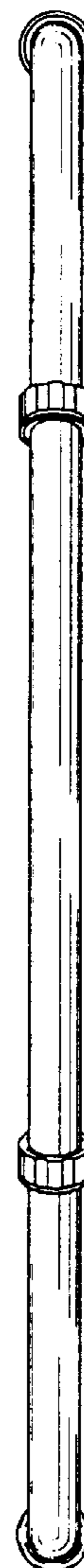

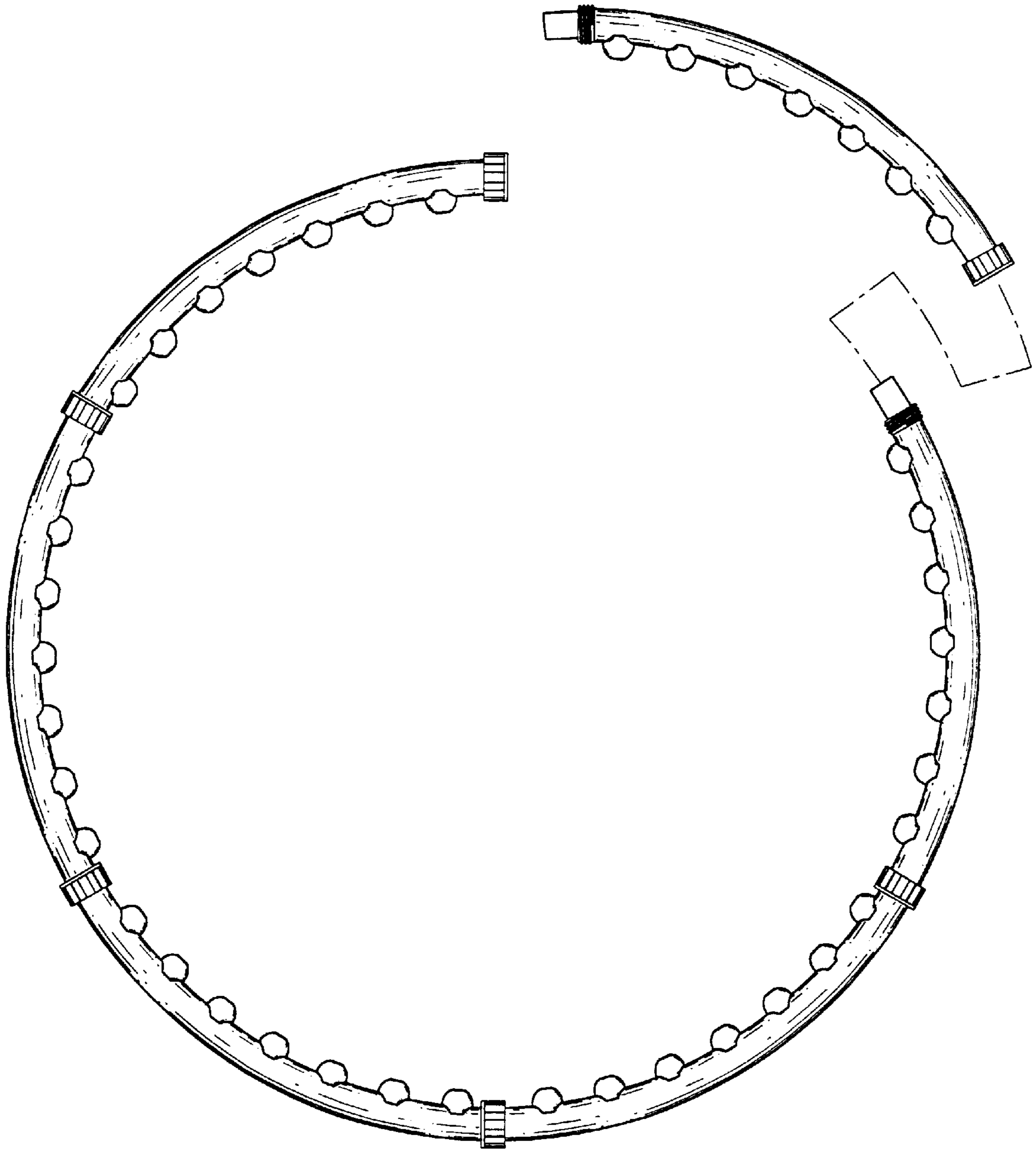

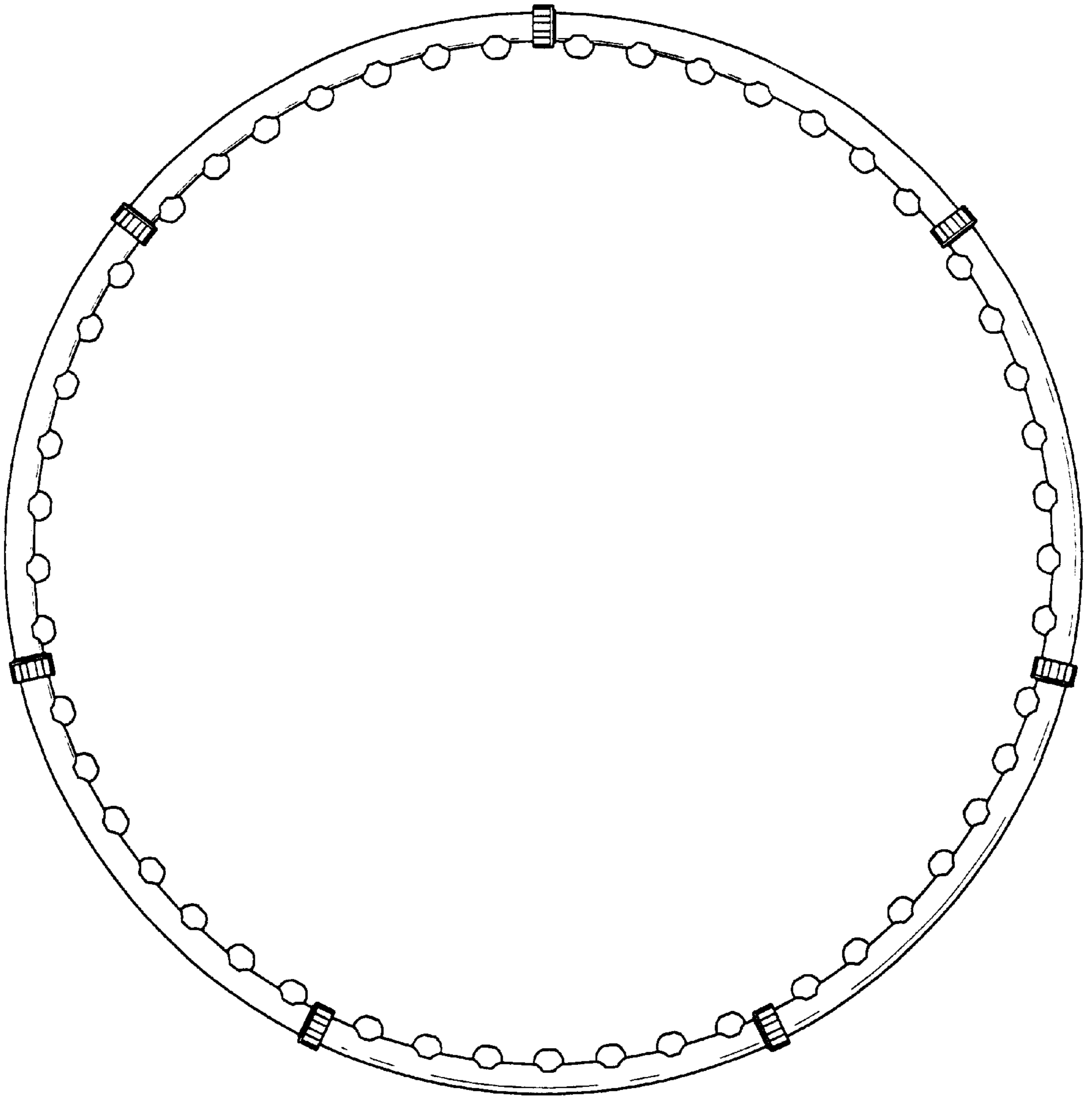

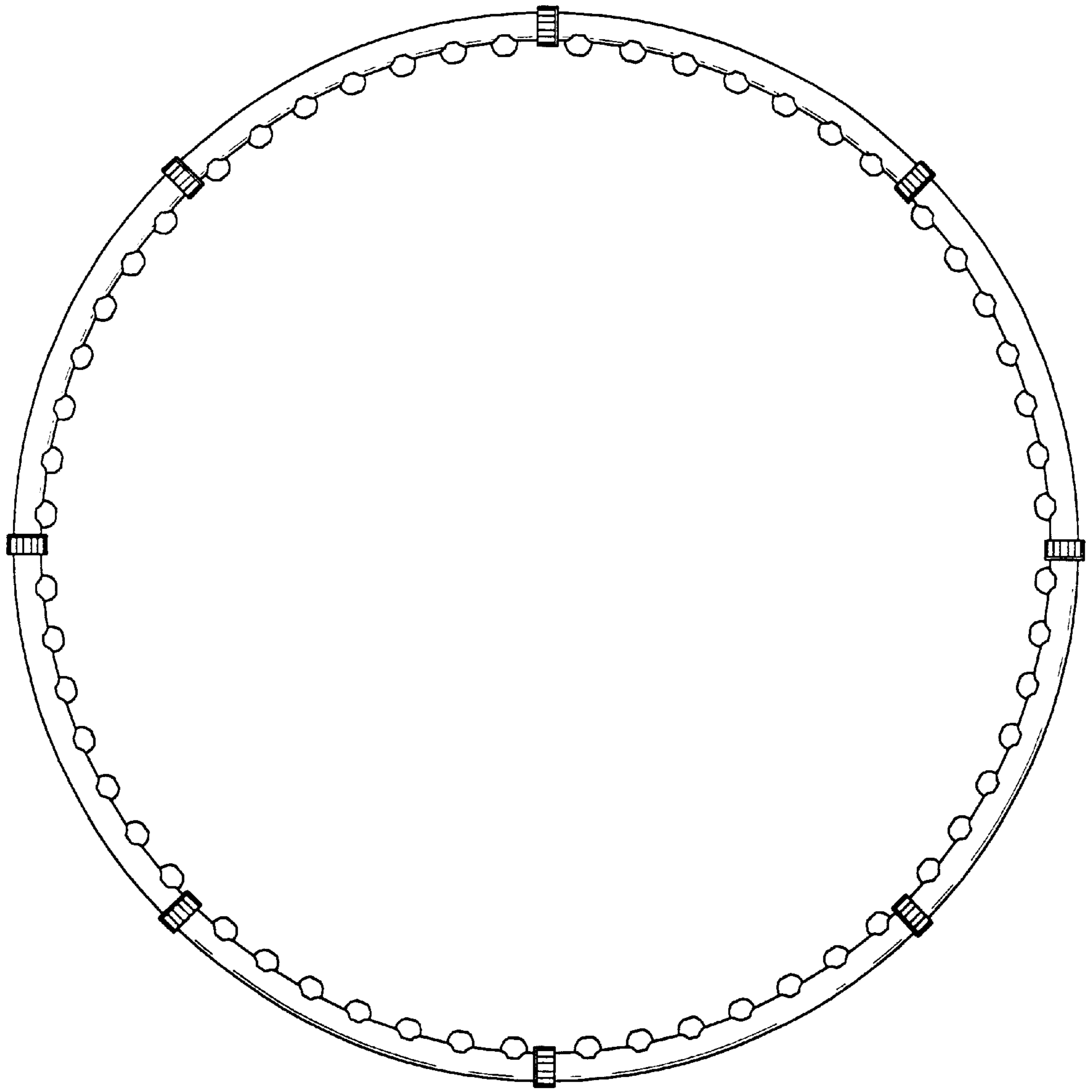
