(57) **CLAIM**

The ornamental design for a vertical dial stick case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a slim line dial stick heart shaped lipstick case showing the first embodiment of the invention;

FIG. 2 is a top view of the lipstick case of FIG. 1;

FIG. 3 is a bottom view of the lipstick case of FIG. 1;

FIG. 4 is a left side view of the lipstick case of FIG. 1;

FIG. 5 is a right side view of the lipstick case of FIG. 1; and,

FIG. 6 is a rear view of the lipstick case of FIG. 1;

FIG. 7 is a perspective view of a regular dial stick heart shaped lipstick case showing the second embodiment of the invention;

FIG. 8 is a top view of the lipstick case of FIG. 7;

FIG. 9 is a bottom view of the lipstick case of FIG. 7;

FIG. 10 is a left side view of the lipstick case of FIG. 7;

FIG. 11 is a right side view of the lipstick case of FIG. 7;

and,

FIG. 12 is a rear view of the lipstick case of FIG. 7;

FIG. 13 is a perspective view of a heart shaped foundation dial stick case showing the third embodiment of the invention;

FIG. 14 is a top view of the foundation case of FIG. 13;

FIG. 15 is a bottom view of the foundation case of FIG. 13;

FIG. 16 is a left side view of the foundation case of FIG. 13;

FIG. 17 is a right side view of the foundation case of FIG. 13; and,

FIG. 18 is a rear view of the foundation case of FIG. 13;

FIG. 19 is a perspective view of a slim line dial stick curved heart shaped lipstick case showing the fourth embodiment of the invention;

FIG. 20 is a top view of the lipstick case of FIG. 19;

FIG. 21 is a bottom view of the lipstick case of FIG. 19;

FIG. 22 is a left side view of the lipstick case of FIG. 19;

FIG. 23 is a right side view of the lipstick case of FIG. 19; and,

FIG. 24 is a rear view of the lipstick case of FIG. 19;

FIG. 25 is a perspective view of a regular dial stick curved heart shaped lipstick case showing the fifth embodiment of the invention;

FIG. 26 is a top view of the lipstick case of FIG. 25;

FIG. 27 is a bottom view of the lipstick case of FIG. 25;

FIG. 28 is a left side view of the lipstick case of FIG. 25;

FIG. 29 is a right side view of the lipstick case of FIG. 25; and,

FIG. 30 is a rear view of the lipstick case of FIG. 25;

FIG. 31 is a perspective view of a curved heart shaped foundation dial stick case showing the sixth embodiment of the invention;

FIG. 32 is a top view of the foundation case of FIG. 31;

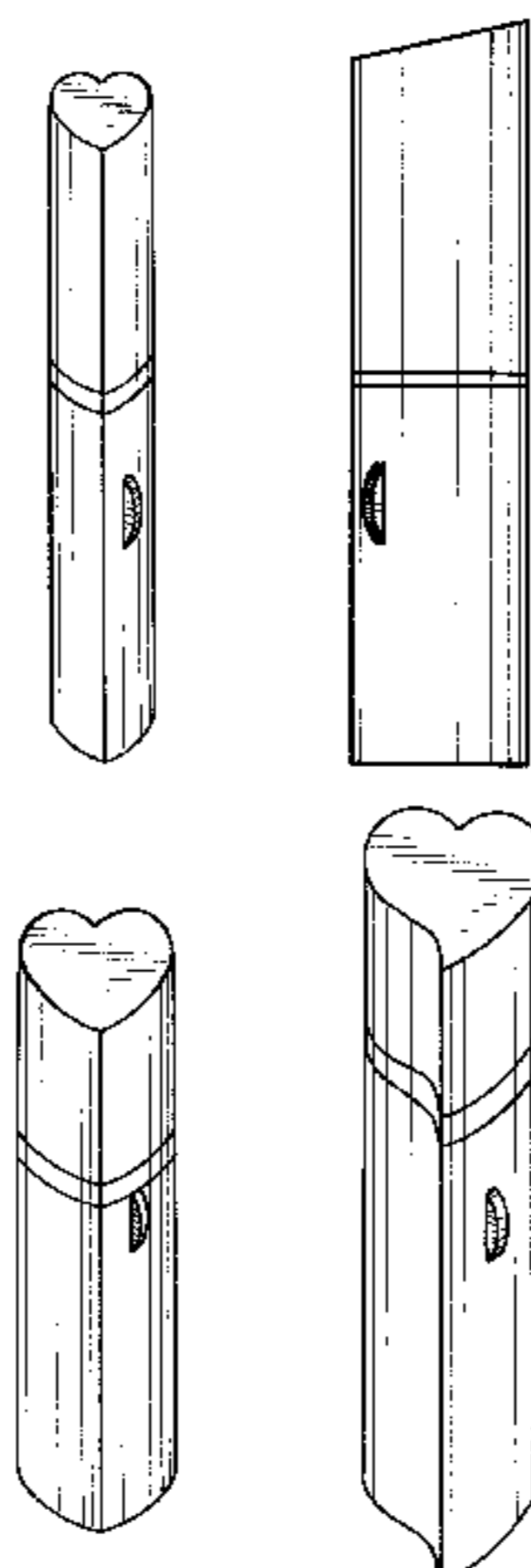
FIG. 33 is a bottom view of the foundation case of FIG. 31;

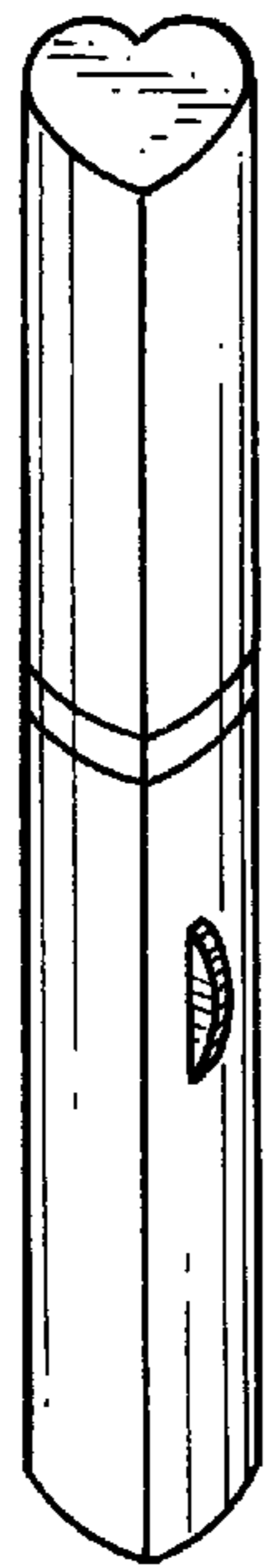

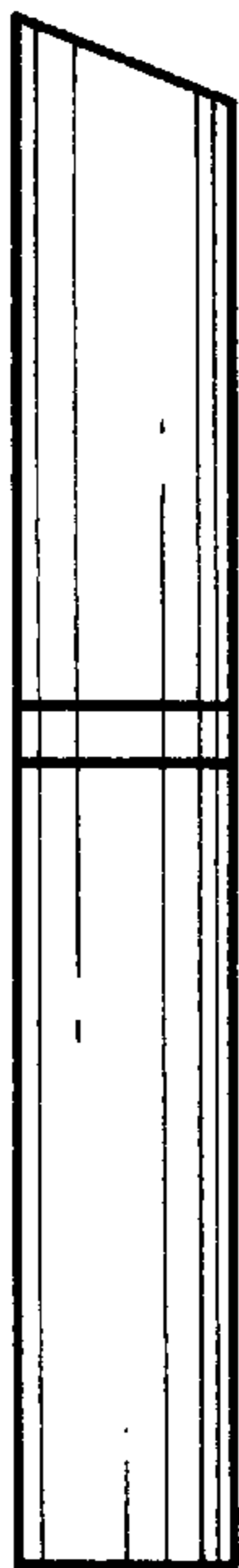

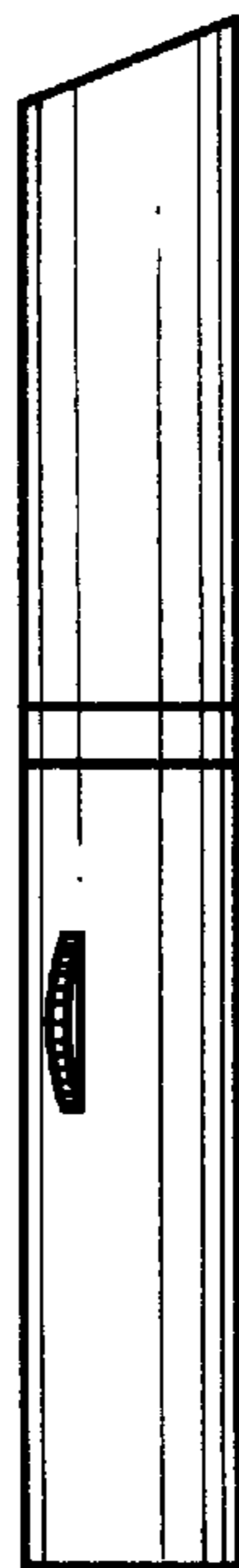

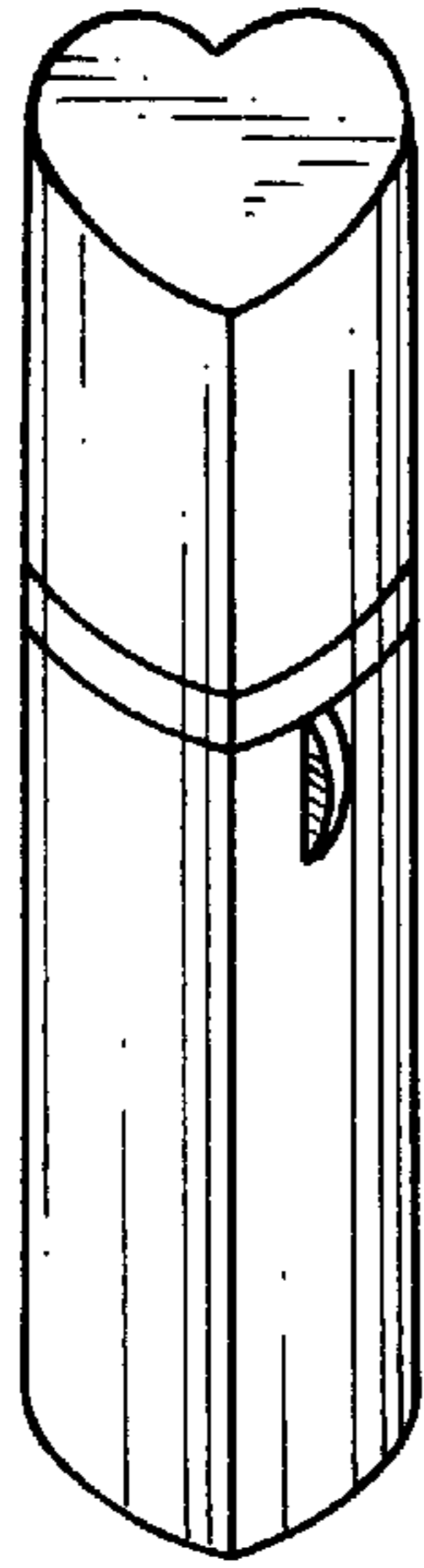

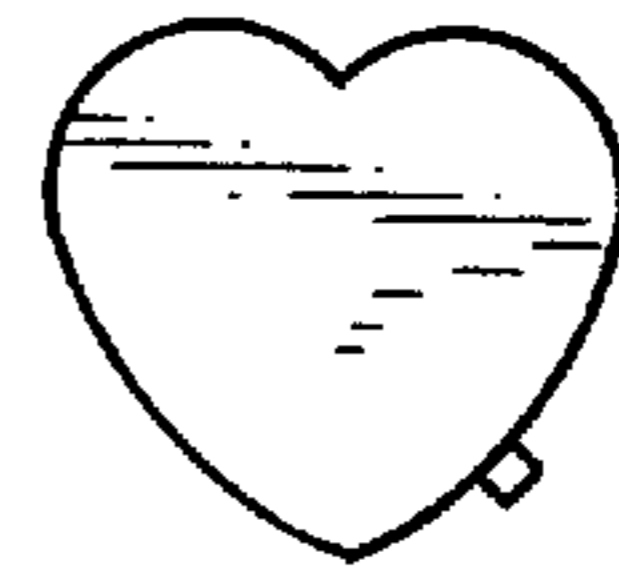

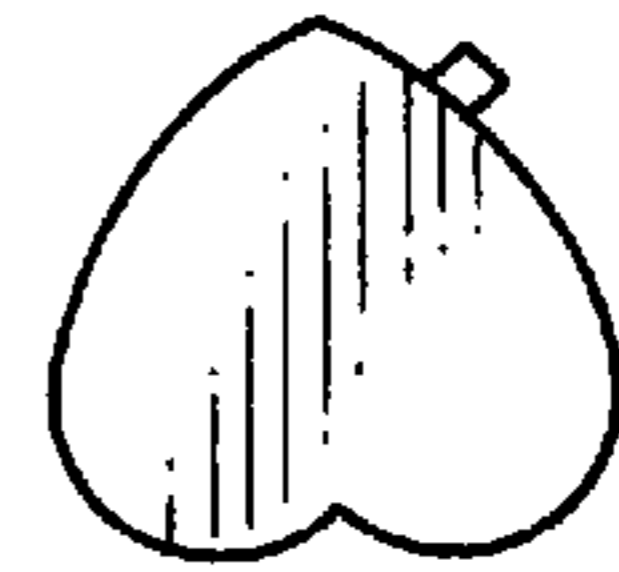

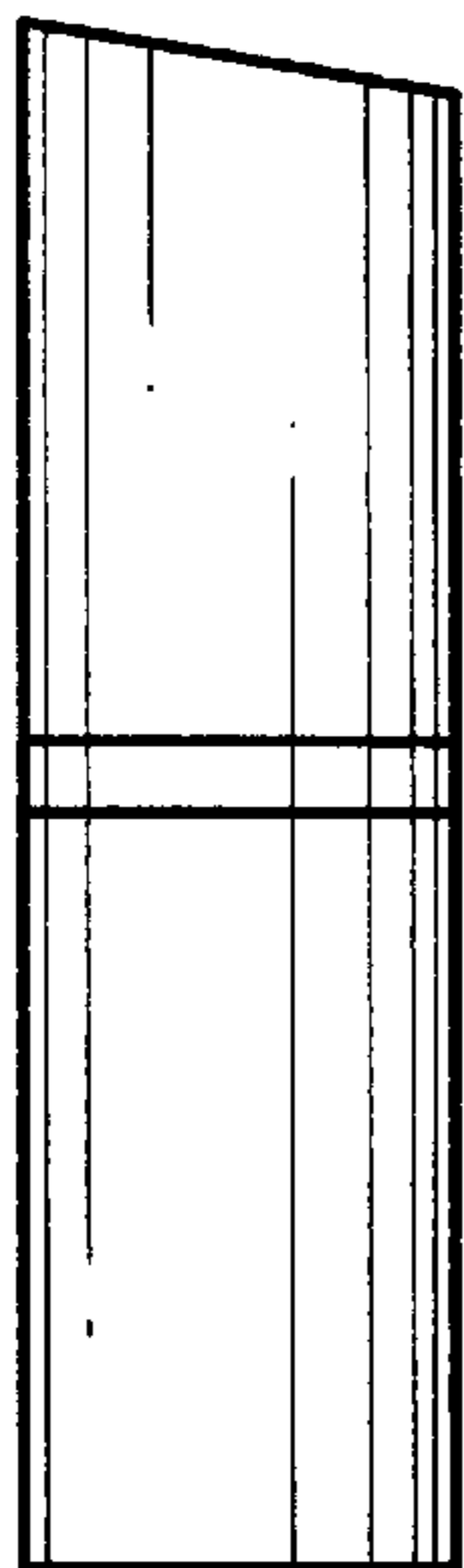

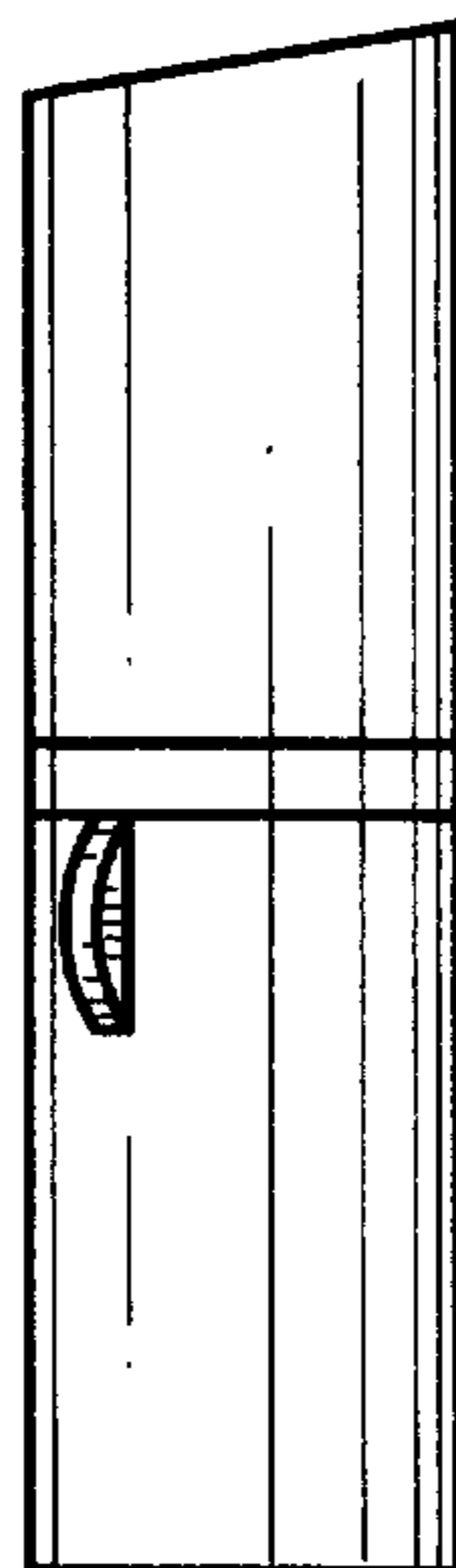

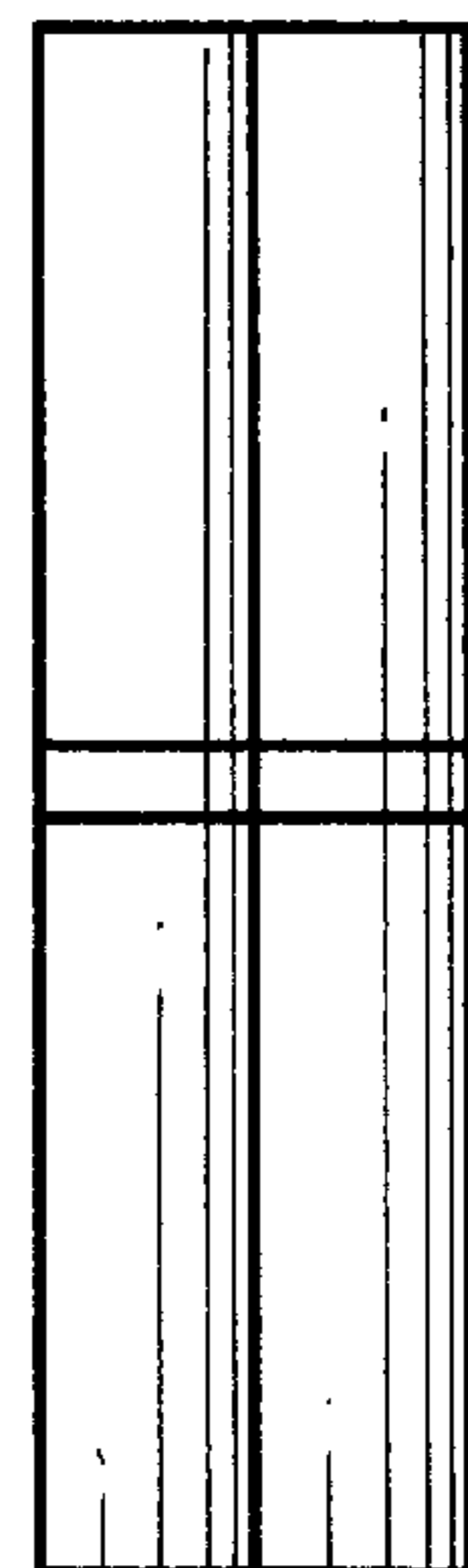

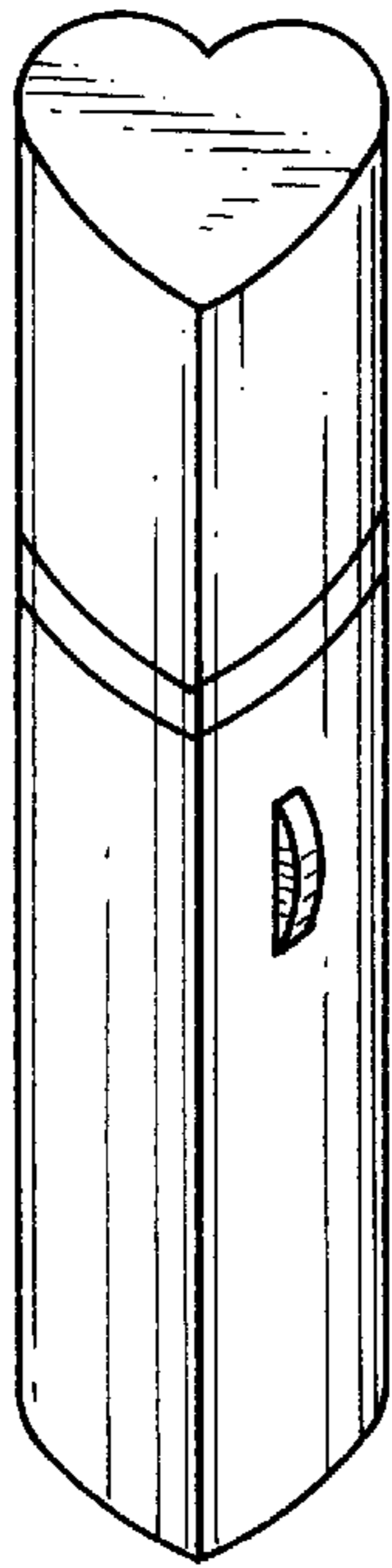

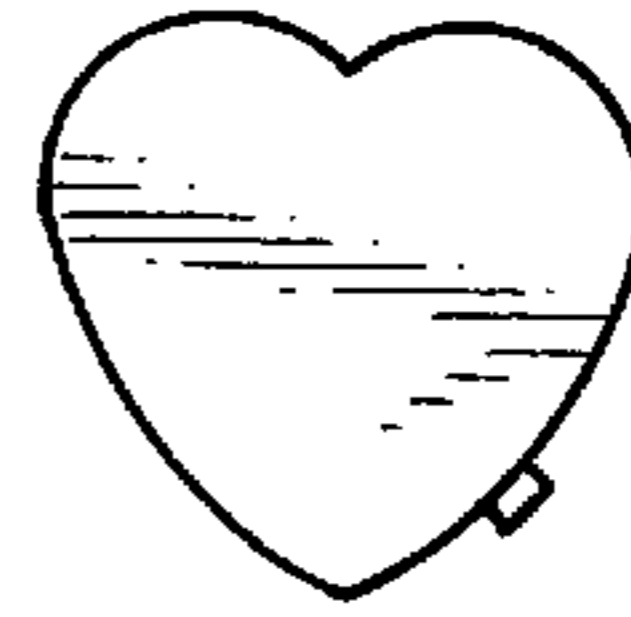

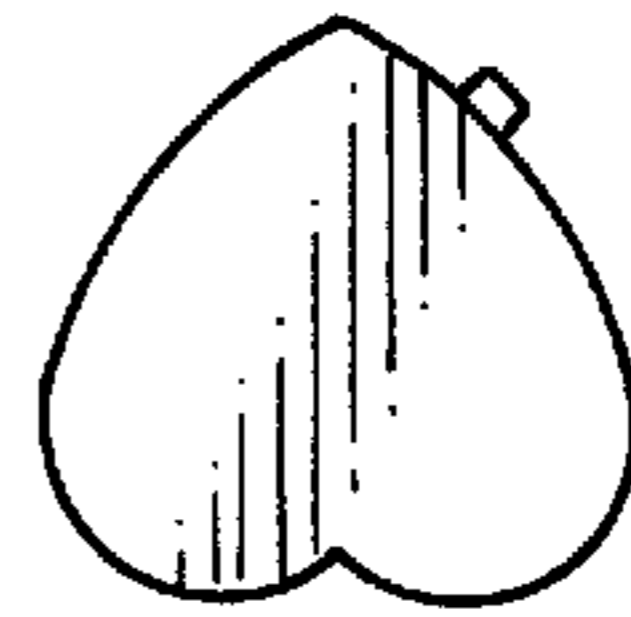

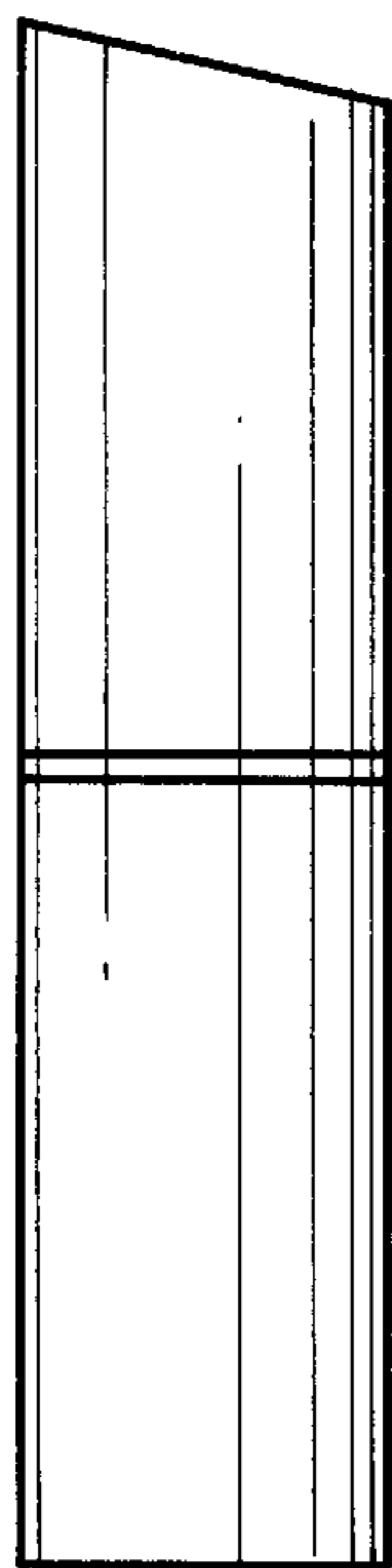

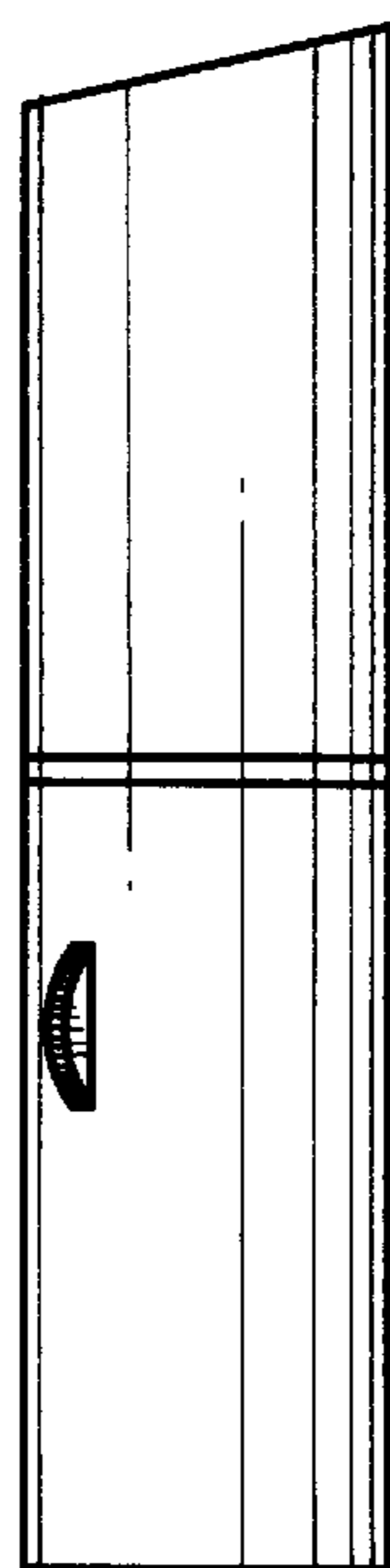

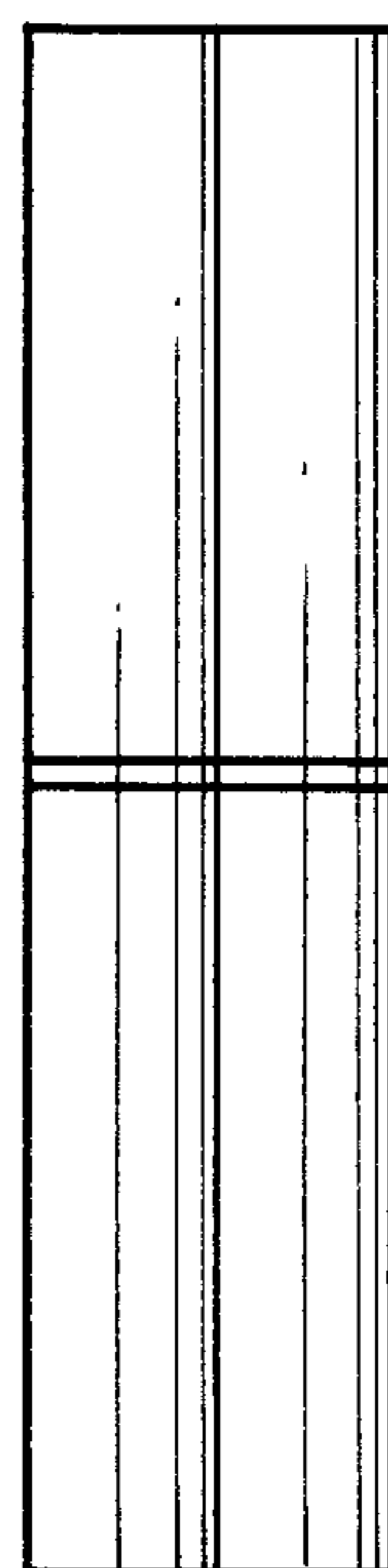

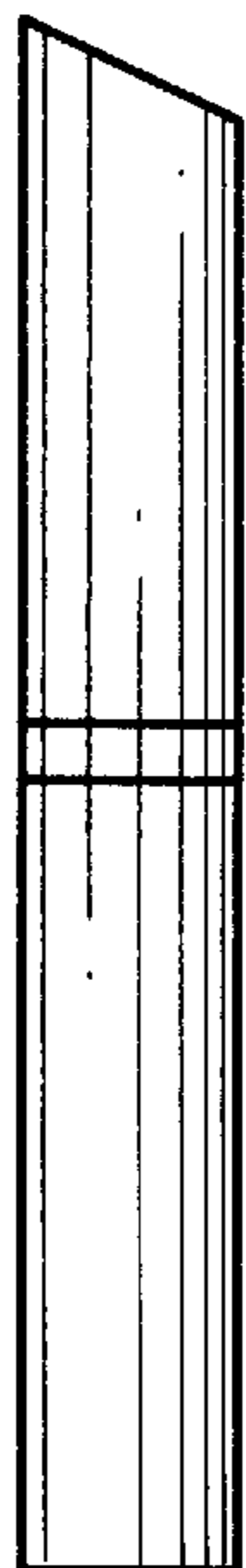

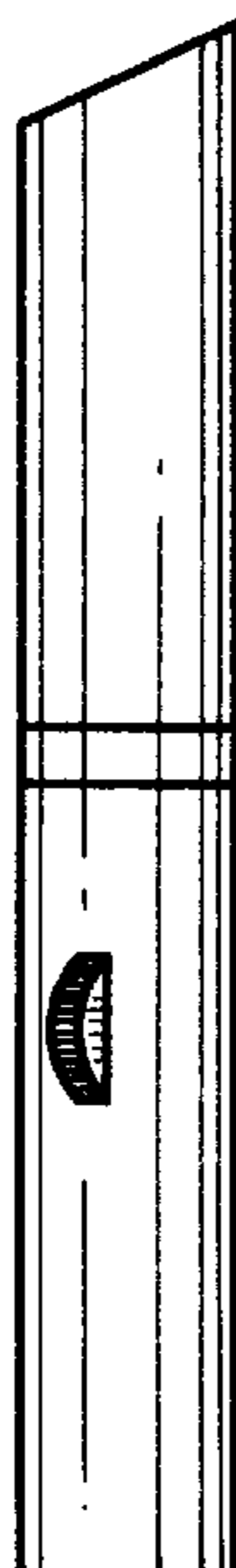

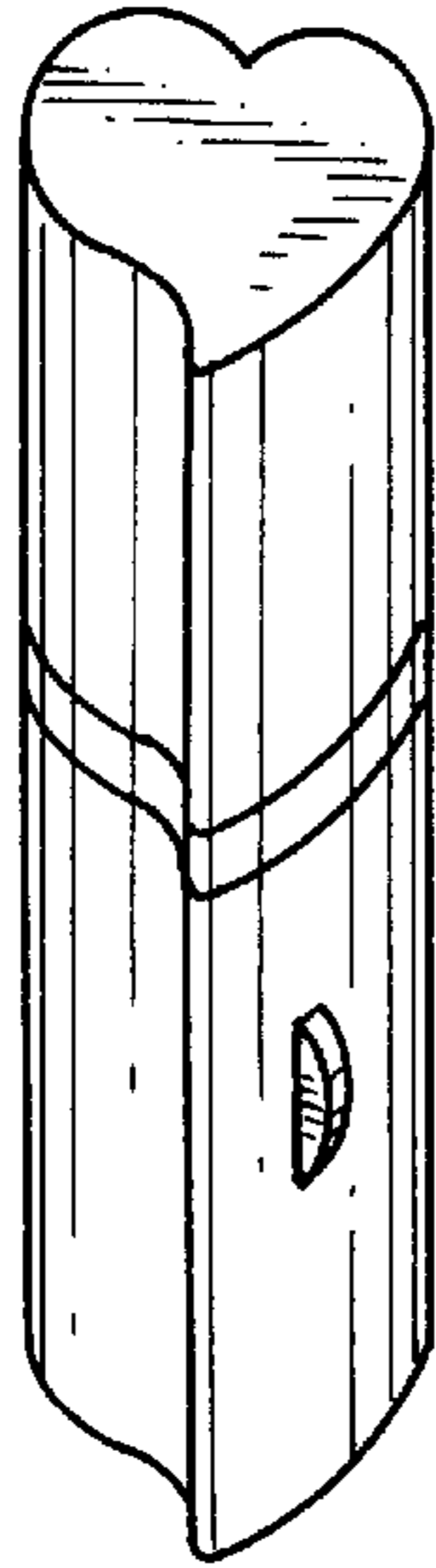

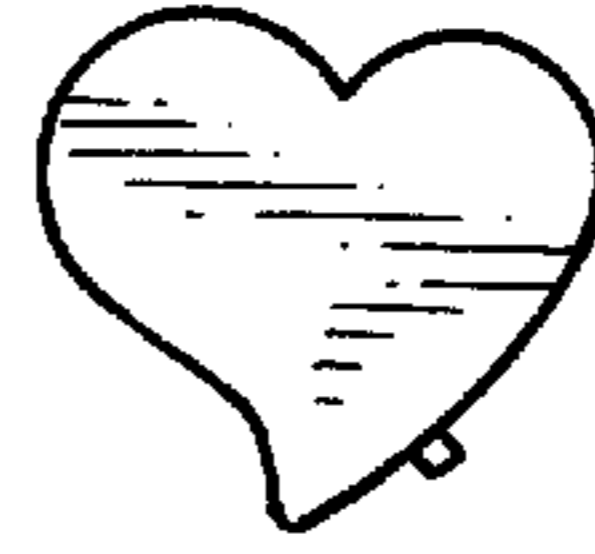

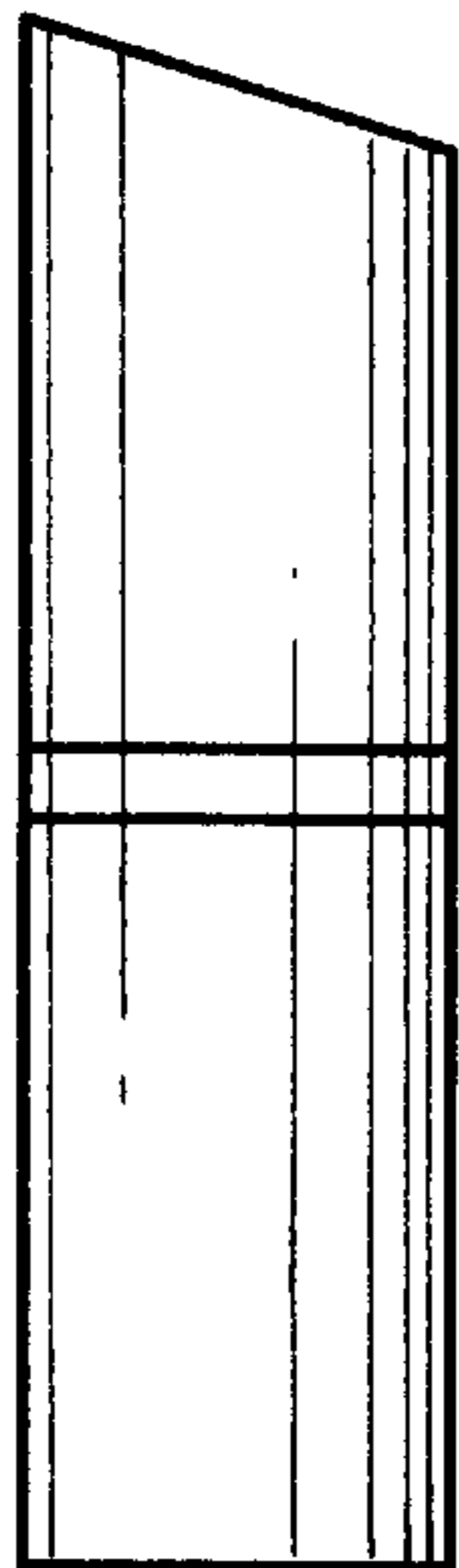

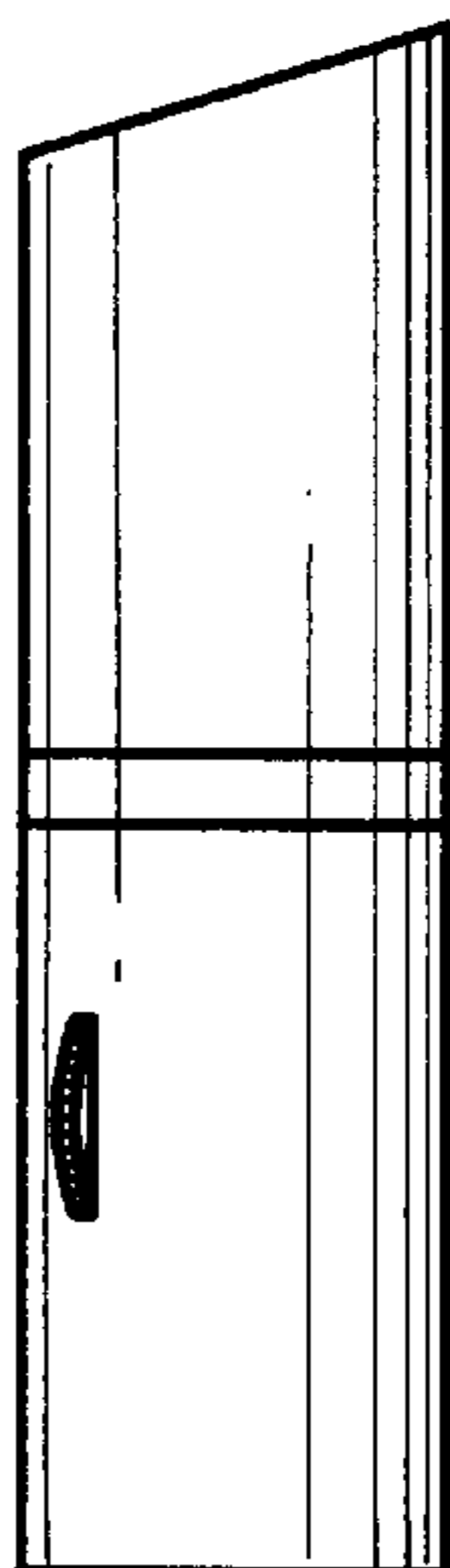

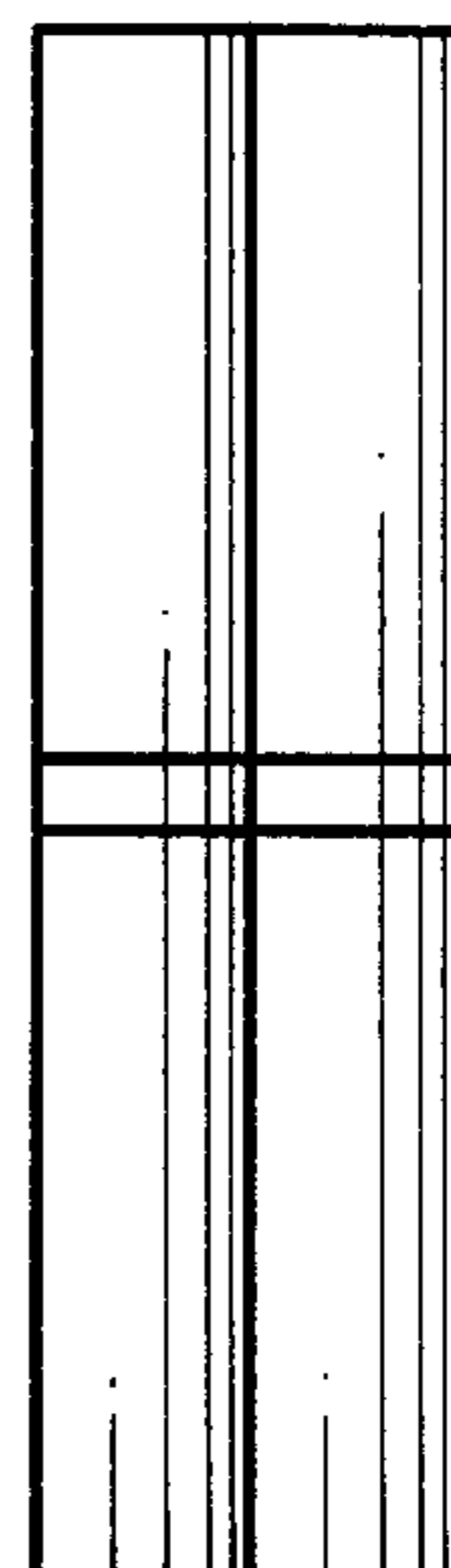

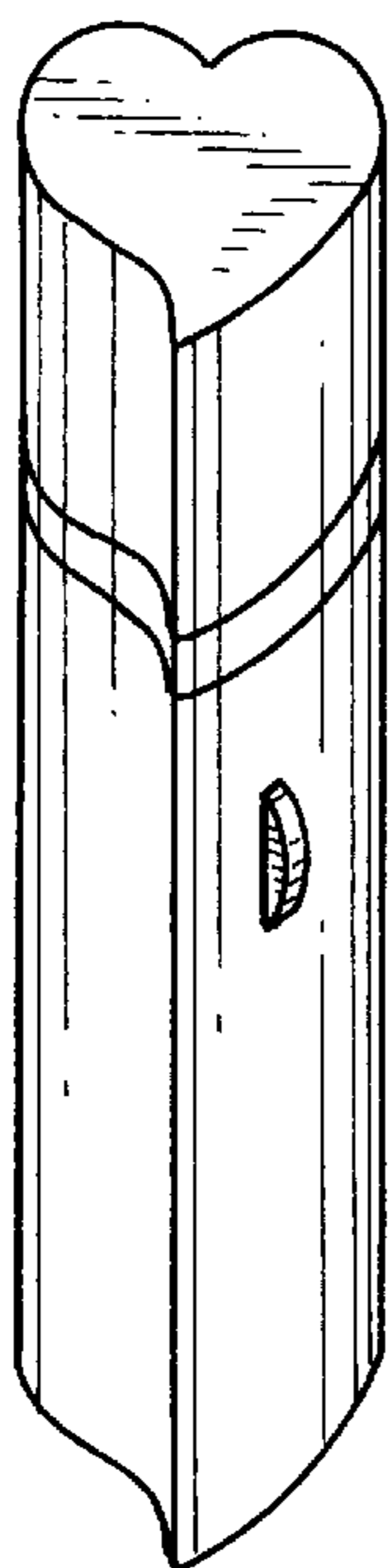

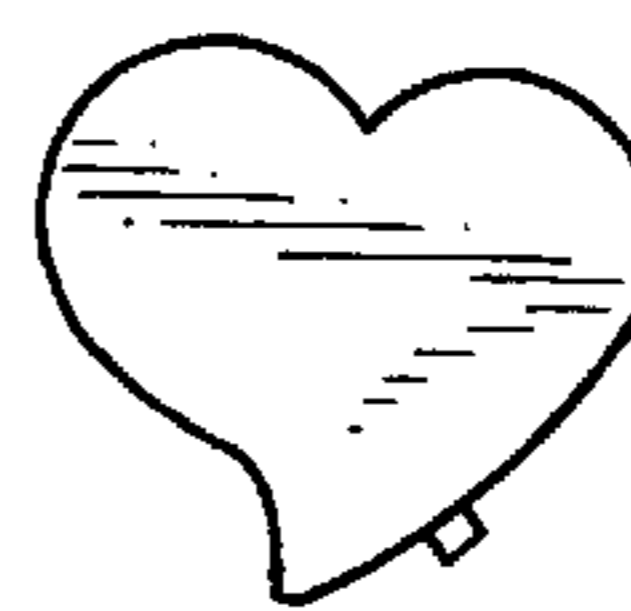

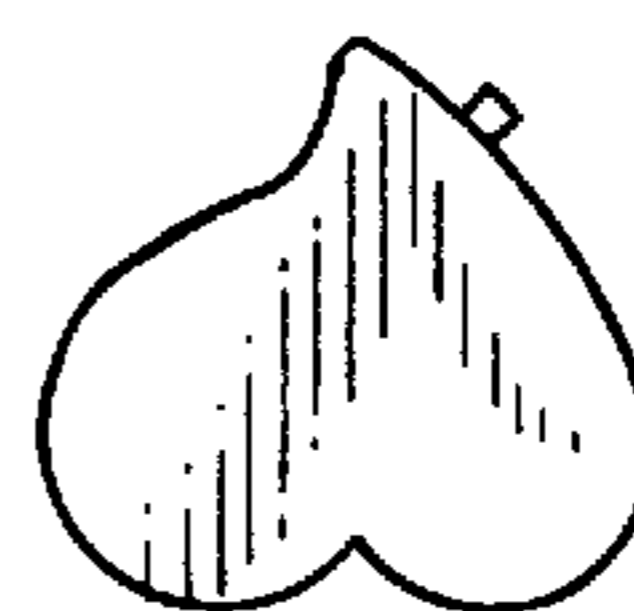

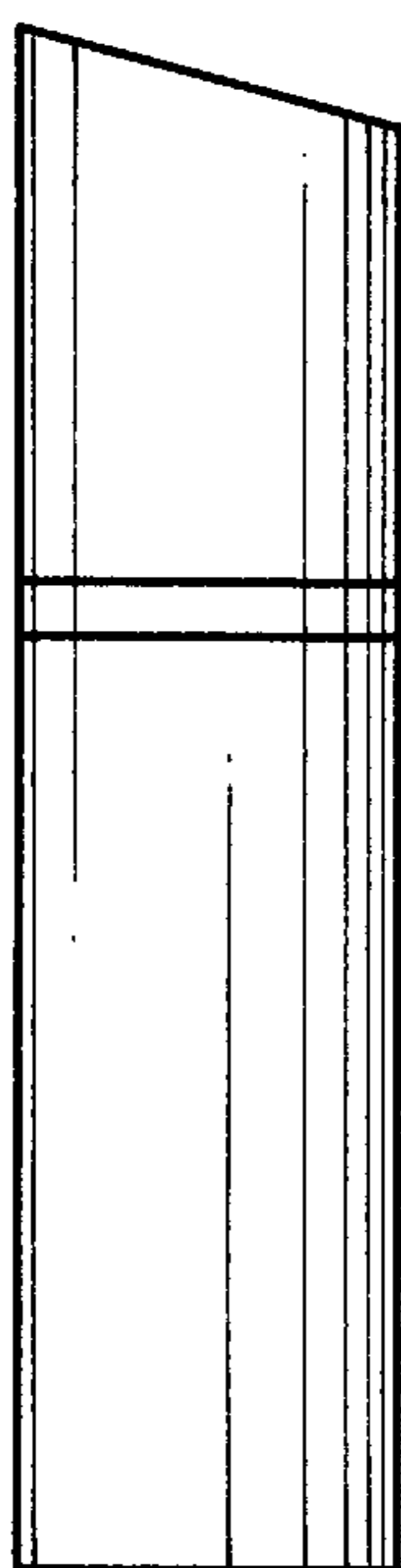

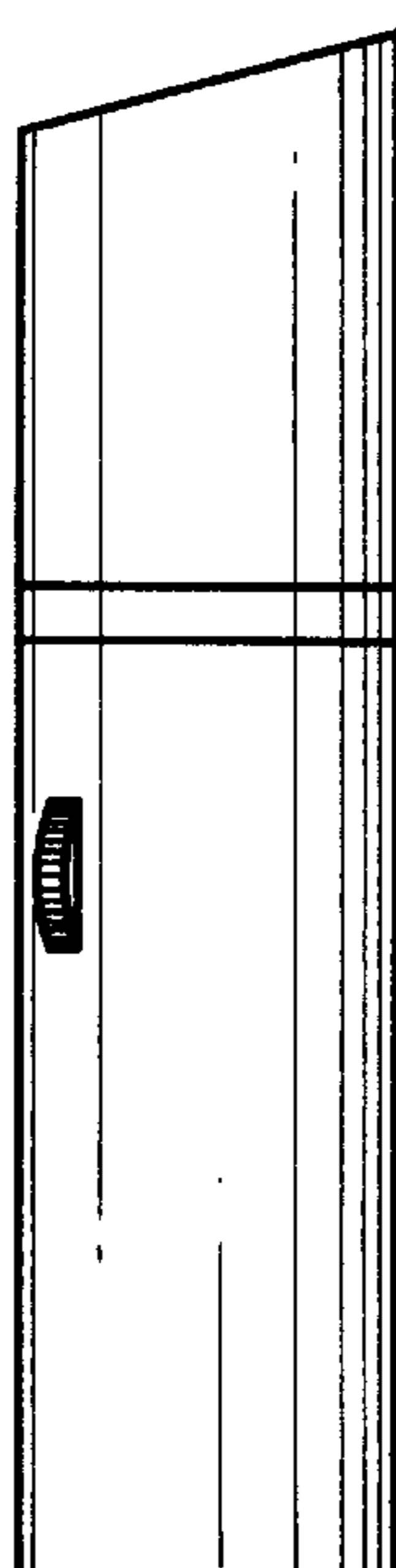

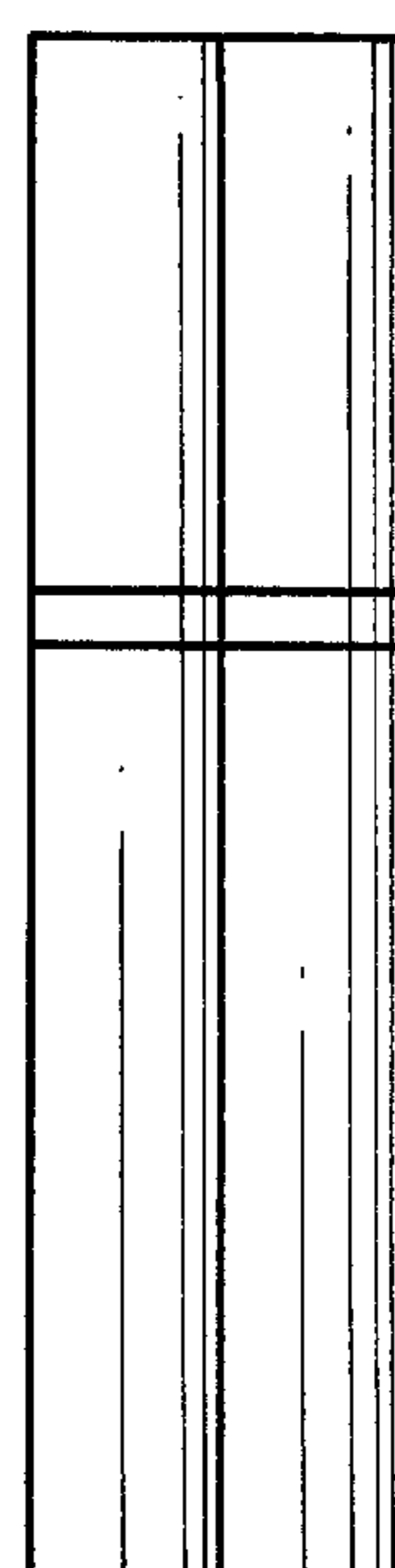
