**DESCRIPTION**

FIG. 1 is a front perspective view of the glider showing our new design;

FIG. 2 is an end elevational view, the other end elevational view is a mirror image;

FIG. 3 is a front elevational view;

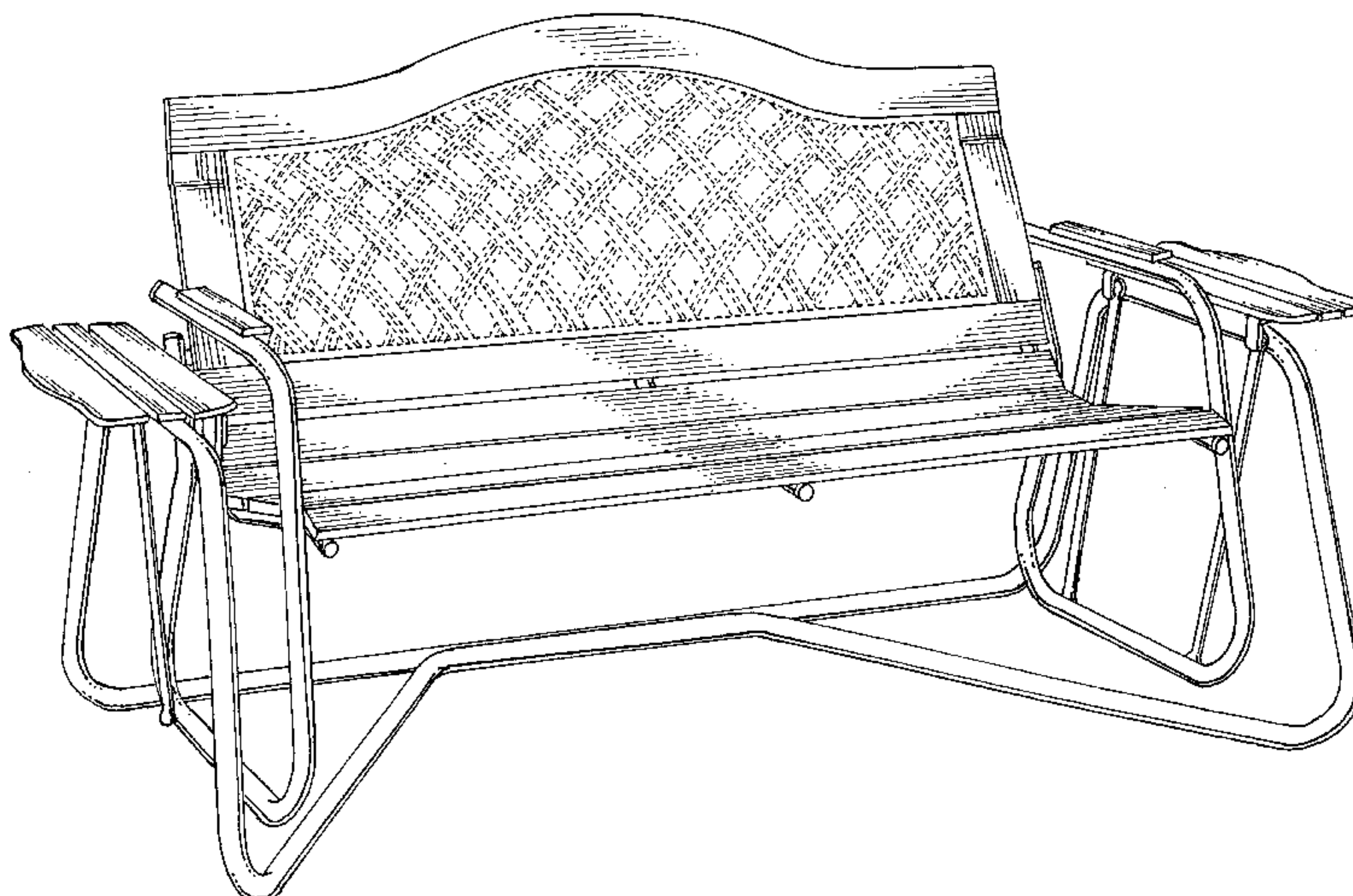
FIG. 4 is a rear elevational view;

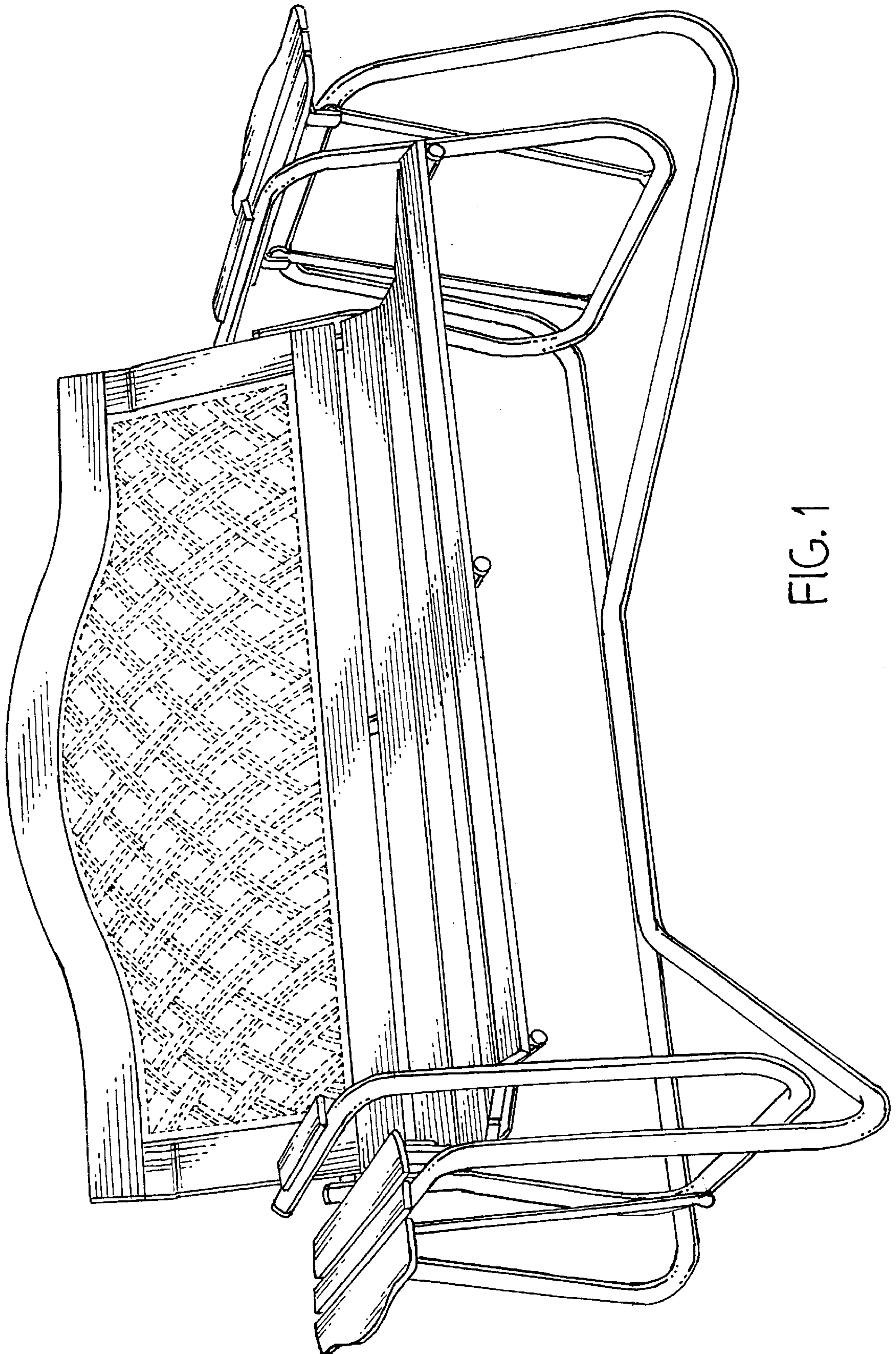

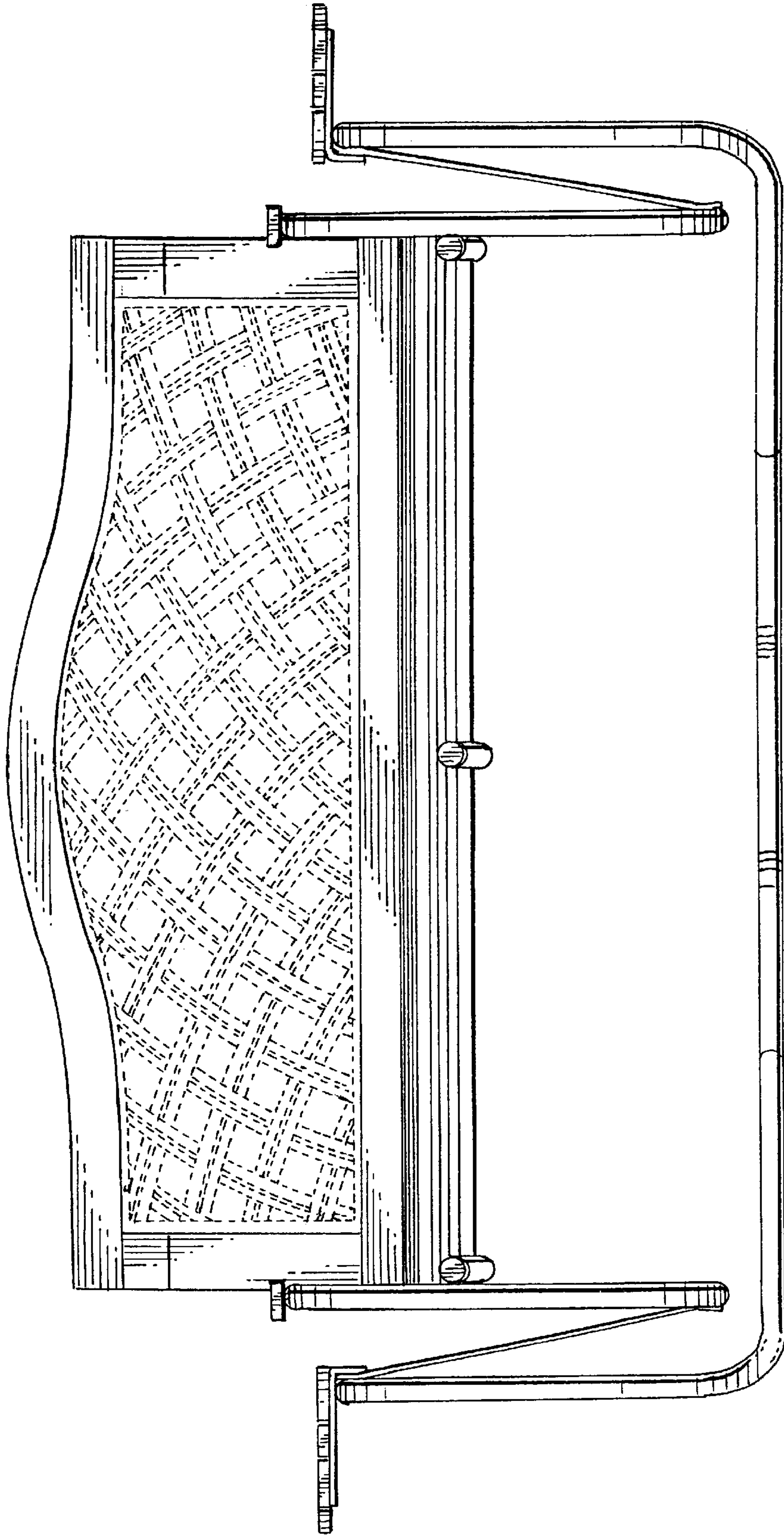

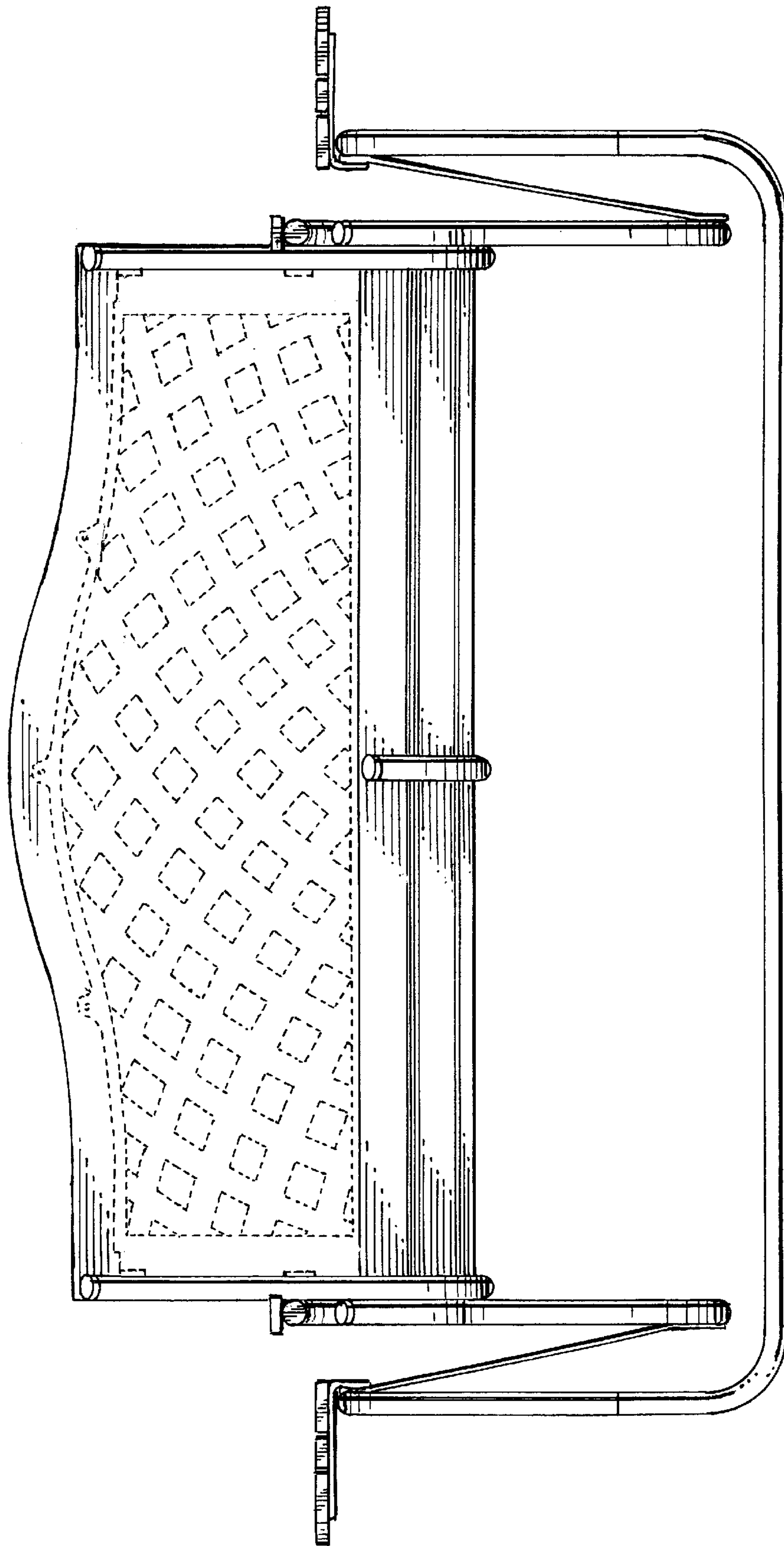

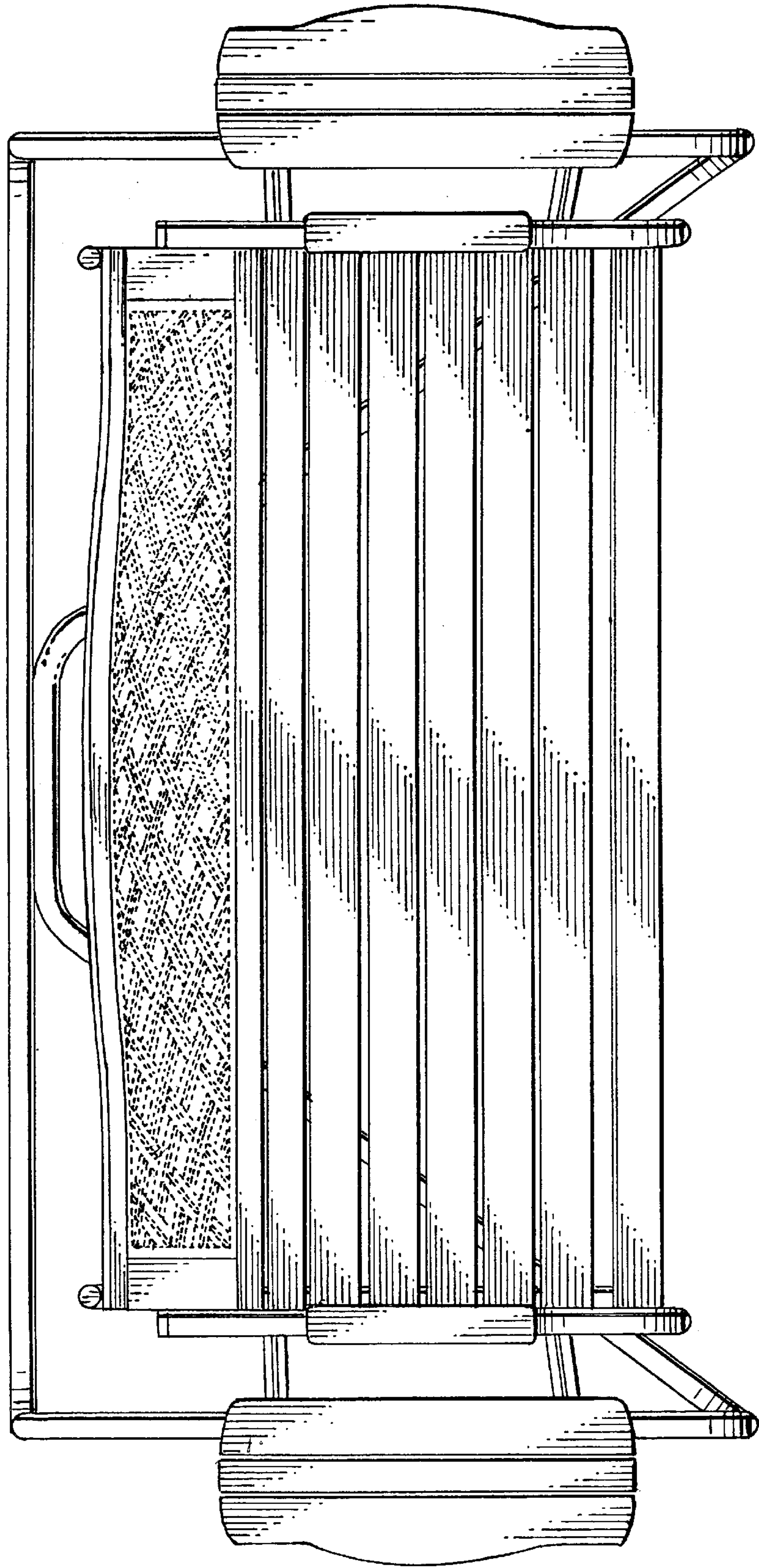

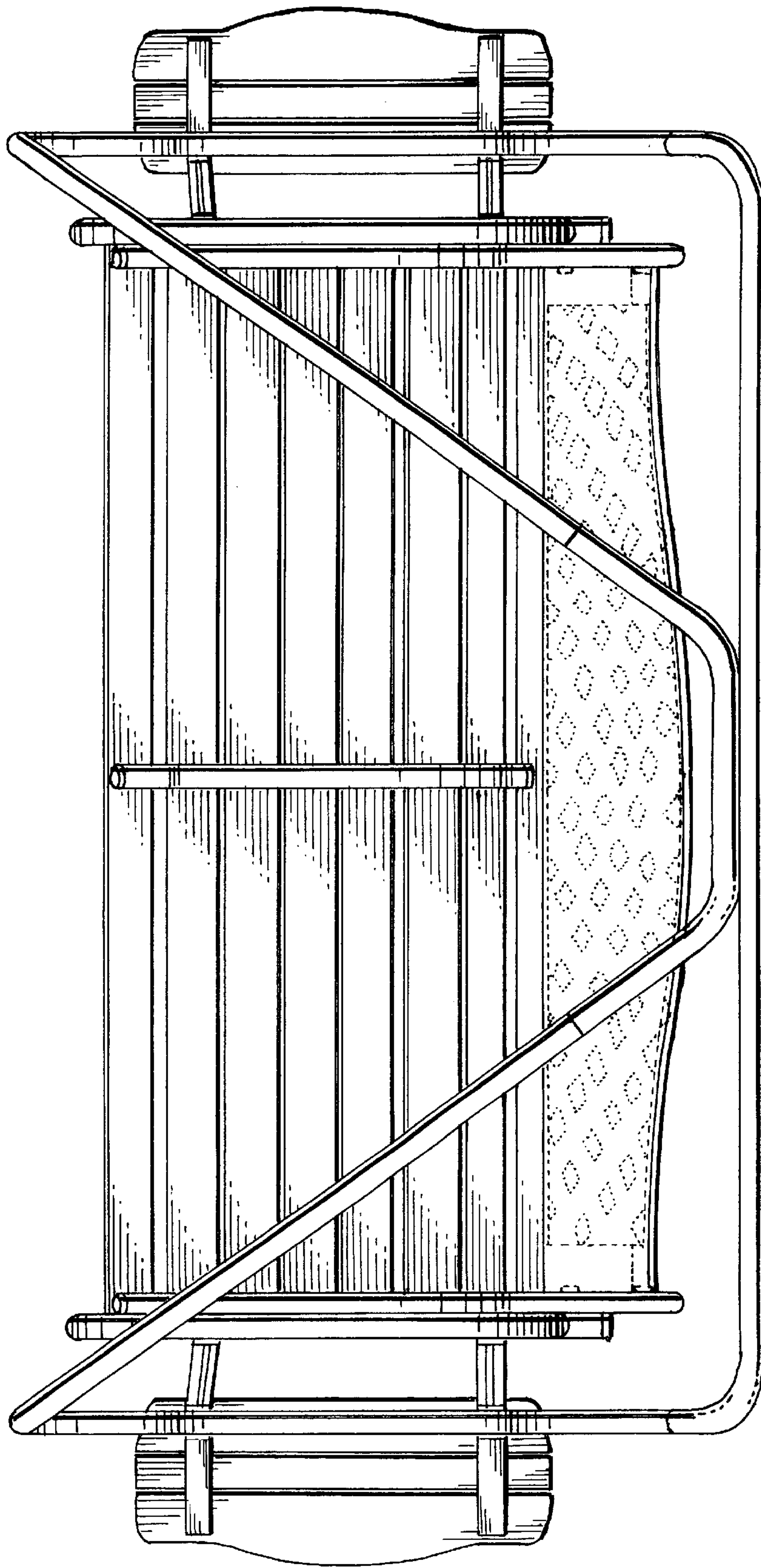
