DESCRIPTION

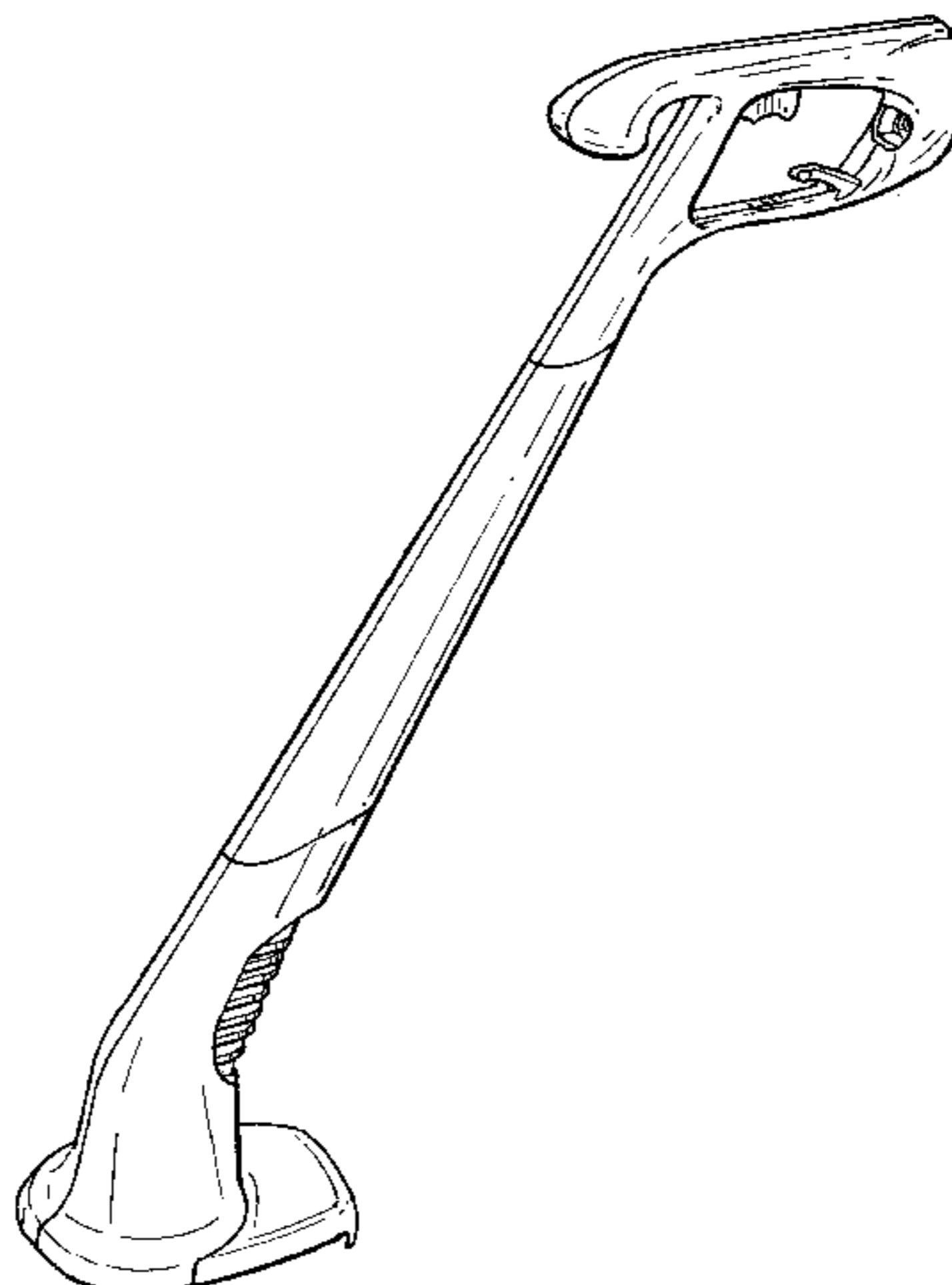
FIG. 1 is a perspective view of a vegetation trimmer according to the present invention; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken line showing of the cutting head in FIGS. 2-5 and 7 is for illustrative purposes only and forms no part of the claimed invention.

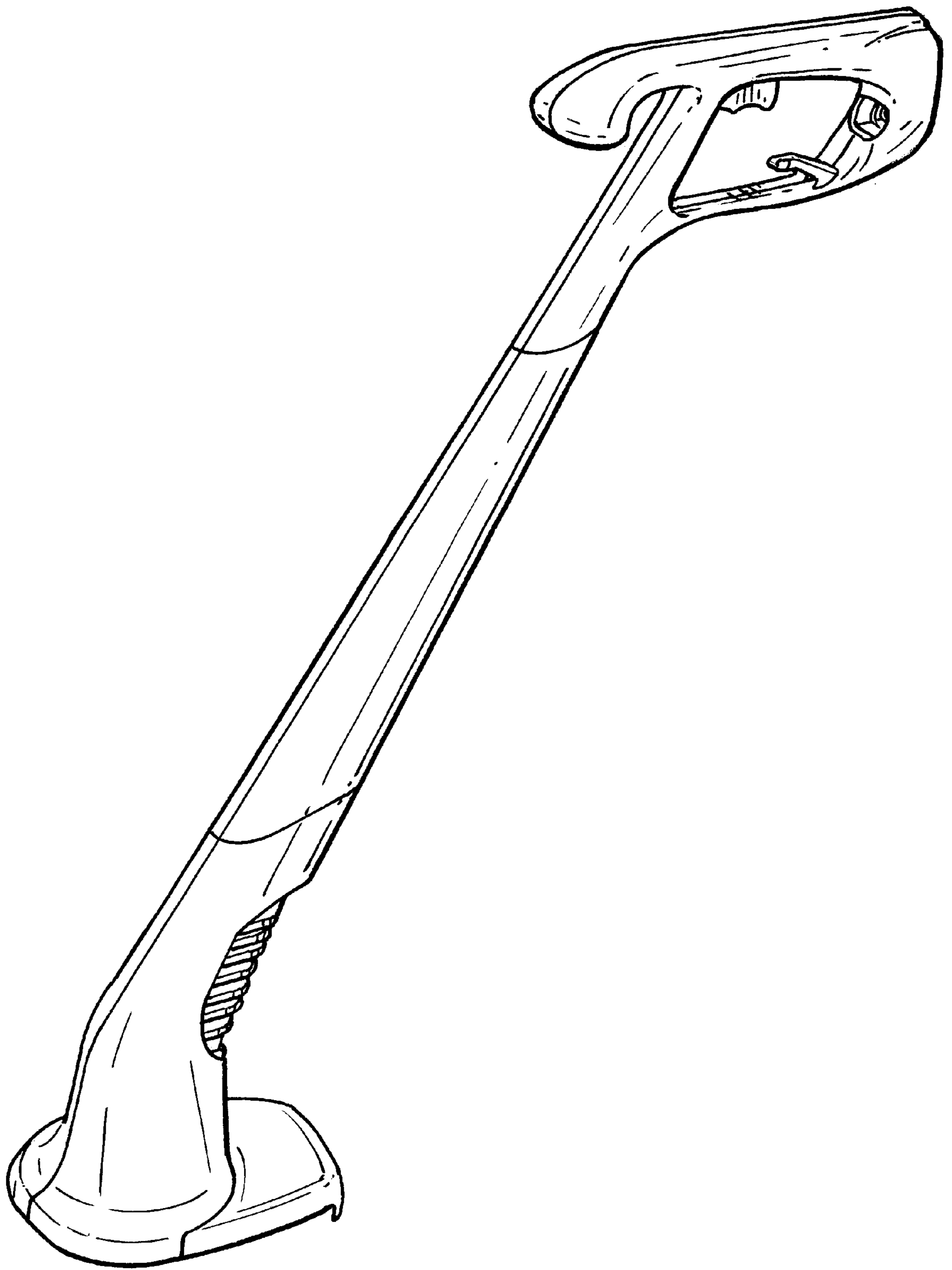

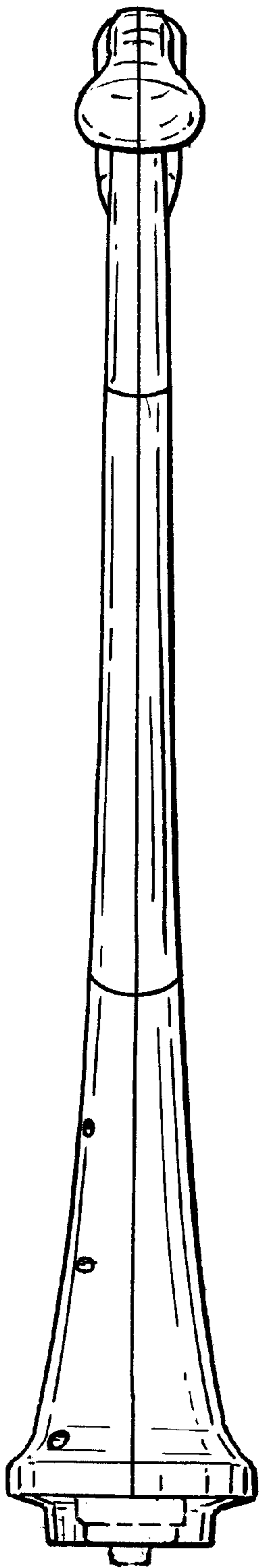

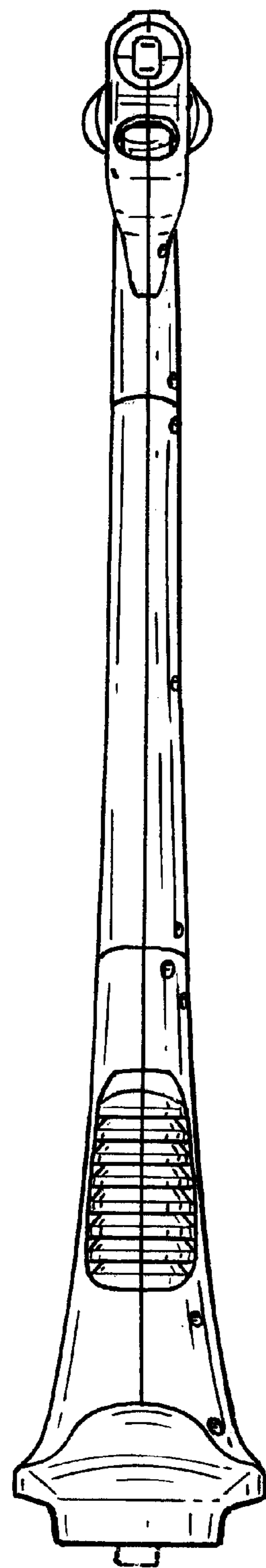

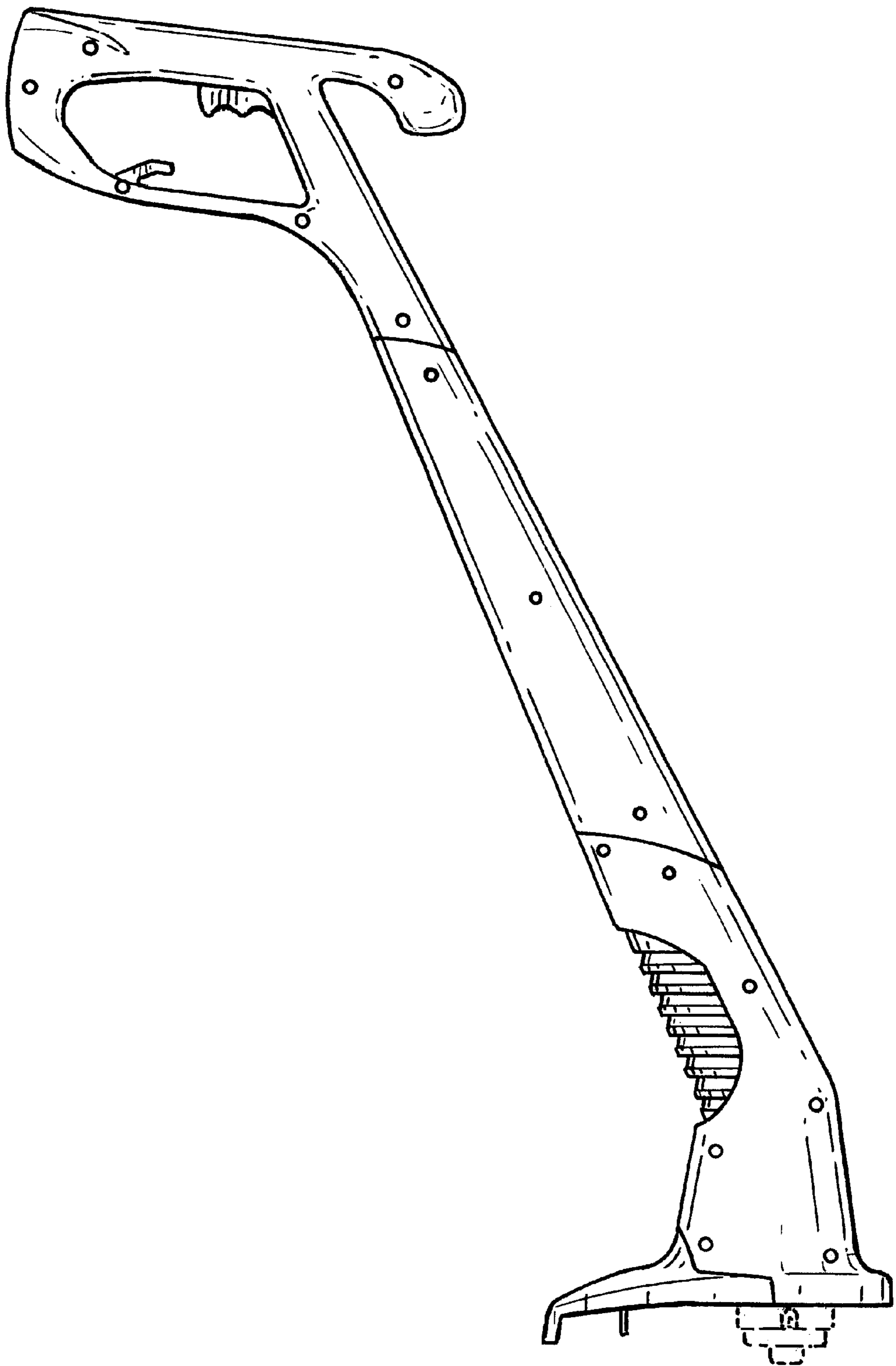

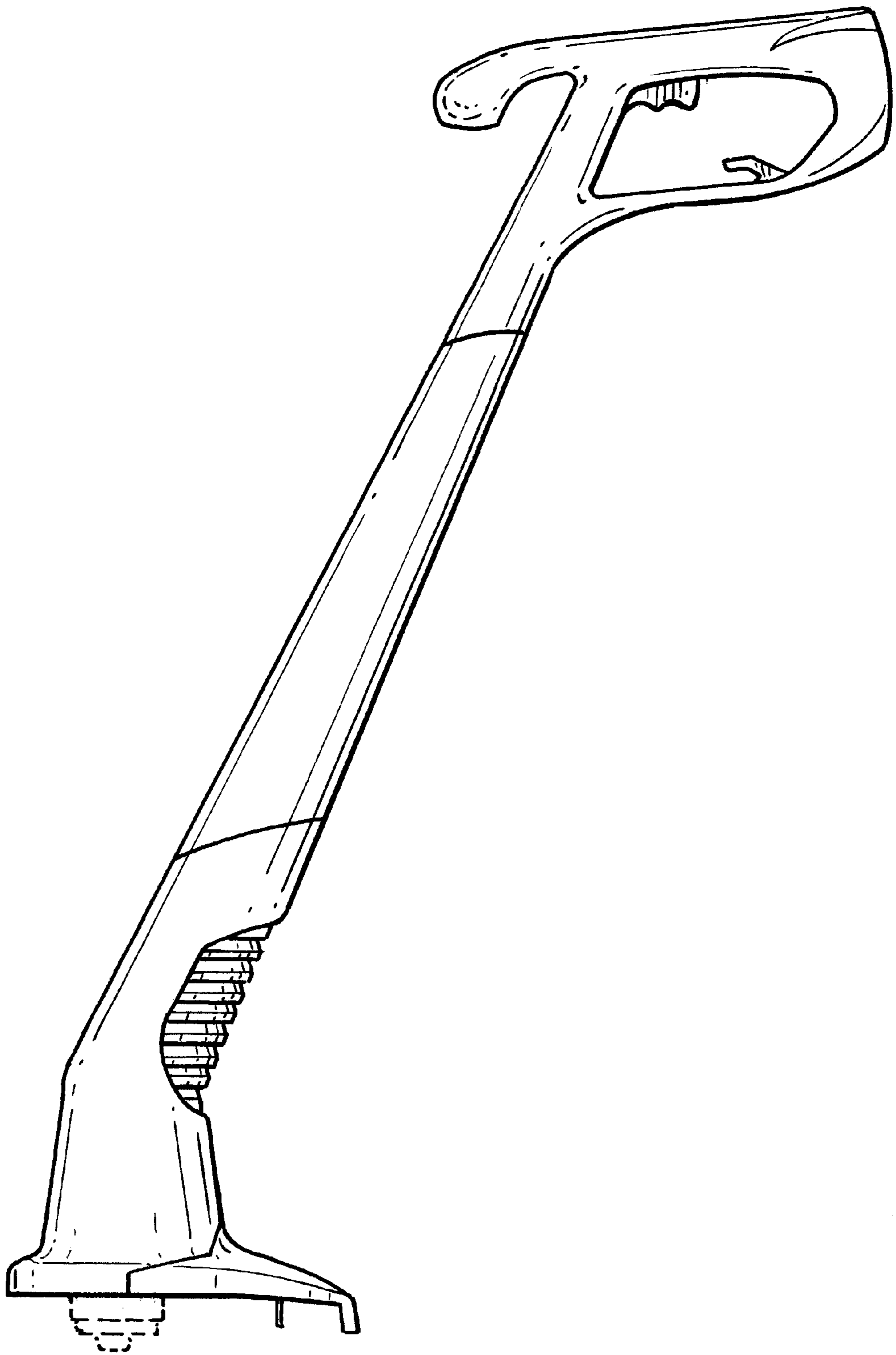

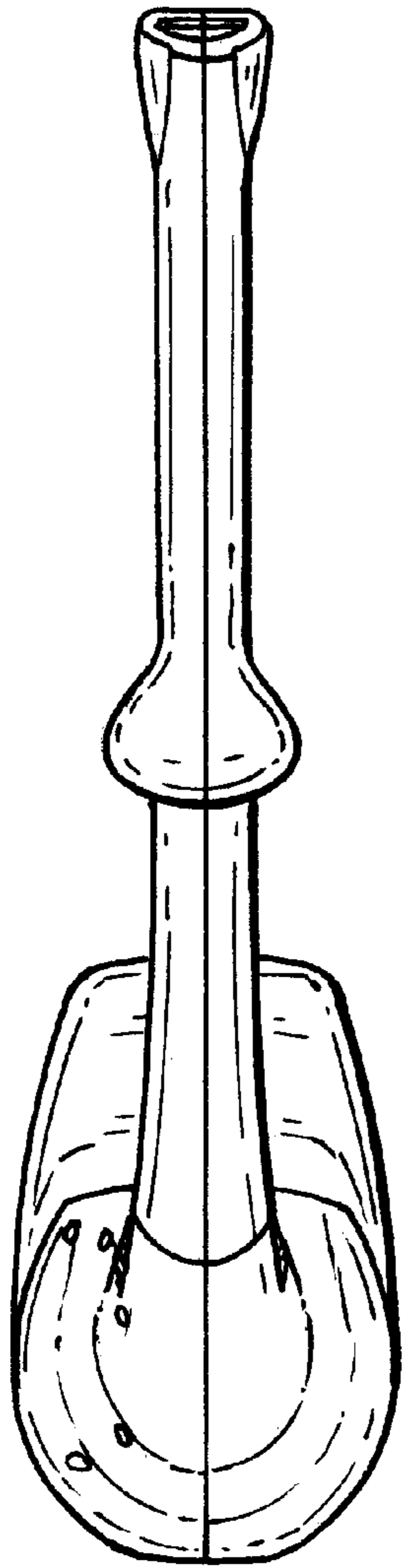

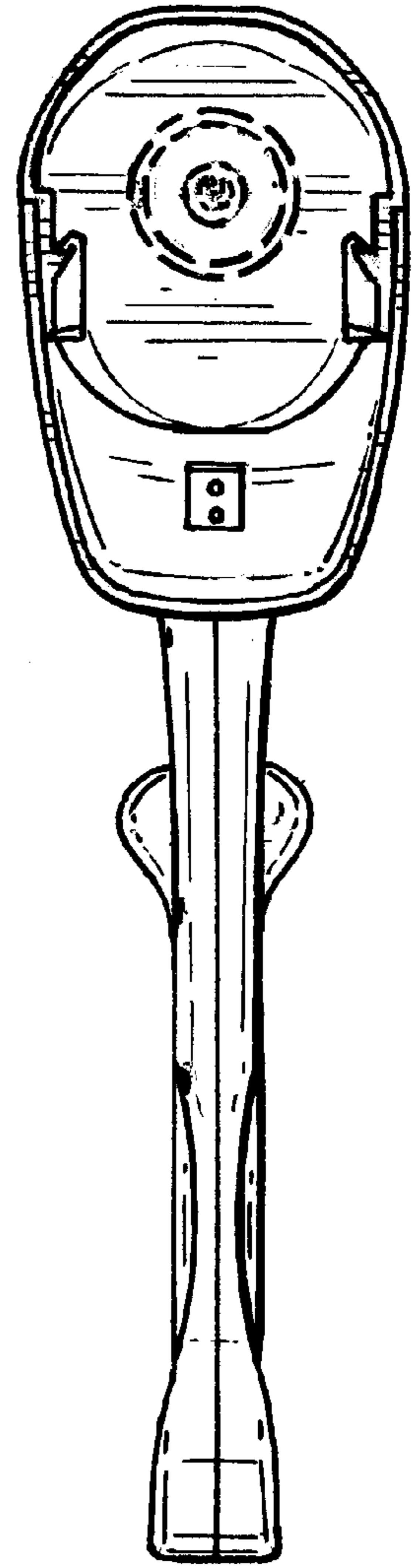
