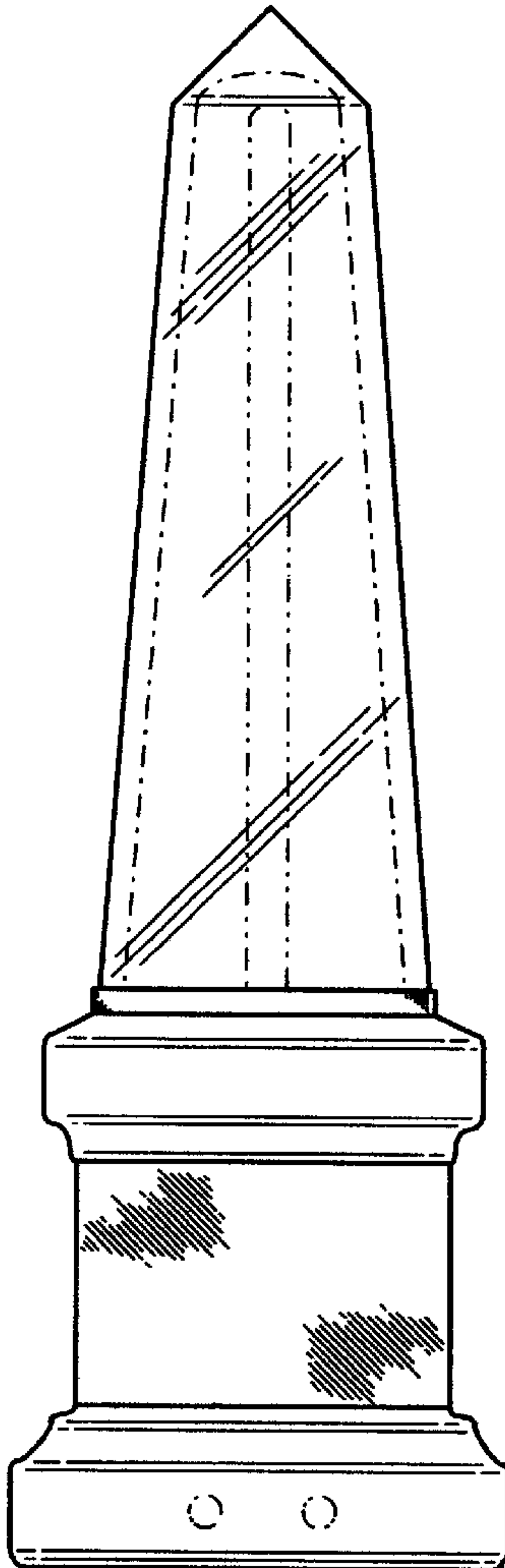
FIG. 1 is a front view of the obelisk plasma display;

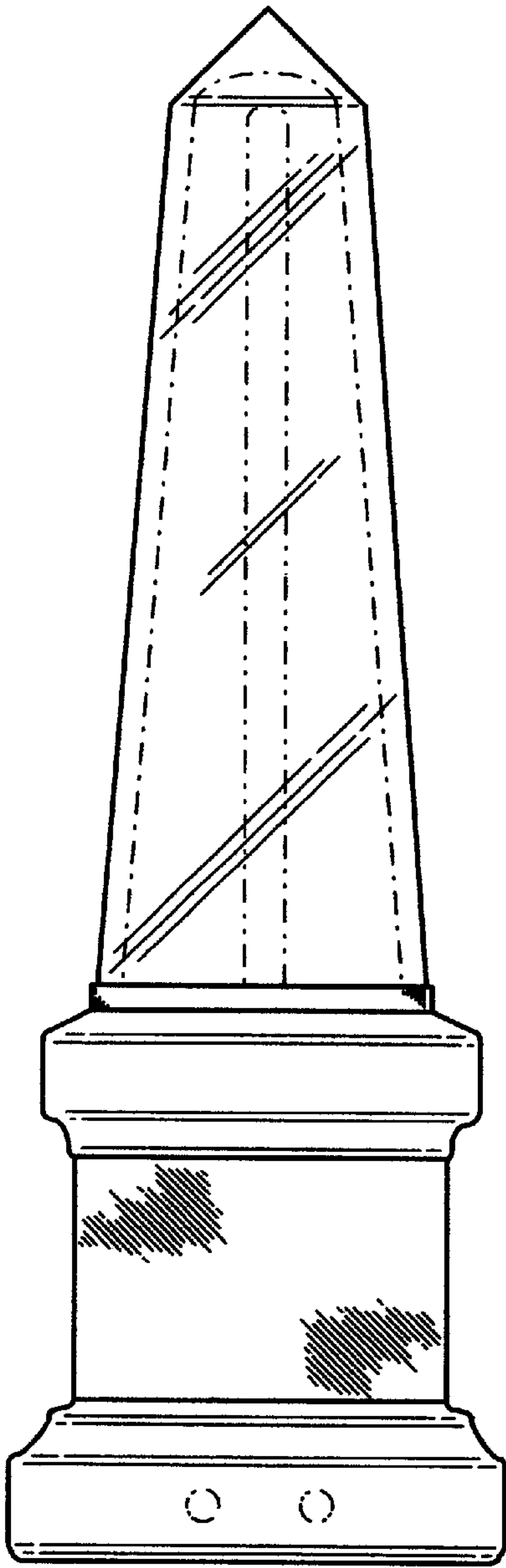

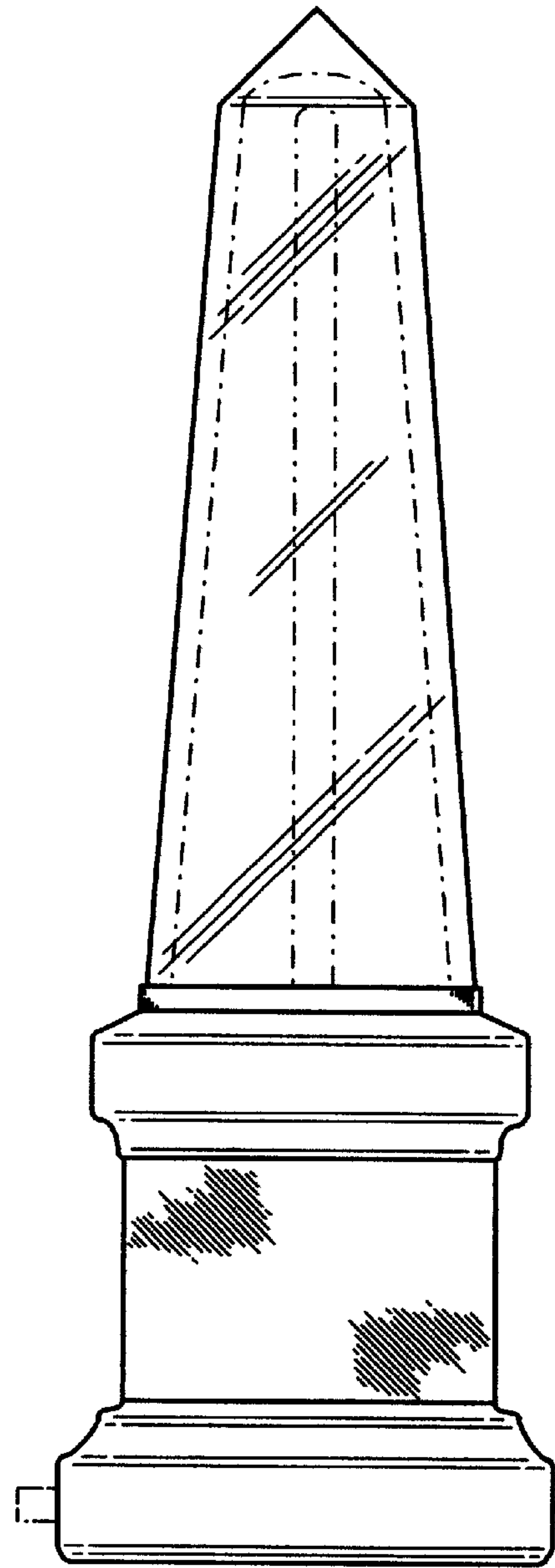

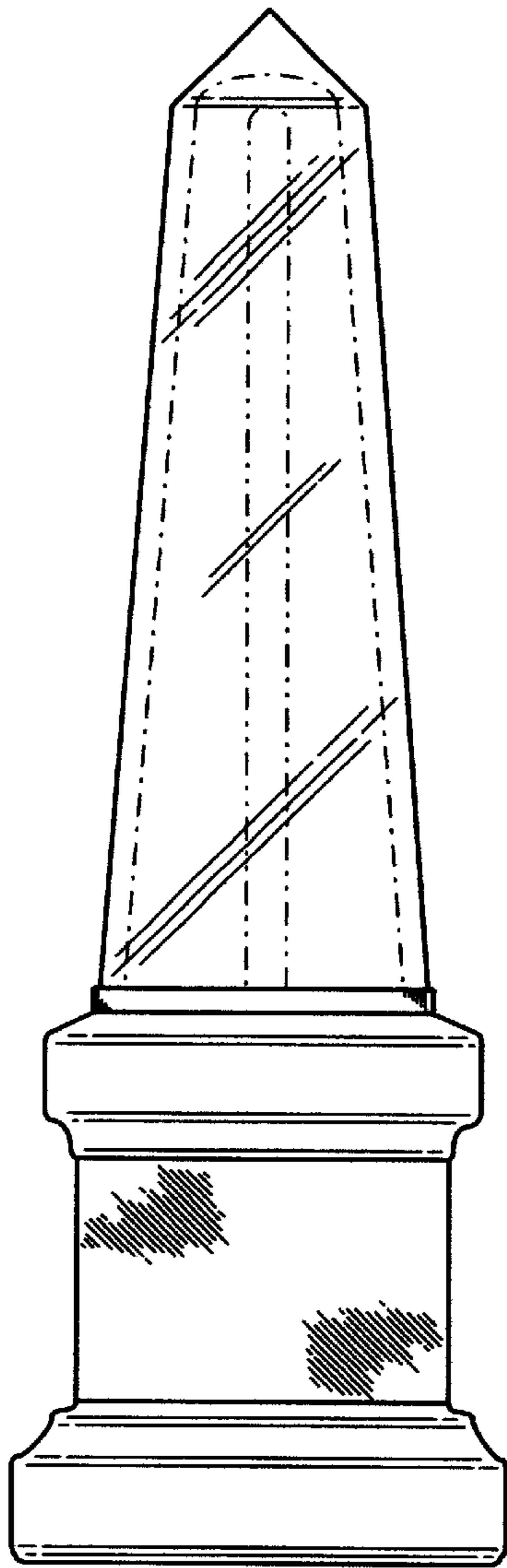

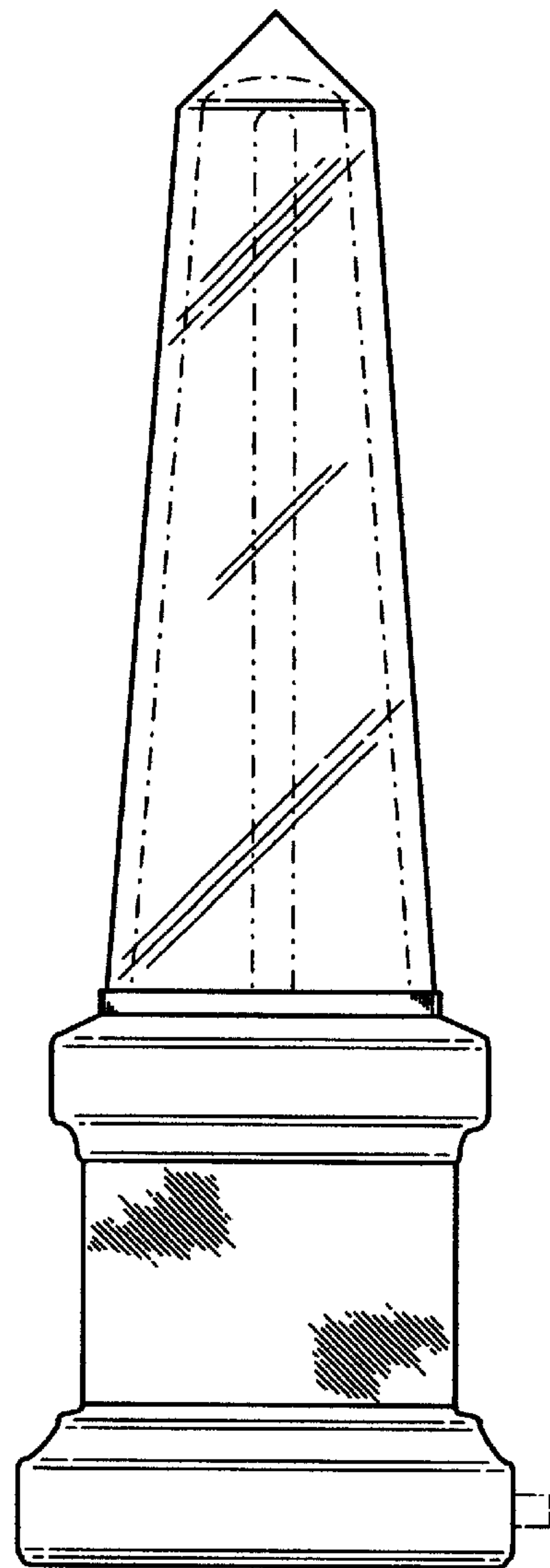

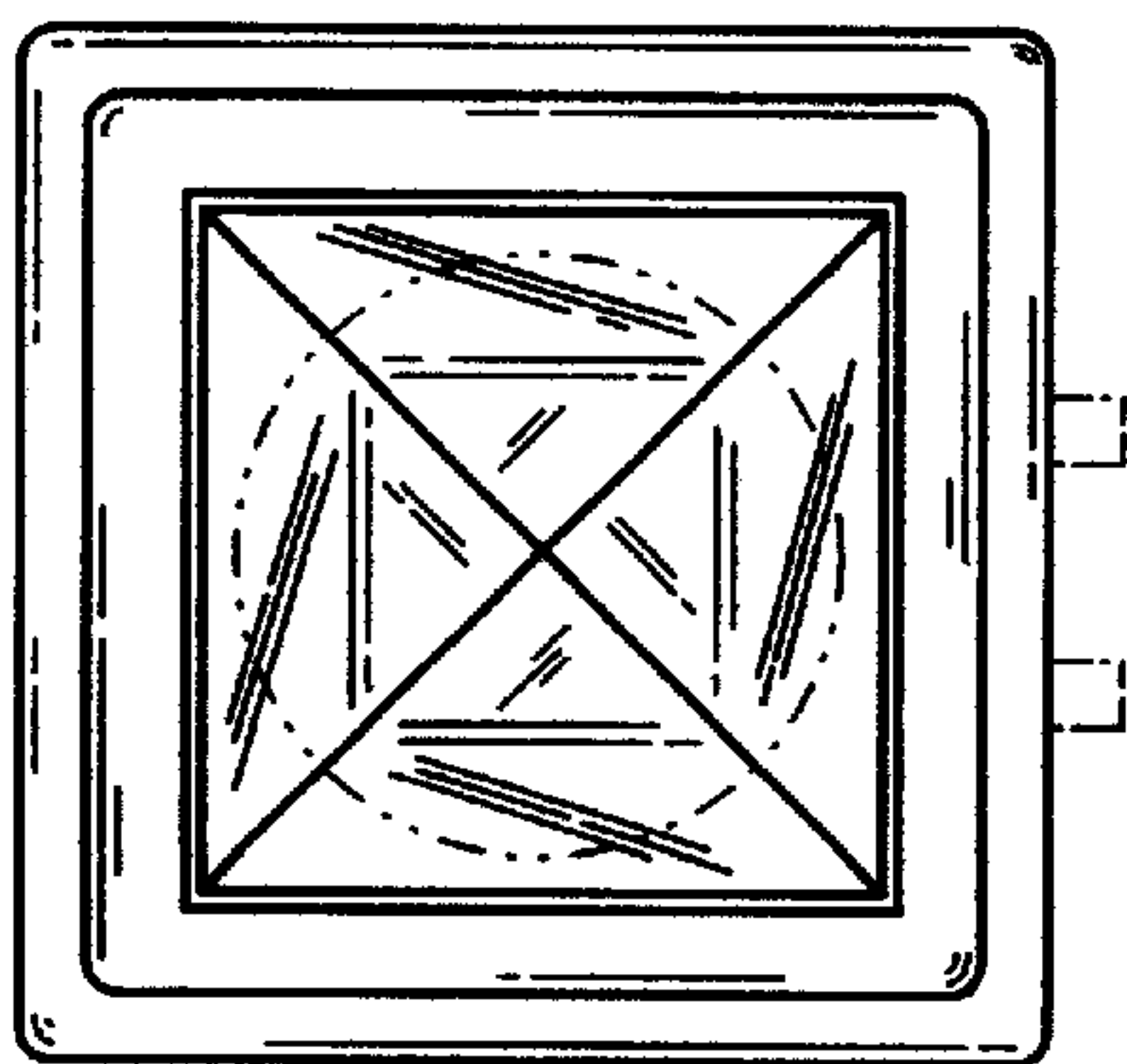
