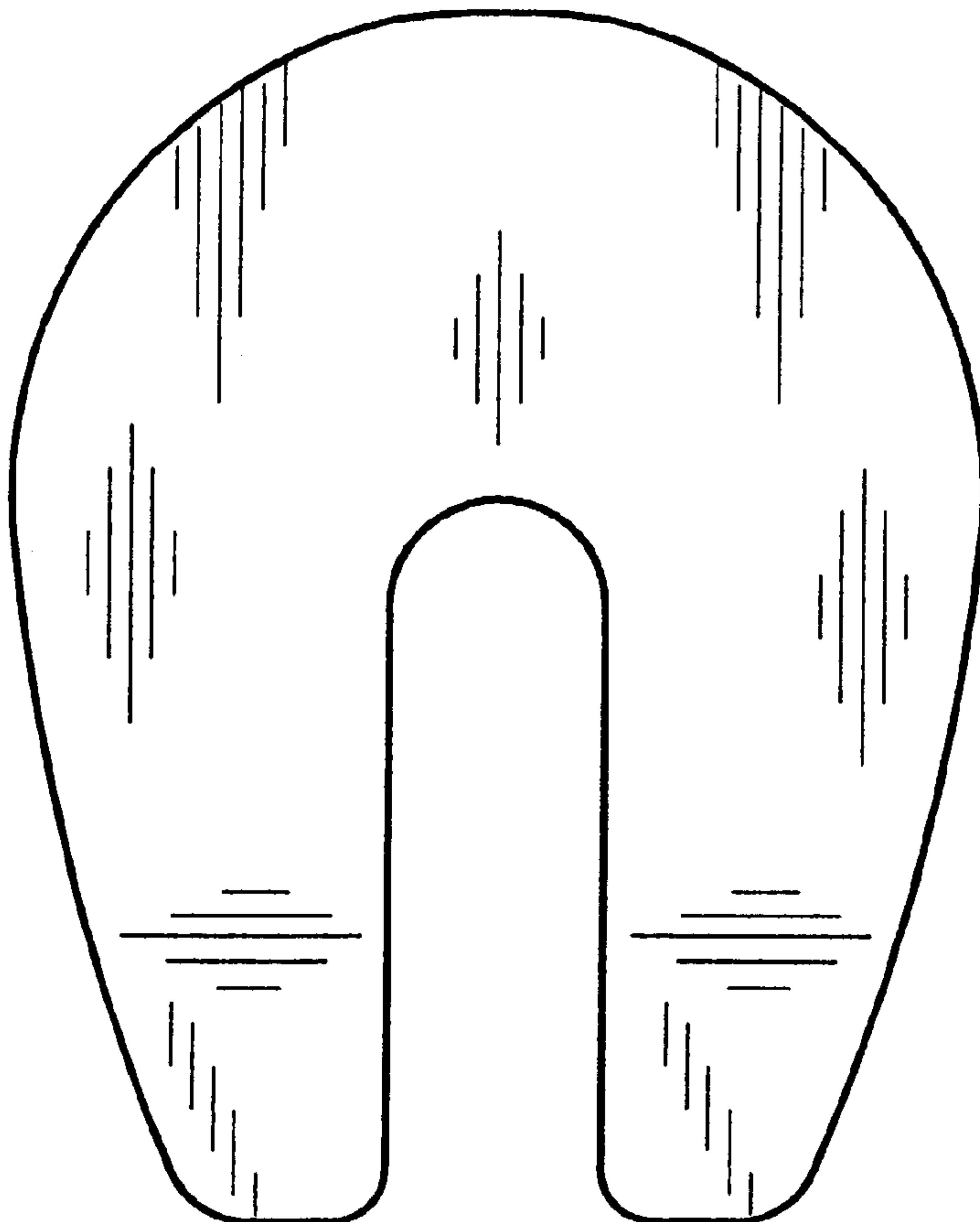
(57) **CLAIM**

The ornamental design for a fifth-wheel hitch cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the fifth-wheel hitch cover of the present invention;  
 FIG. 2 is a rear elevational view of the fifth-wheel hitch cover of FIG. 1;  
 FIG. 3 is a left side elevational view of the fifth-wheel hitch cover of FIG. 1, the right view being a mirror image thereof;  
 FIG. 4 is a top plan view of the fifth-wheel hitch cover of FIG. 1;  
 FIG. 5 is a bottom plan view of the fifth-wheel hitch cover of FIG. 1; and,  
 FIG. 6 is a cross-sectional view of the fifth-wheel hitch cover taken along line 6—6.

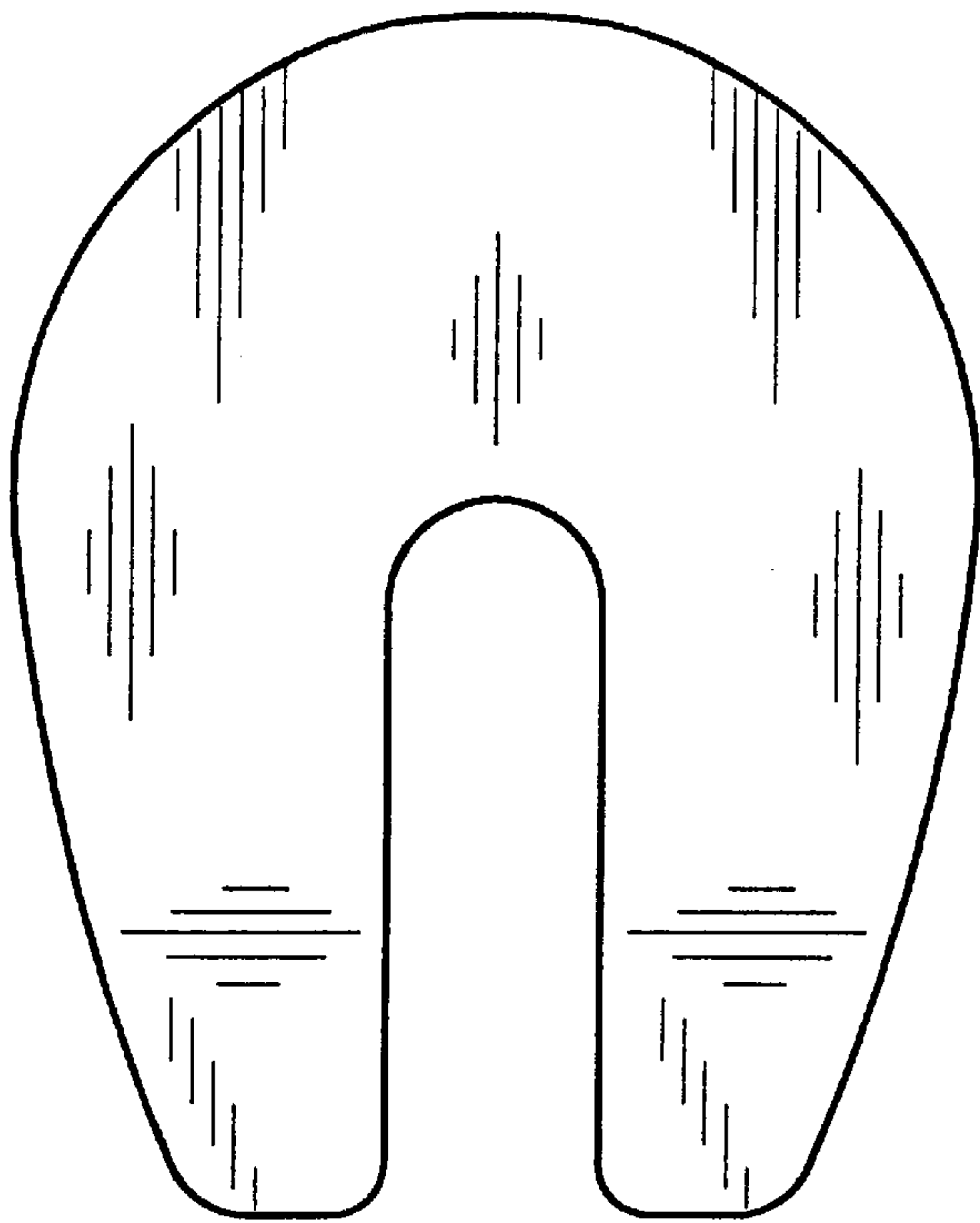

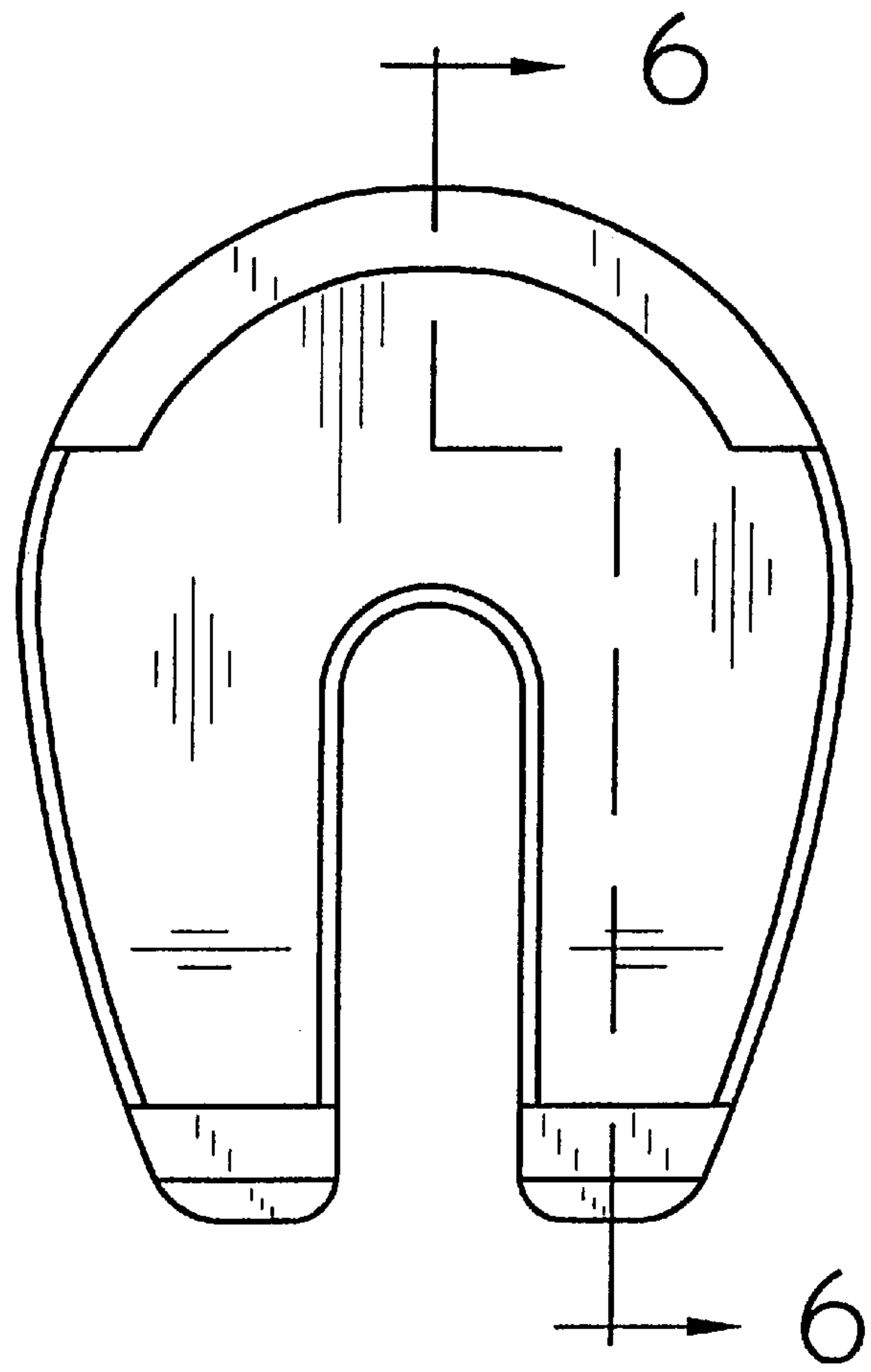

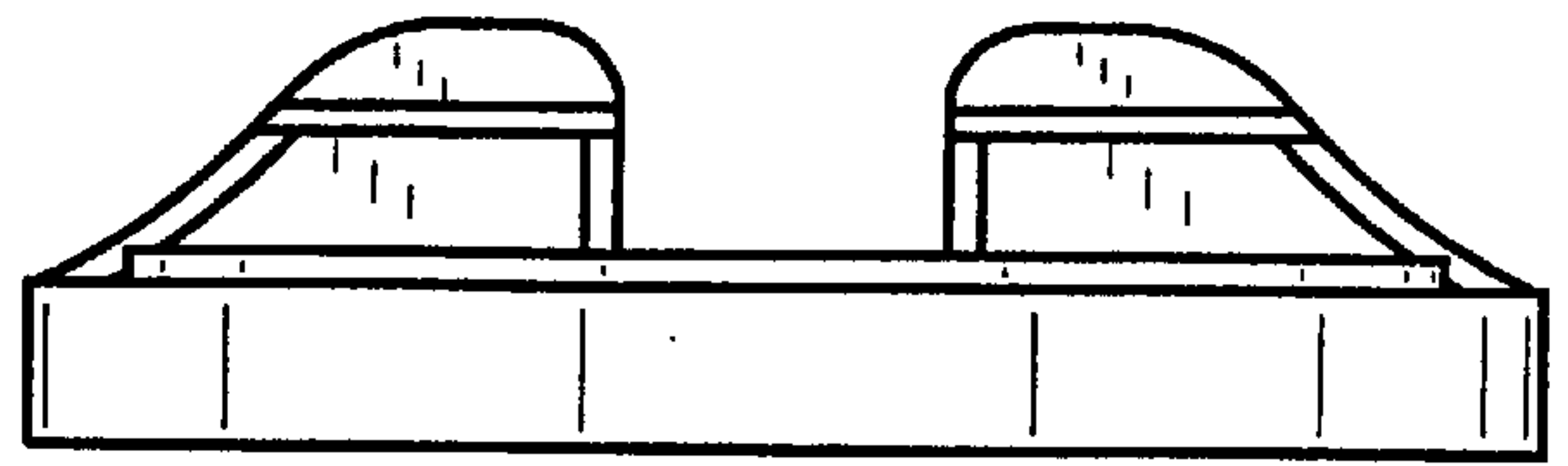

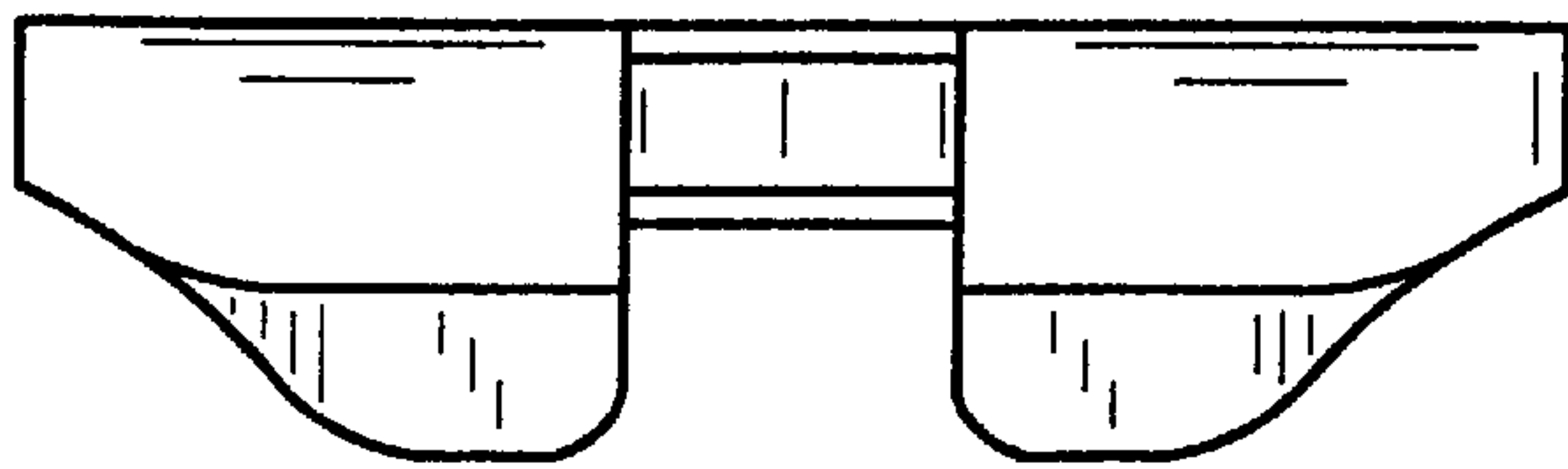

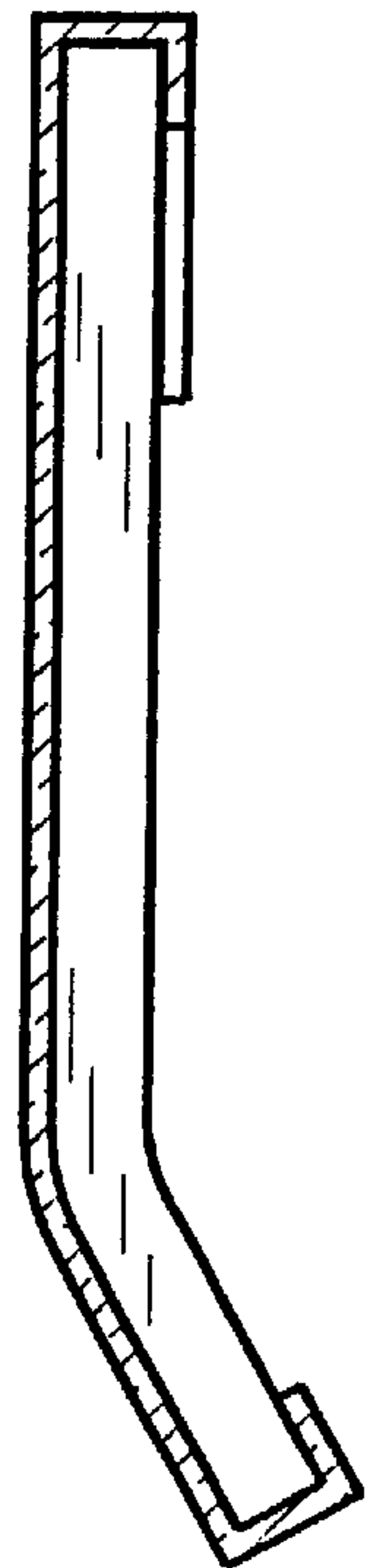
