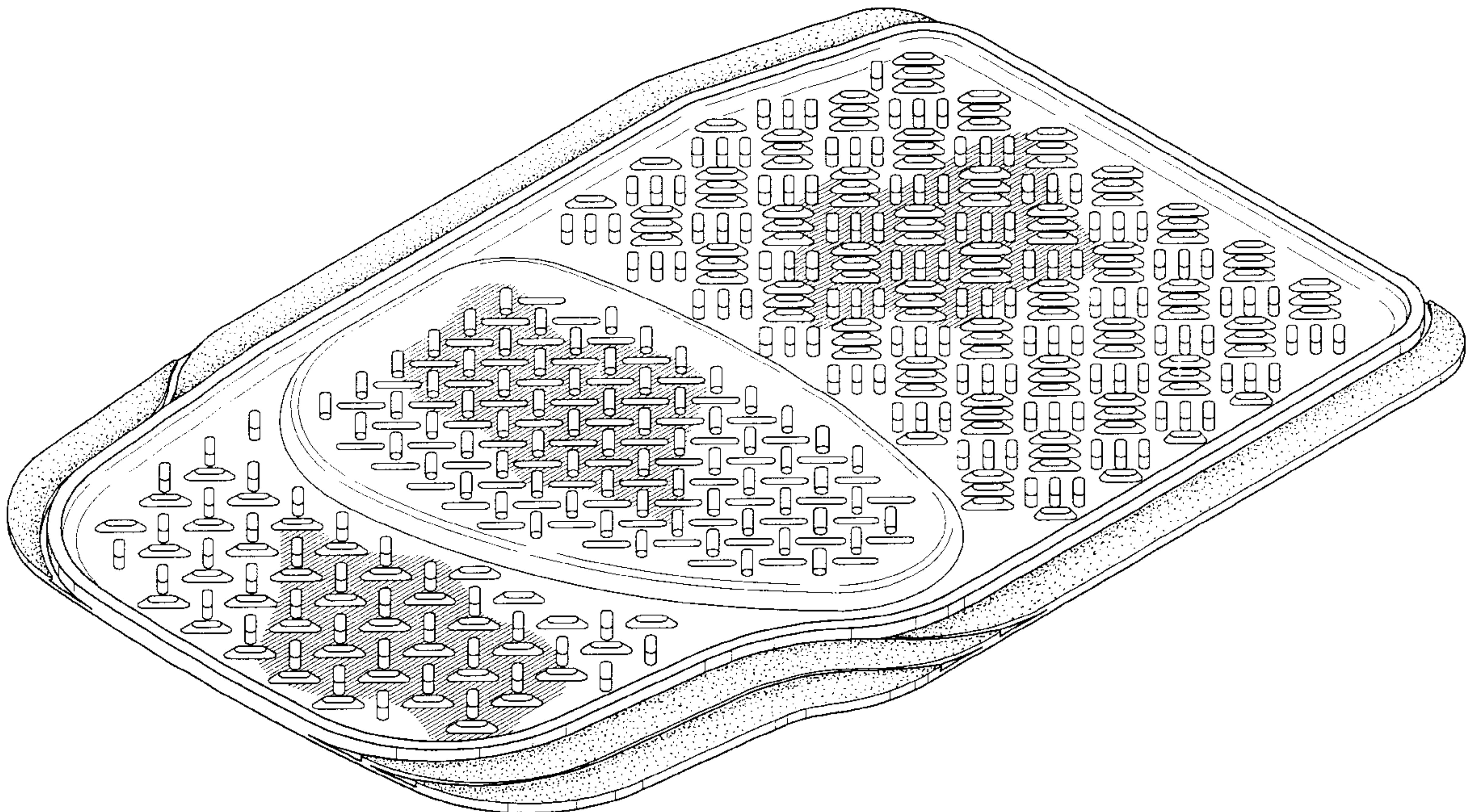
(57) **CLAIM**

The ornamental design for a floor mat for vehicles, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a floor mat for vehicles showing my new design;

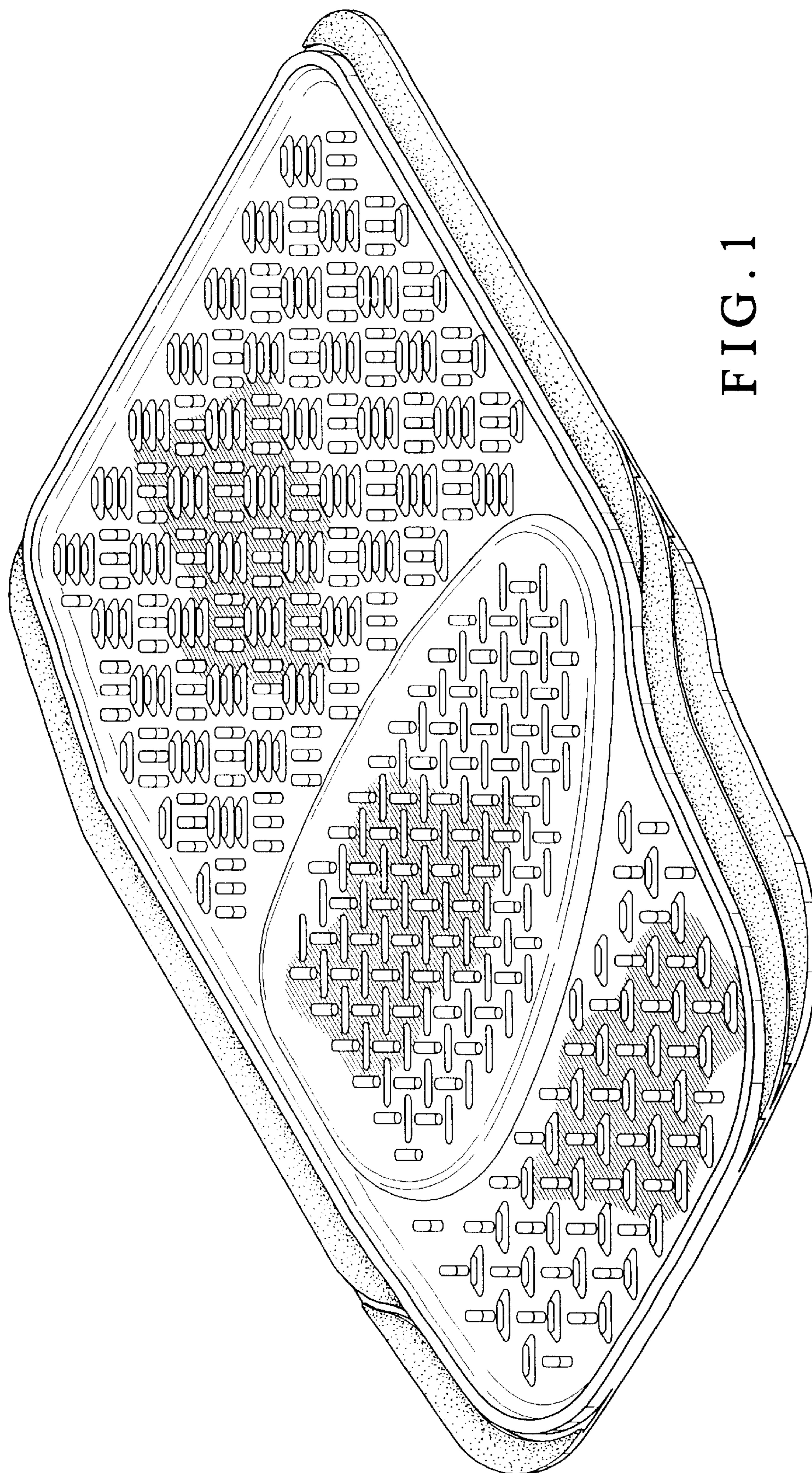

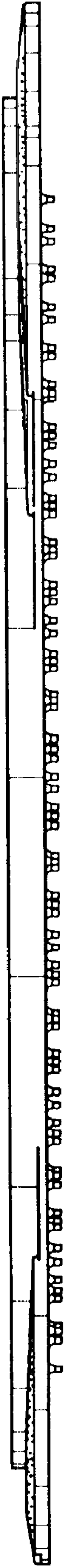

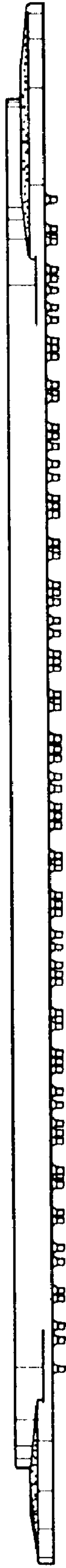

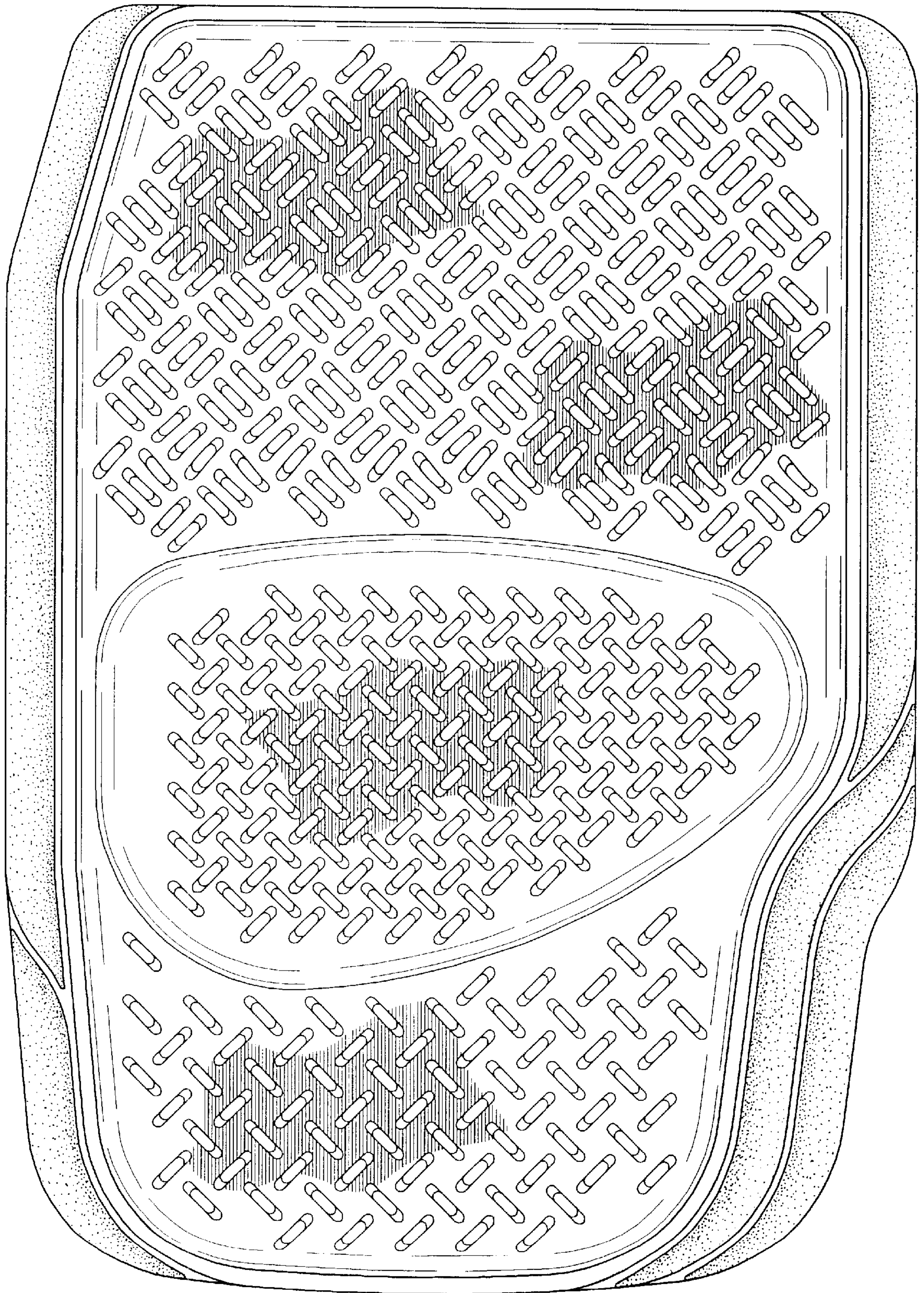

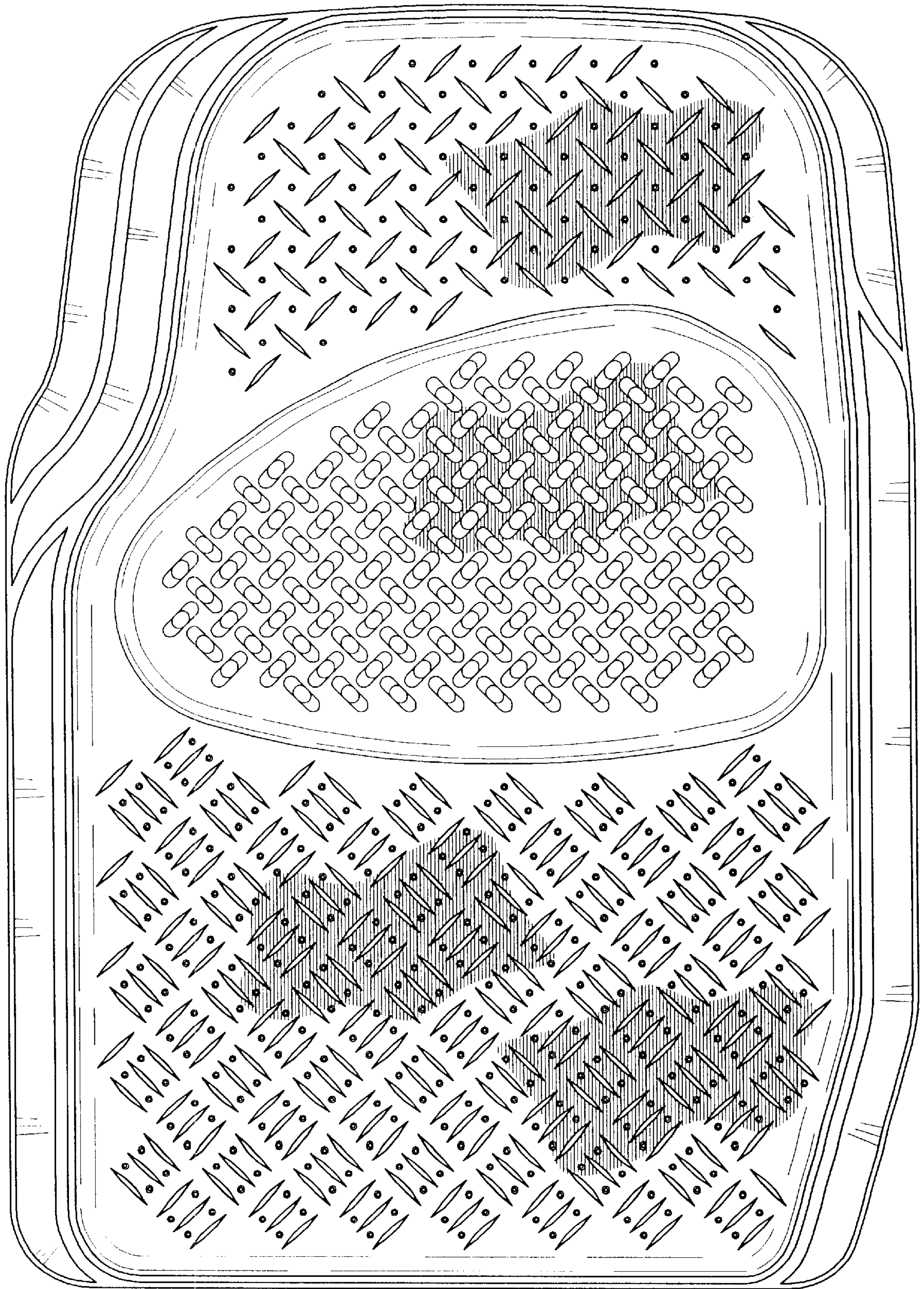
