(57) **CLAIM**

The ornamental design for an IC recorder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an IC recorder showing our design;

FIG. 2 is a top plan view thereof;

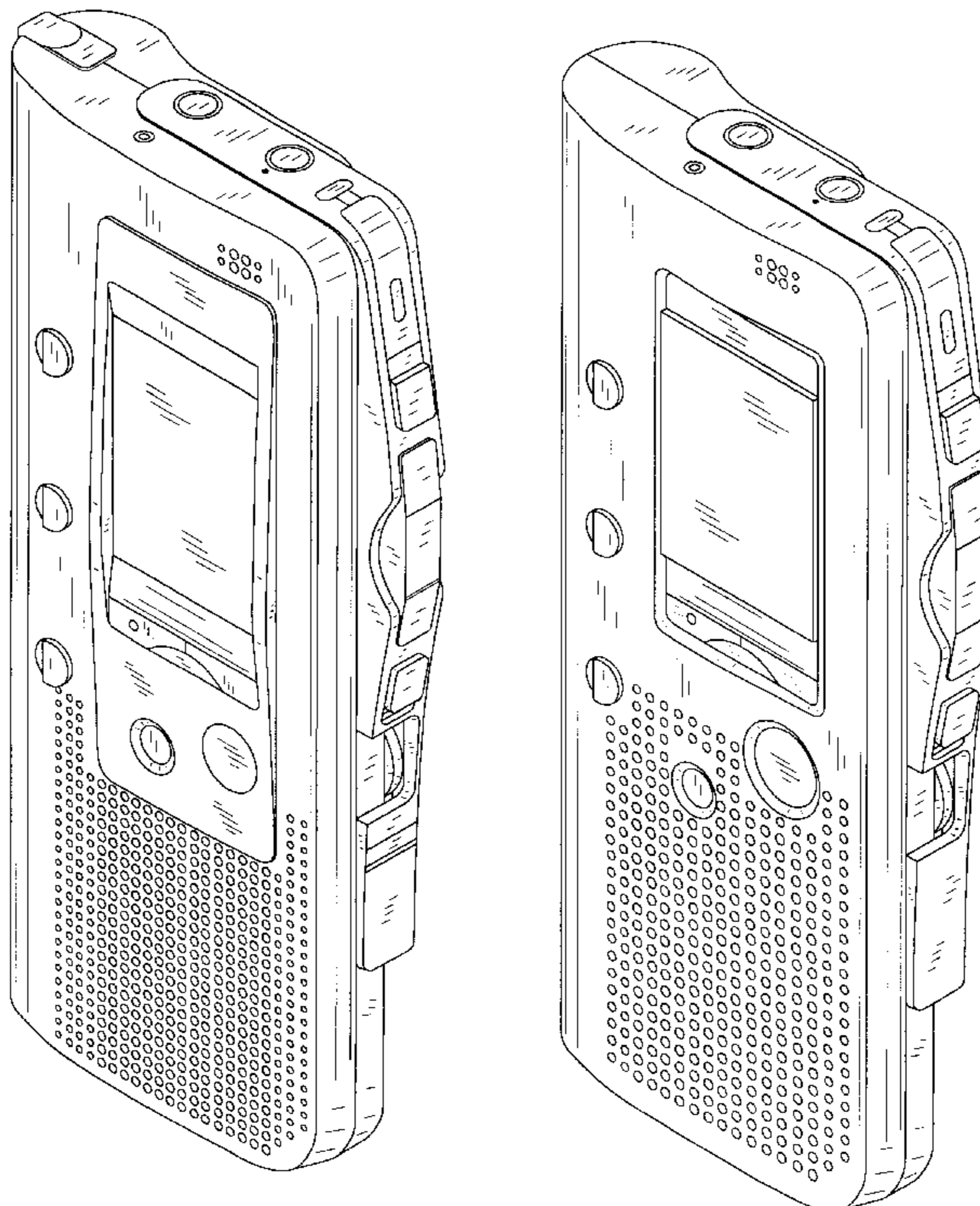

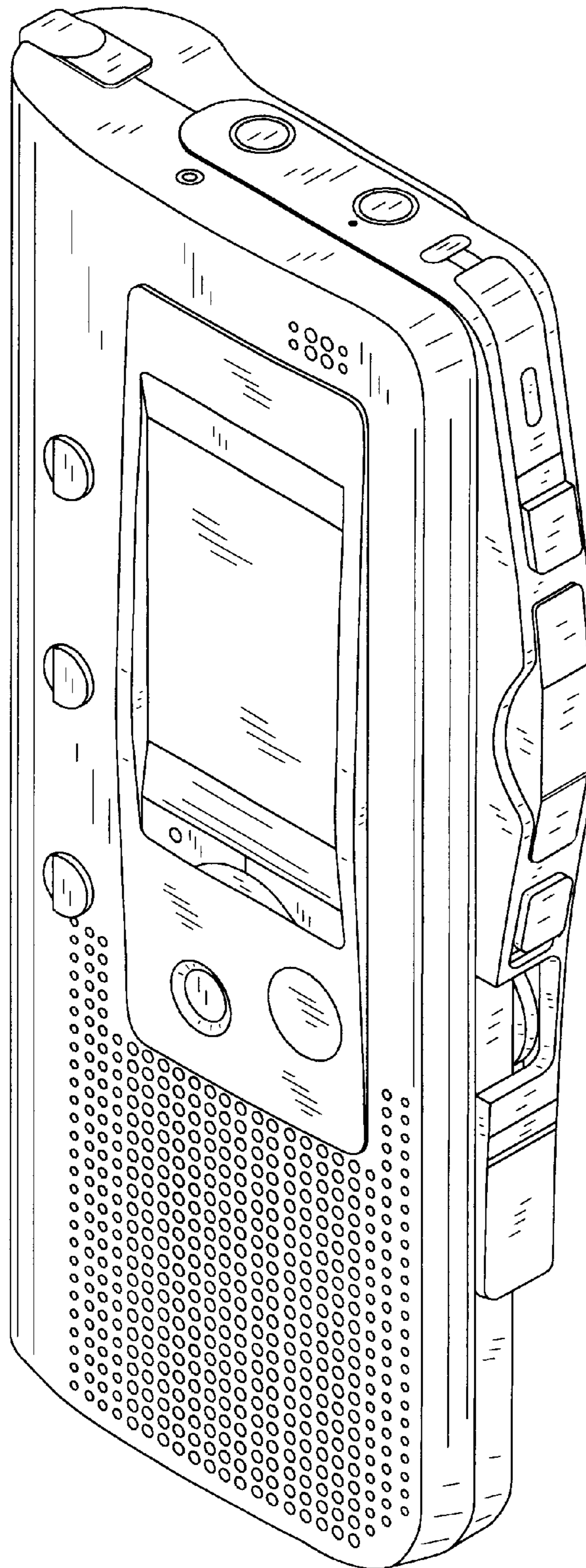

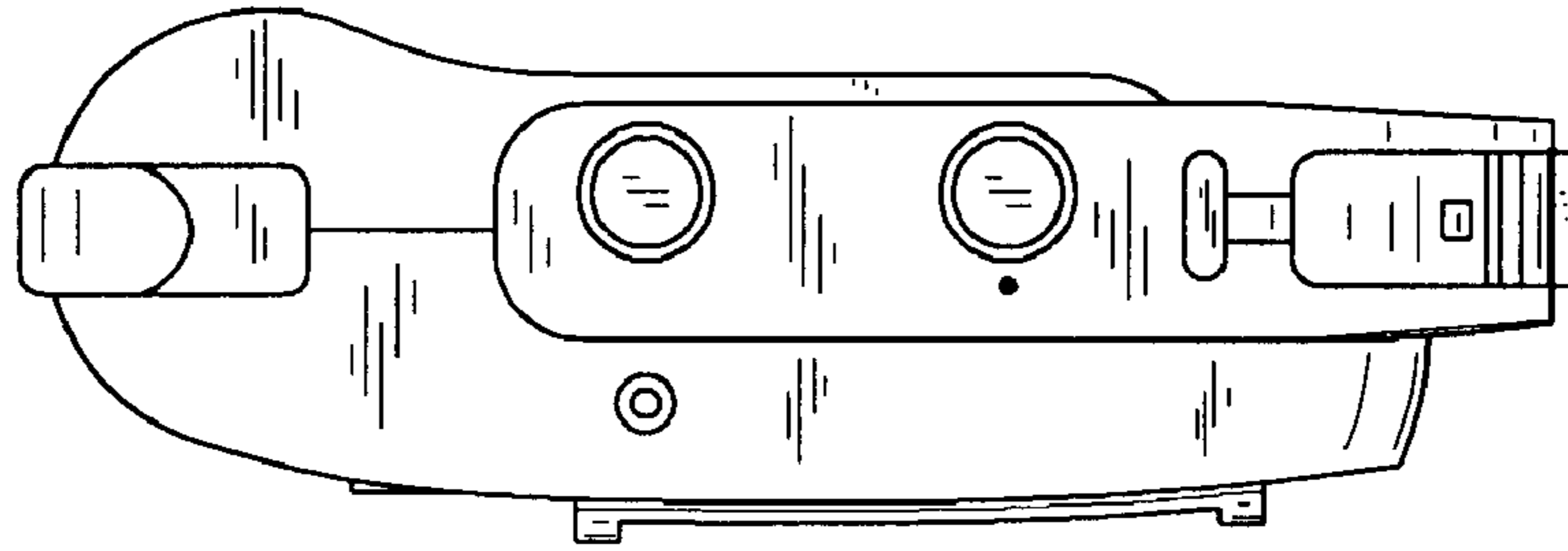

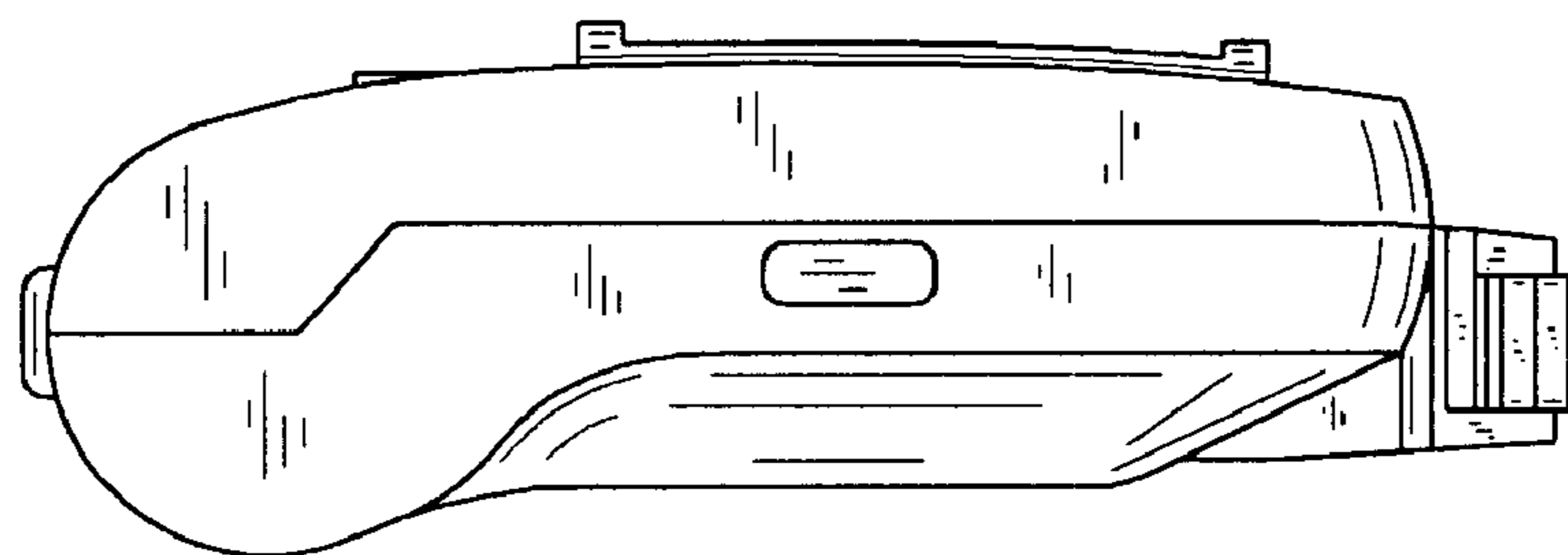

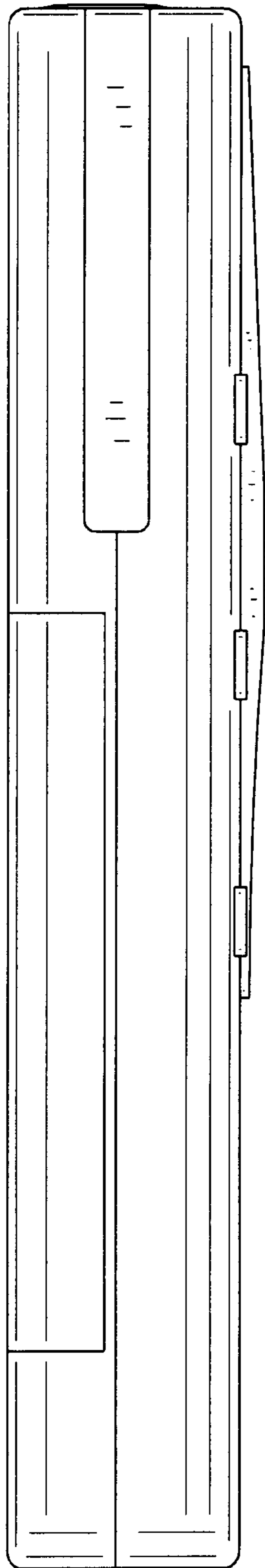

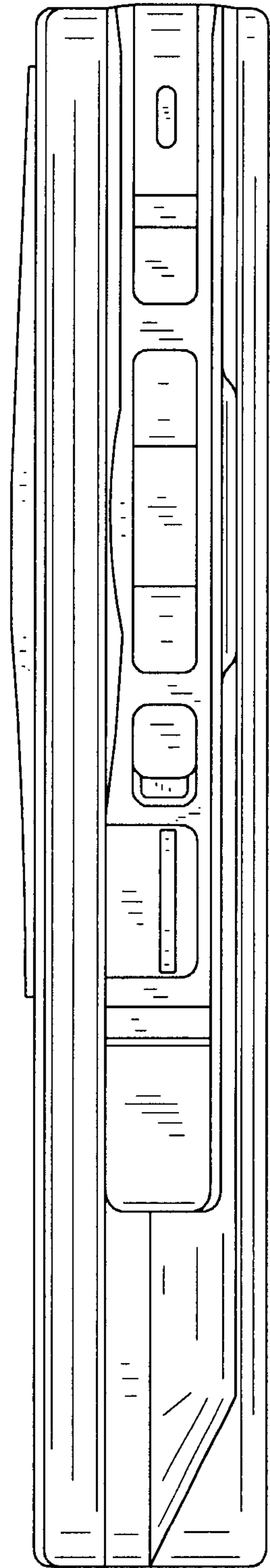

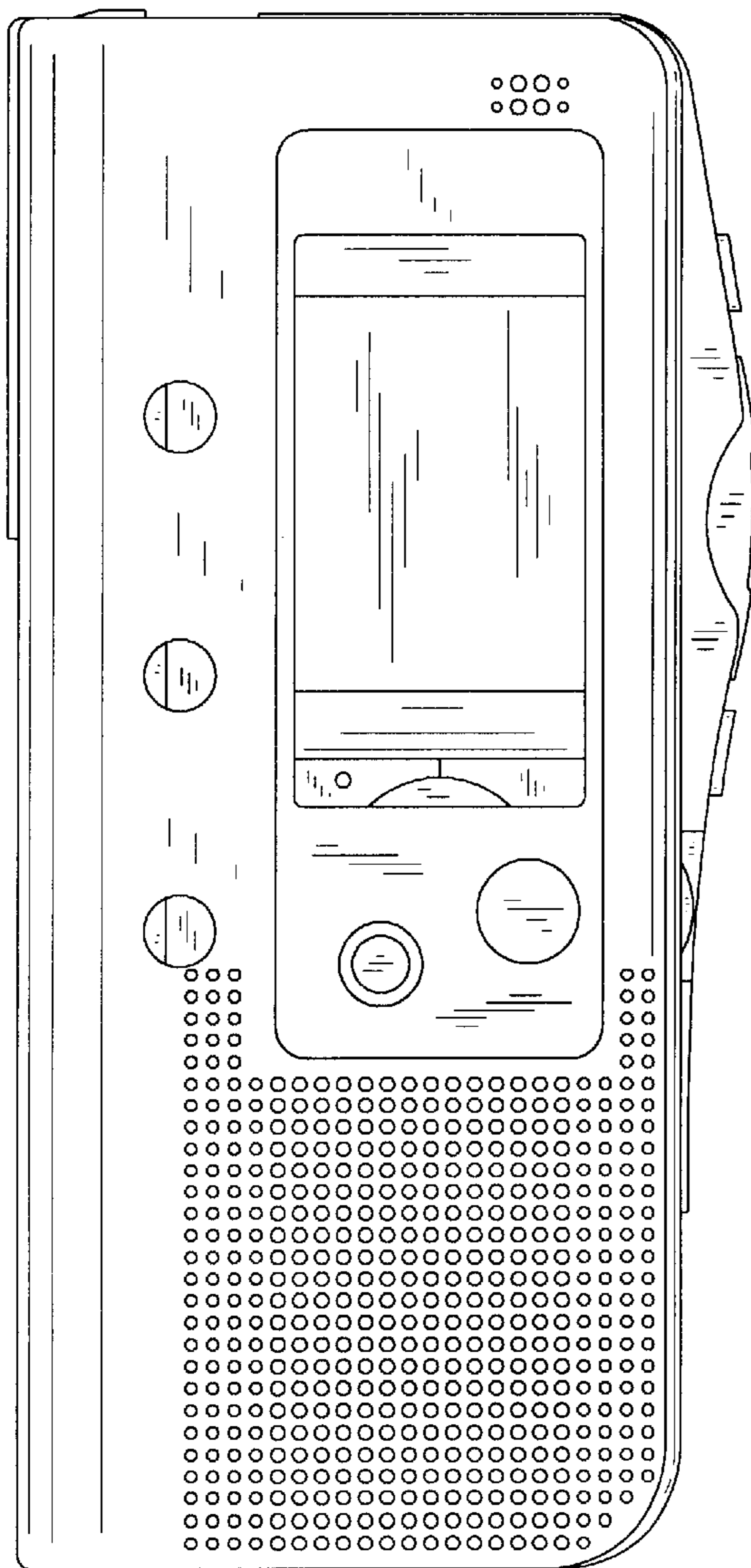

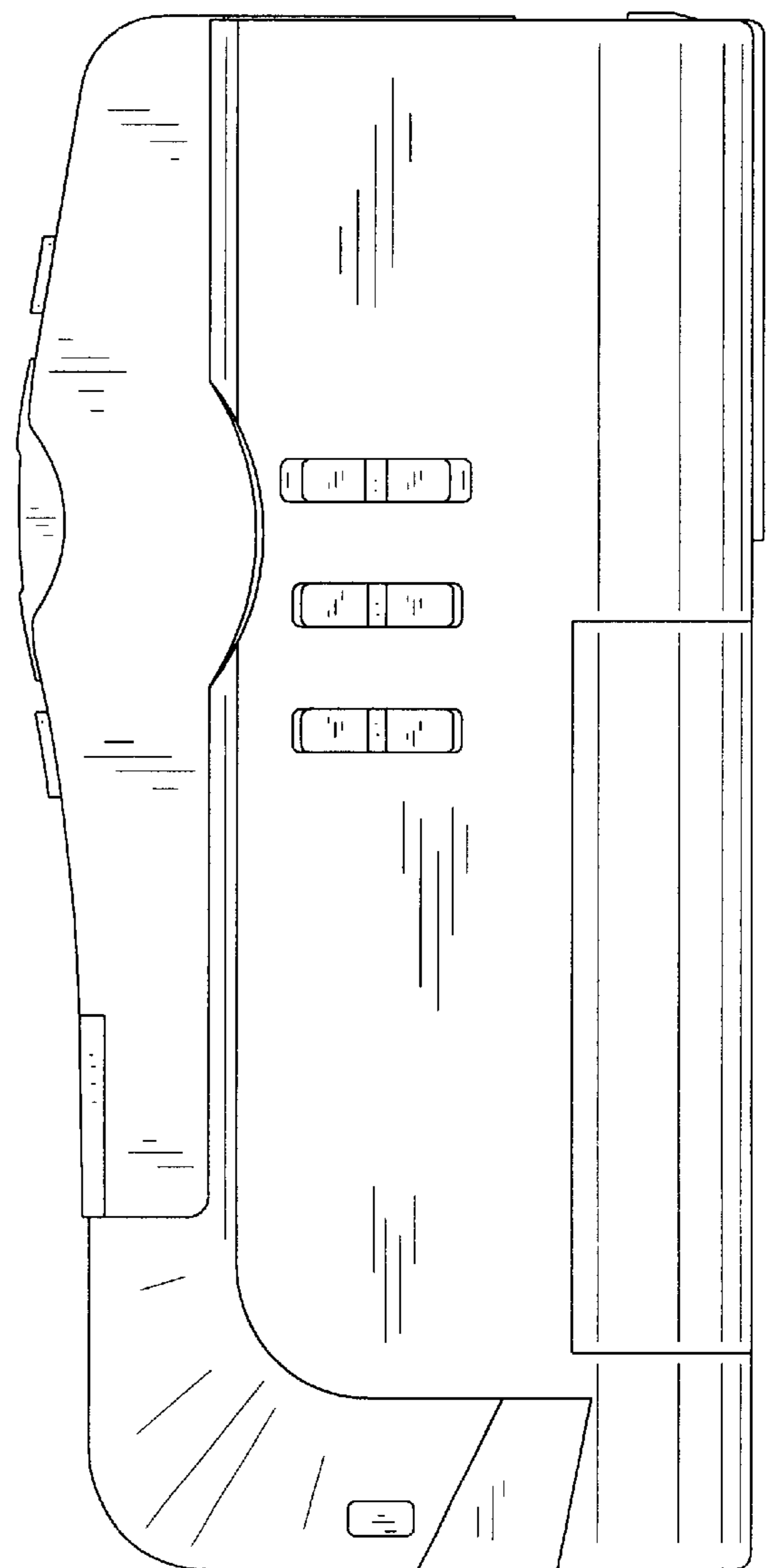

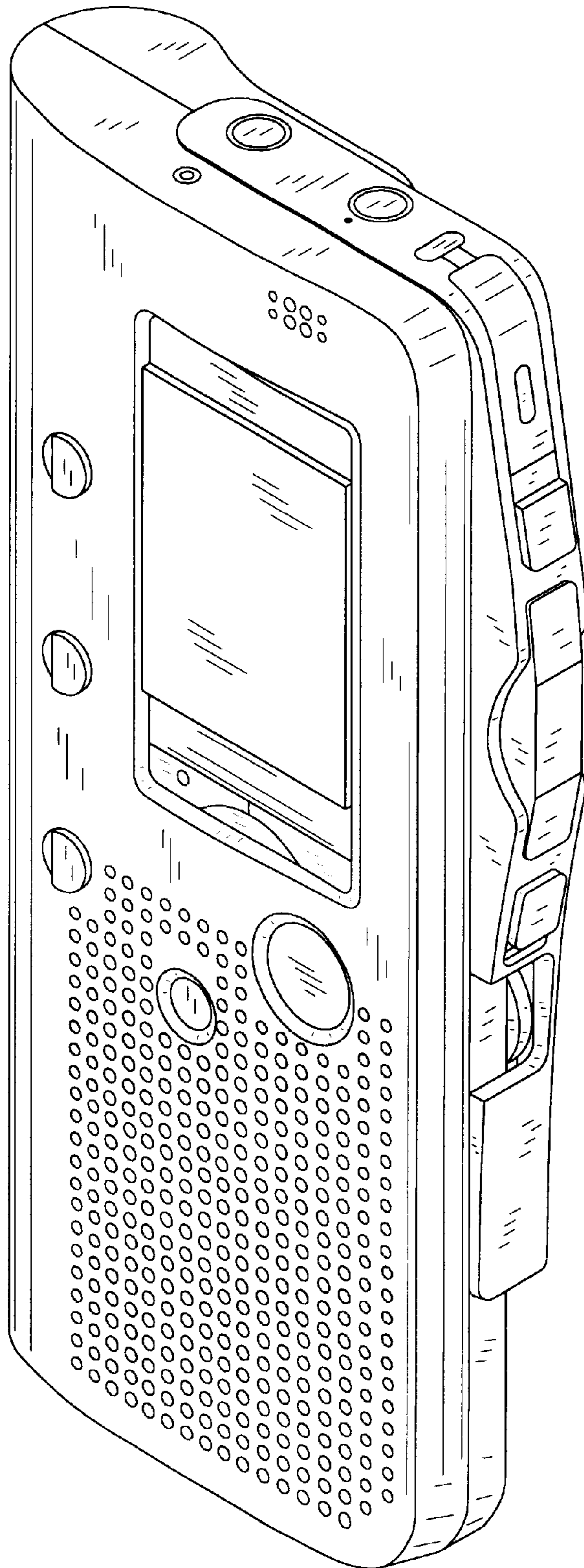

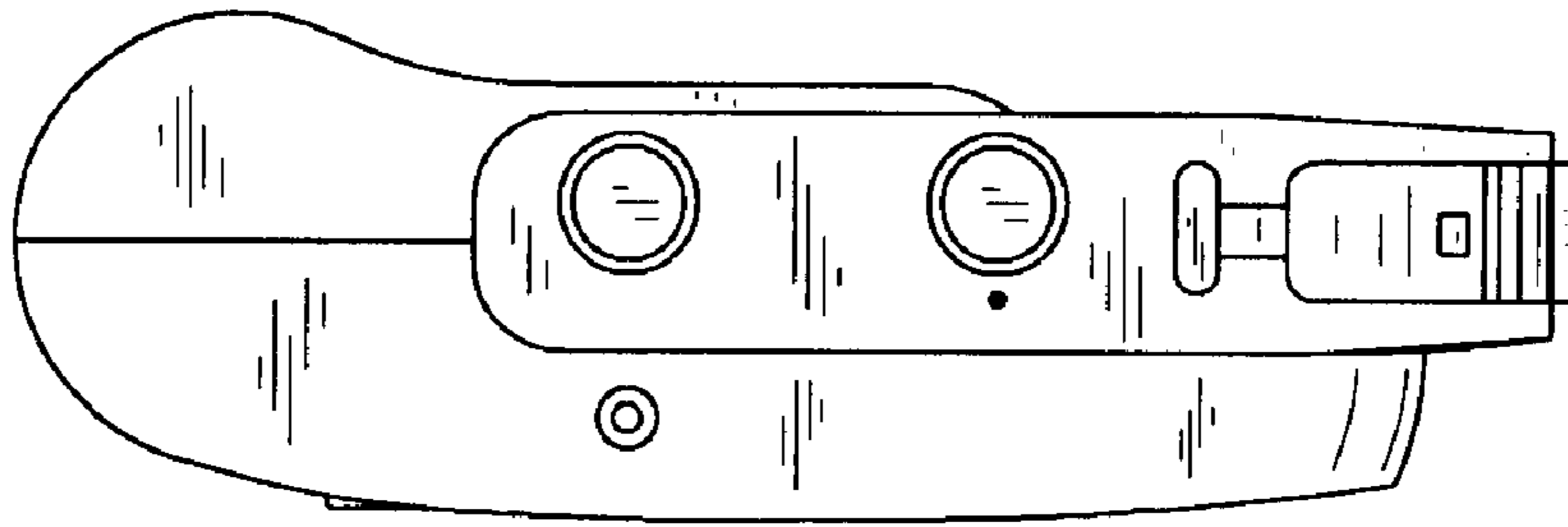

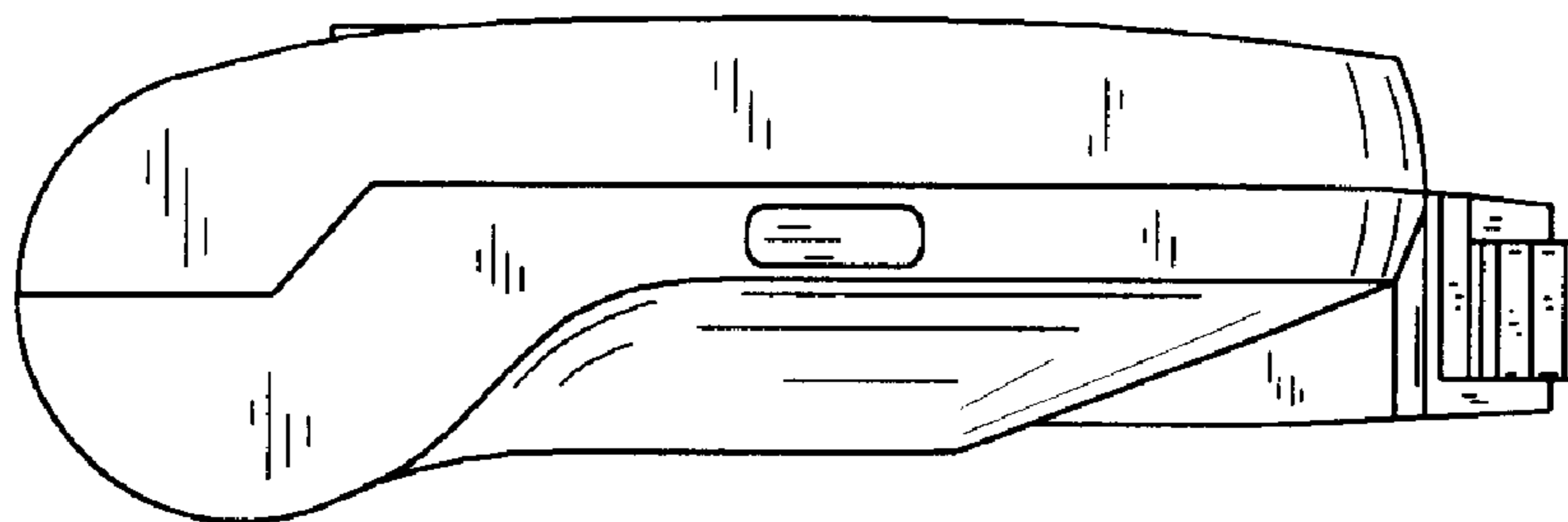

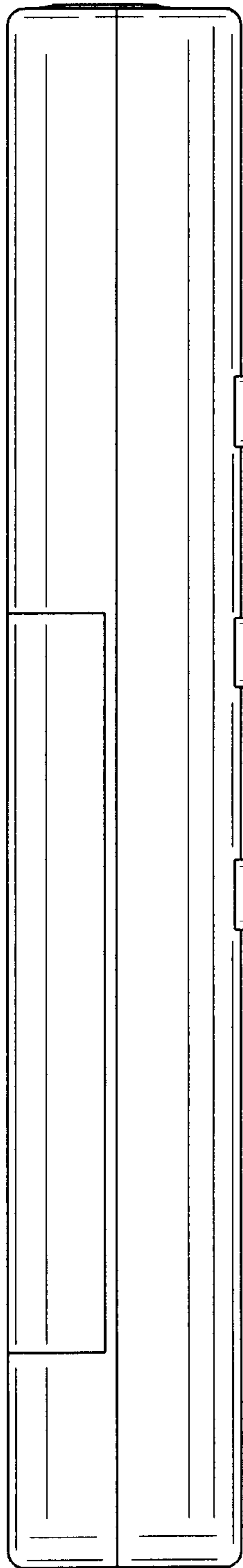

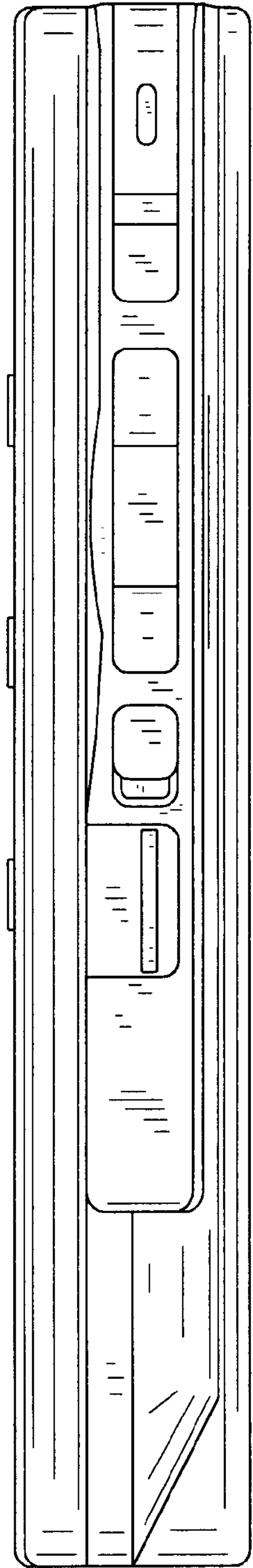

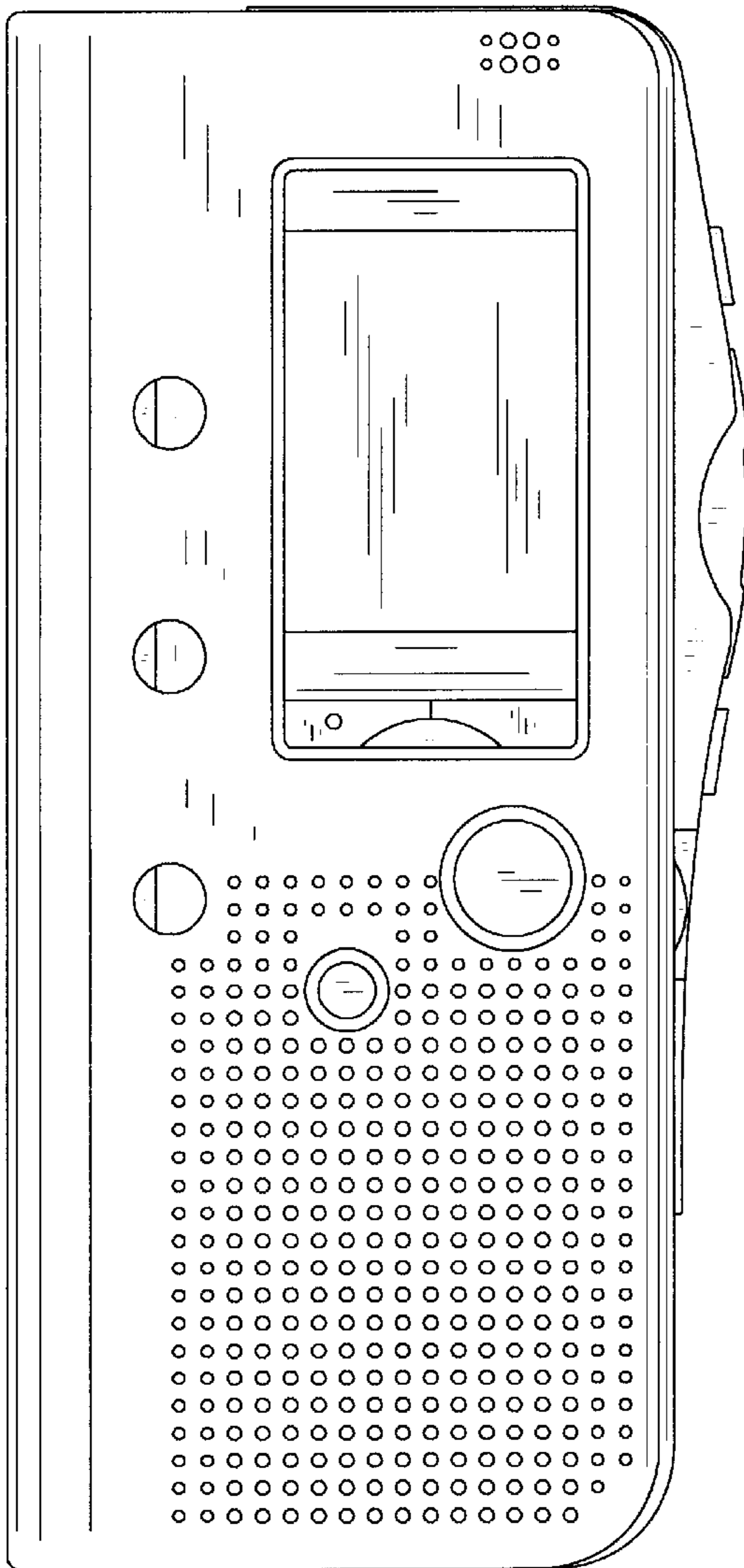
