(57) **CLAIM**

The ornamental design for a remote controller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a remote controller showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view similar to FIG. 1 showing a second embodiment thereof; and,

FIG. 9 is a front elevational view of the remote controller of FIG. 8.

The remaining views of the second embodiment are identical to FIGS. 2-7.

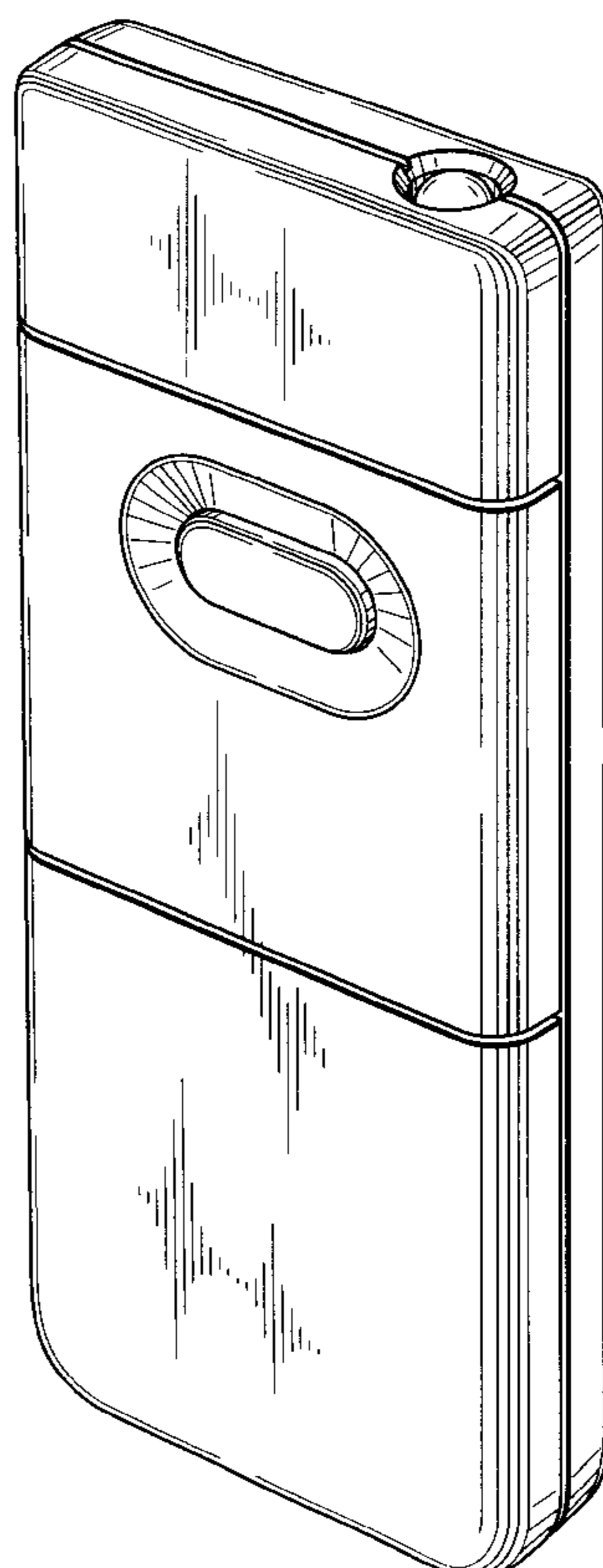
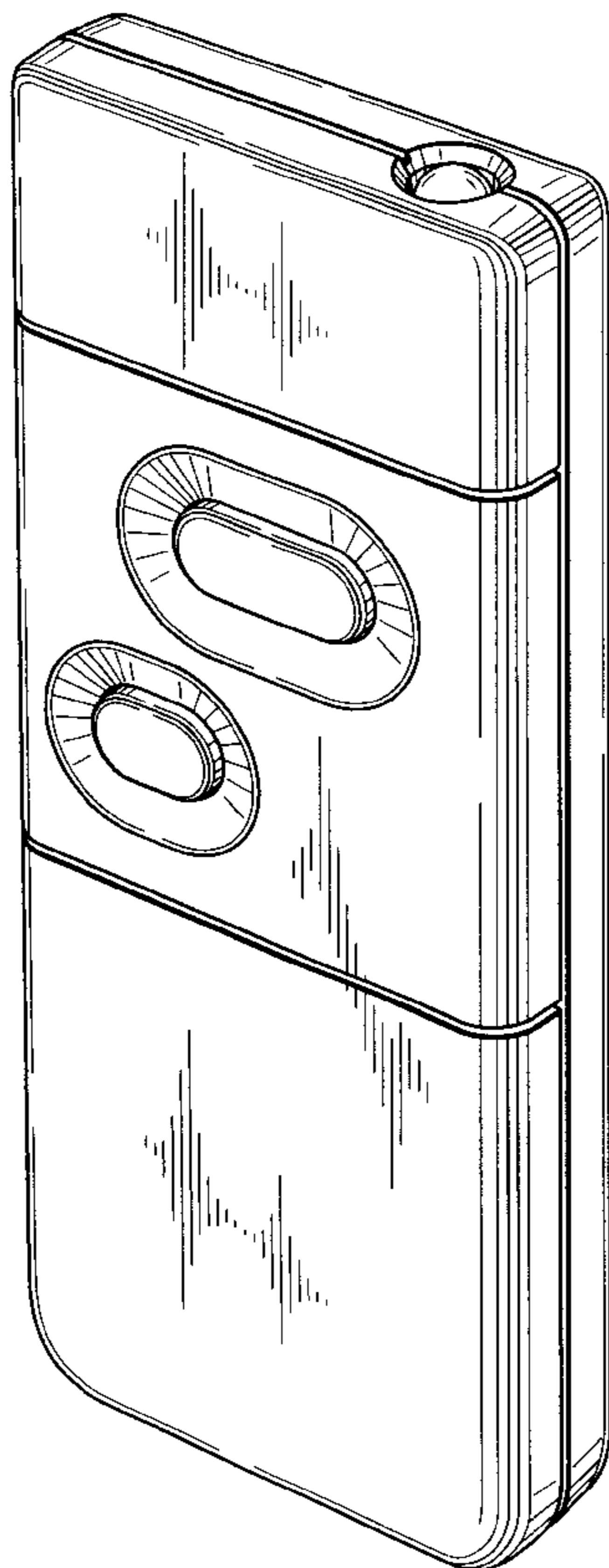

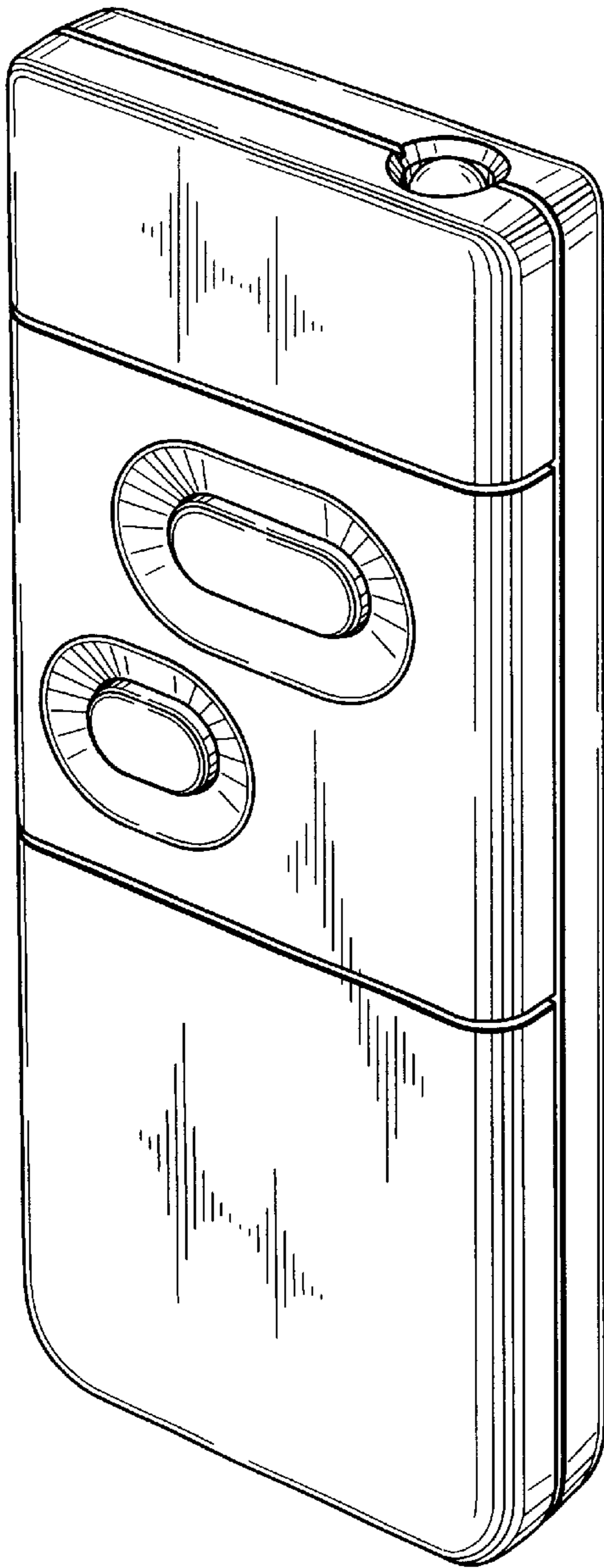

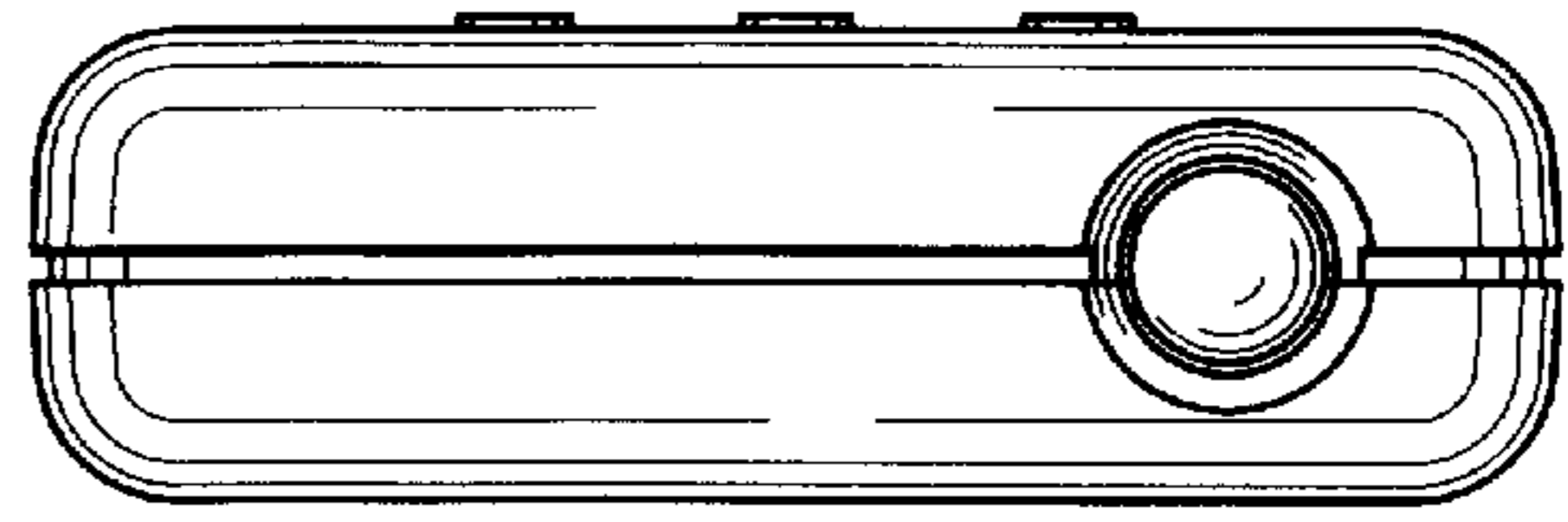

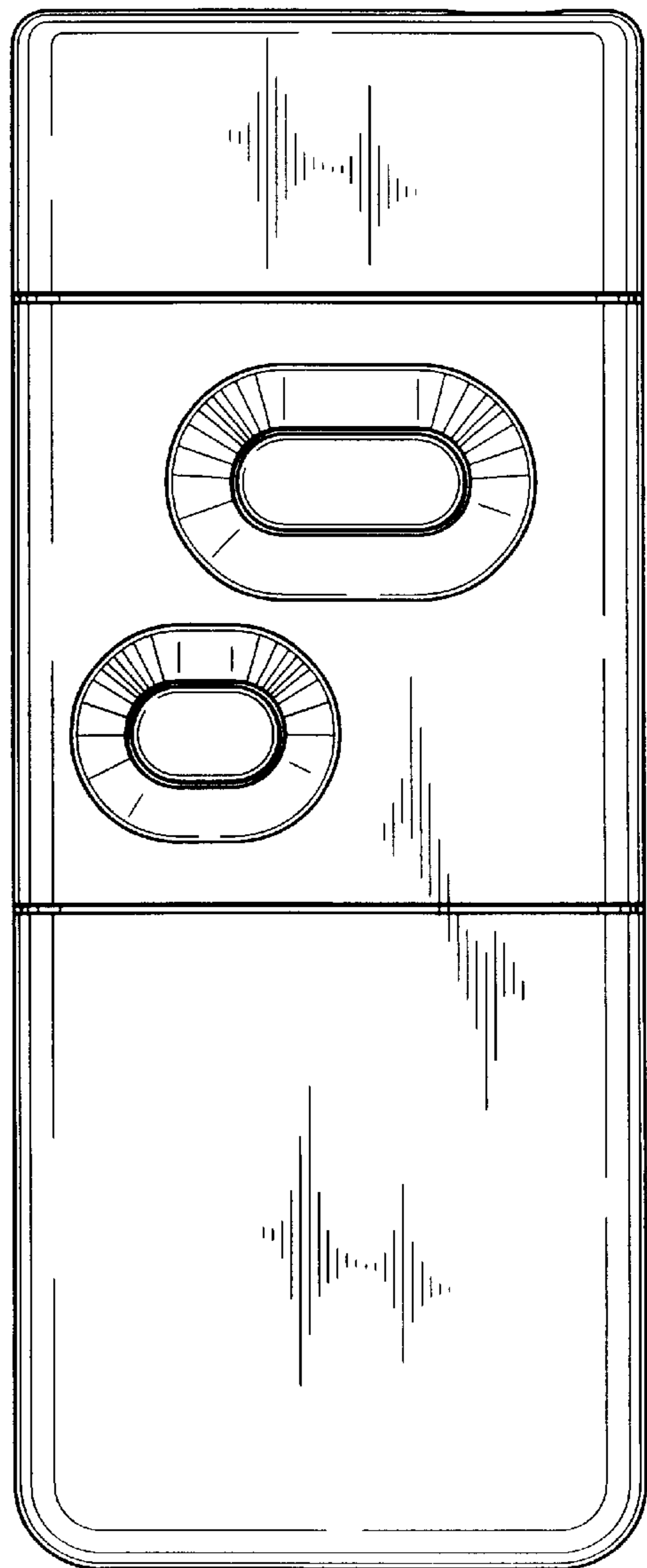

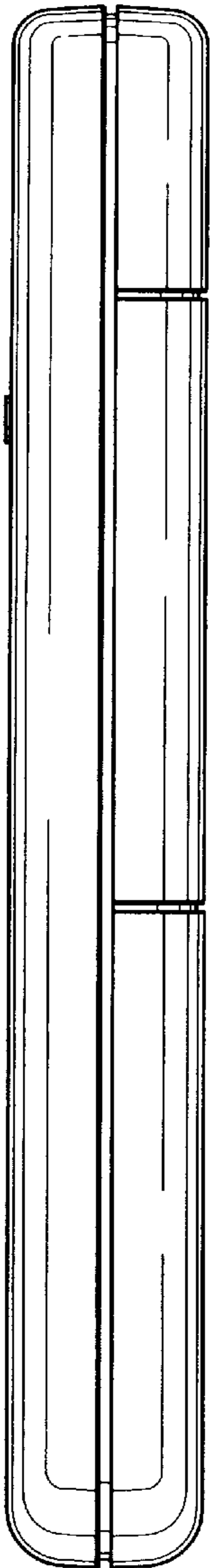

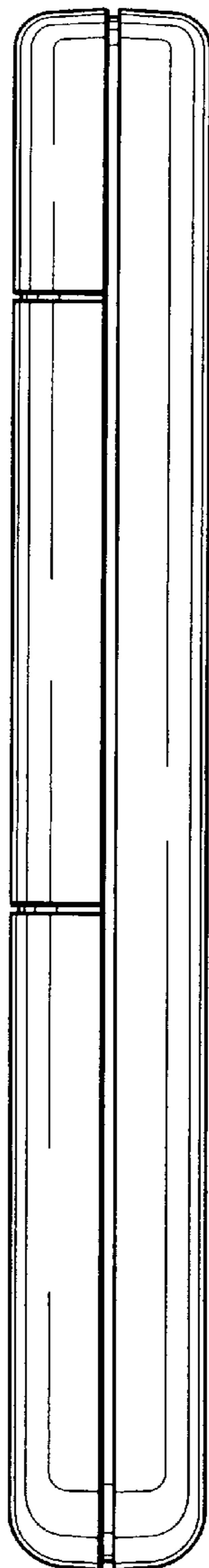

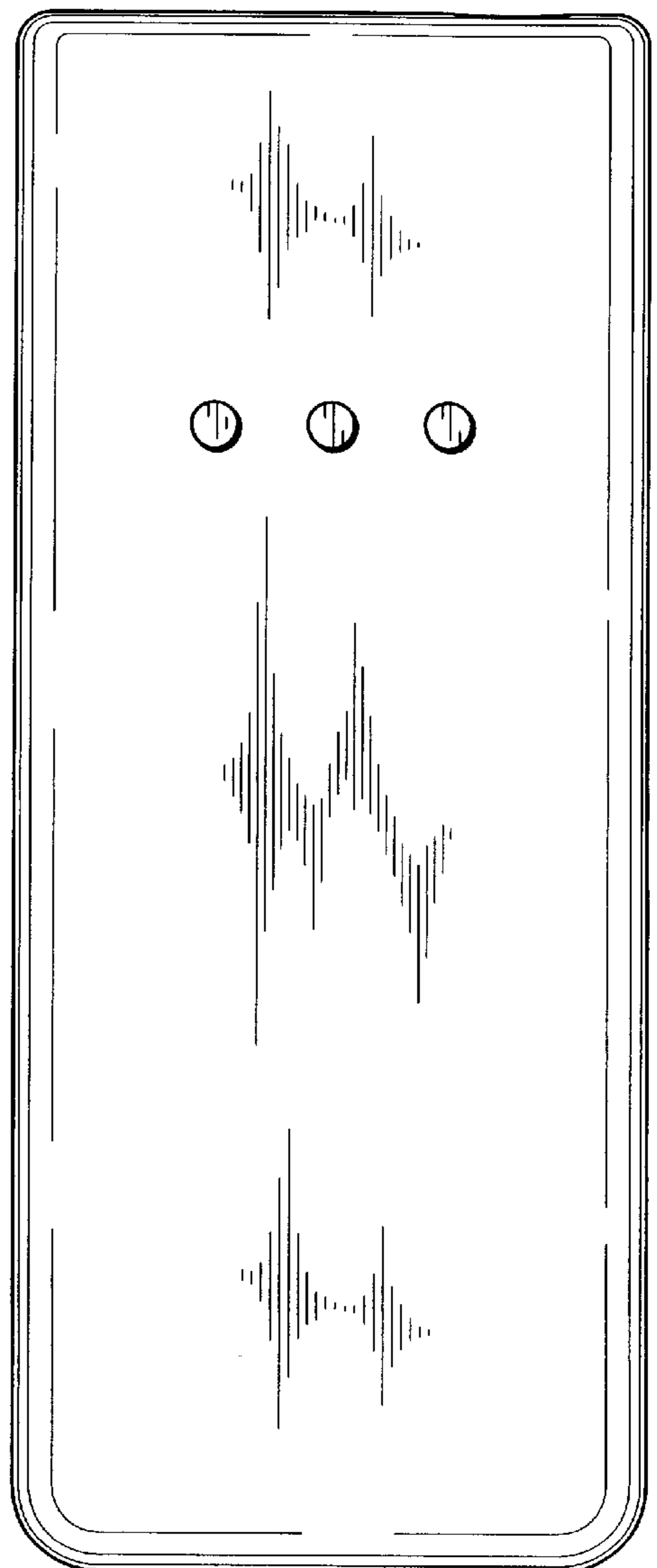

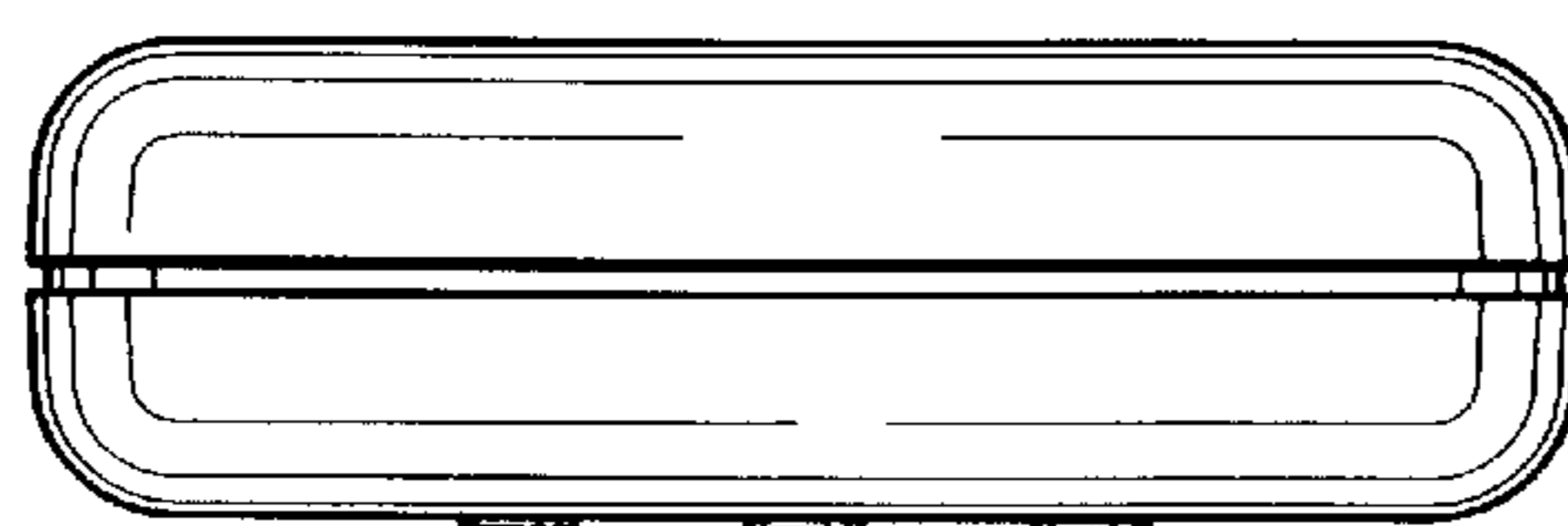

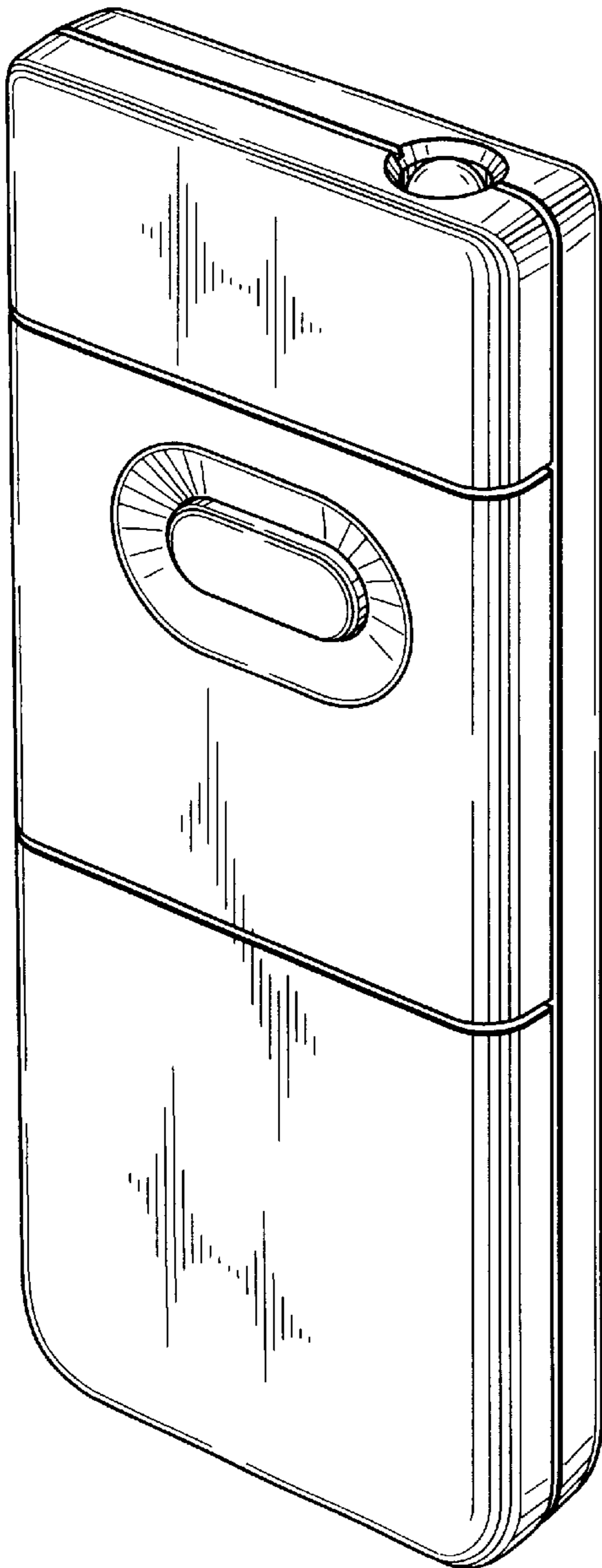
