FIG. 2 is a front view thereof, the rear view being identical;

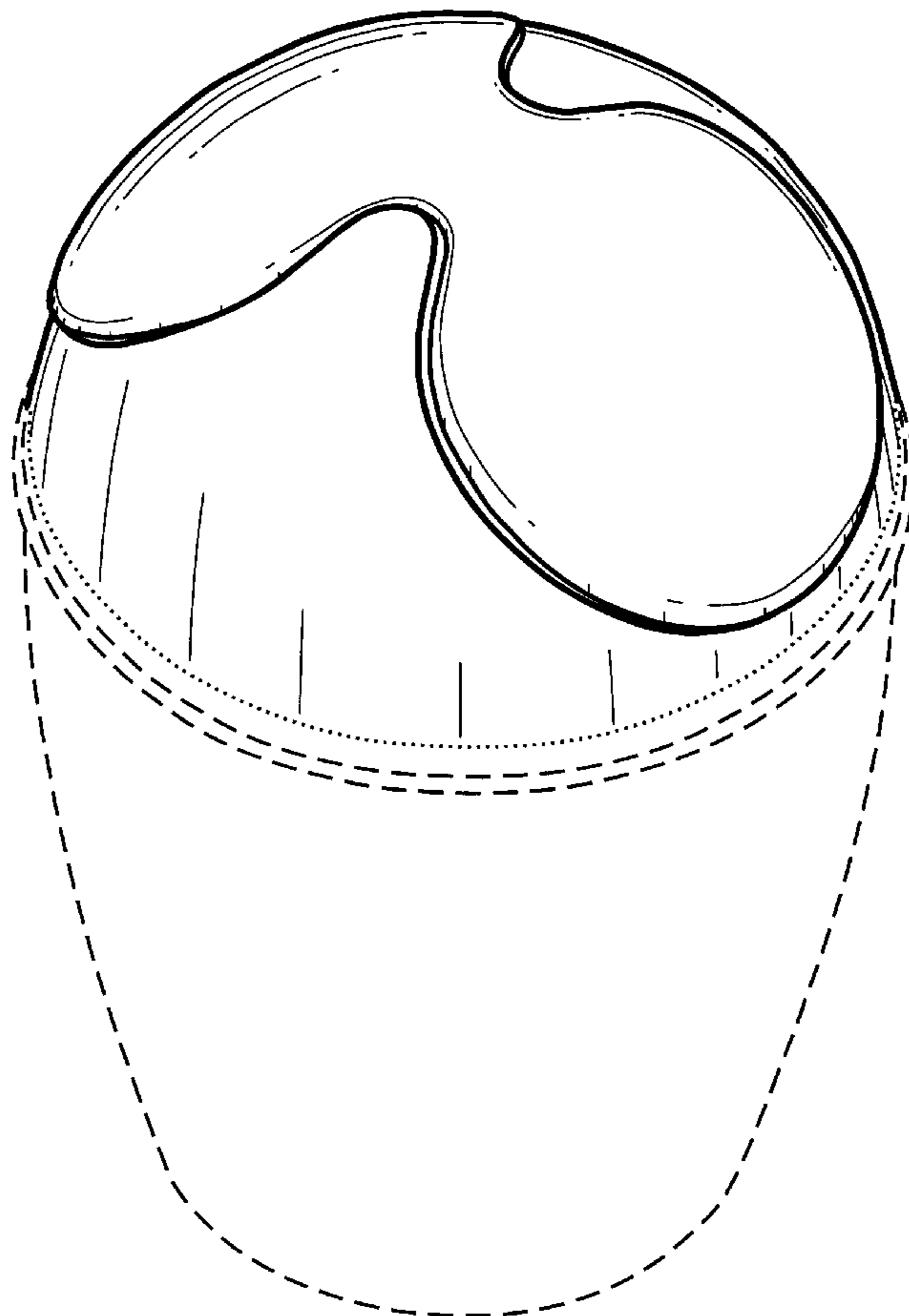
FIG. 3 is a top view thereof; and,

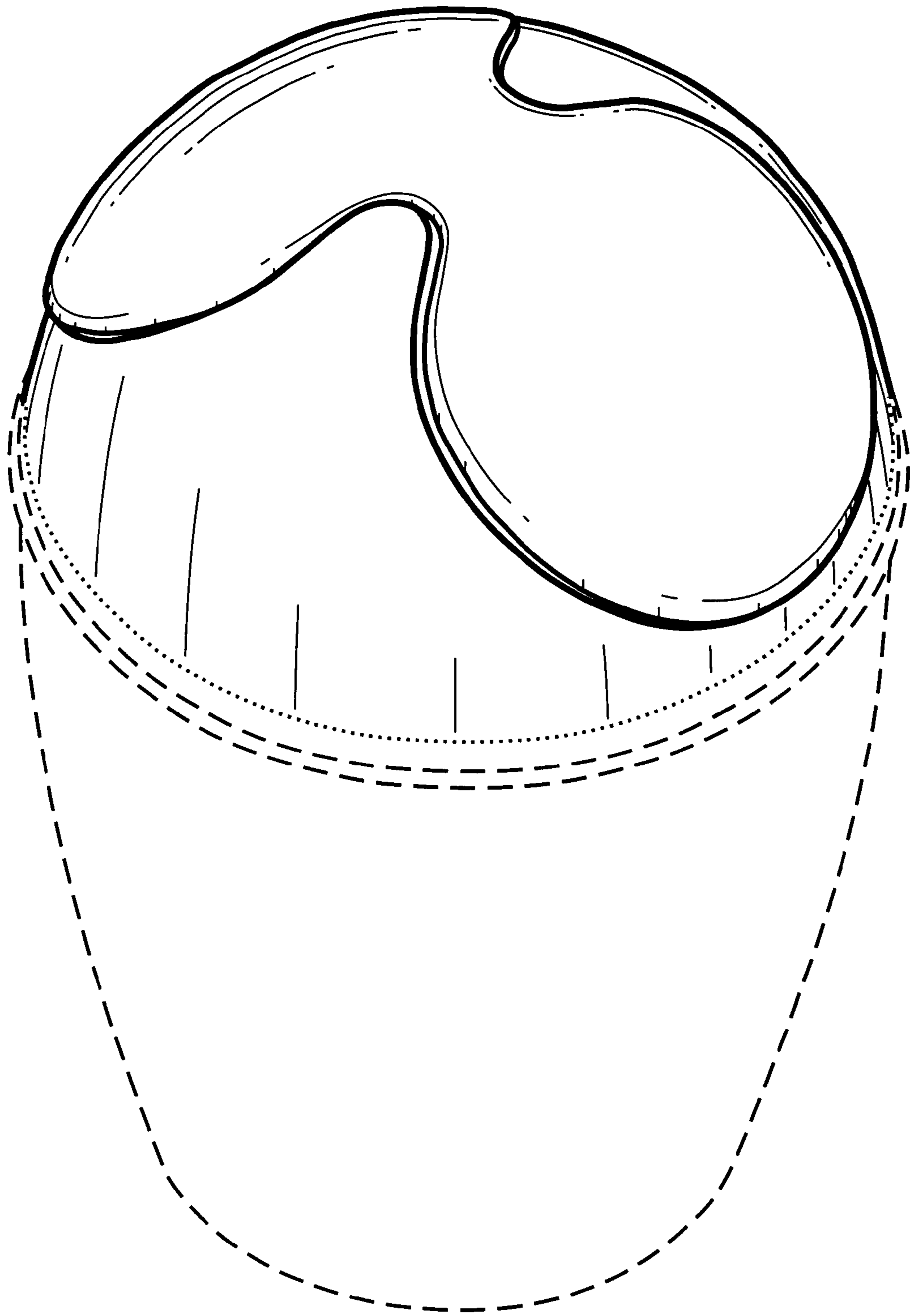
FIG. 4 is a left side view thereof, the right side view being identical.

The bottom is not part of the claimed design.

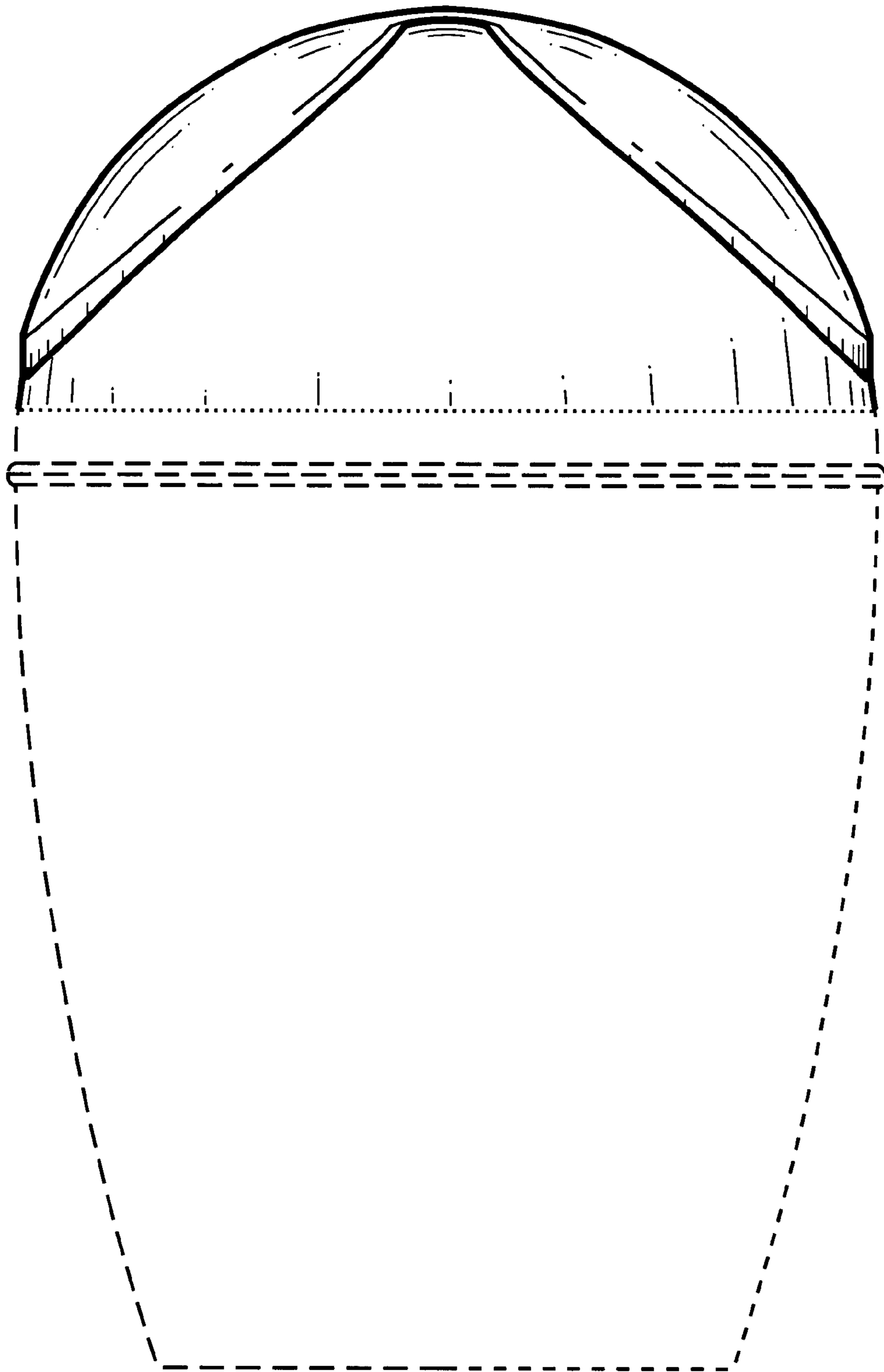

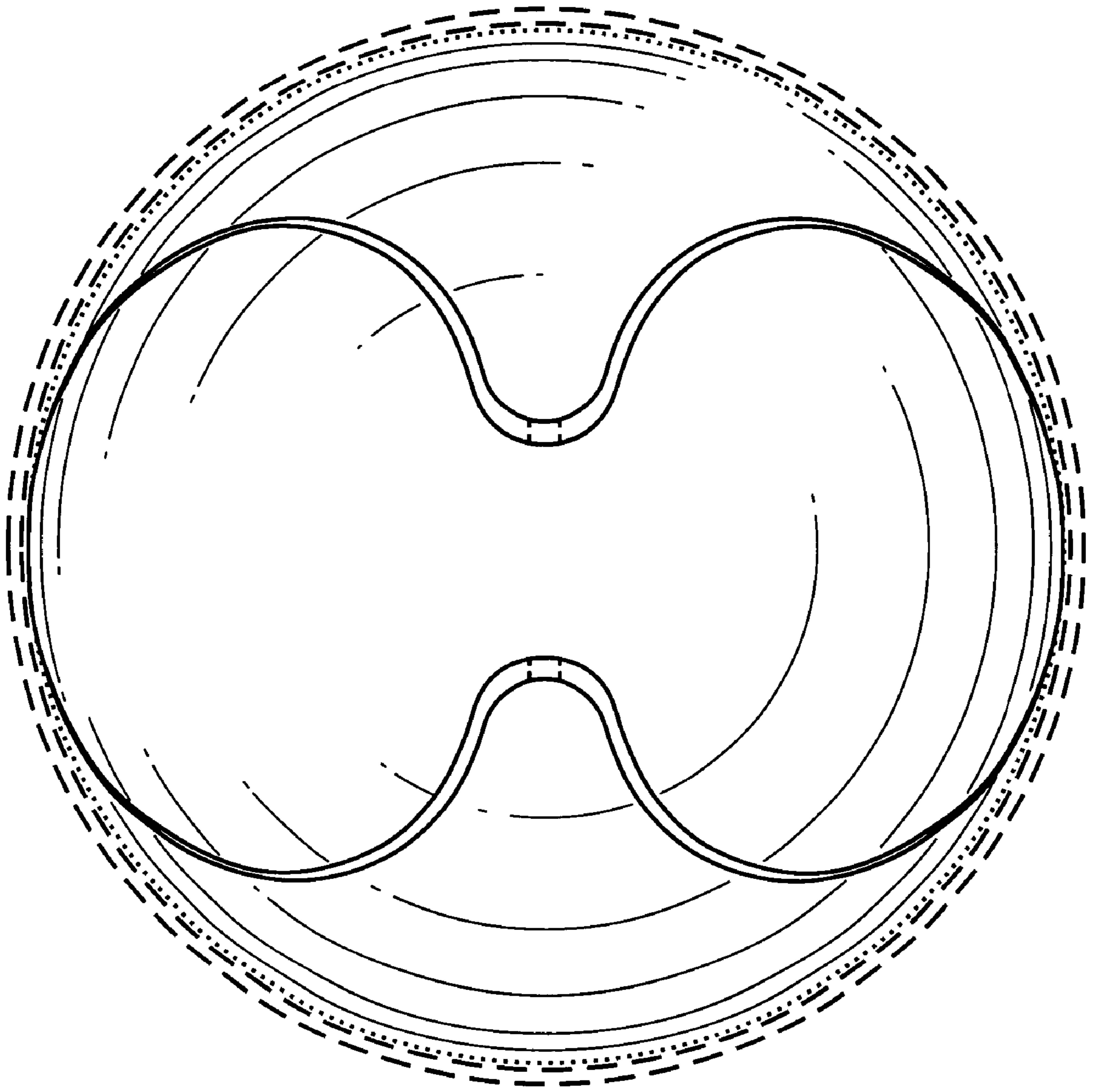




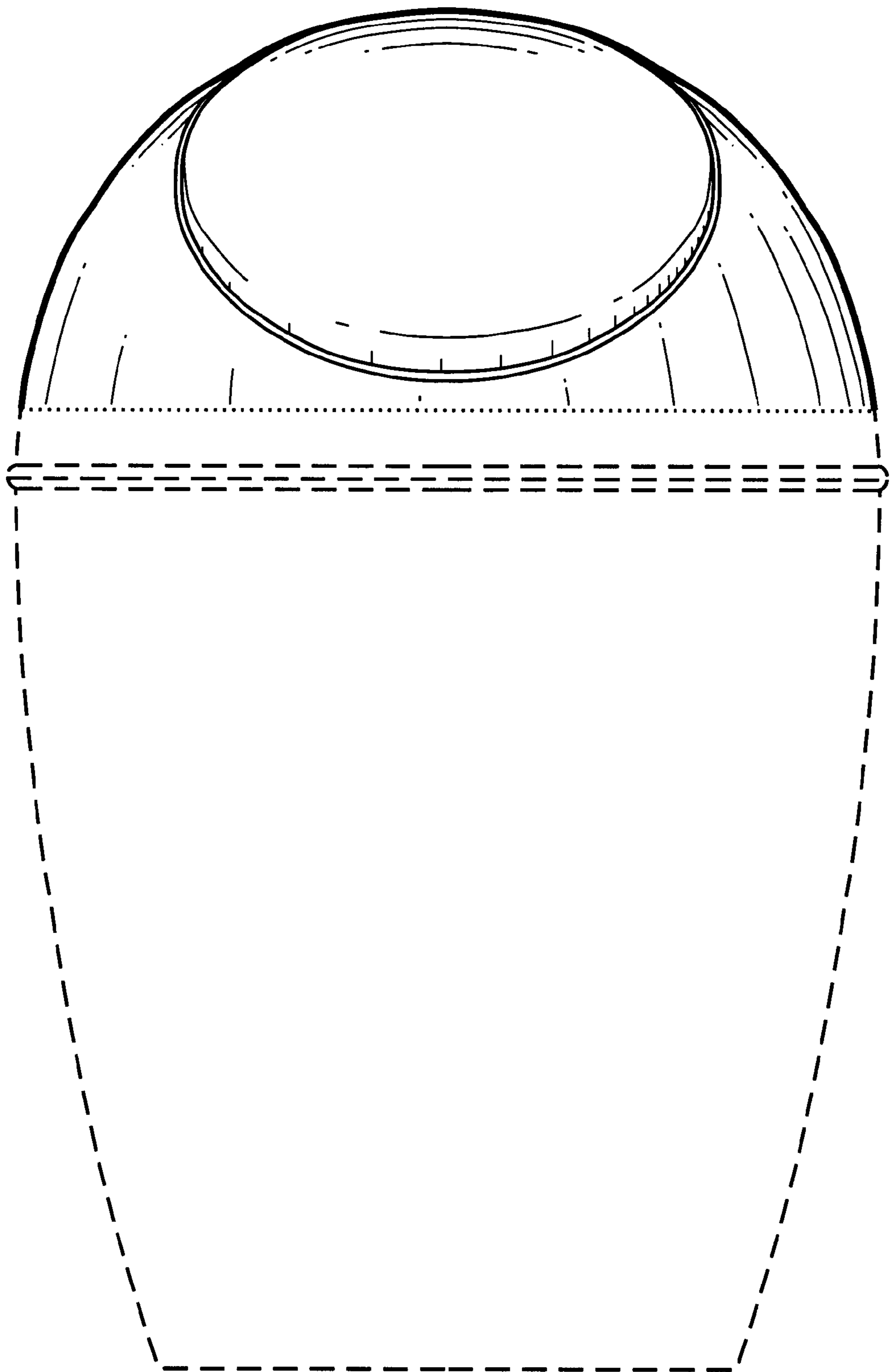
