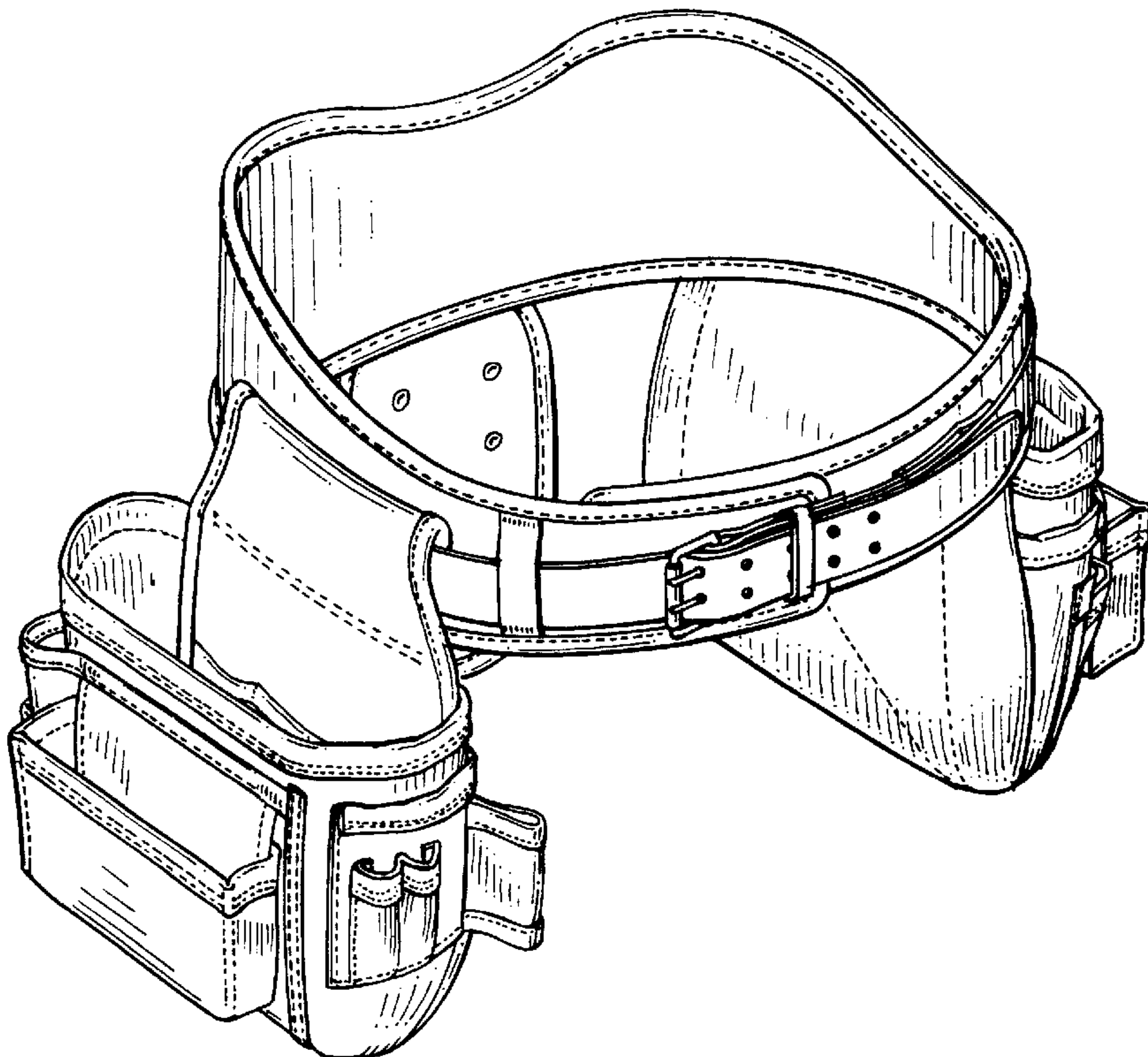
(57) **CLAIM**

The ornamental design for a tool belt, as shown.

**DESCRIPTION**

FIG. 1 is a front perspective view of the tool belt showing our new design;  
FIG. 2 is a rear perspective view;  
FIG. 3 is a plan view of the tool belt in the open position viewed from the outside of the belt;  
FIG. 4 a plan view of the tool belt in the open position from the inside and opposite the side depicted in FIG. 3;  
FIG. 5 is a top plan view of the tool belt of FIG. 3;  
FIG. 6 is a bottom plan view of the tool belt of FIG. 3;  
FIG. 7 is a side view of the tool belt as viewed from the buckle end of the belt in FIG. 3 depicting a pocket section of the design of the tool belt;  
FIG. 8 is a side view of the tool belt as viewed in FIG. 3 at the opposite end from the view of FIG. 7;  
FIG. 9 is a side view taken along the line 9—9 in FIG. 3; and,  
FIG. 10 is a side view taken along the line 10—10 in FIG. 3.

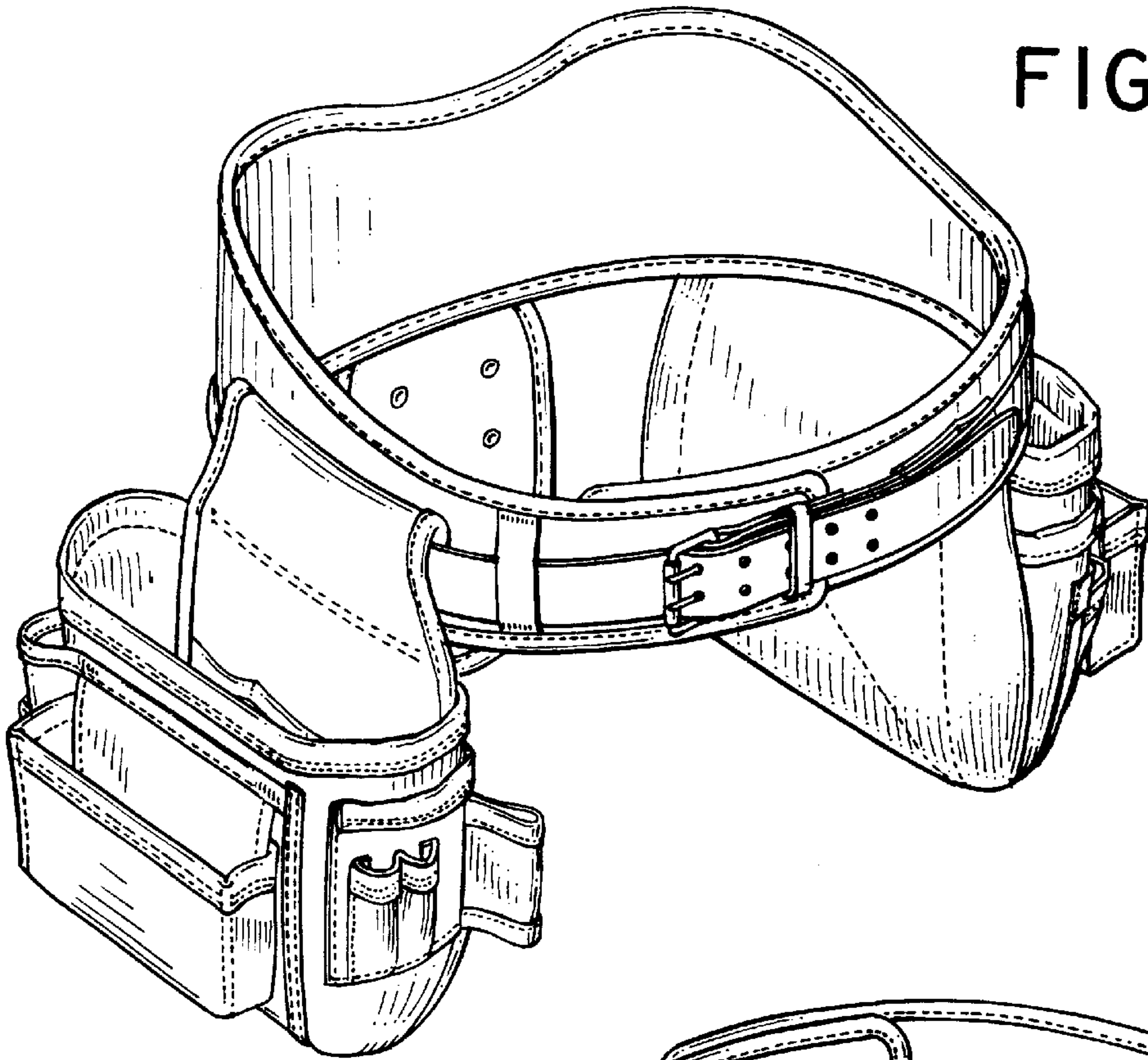

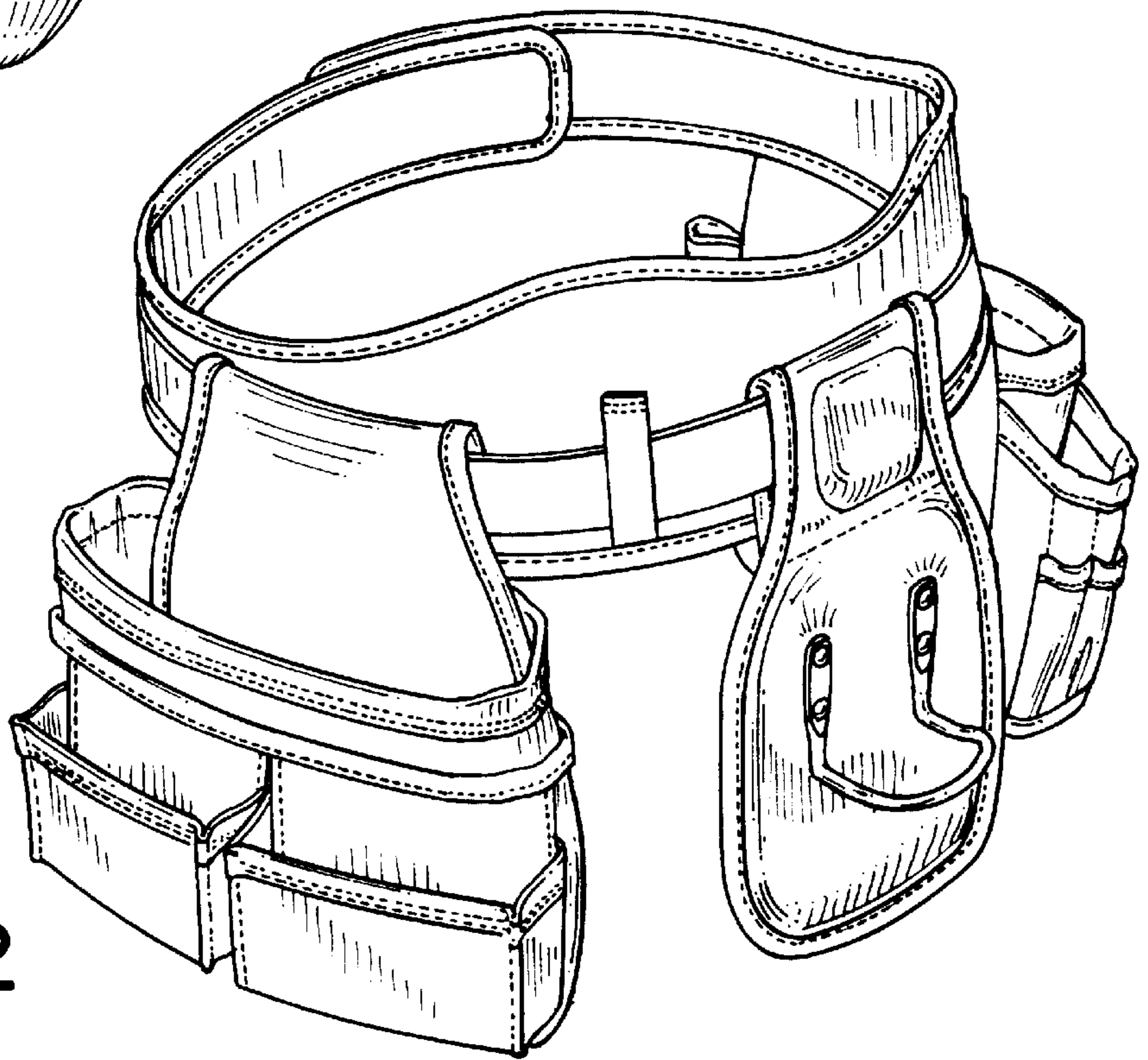

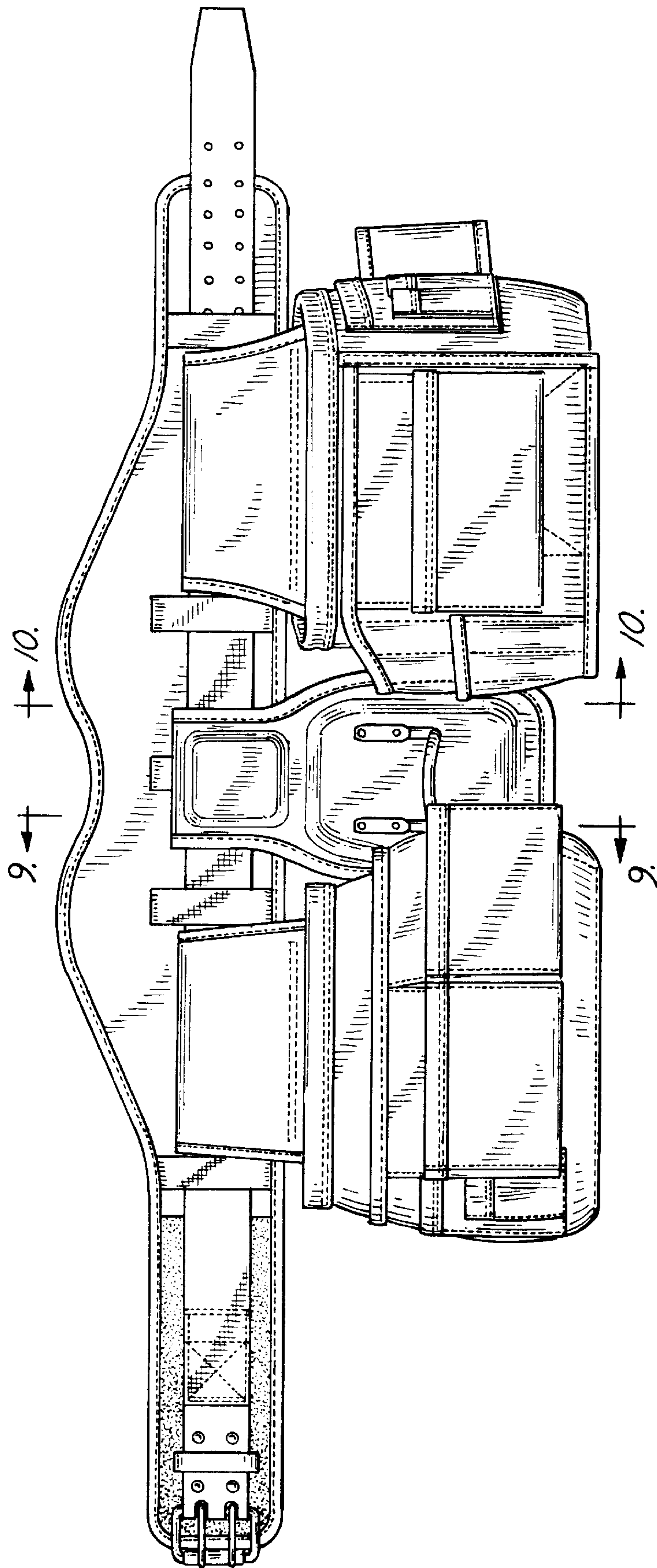

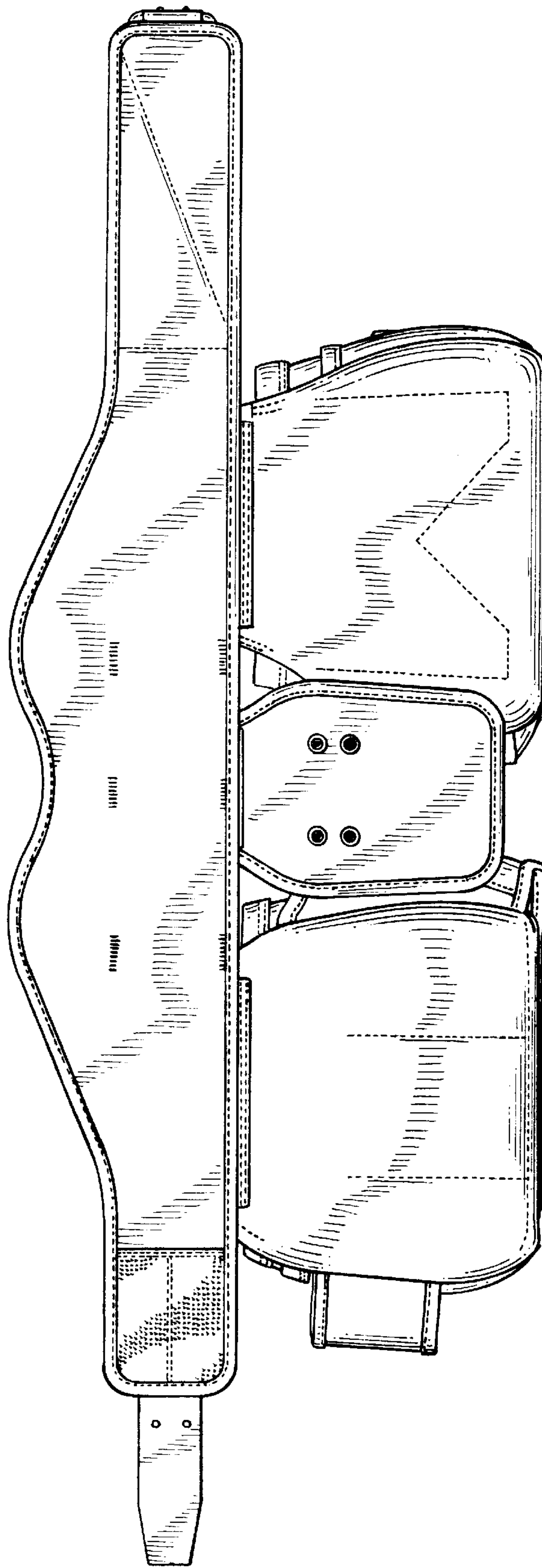

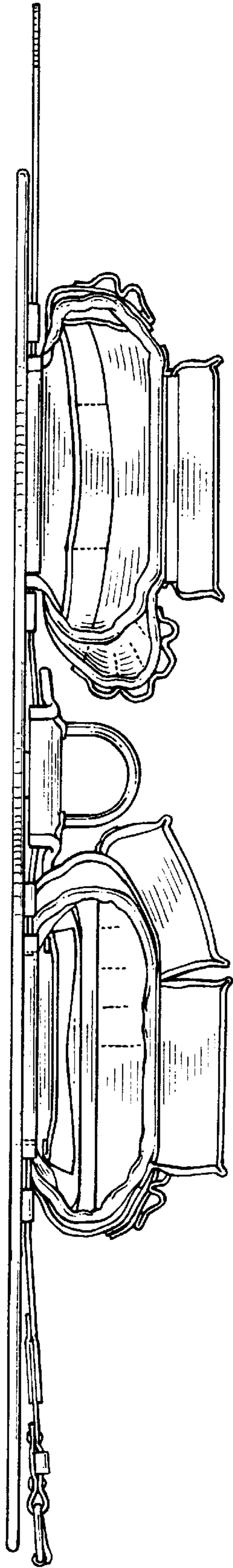

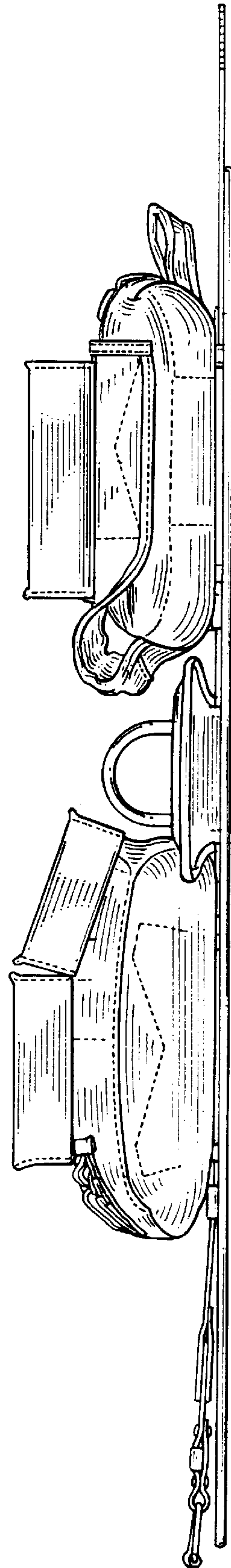

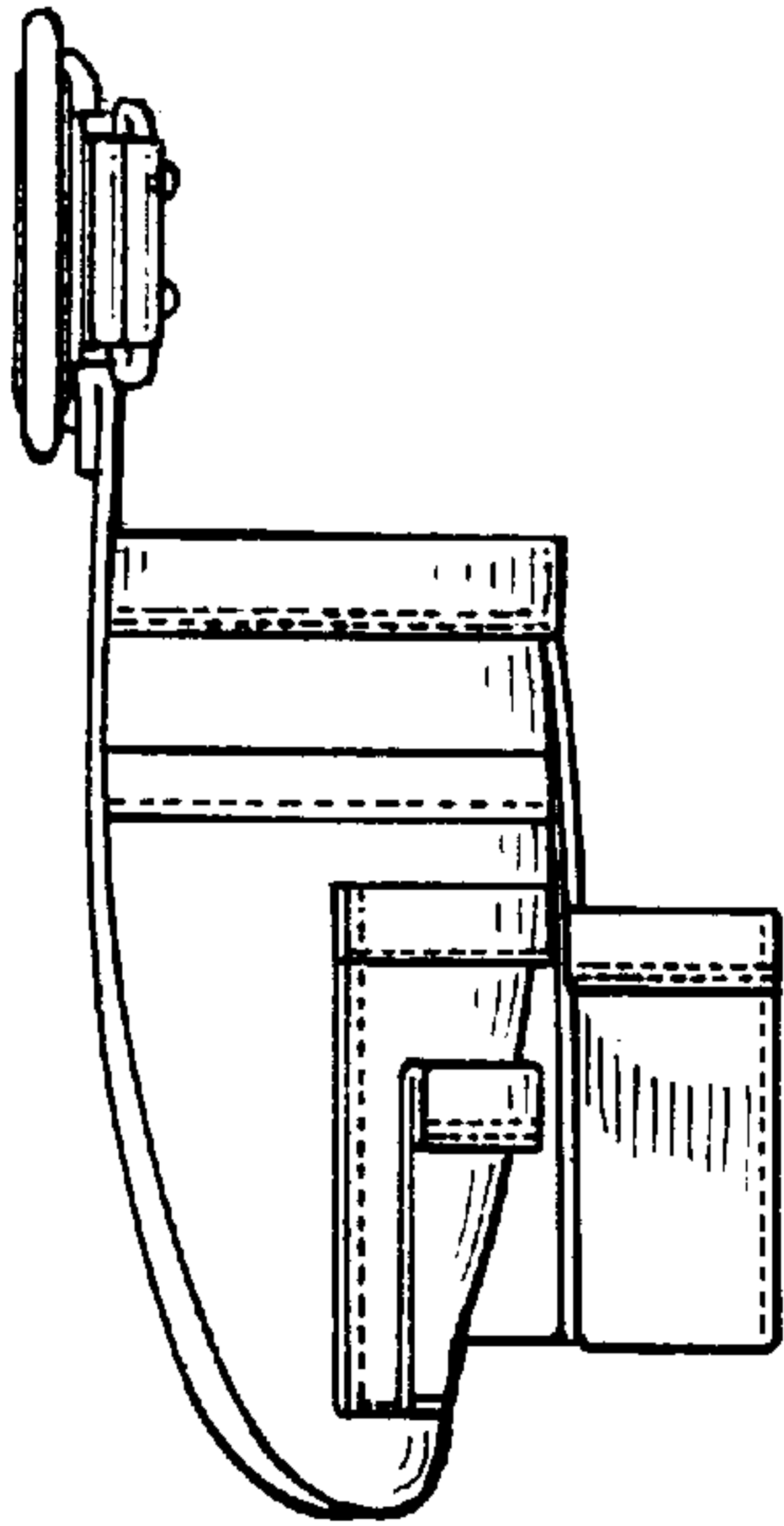

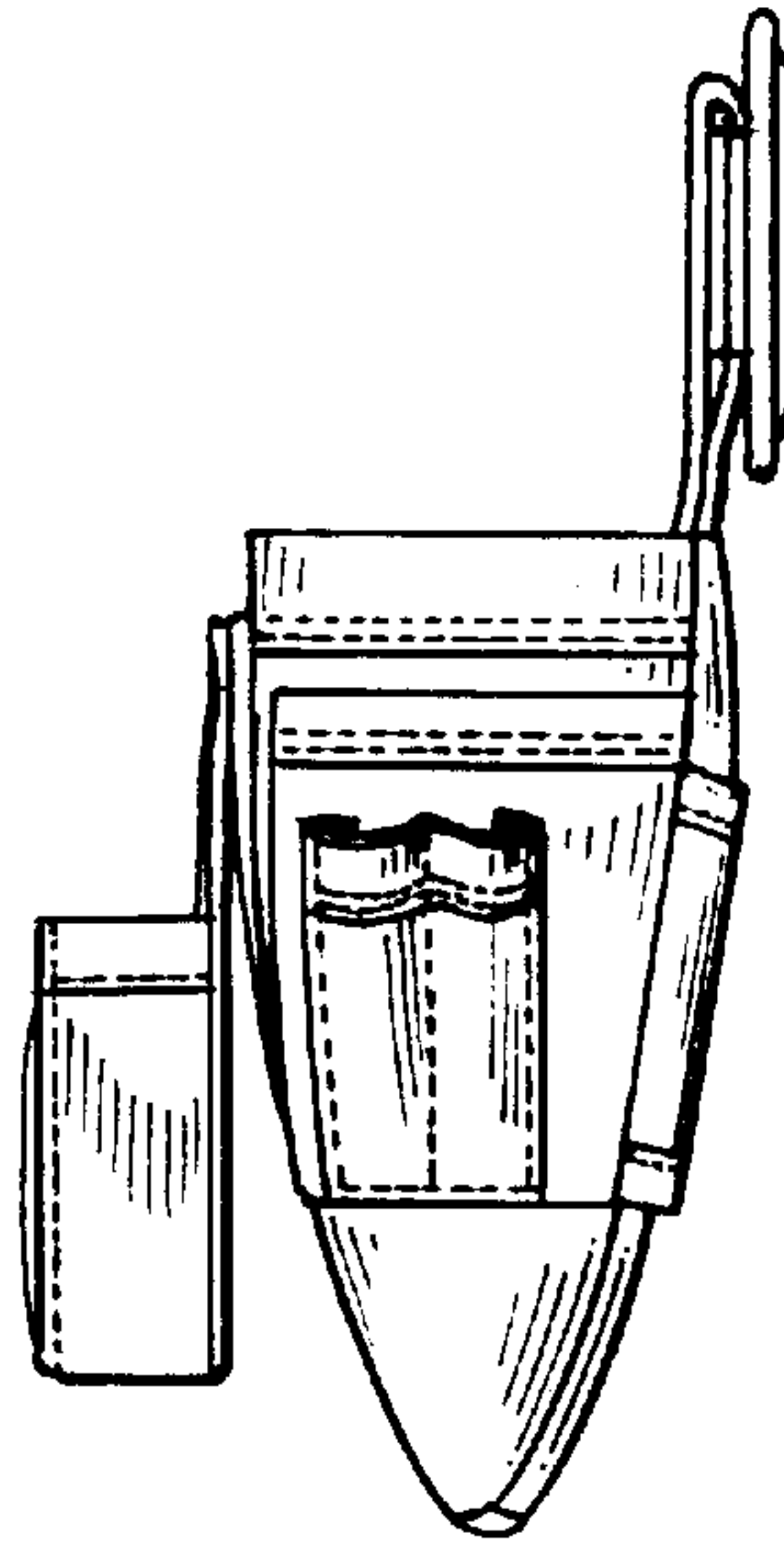

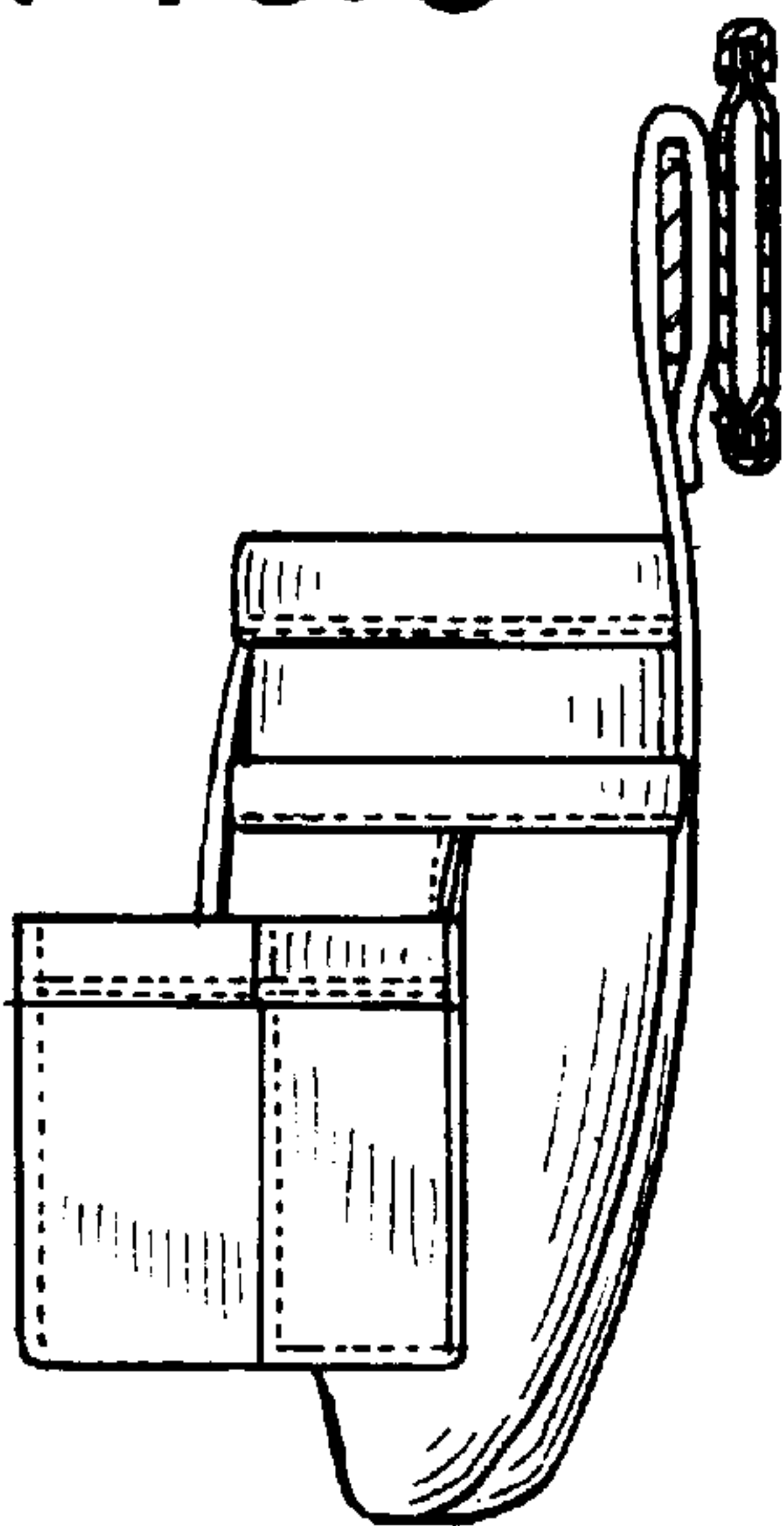
