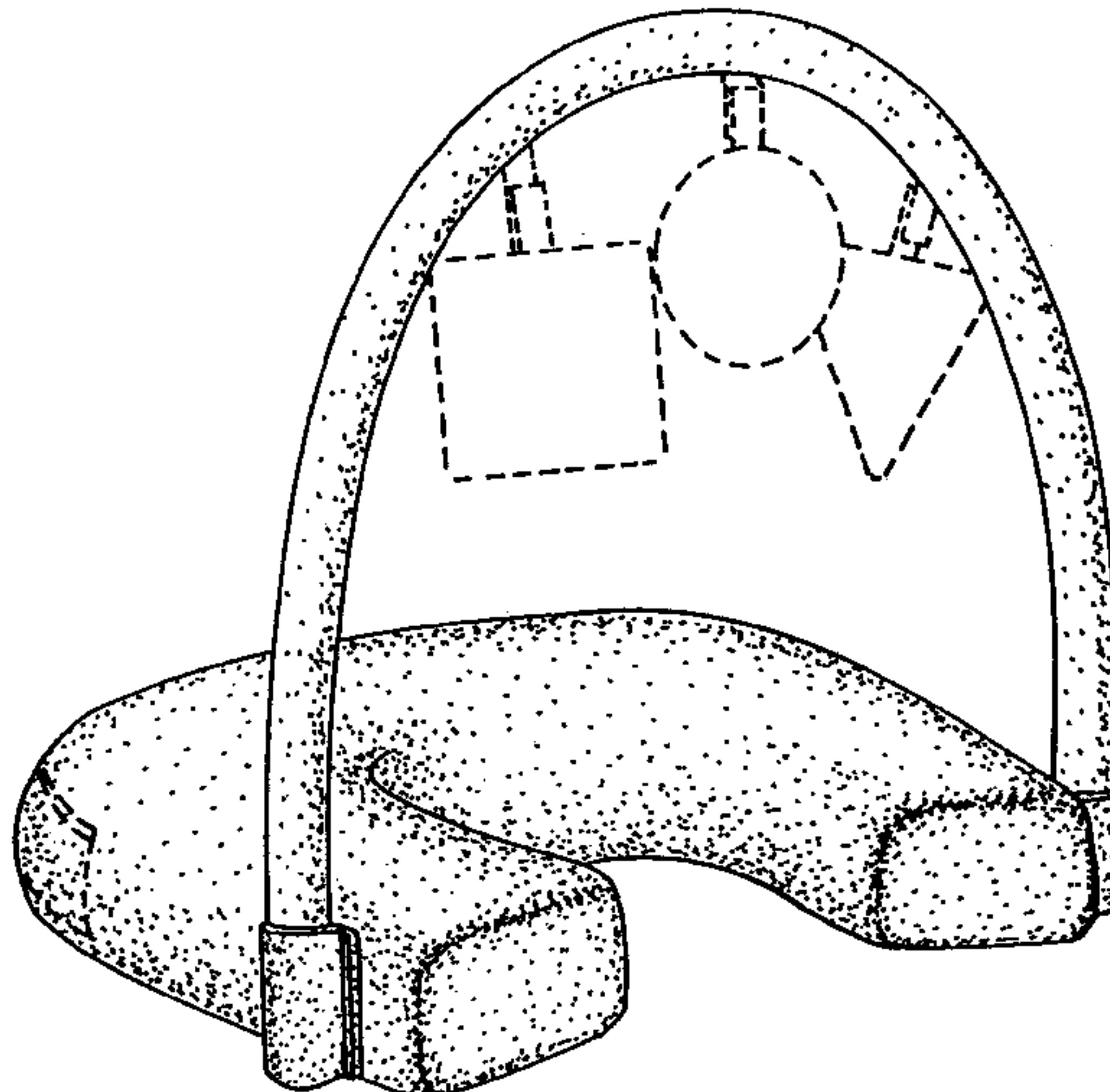

DESCRIPTION

FIG. 1 is a perspective view of an infant support pillow showing our new design;
FIG. 2 is a front view of the infant support pillow of FIG. 1;
FIG. 3 is a rear view of the infant support pillow of FIG. 1;
FIG. 4 is a top view of the infant support pillow of FIG. 1;
FIG. 5 is a bottom view of the infant support pillow of FIG. 1;
FIG. 6 is a right side view of the infant support pillow of FIG. 1;
FIG. 7 is a left side view of the infant support pillow of FIG. 1; and,
FIG. 8 is a perspective view of an alternate embodiment of the infant support pillow according to our new design.
The broken lines in the figures merely illustrate the environment for the infant support pillow of the present design and therefore form no part of the claimed design.

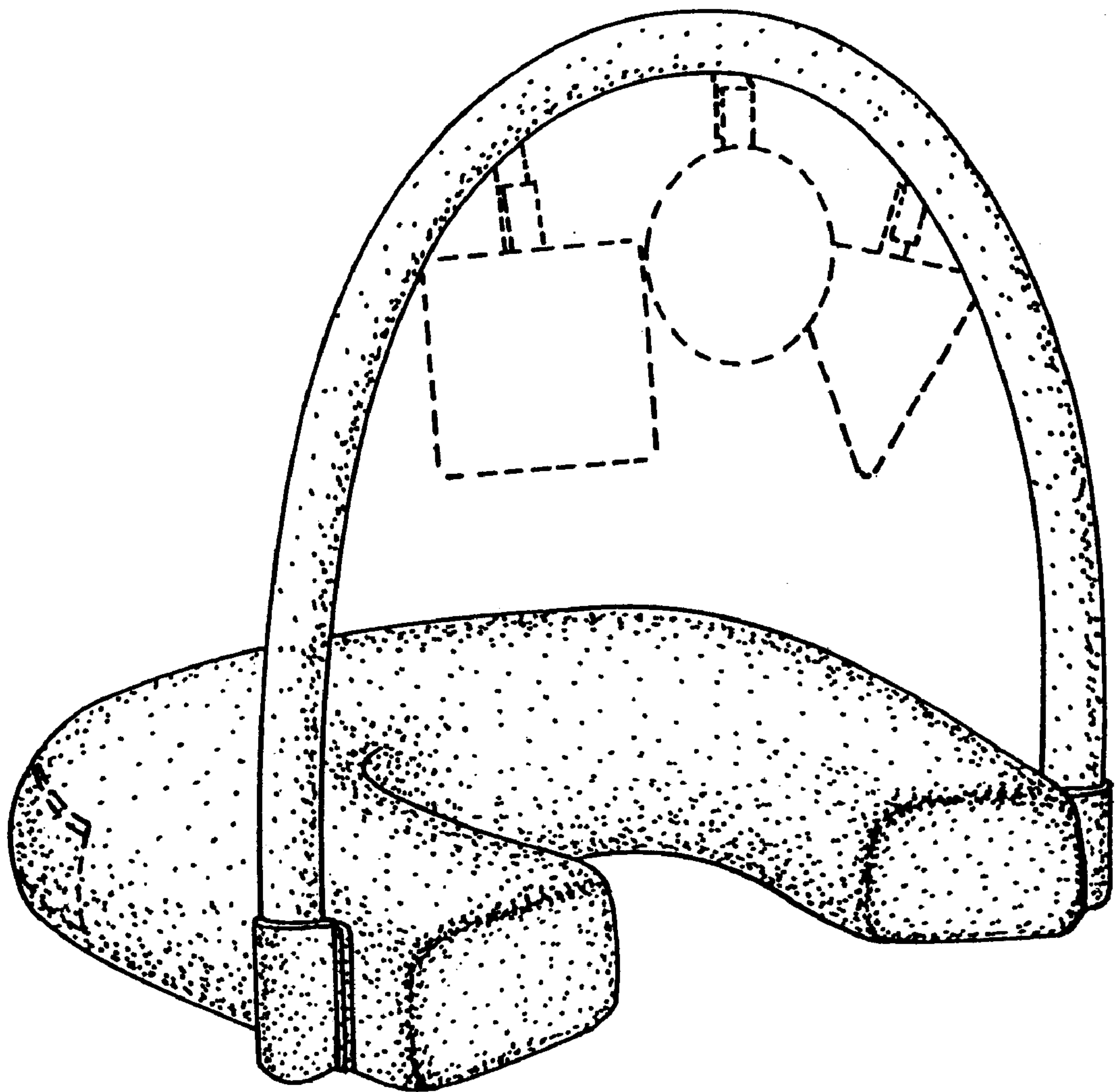

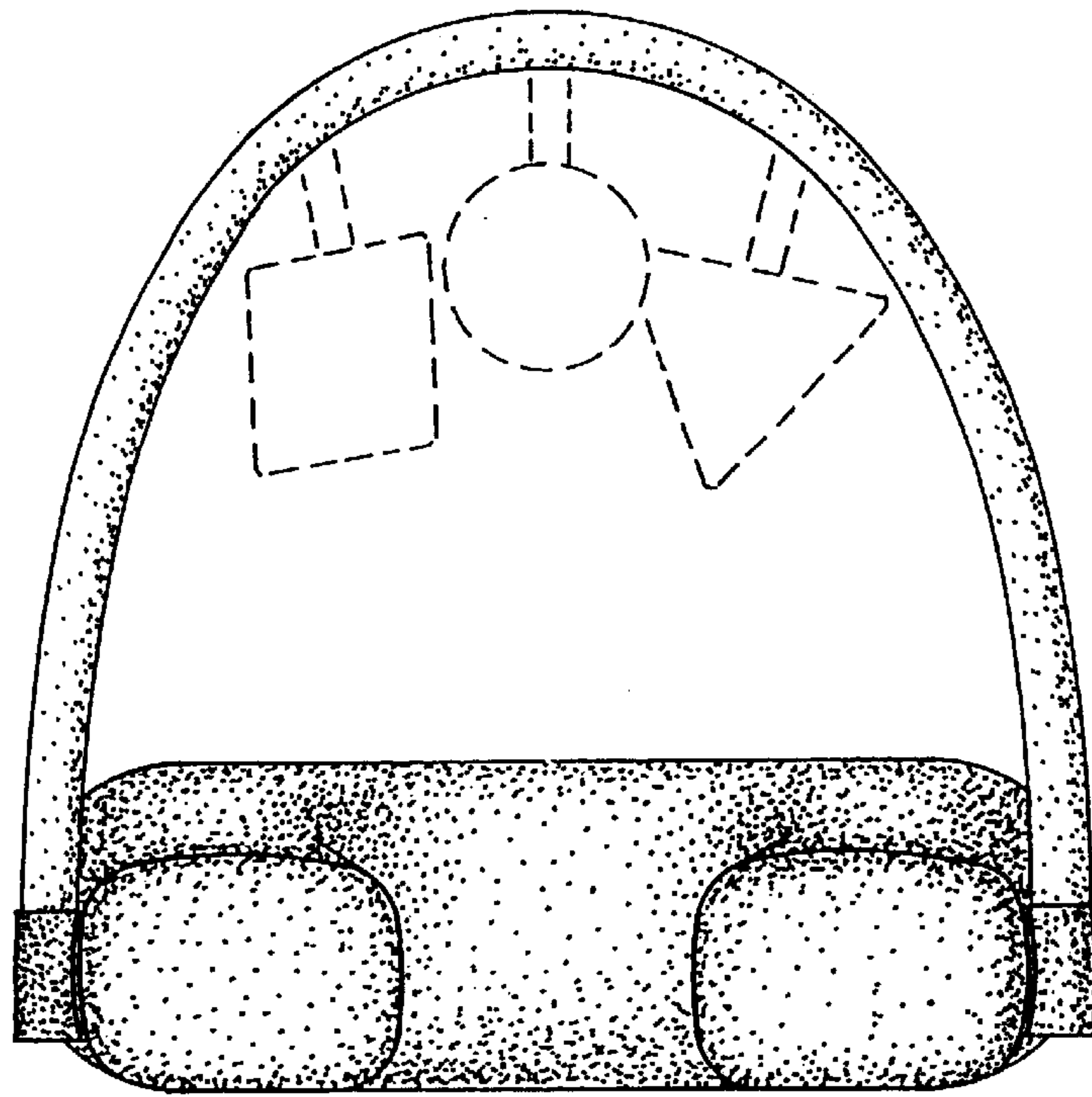

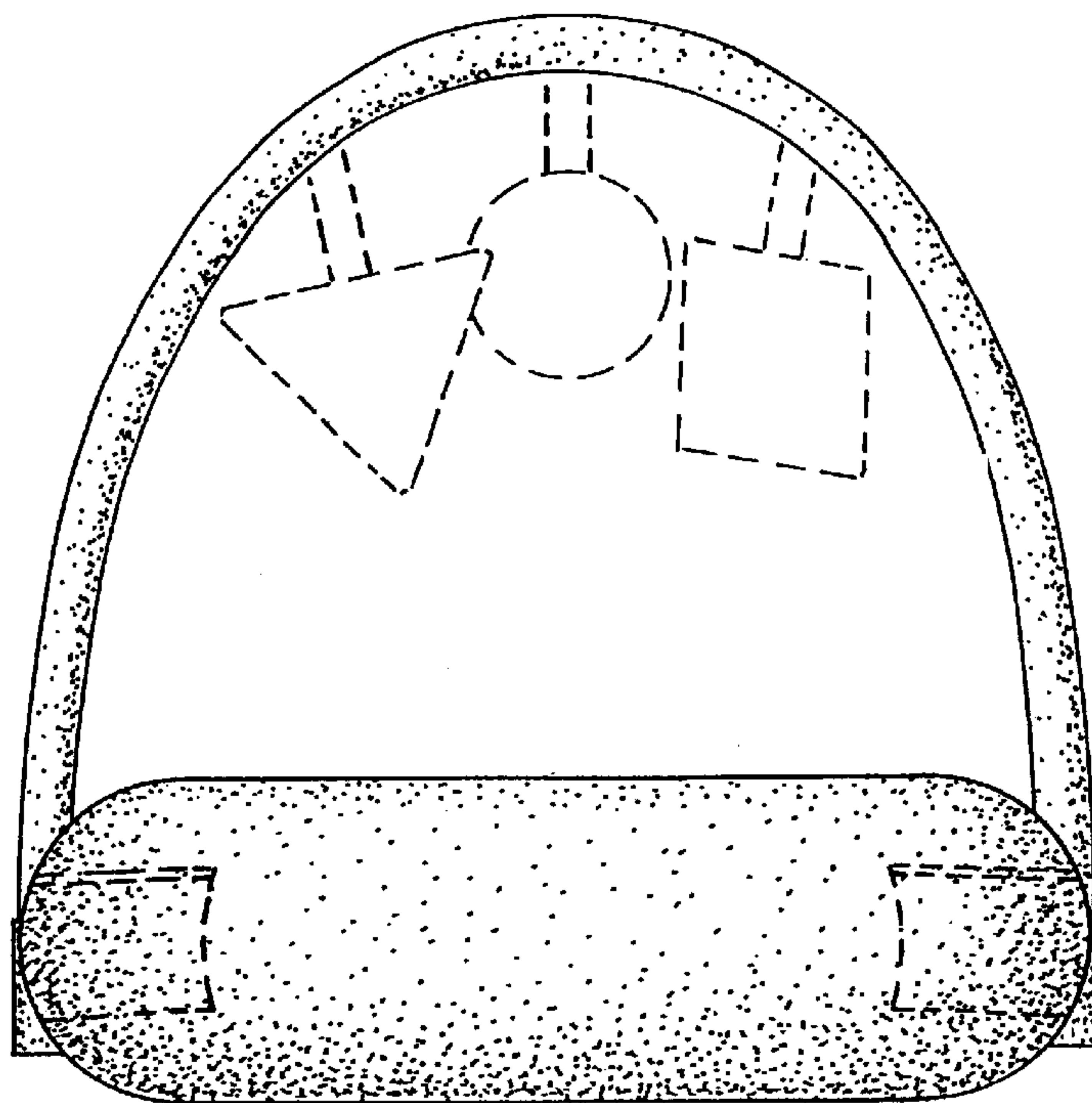

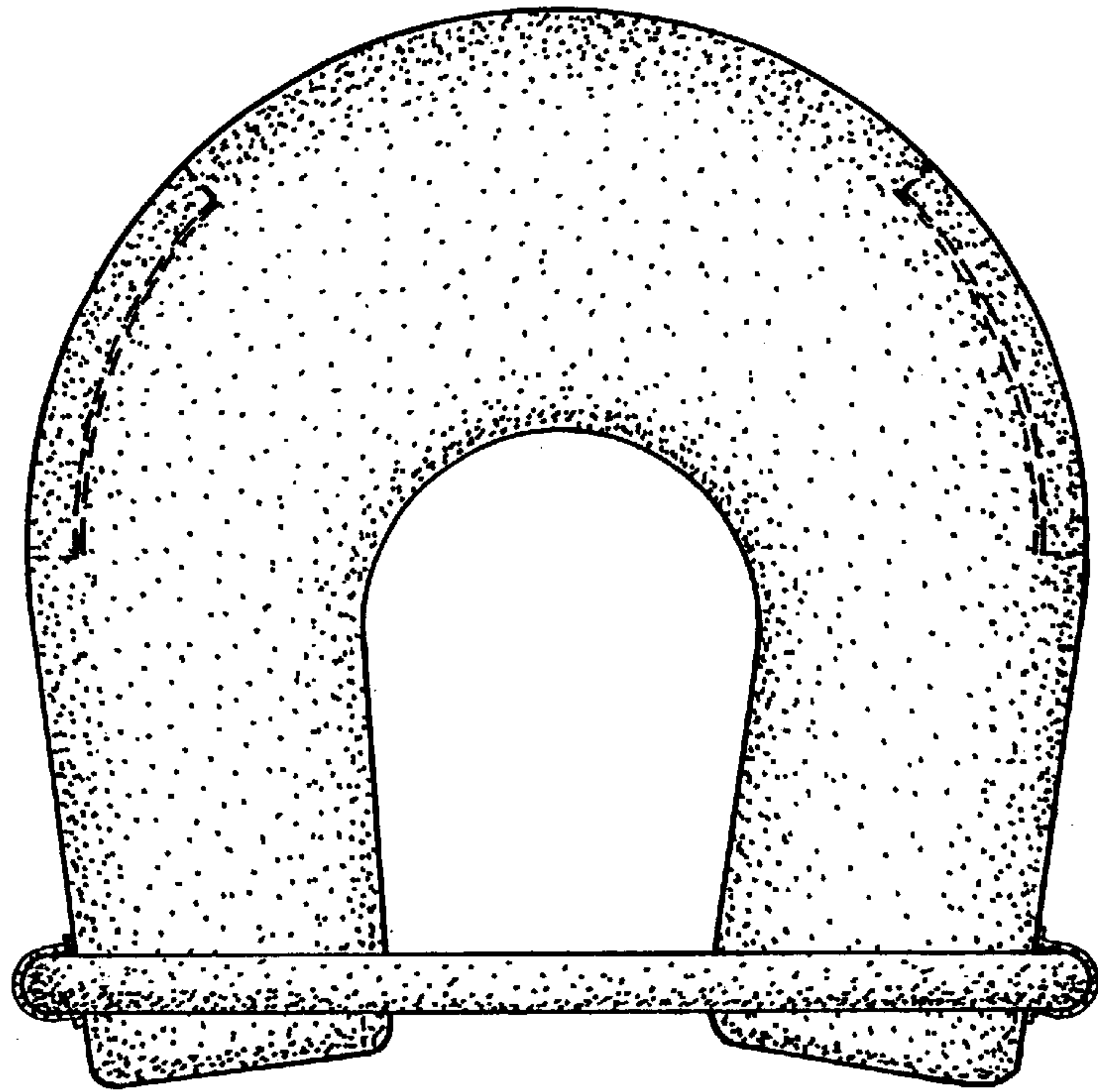

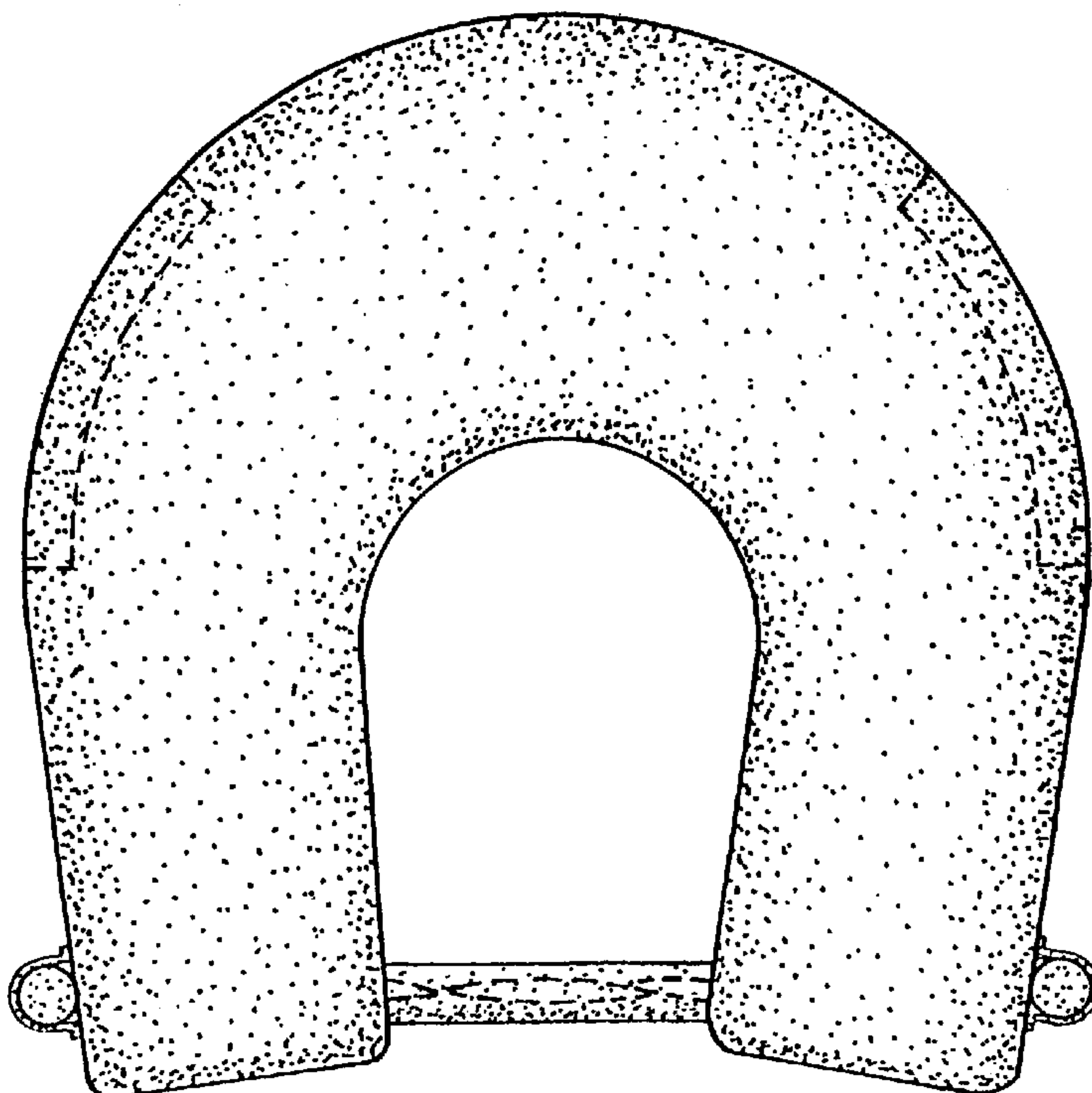

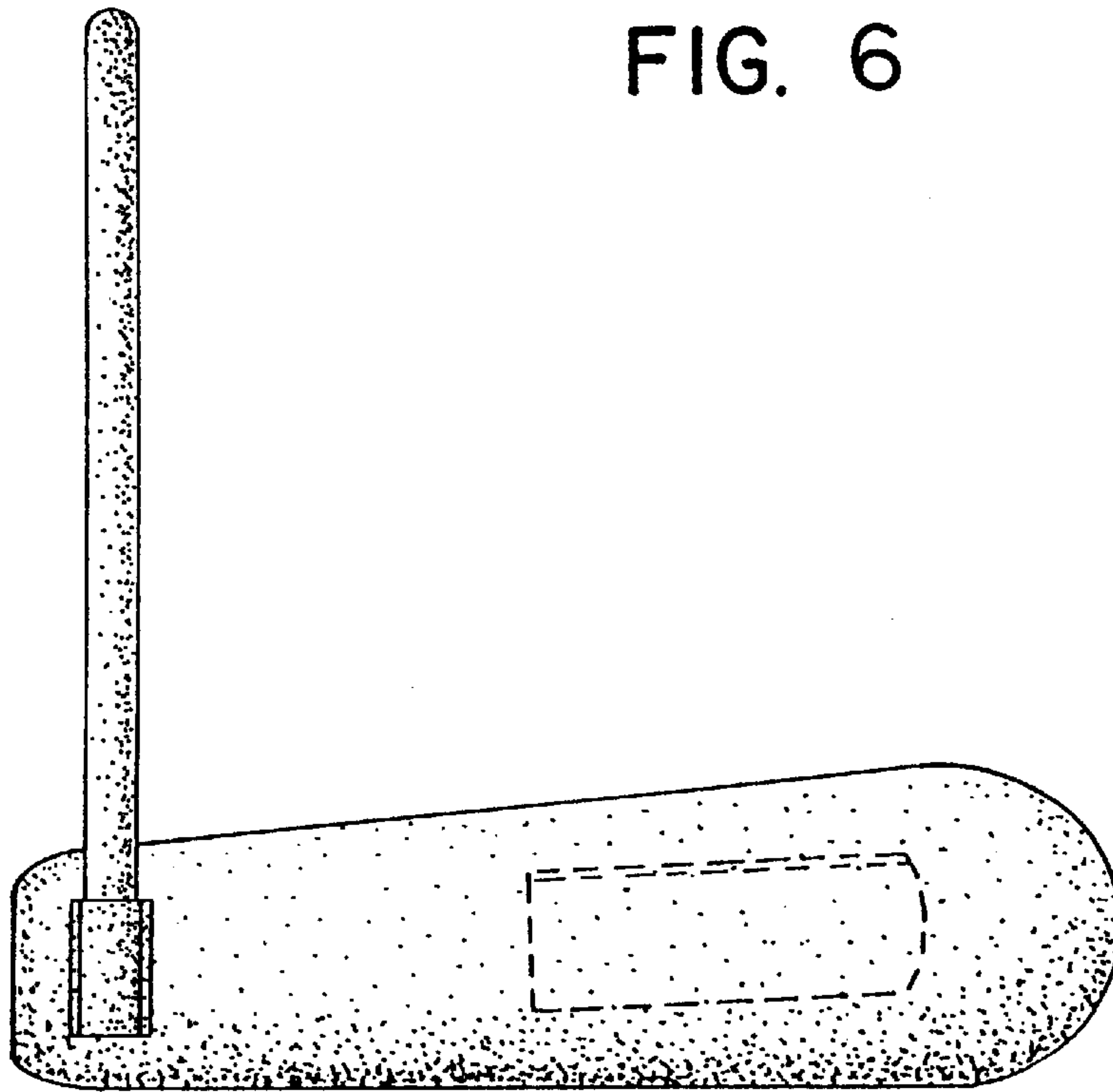

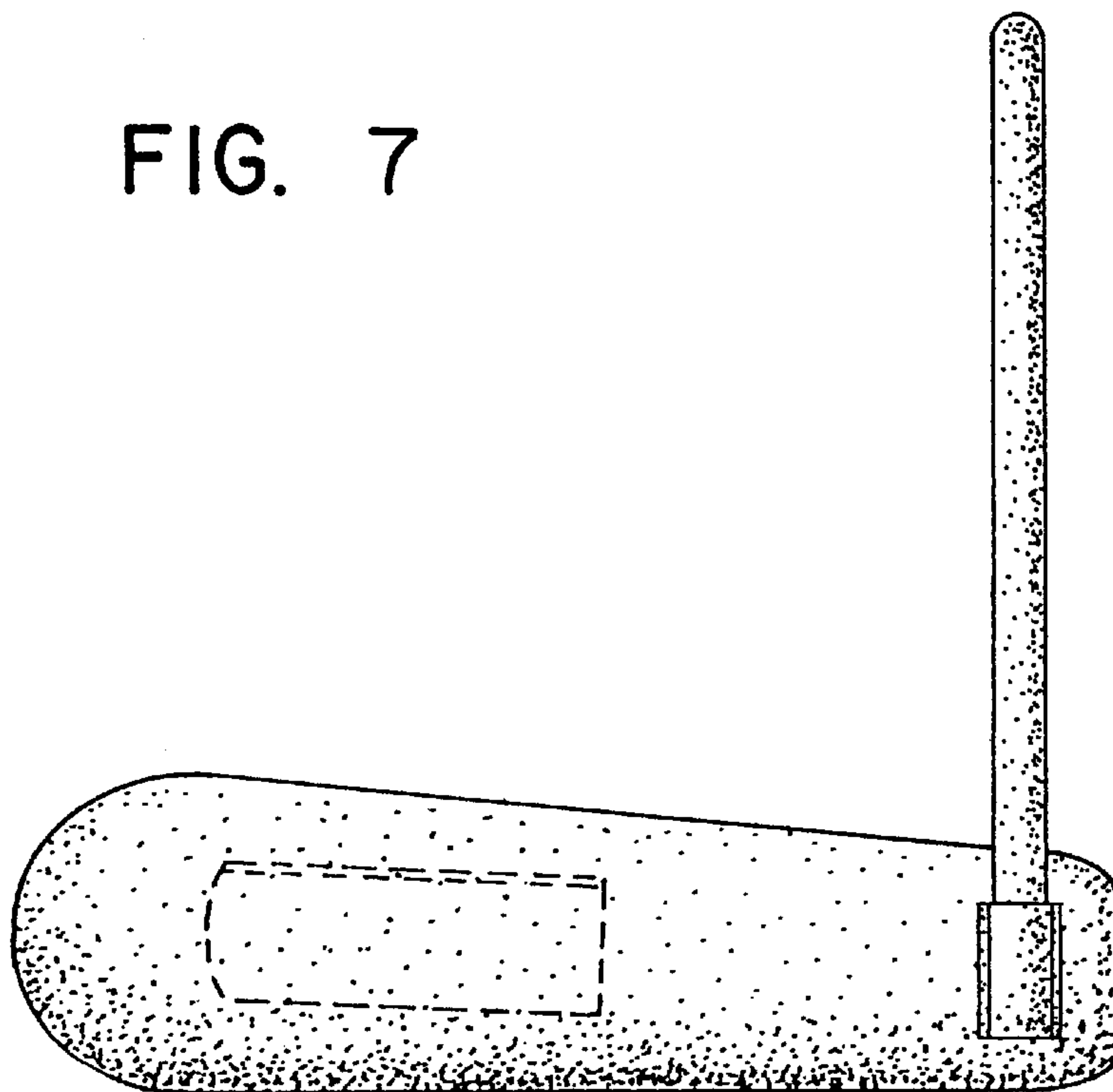
