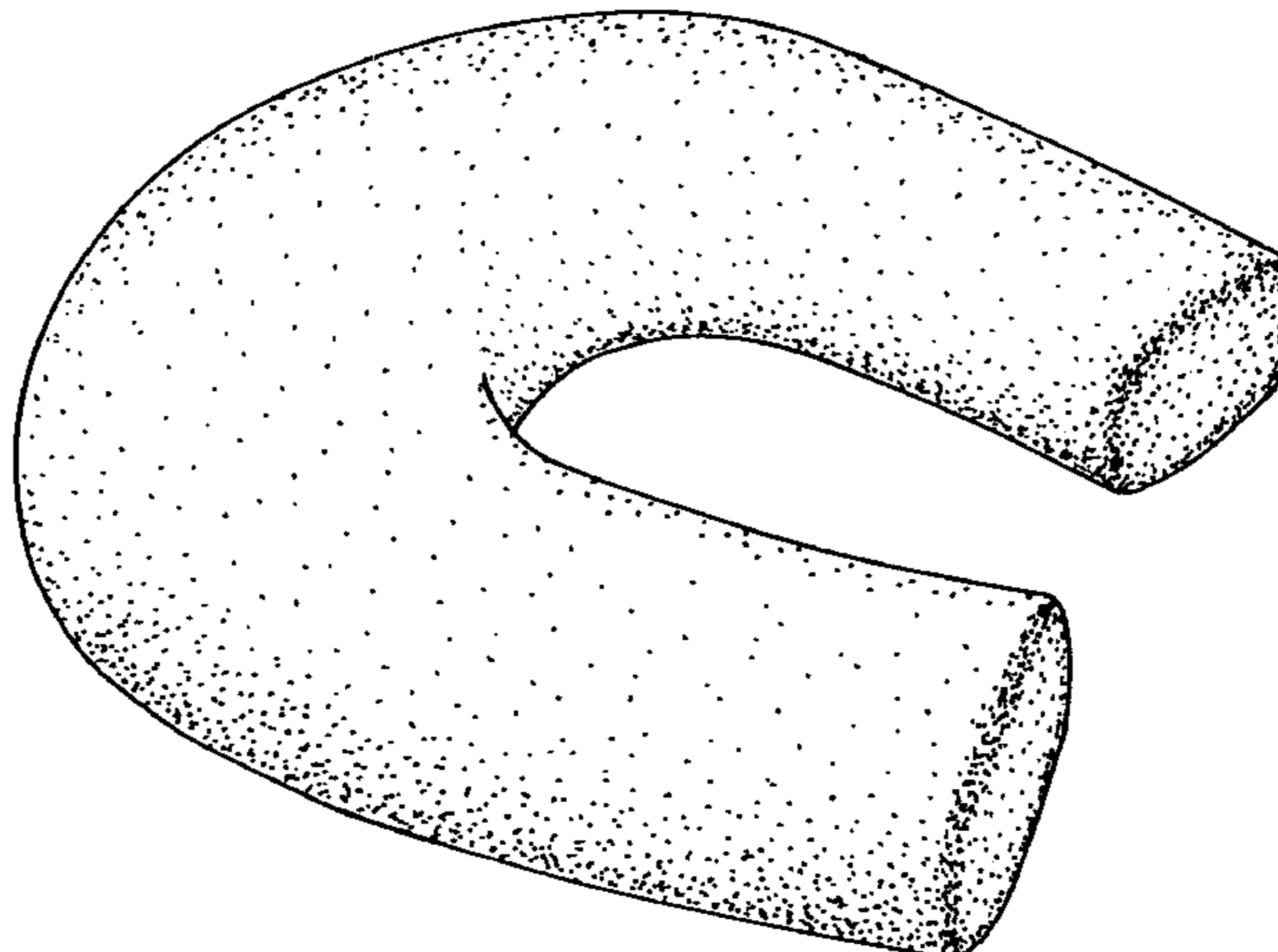
(57) **CLAIM**

The ornamental design for an infant support pillow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an infant support pillow showing our new design; FIG. 2 is a front view of the infant support pillow of FIG. 1; FIG. 3 is a rear view of the infant support pillow of FIG. 1; FIG. 4 is a top view of the infant support pillow of FIG. 1; FIG. 5 is a bottom view of the infant support pillow of FIG. 1; FIG. 6 is a right side view of the infant support pillow of FIG. 1; and, FIG. 7 is a left side view of the infant support pillow of FIG. 1.

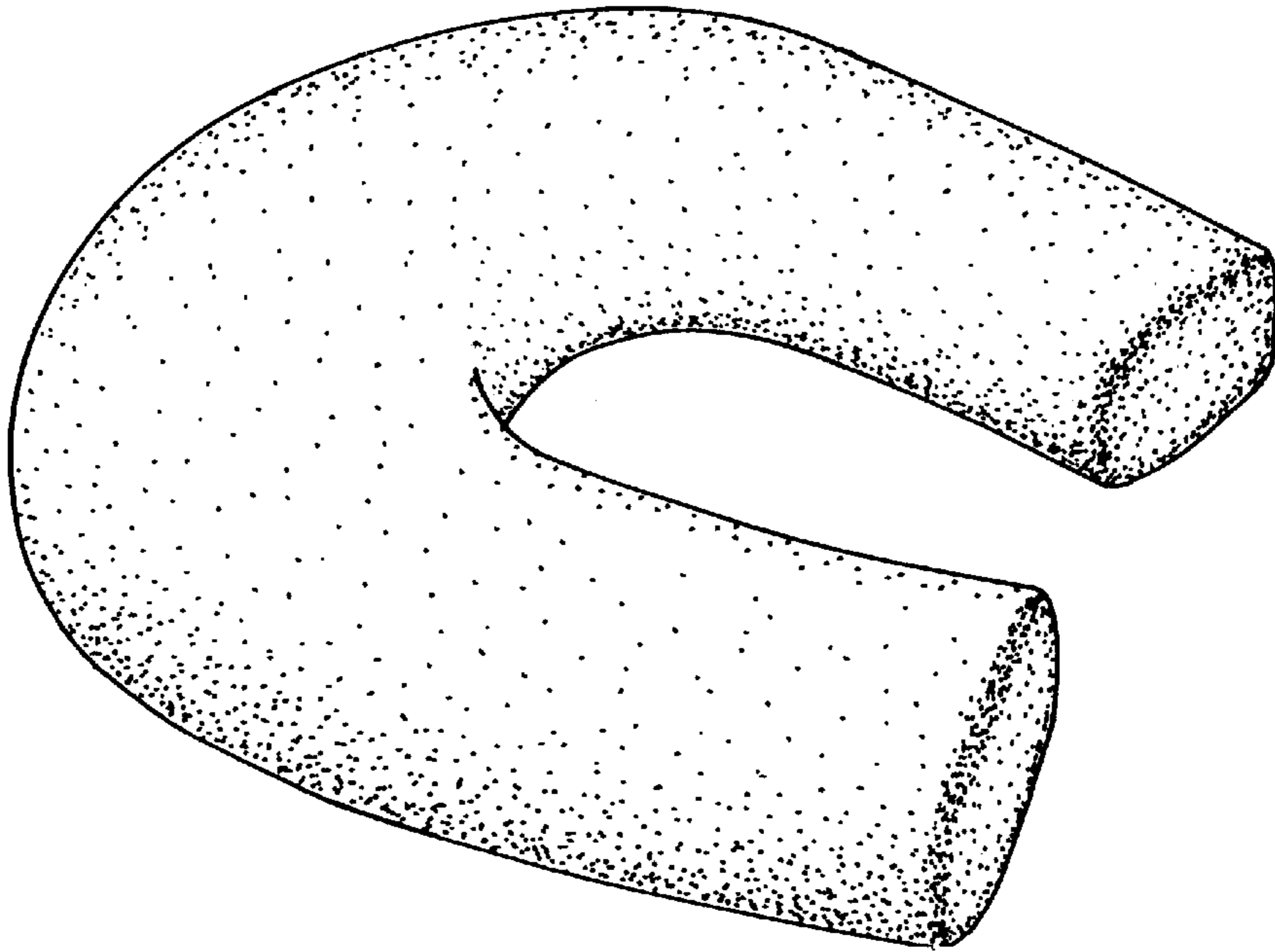

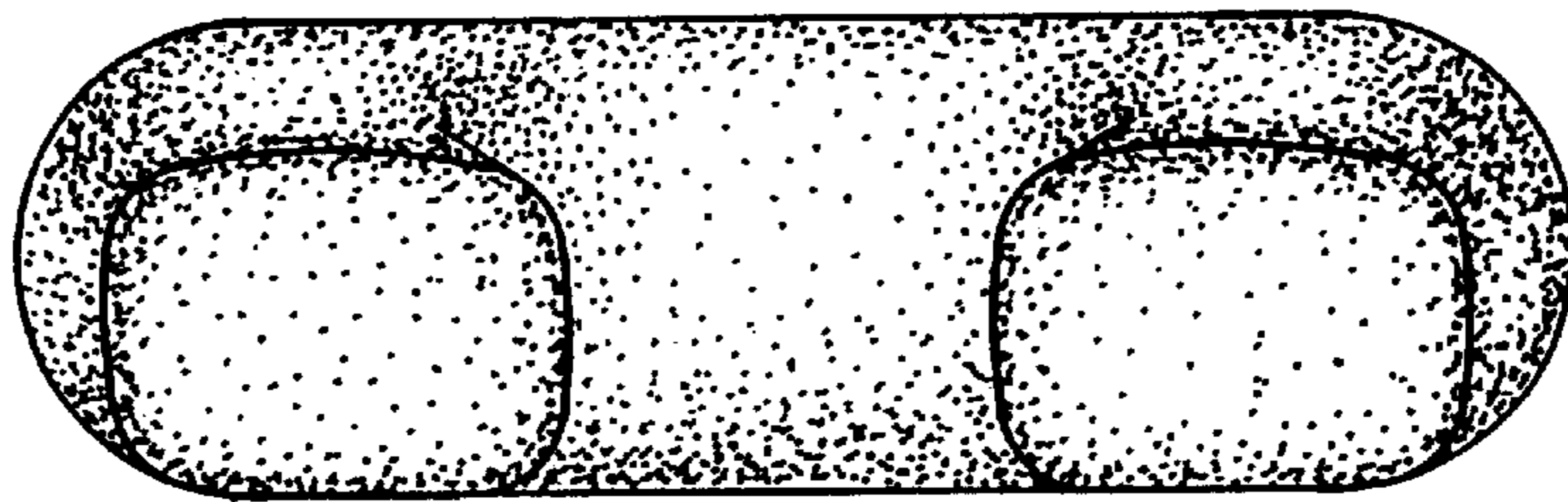

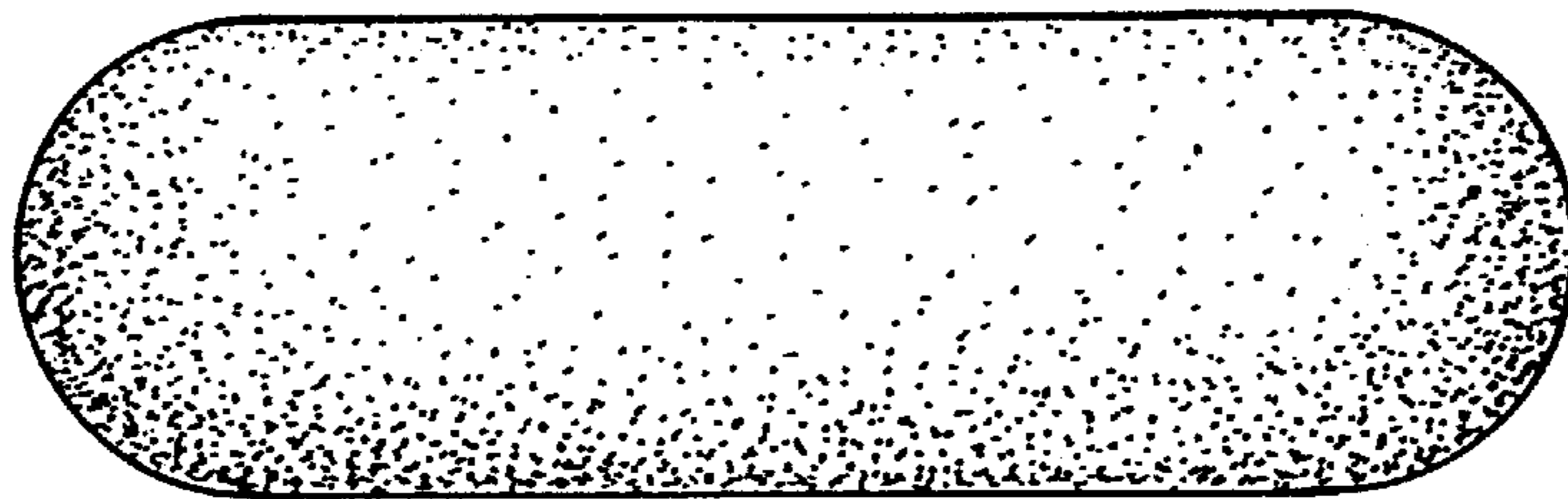

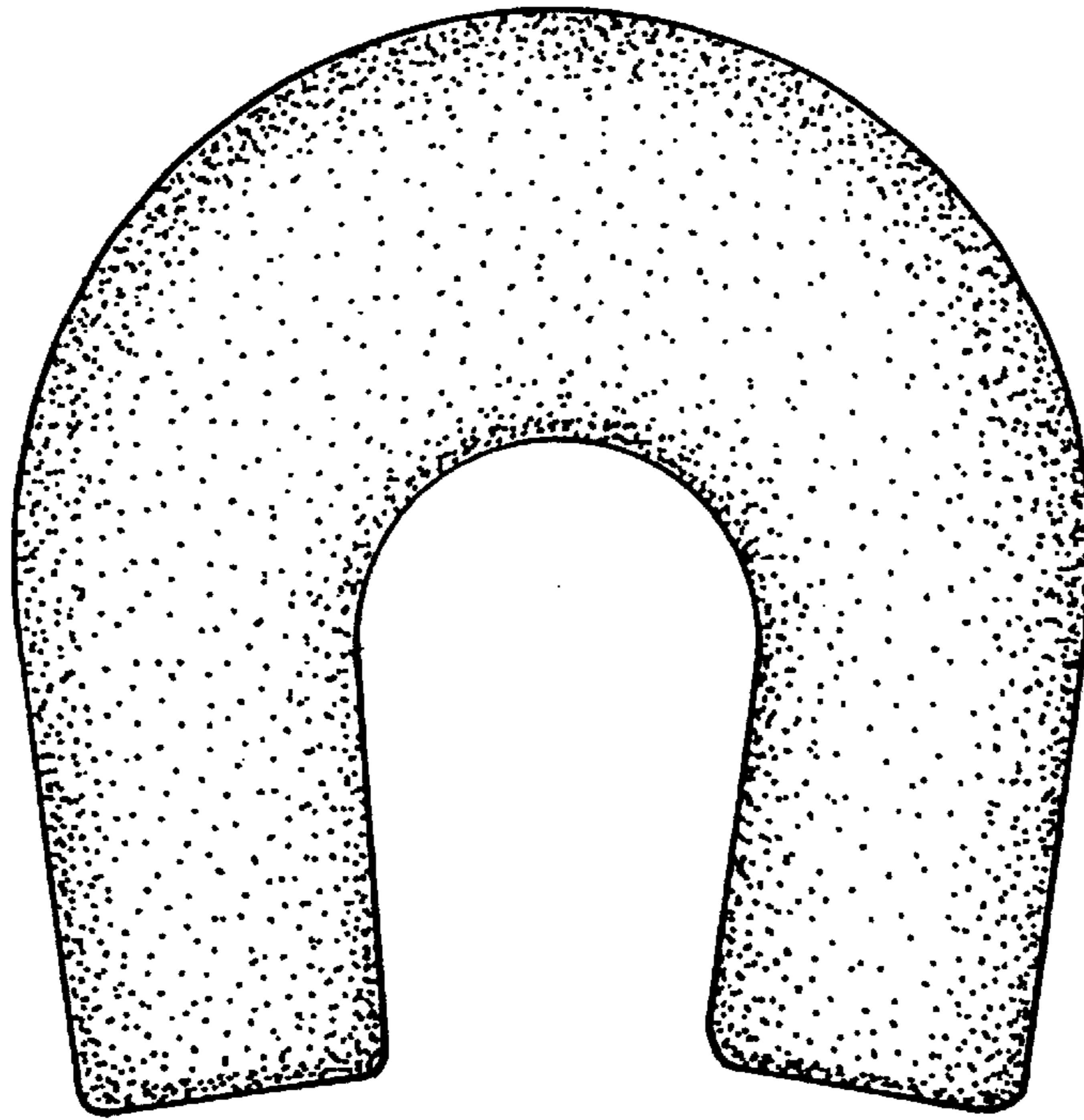

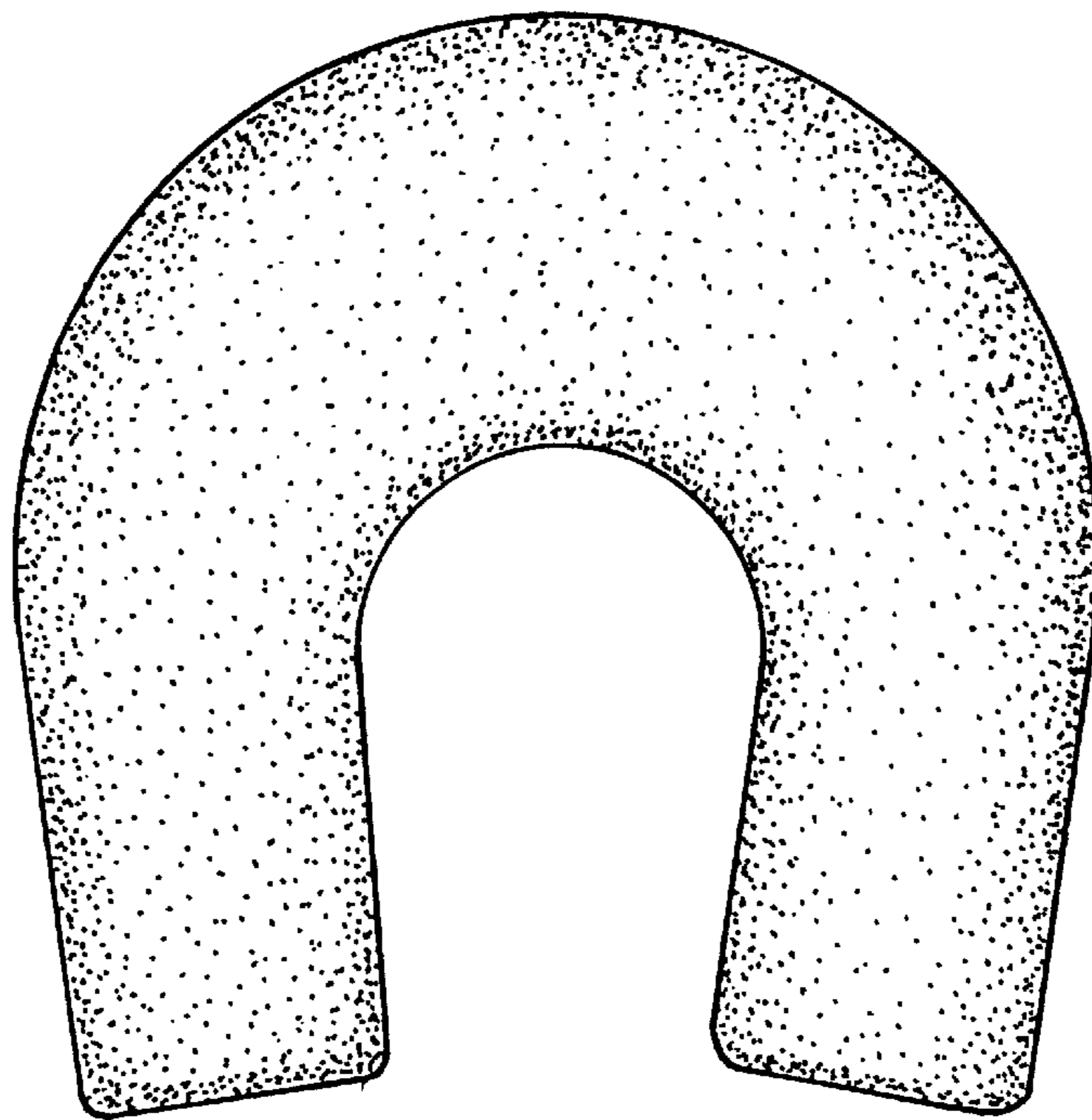

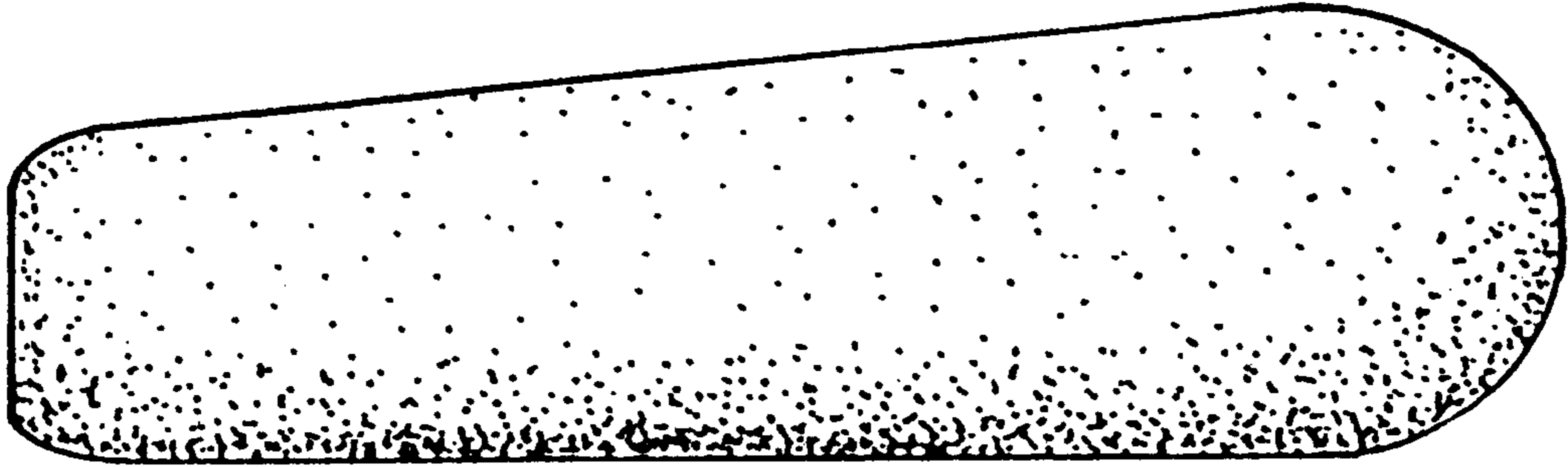
