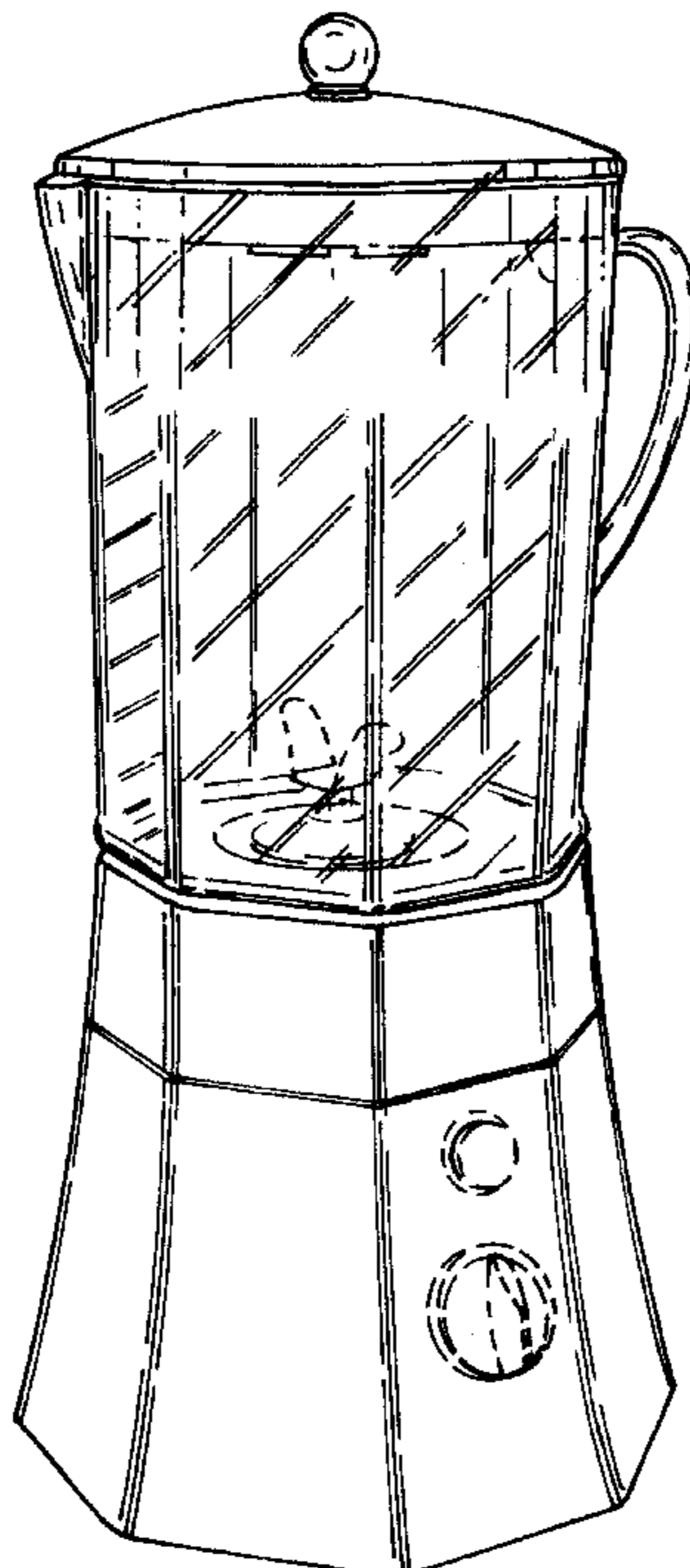

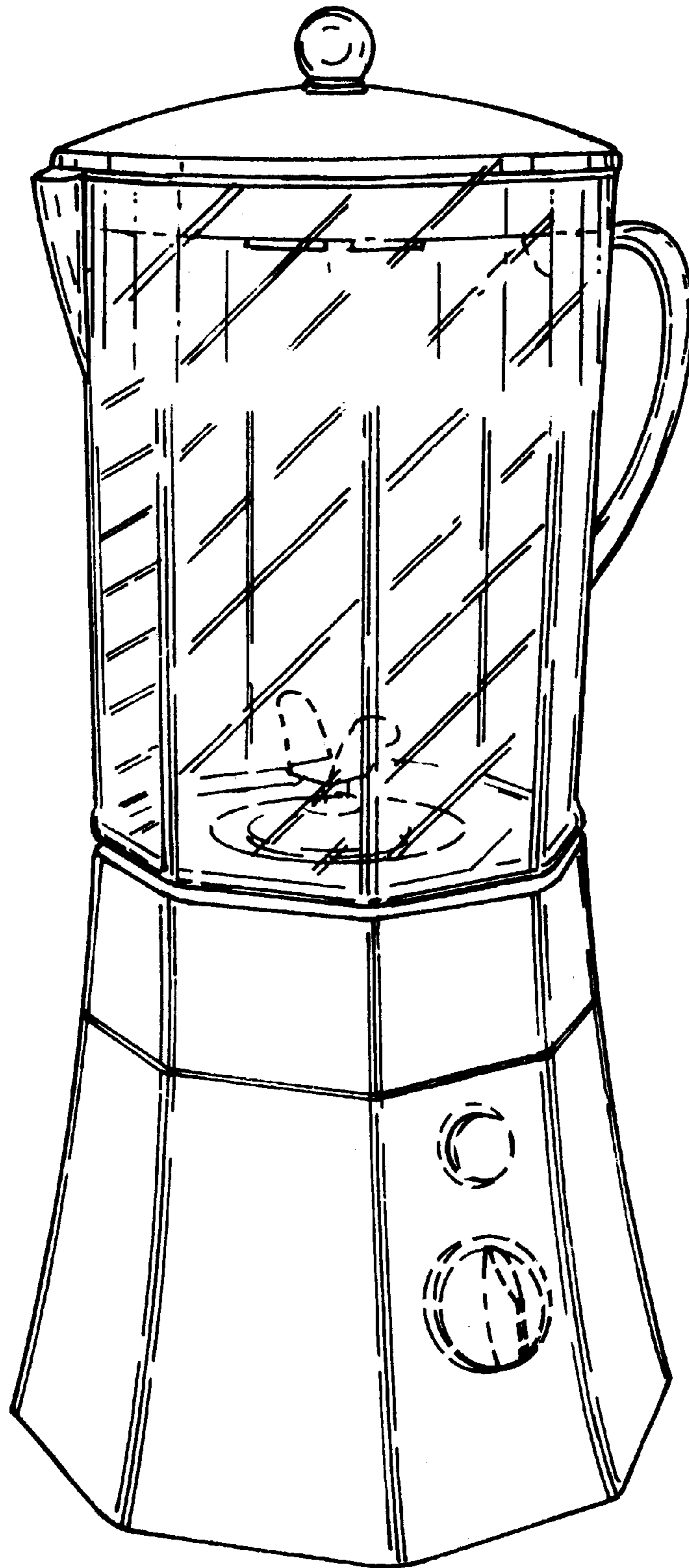
The ornamental design for a blender, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a blender in accordance with my new design;

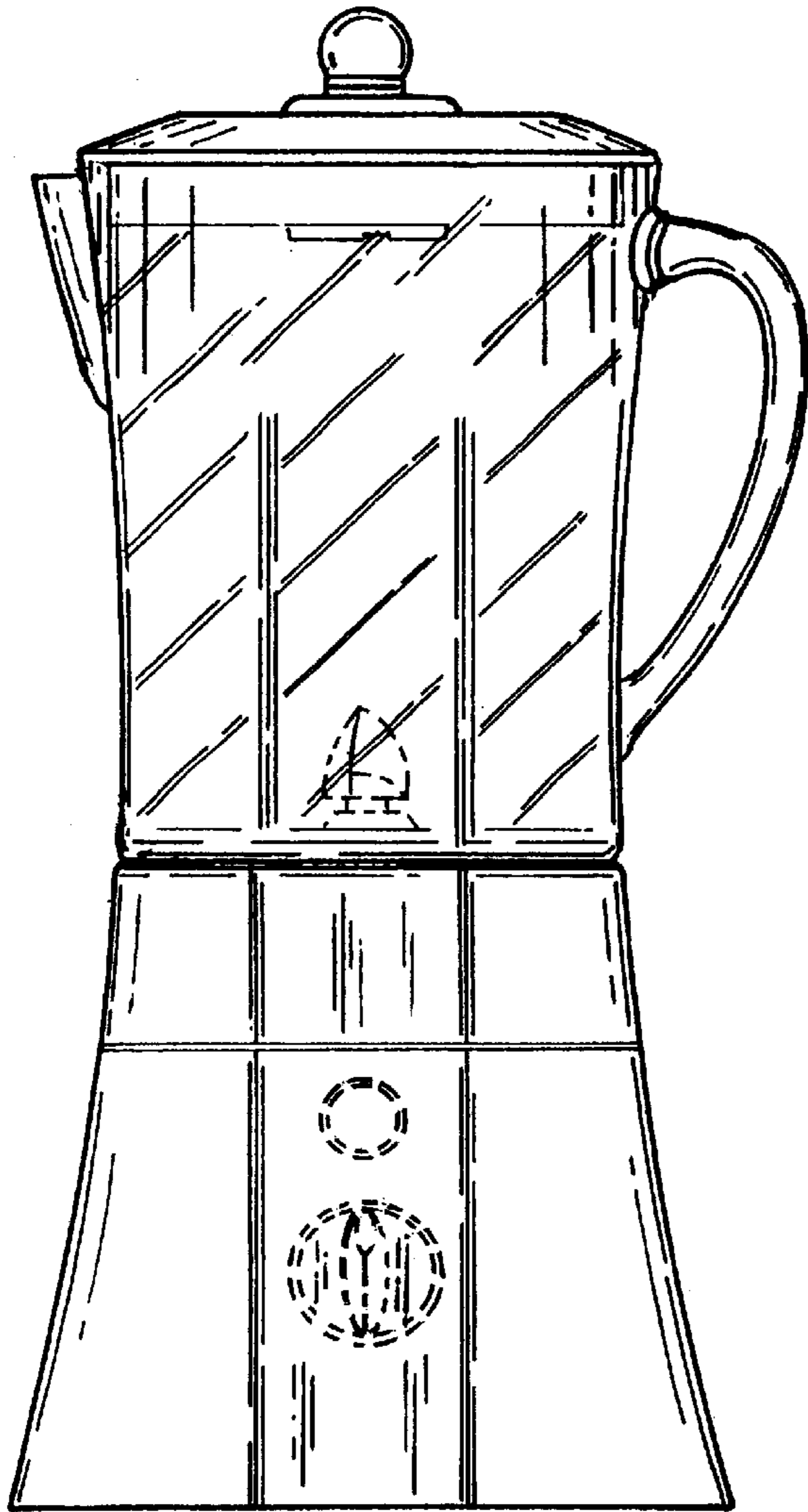

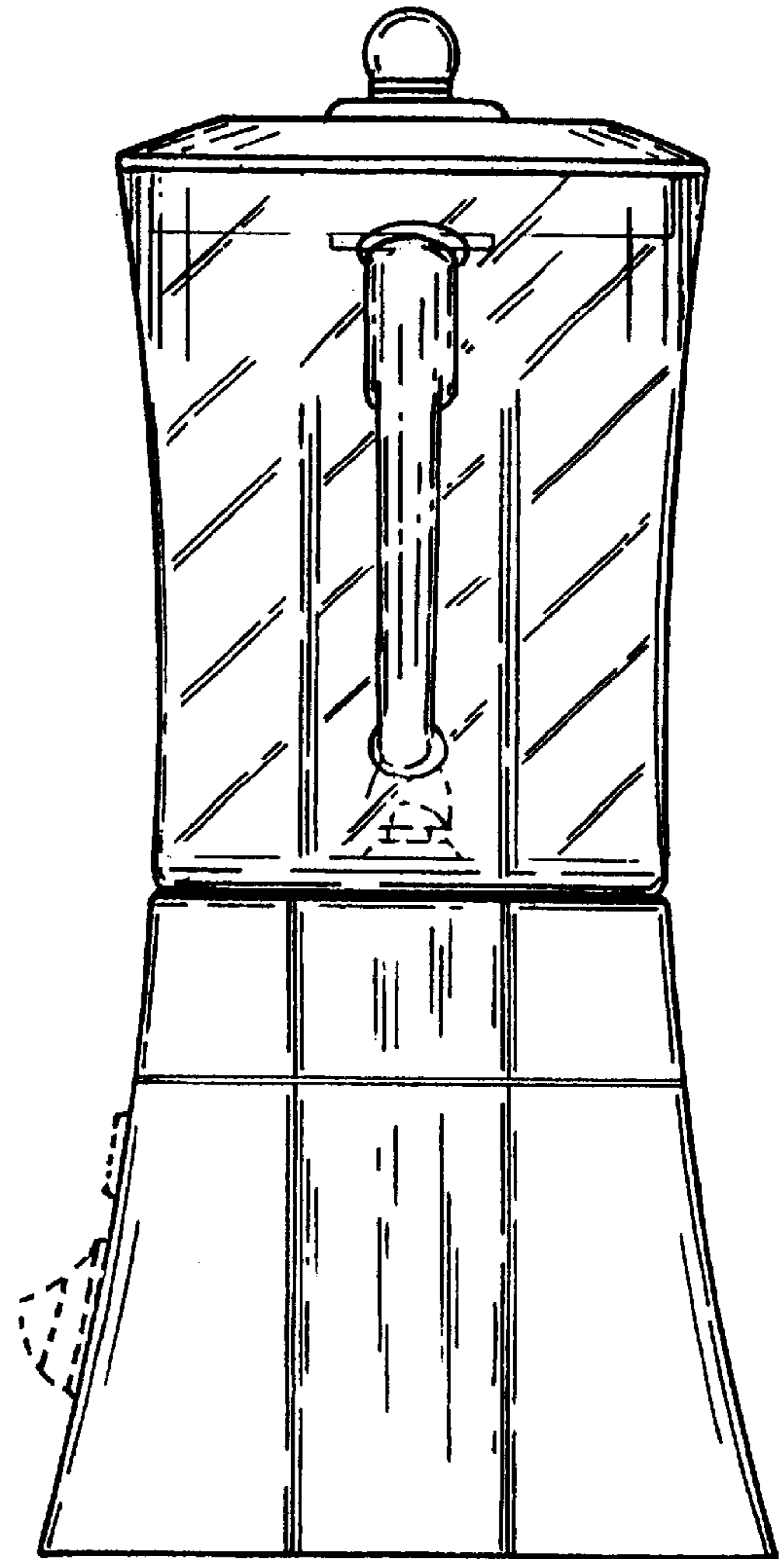
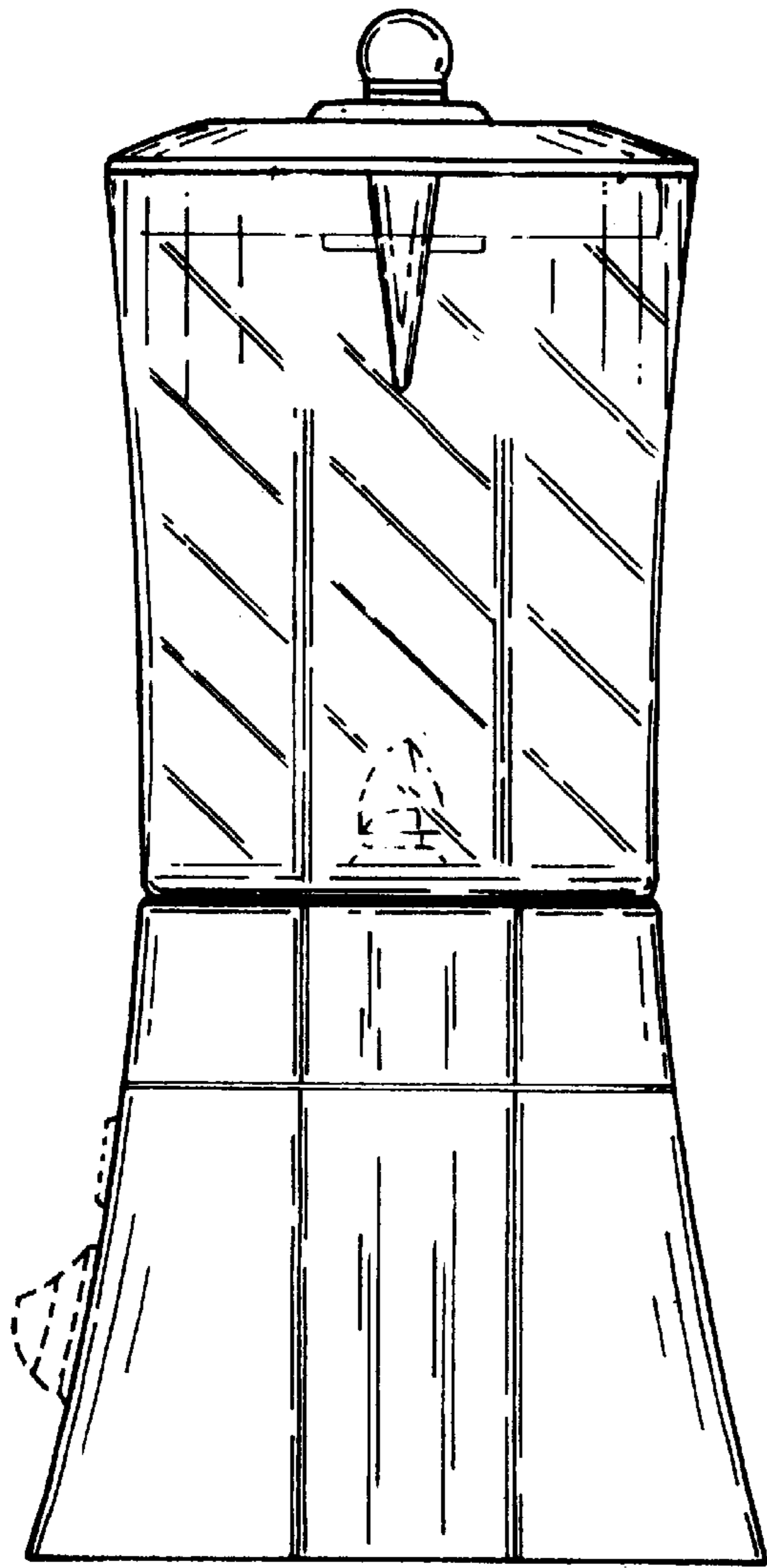
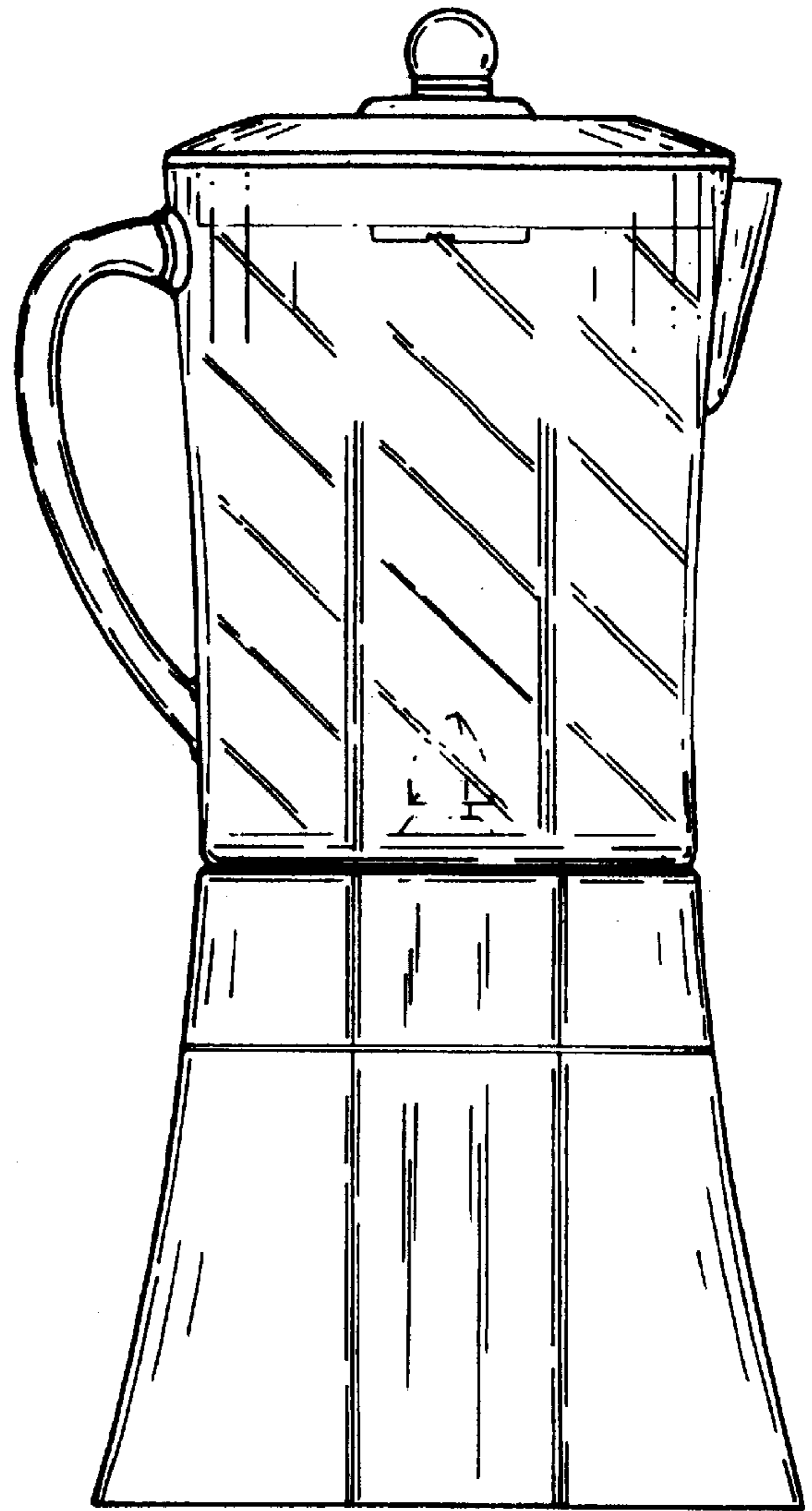

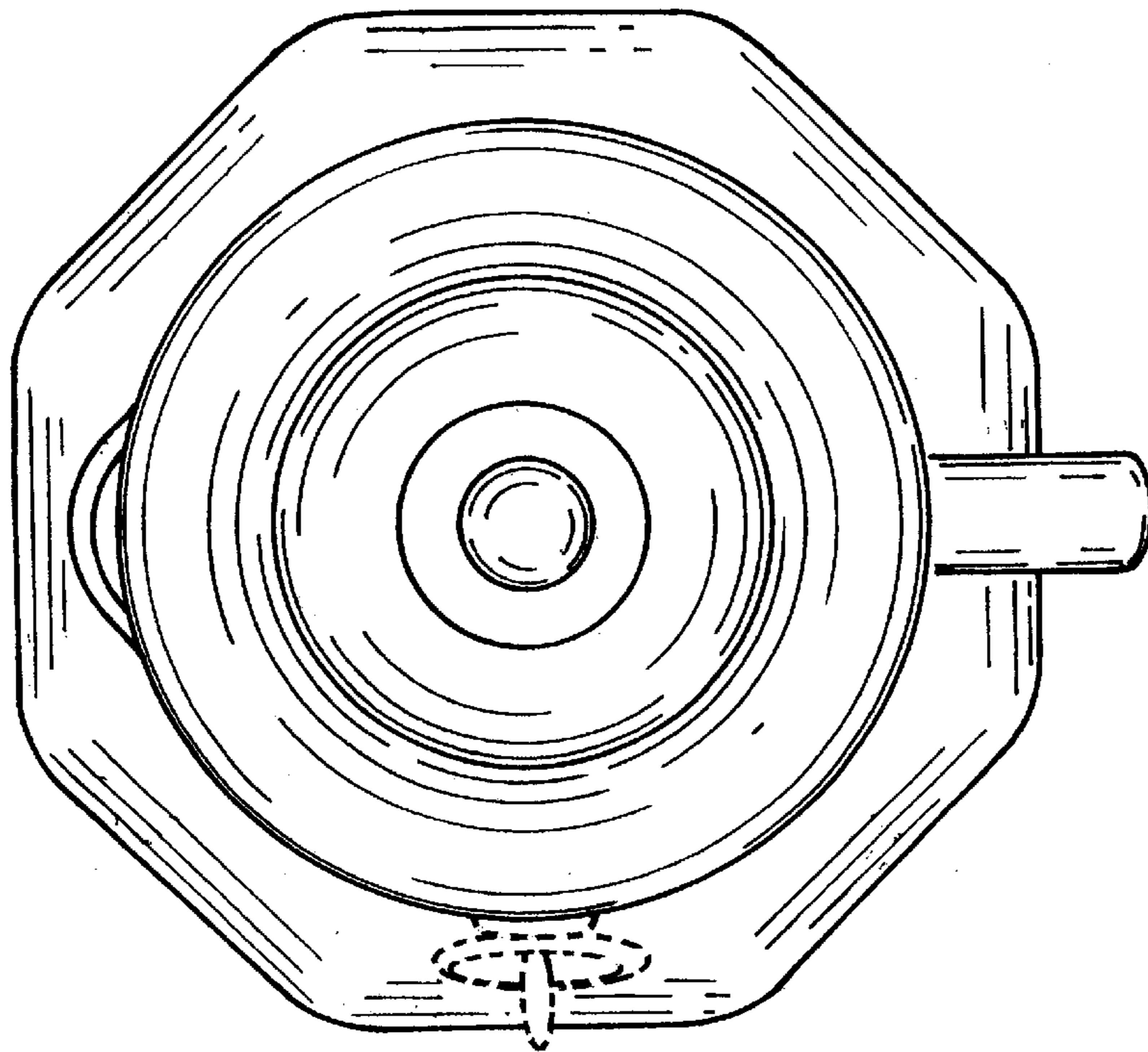

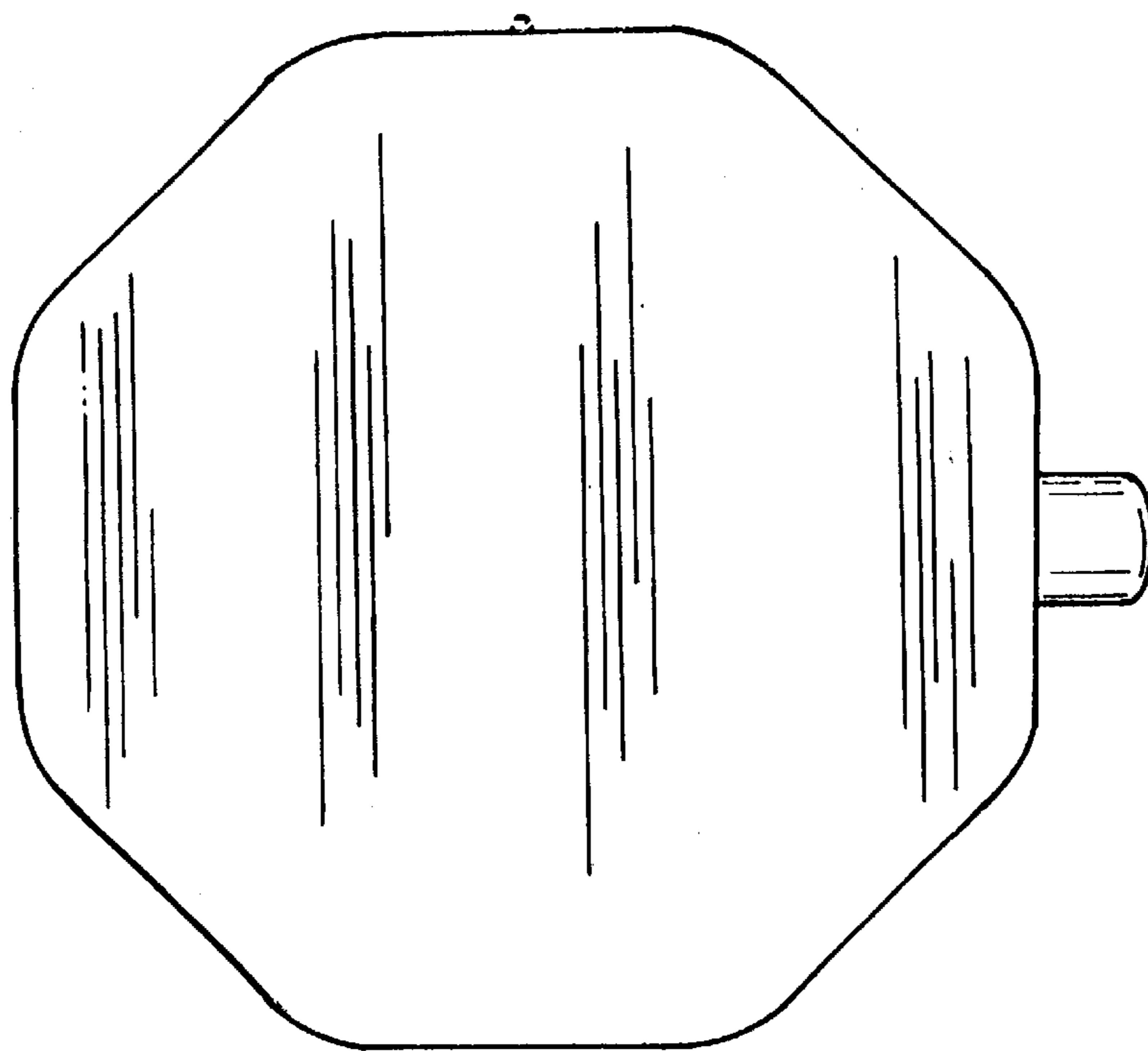
