The ornamental design for a plate, as shown and described.

DESCRIPTION

FIG. 17 is a side elevational view thereof; the other side elevational views being the same;

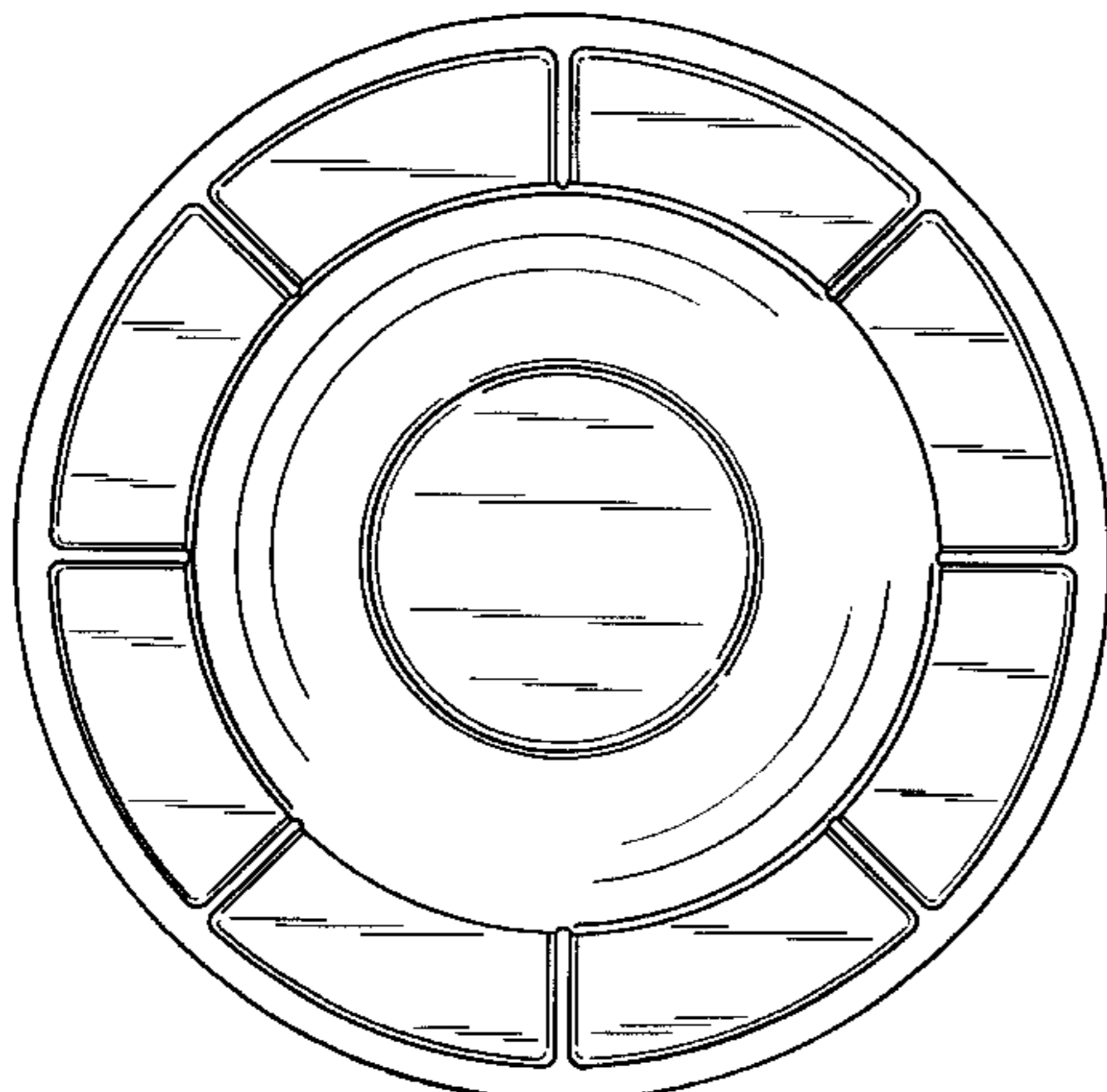
FIG. 18 is a bottom view thereof;

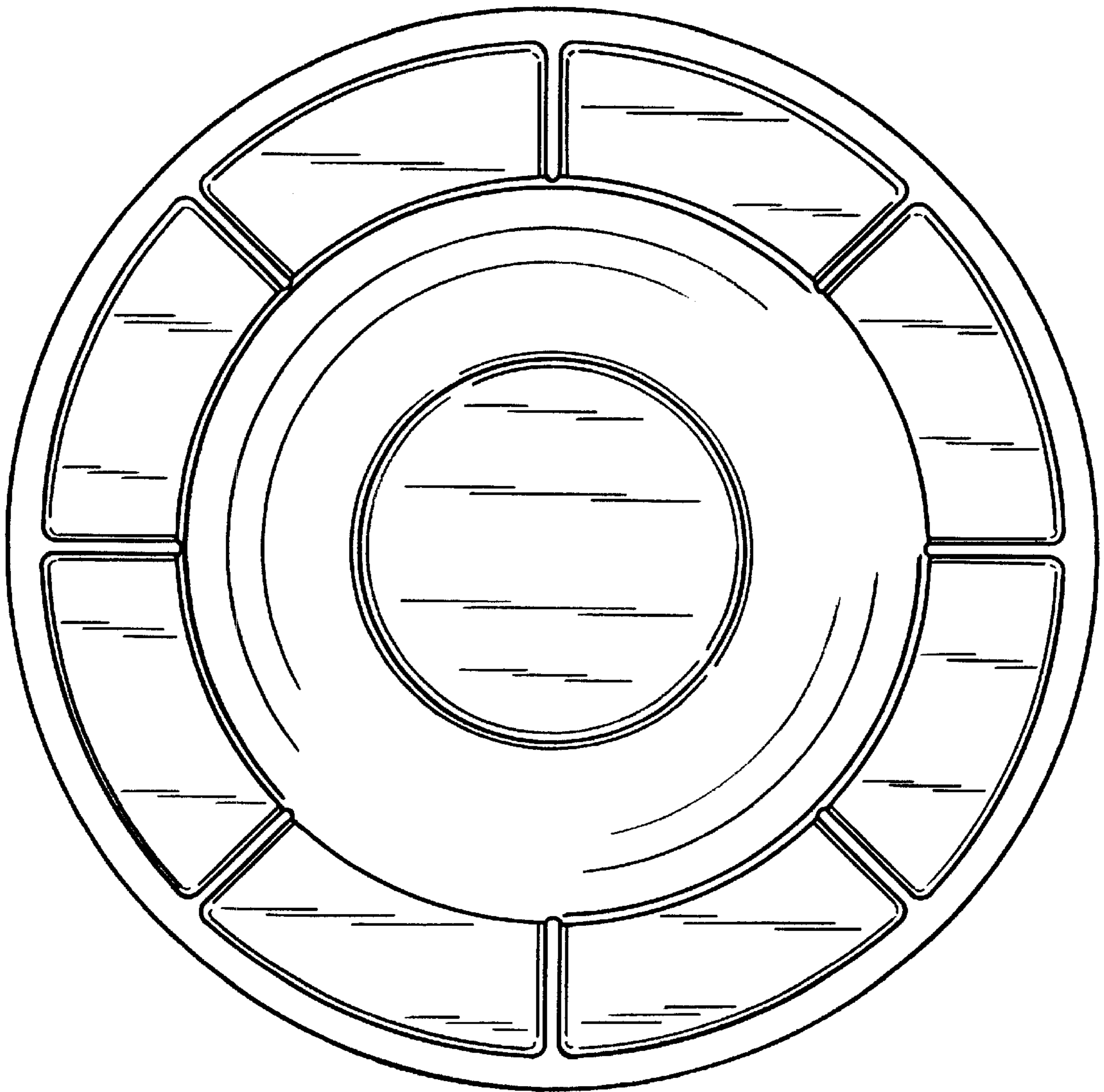

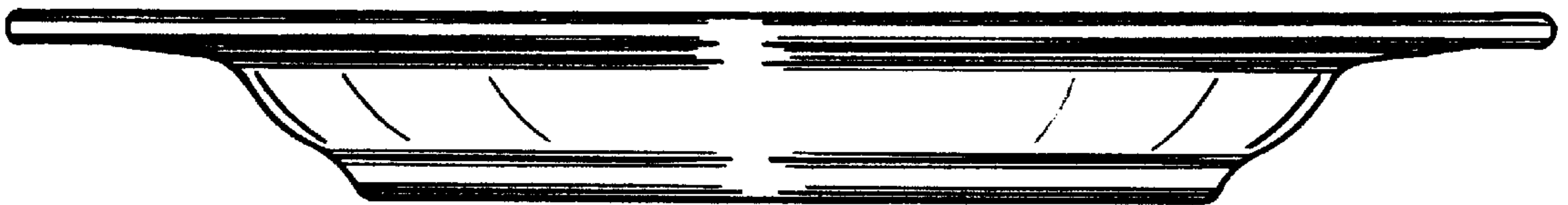
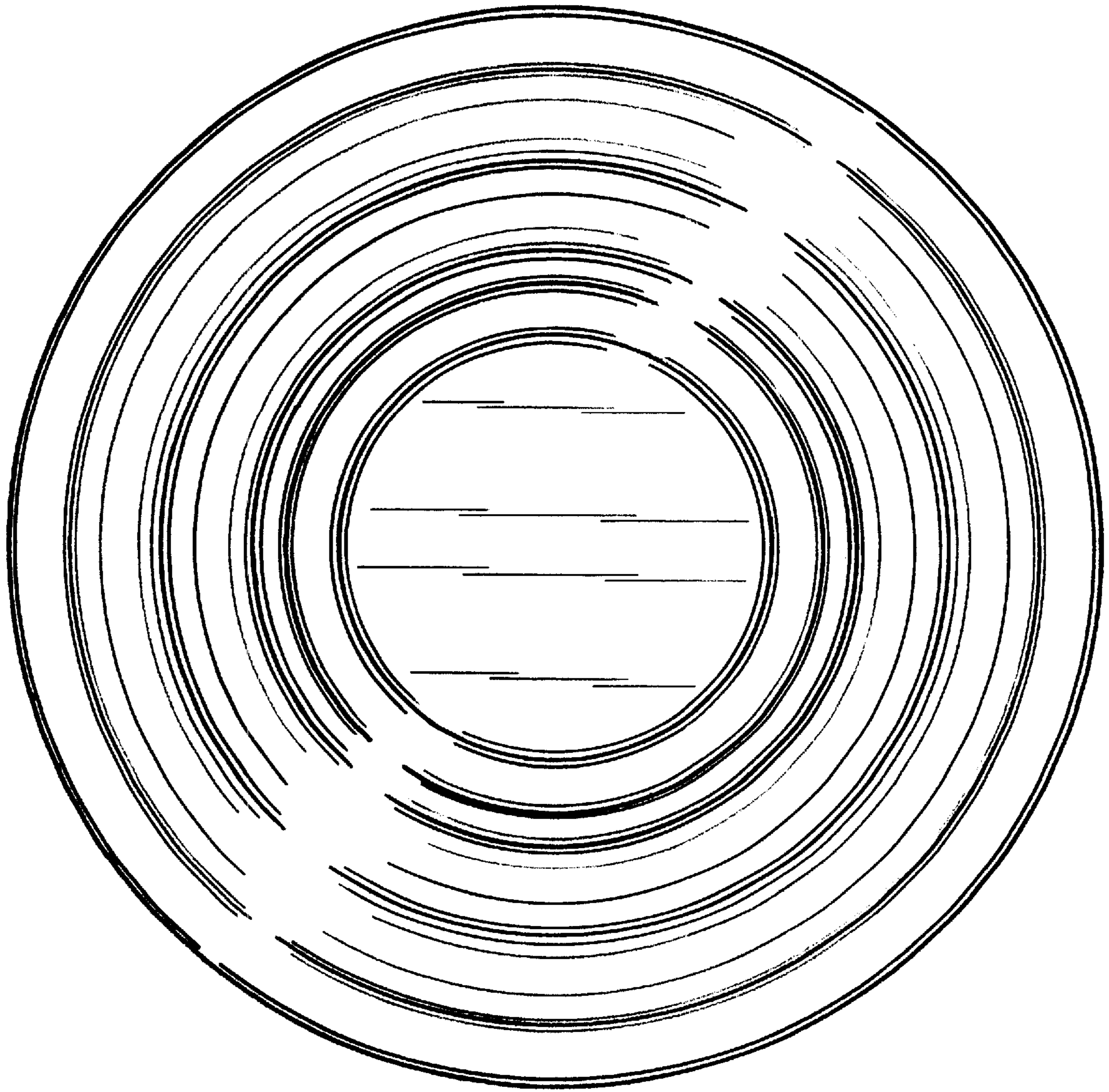
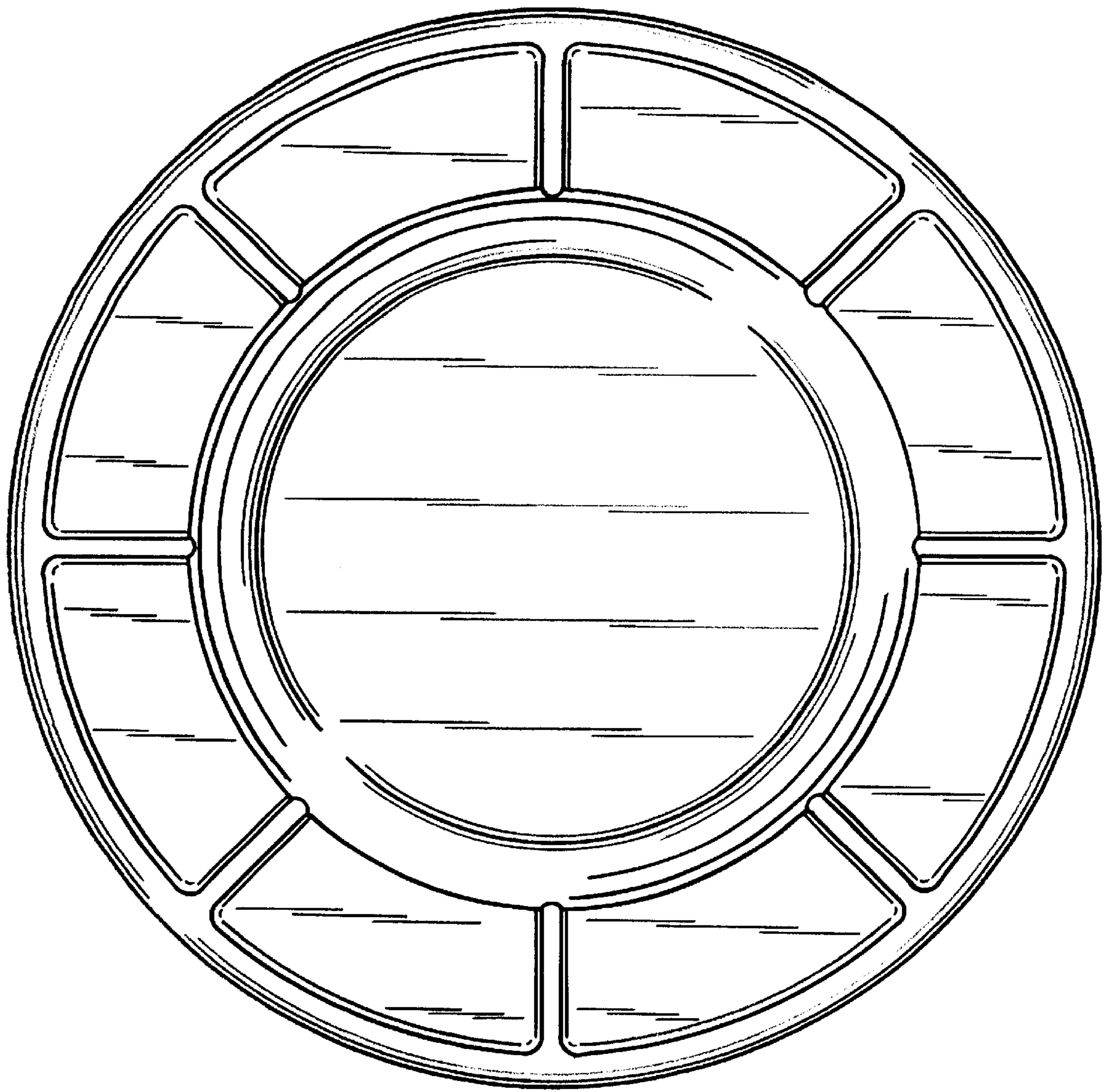

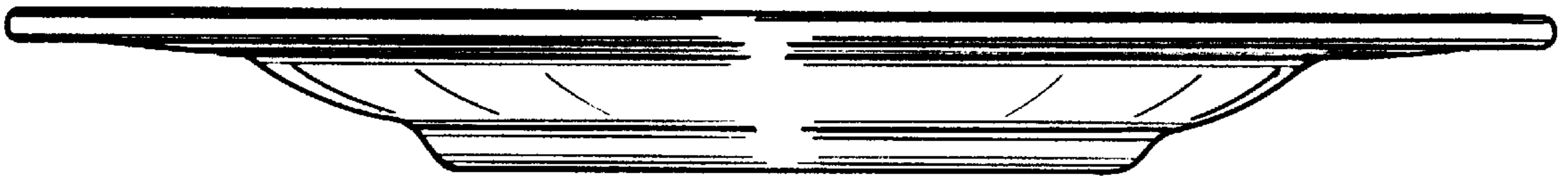
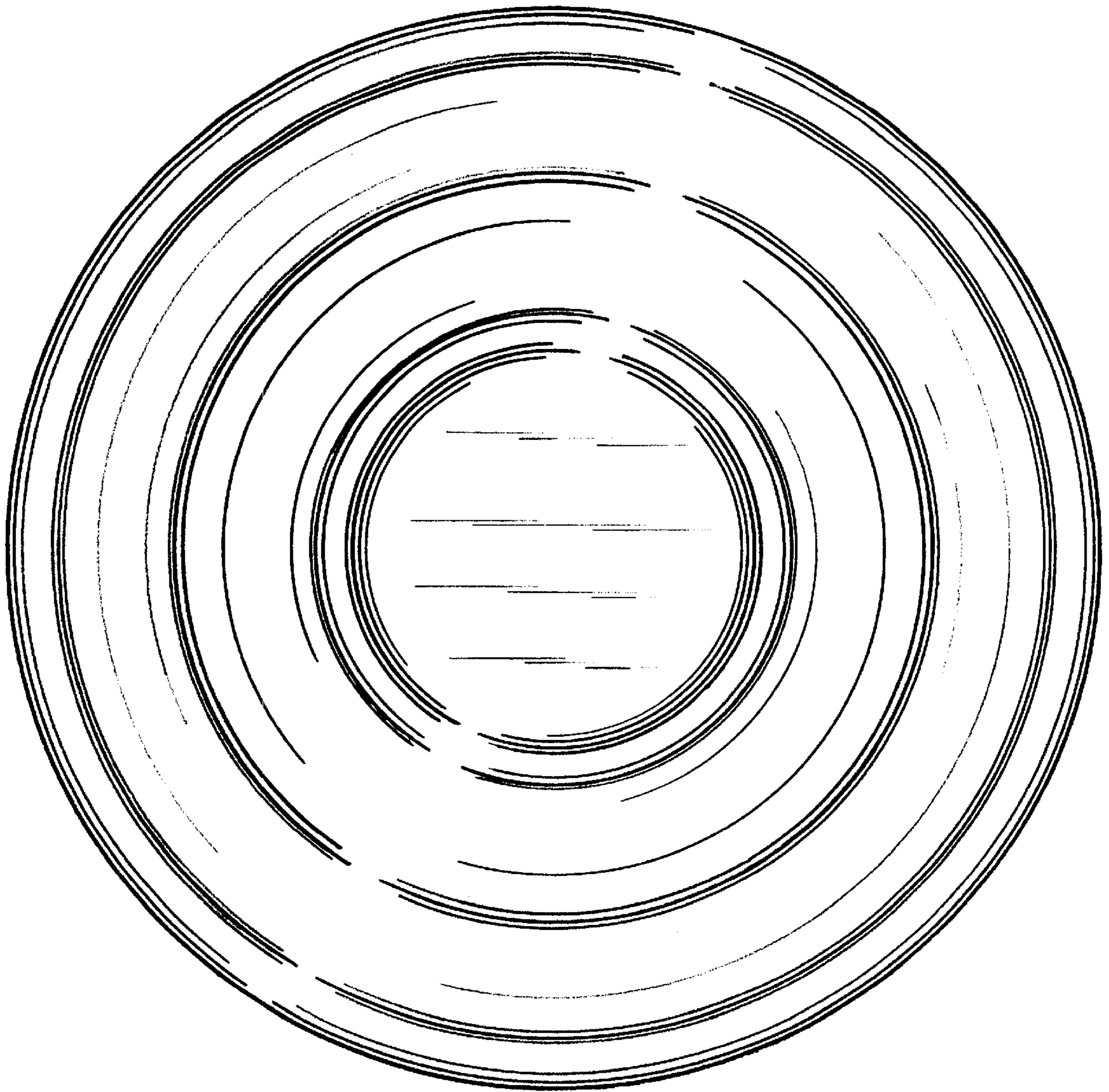
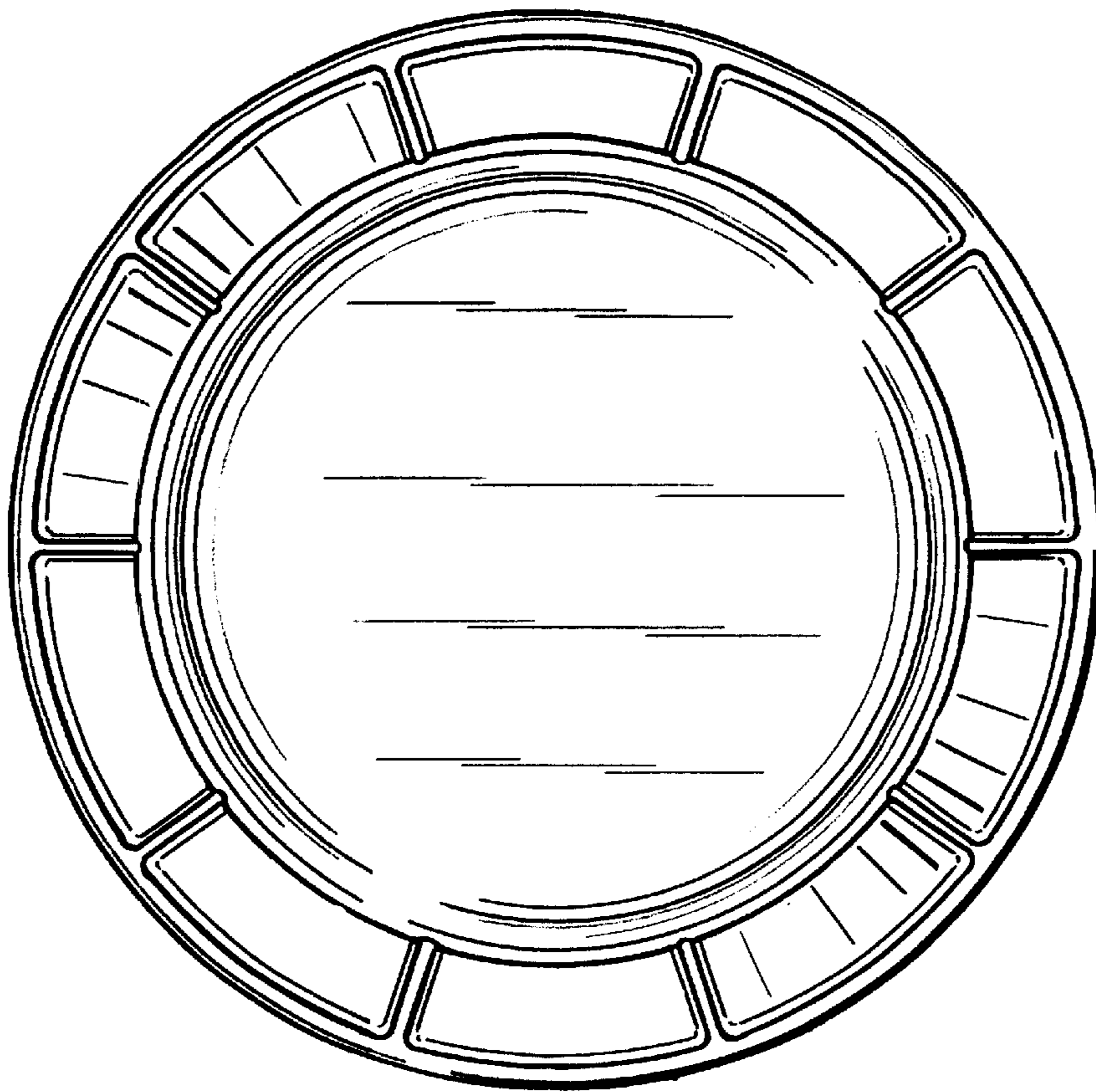


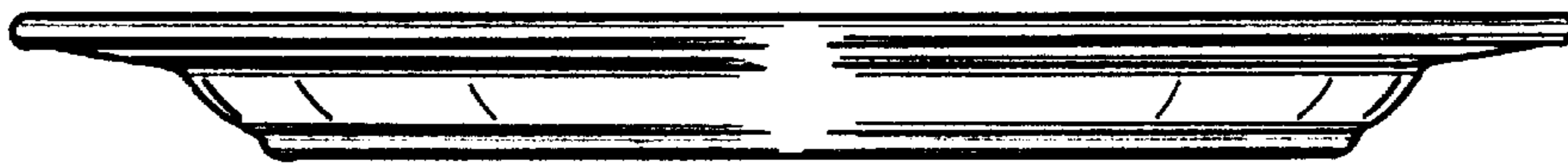

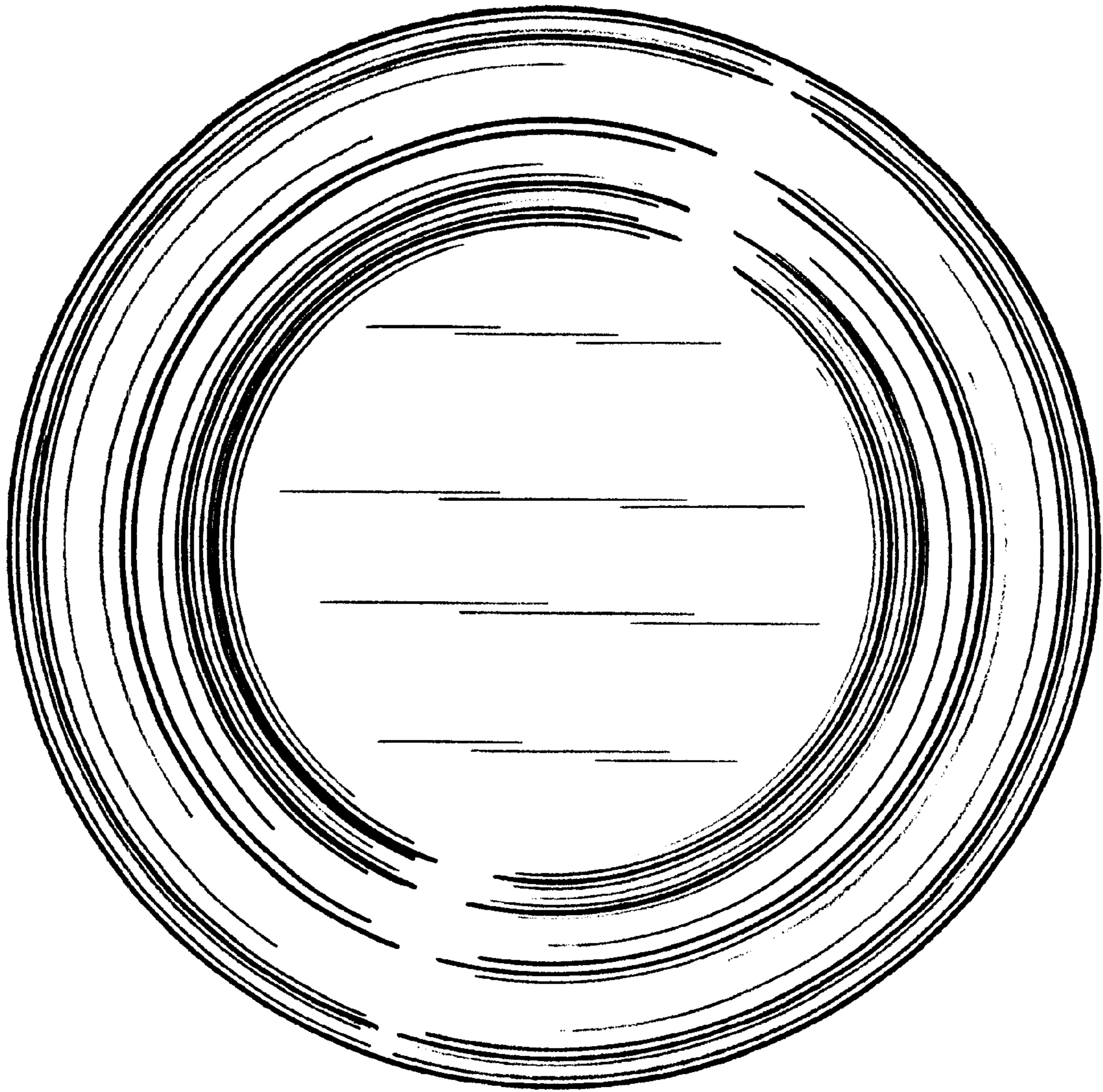

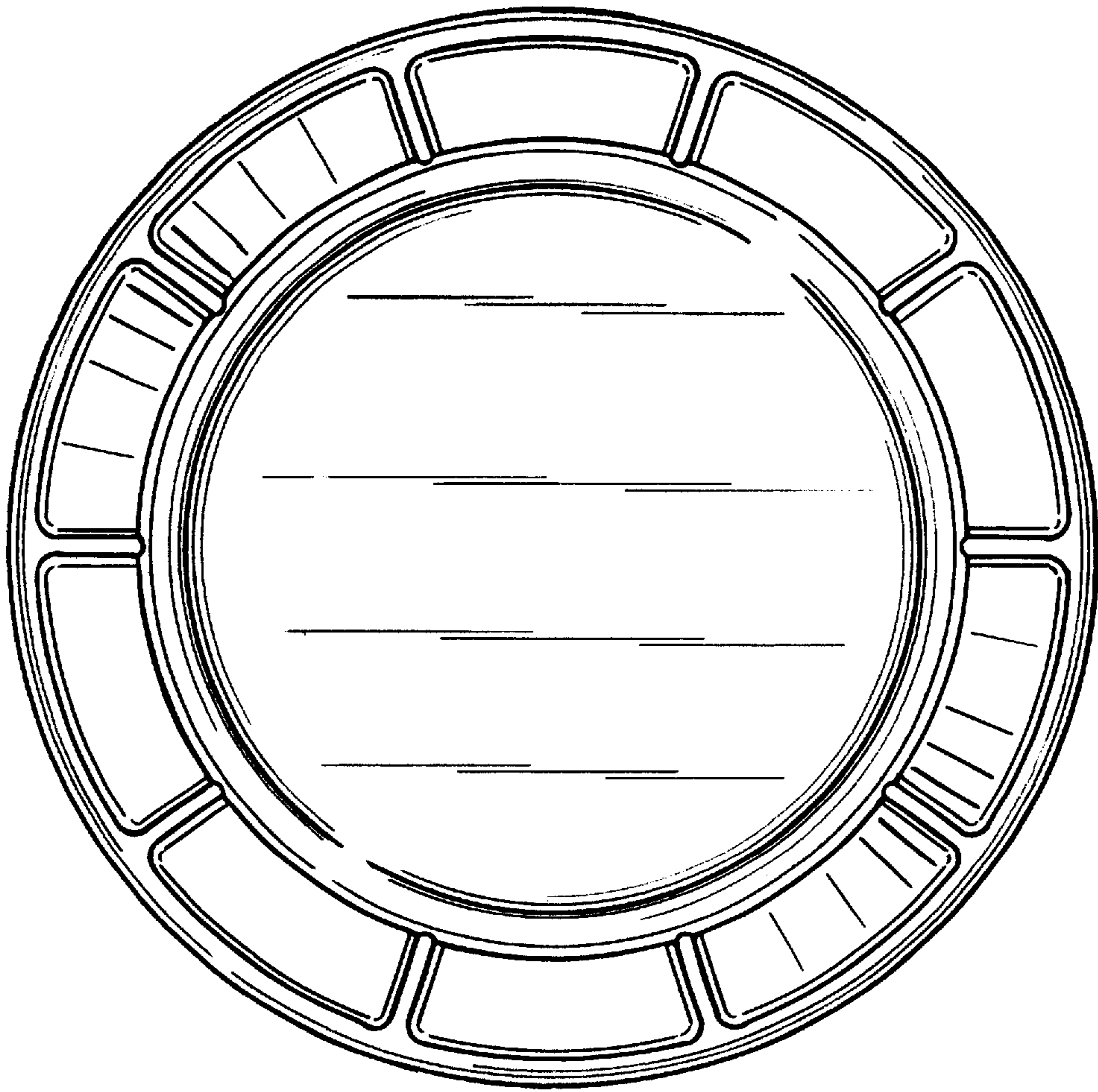
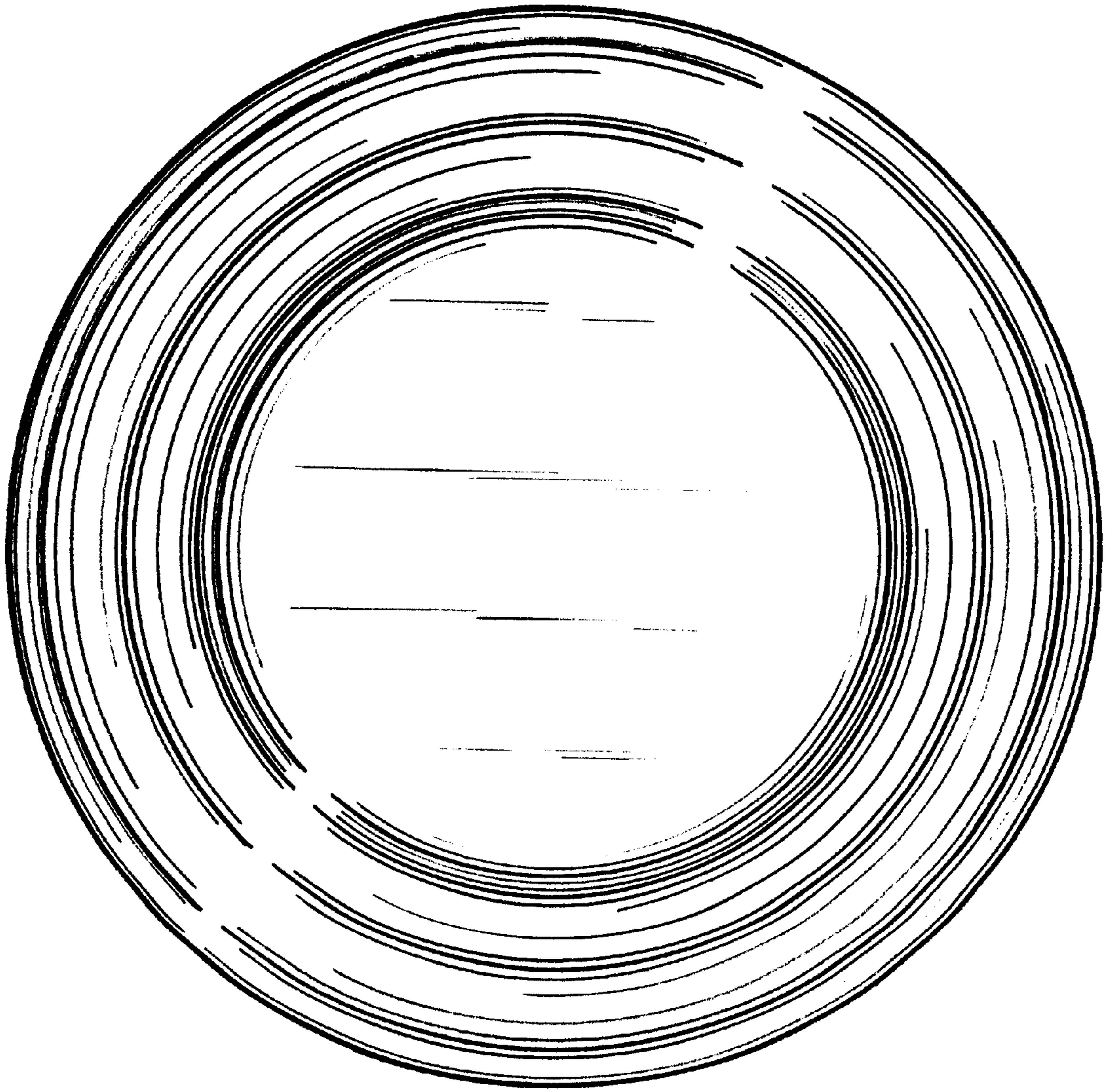


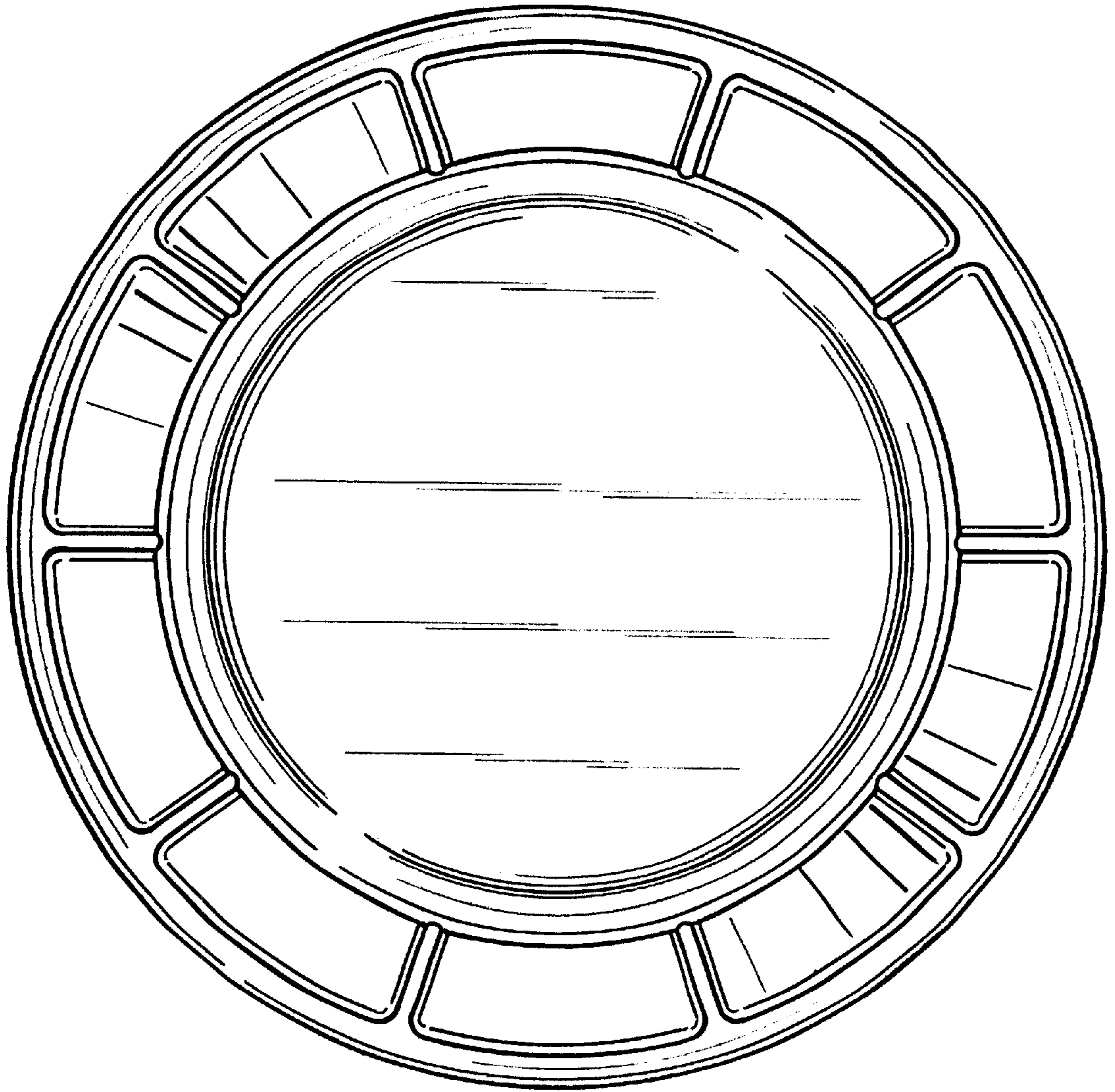

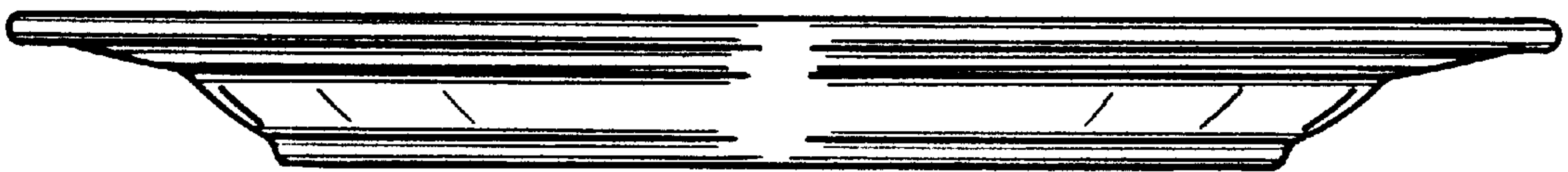

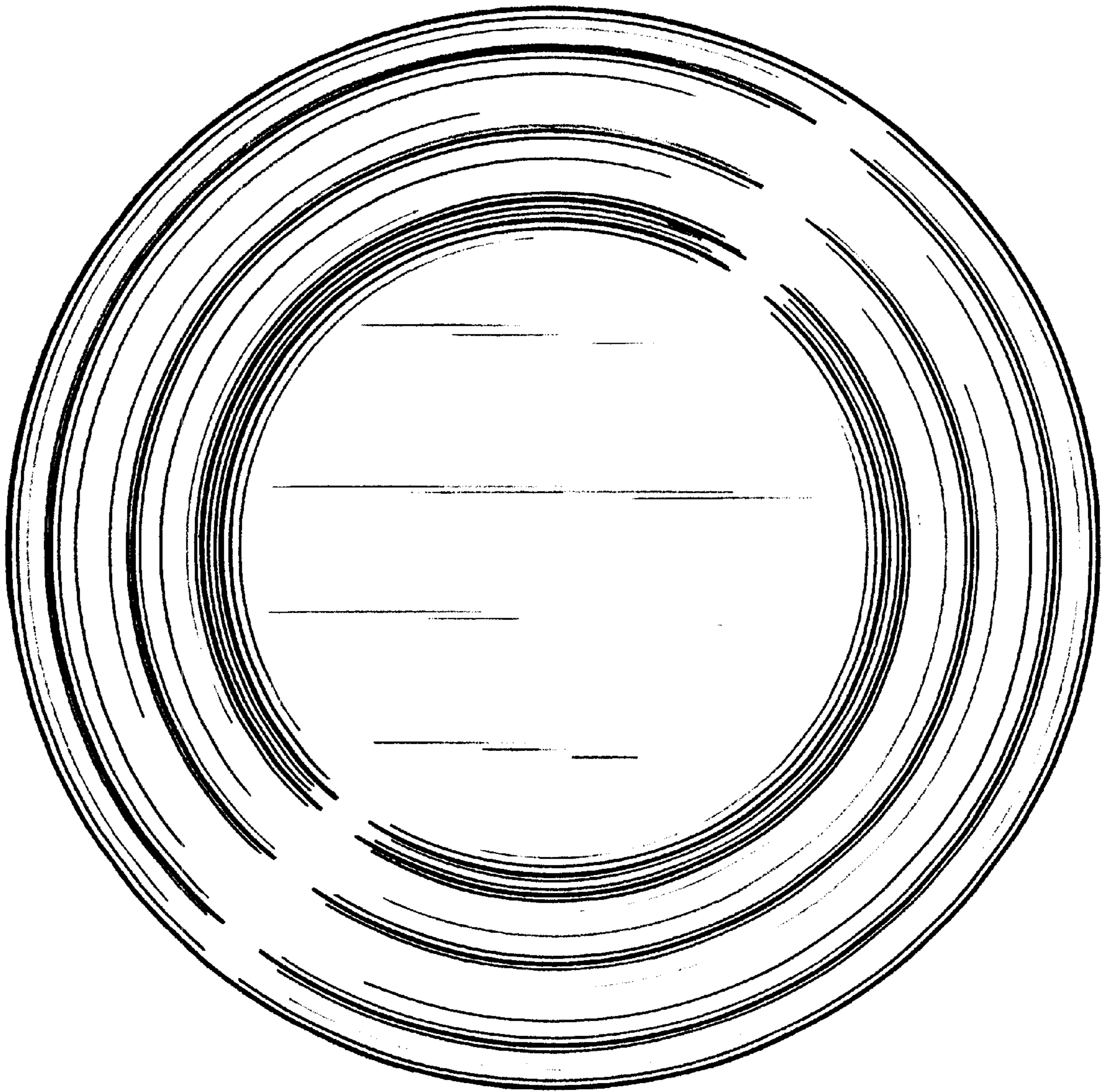

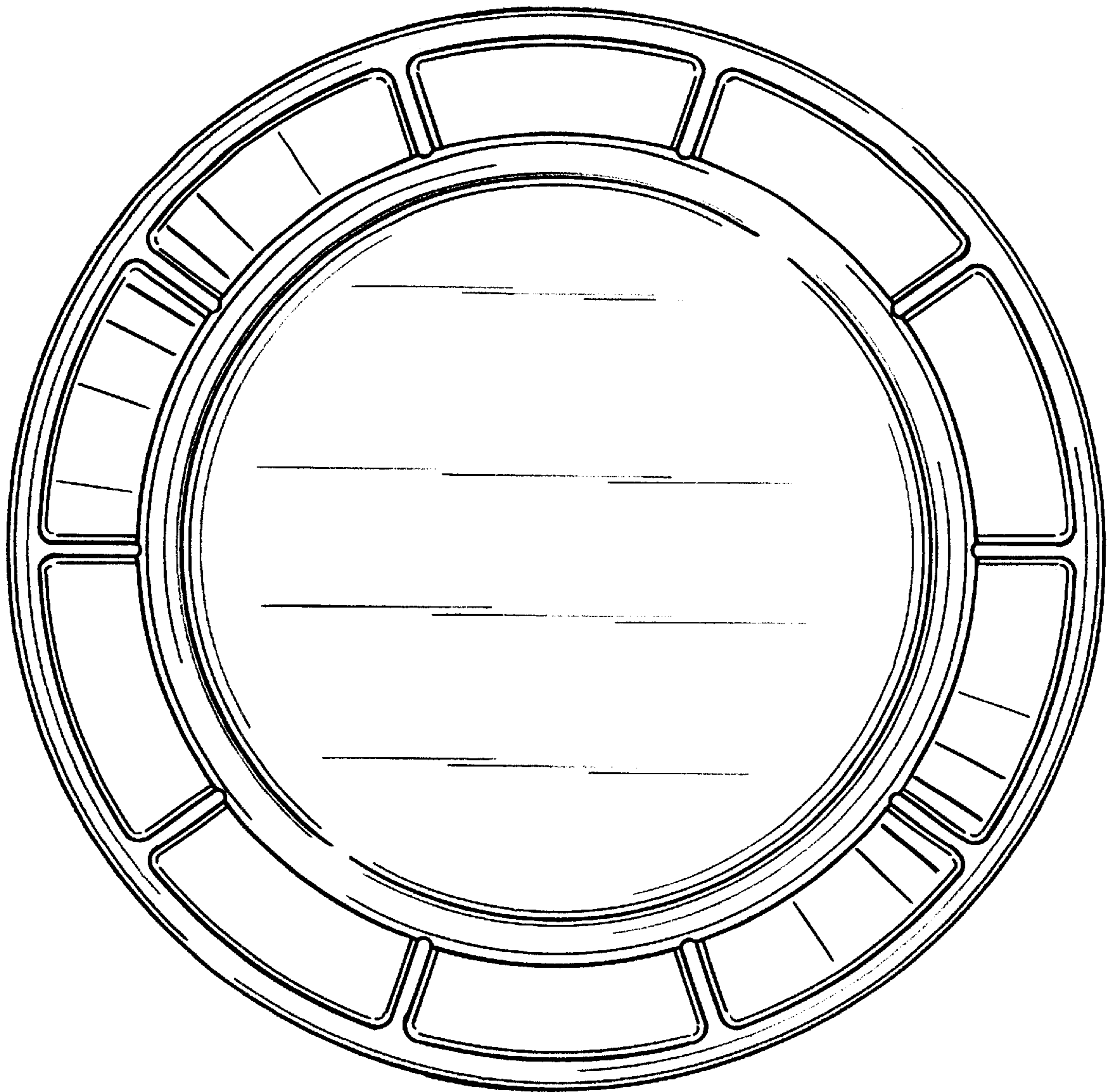

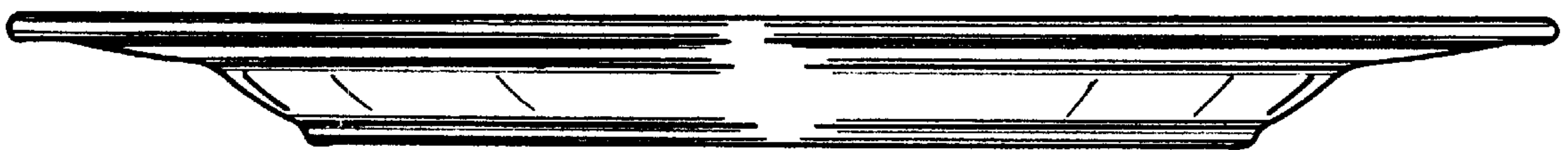

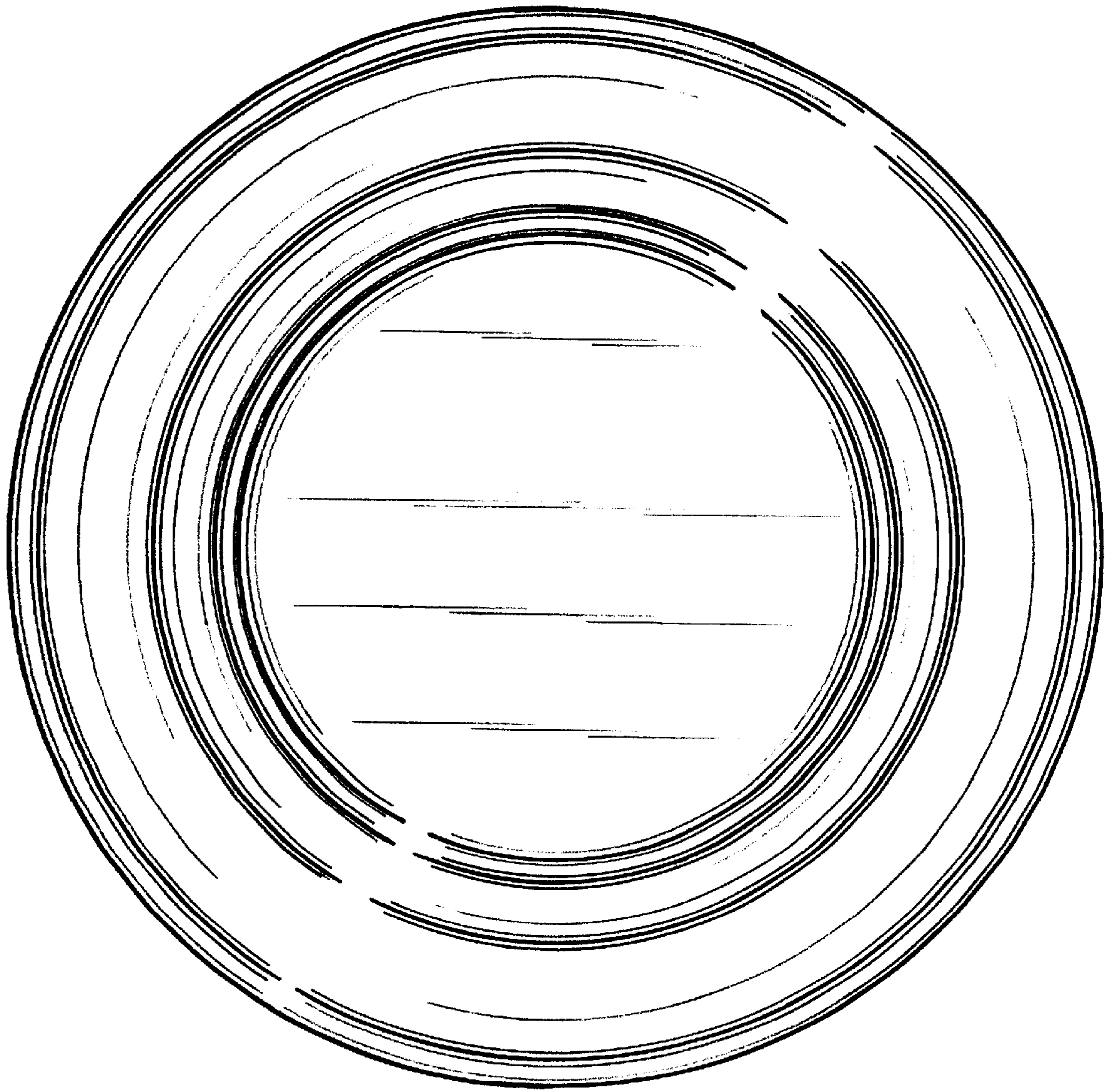
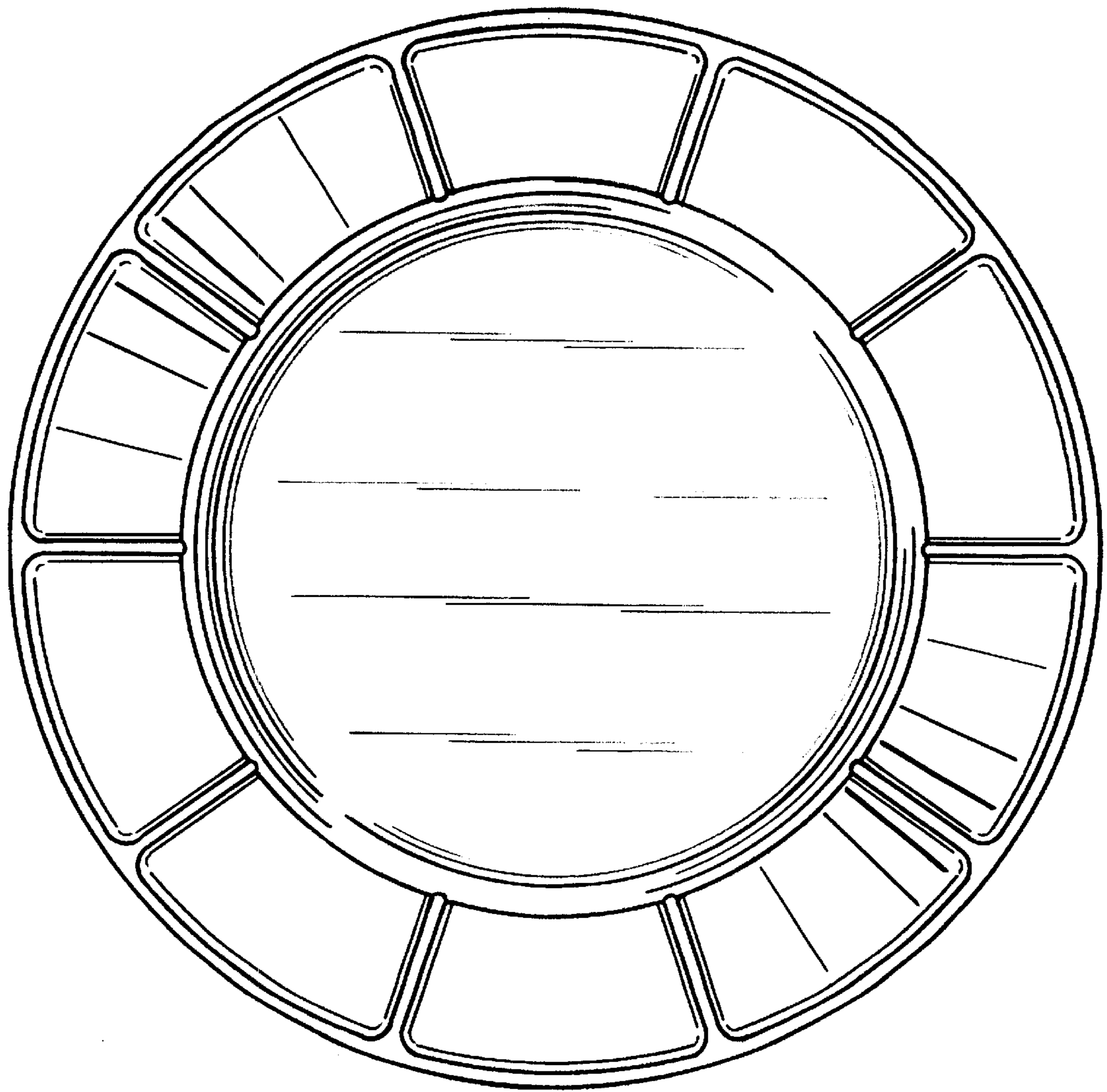


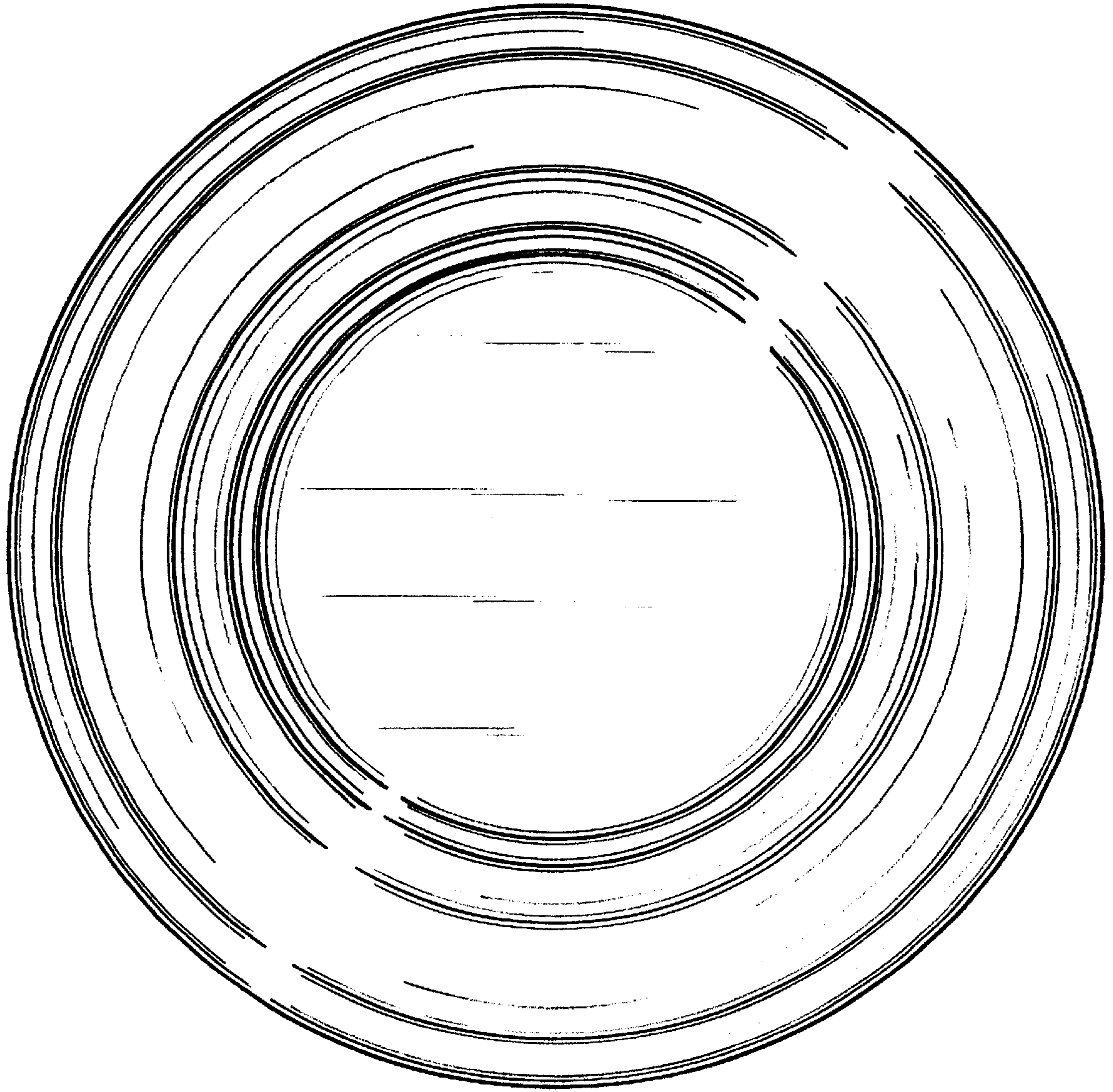
