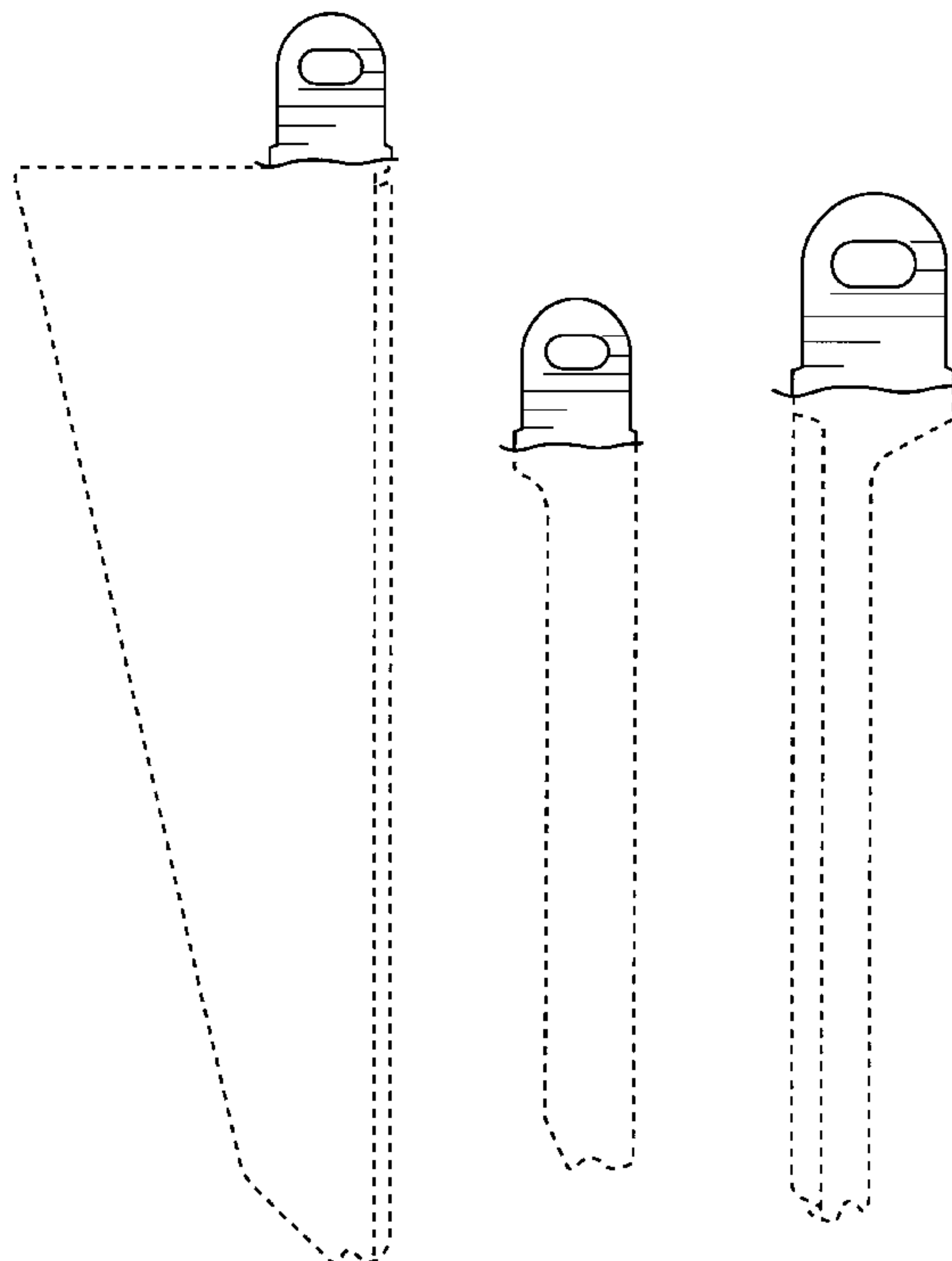
(57) **CLAIM**

The ornamental design for saw blade with decorative shank, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of a saw blade with decorative shank;  
 FIG. 2 is an opposite side elevation view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a rear elevation view thereof;  
 FIG. 6 is a front elevation view thereof;  
 FIG. 7 is a side elevation view of a saw blade with a decorative shank showing a second embodiment of the design;  
 FIG. 8 is an opposite side elevation view of FIG. 7;  
 FIG. 9 is a front elevation view of FIG. 7;  
 FIG. 10 is a rear elevation view of FIG. 7;  
 FIG. 11 is a top plan view of FIG. 7;  
 FIG. 12 is a bottom plan view of FIG. 7;  
 FIG. 13 is a side elevation view of a saw blade with a decorative shank showing a third embodiment of the design;  
 FIG. 14 is an opposite side elevation view of FIG. 13;  
 FIG. 15 is a front elevation view of FIG. 13;  
 FIG. 16 is a rear elevation view of FIG. 13;  
 FIG. 17 is a top plan view of FIG. 13; and,  
 FIG. 18 is a bottom plan view of FIG. 13.

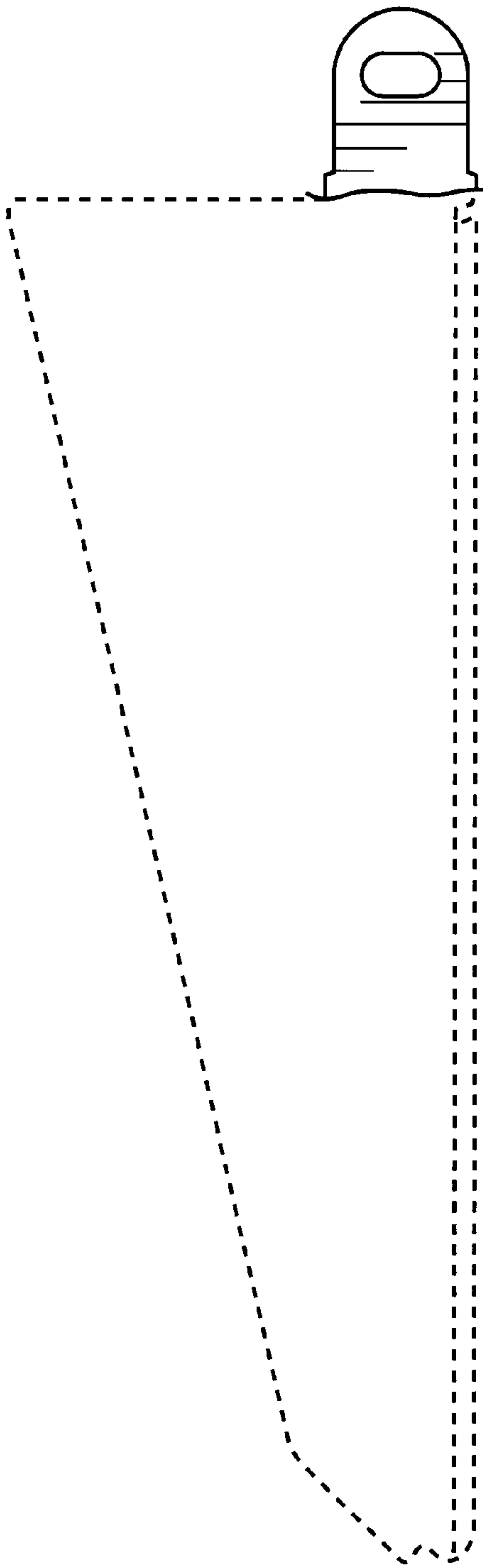

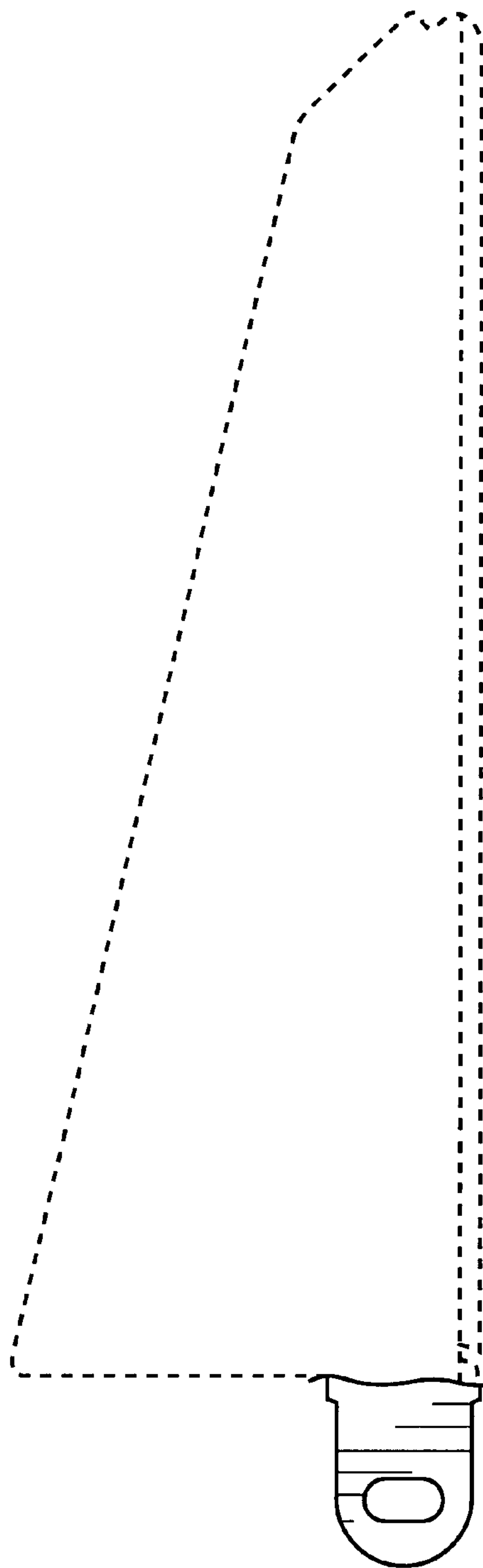

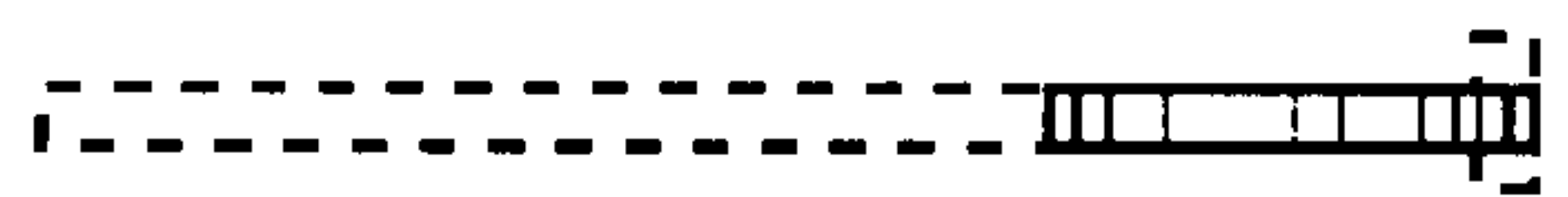

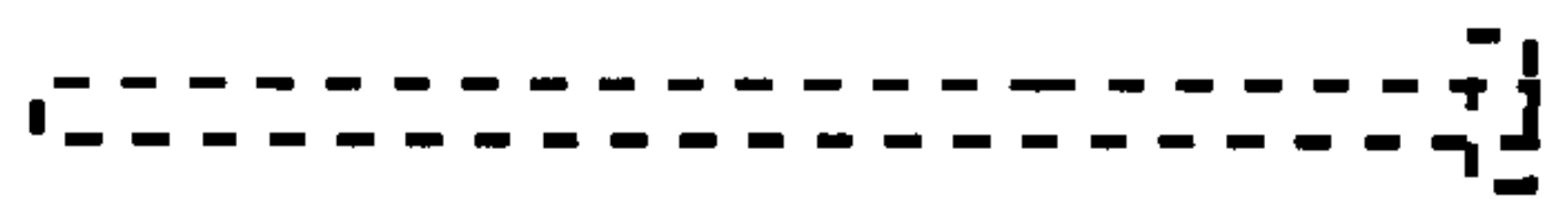

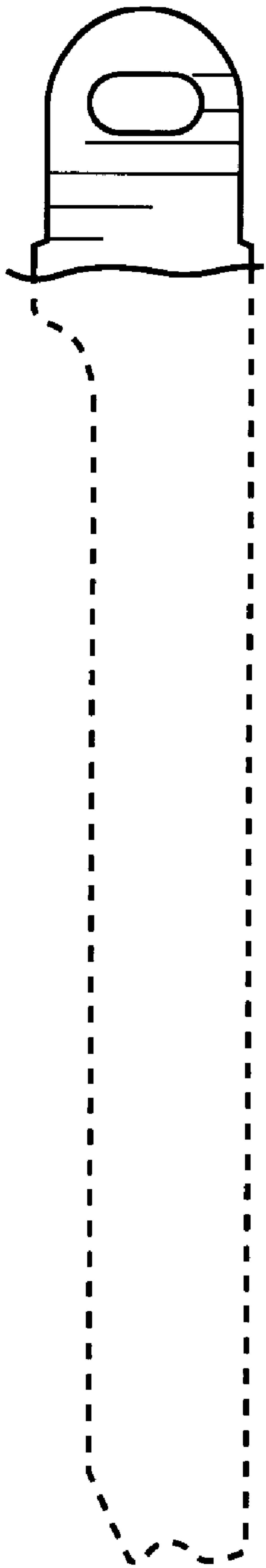

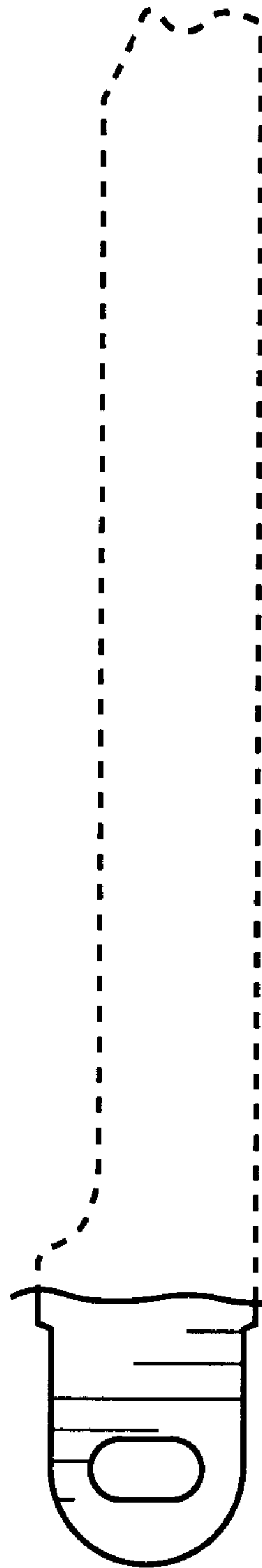

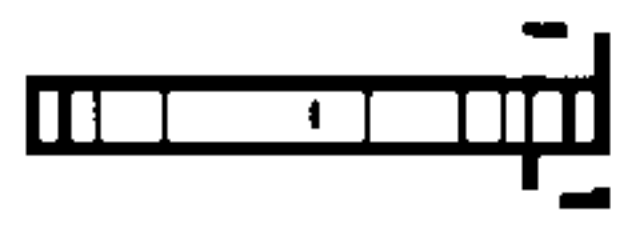

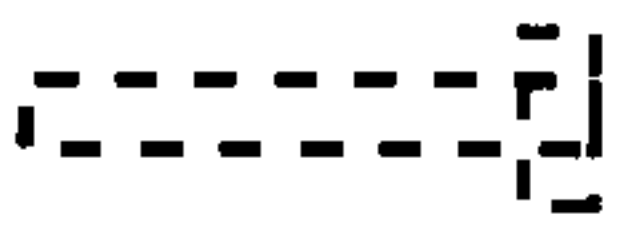

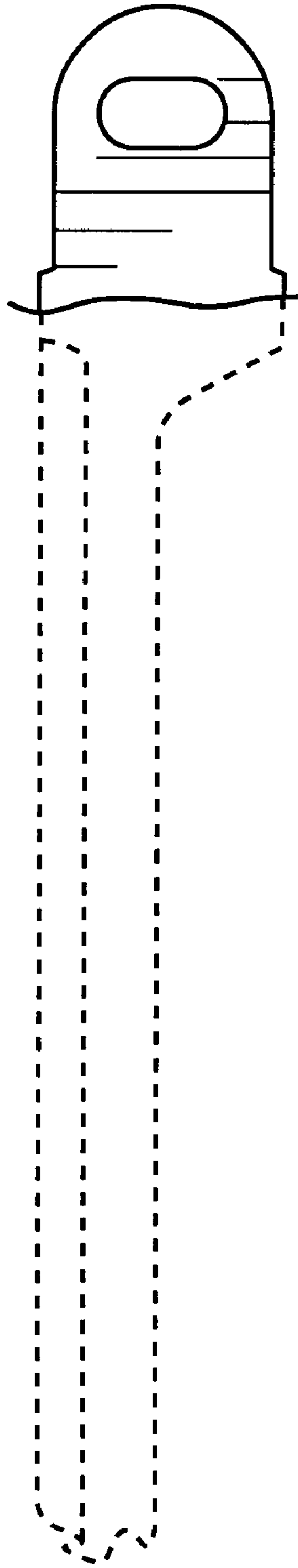

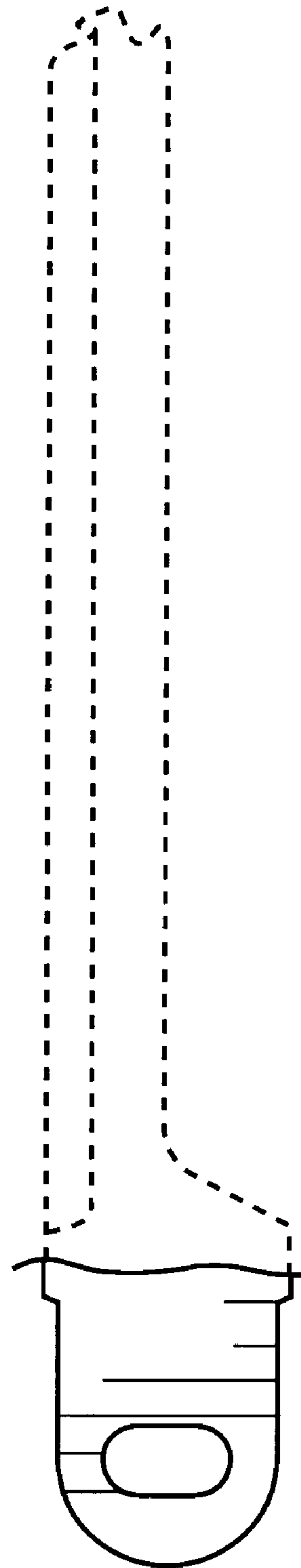

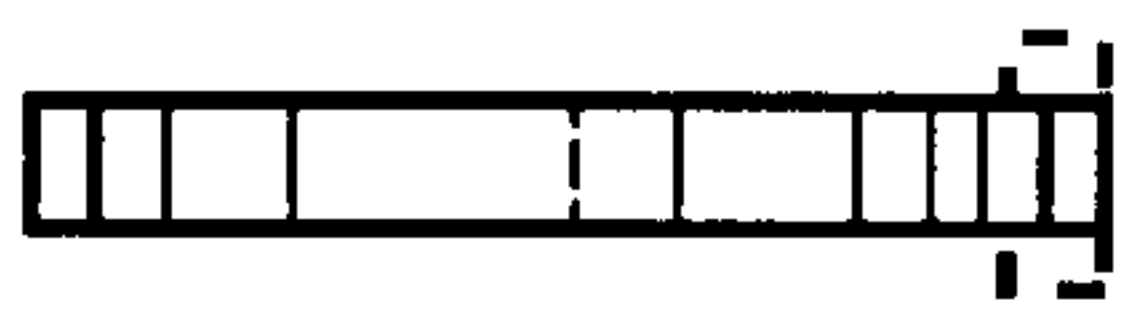

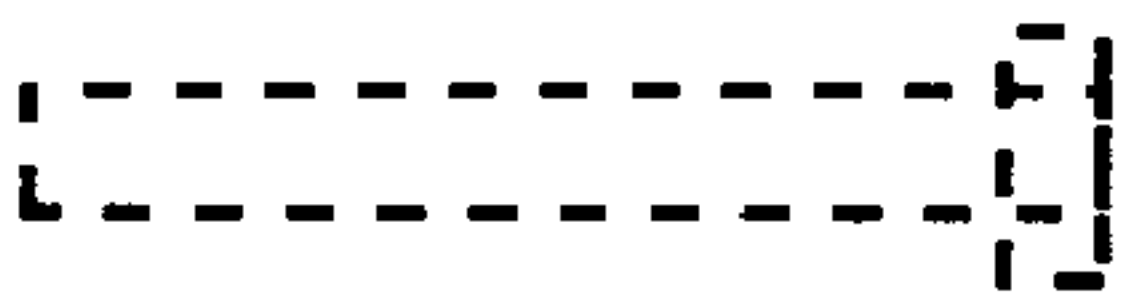
