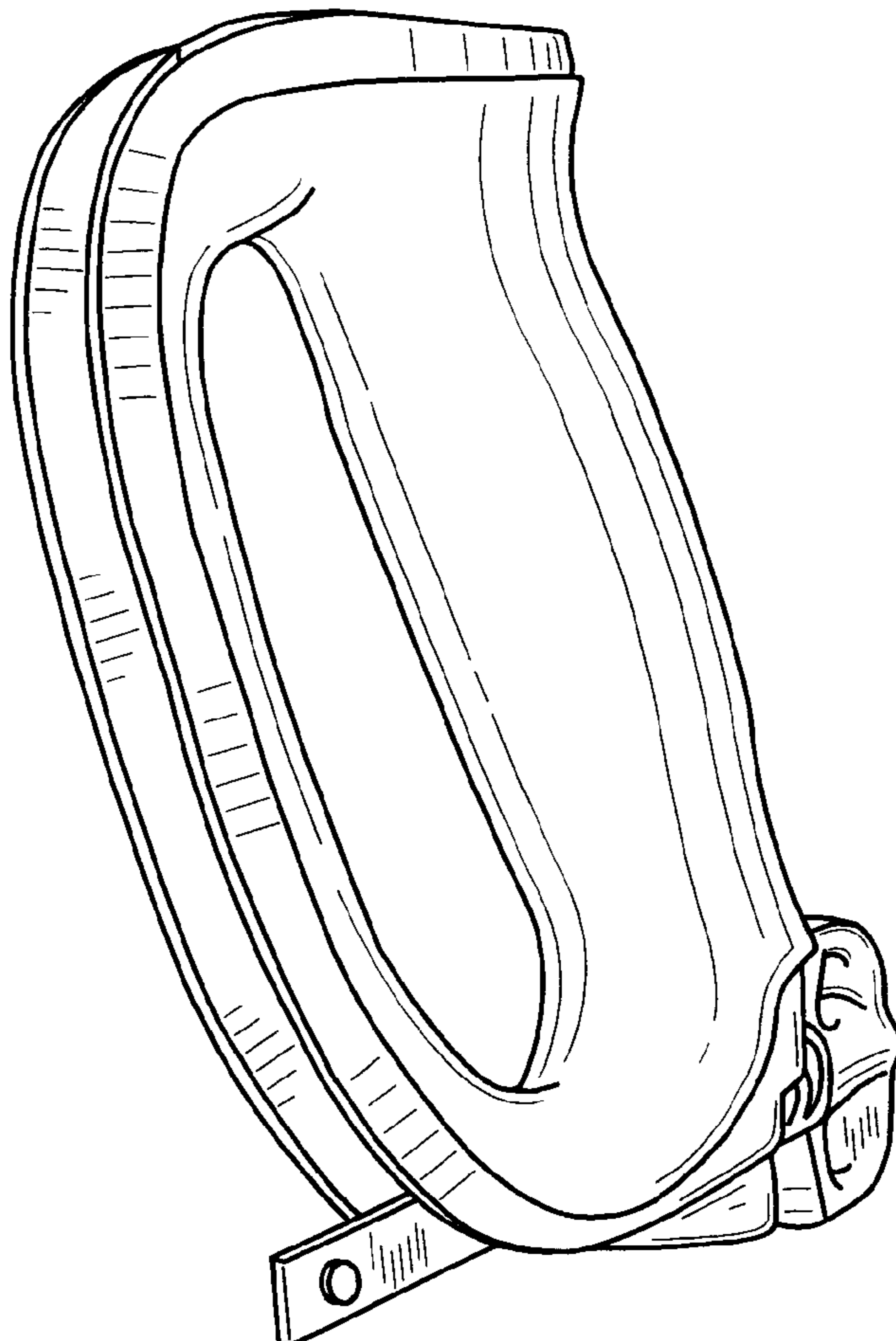

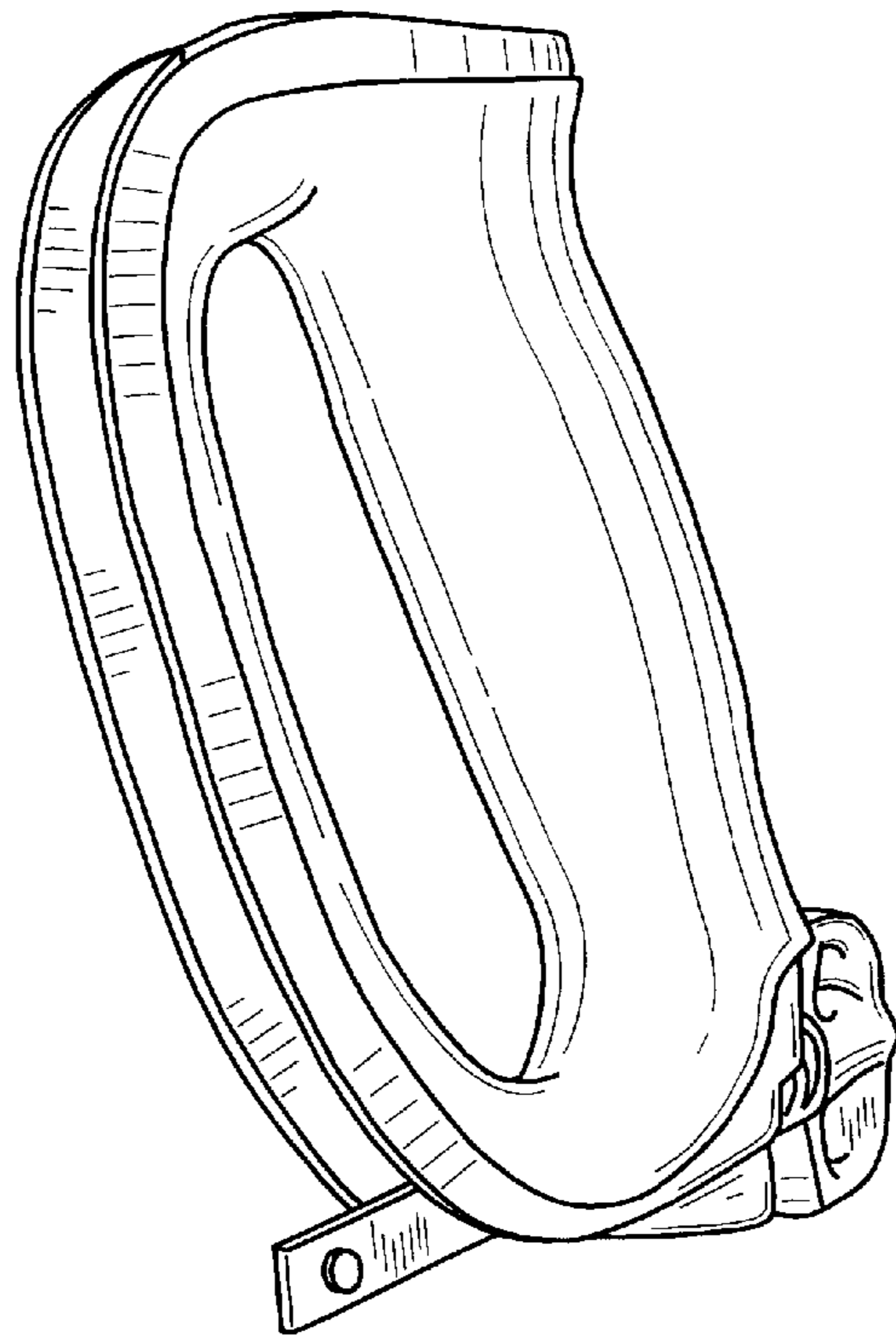
The ornamental design for a handle for a bow saw, as shown and described.

**DESCRIPTION**

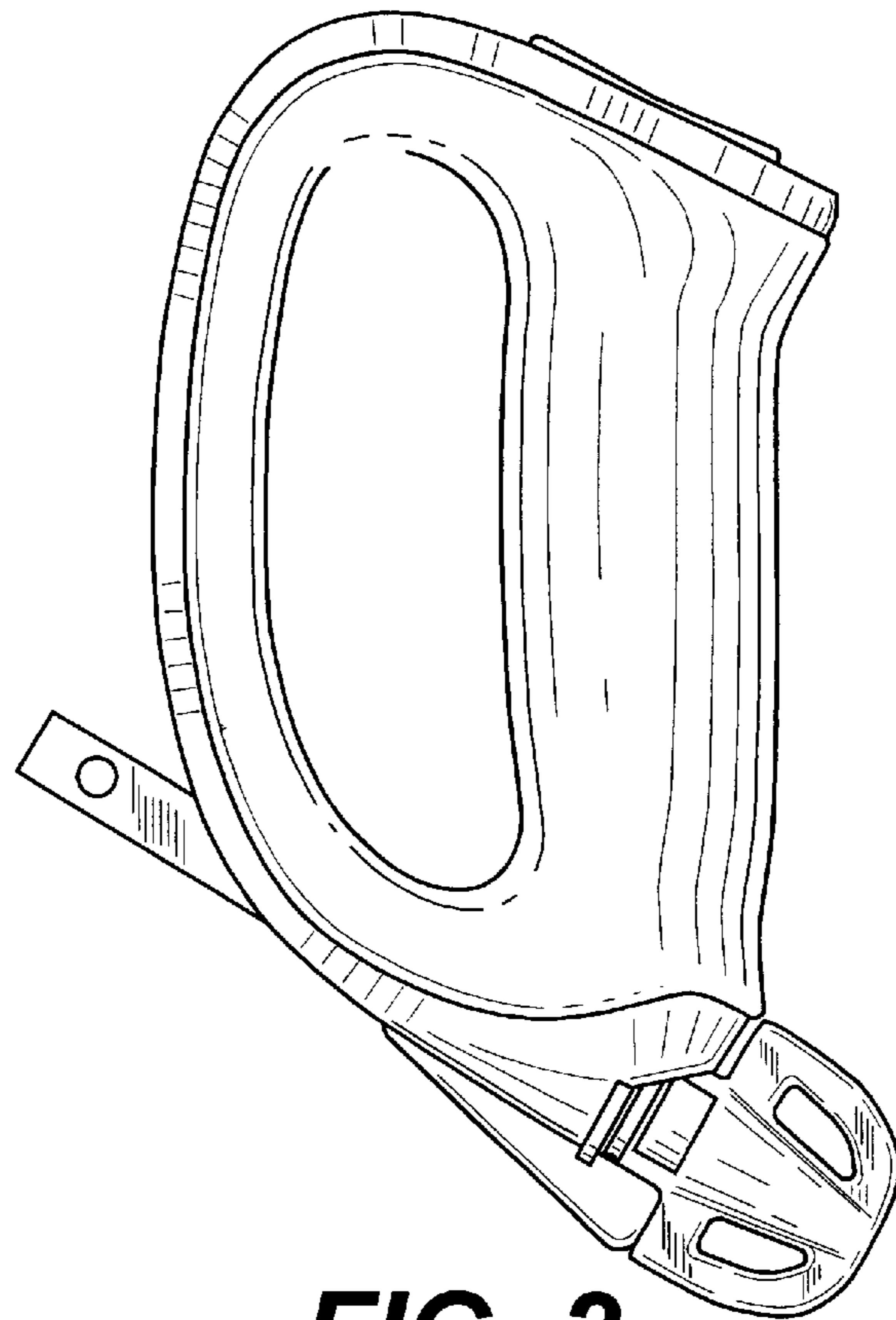
FIG. 1 is a front, side perspective view of a handle for a bow saw showing my new design;

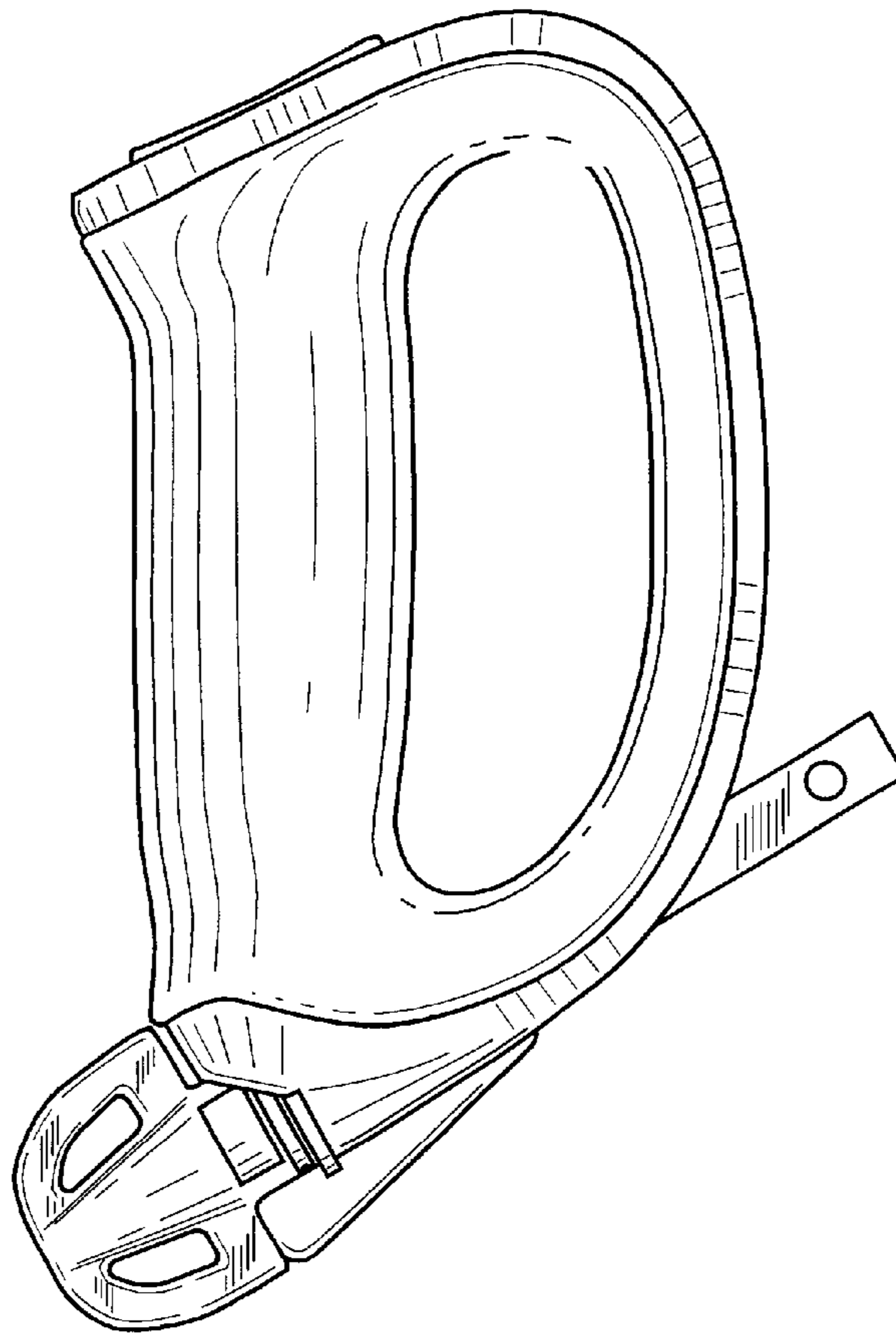




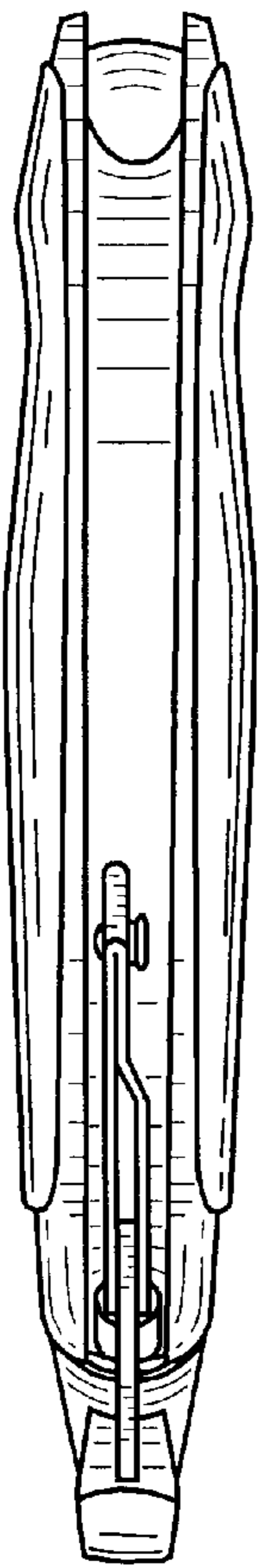

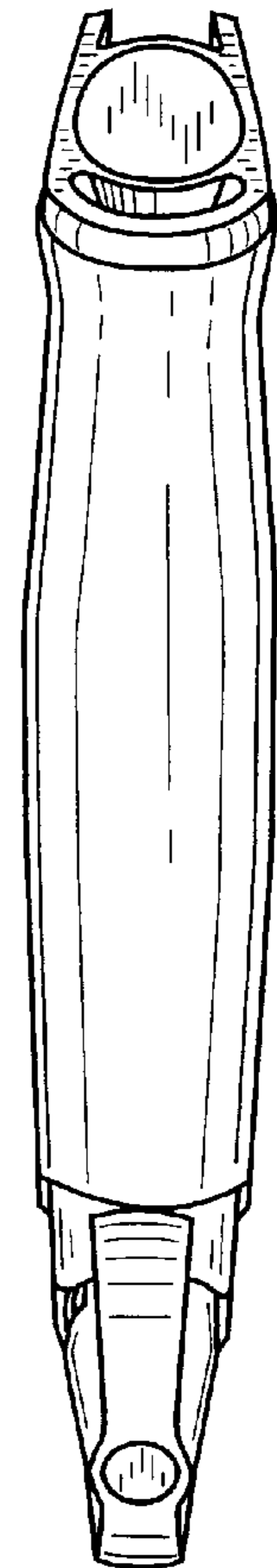

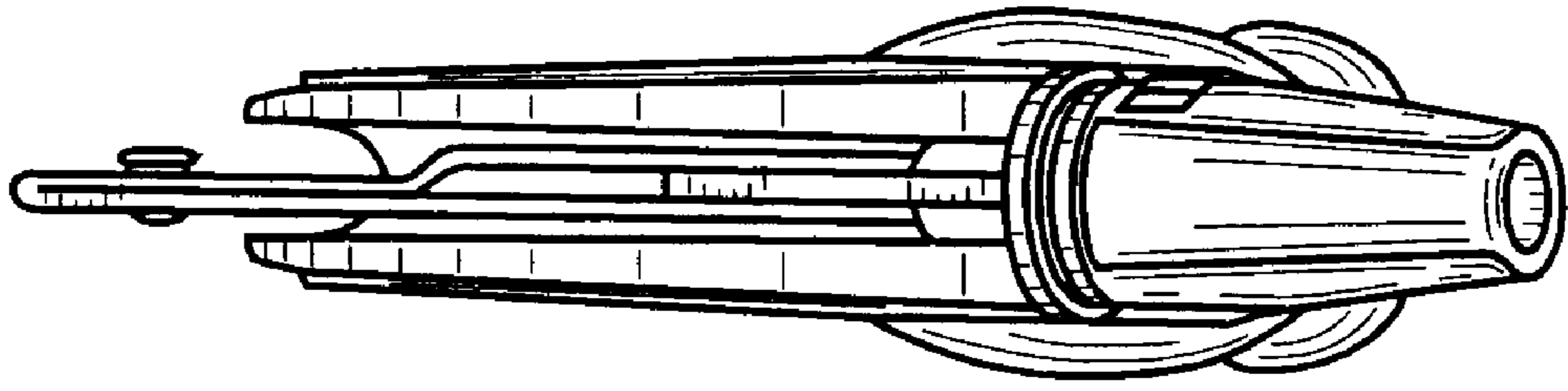

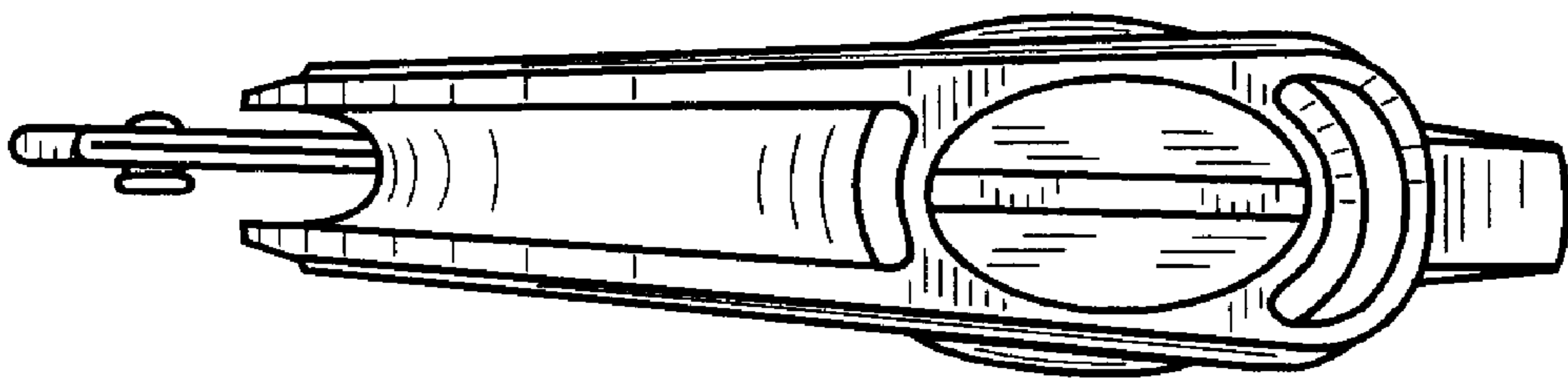
