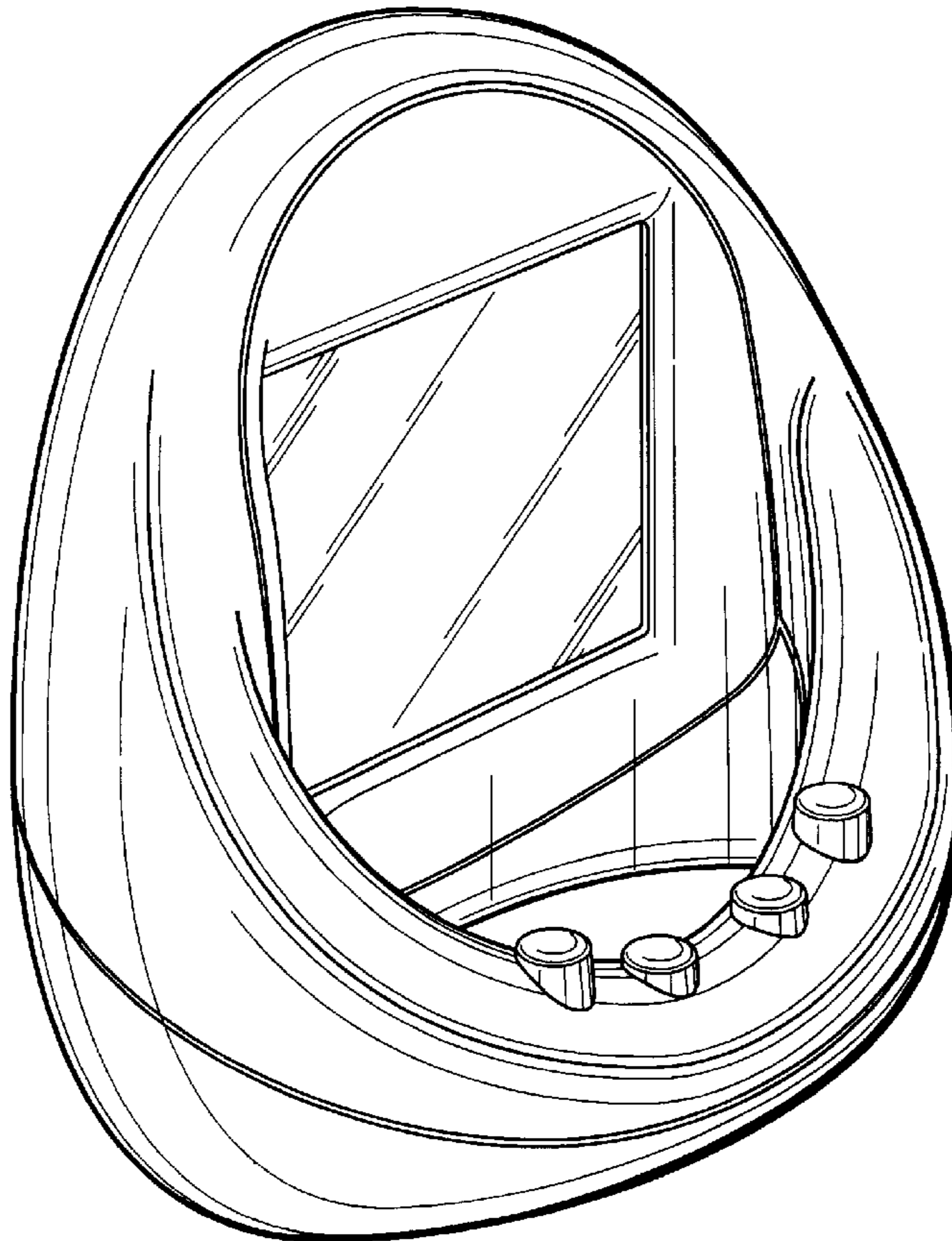
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a clock with thermometer showing my new design;
FIG. 2 is a front elevational view thereof;

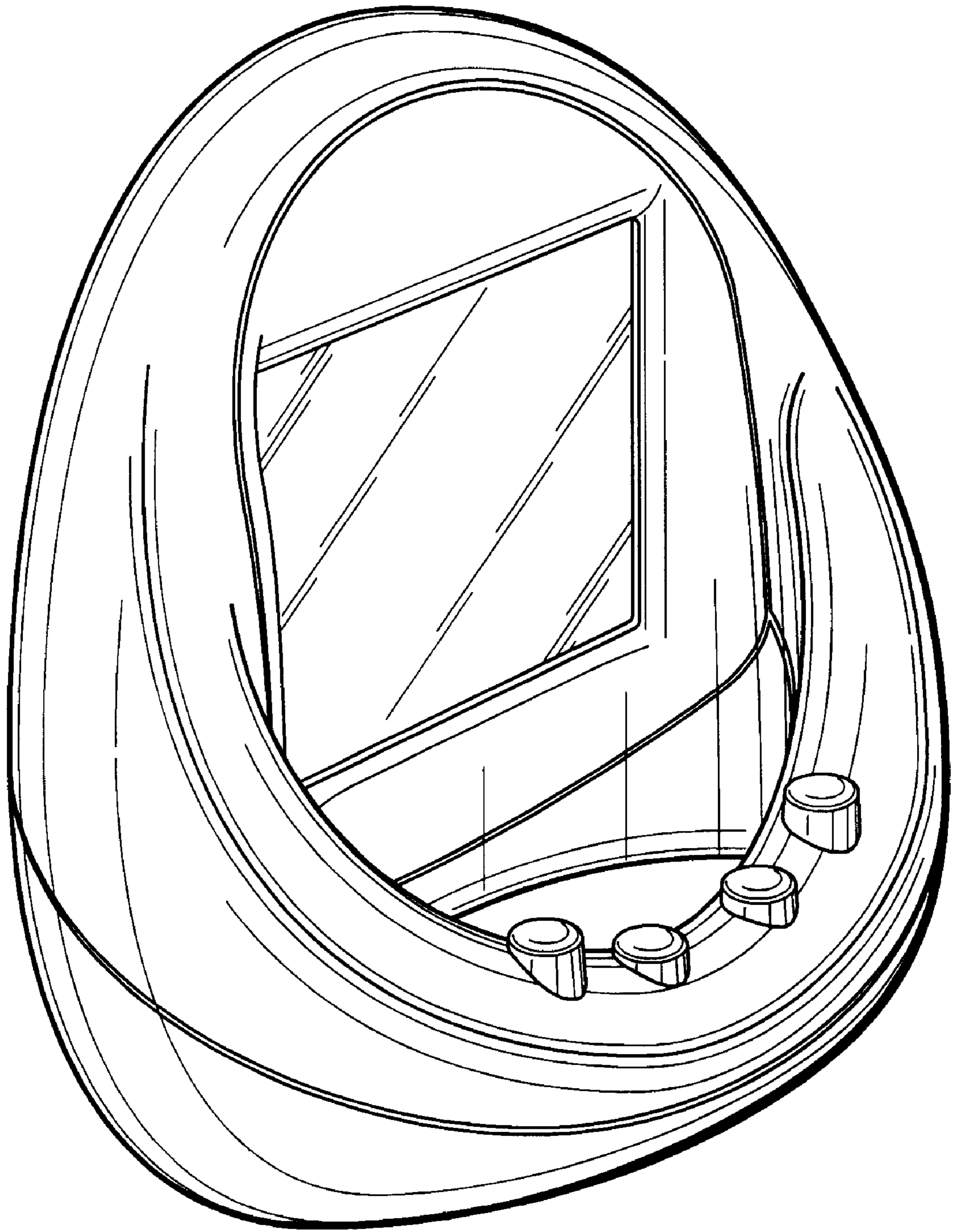

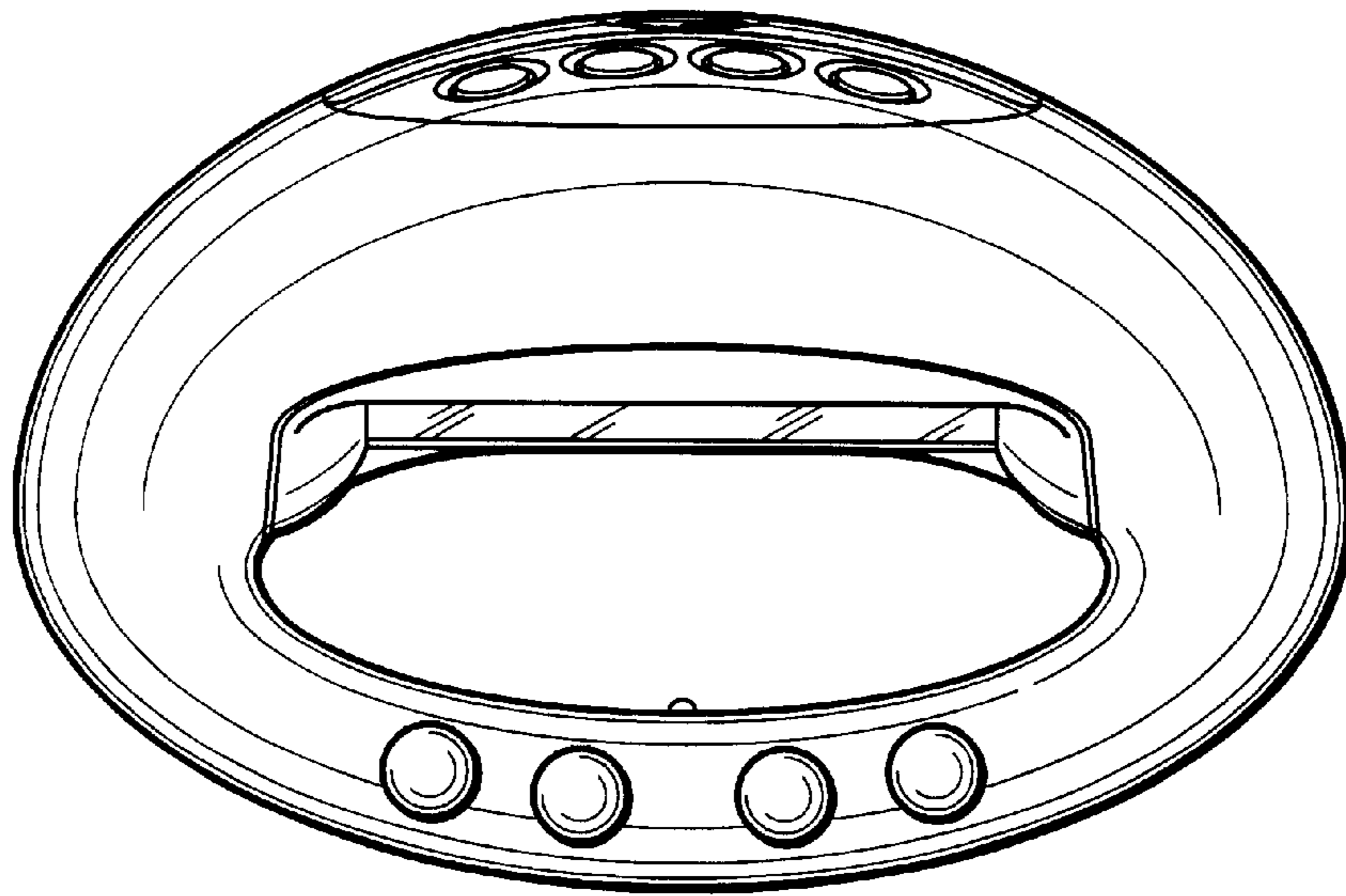

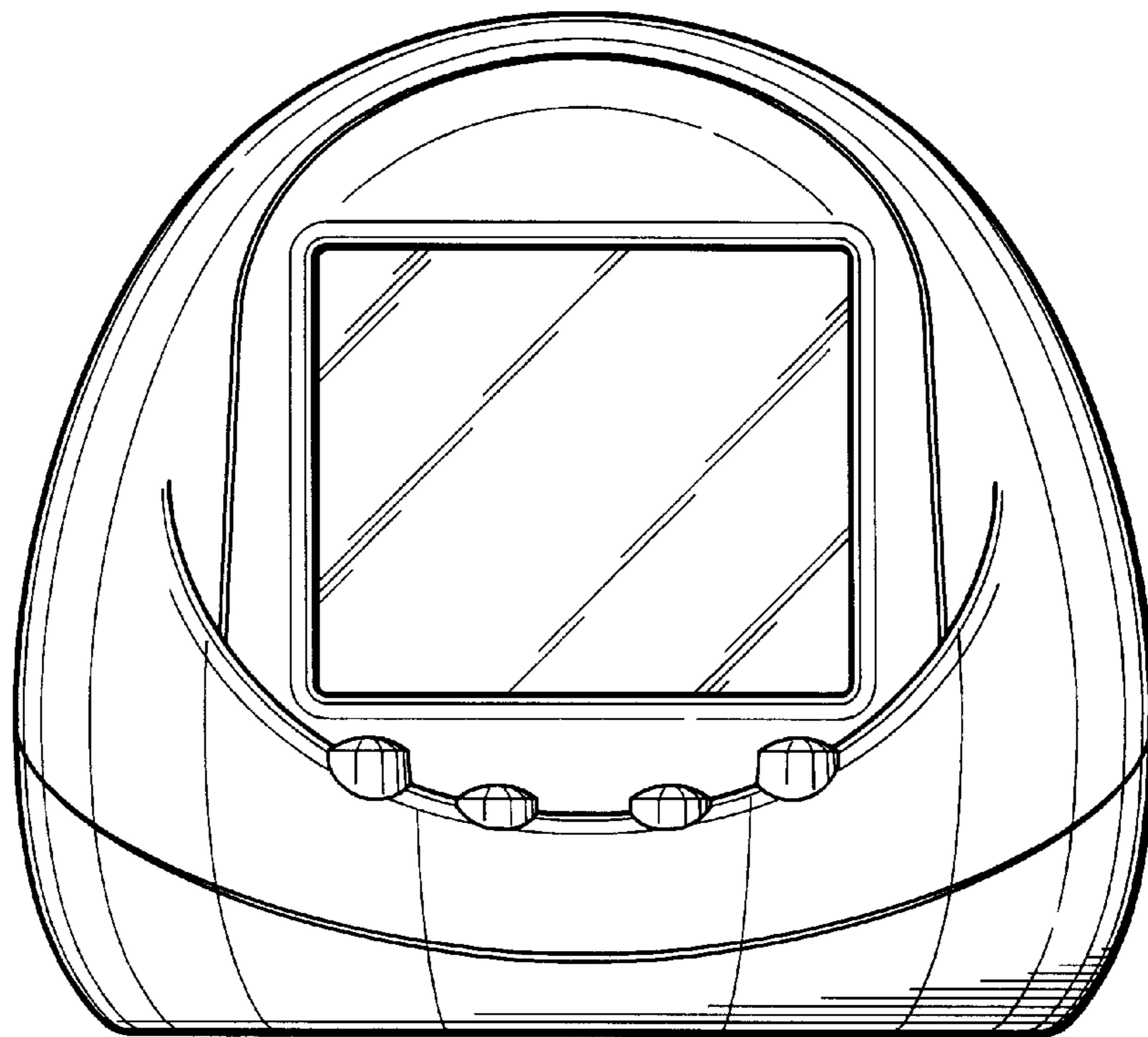

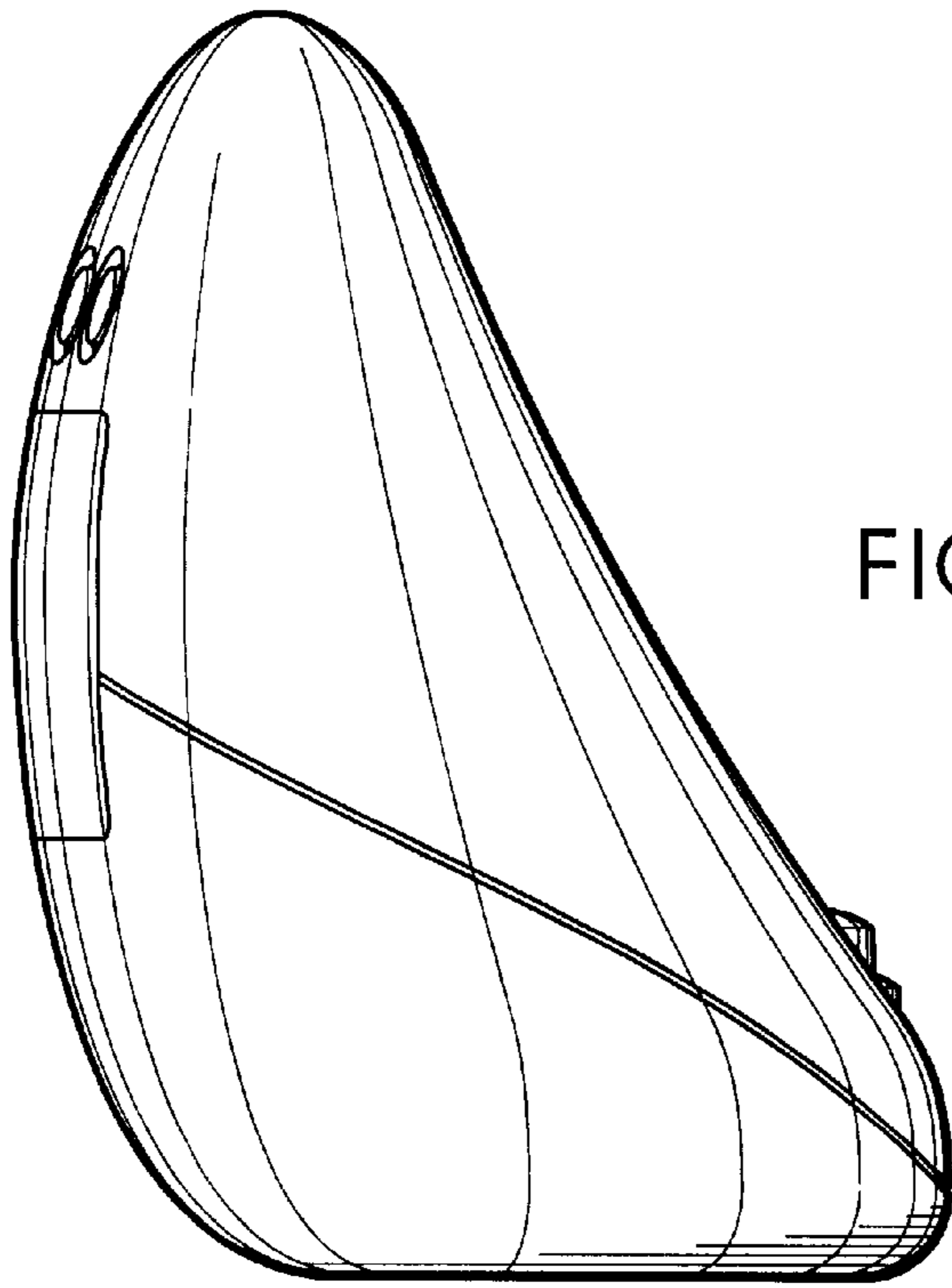

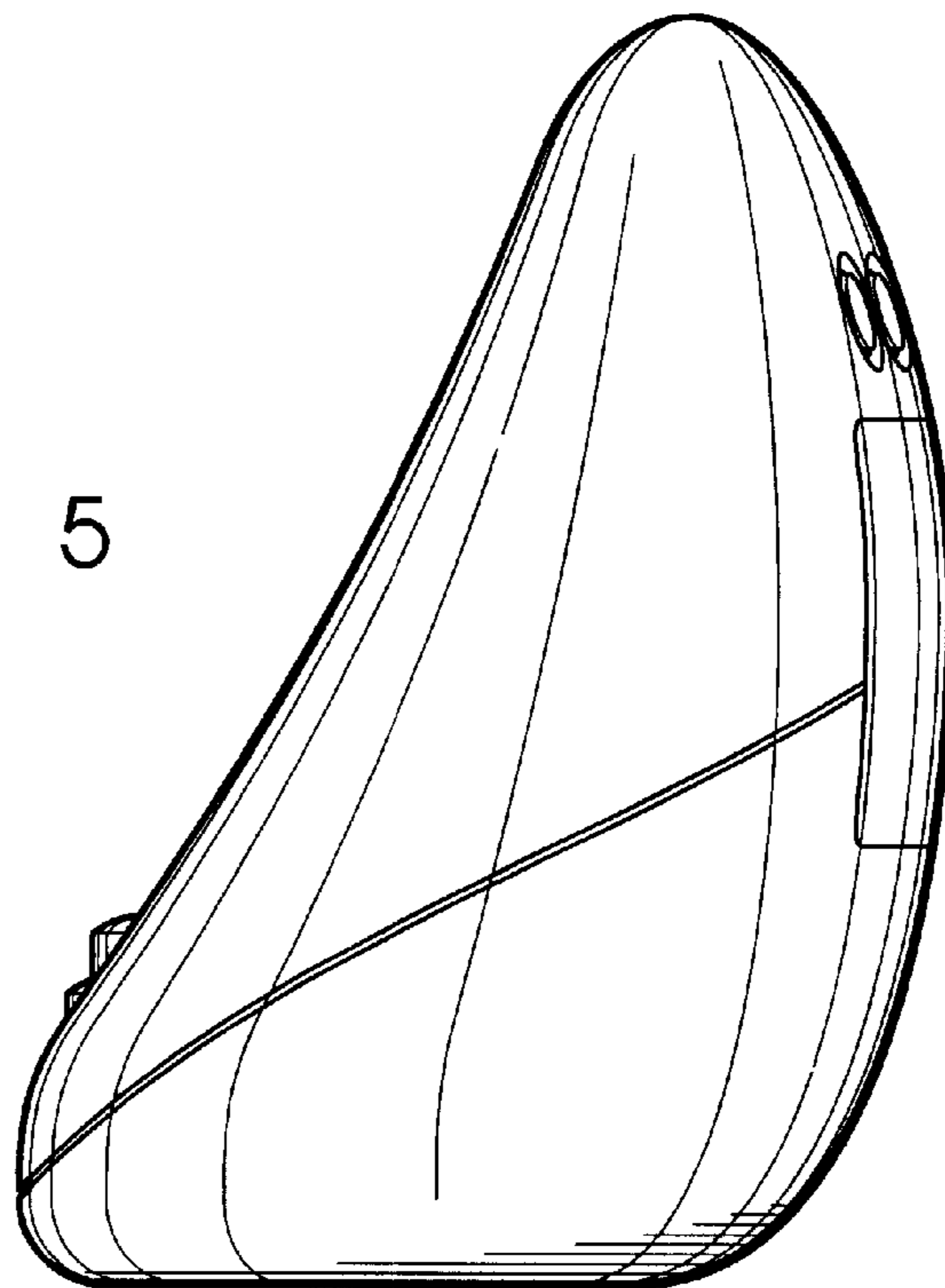

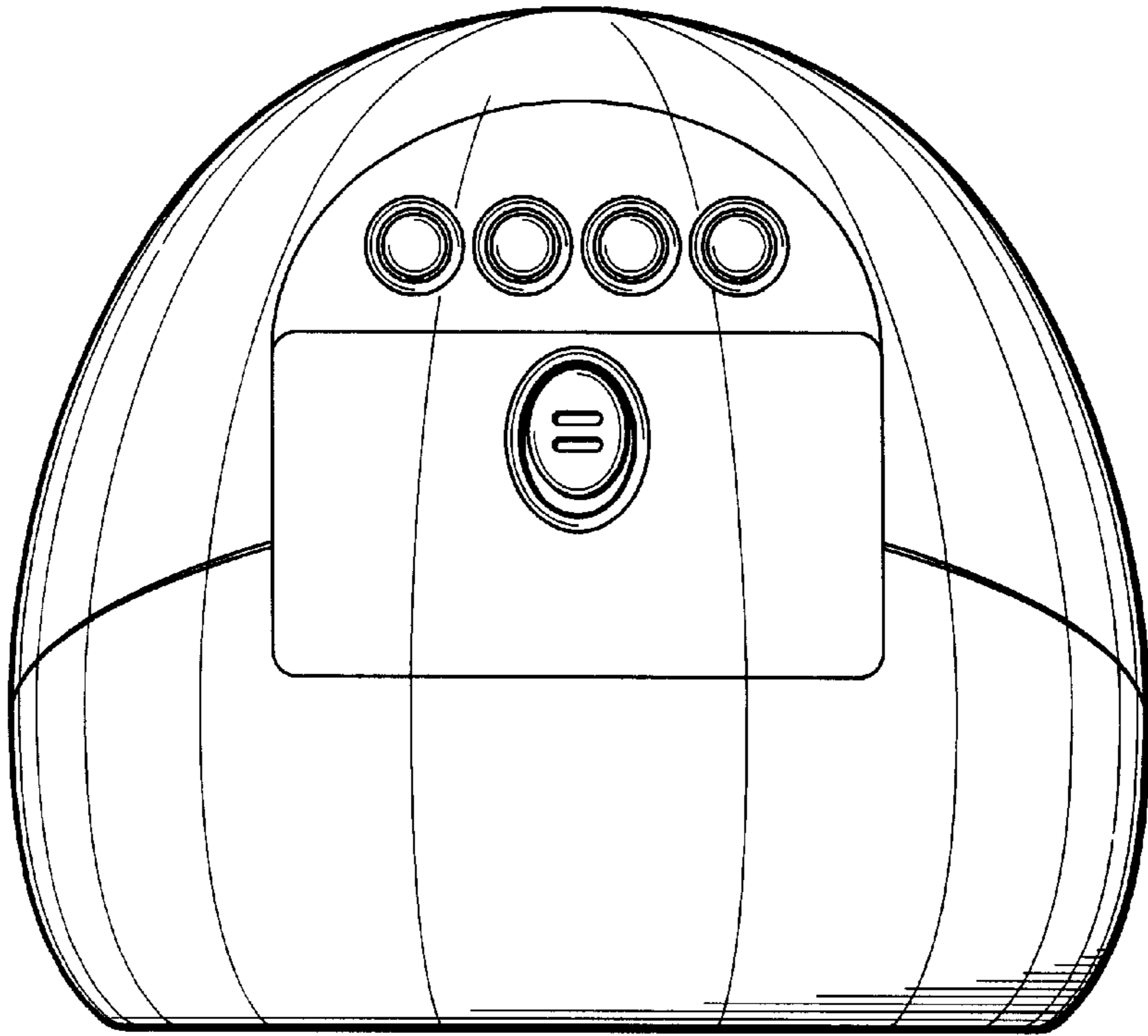

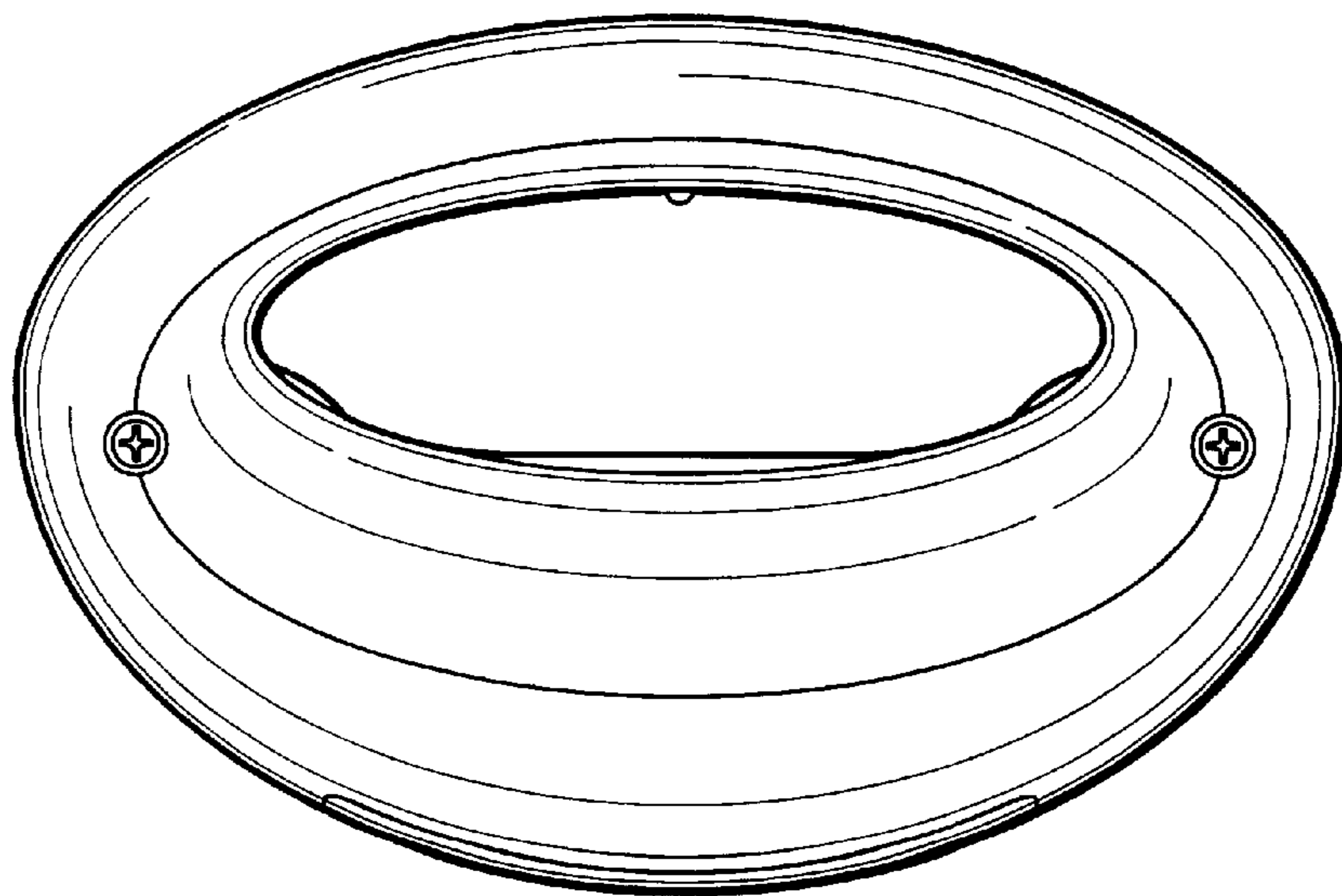
