The ornamental design for a watch case and bracelet (poly watch), as shown and described.

**DESCRIPTION**

FIG. 9 is a bottom view of the alternative embodiment;

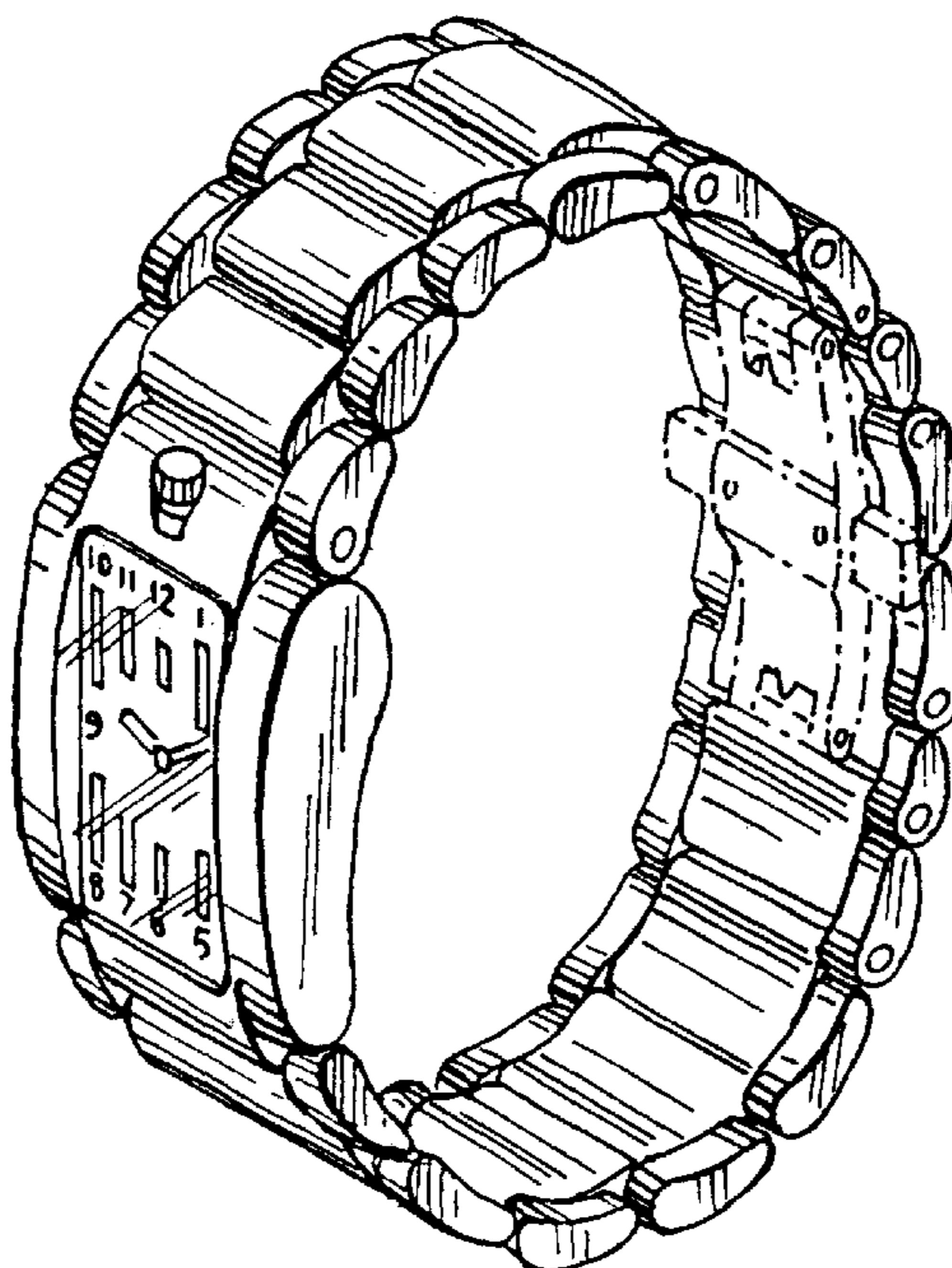
FIG. 10 is a front view of the alternative embodiment;

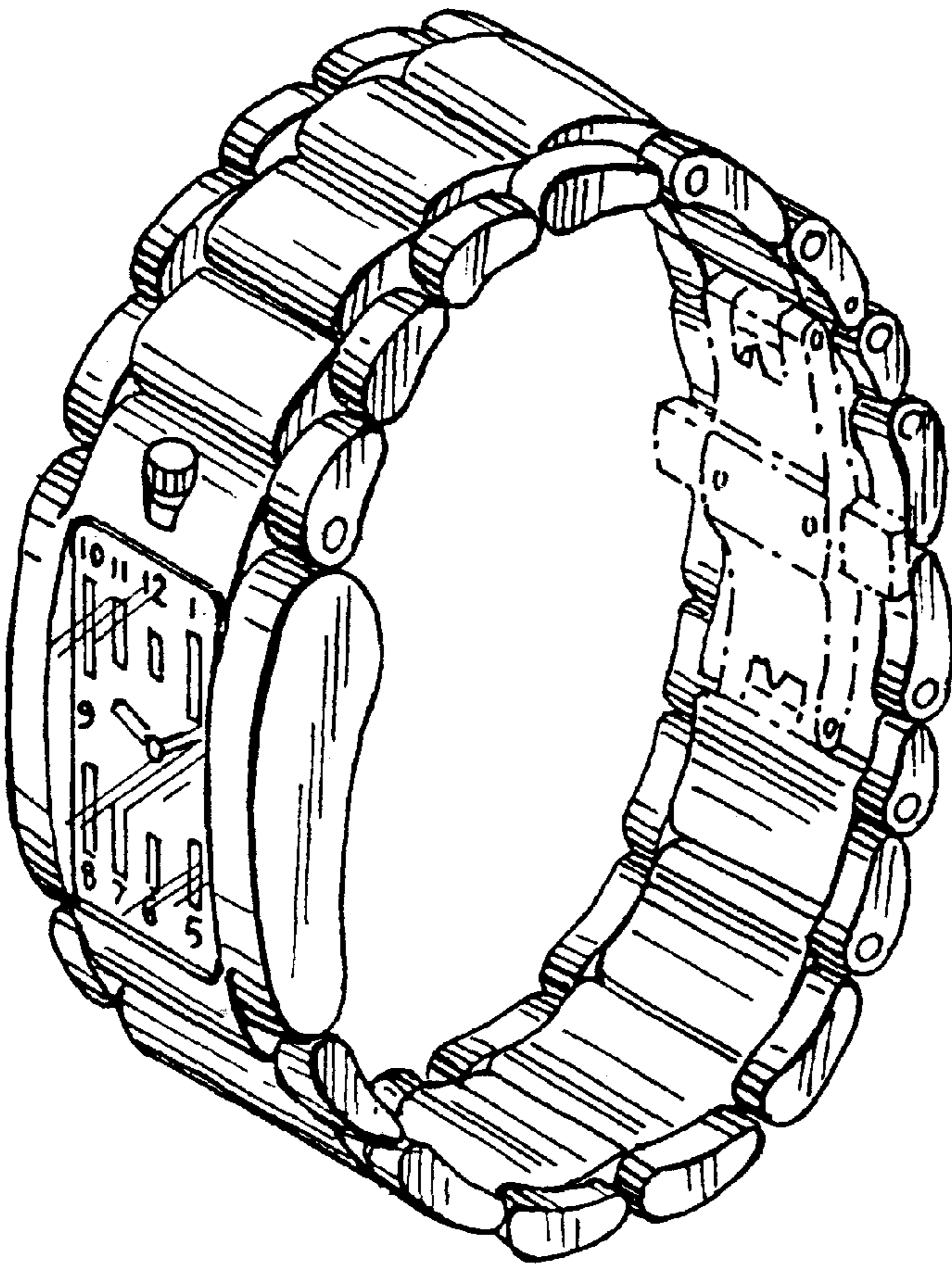

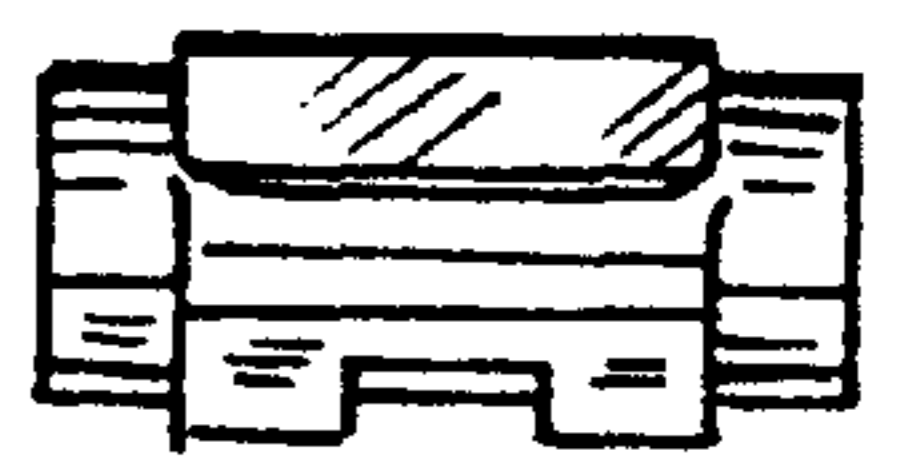
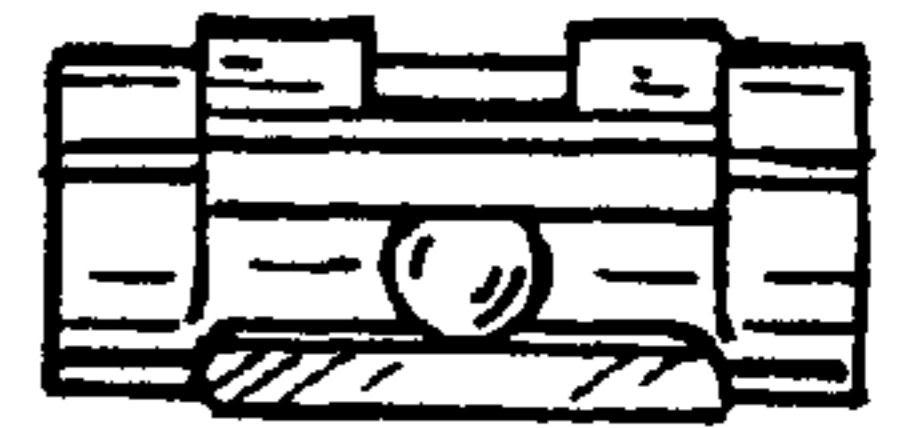

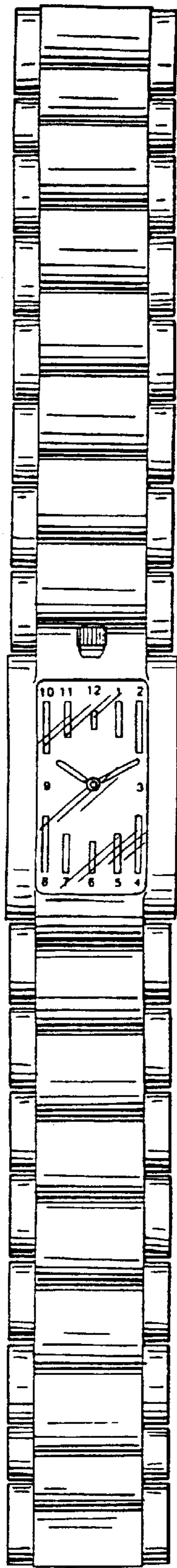

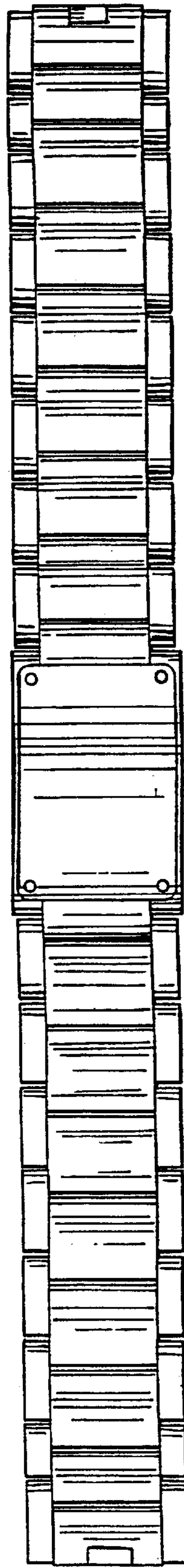

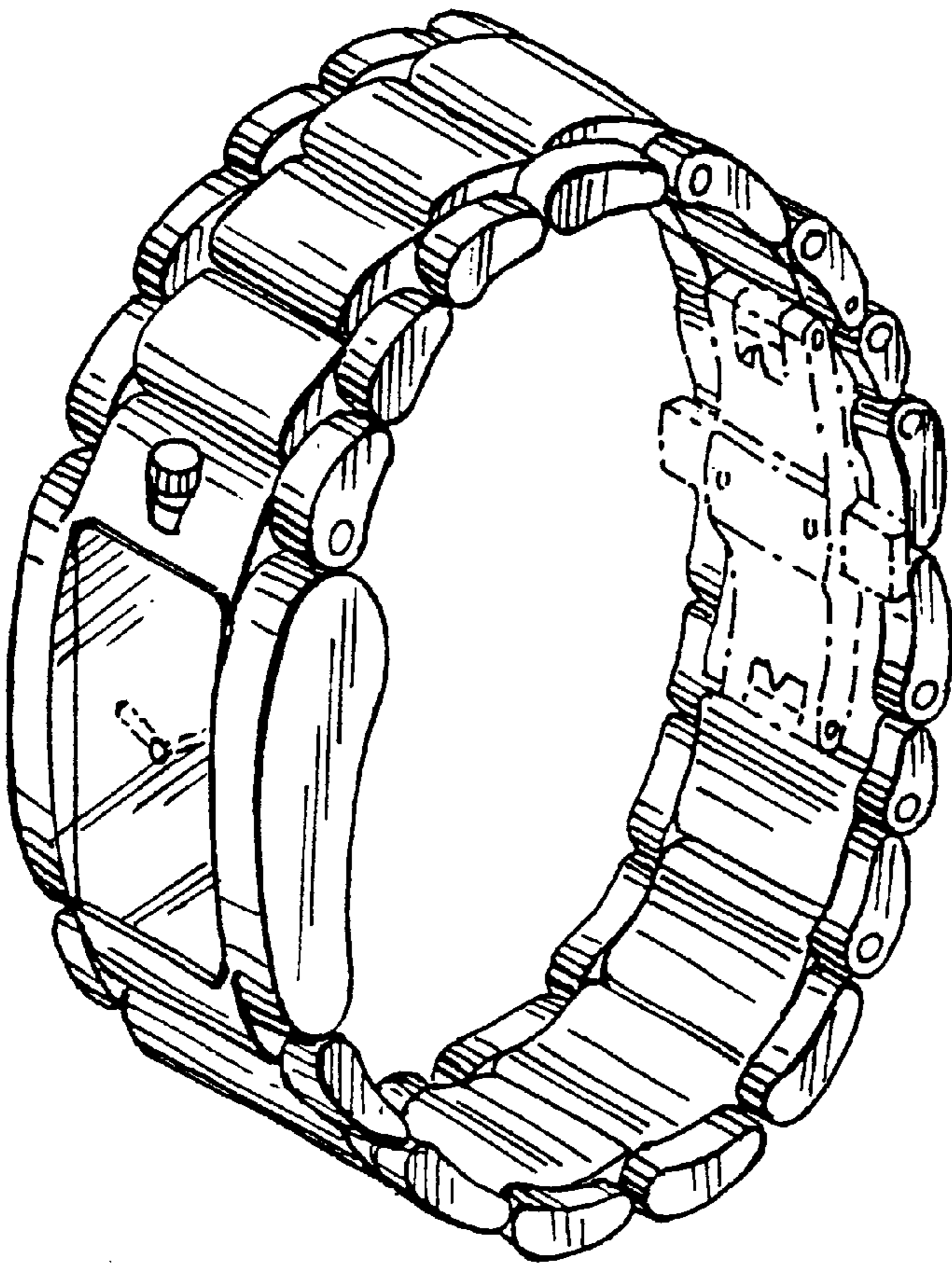

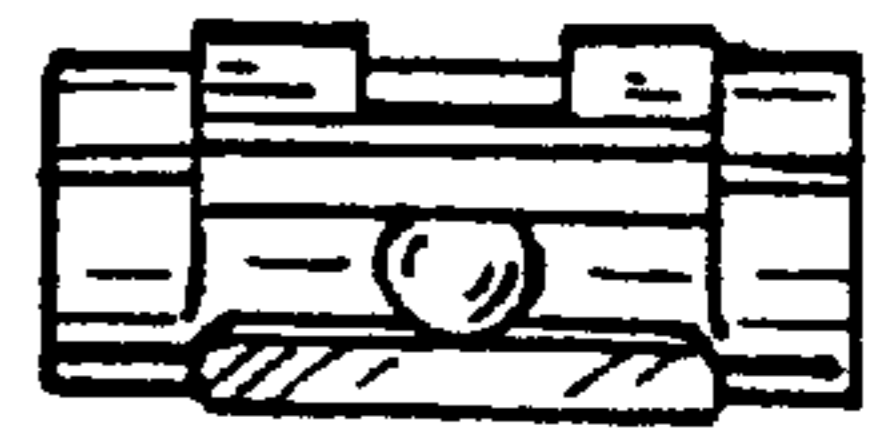

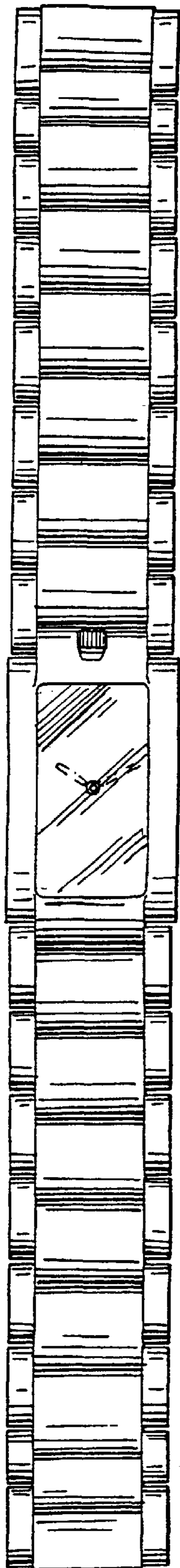

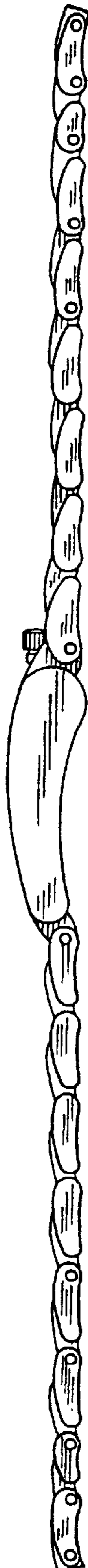

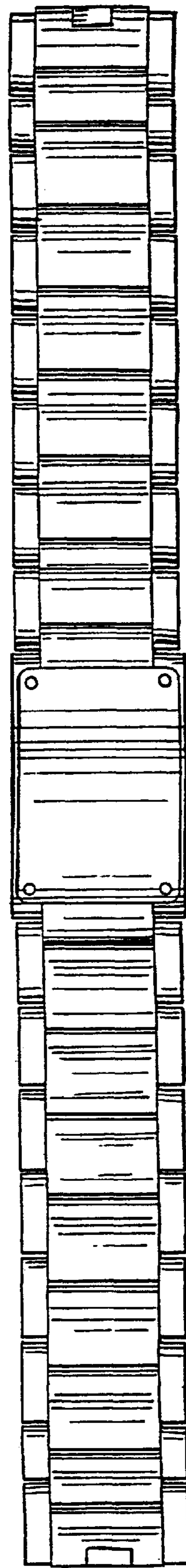
