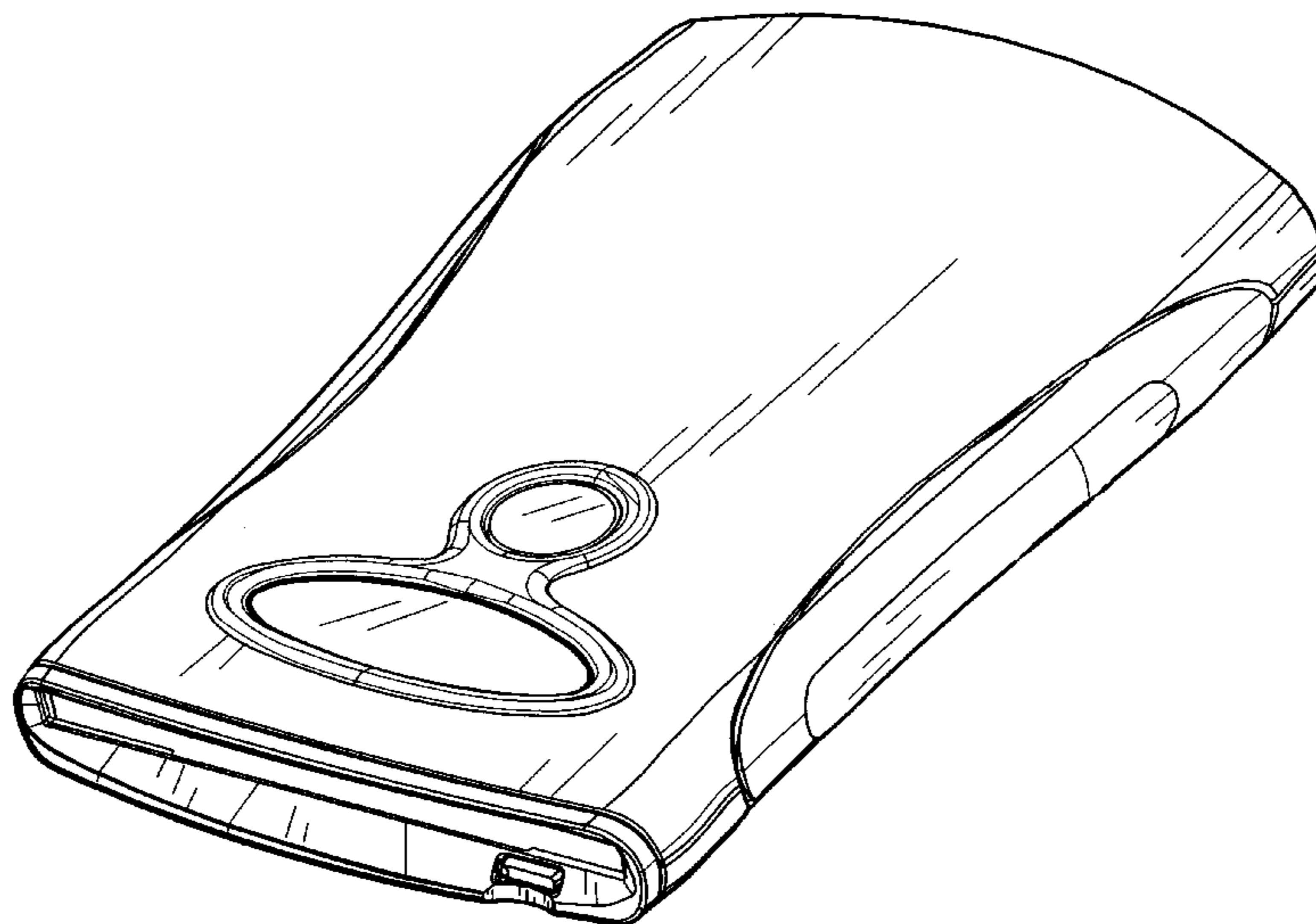
(57) **CLAIM**

The ornamental design for a removable storage drive enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a removable storage drive enclosure showing our new design;
 FIG. 2 is a front elevational view of FIG. 1
 FIG. 3 is a top plan view of the embodiment shown in FIG. 1.
 FIG. 4 is a side elevational view of FIG. 1.
 FIG. 5 is a rear elevational view of FIG. 1.

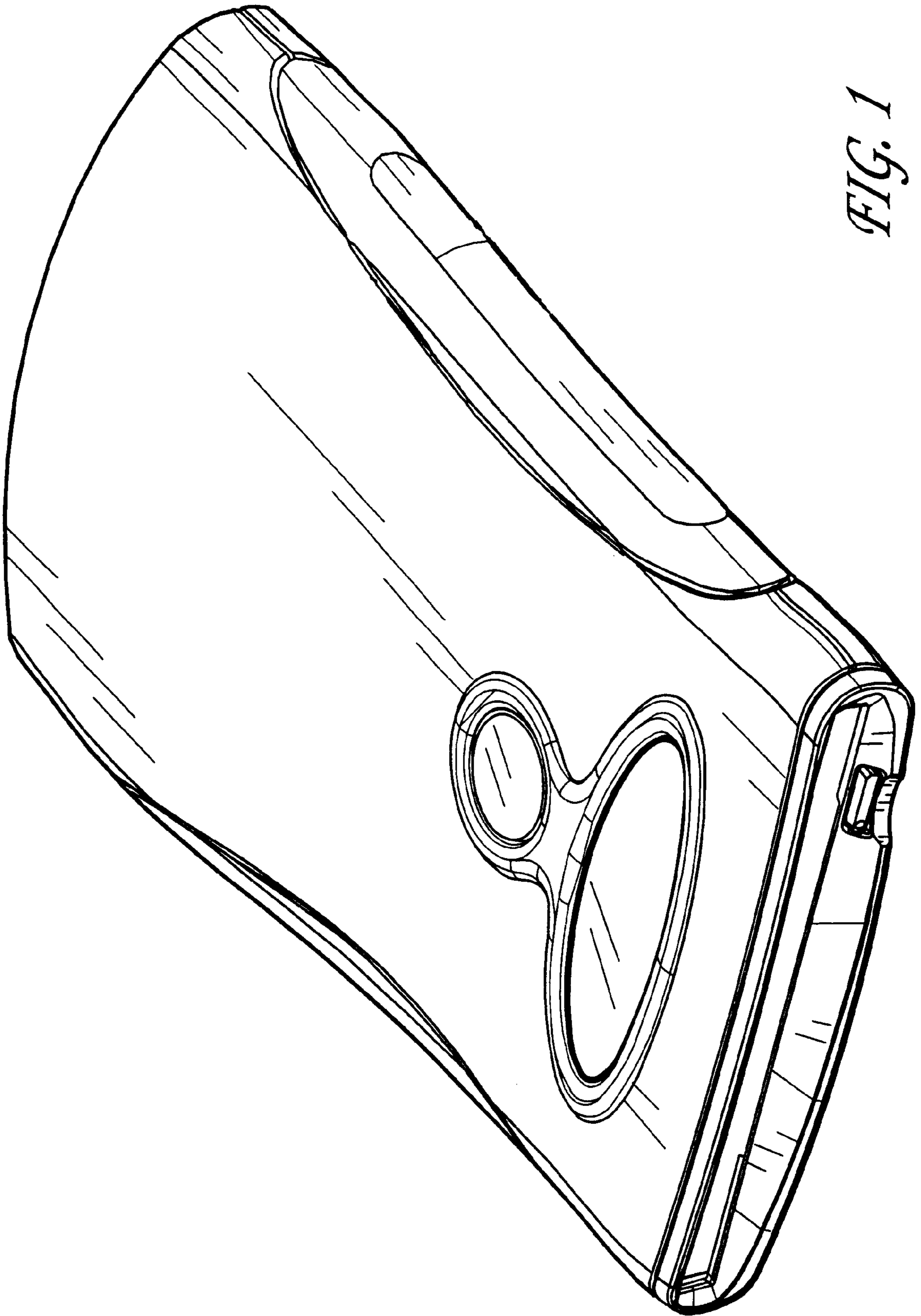

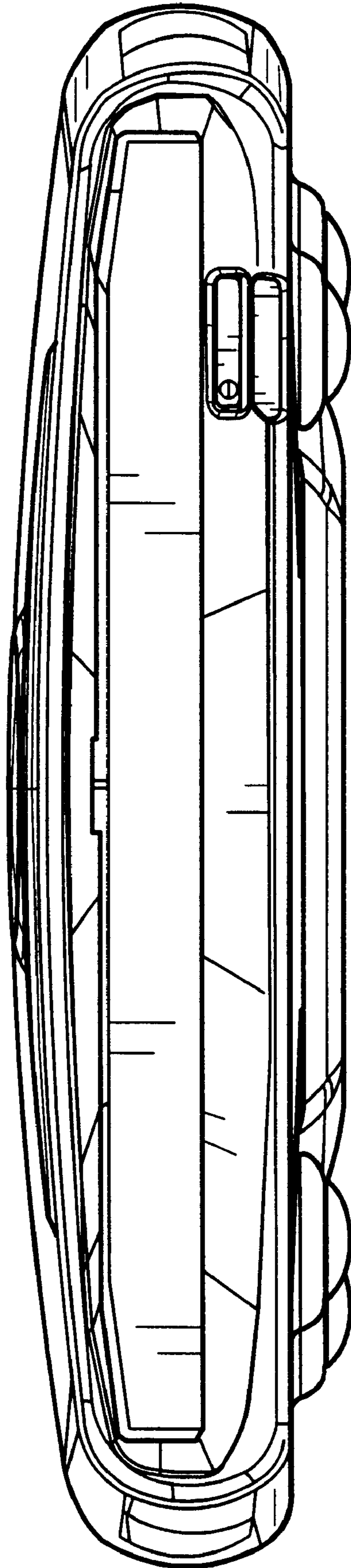

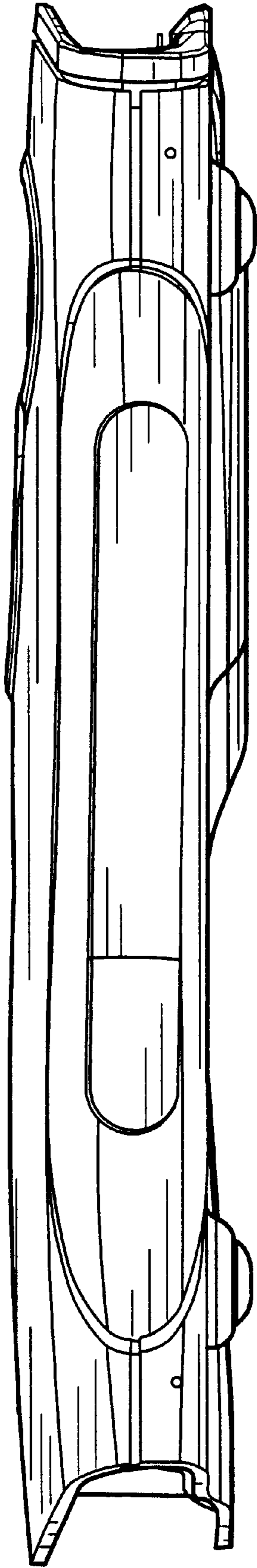

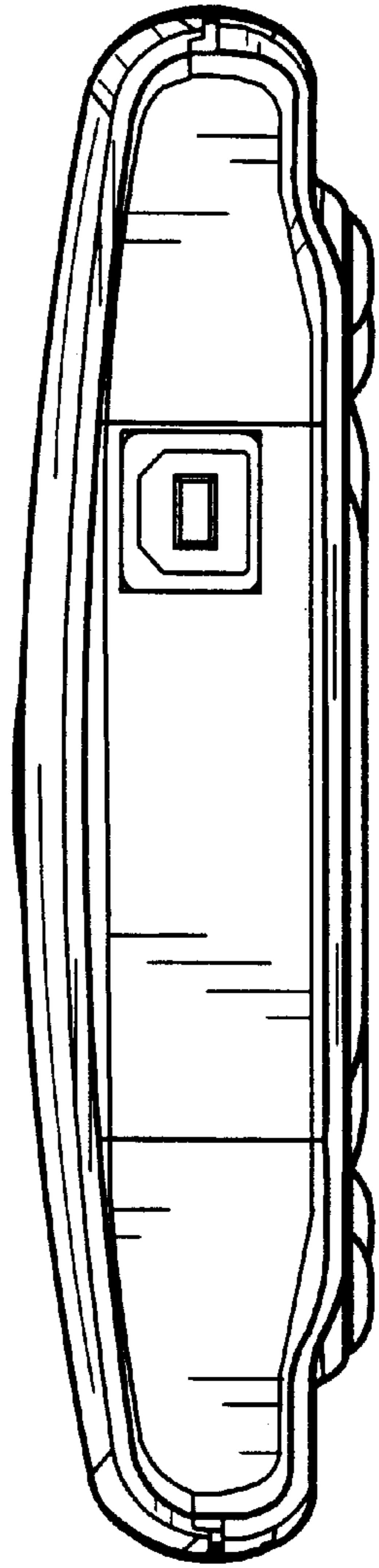

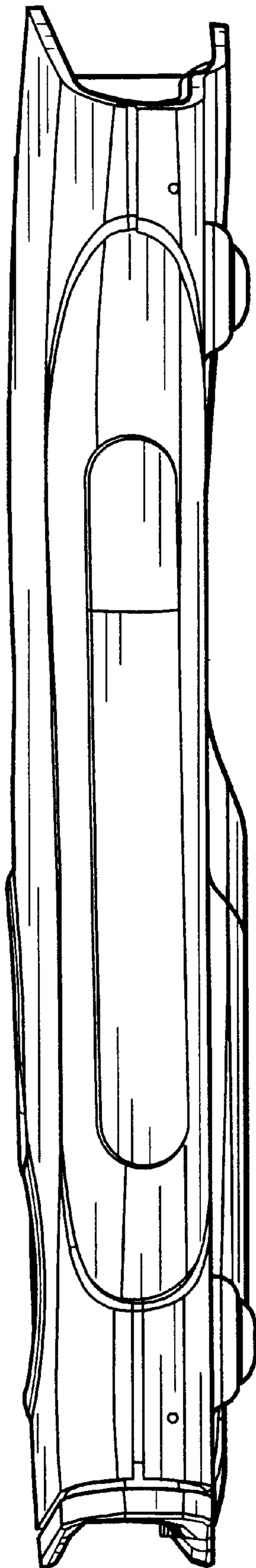
