The ornamental design for a portion of a book with maraca  
implanted therein, as shown and described.

**DESCRIPTION**

maraca implanted therein showing the invention, the book  
being shown in a closed position;

FIG. 4 is a bottom view of the invention;

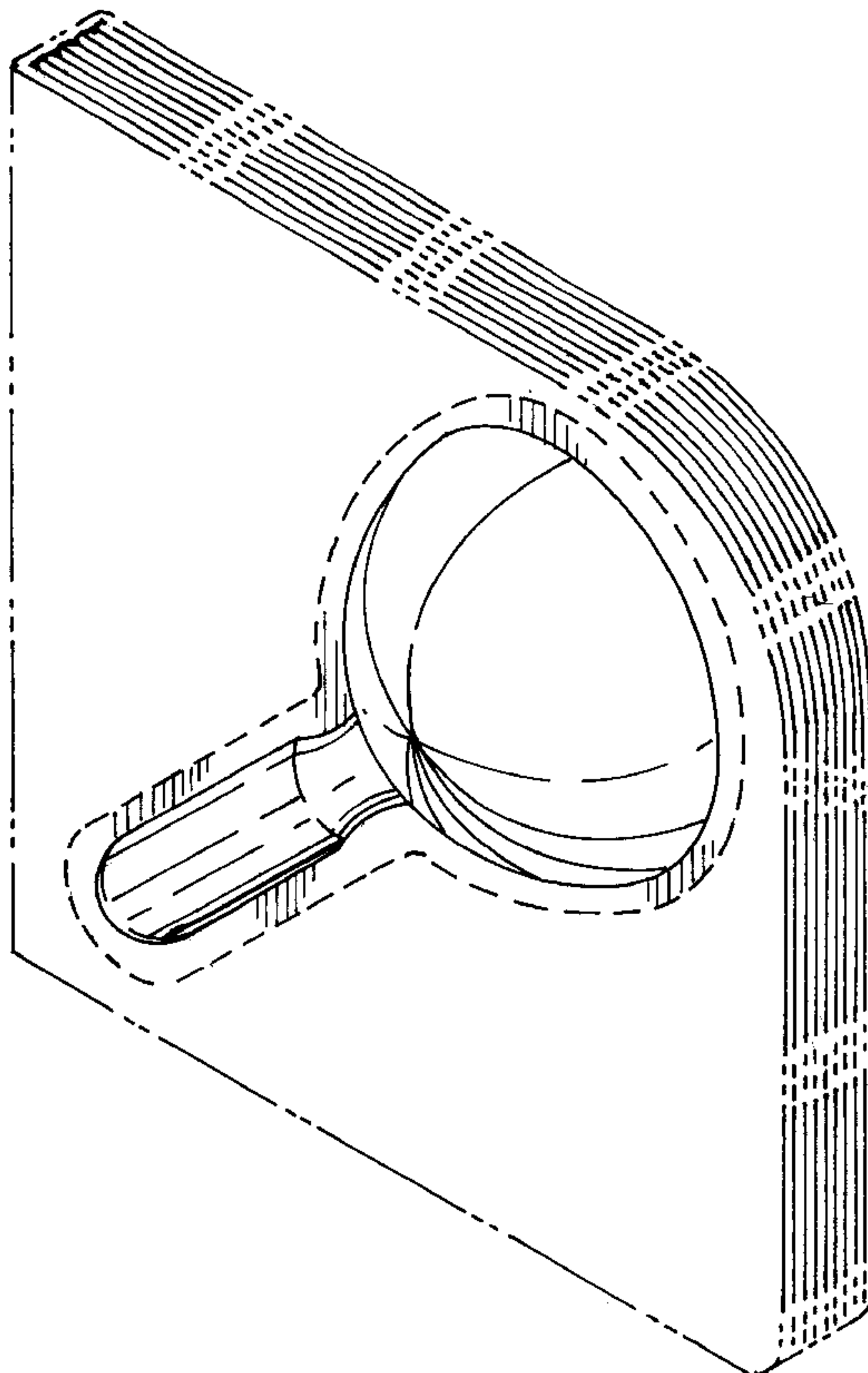
FIG. 5 is a front view of the invention;

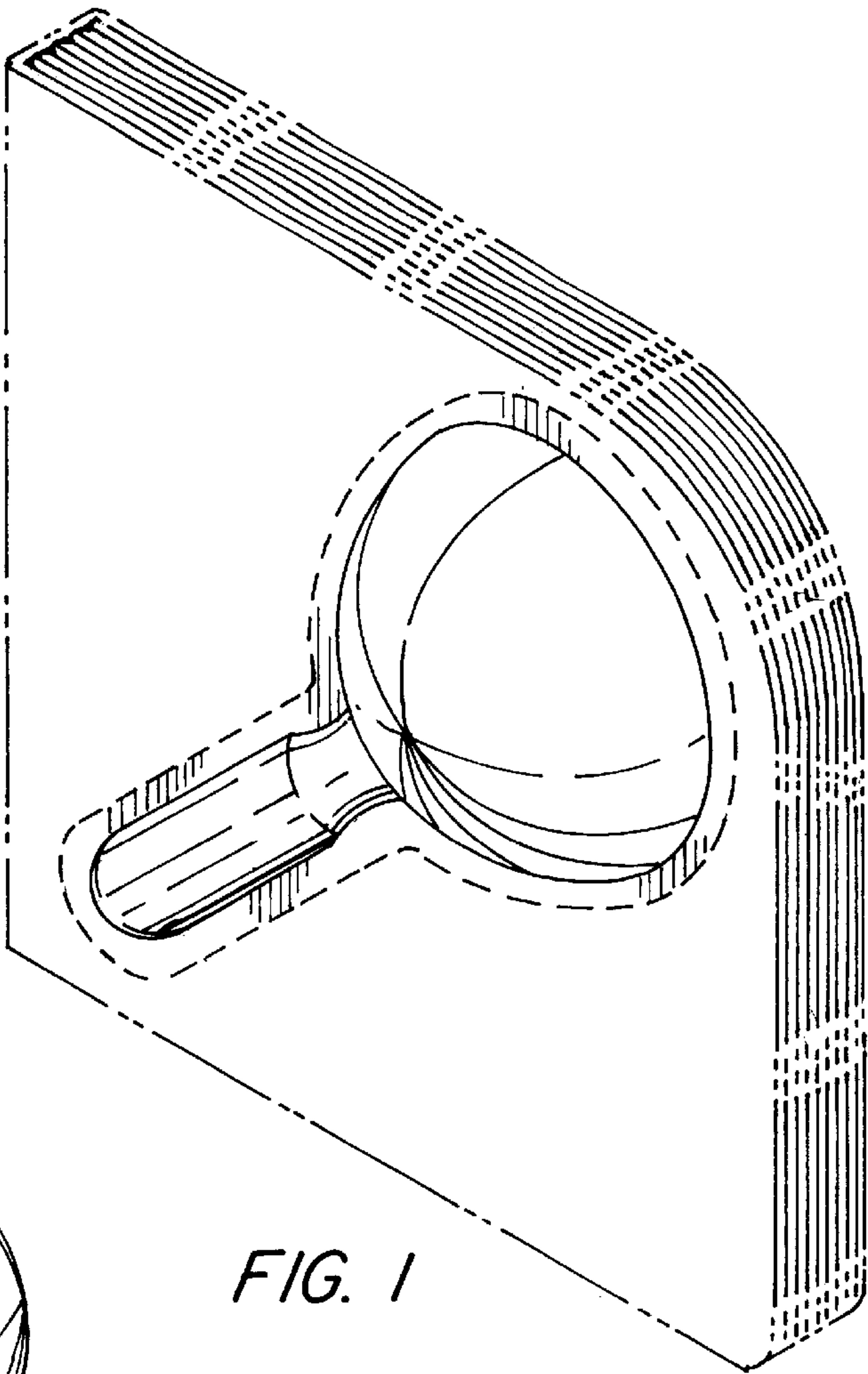

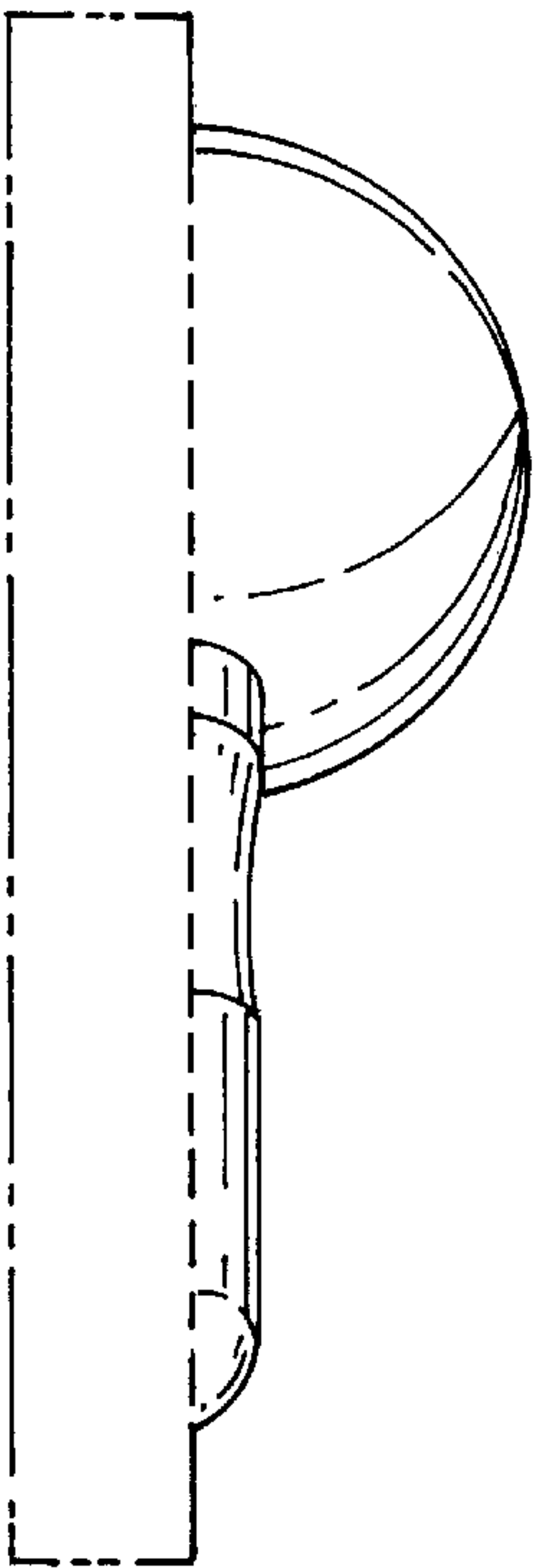

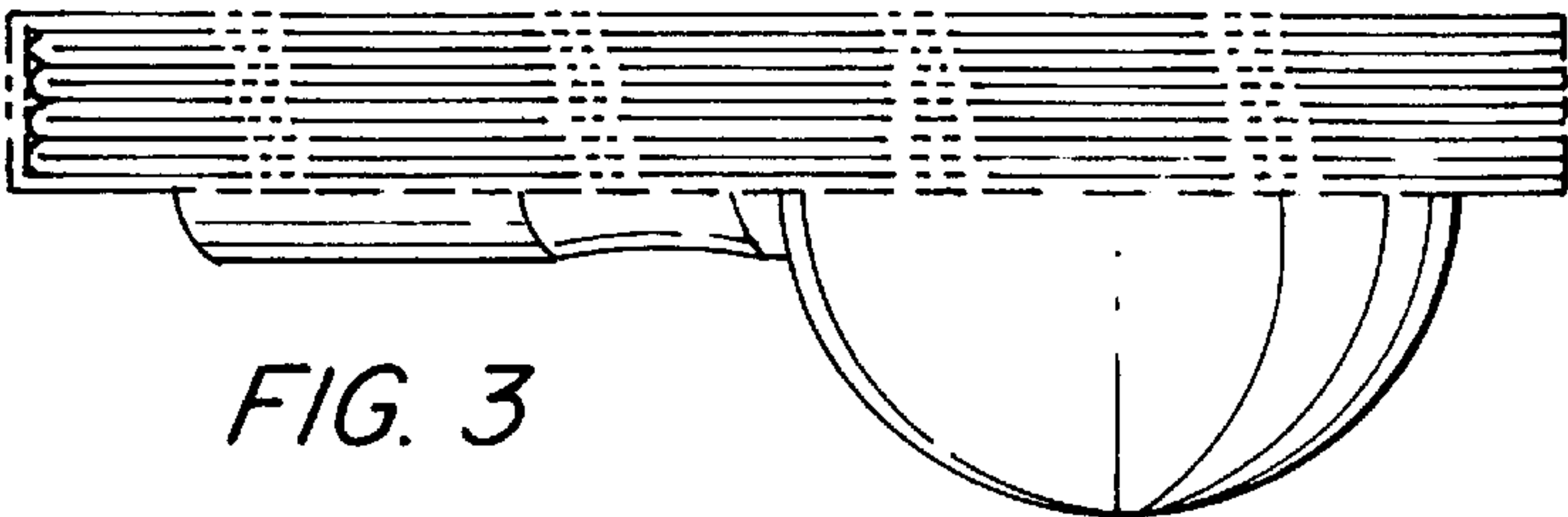

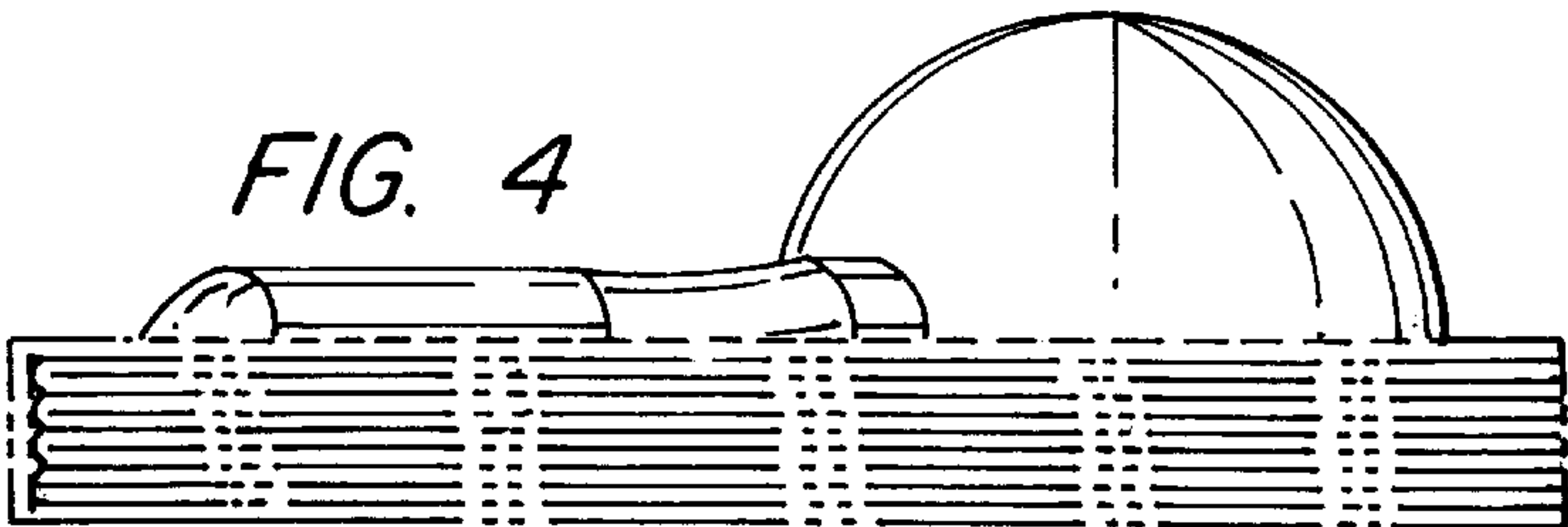

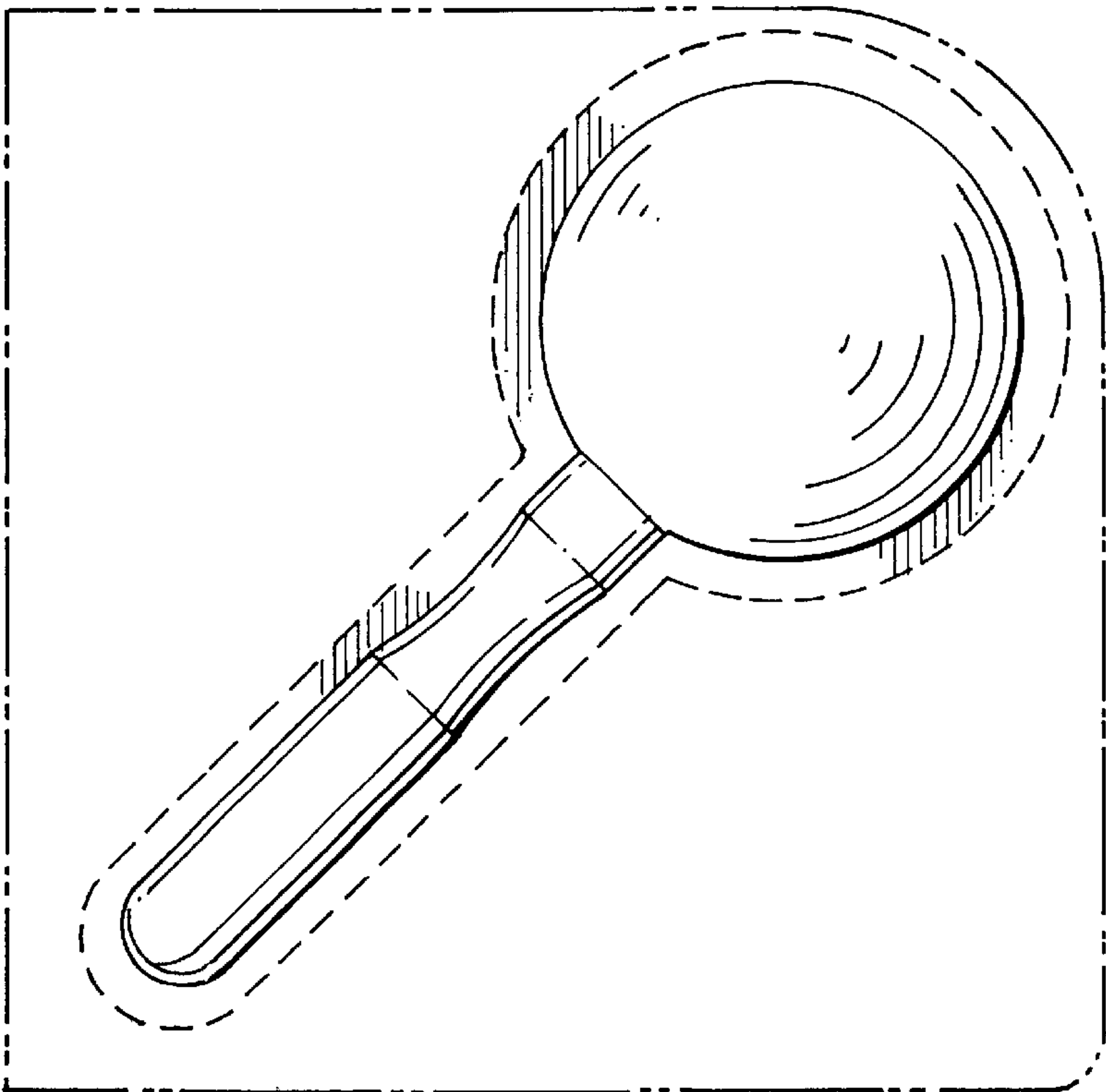

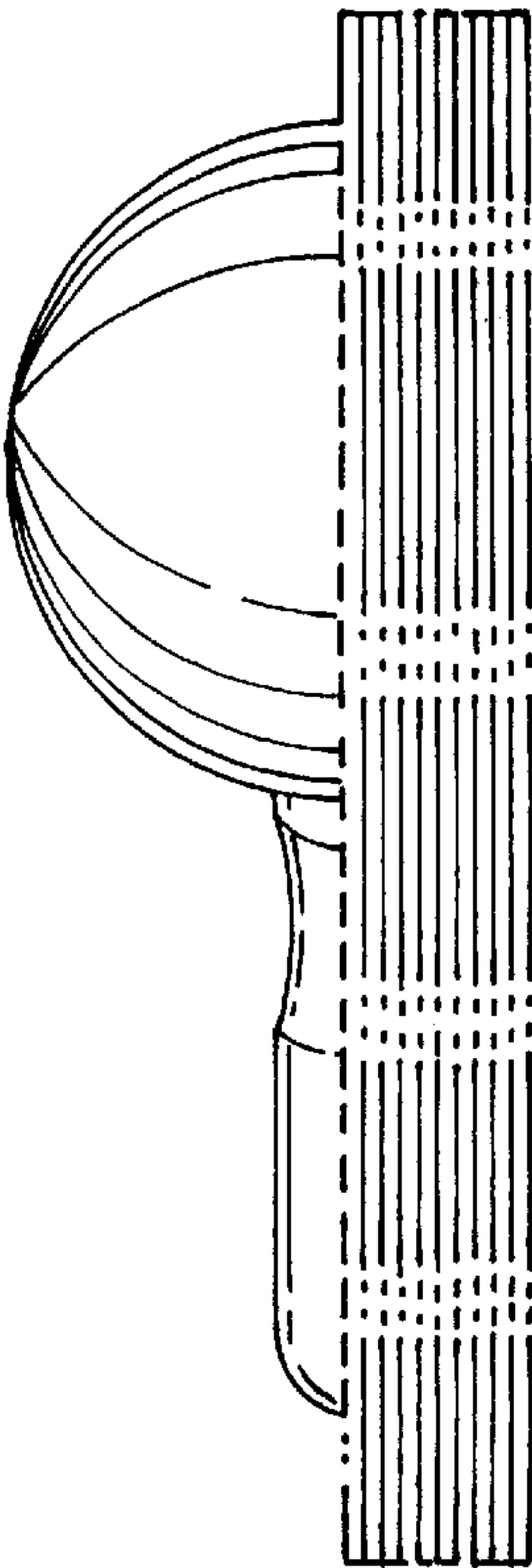

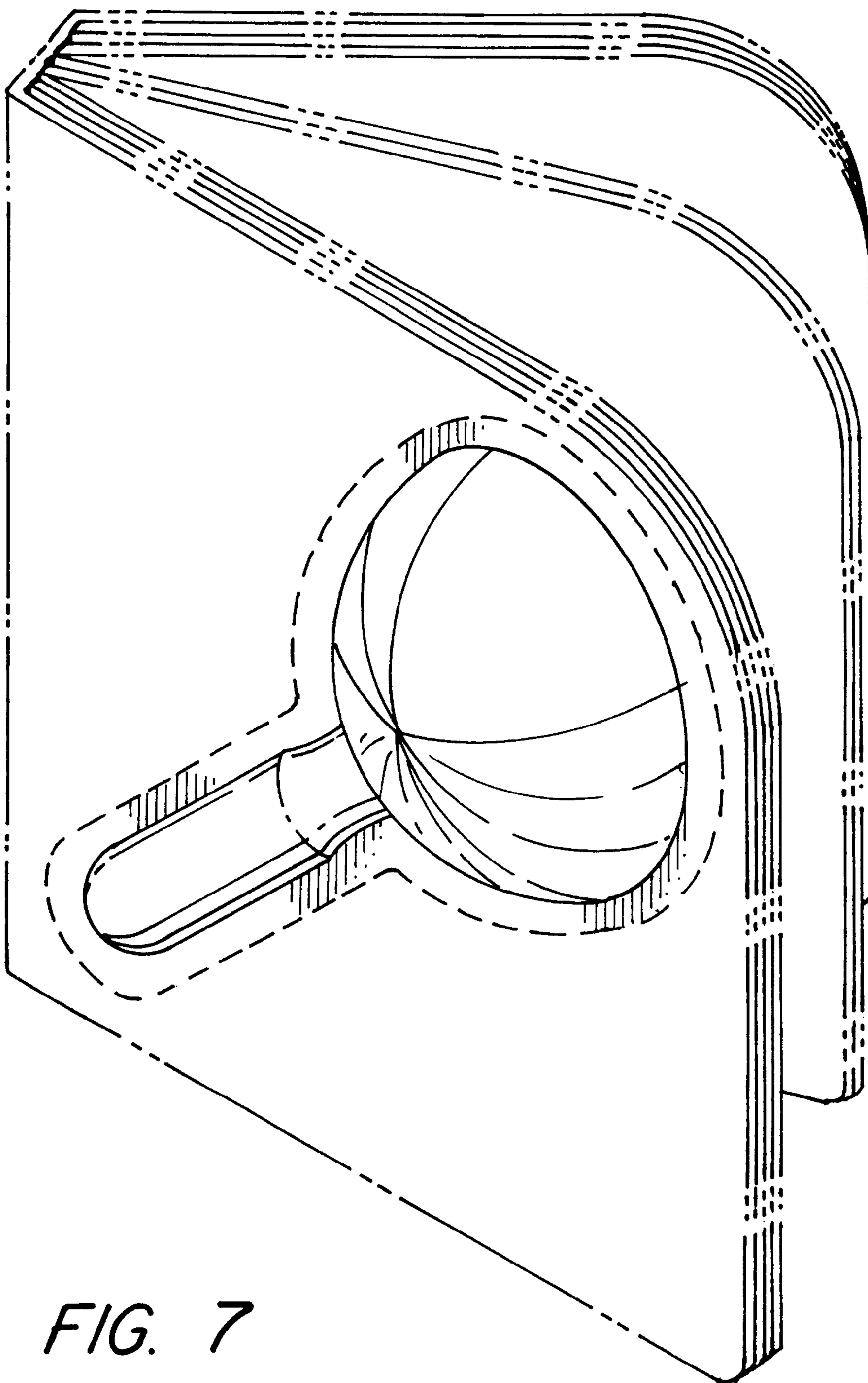
