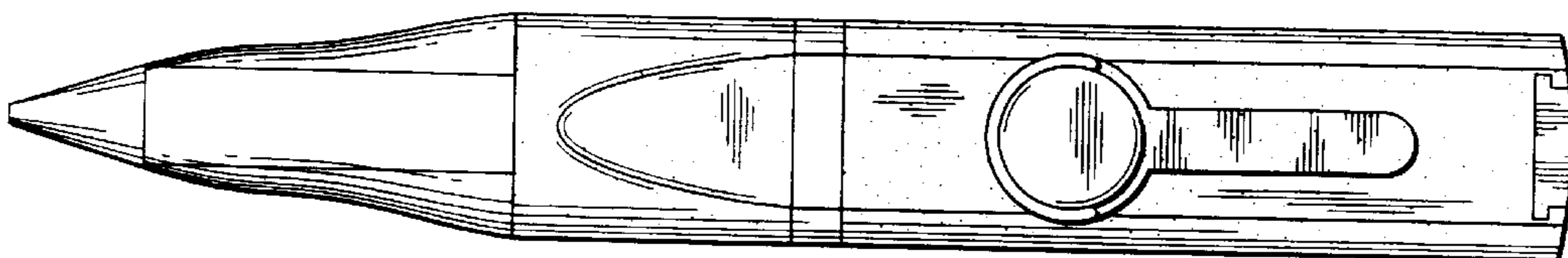
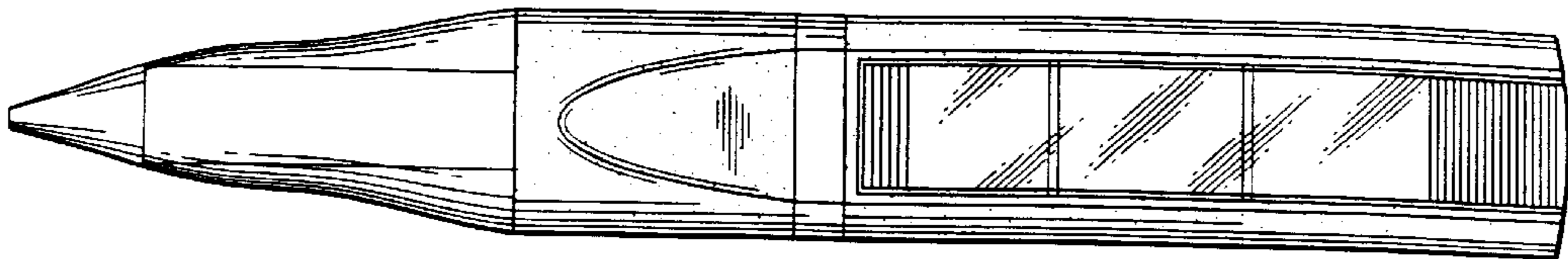
(57) **CLAIM**

The ornamental design for a game card writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a rear elevational view of the game card writing instrument showing my new design; FIG. 2 is a right side elevational view, the left side elevational view being a mirror image thereof; FIG. 3 is a front elevational view; FIG. 4 is a bottom plan view; and, FIG. 5 is a top plan view thereof.

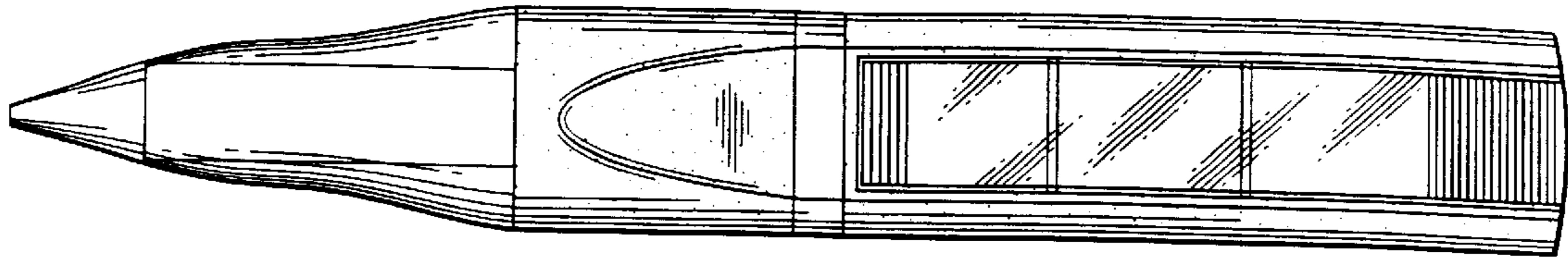

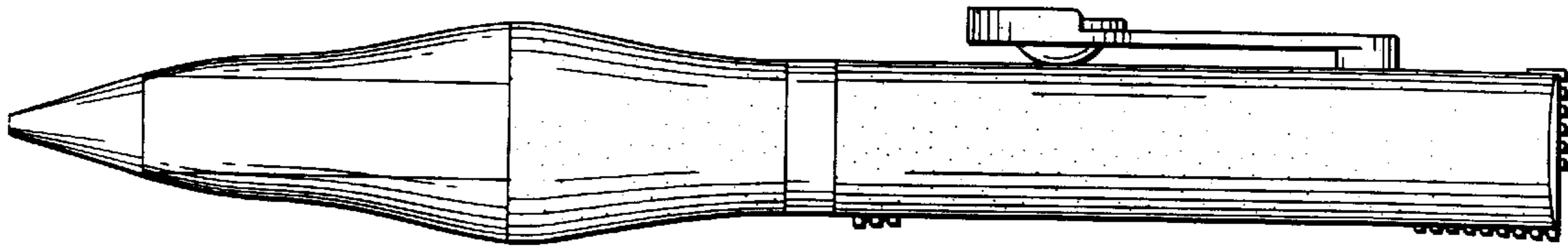

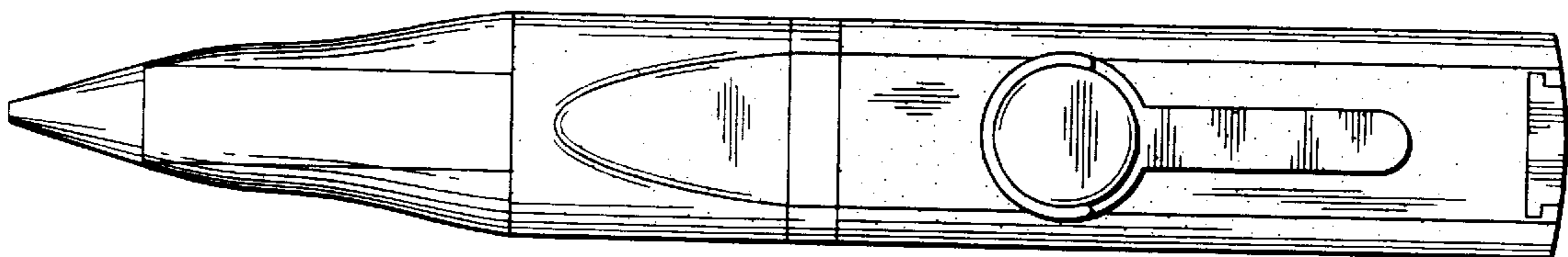

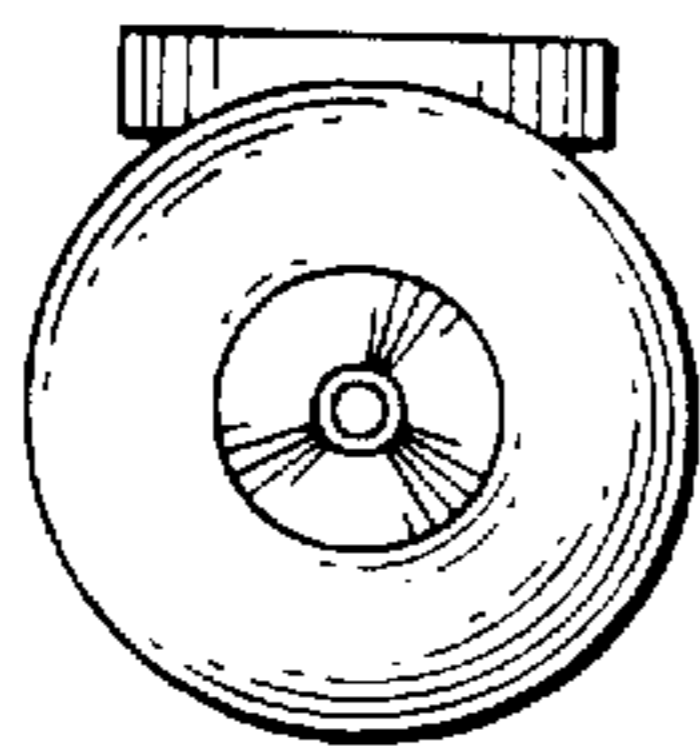

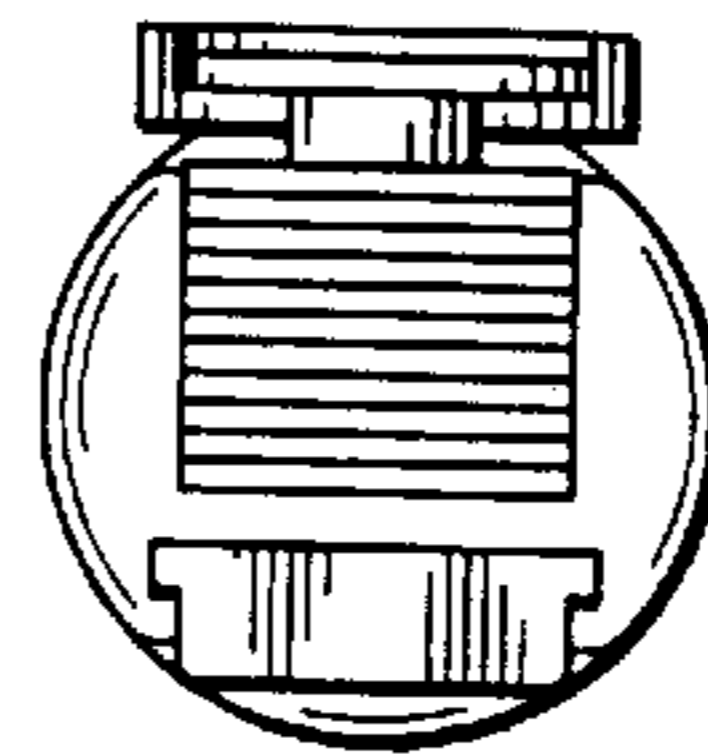
