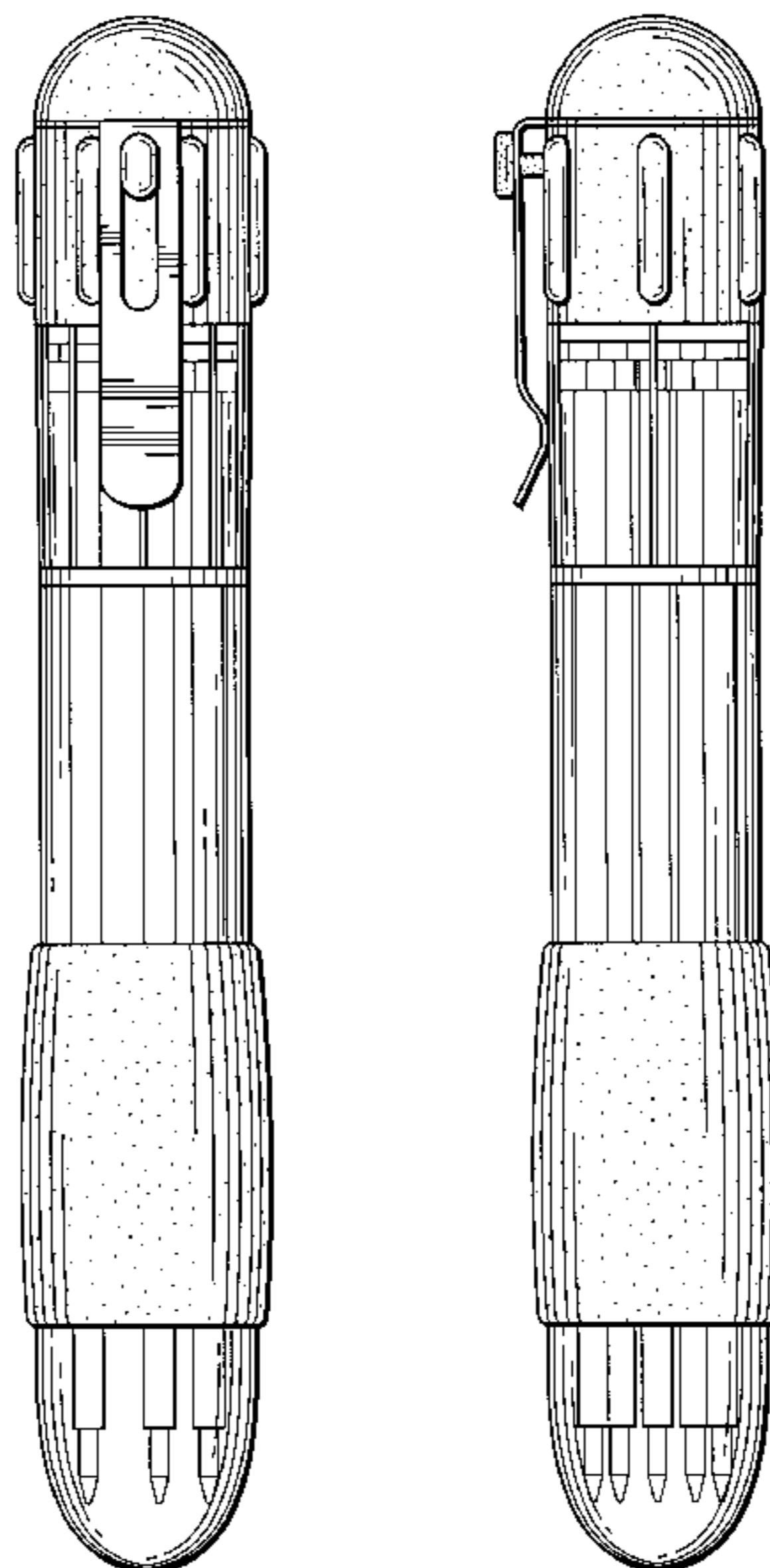

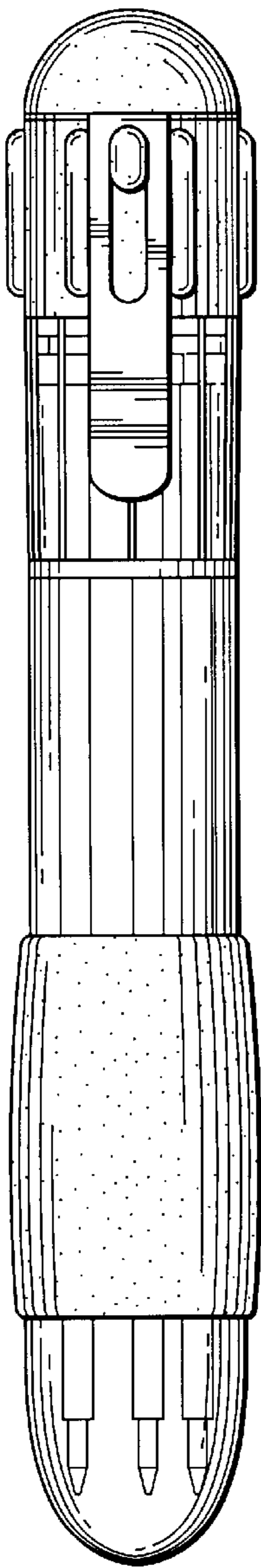
The ornamental design for a writing instrument, as shown and described.

**DESCRIPTION**

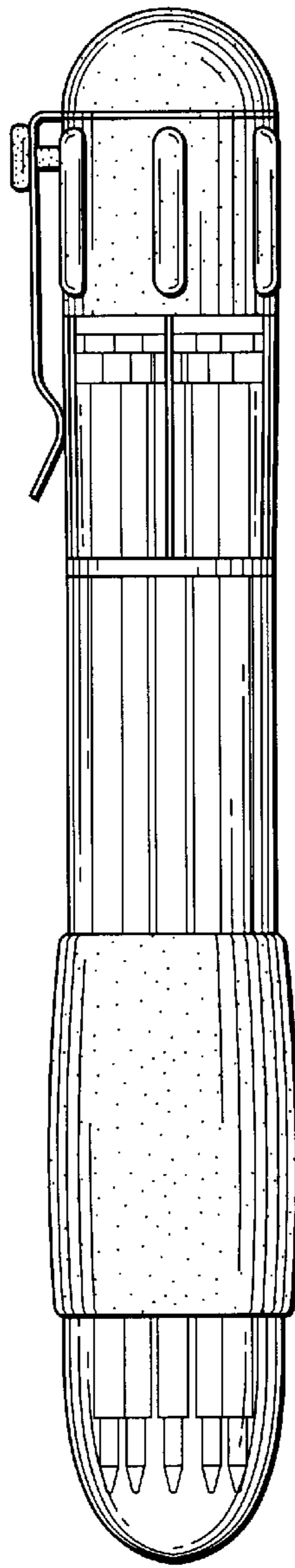
FIG. 1 is a front elevational view of the writing instrument of this invention;

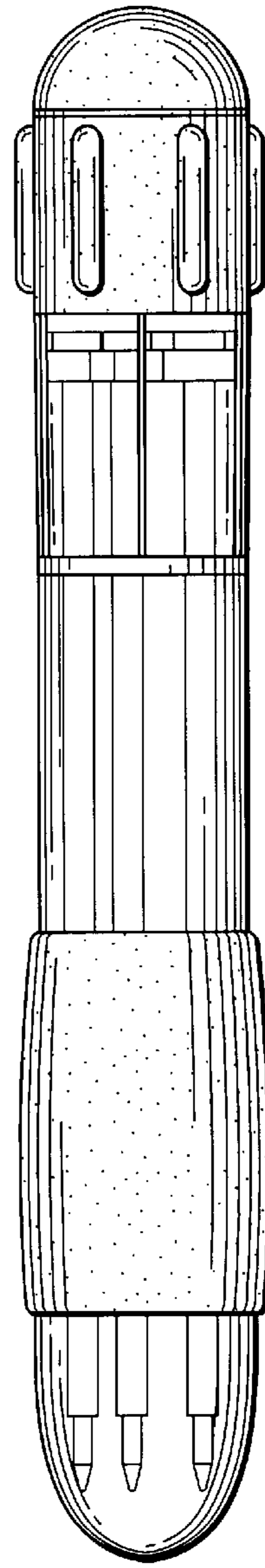




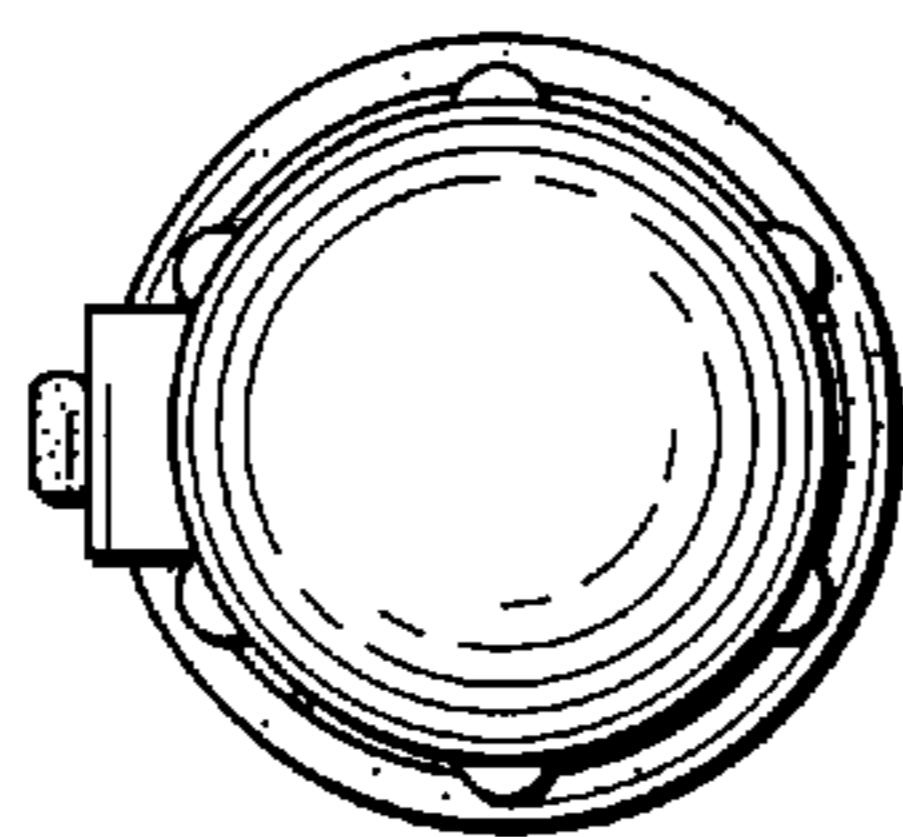

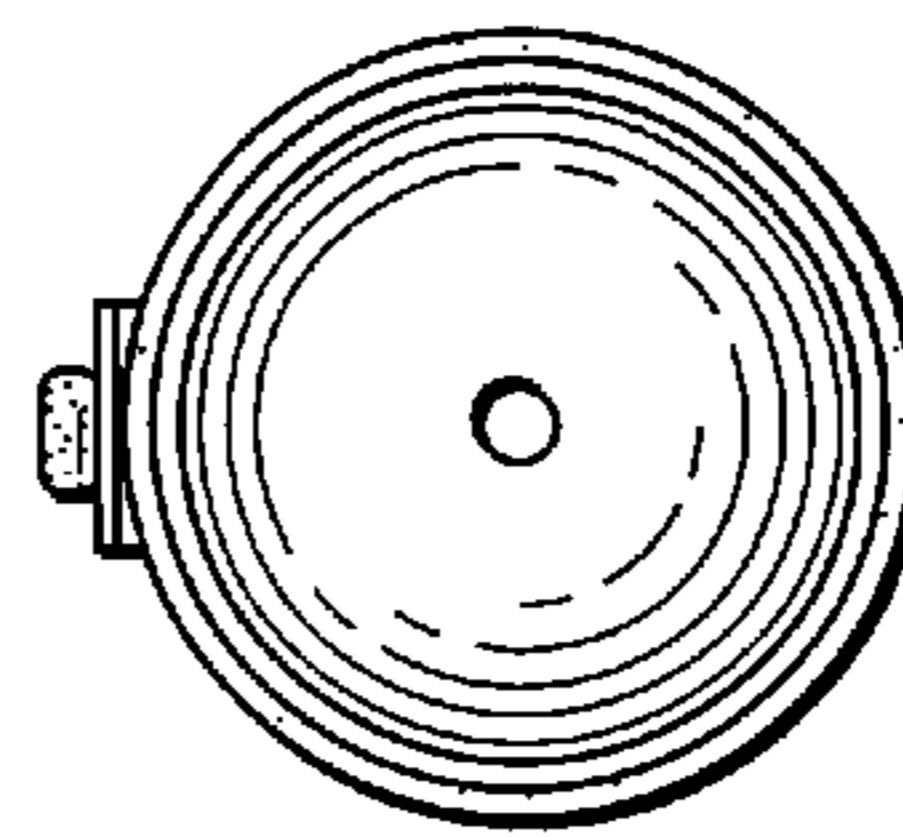
