The ornamental design for an annular joined dual cosmetic dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an annular joined dual cosmetic dispenser, showing our new design;

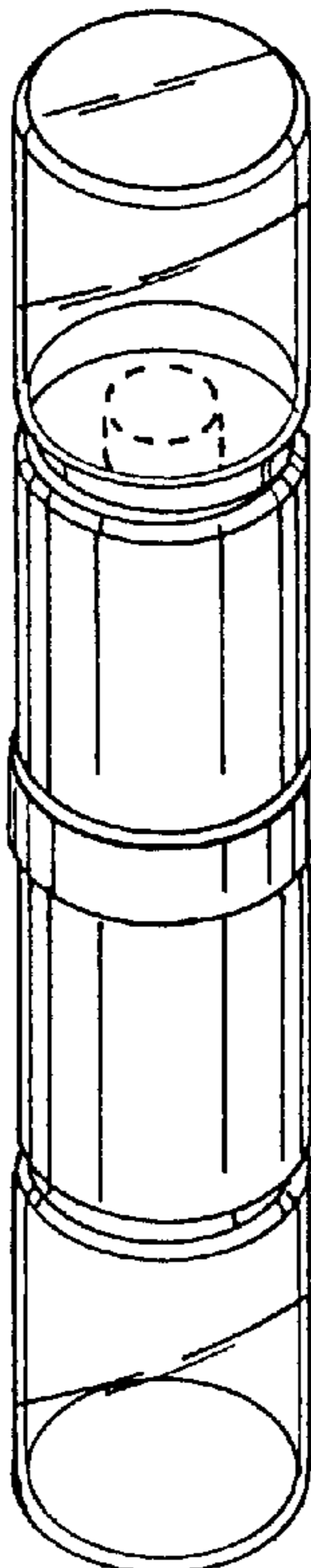
FIG. 2 is a front elevation view thereof, the rear, left side and right side elevational views being identical thereto; and,

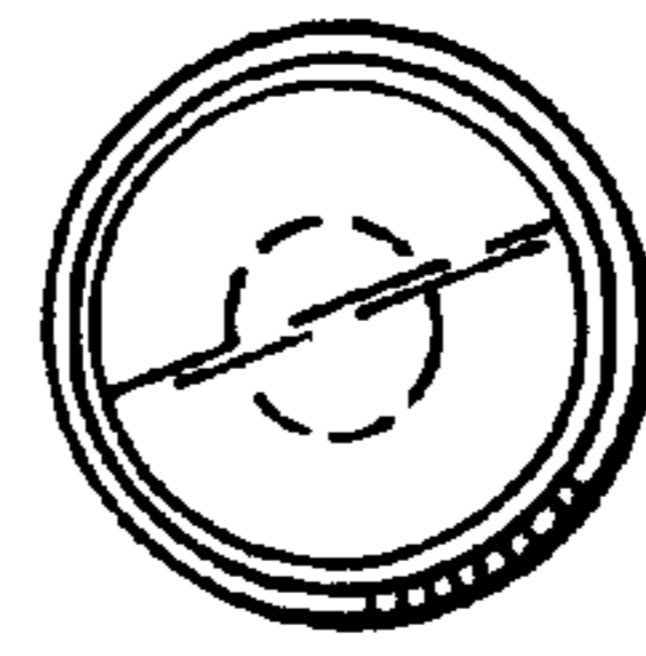

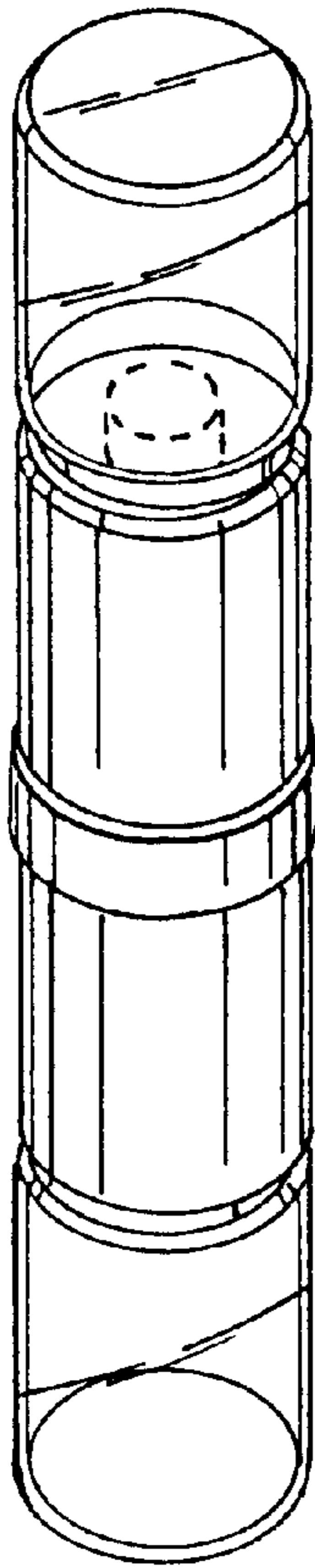

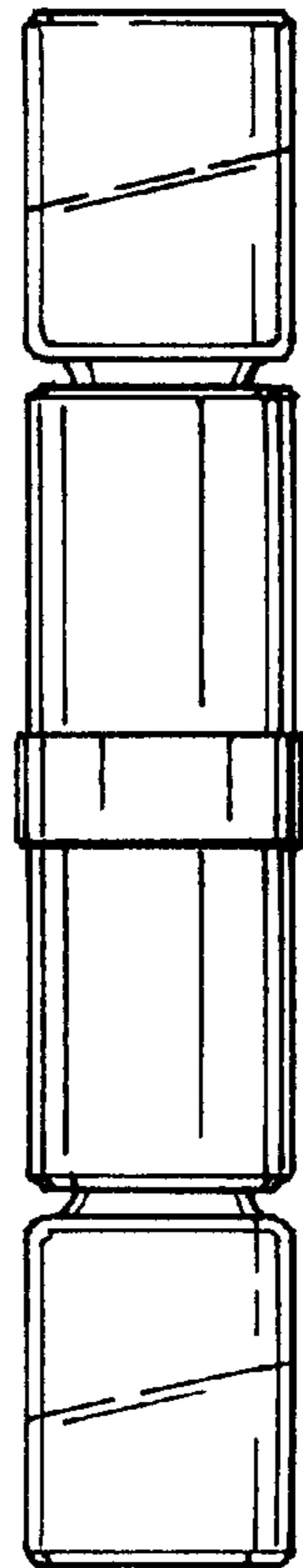

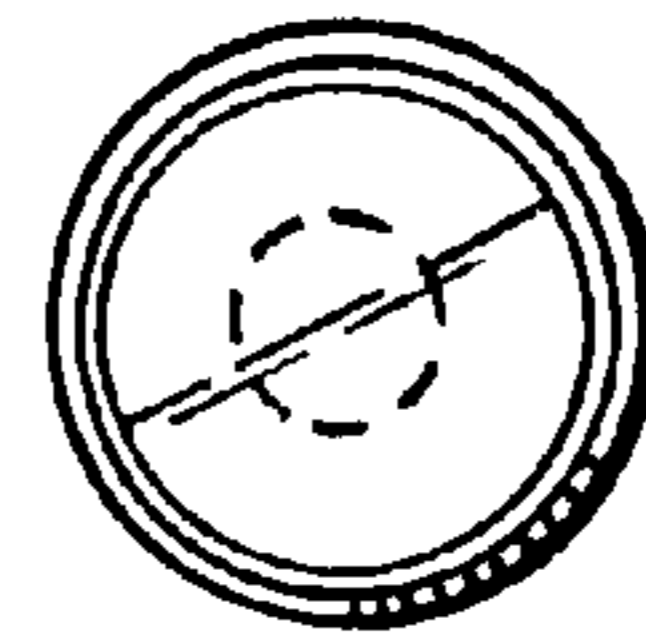
