**DESCRIPTION**

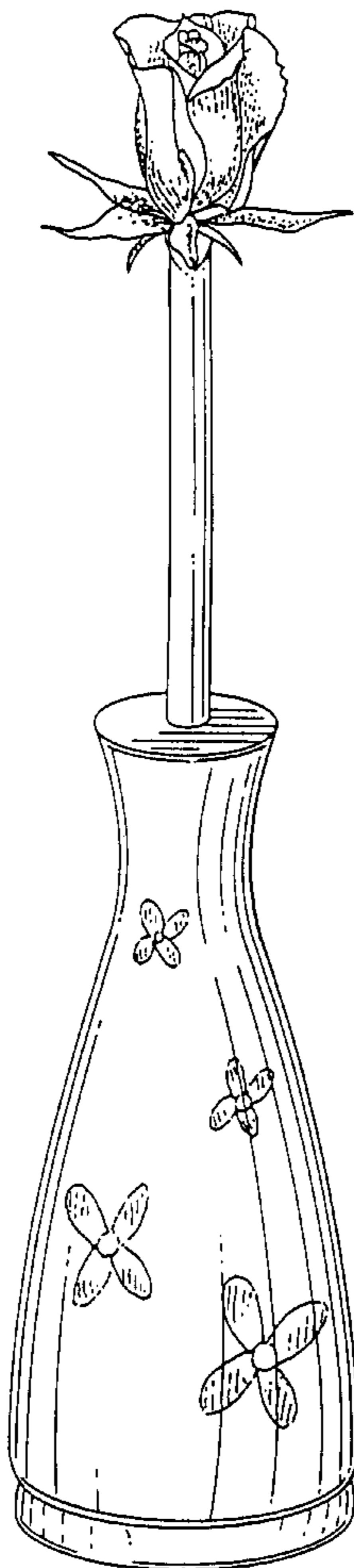
FIG. 1. is a perspective view of a toilet plunger and cover of

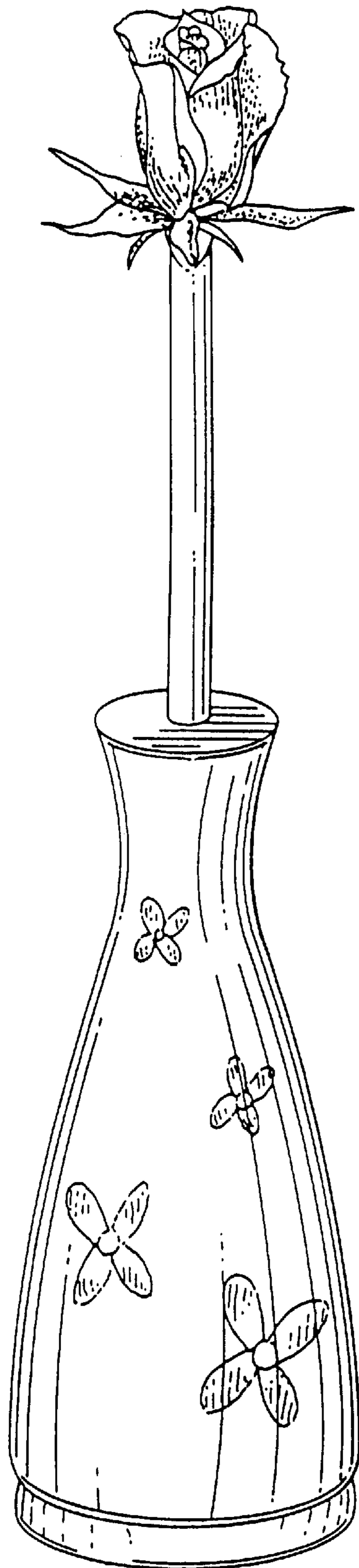

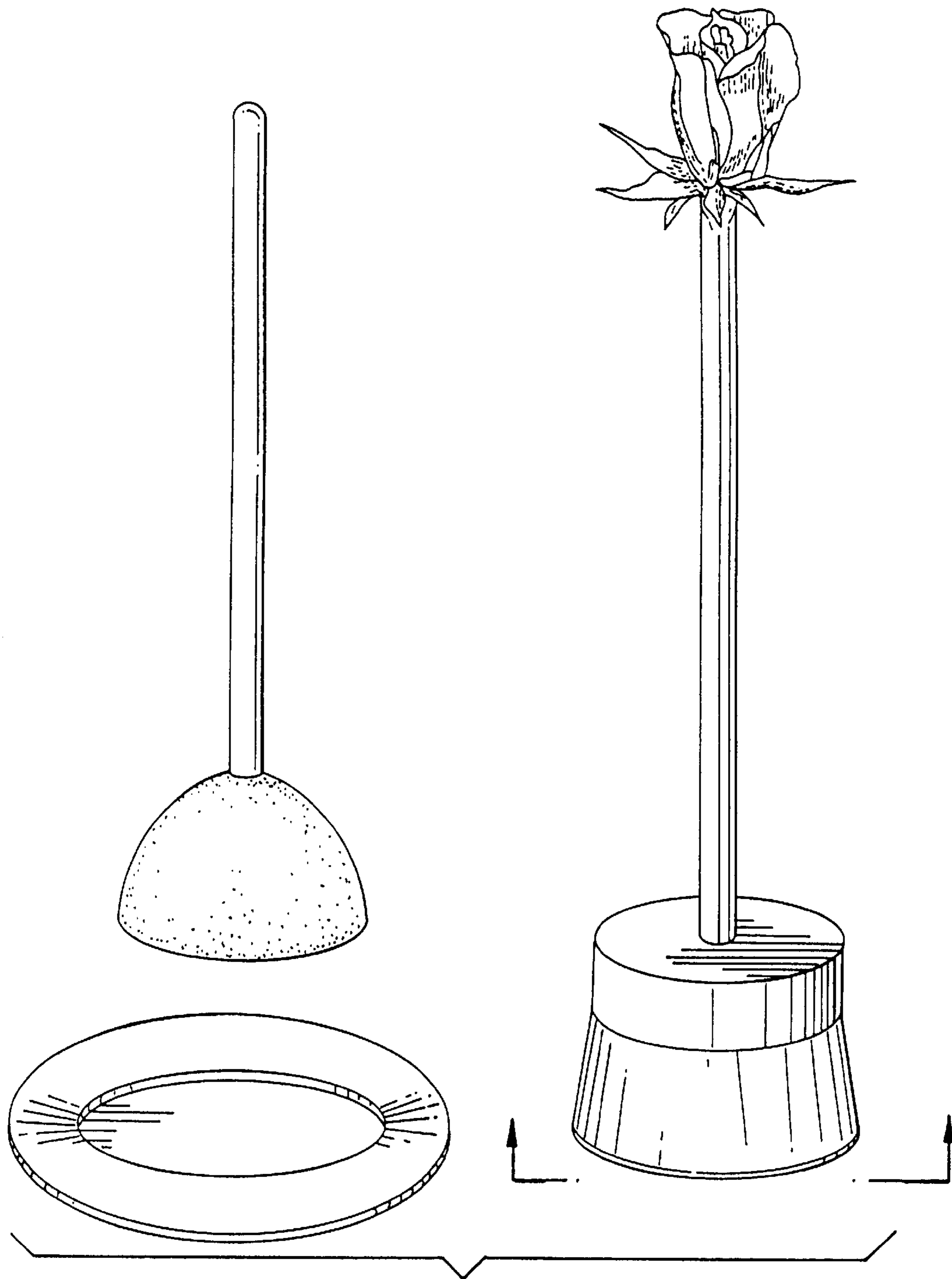

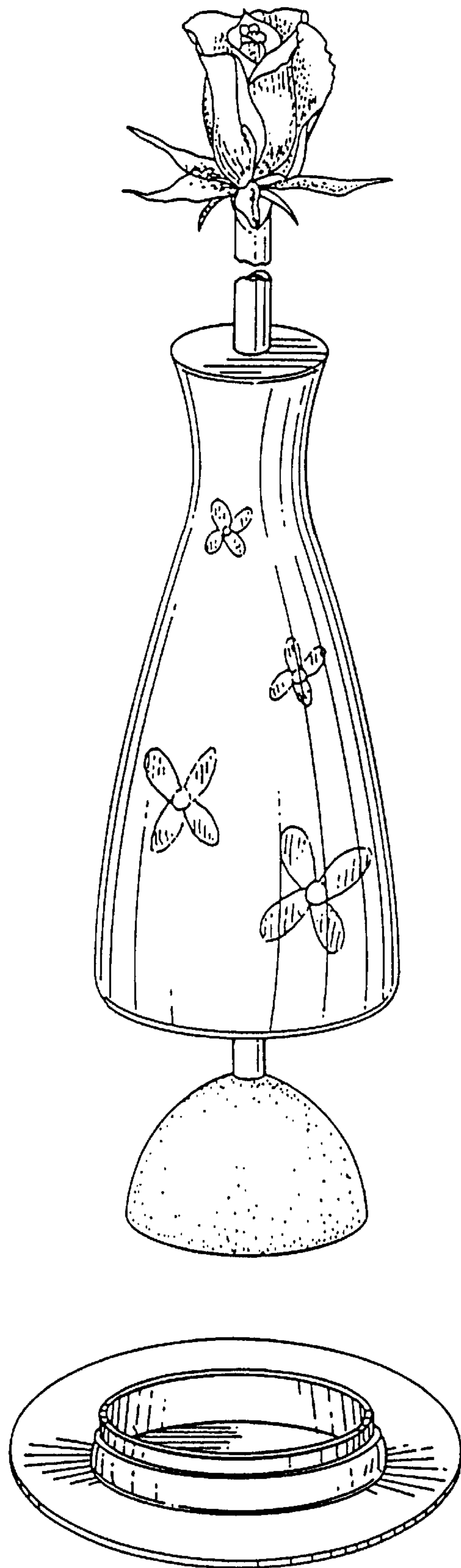
