(57) **CLAIM**

The ornamental design for an umbrella carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left side perspective view of an umbrella carrier showing the design with the carrier closed;

FIG. 2 is a top, left side perspective view of the umbrella carrier according to FIG. 1 carrier showing the carrier open, the broken line disclosure of the handle of an umbrella protruding from the carrier being shown for illustrative purposes only and forming no part of the claimed design;

FIG. 3 is a top plan view of the umbrella carrier;

FIG. 4 is a bottom plan view of the umbrella carrier;

FIG. 5 is a left side elevational view of the umbrella carrier;

FIG. 6 is a right side elevational view of the umbrella carrier;

FIG. 7 is a front elevational view of the umbrella carrier;

FIG. 8 is a rear elevational view of the umbrella carrier;

FIG. 9 is a top, left side perspective view of the umbrella carrier according to FIG. 1, the broken line disclosure of a person's hand holding the umbrella carrier being shown for illustrative purposes only and forming no part of the claimed design;

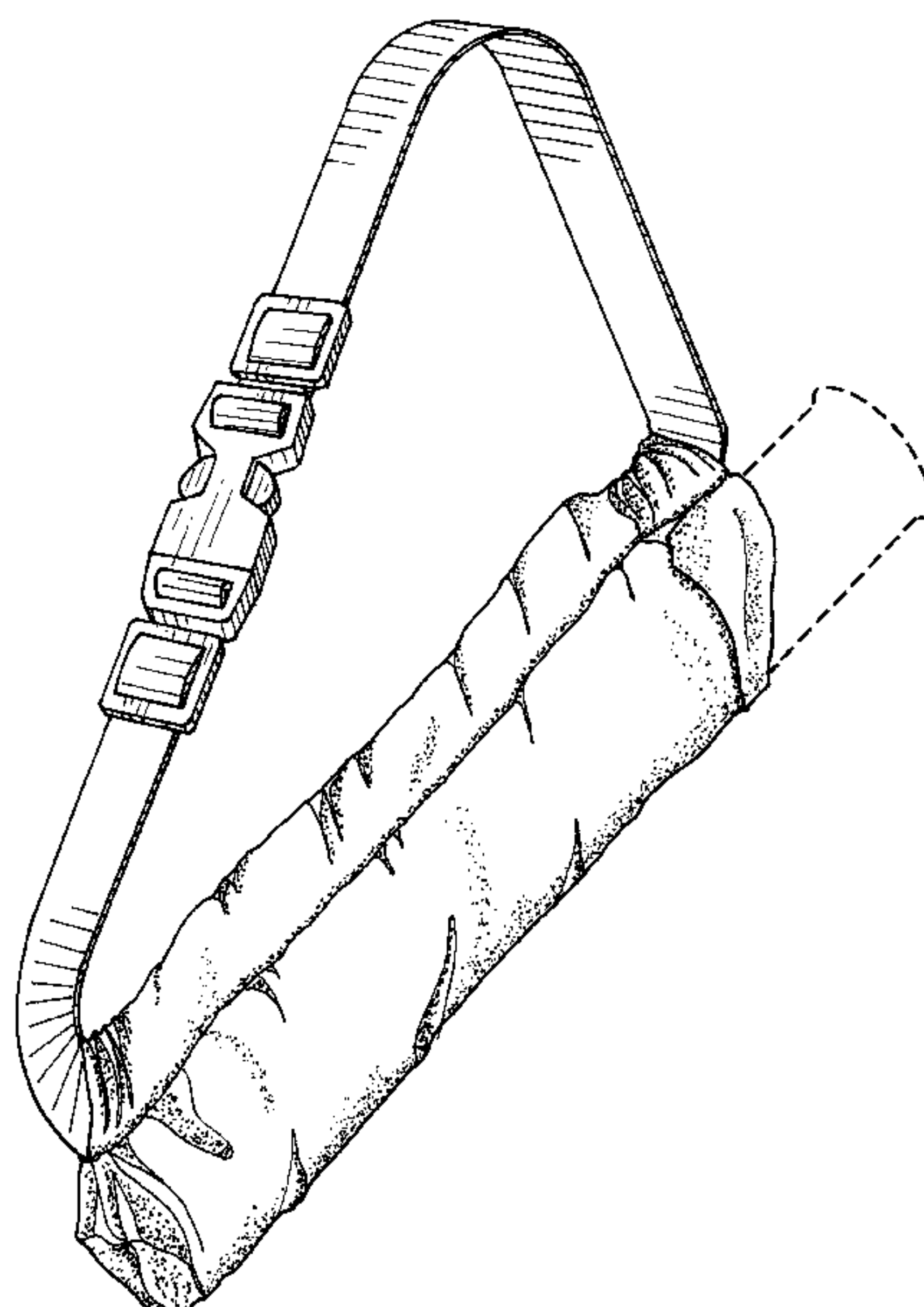
FIG. 10 is a top, left side perspective view of the umbrella carrier according to FIG. 1, the broken line disclosure of a person toting the carrier with its straps suspended from her shoulder being shown for illustrative purposes only and forming no part of the claimed design;

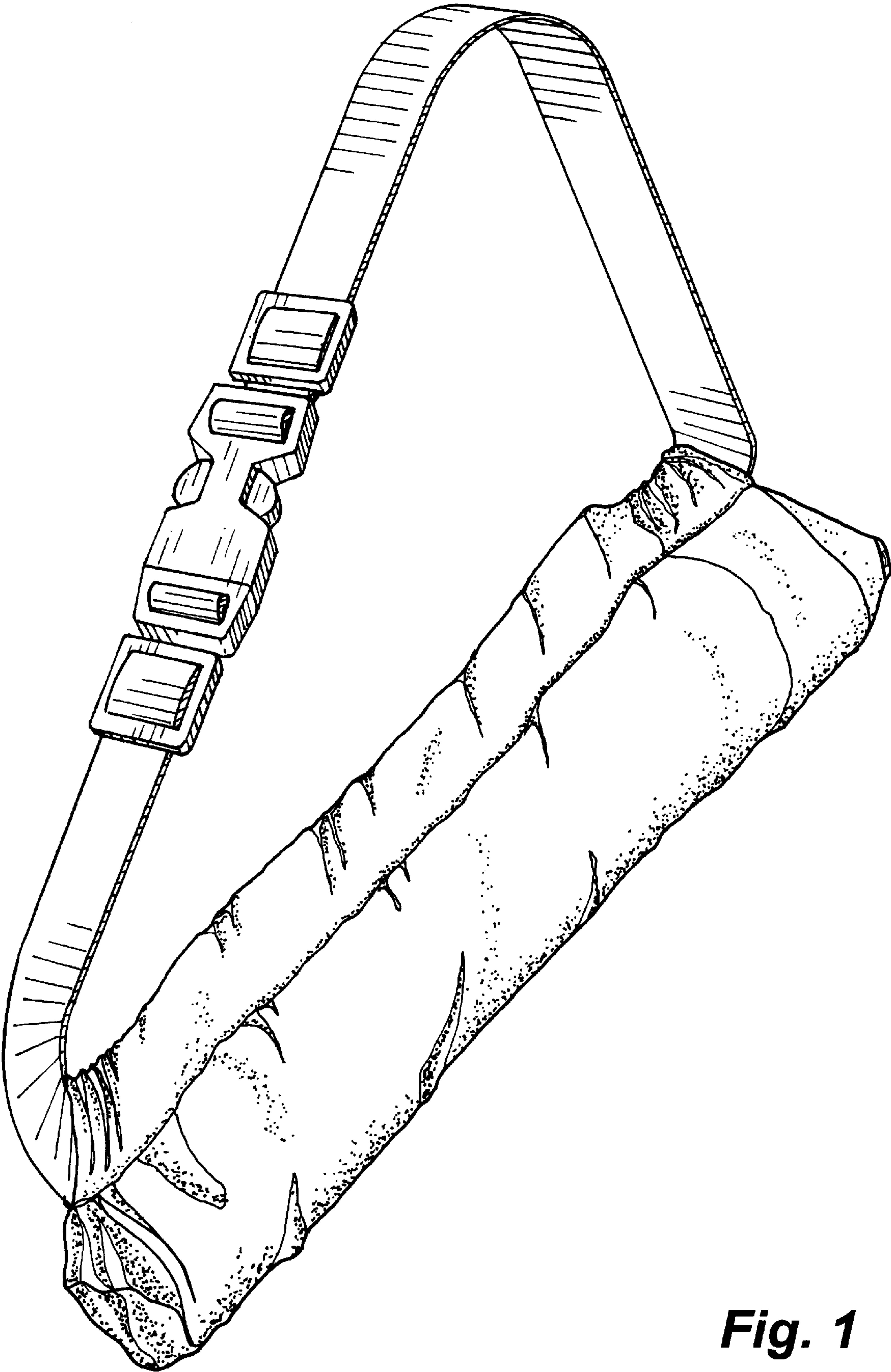
FIG. 11 is a perspective view of the umbrella carrier according to FIG. 1, the broken line disclosure of a person toting the carrier with its straps across his back being shown for illustrative purposes only and forming no part of the claimed design; and,

FIG. 12 is a perspective view of the umbrella carrier according to FIG. 1, the broken line disclosure of a person toting the carrier with its straps across her lower back being shown for illustrative purposes only and forming no part of the claimed design.

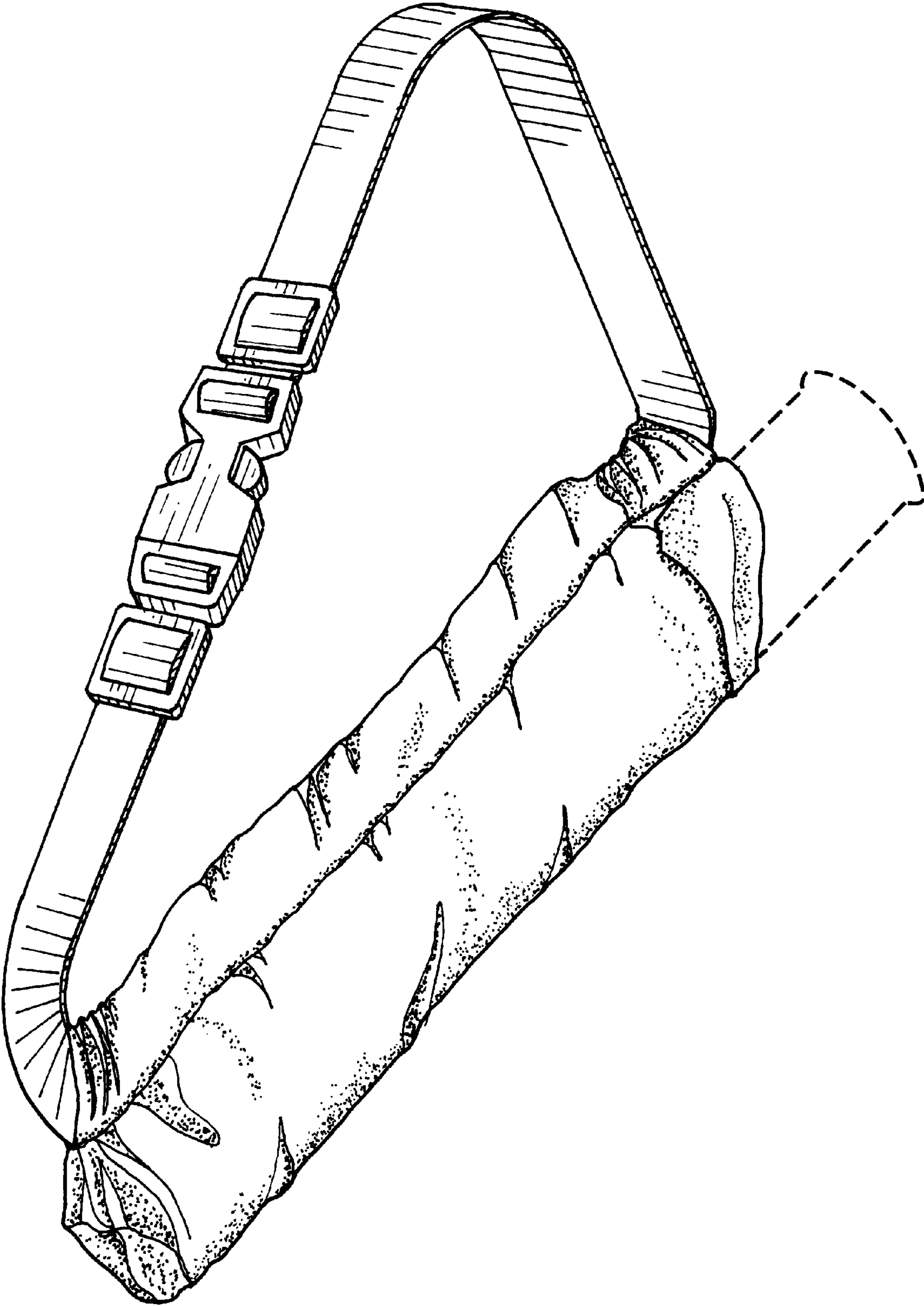
FIGS. 3 through 12 are shown with the umbrella carrier in the closed position.

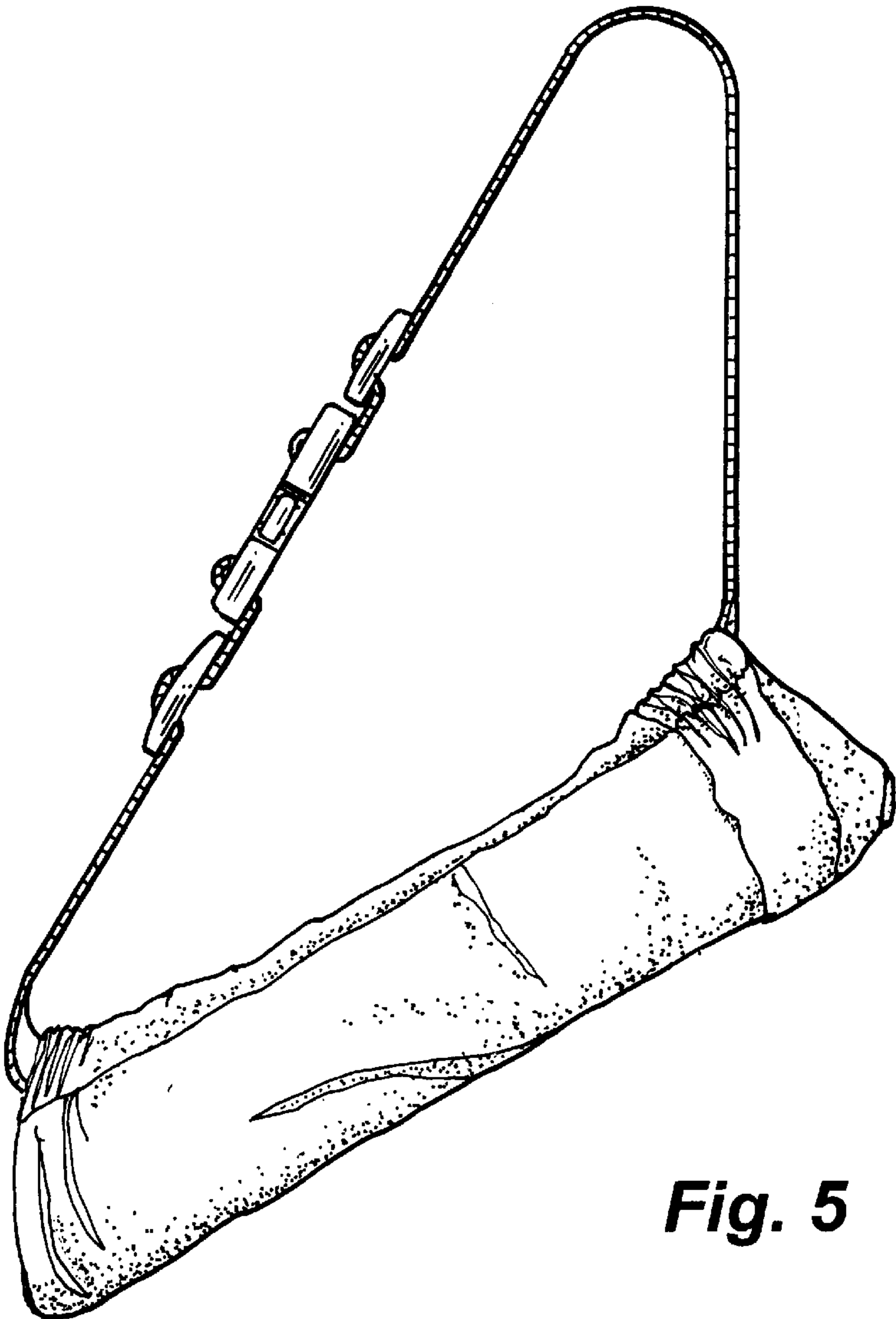
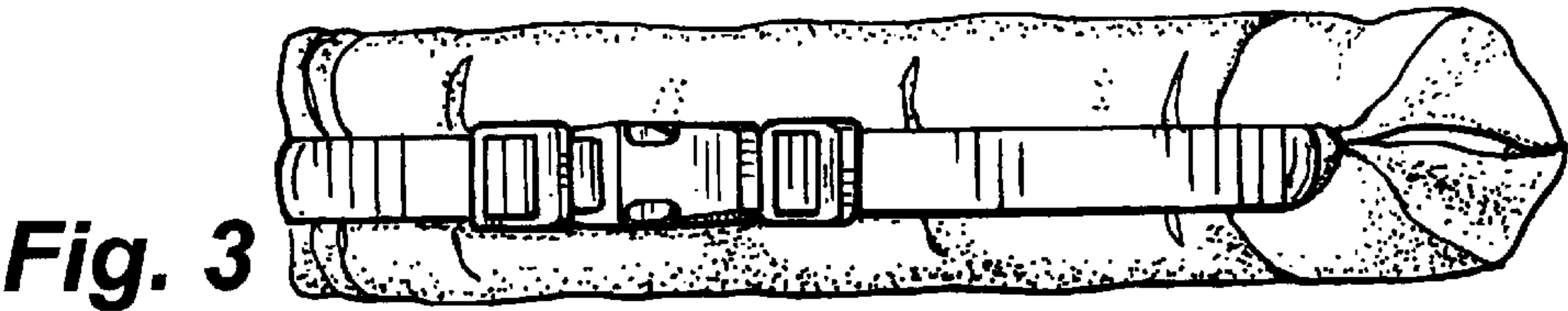

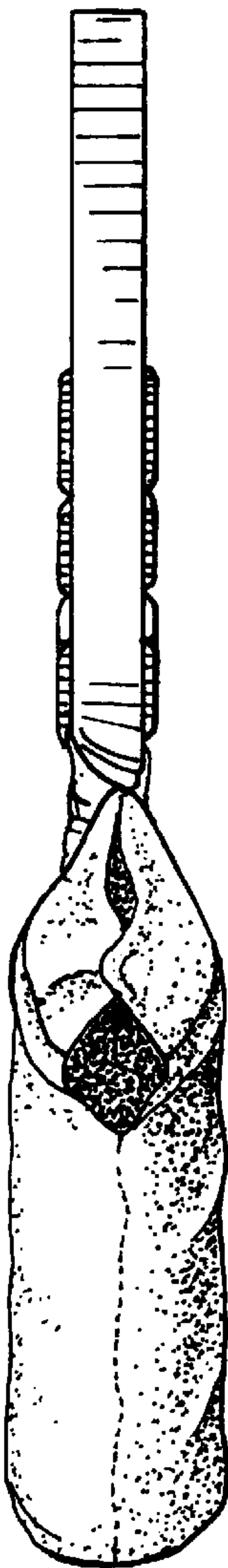

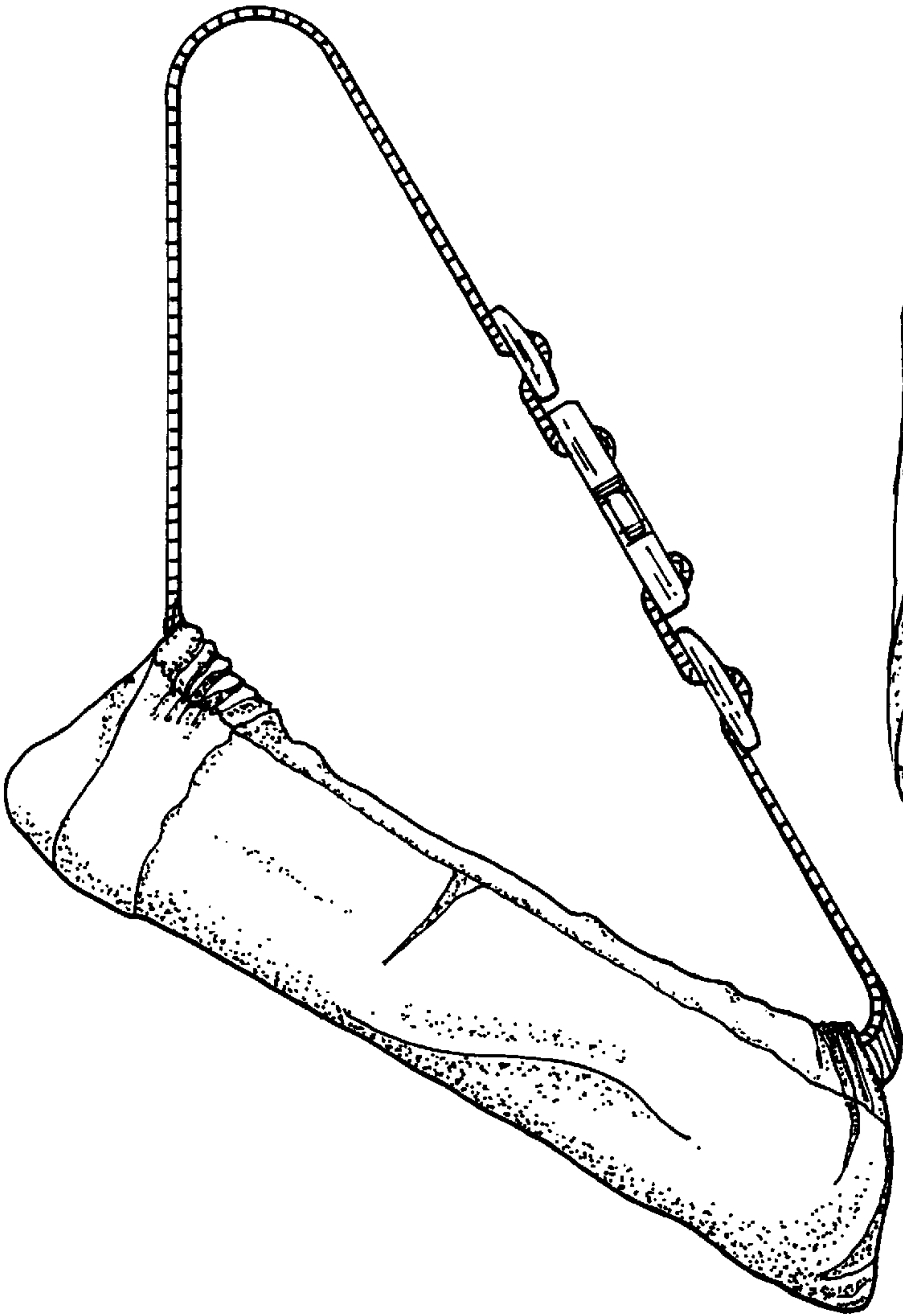

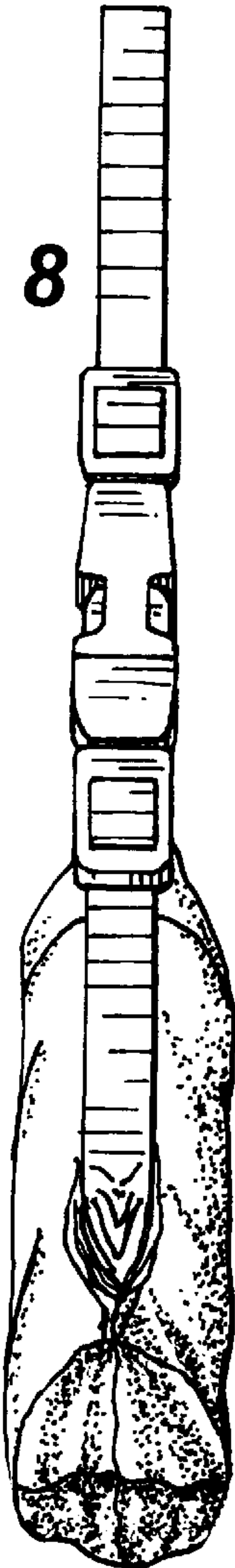


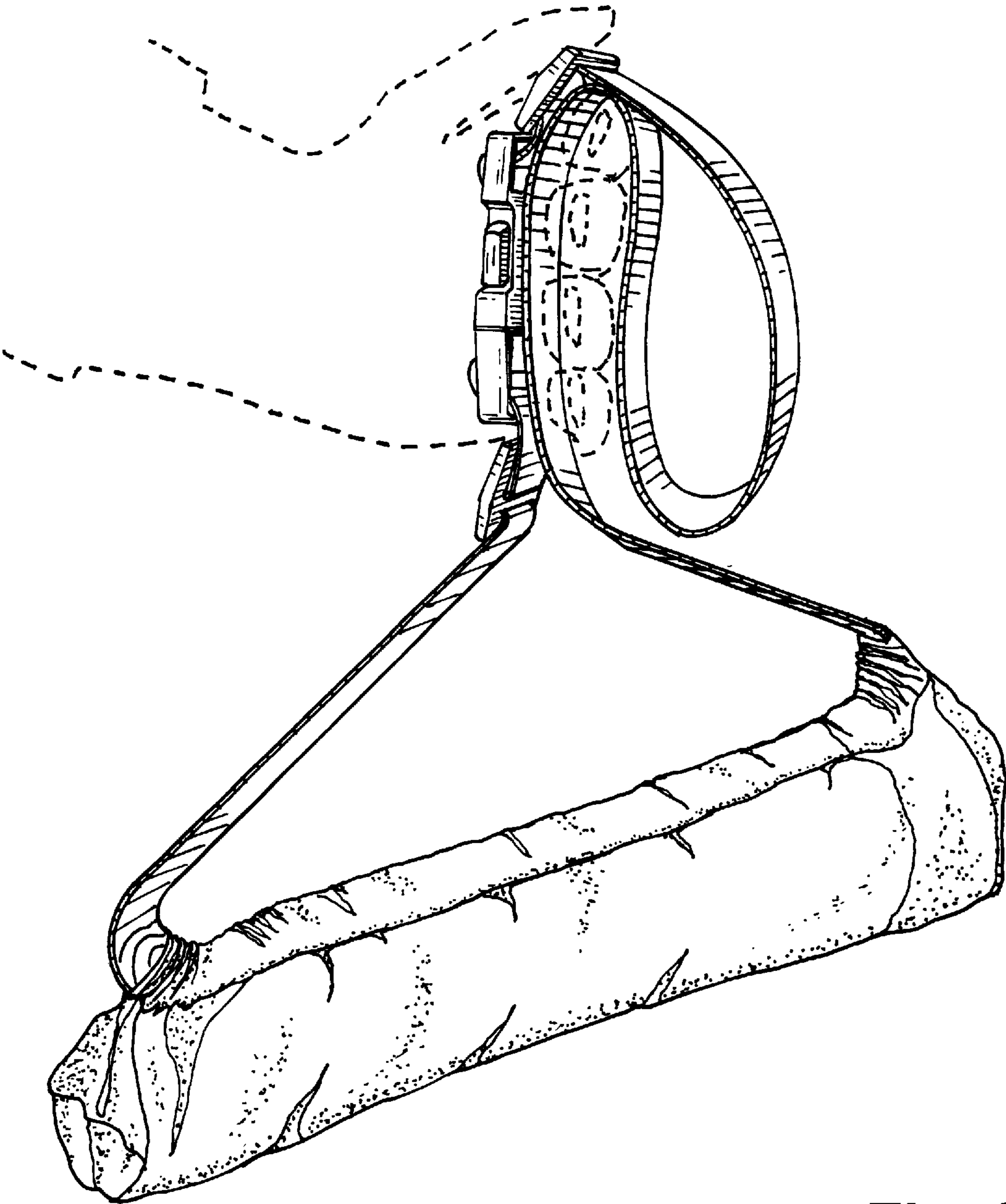

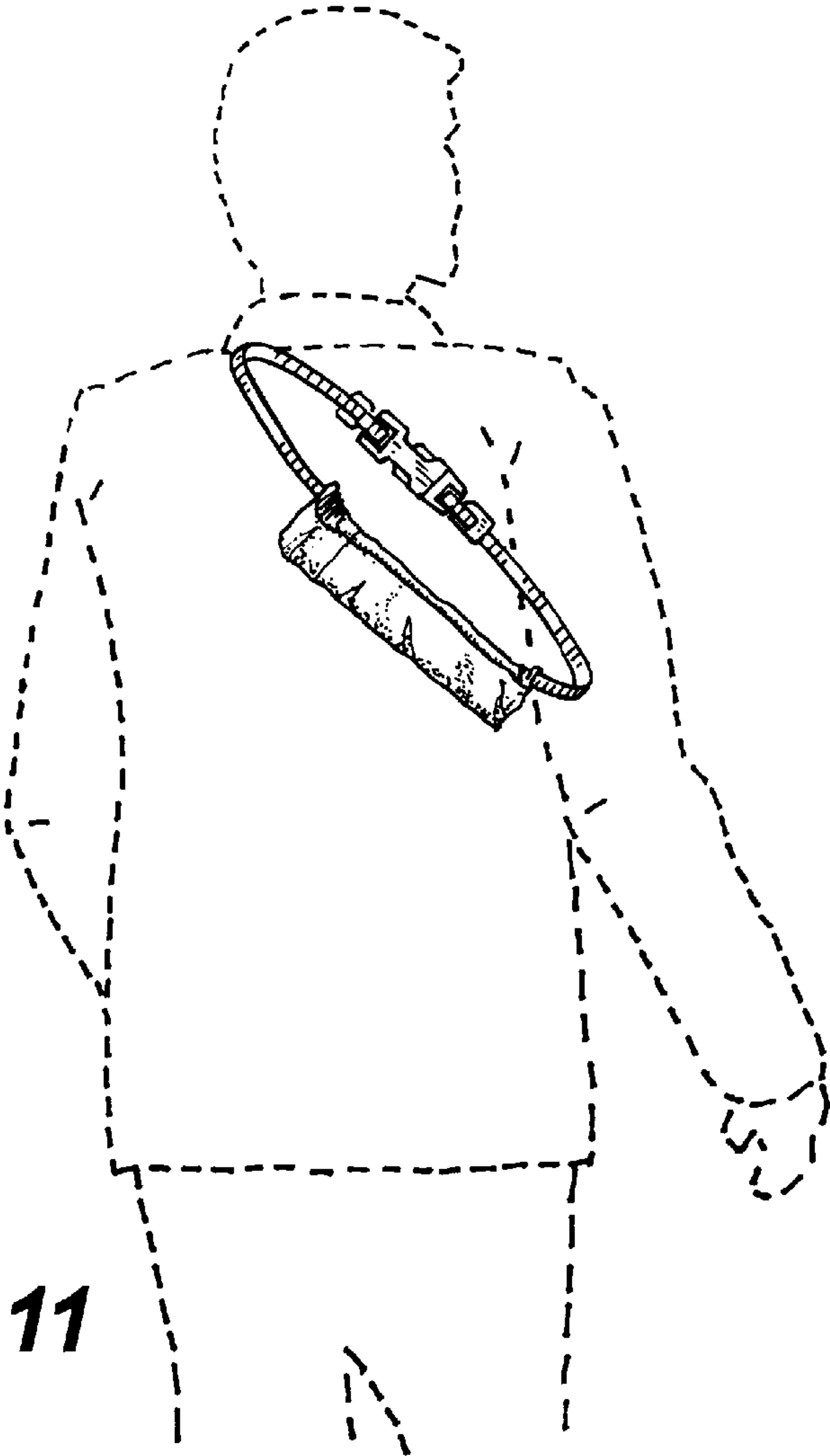
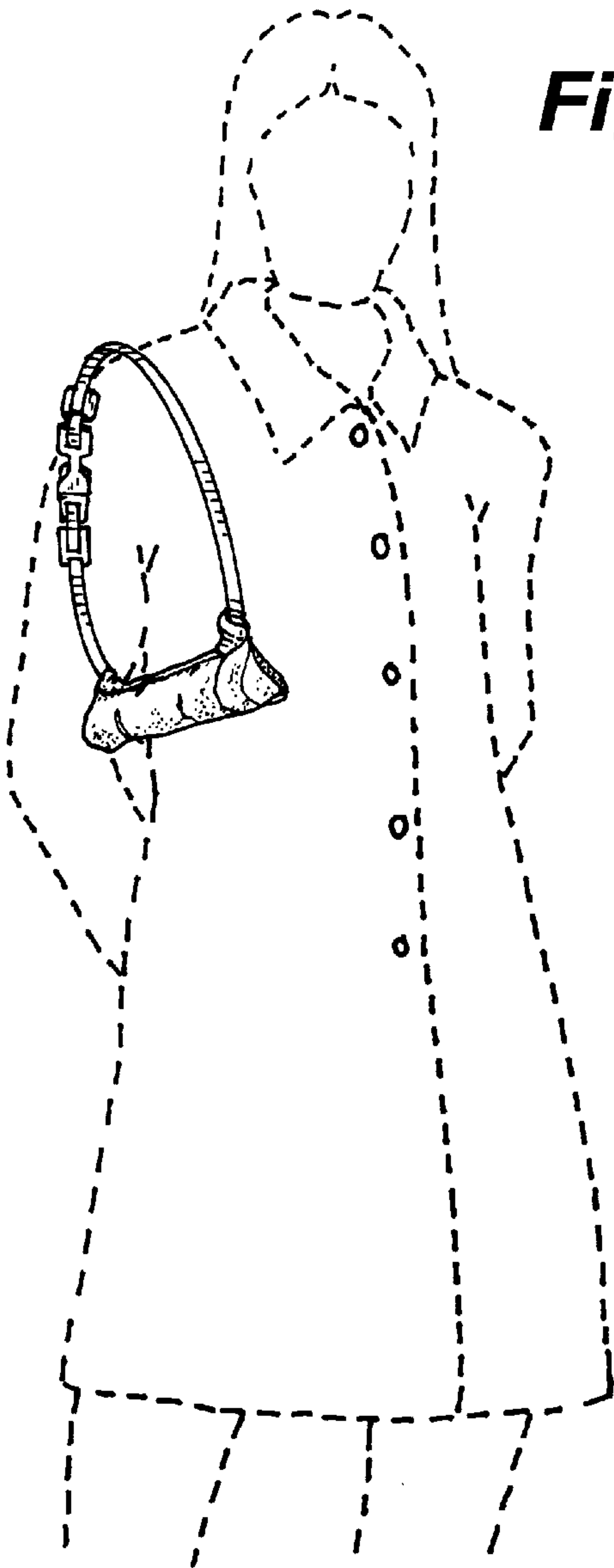

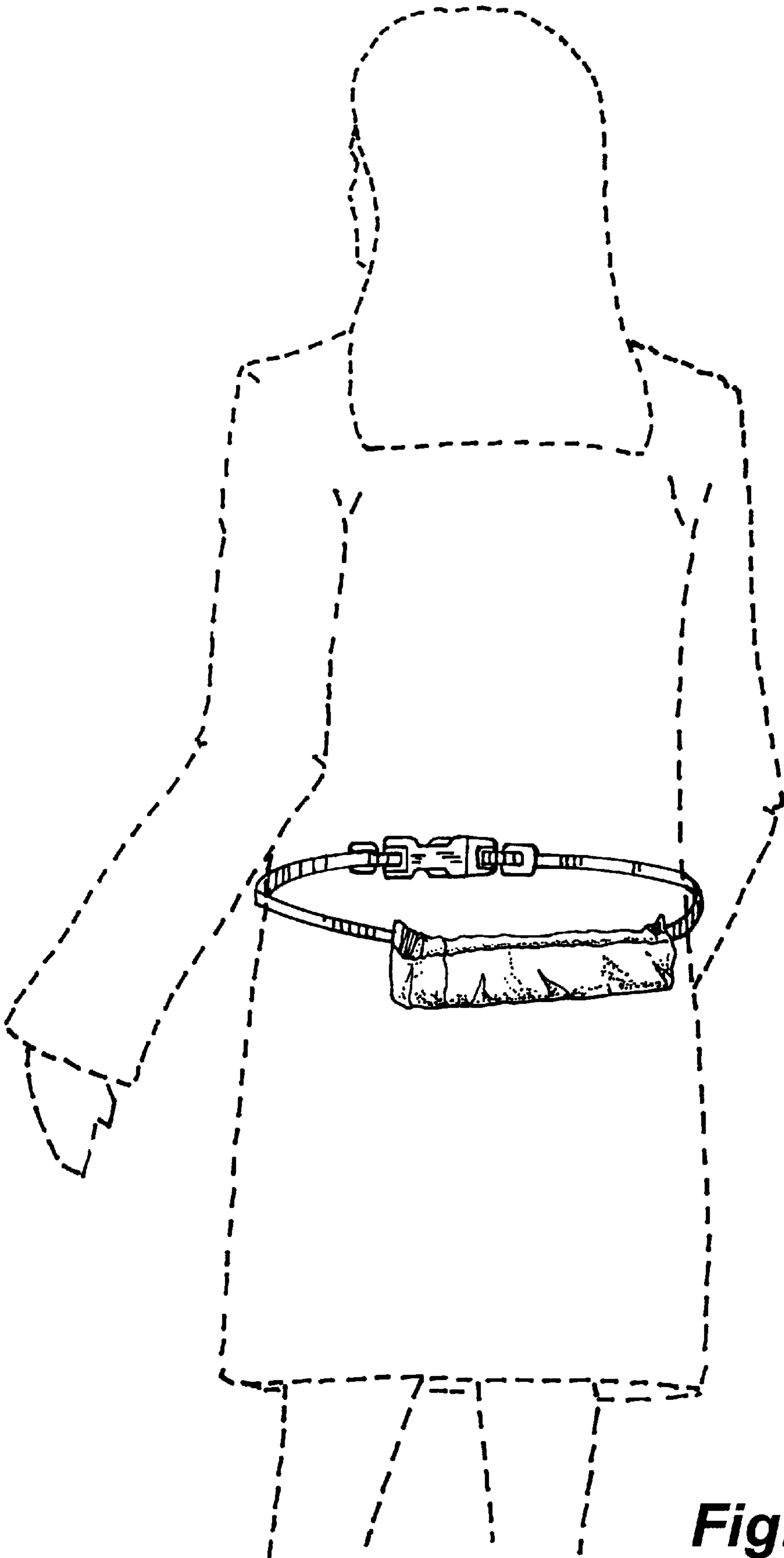
