(57) **CLAIM**

The ornamental design for a stool to be employed by baseball players, coaches, umpires and the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the stool to be employed by baseball players, coaches, umpires and the like, FIG. 2 is a top view thereof, FIG. 3 is a front side or rear side view thereof, FIG. 4 is a bottom view thereof; and, FIG. 5 is a right side or left side view thereof.

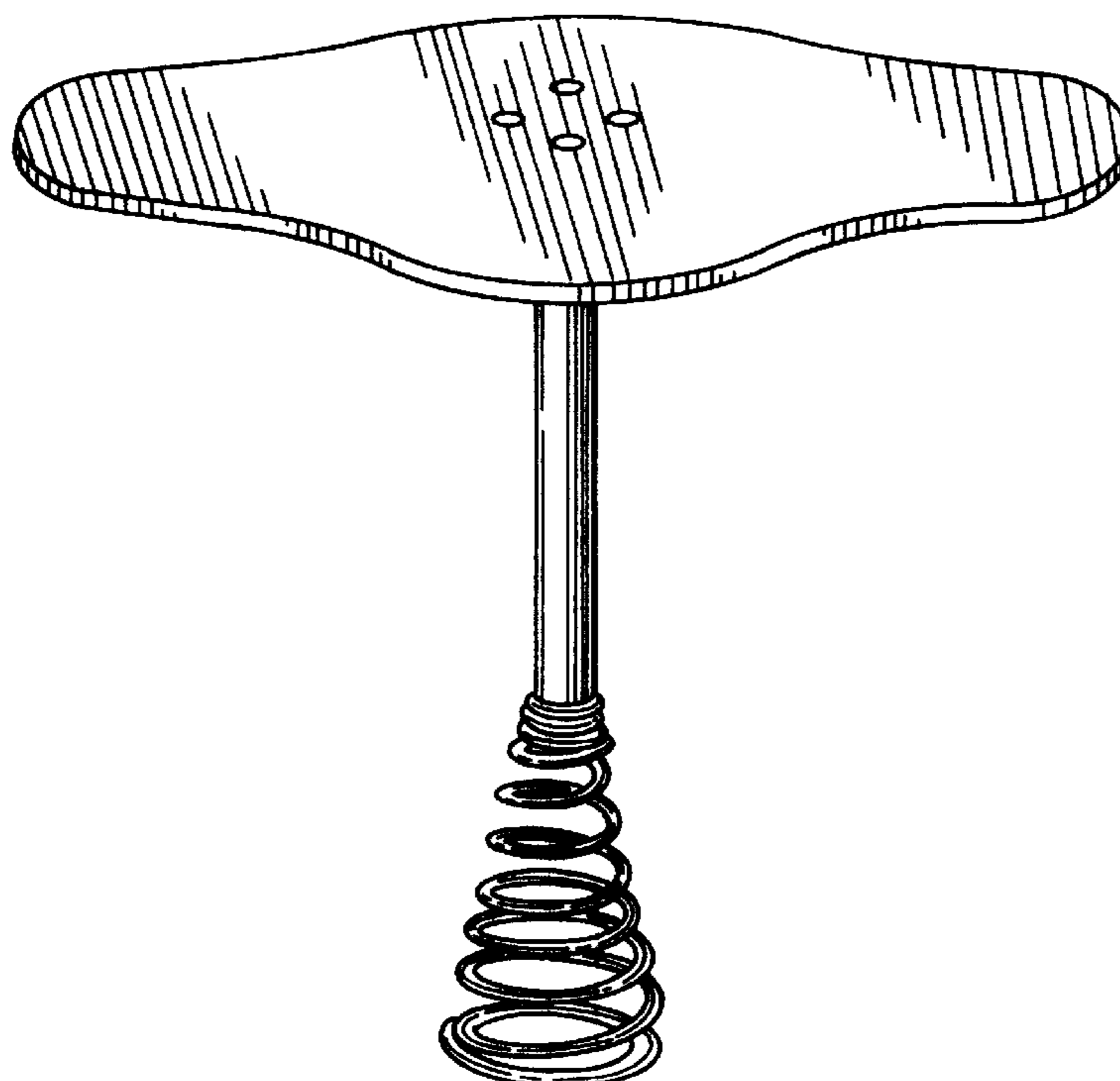

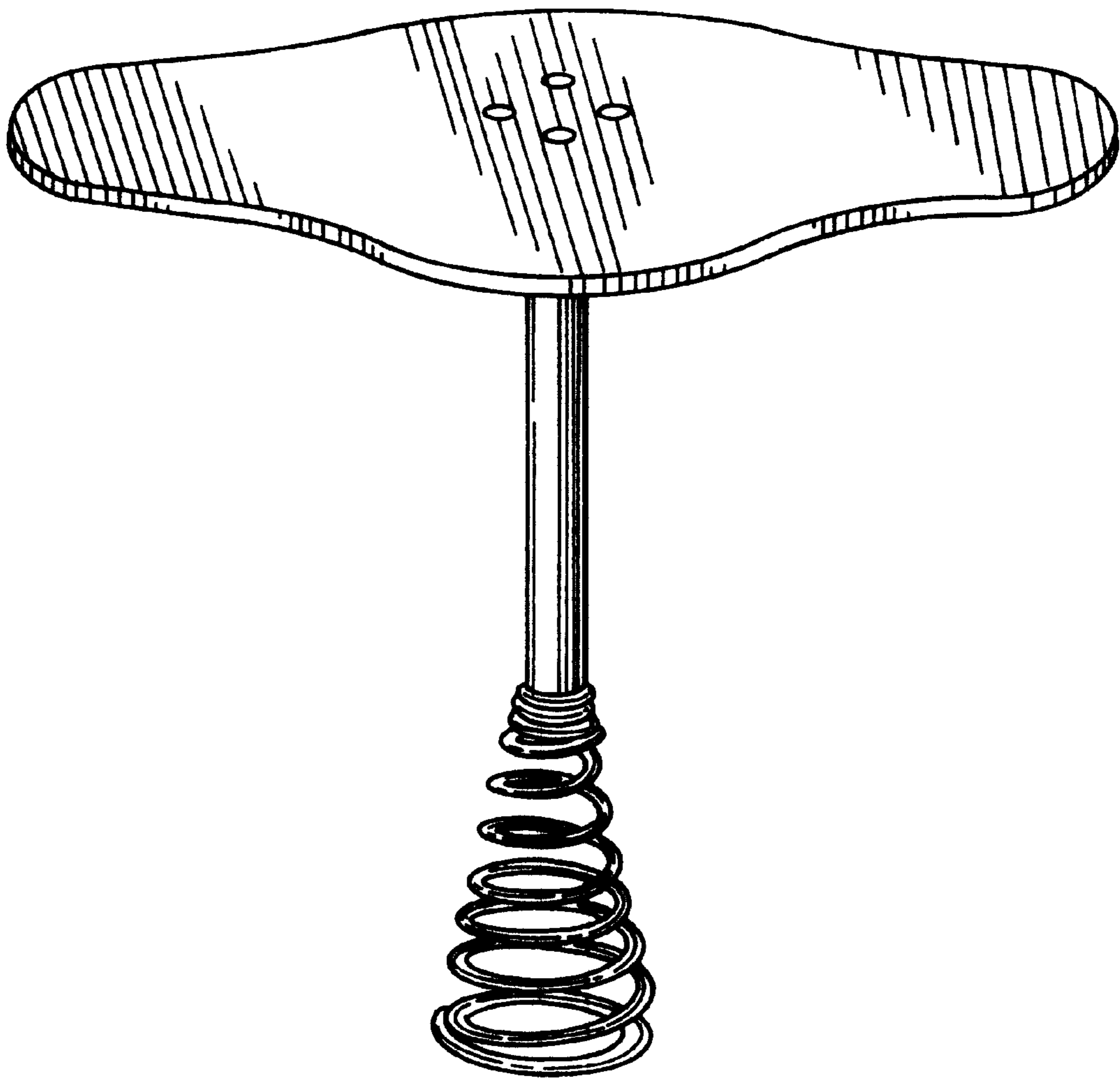

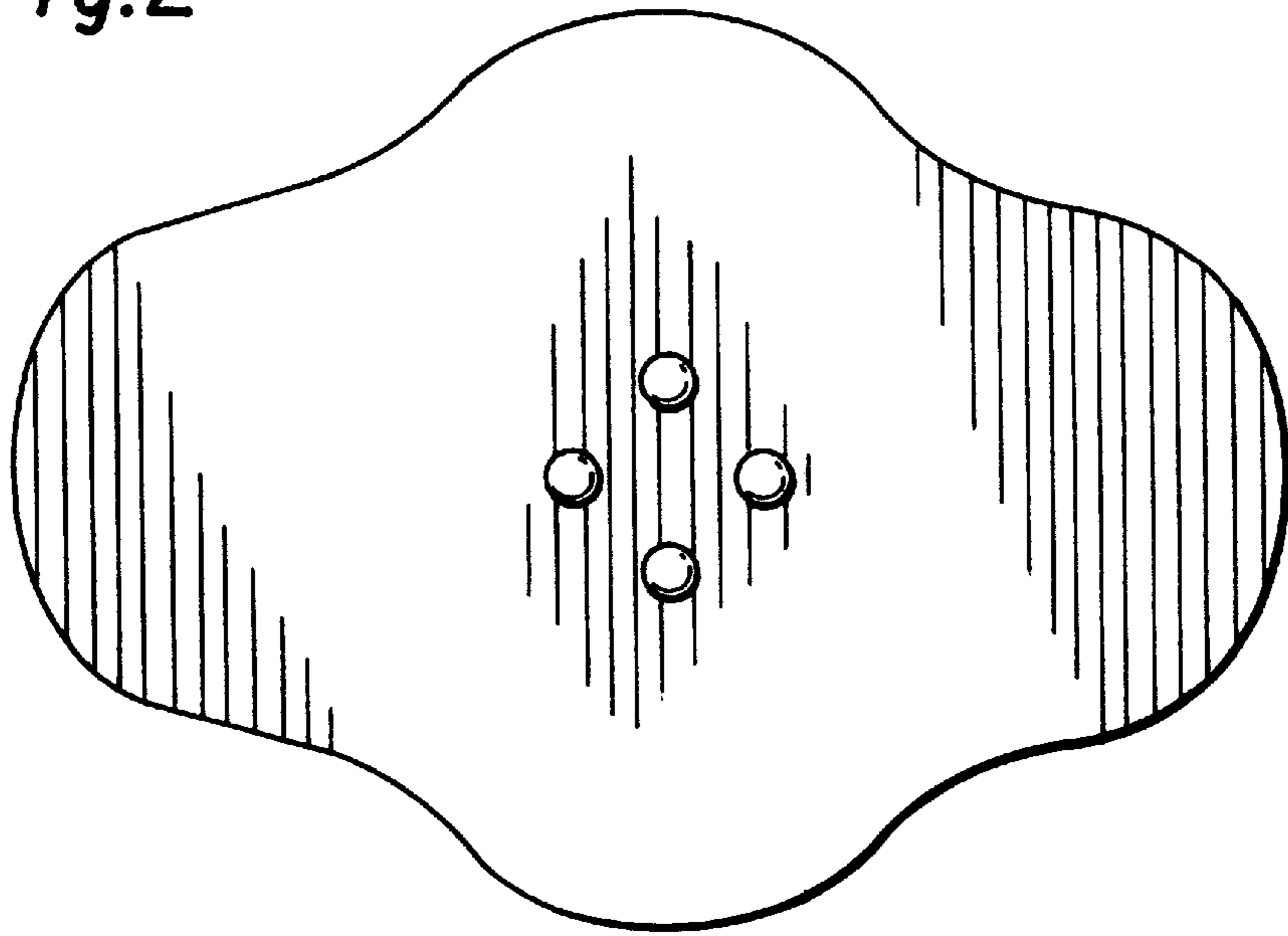

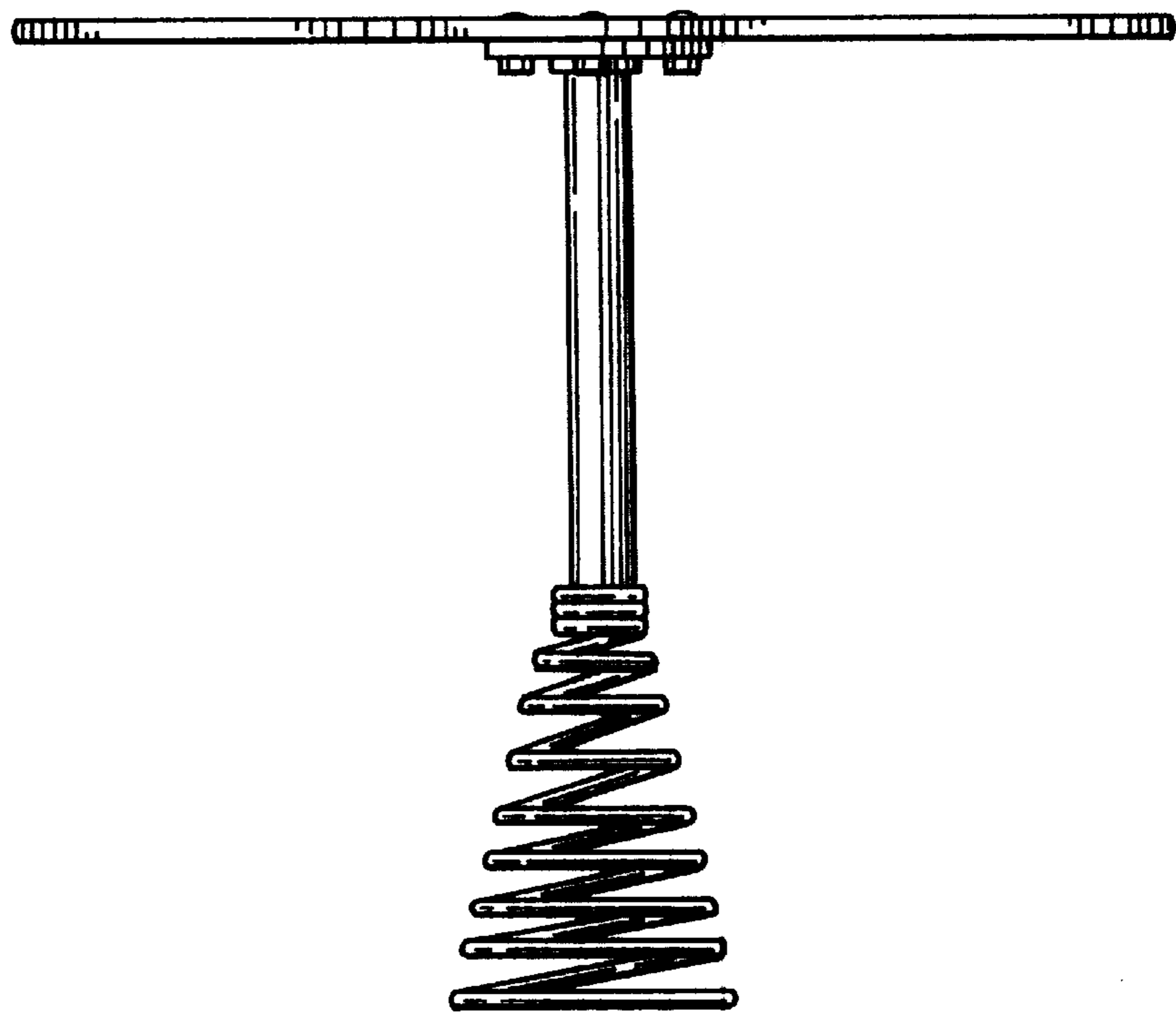

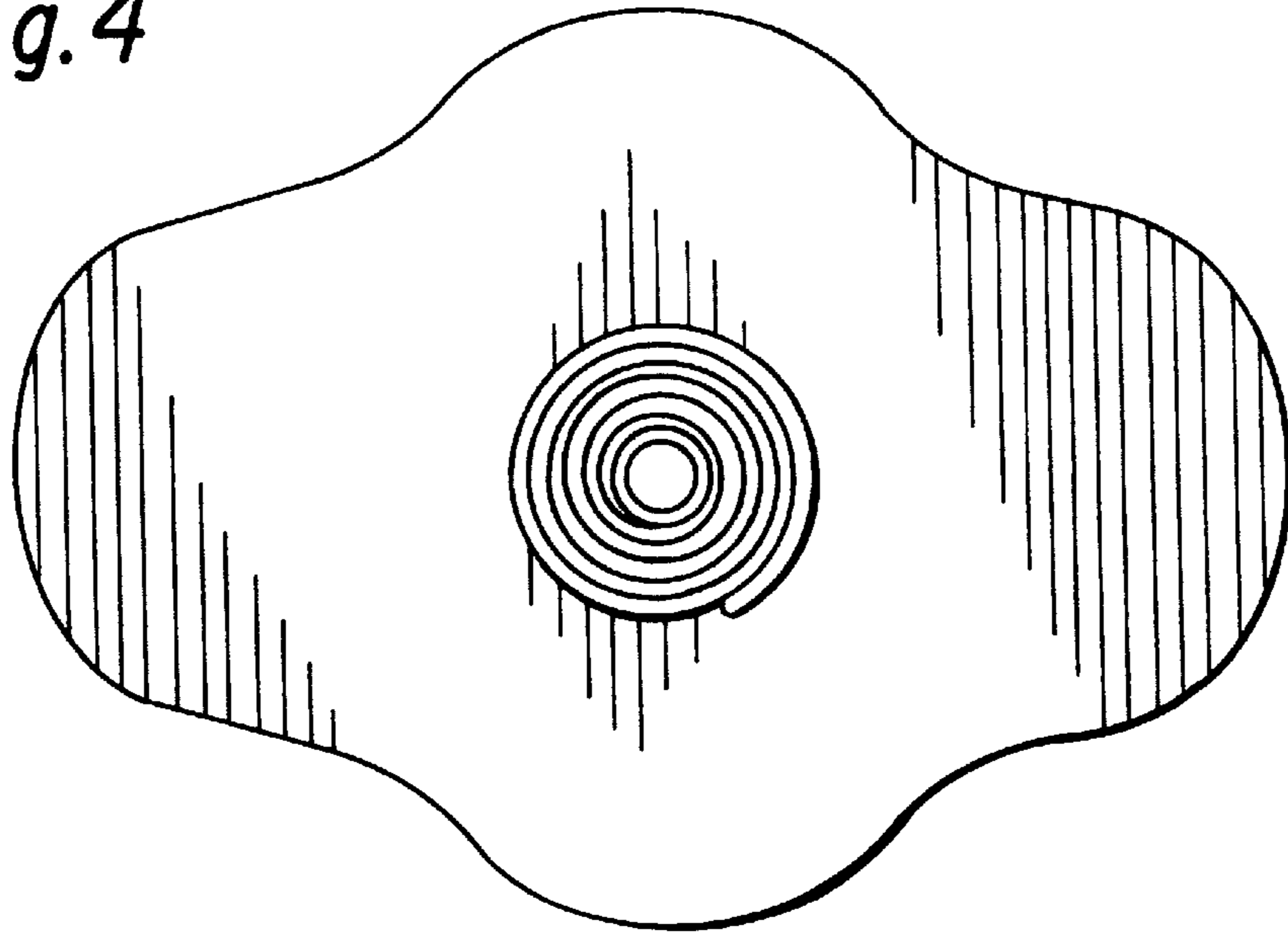
