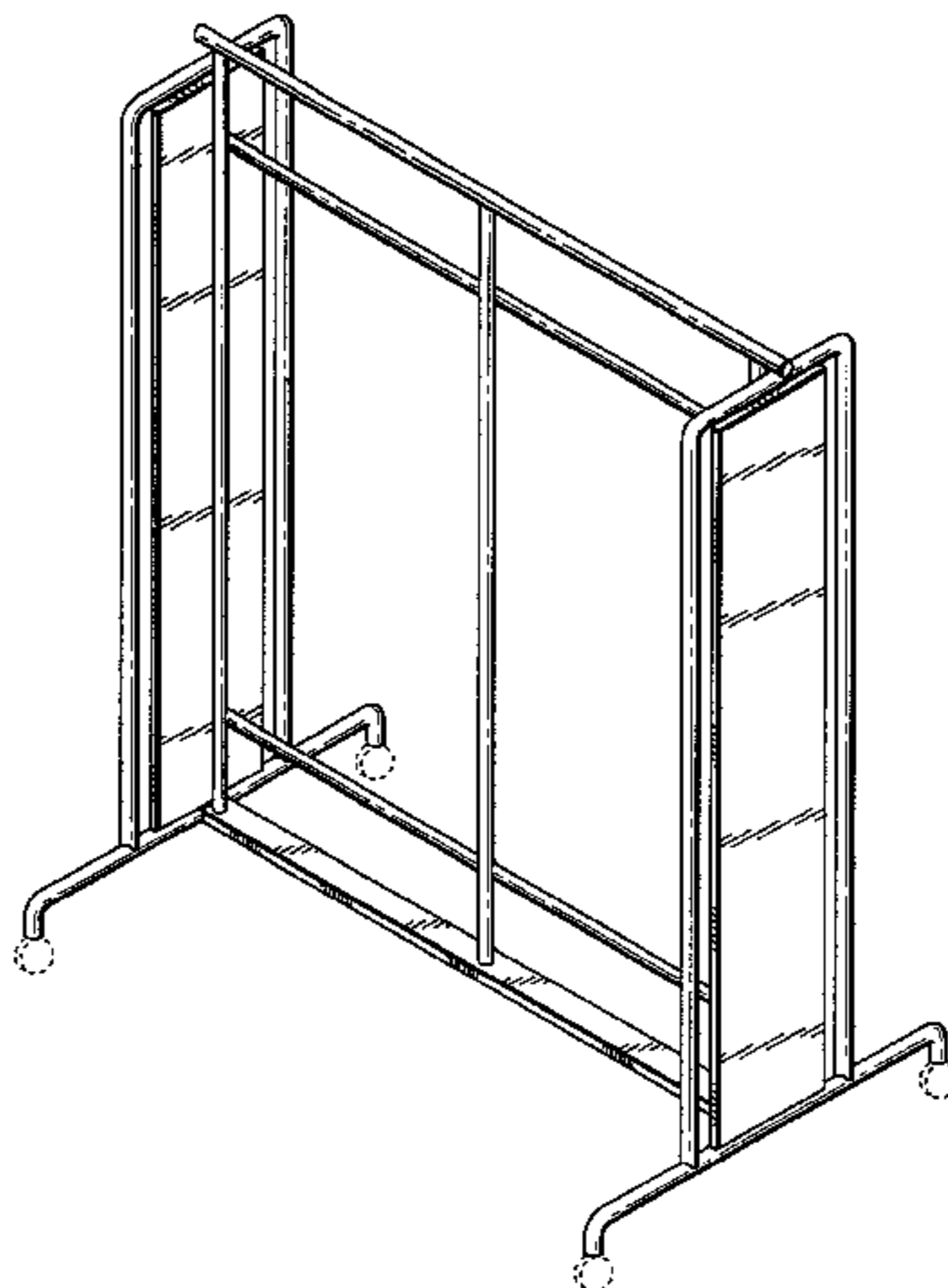

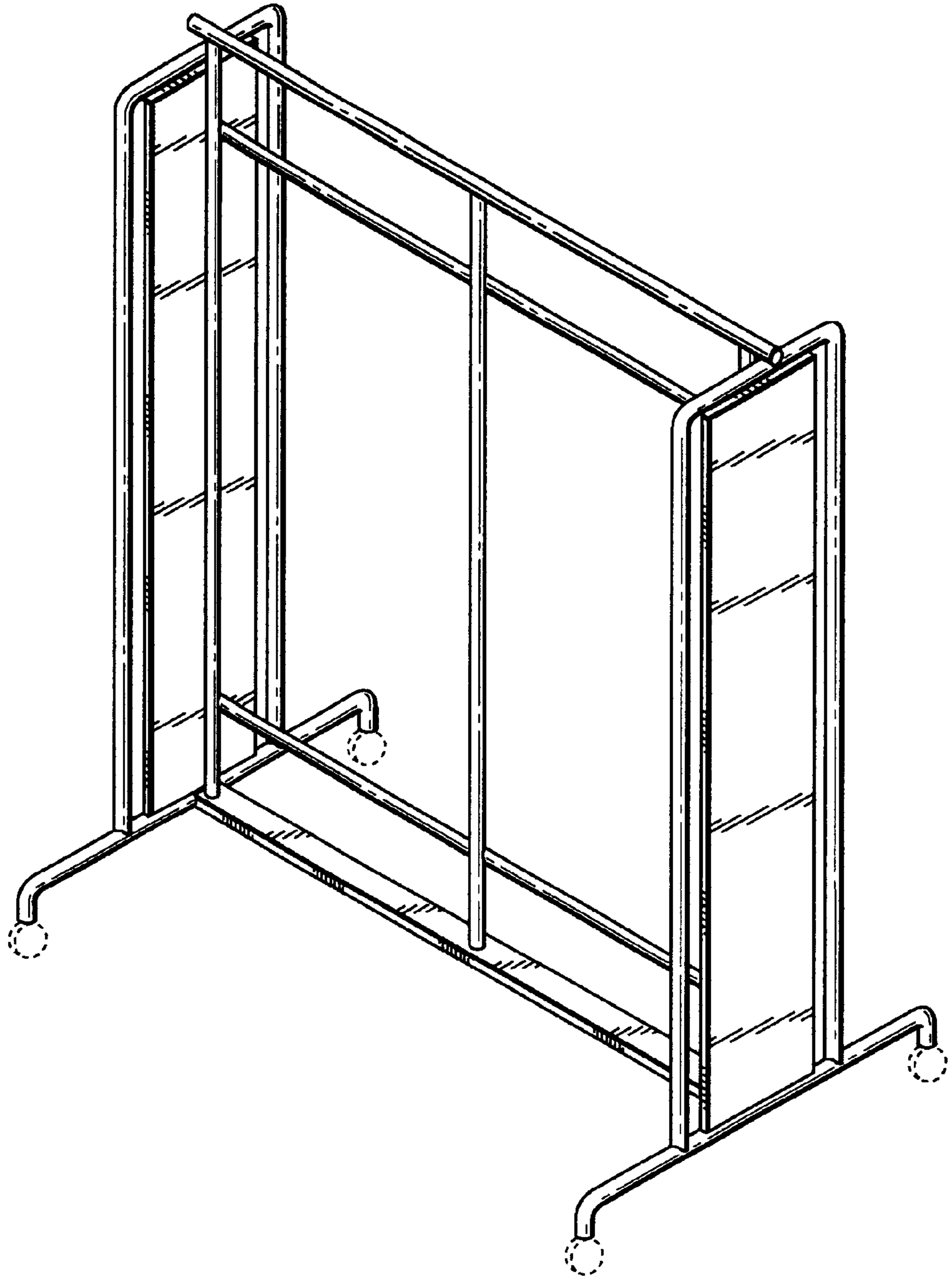
The ornamental design for a merchandising fixture, as shown and described.

**DESCRIPTION**

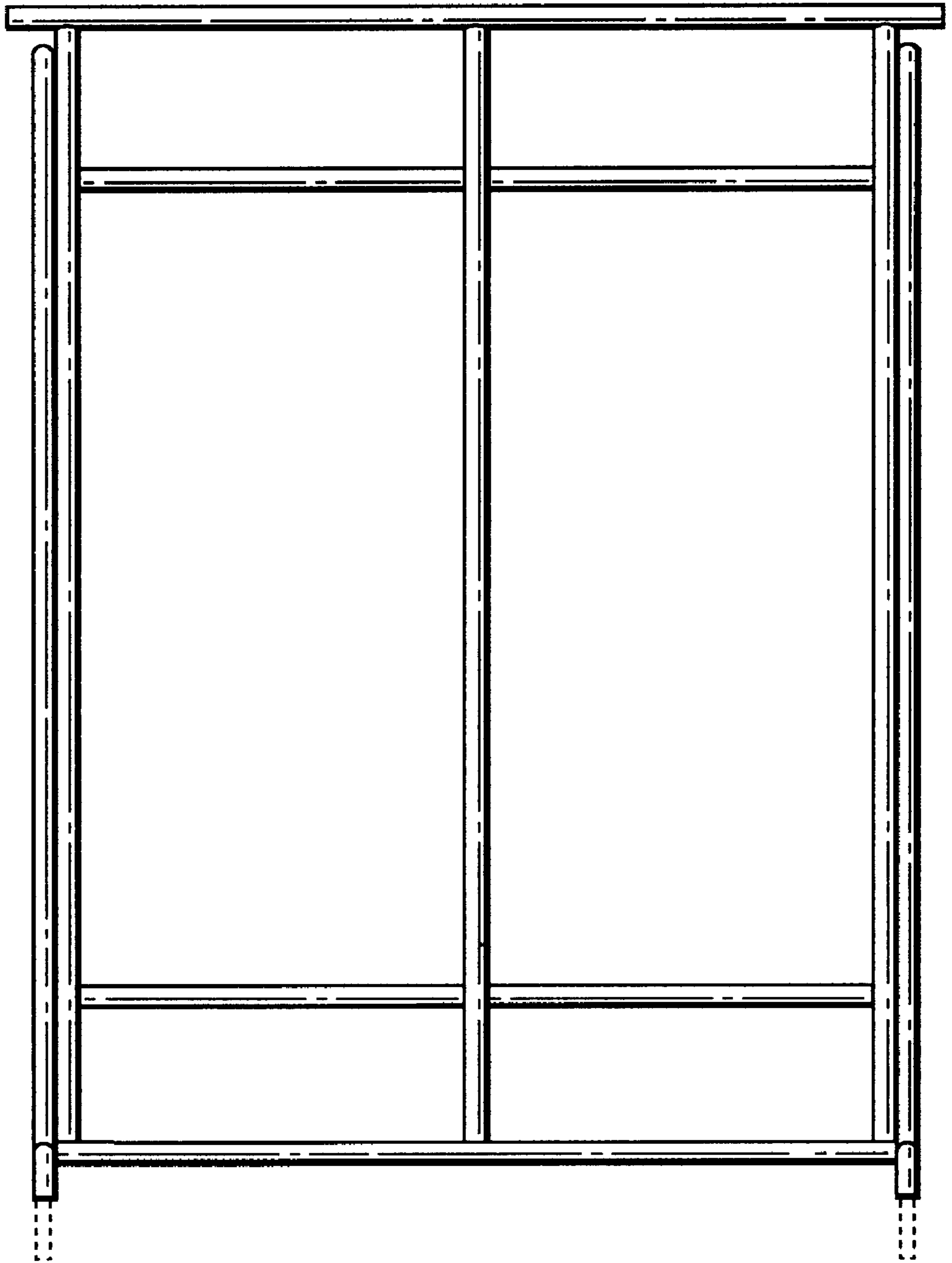

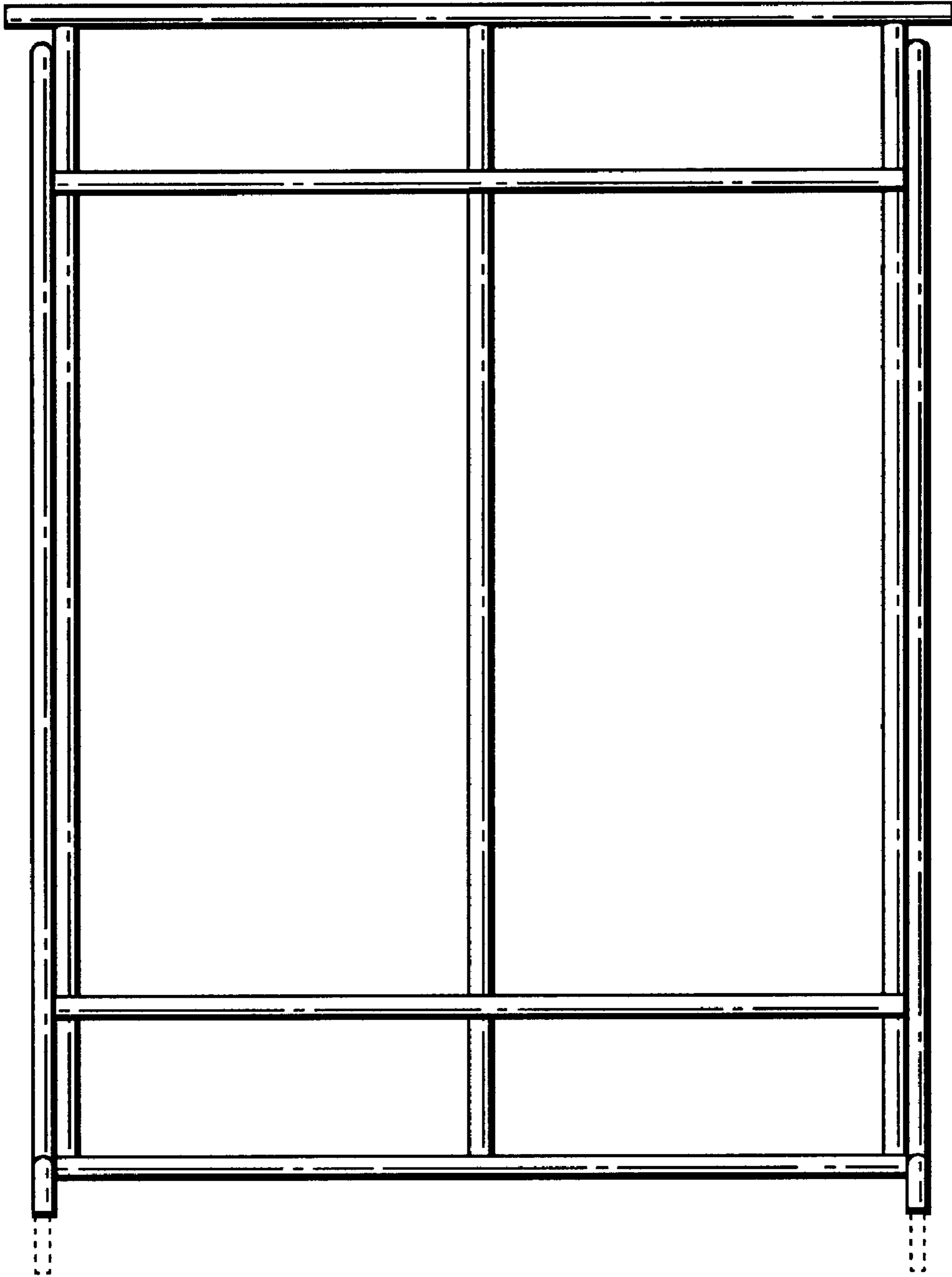

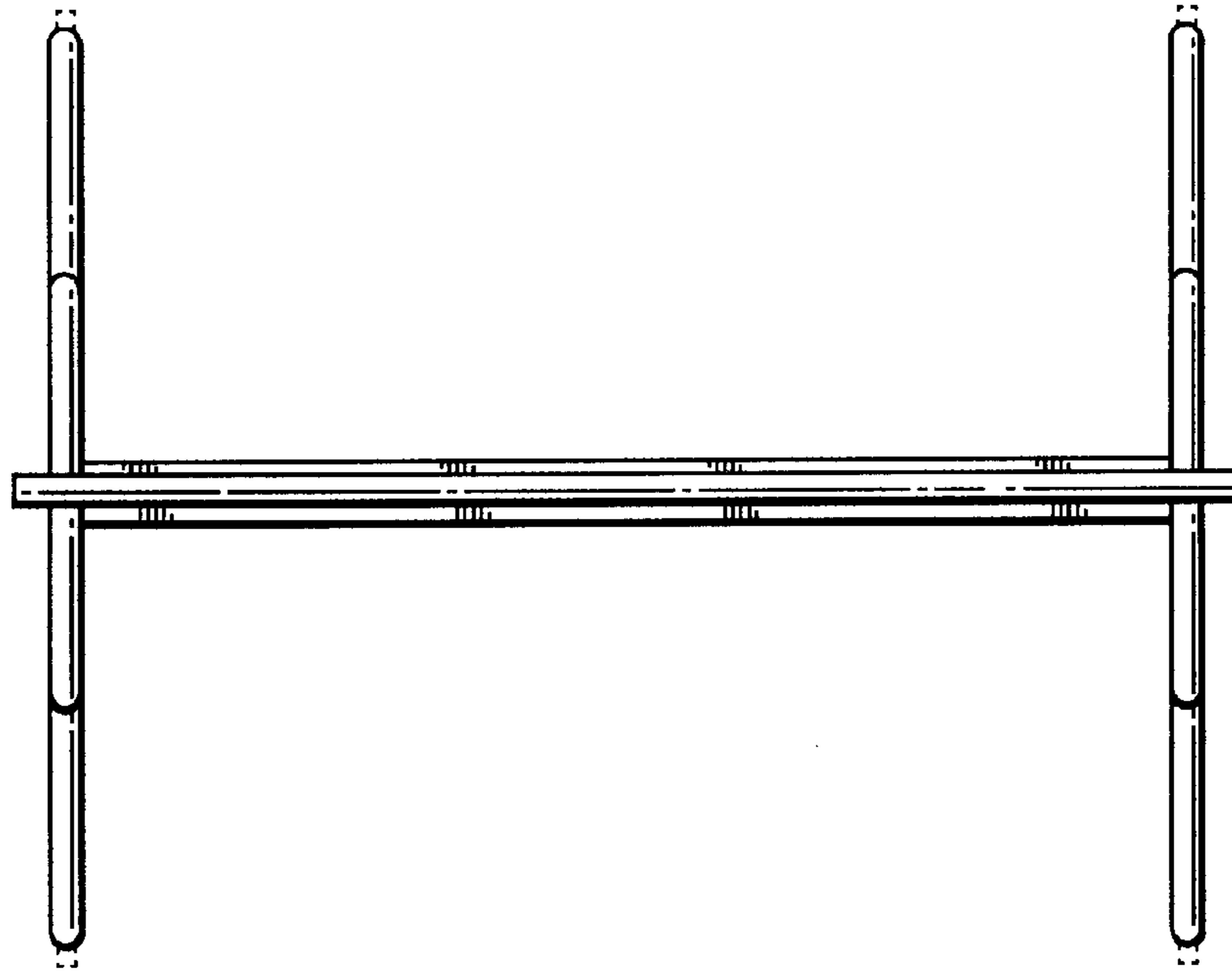

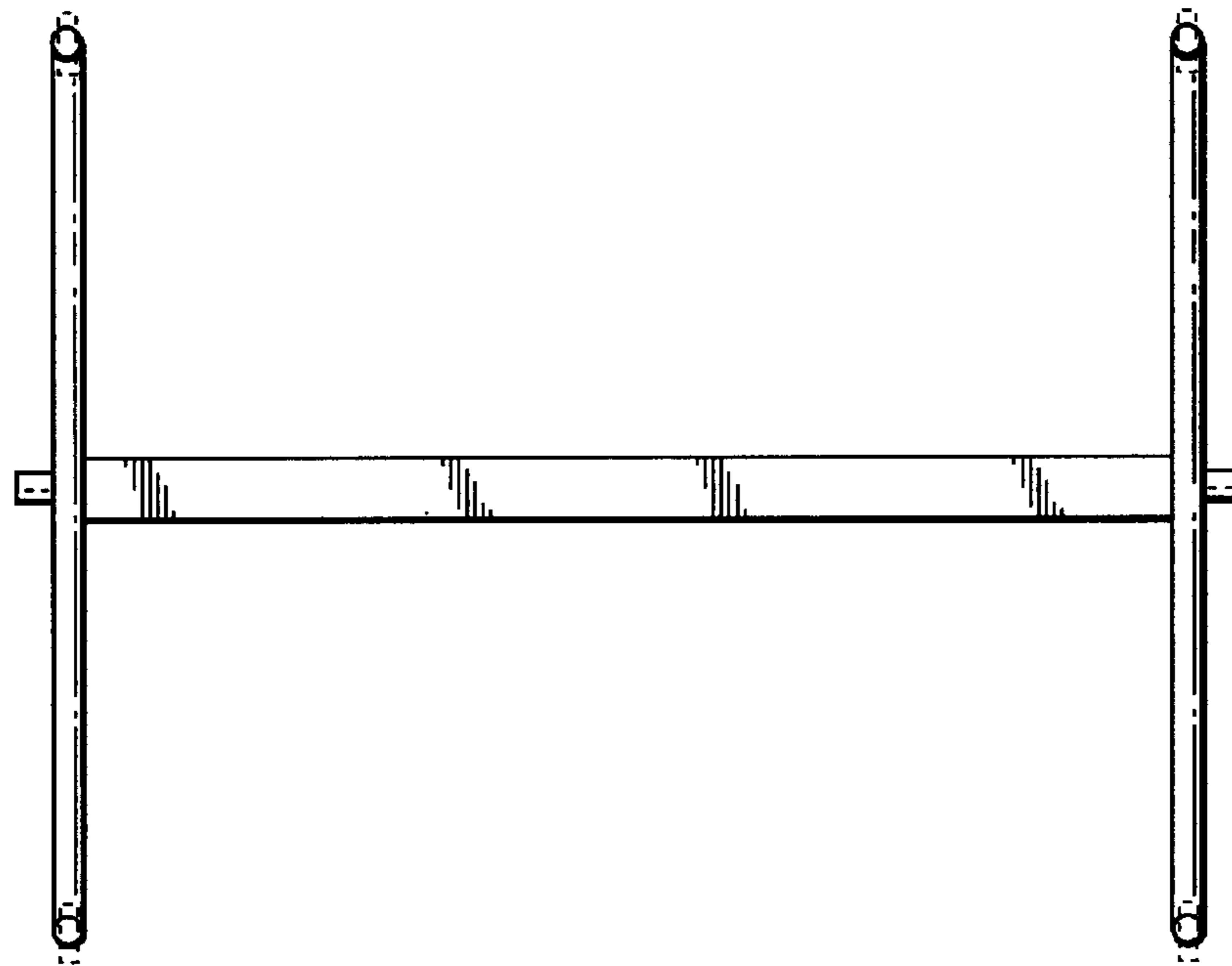
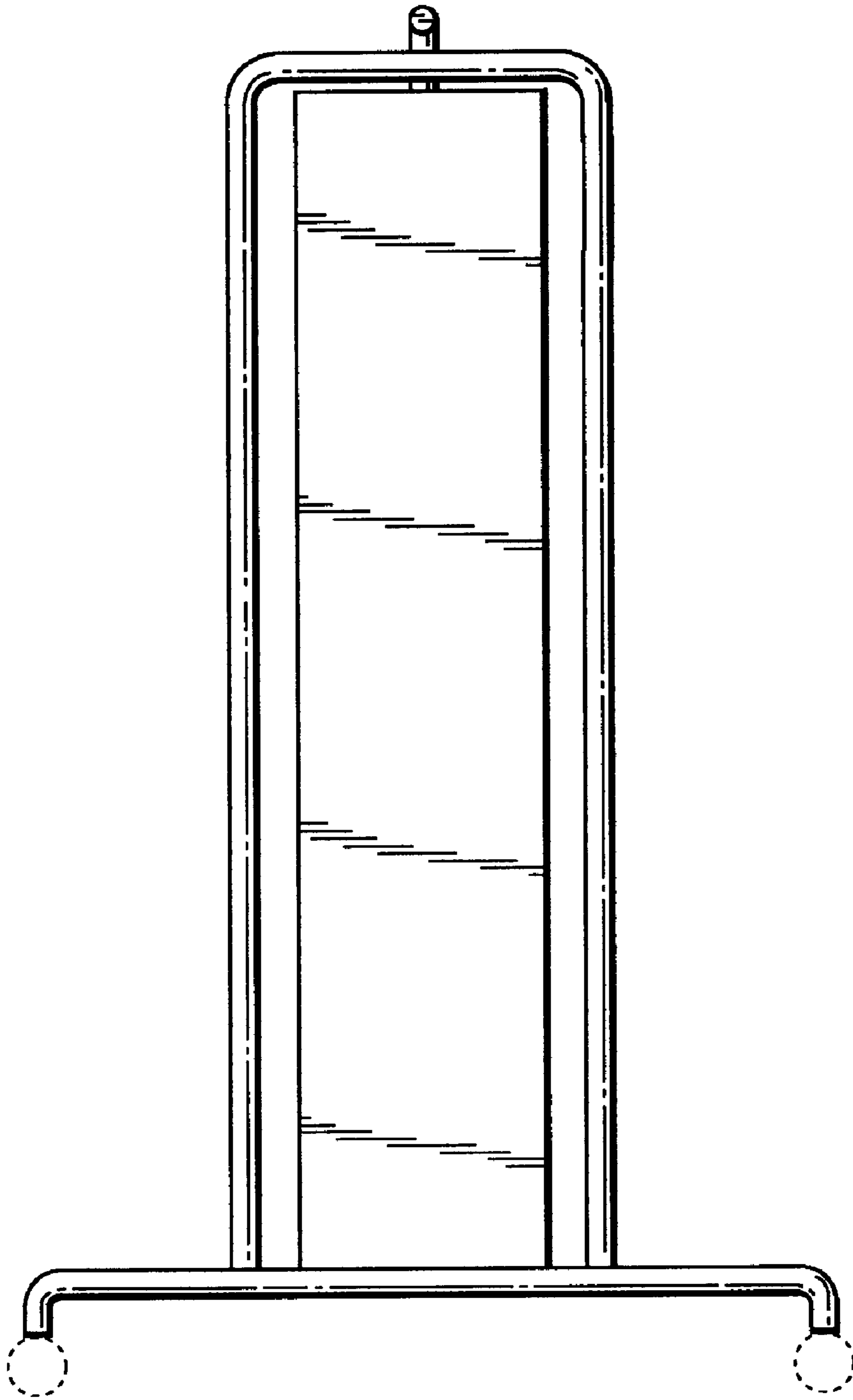
