(57) **CLAIM**

The ornamental design for a rolled product dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rolled product dispenser showing our new design, the broken-line disclosure of a window in the front panel is for illustrative purposes only and forms no part of the claimed design.

FIG. 2 is a front view of the embodiment shown in FIG. 1. FIG. 3 is a back view of the embodiment shown in FIG. 1. FIG. 4 is a right side view of the embodiment shown in FIG. 1.

FIG. 5 is a left side view of the embodiment shown in FIG. 1.

FIG. 6 is a top view of the embodiment shown in FIG. 1; and,

FIG. 7 is a bottom view of the embodiment shown in FIG. 1.

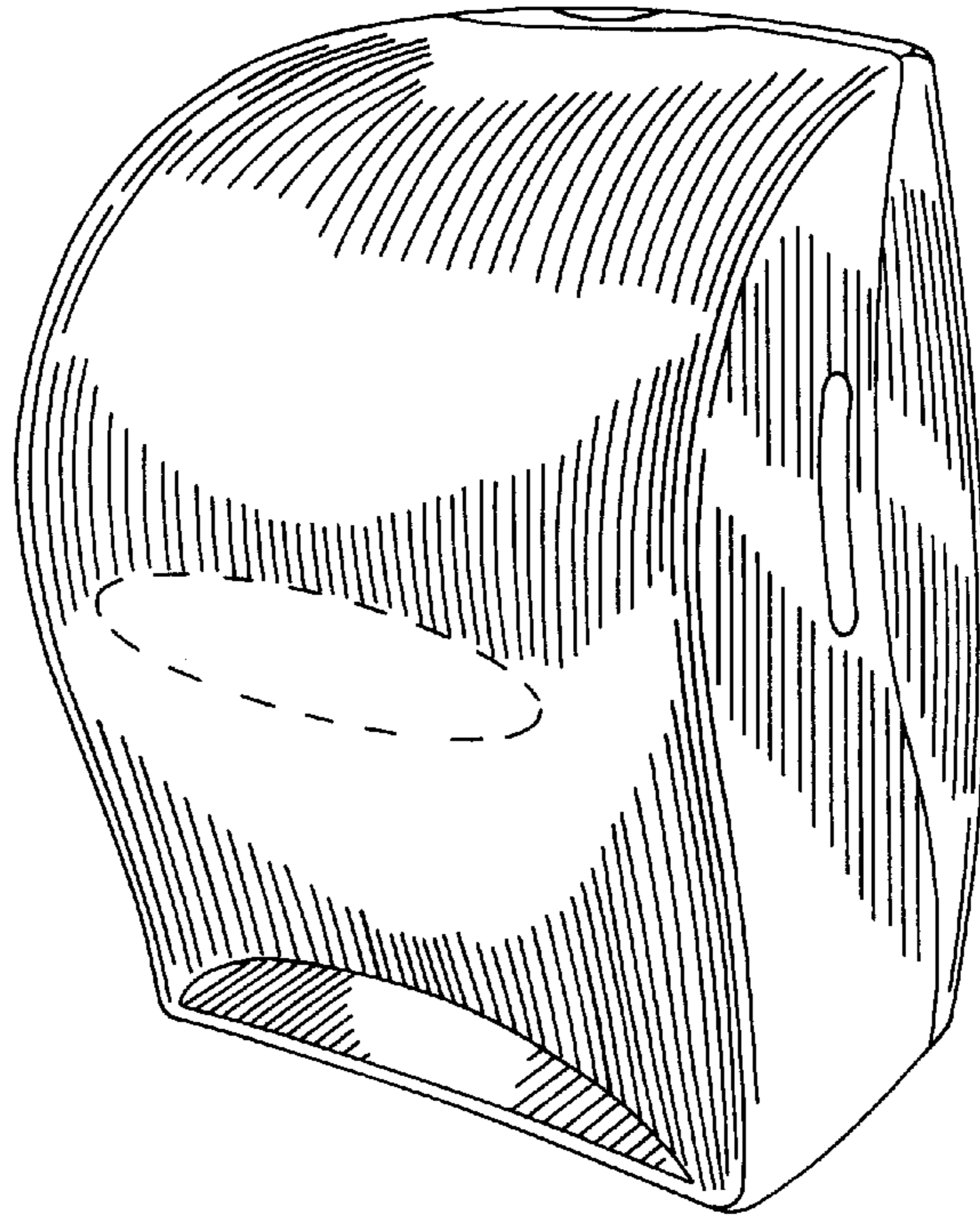

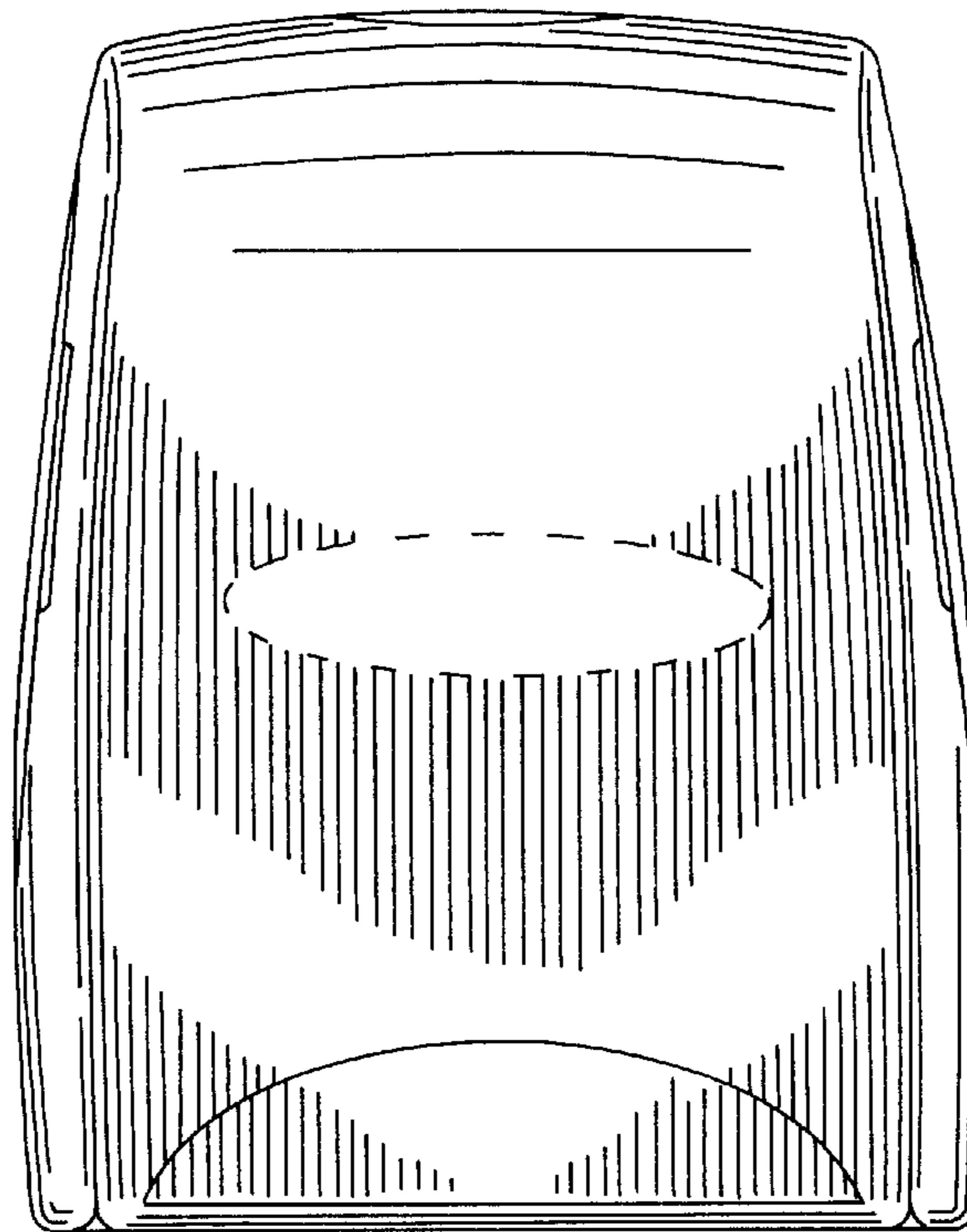

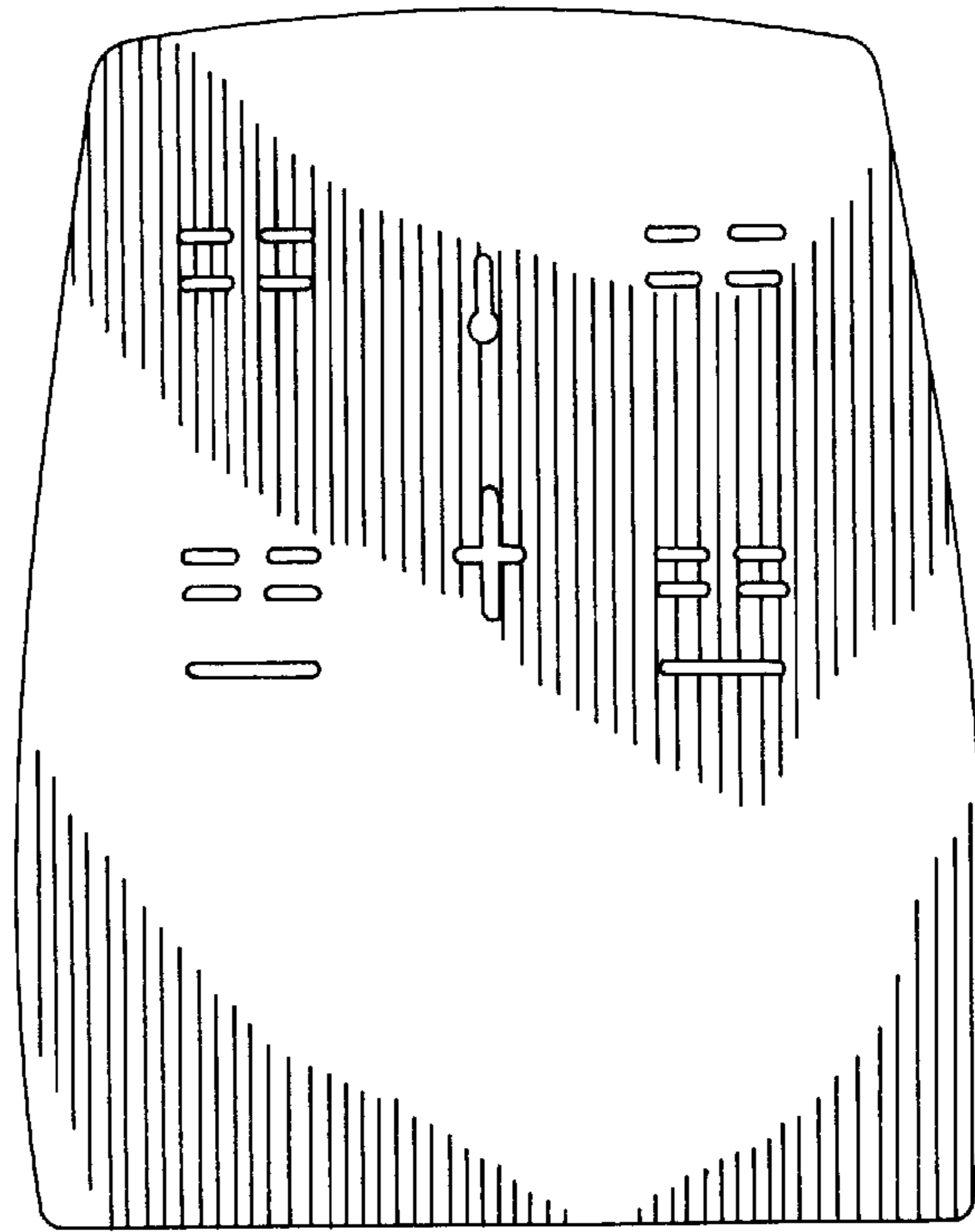

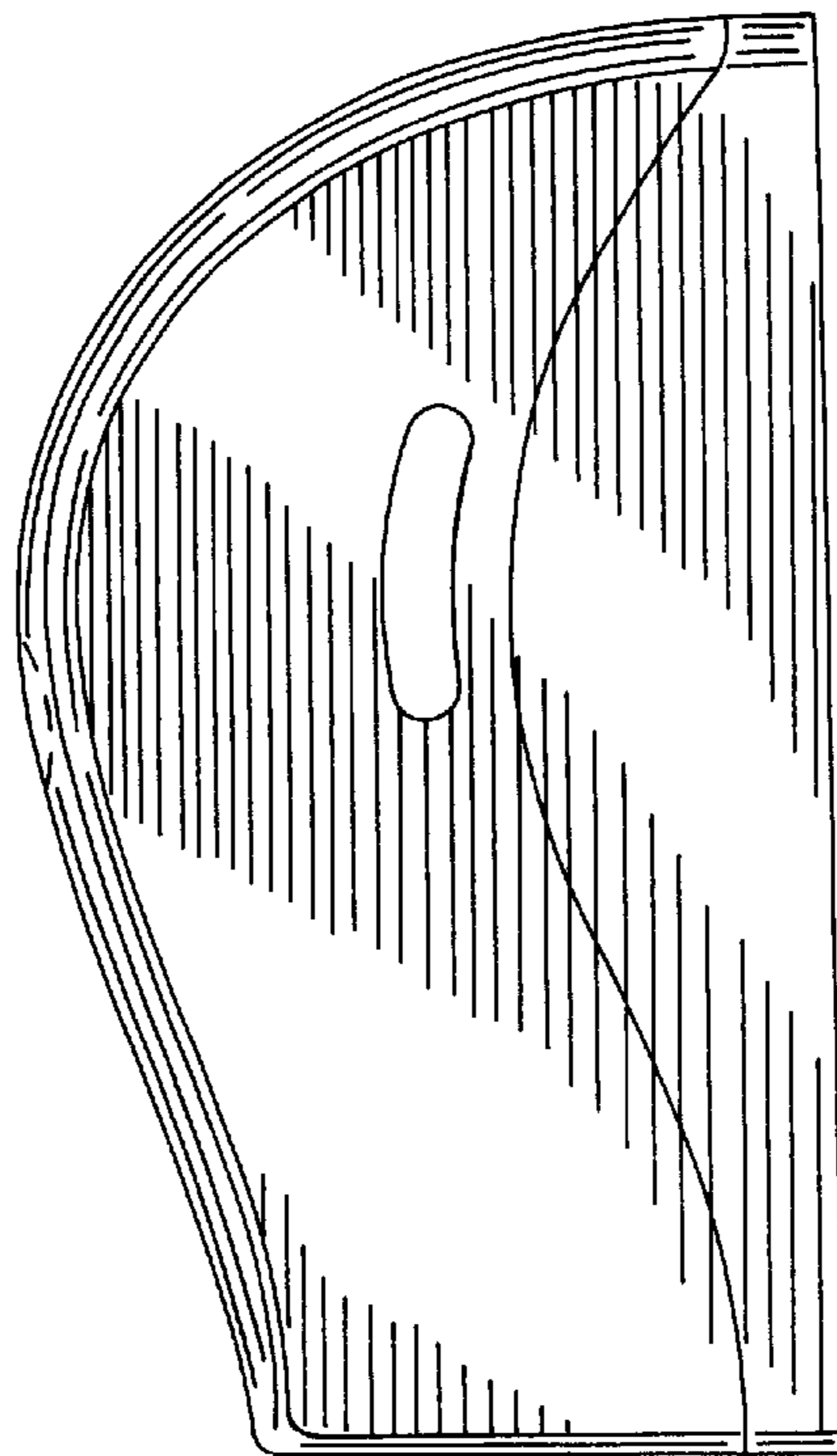

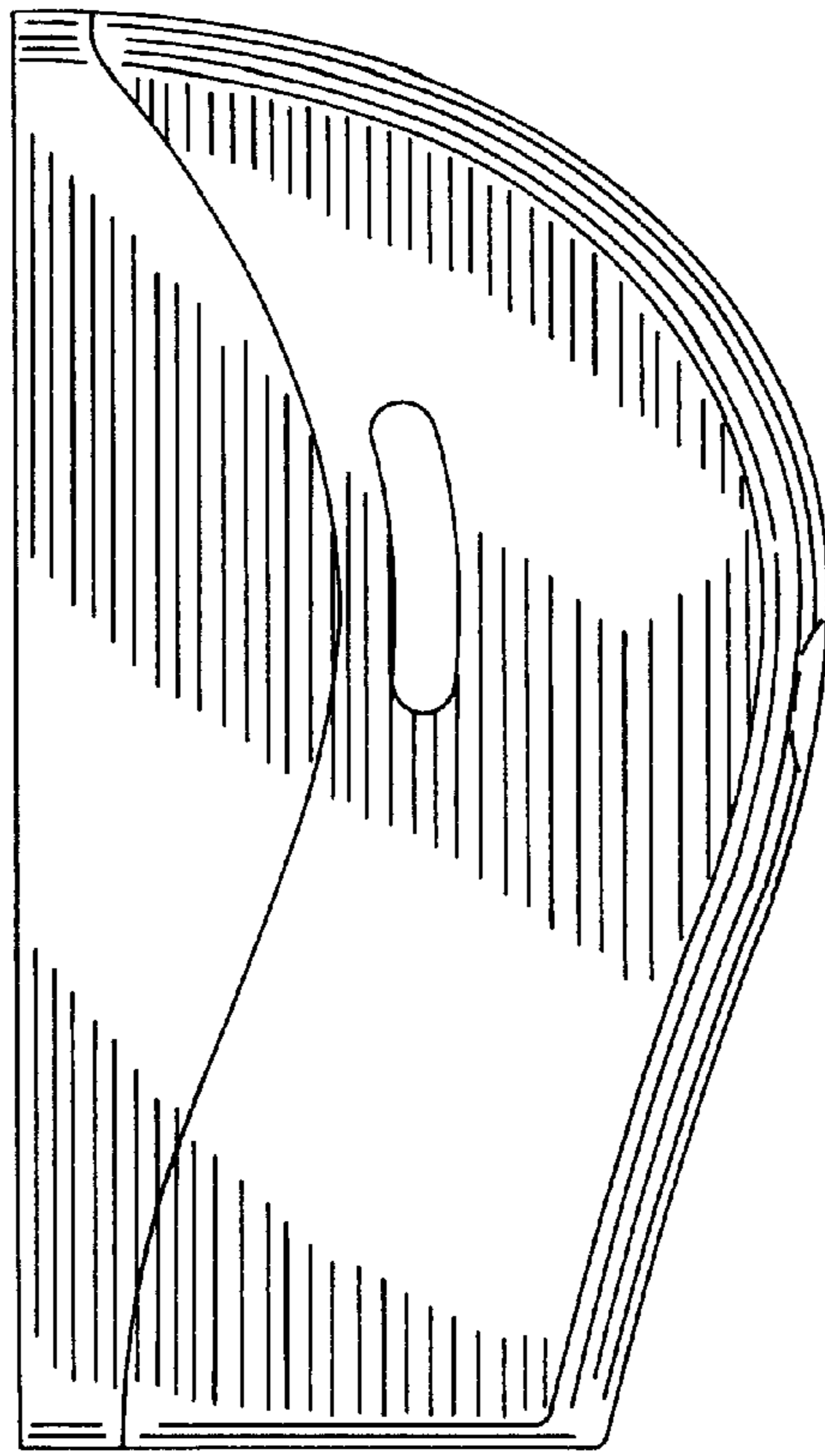

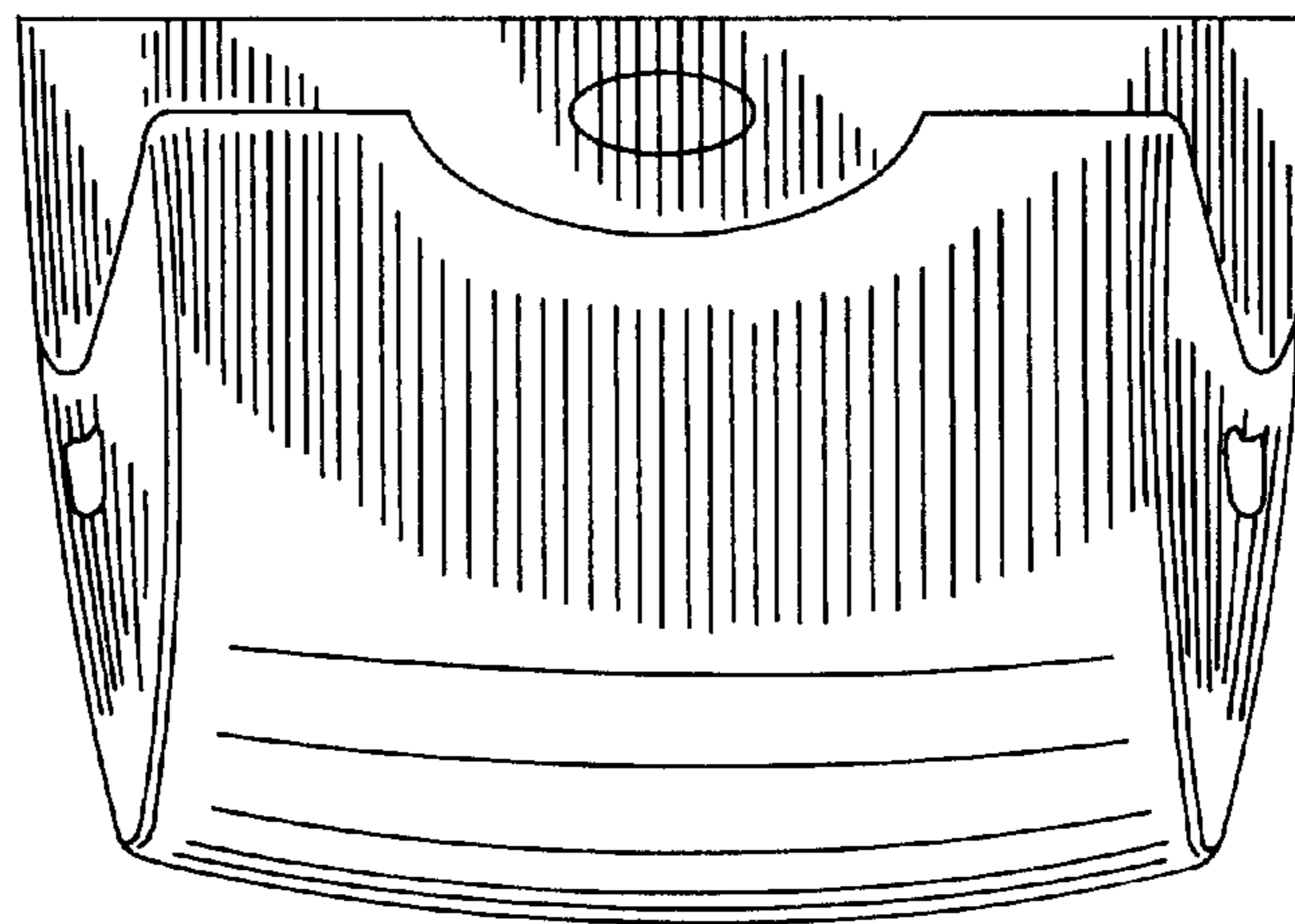
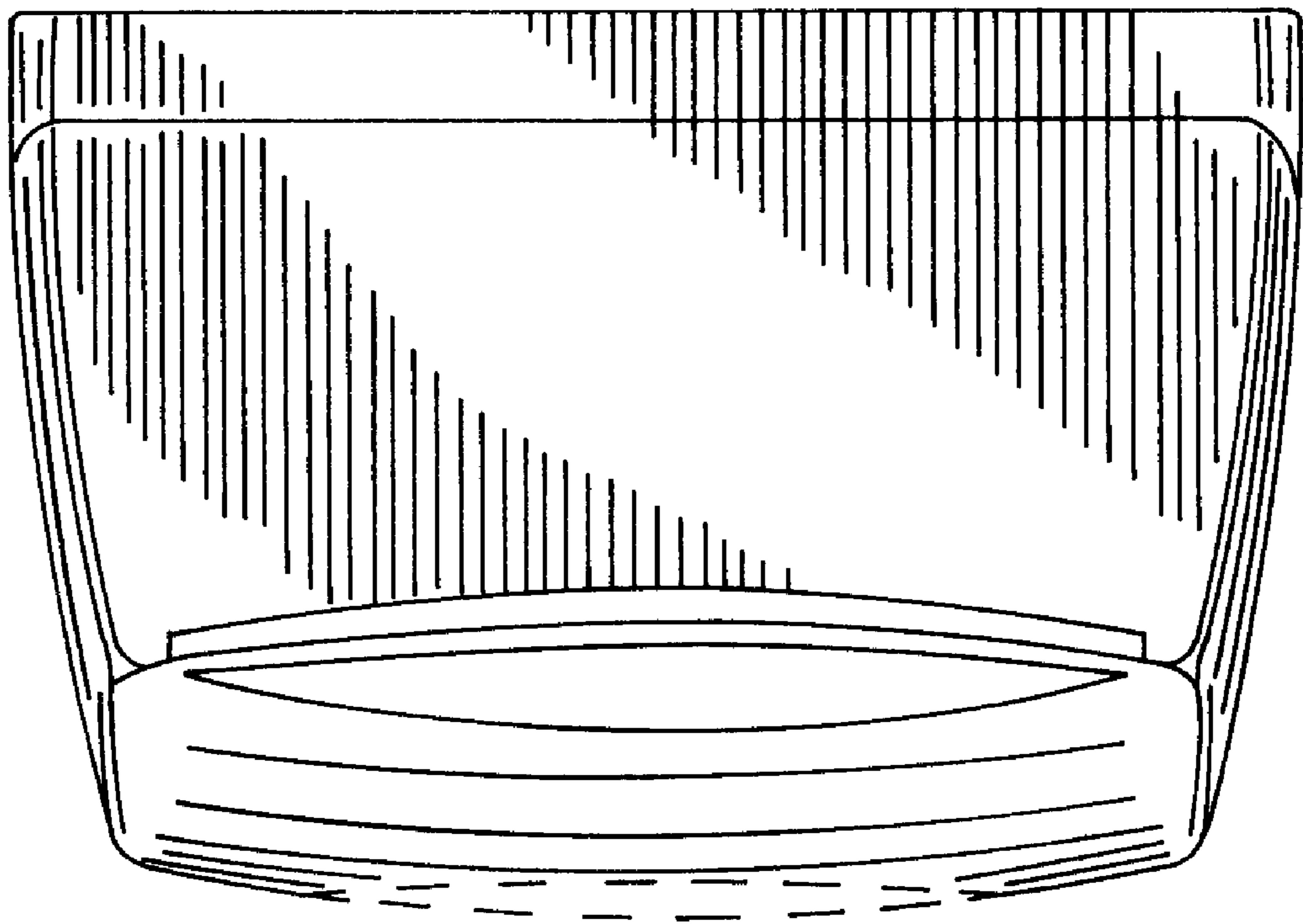
