(57) **CLAIM**

We claim the ornamental design for a pair of double extra large ring duck-billed napping scissors, as shown.

**DESCRIPTION**

FIG. 1 is a view of one face of the scissors of the invention. FIG. 2 is a side view of the scissors of the invention, from the side of the scissors which is toward the bottom of the page in FIG. 1.

FIG. 3 is an end view of the scissors of the invention, from the blade end.

FIG. 4 is an end view of the scissors of the invention, from the handle end.

FIG. 5 is a view of one face of the scissors of the invention, opposite the face shown in FIG. 1; and,

FIG. 6 is a side view of the scissors of the invention, from the opposite side of the scissors from the side shown in FIG. 2.

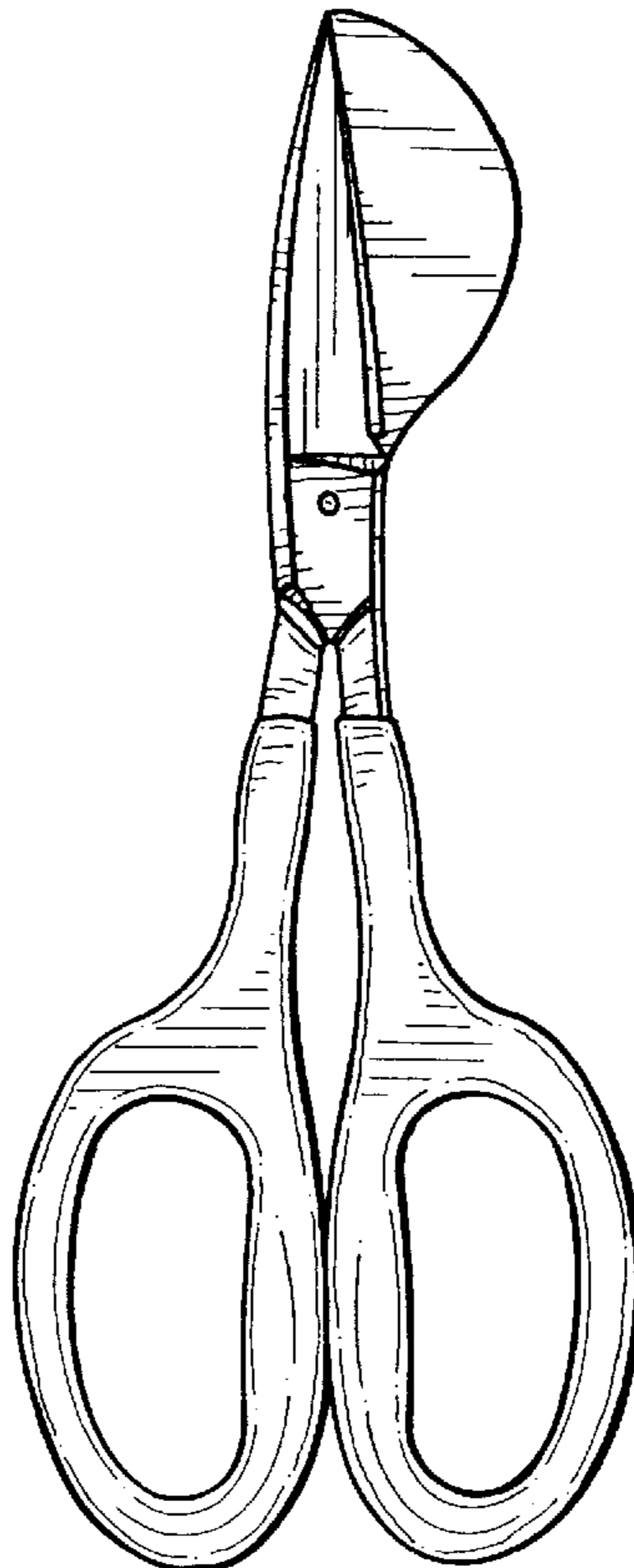

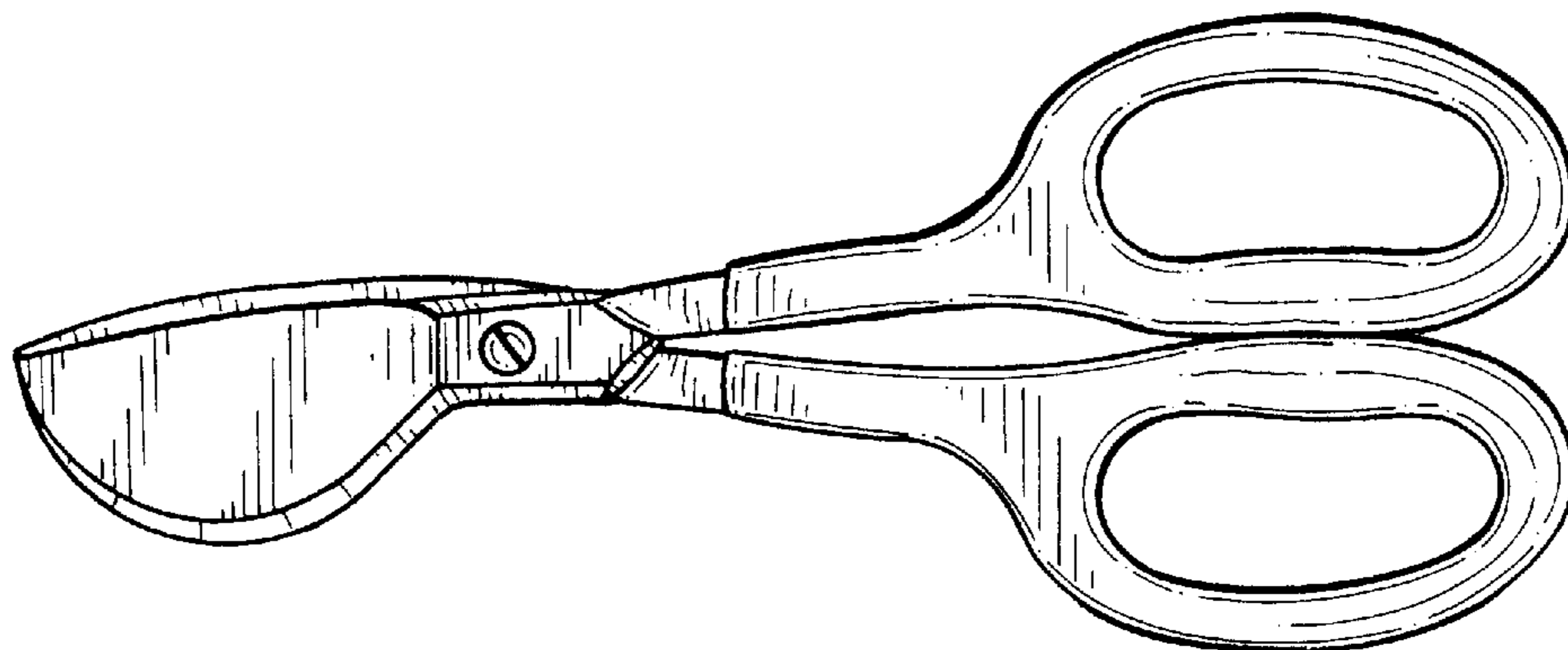

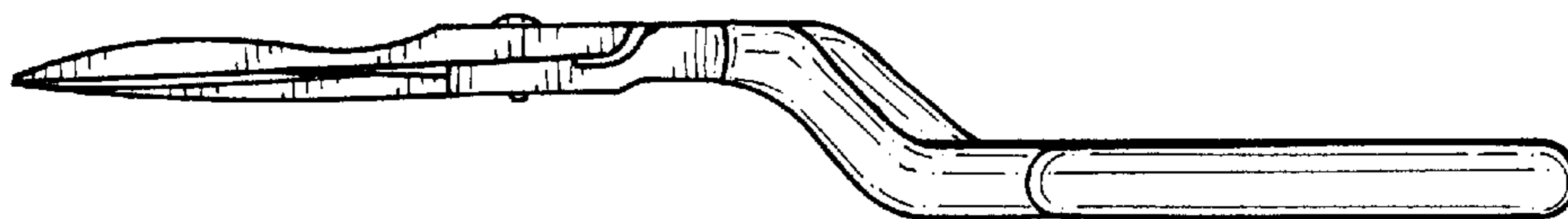

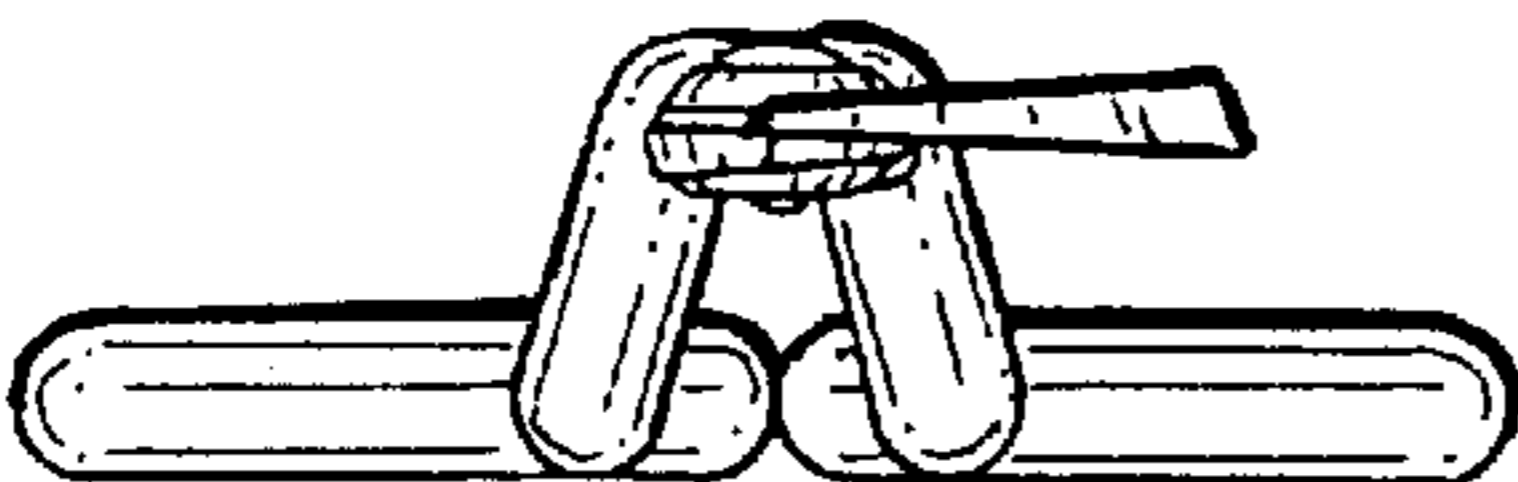

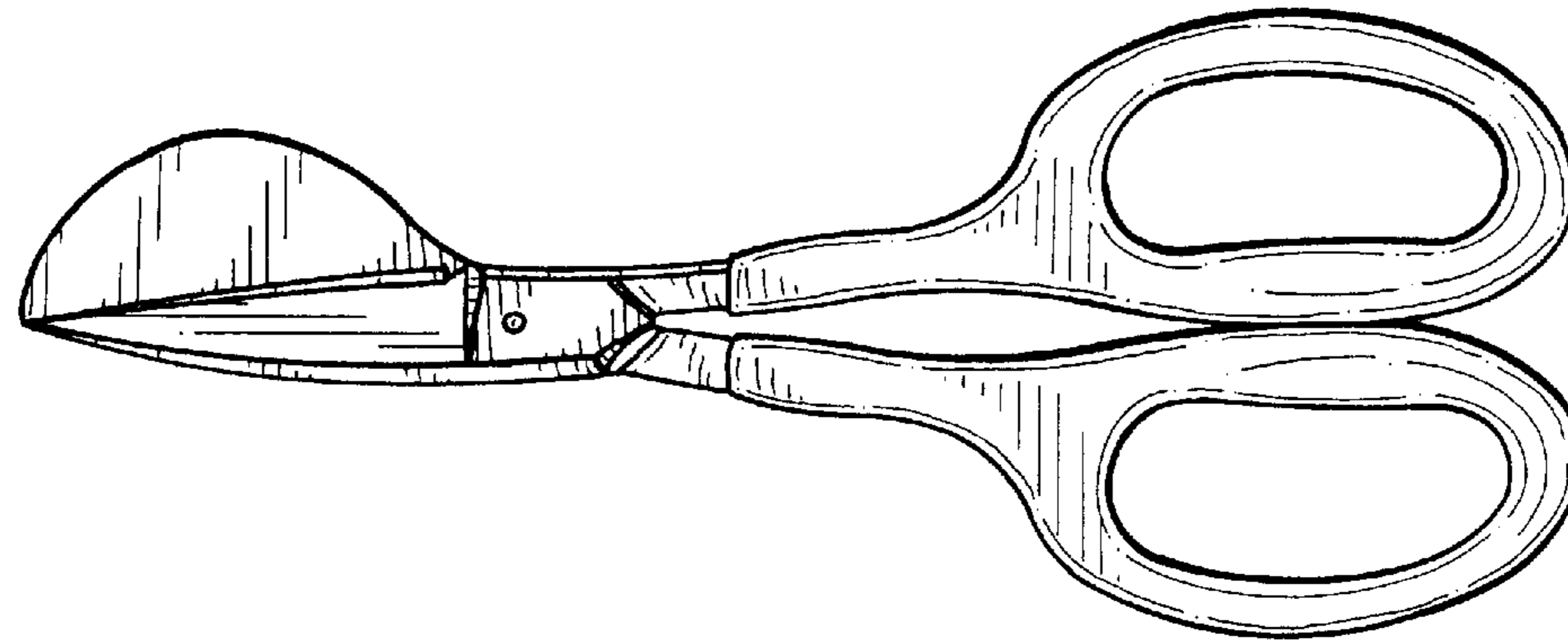
