(57) **CLAIM**

The ornamental design for a hand held electric grinder, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a hand held electric grinder showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a side view of the opposite side of FIG. 1 thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof.

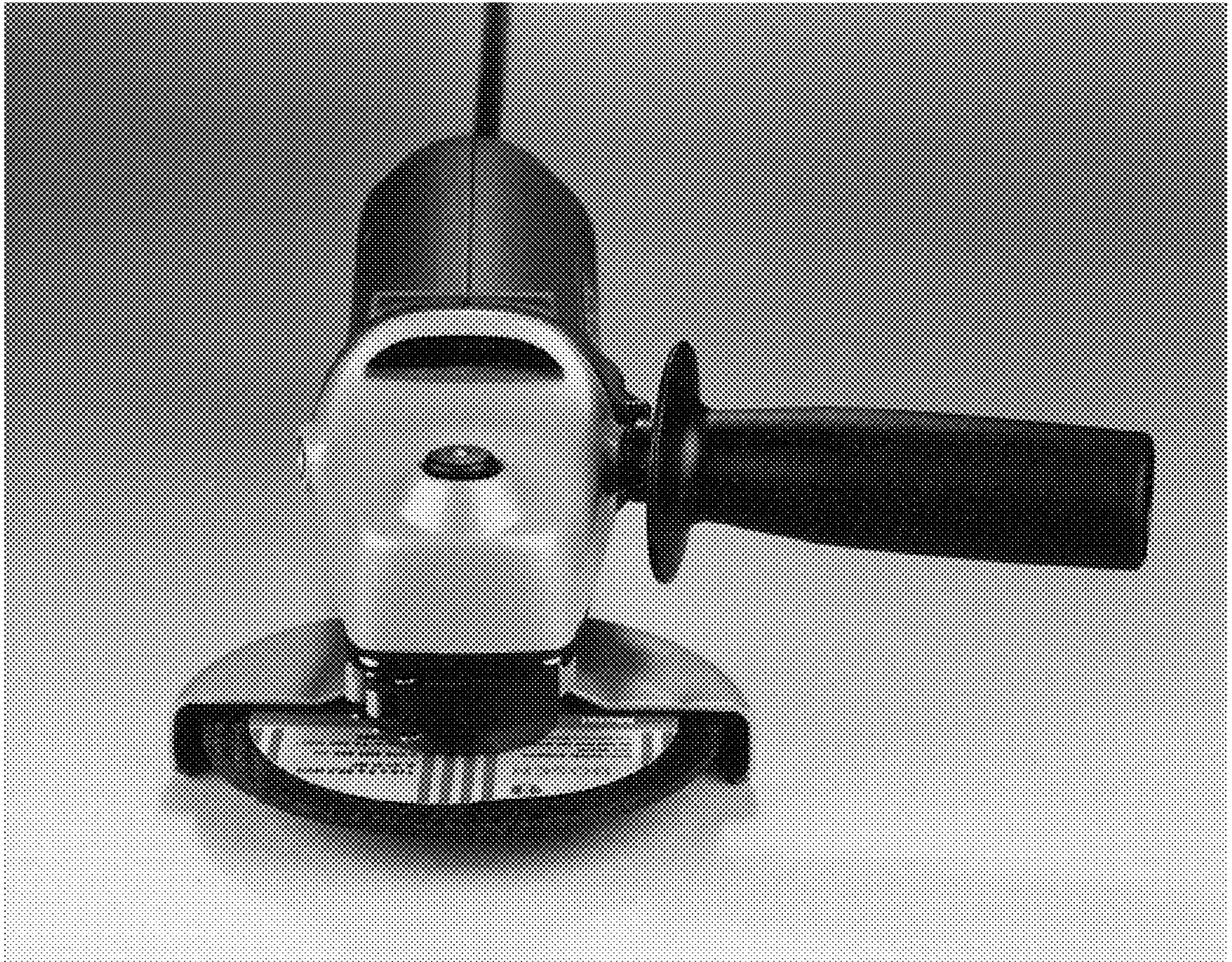

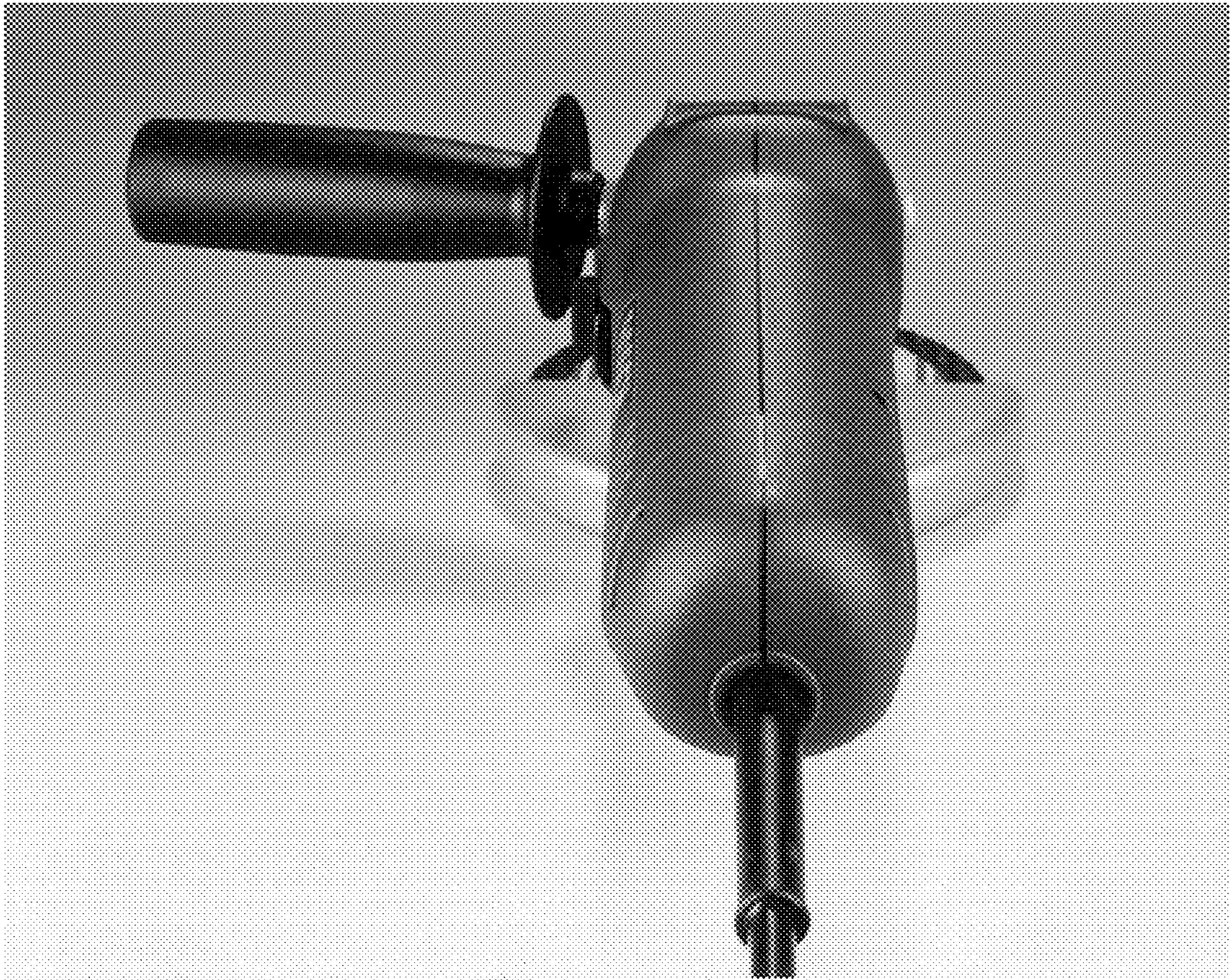

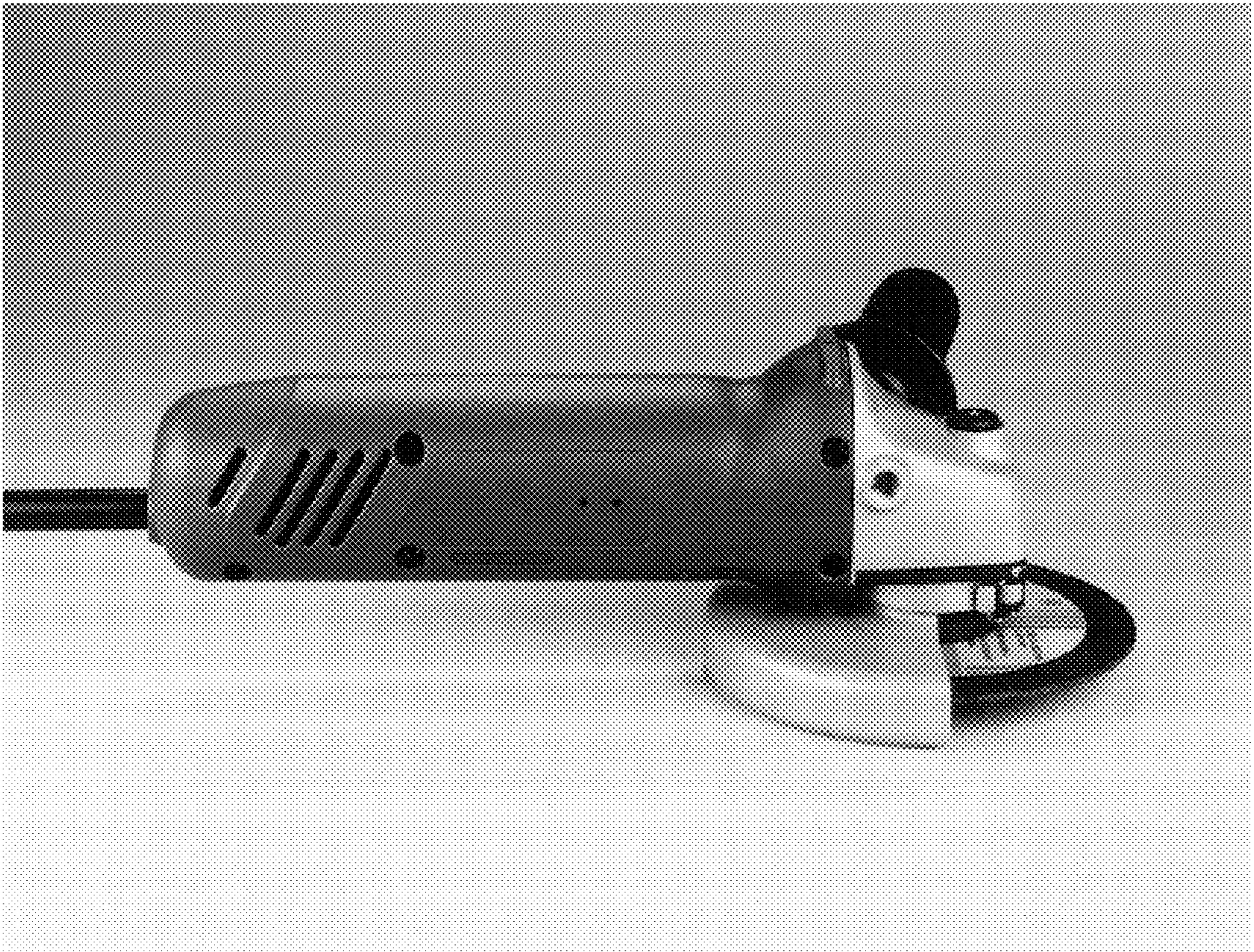

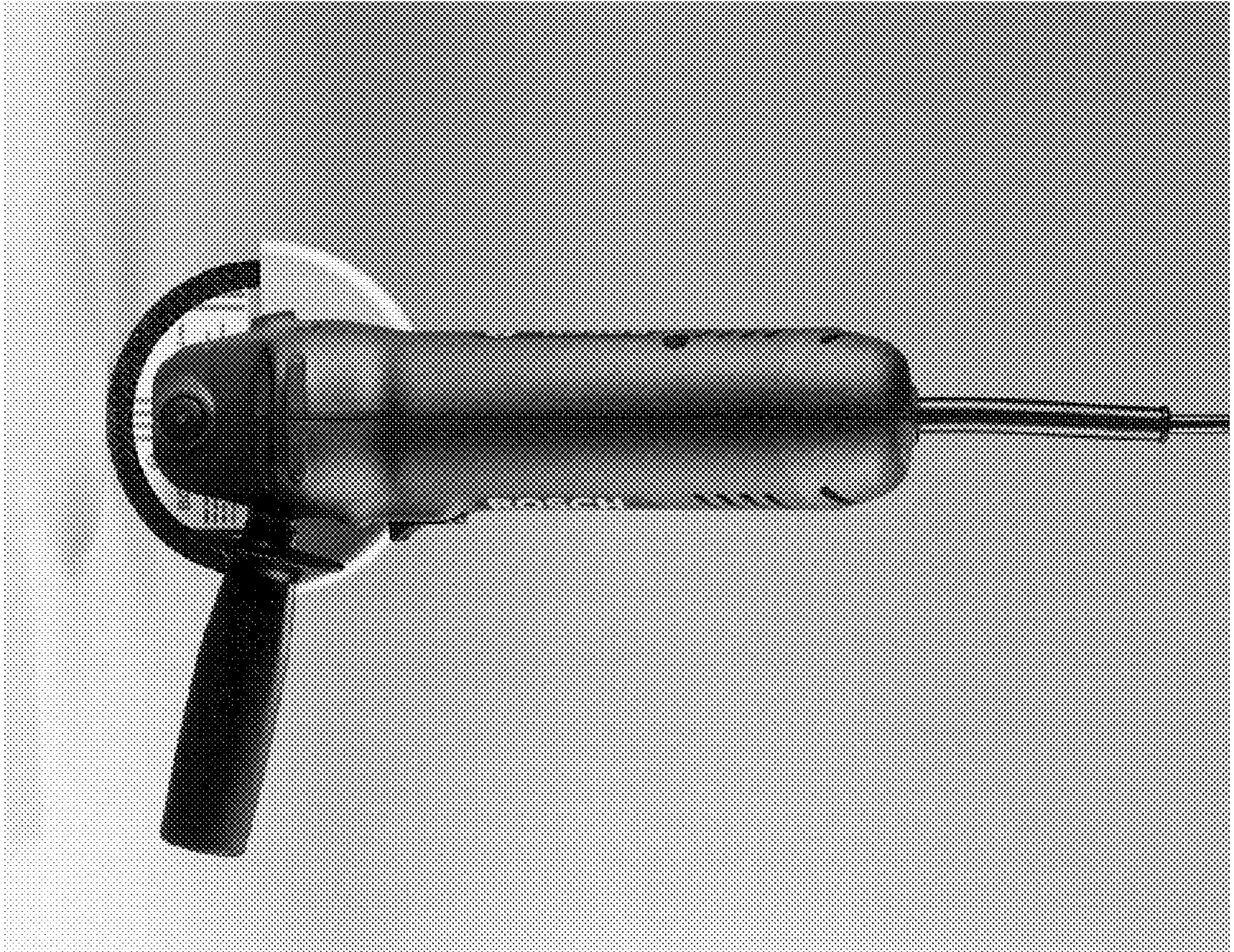

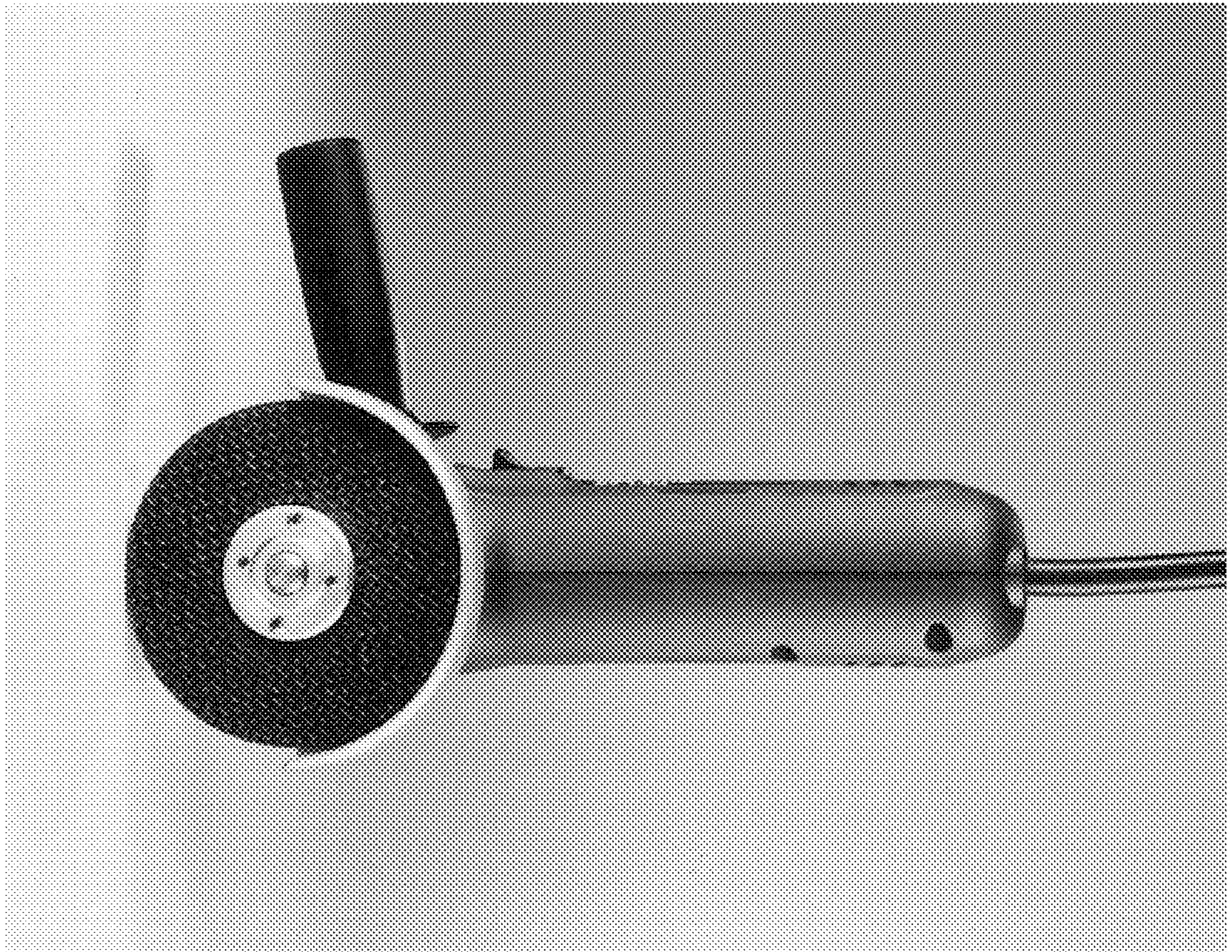
