1; and,

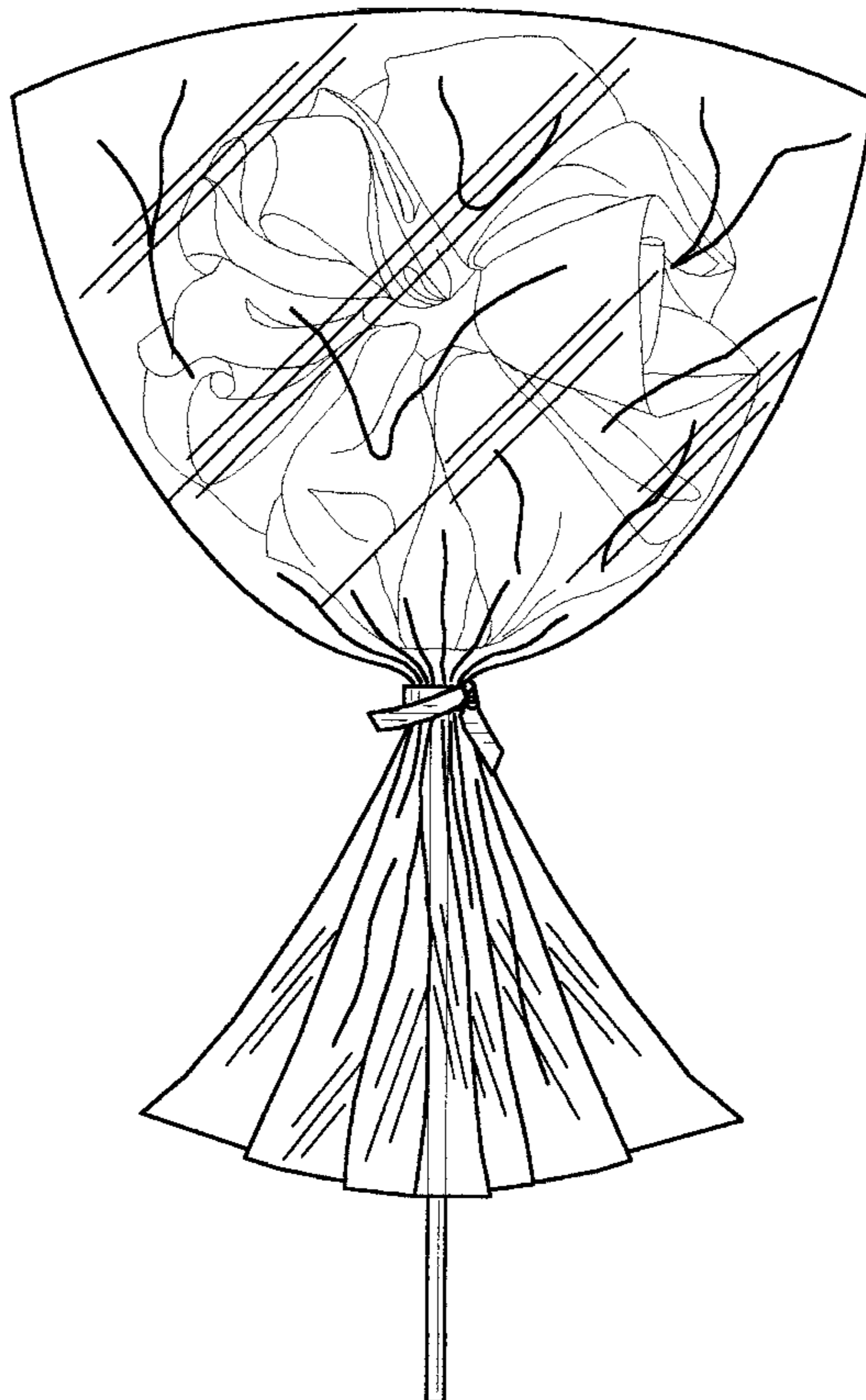
FIG. 6 is a bottom view of the hair scrunchie article of FIG.

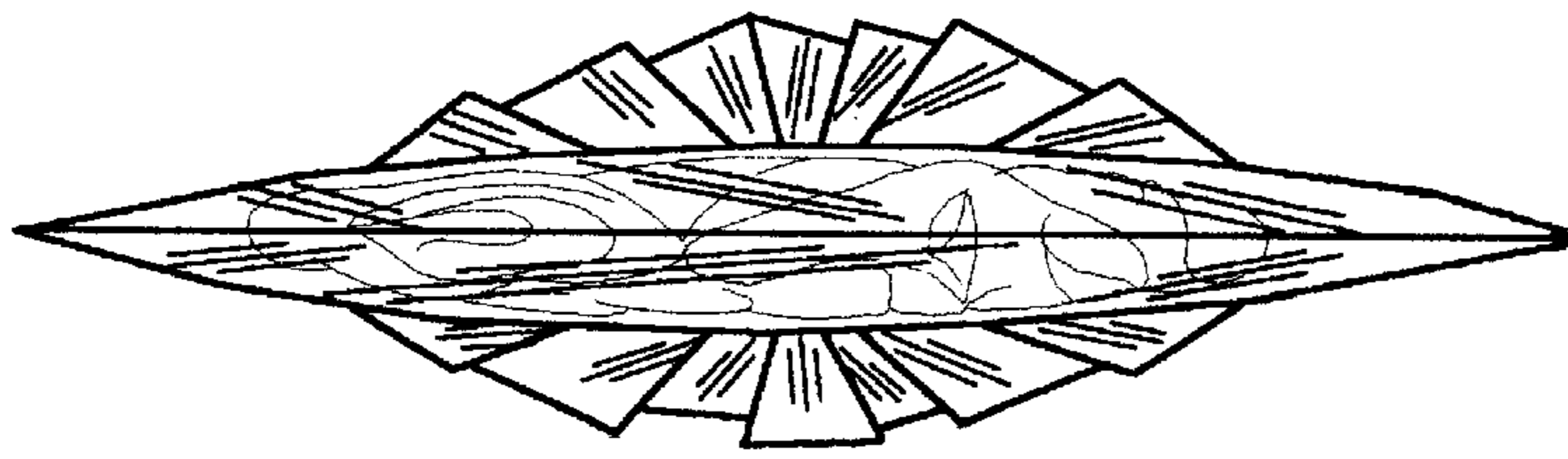

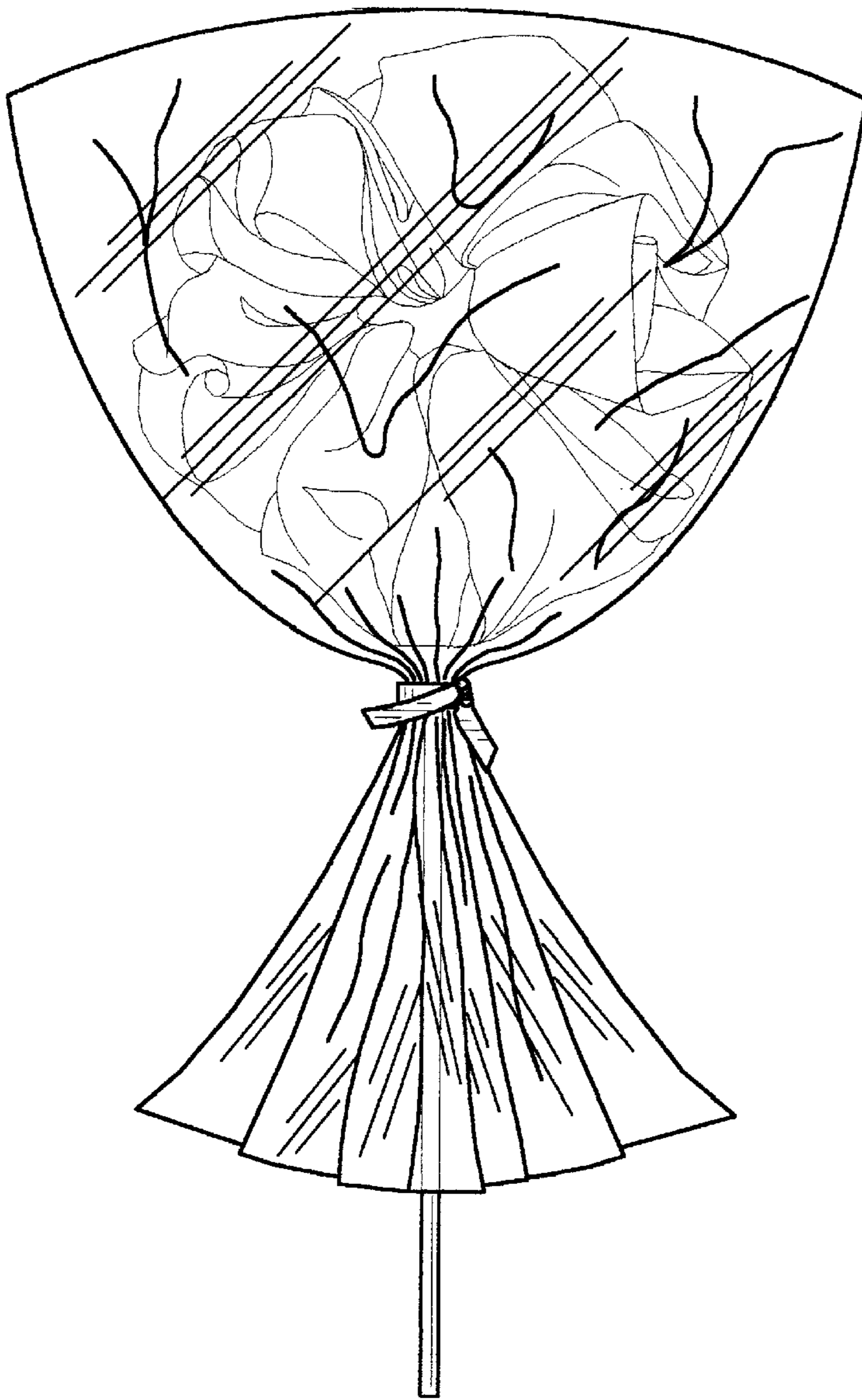

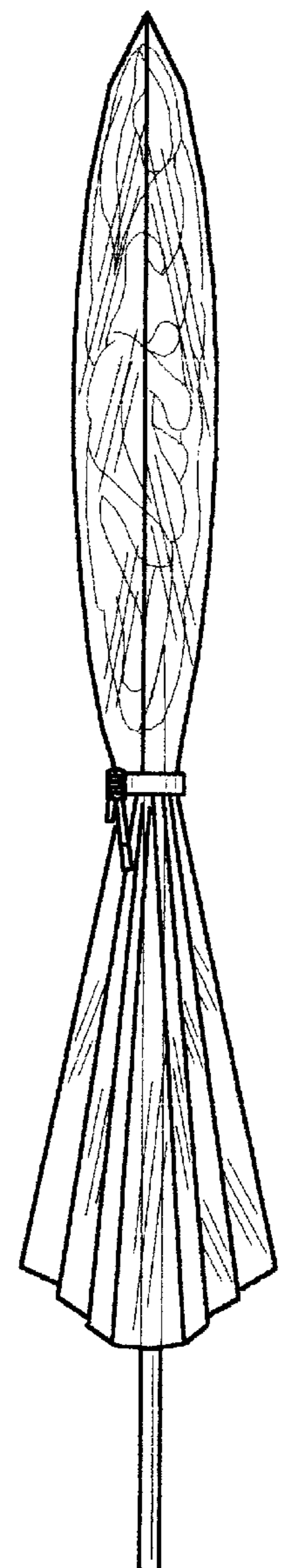

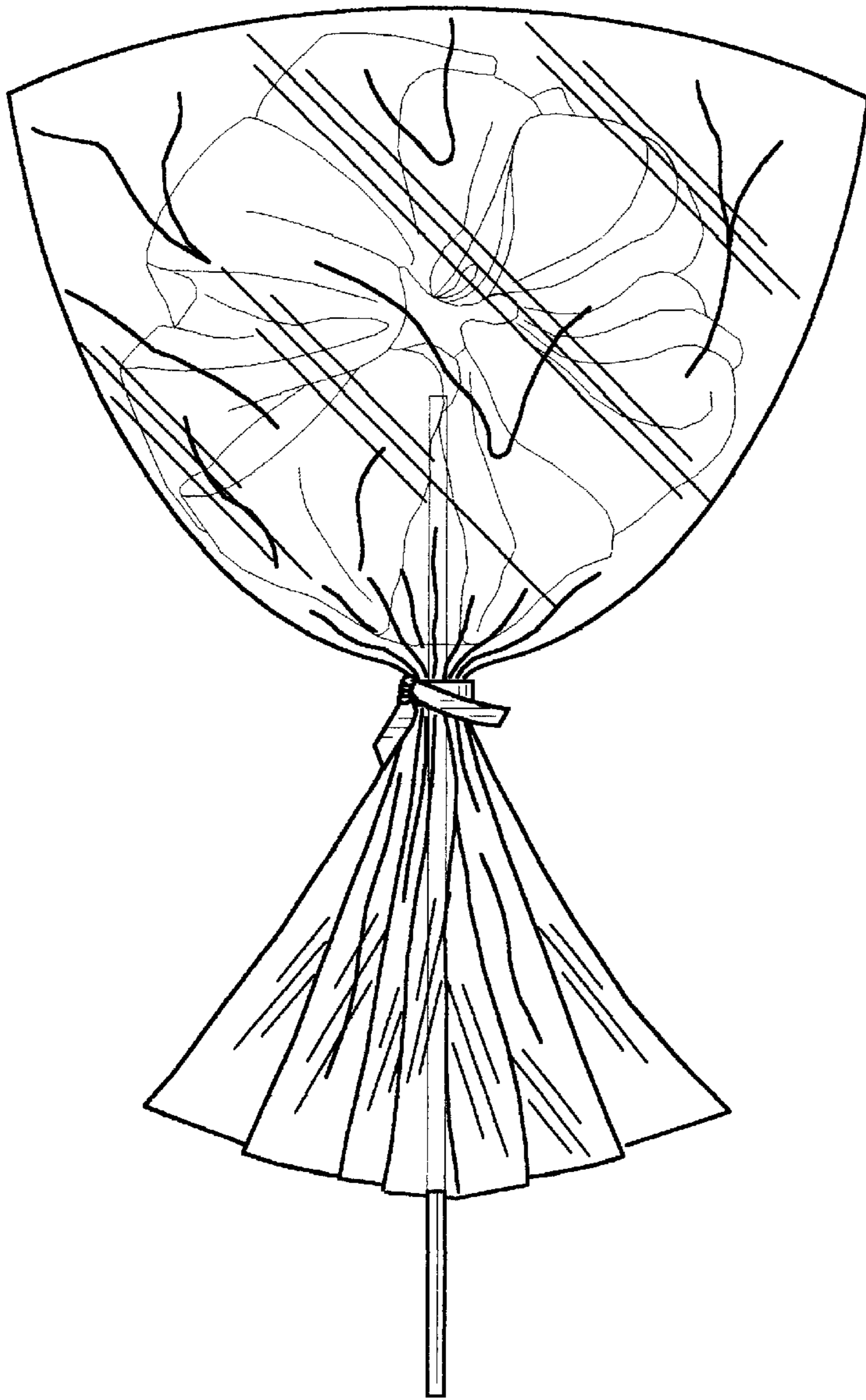

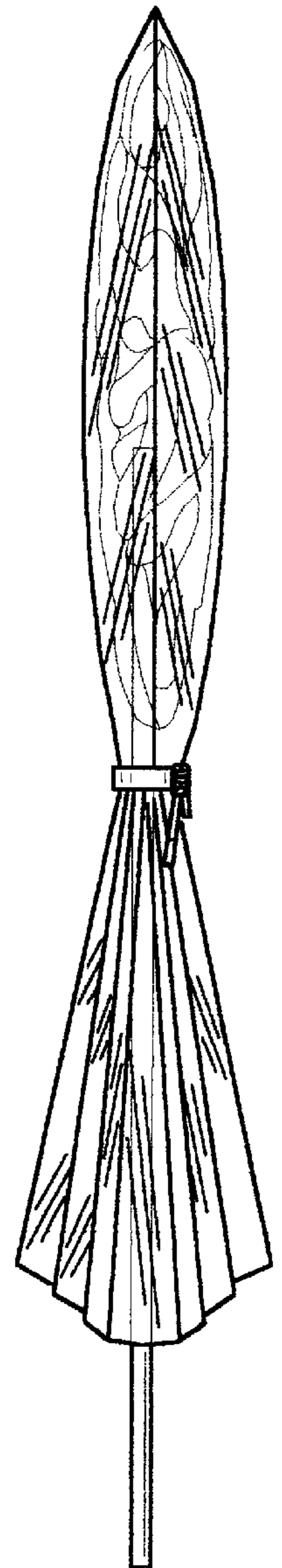

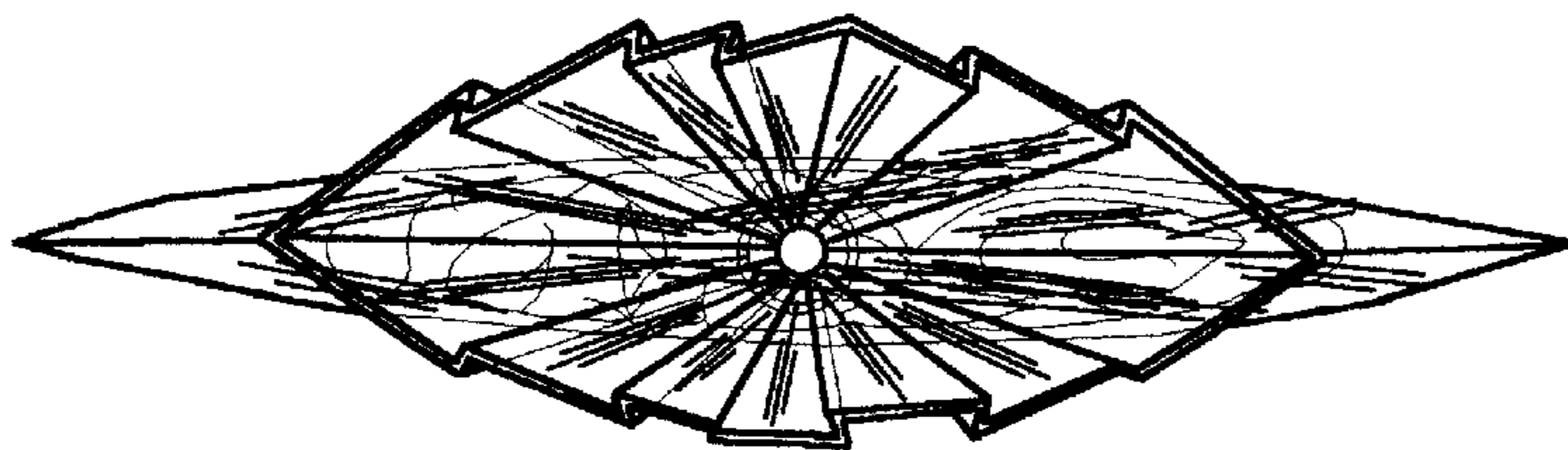
