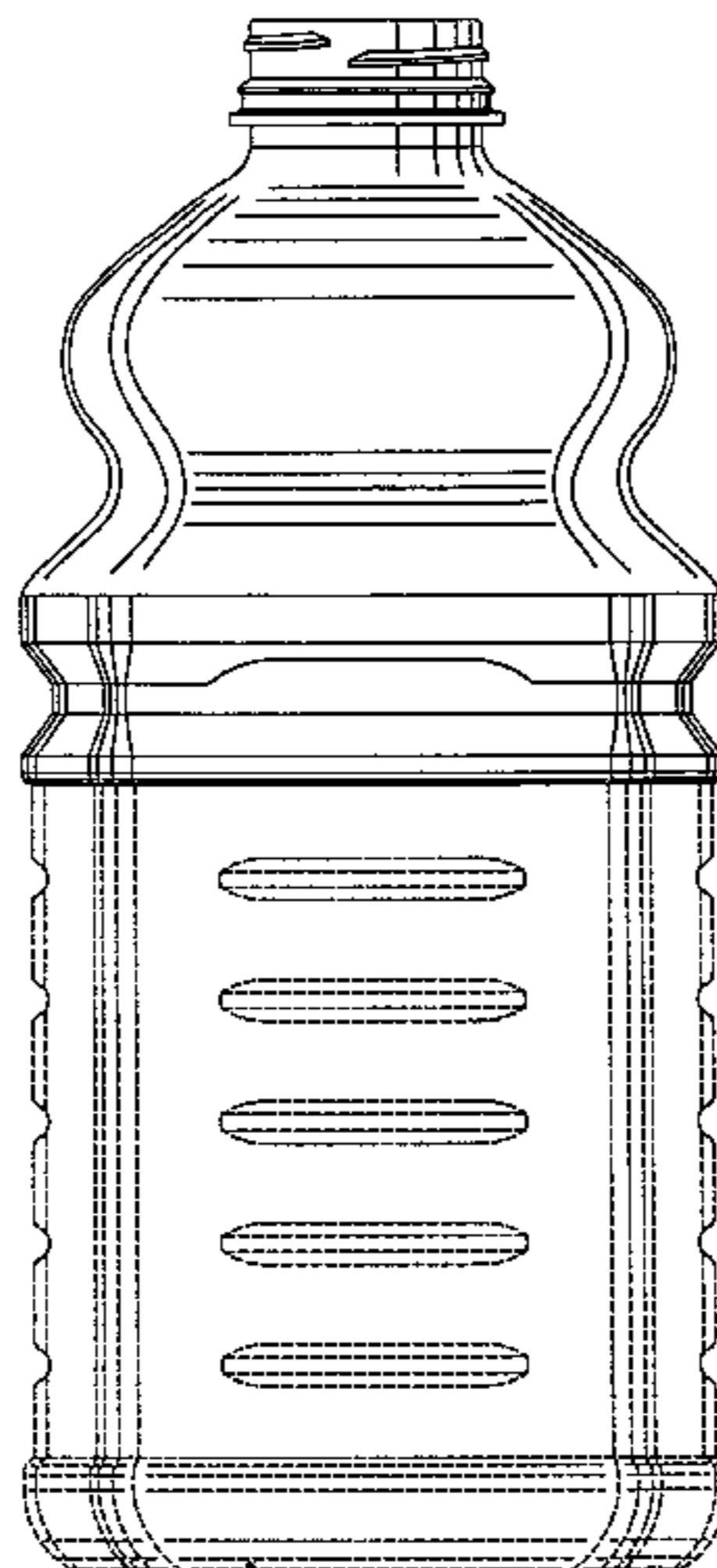
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the container, the opposite side view being a mirror image thereof;
FIG. 2 is a front view thereof, the opposite rear view being a mirror image thereof;
FIG. 3 is a top view thereof; and,
FIG. 4 is a bottom view thereof.
The broken line portions of the container shown in FIGS. 1, 2, 3 and 4 are for illustrative purposes only and form no part of the claimed design.

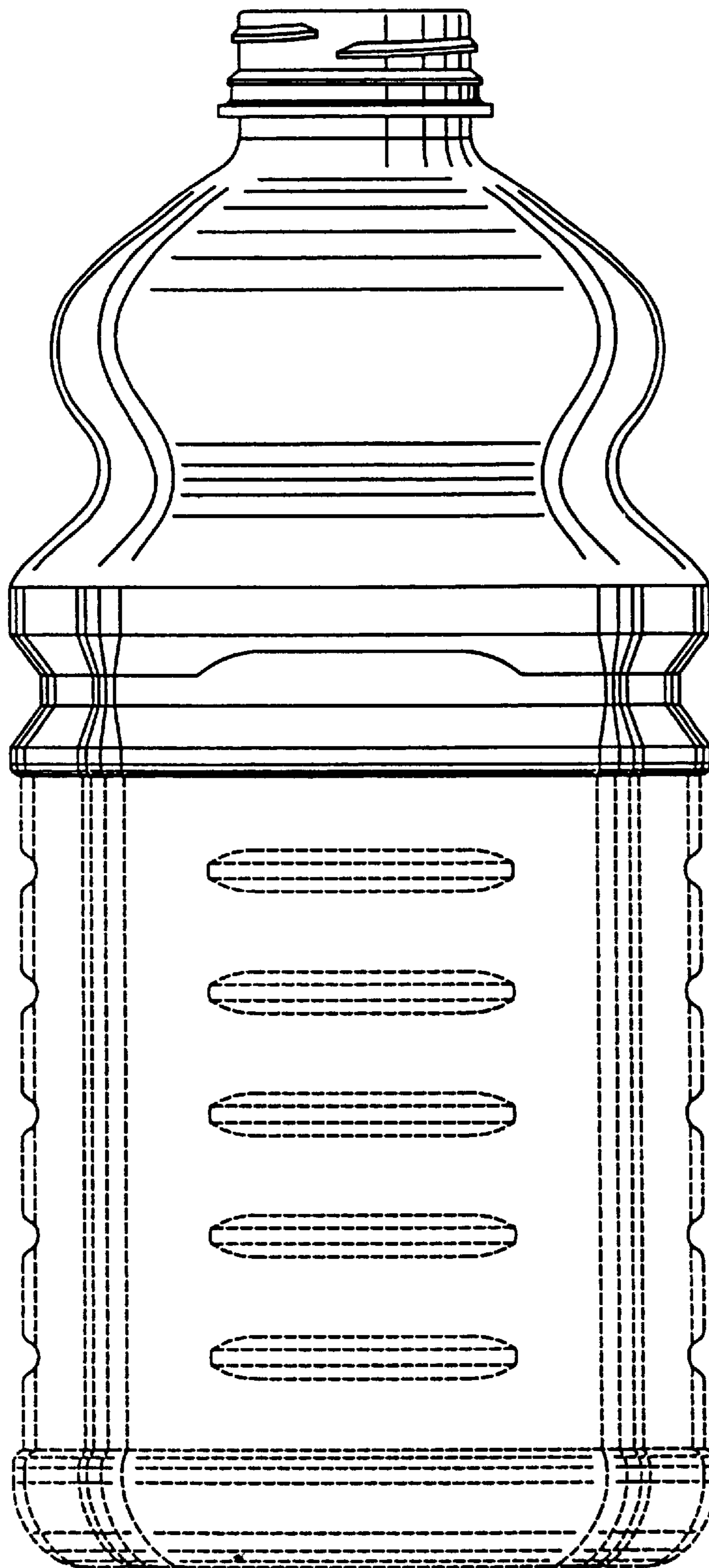

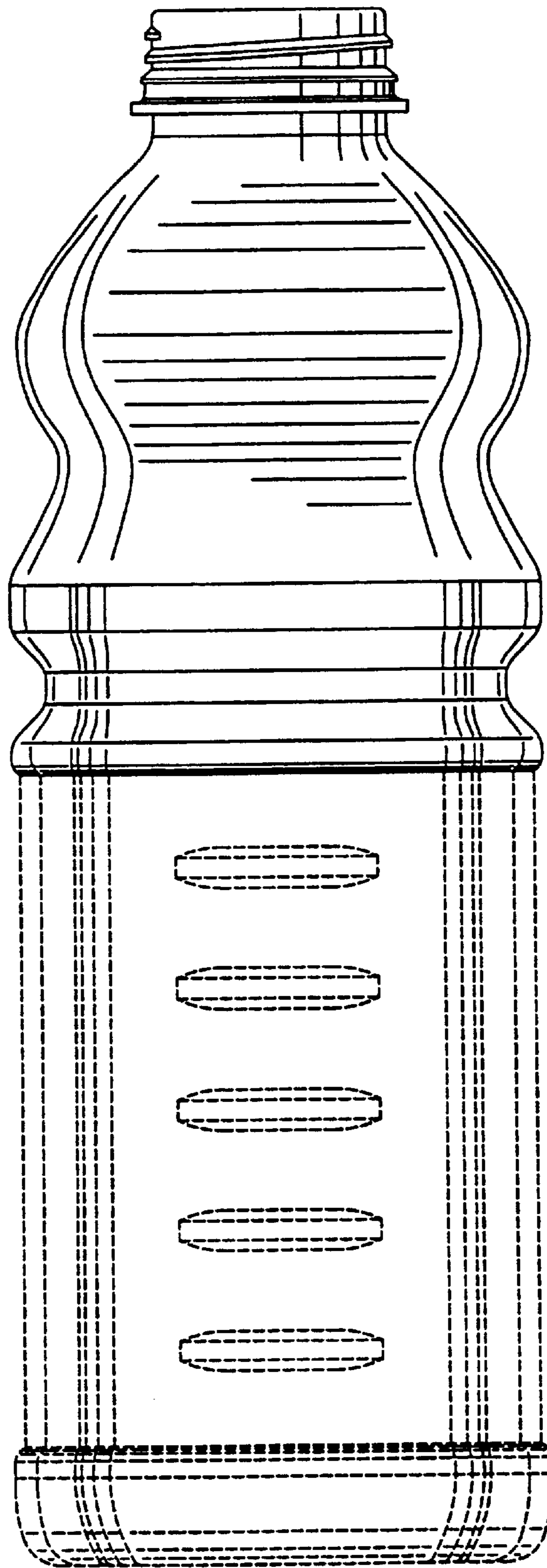

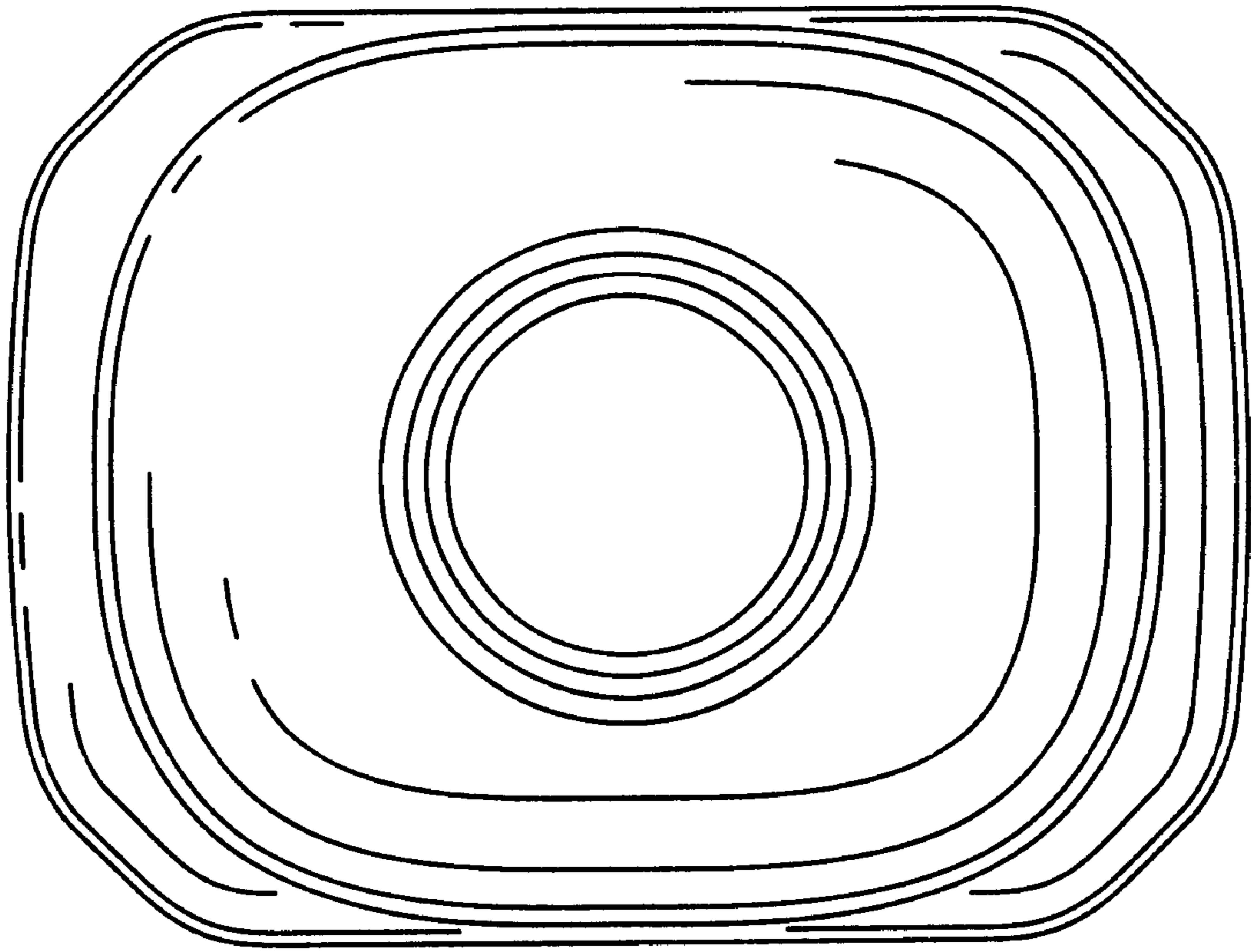

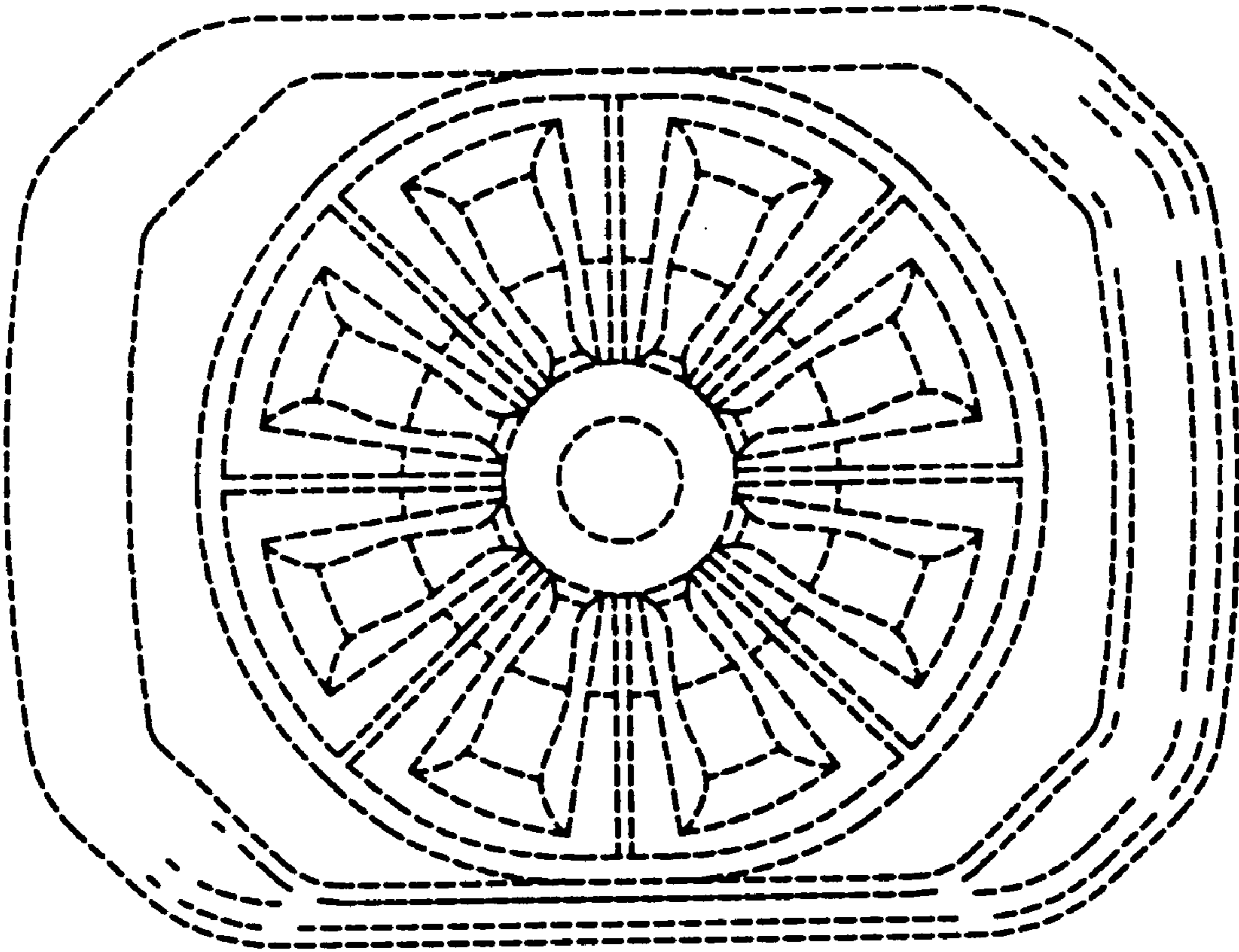
