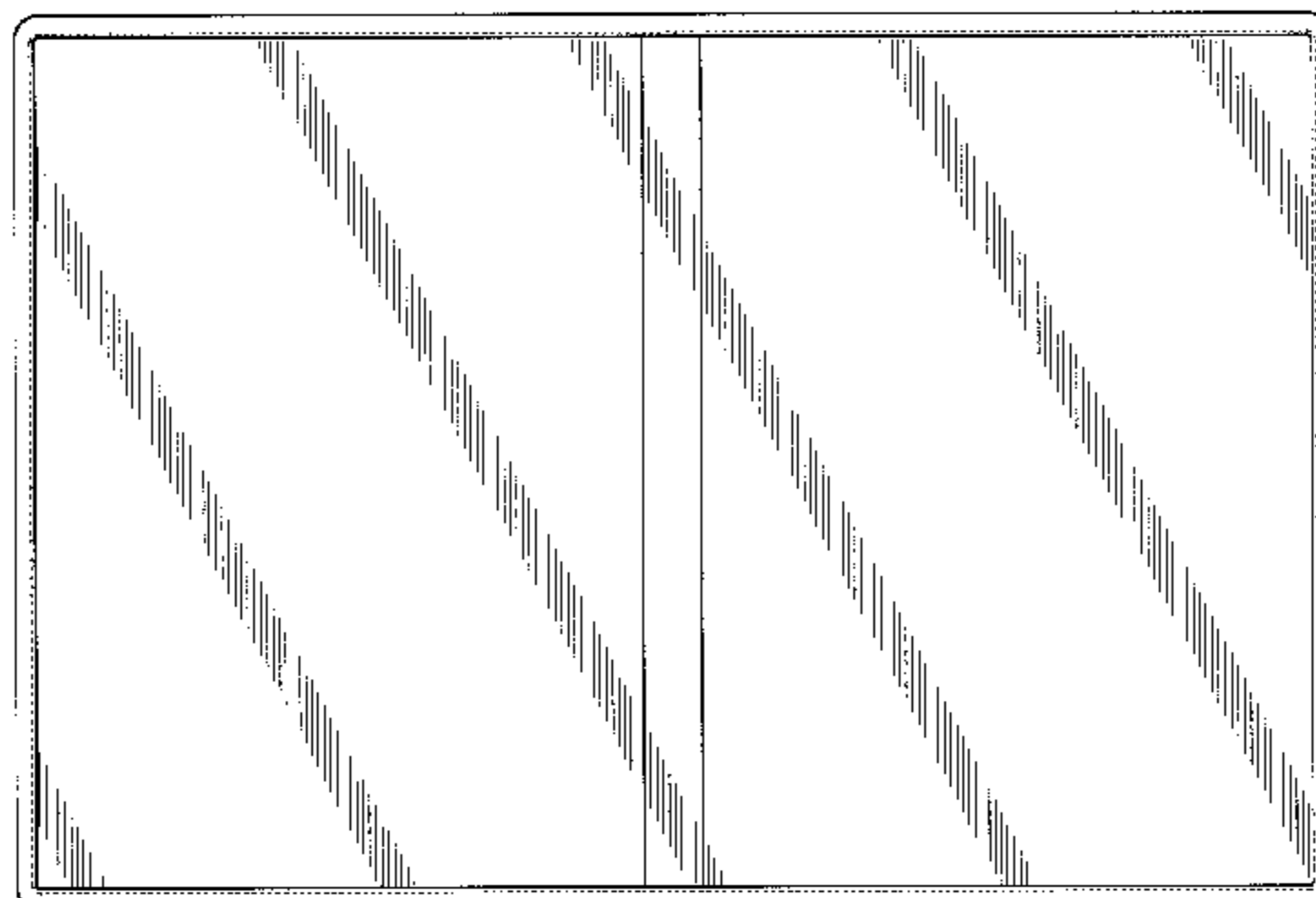
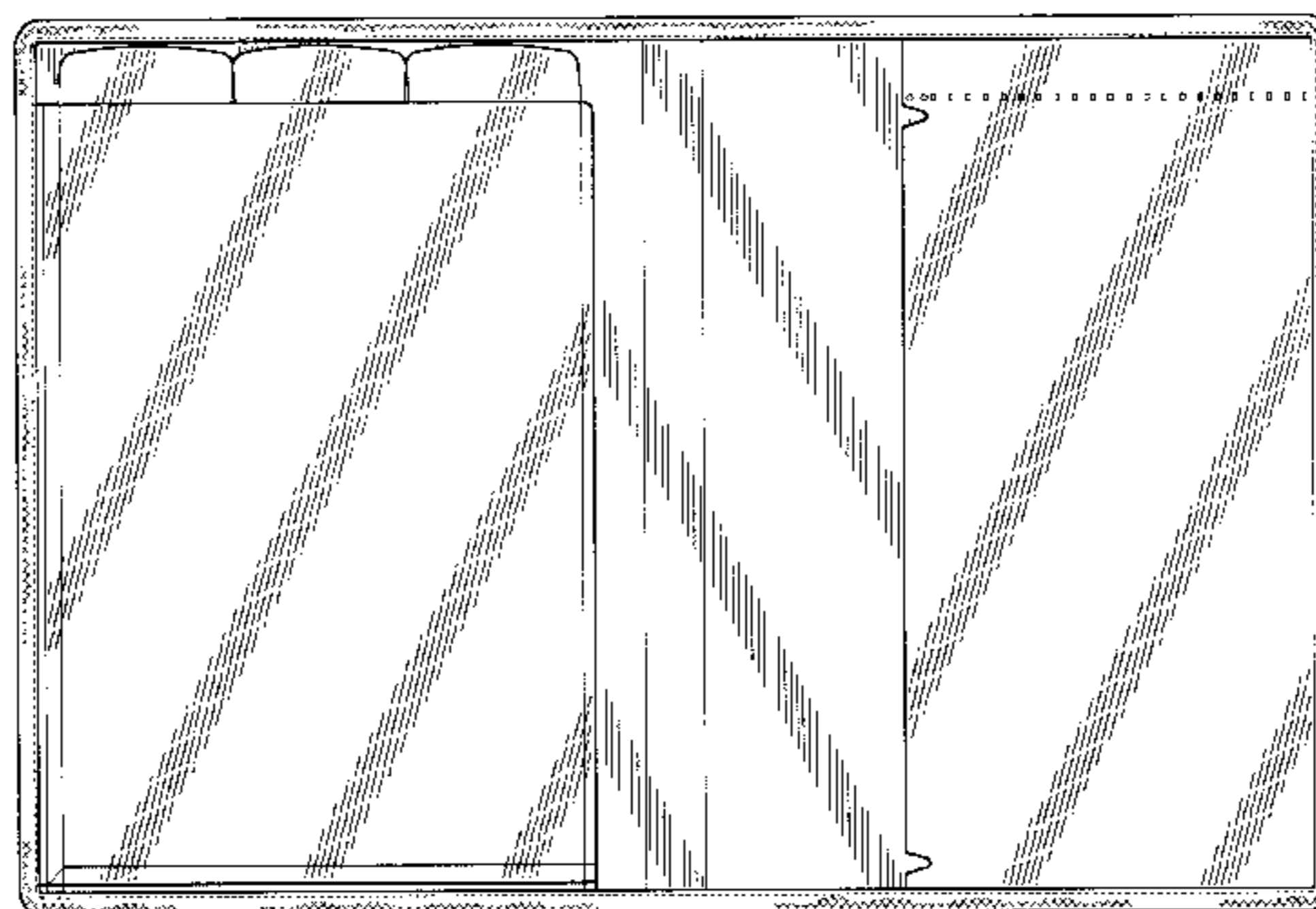
(57) **CLAIM**

The ornamental design for a notebook organizer, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the notebook organizer of the present invention, shown in its open position; FIG. 2 is a front view of the notebook organizer of FIG. 1; FIG. 3 is a top end view of the notebook organizer of FIG. 1; FIG. 4 is a bottom end view of the notebook organizer of FIG. 1; FIG. 5 is a left side view of the notebook organizer of FIG. 1; FIG. 6 is a right side view of the notebook organizer of FIG. 1; and, FIG. 7 is a back view of the notebook organizer of FIG. 1.

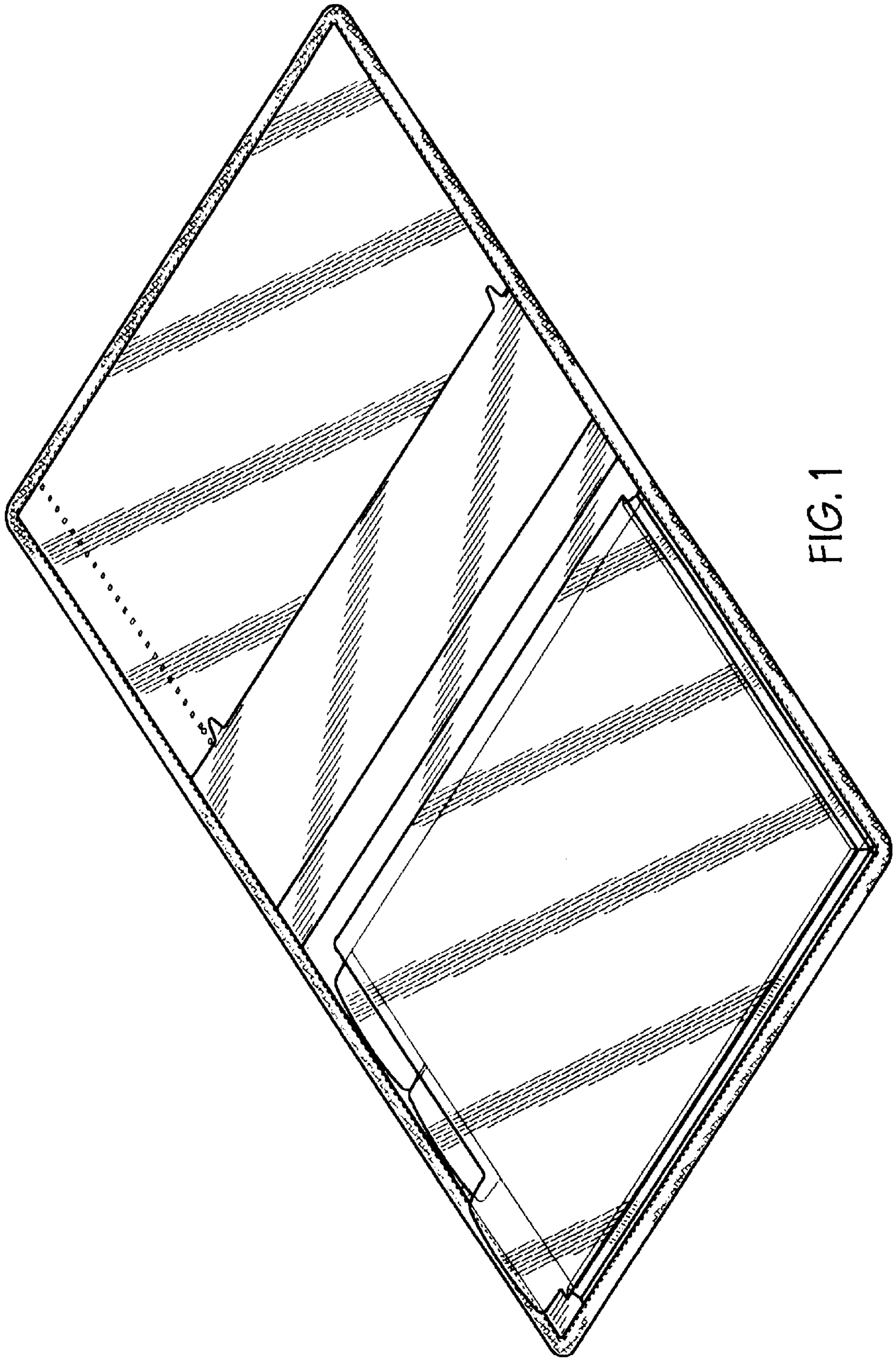

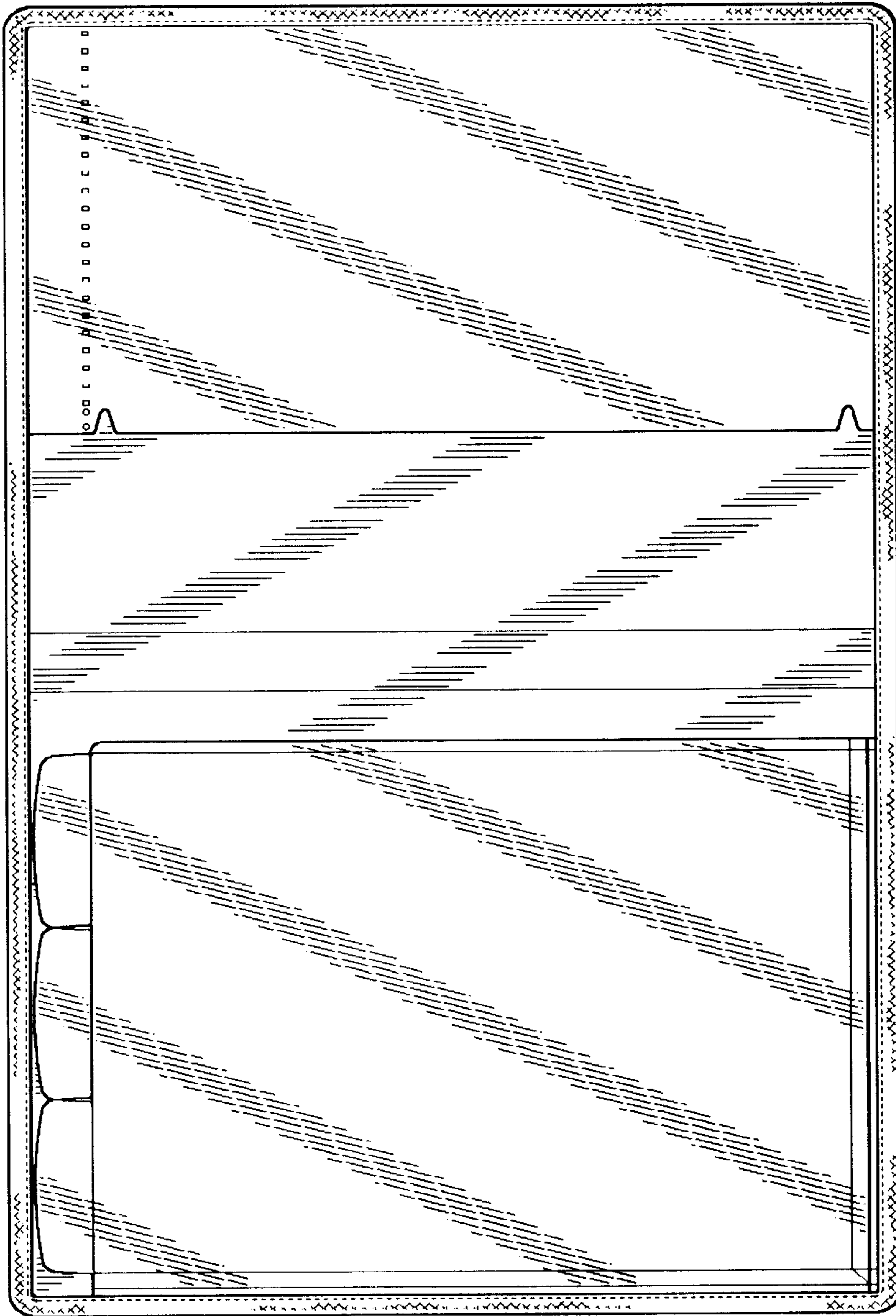

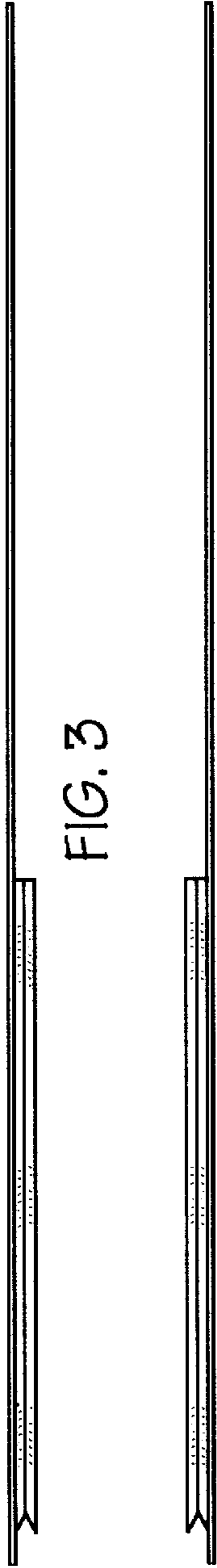

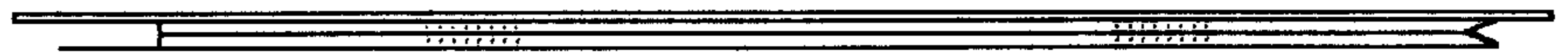

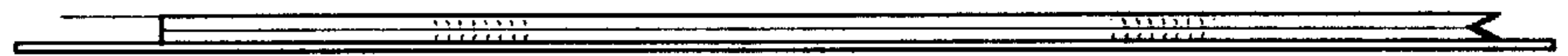

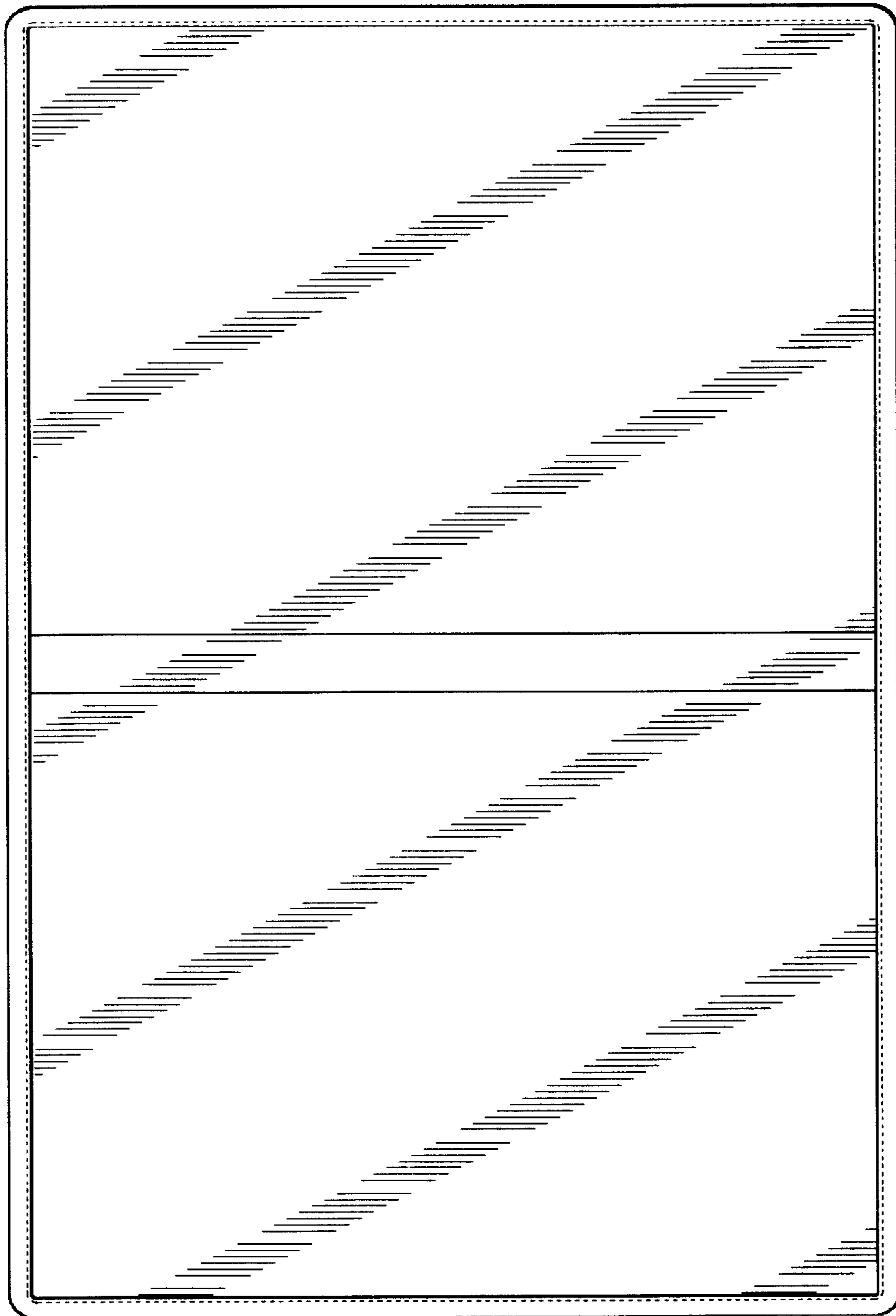
