(57) **CLAIM**

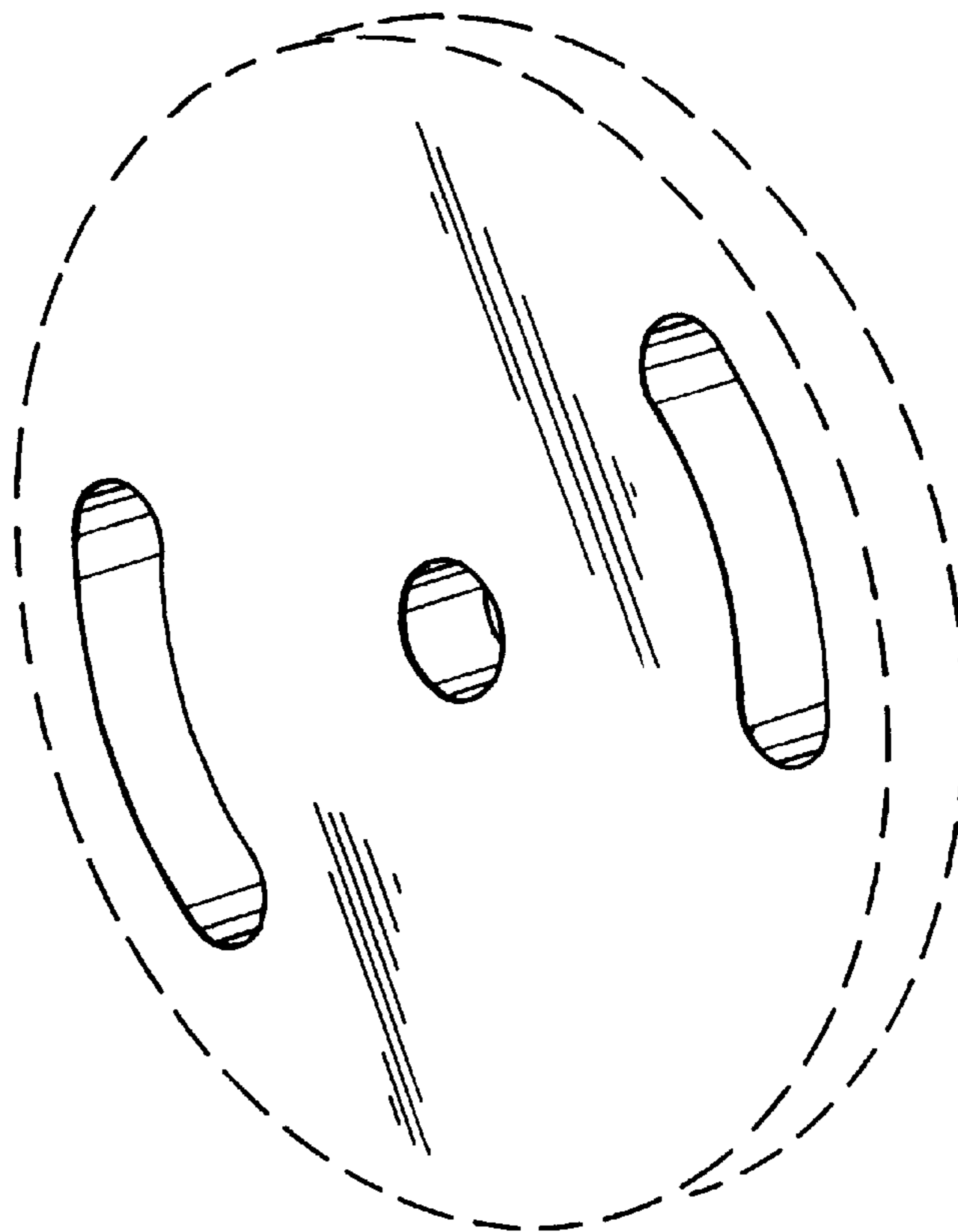
The ornamental design for a plate having two elongated hand grips, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a plate having two elongated hand grips showing our new design; and, FIG. 2 is a front view of the plate having two elongated hand grips shown in FIG. 1, the rear view being a mirror image thereof.

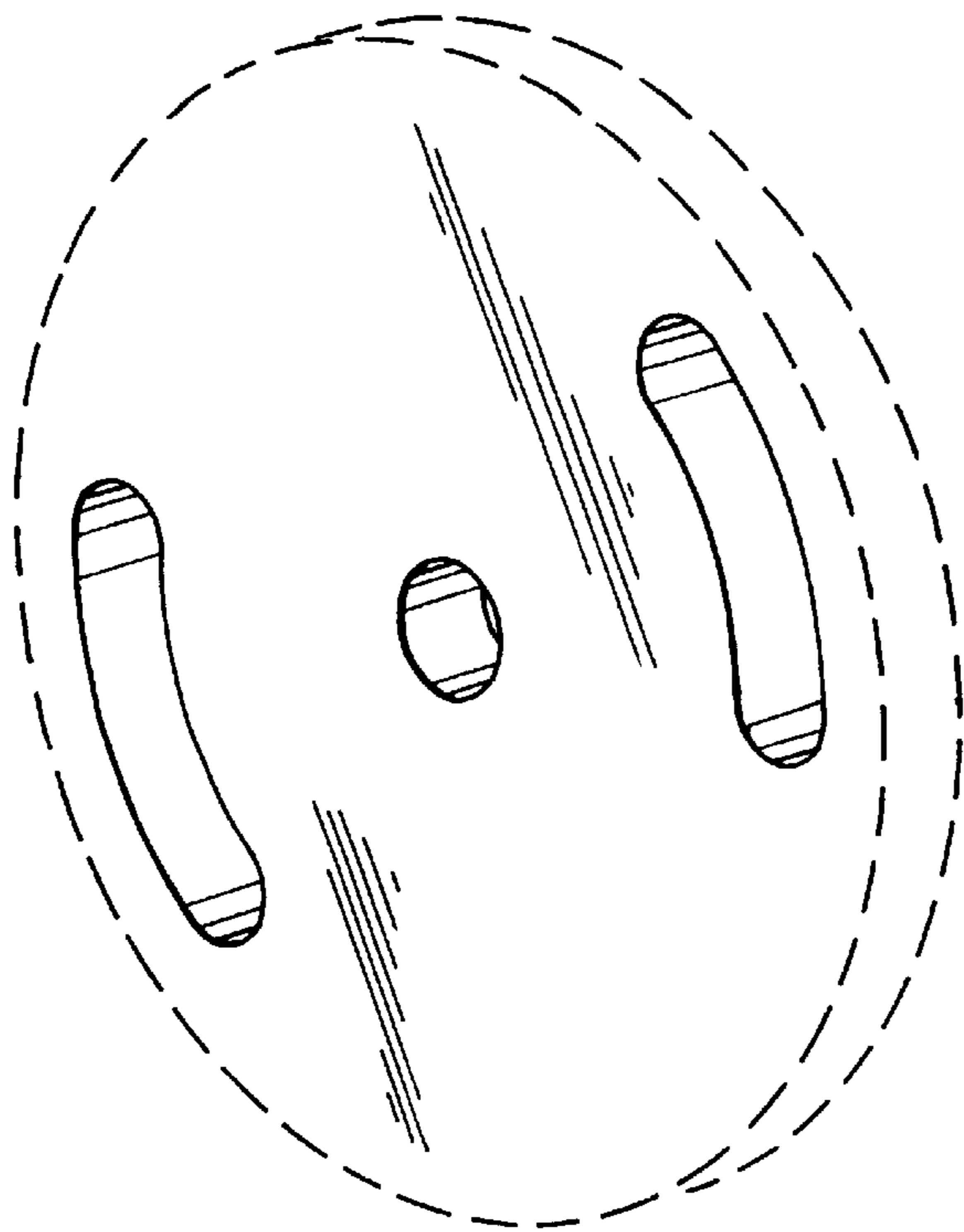
