FIG. 5 is a bottom plan view of the decorative and reversible ceiling fan blade of FIG. 1.

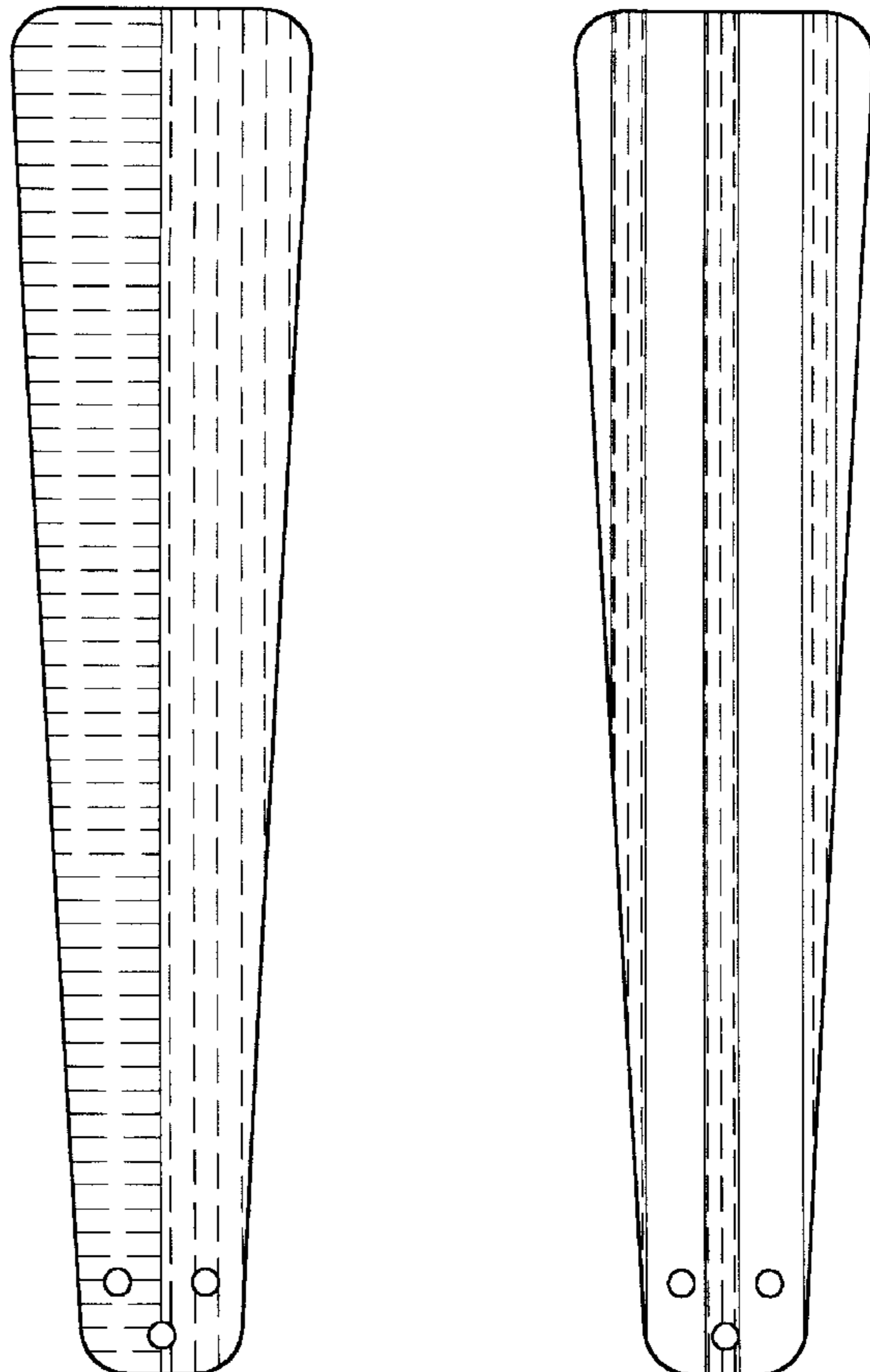
The broken line showing of environmental structure in FIGS. 1 and 2 is for illustrative purposes only and forms no part of the claimed design.

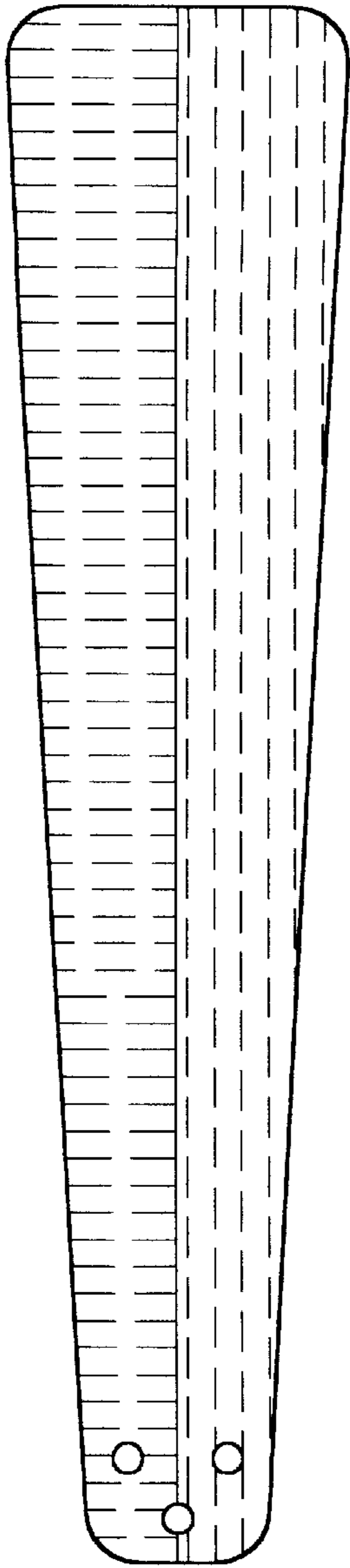

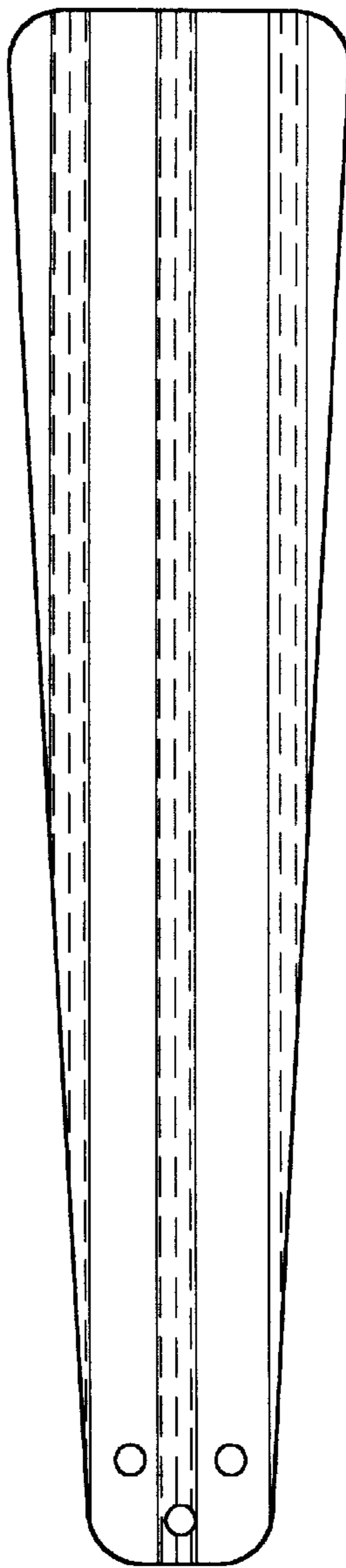

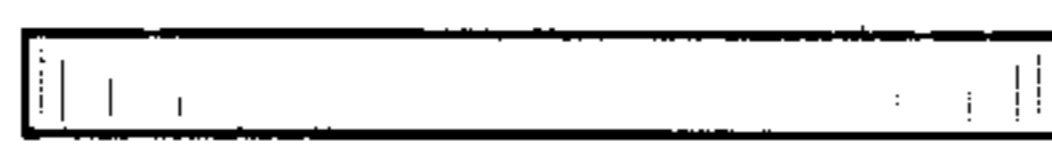

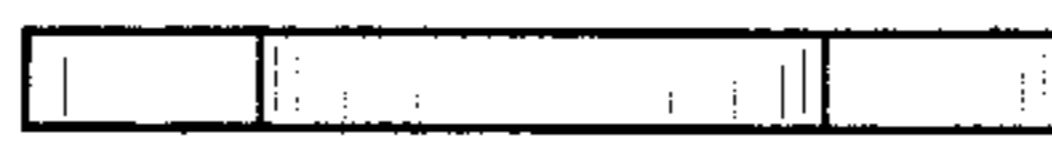
