The ornamental design for a therapeutic cushion, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the therapeutic cushion of the present invention;

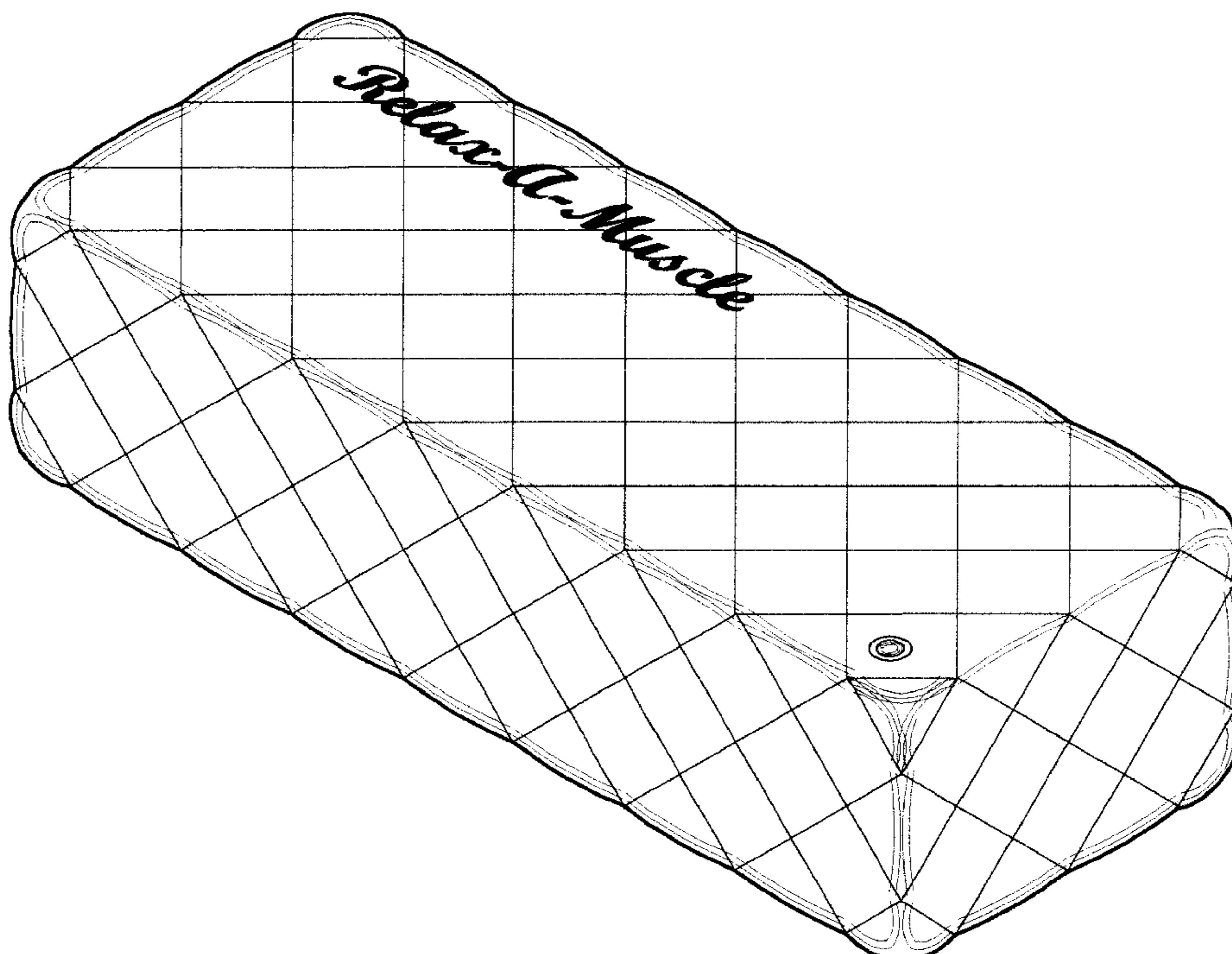
FIG. 2 is a rear elevational view of the therapeutic cushion of FIG. 1;

FIG. 3 is a left side elevational view of the therapeutic cushion of FIG. 1, the right view being a mirror image thereof;

FIG. 4 is a top plan view of the therapeutic cushion of FIG. 1, the bottom view being a mirror image thereof; and,

FIG. 5 is a bottom, front, right side perspective view of the therapeutic cushion of FIG. 1.

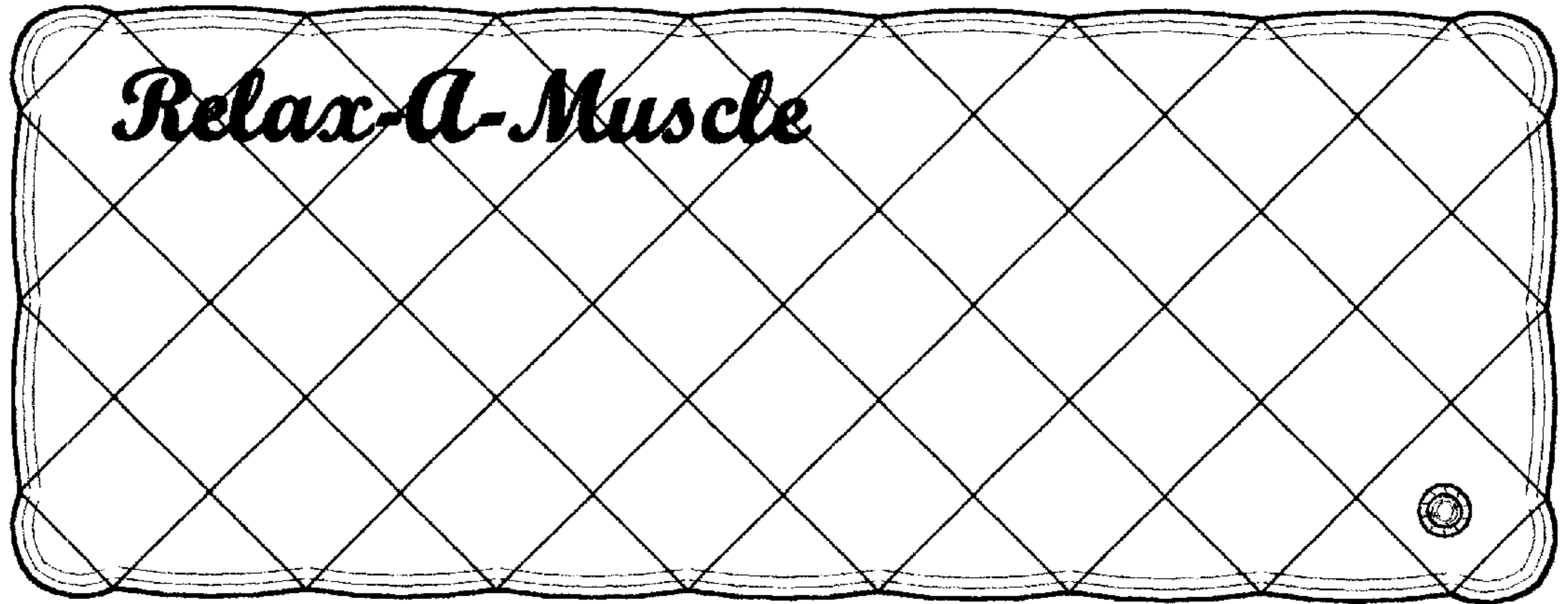

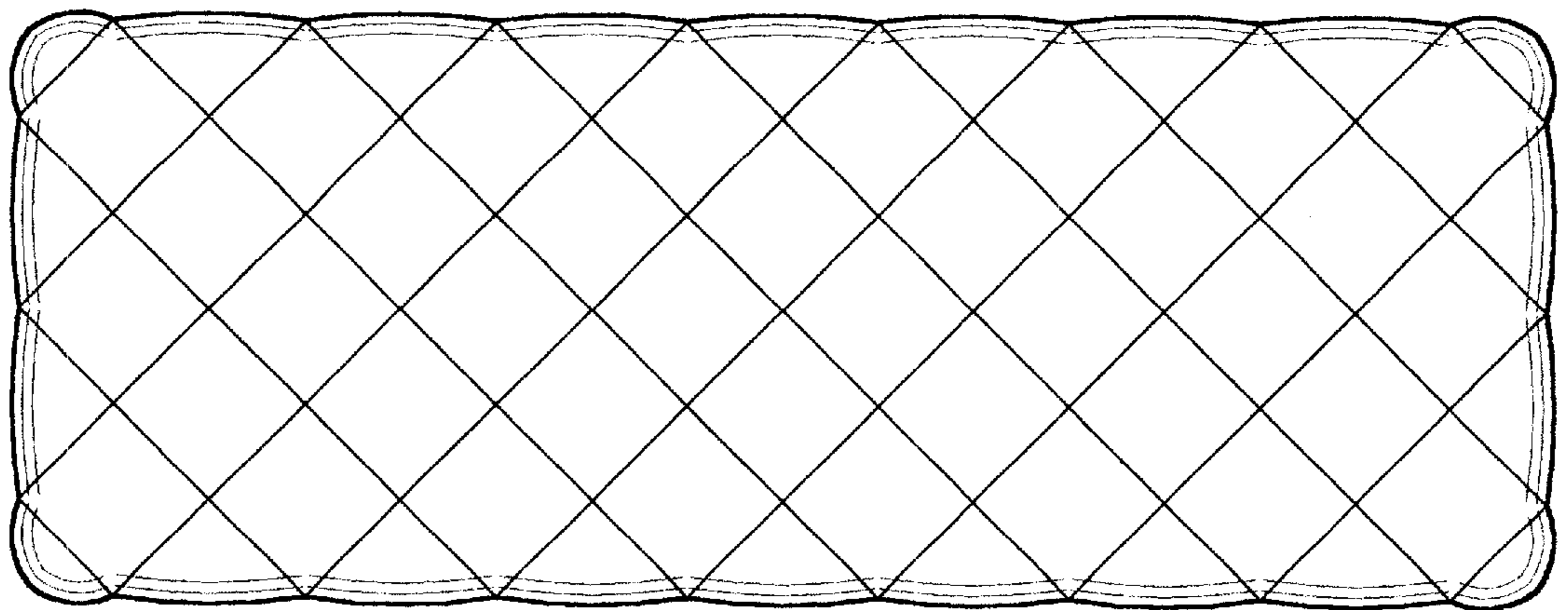

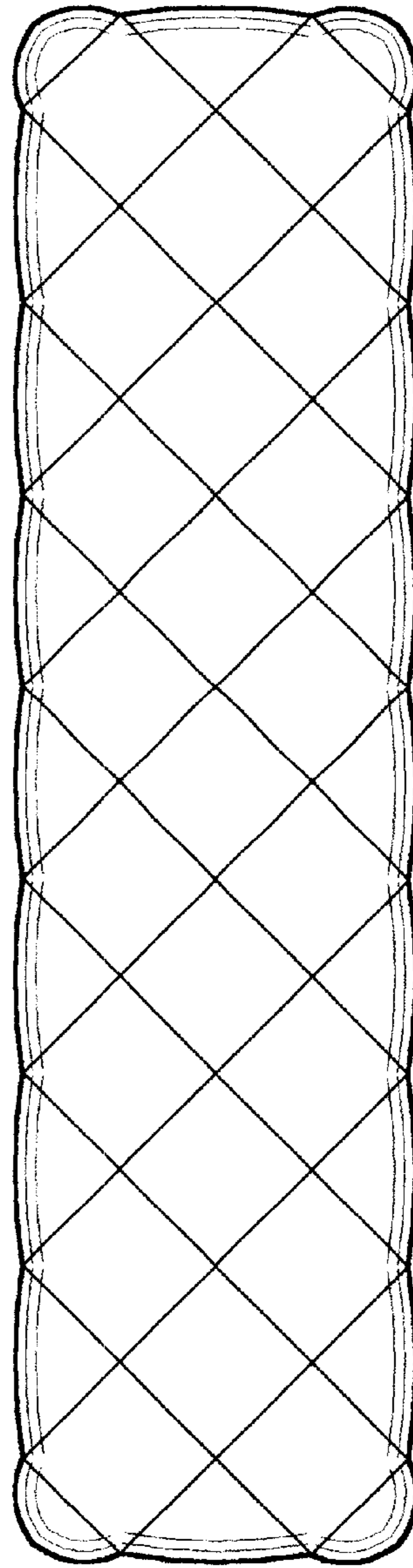
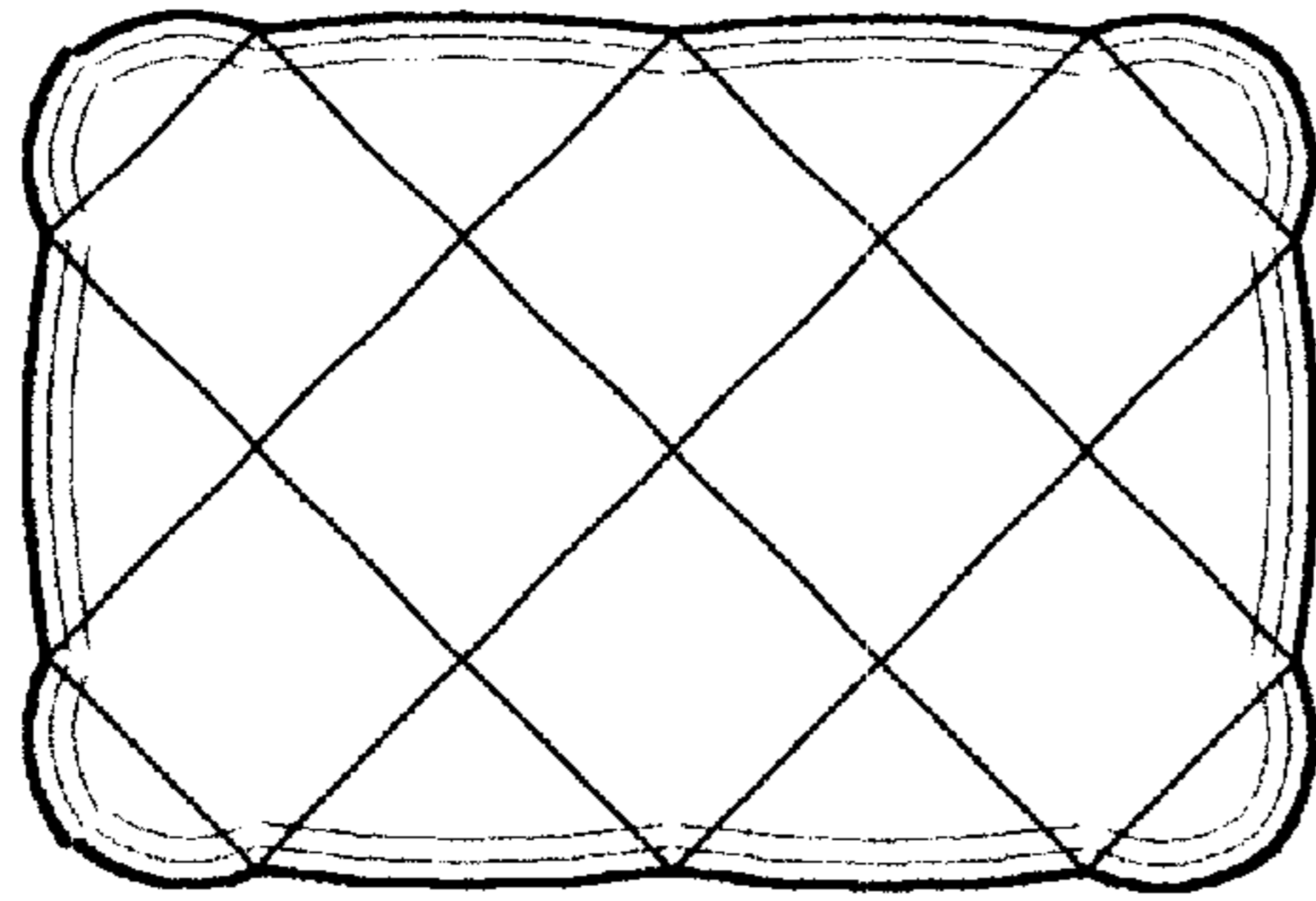

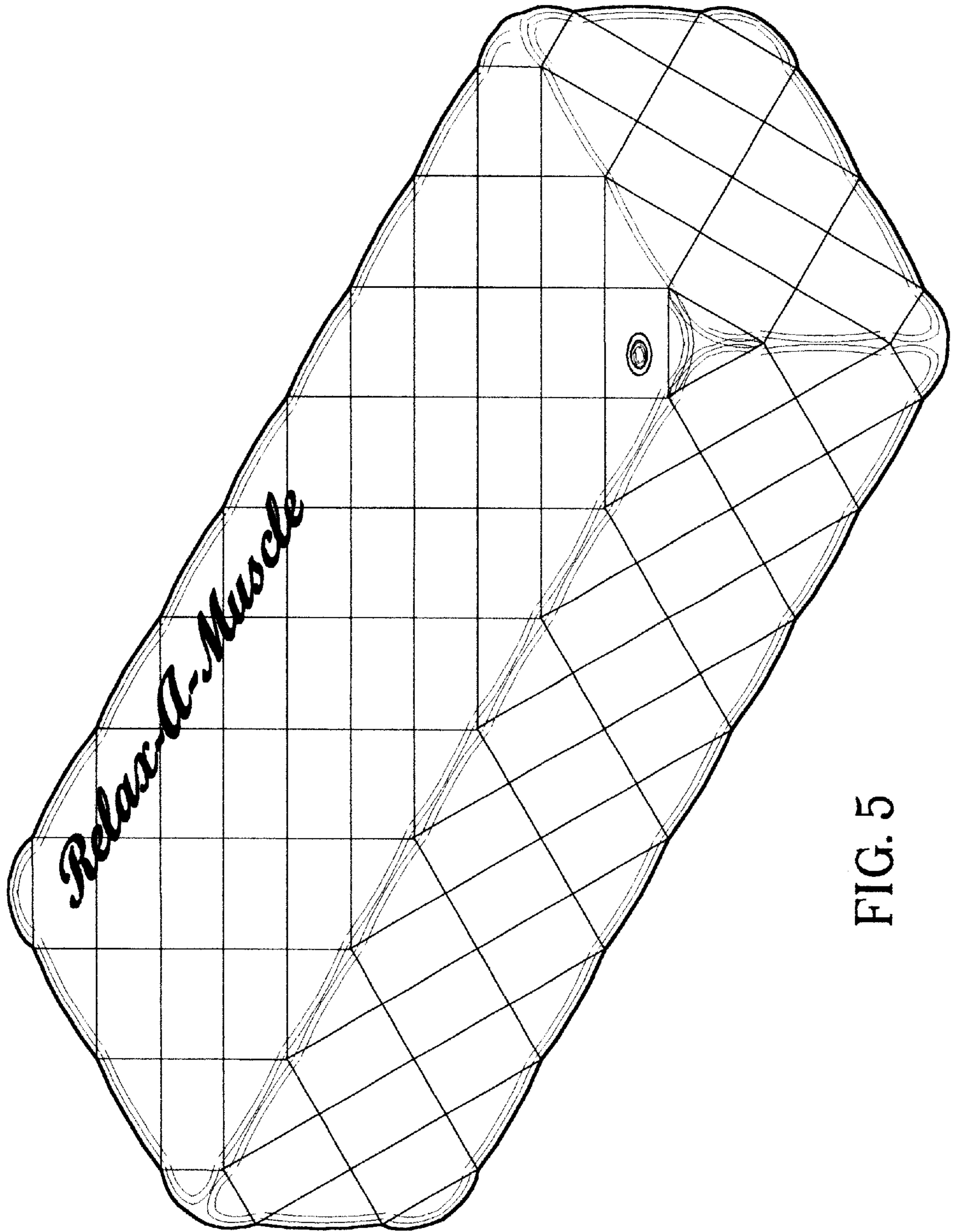
