DESCRIPTION

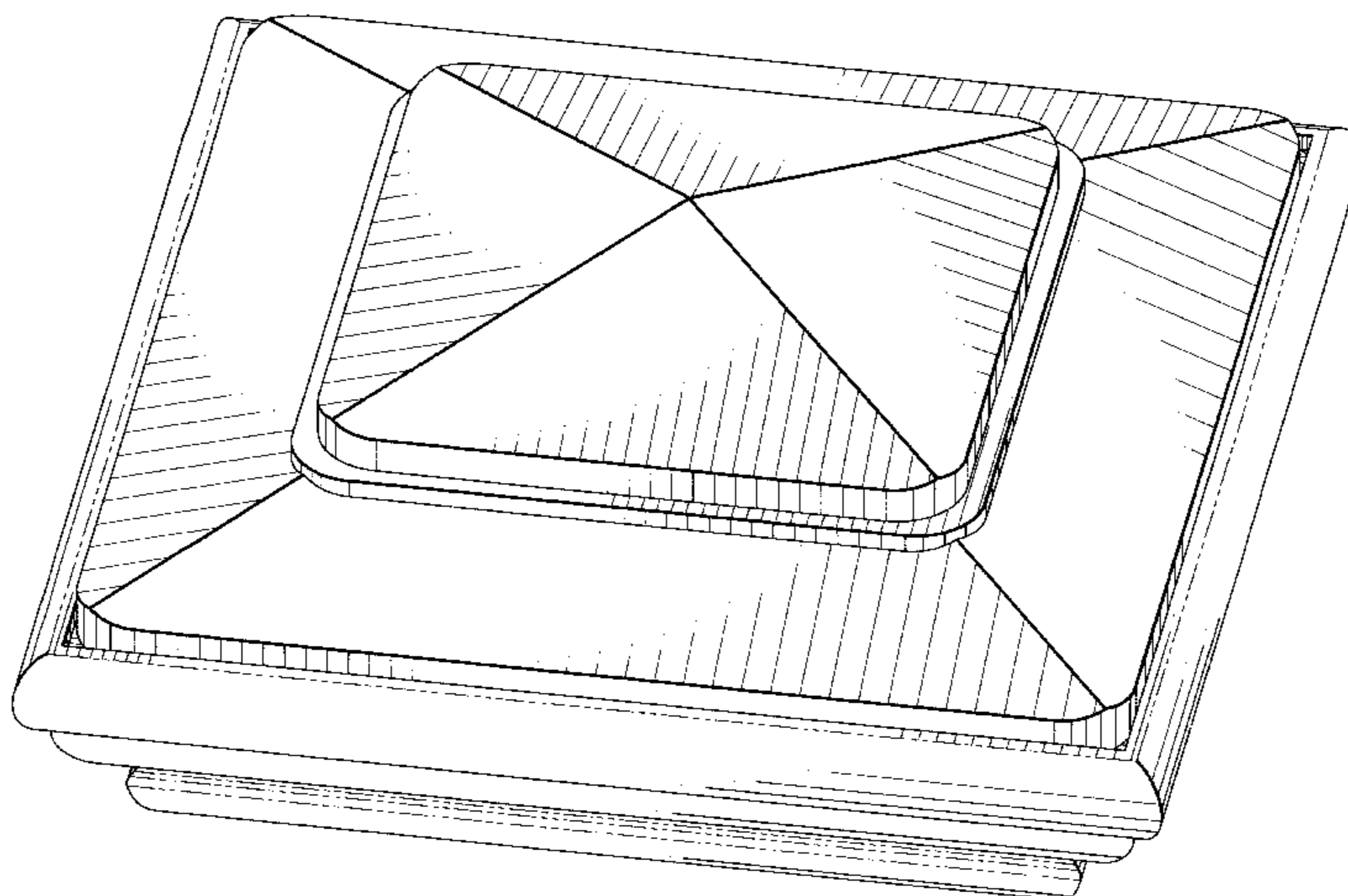
FIG. 1 is a front perspective view showing the stanford deluxe fence post finial of the present invention.

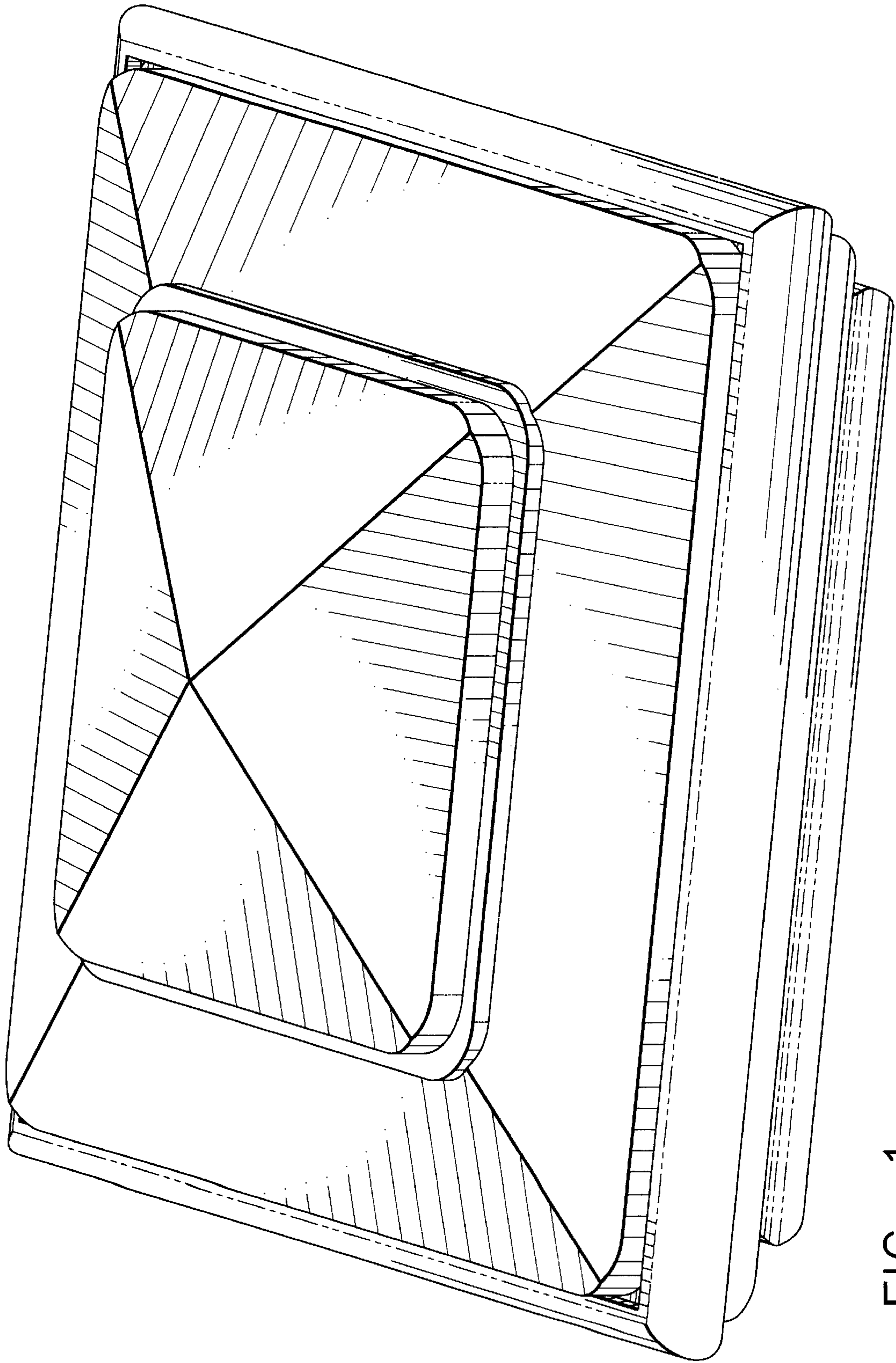

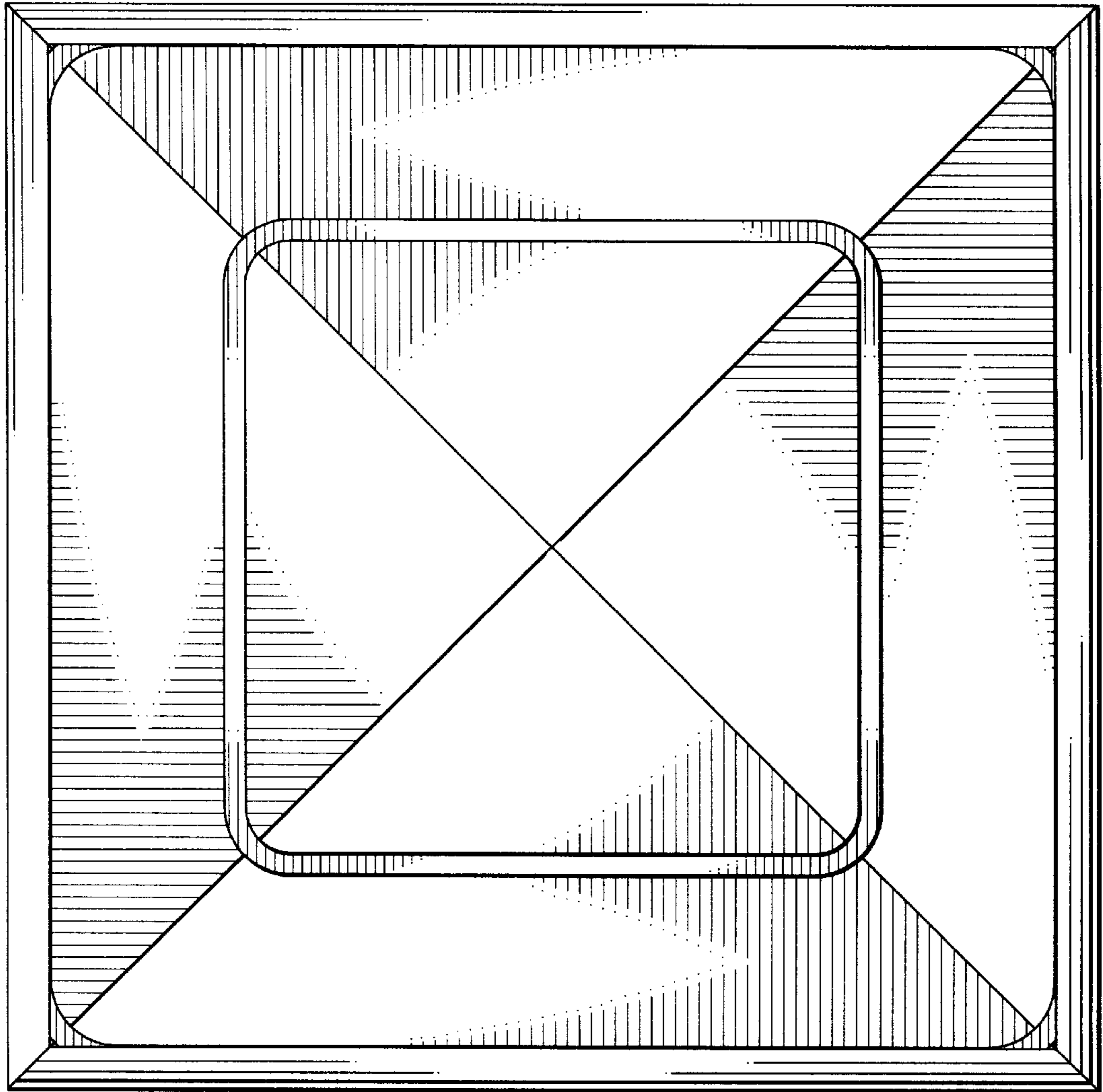

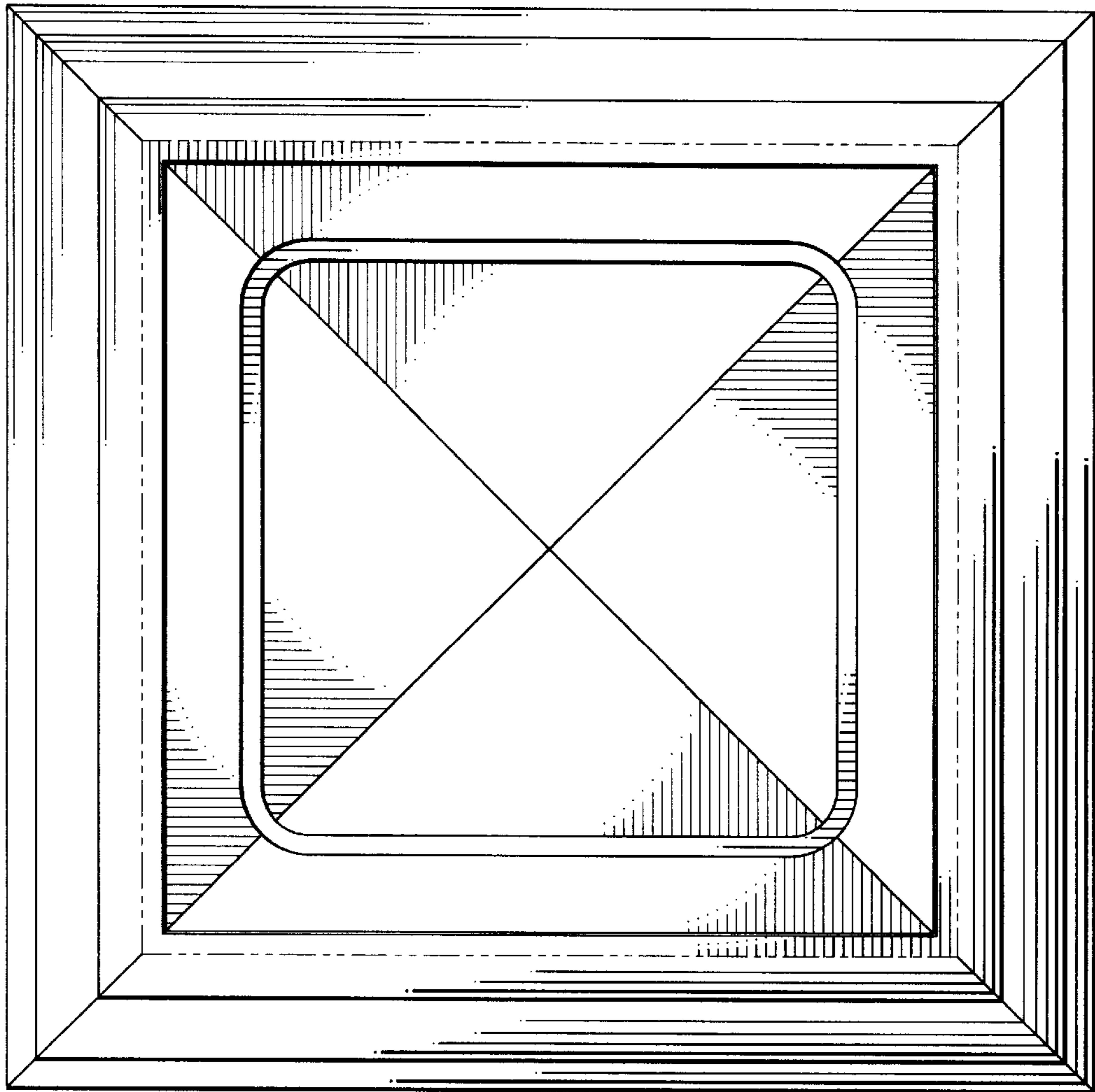

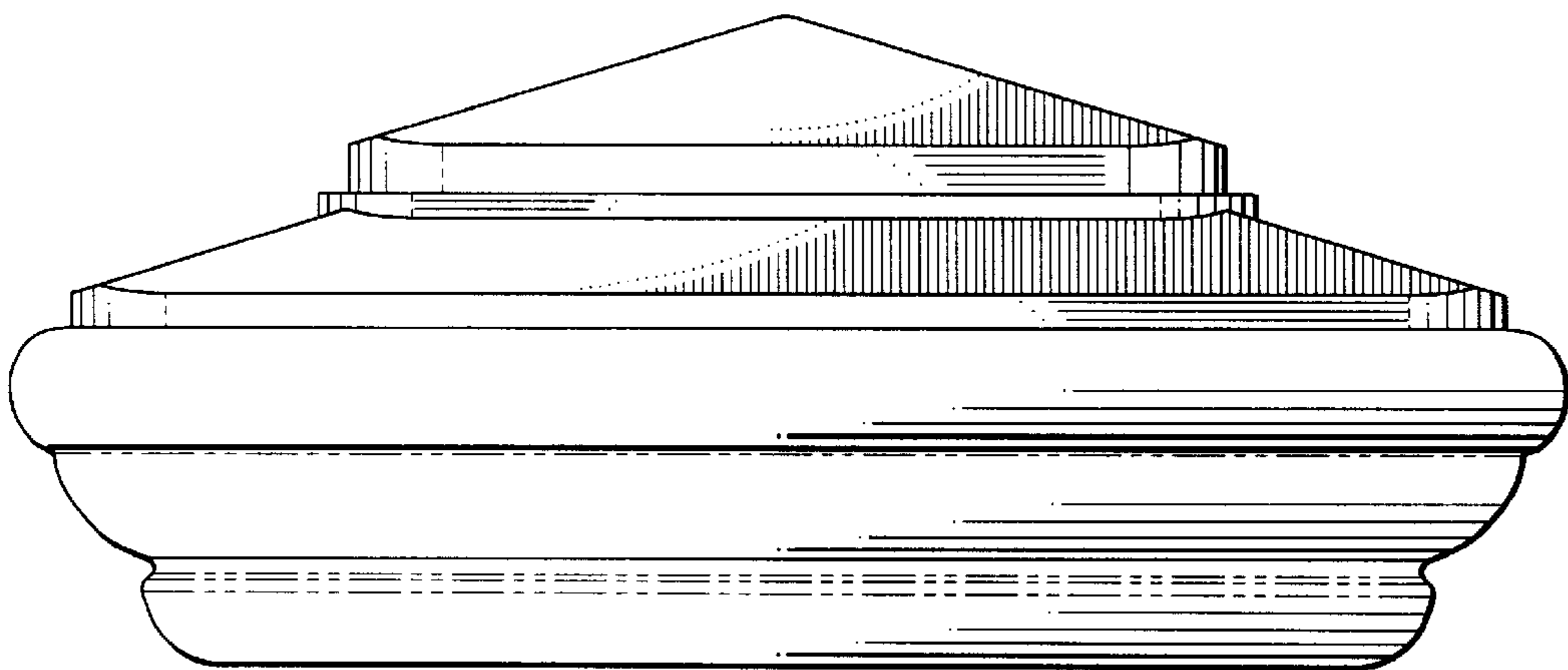
