FIG. 1 is a perspective view of a detergent tablet showing my new design;

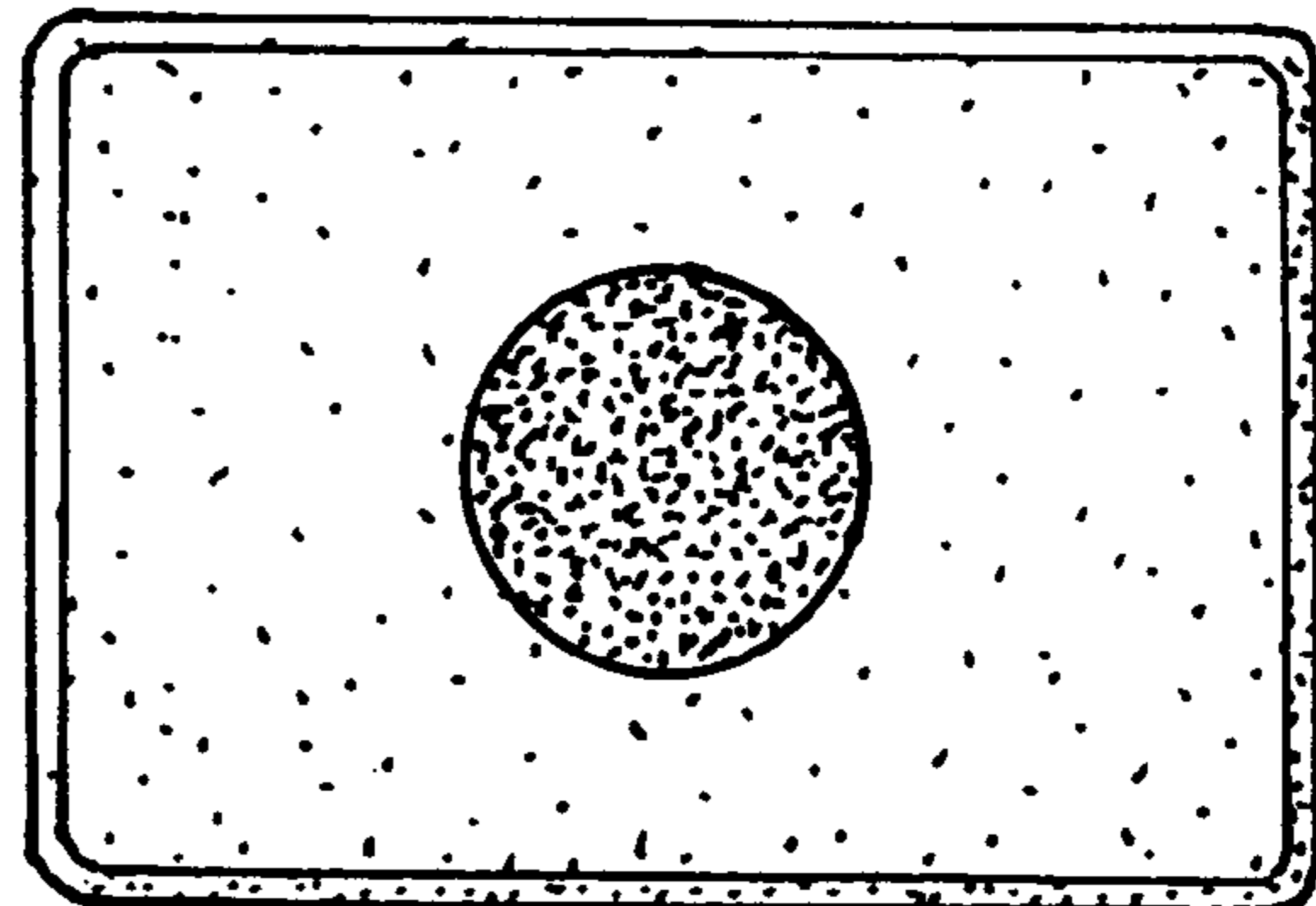
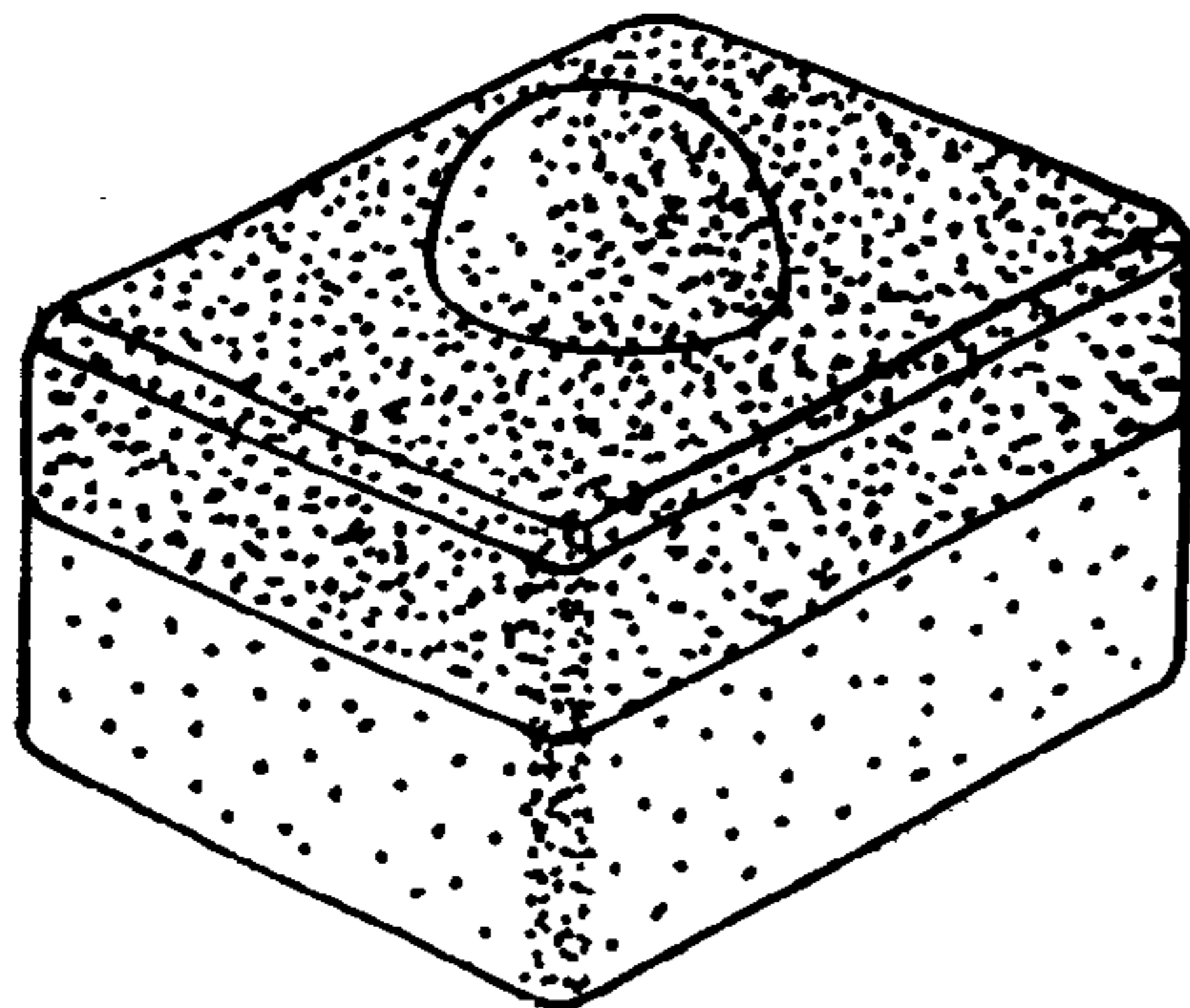
FIG. 2 is a top plan view thereof;

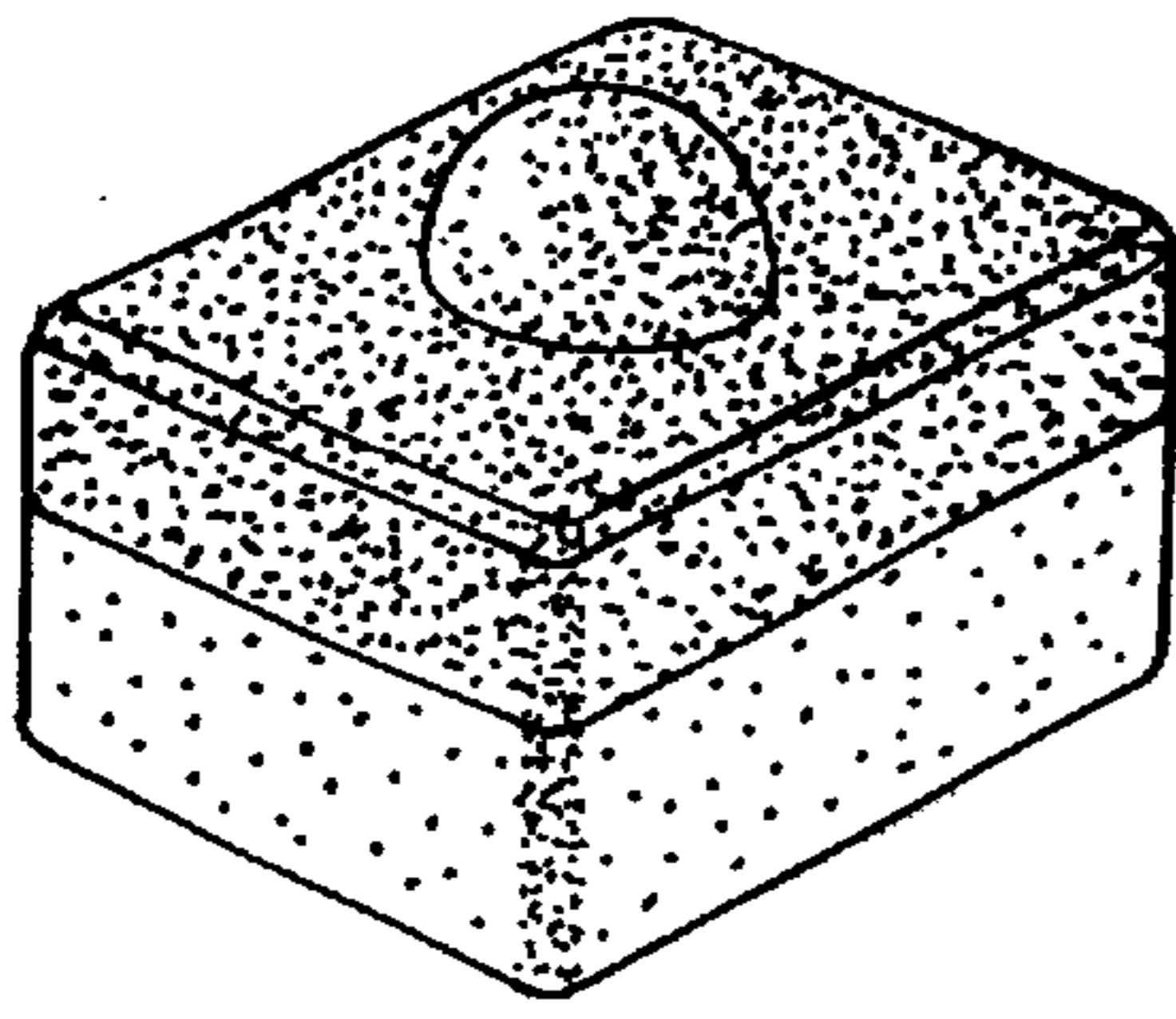
FIG. 3 is a side elevational view thereof;

FIG. 4 is an end elevational view thereof; and,

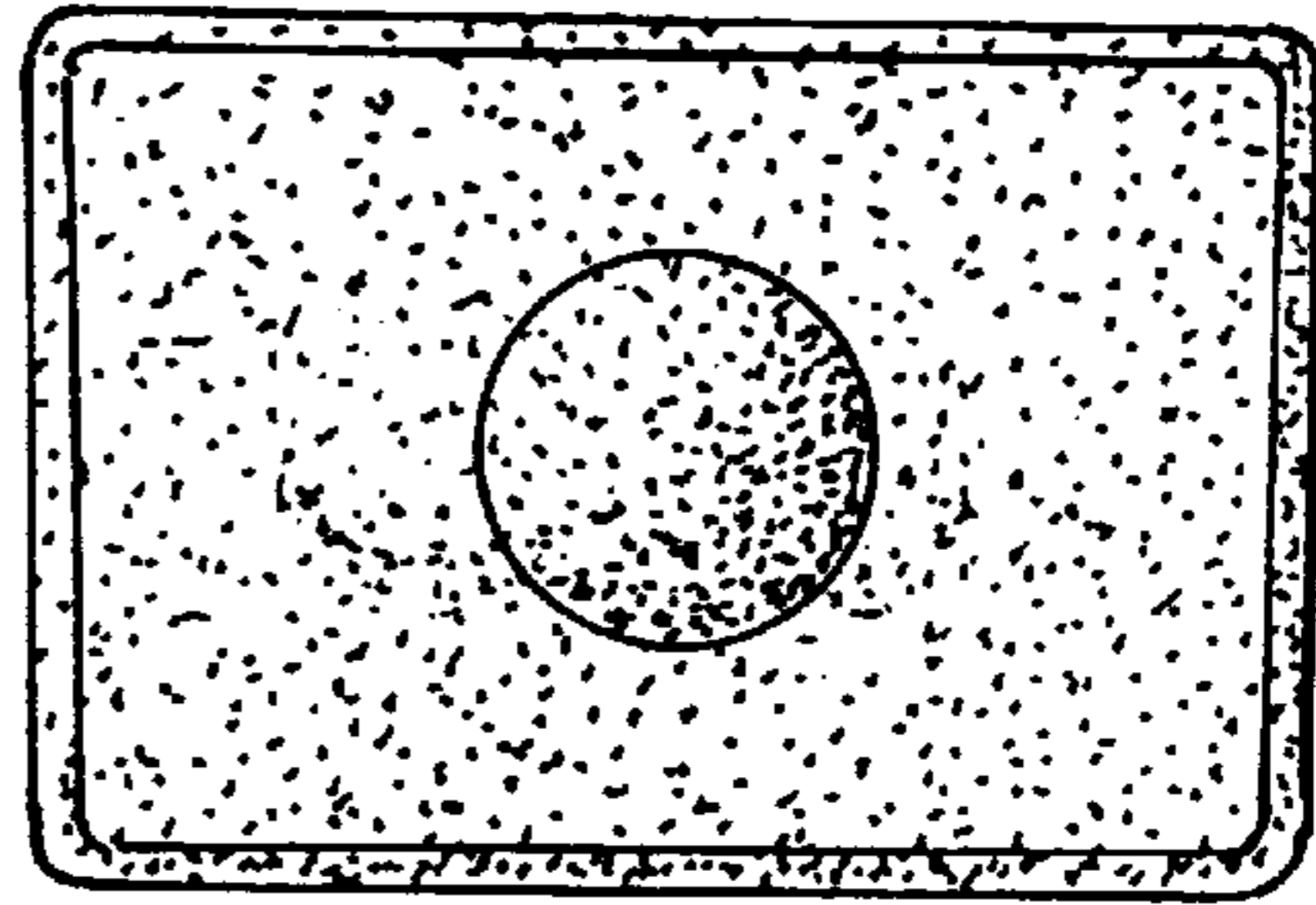
FIG. 5 is a bottom view thereof.

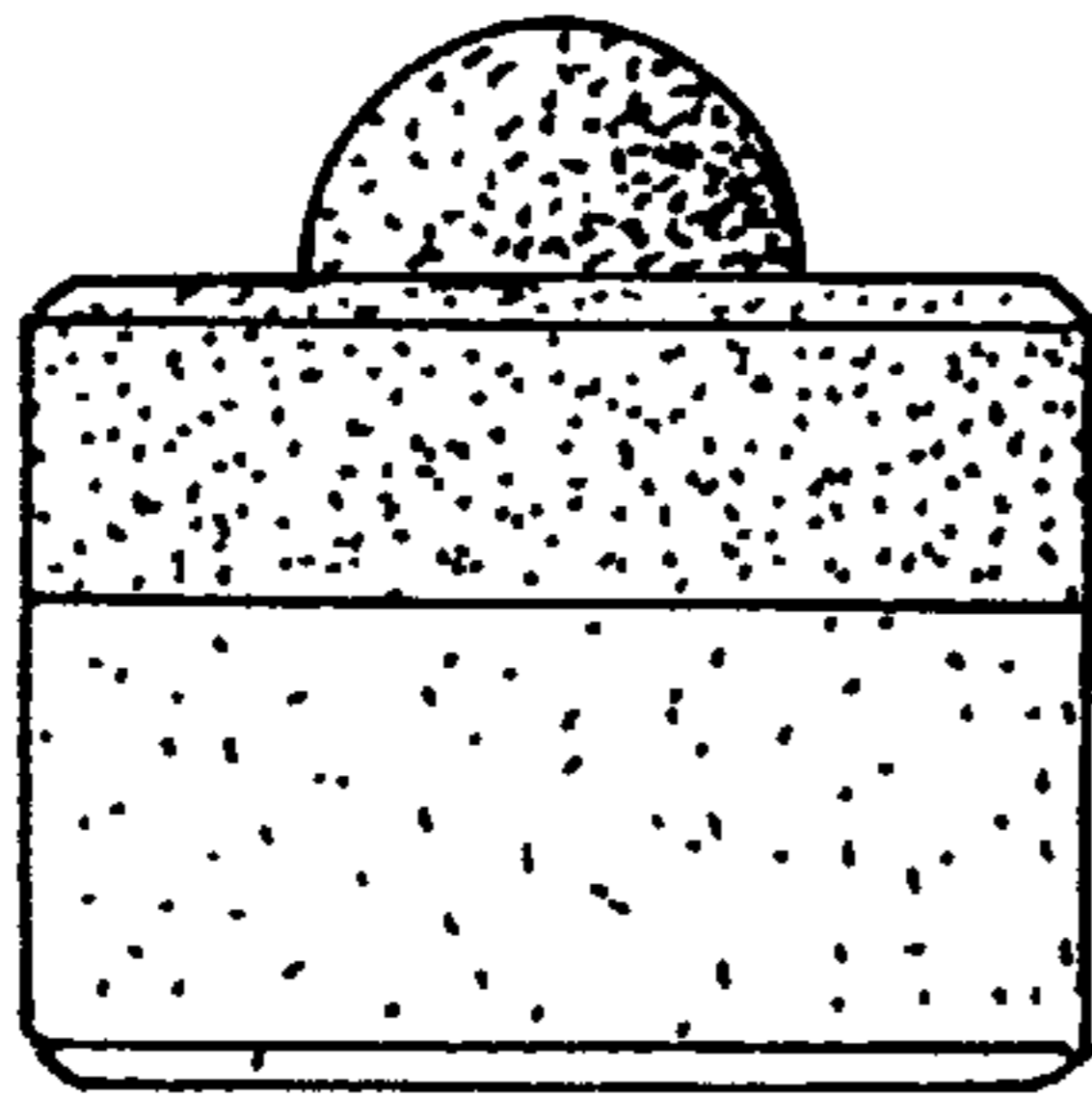




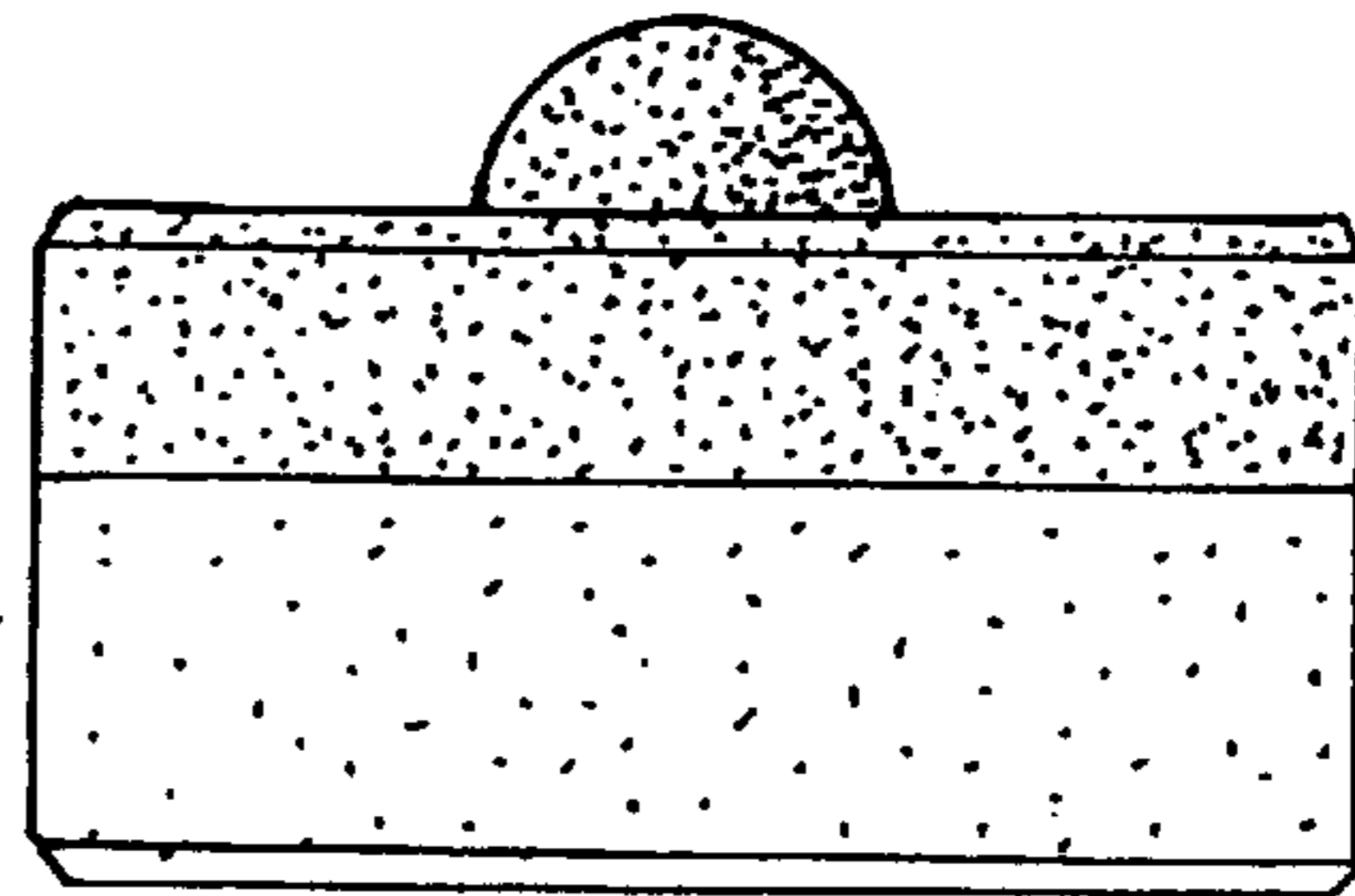

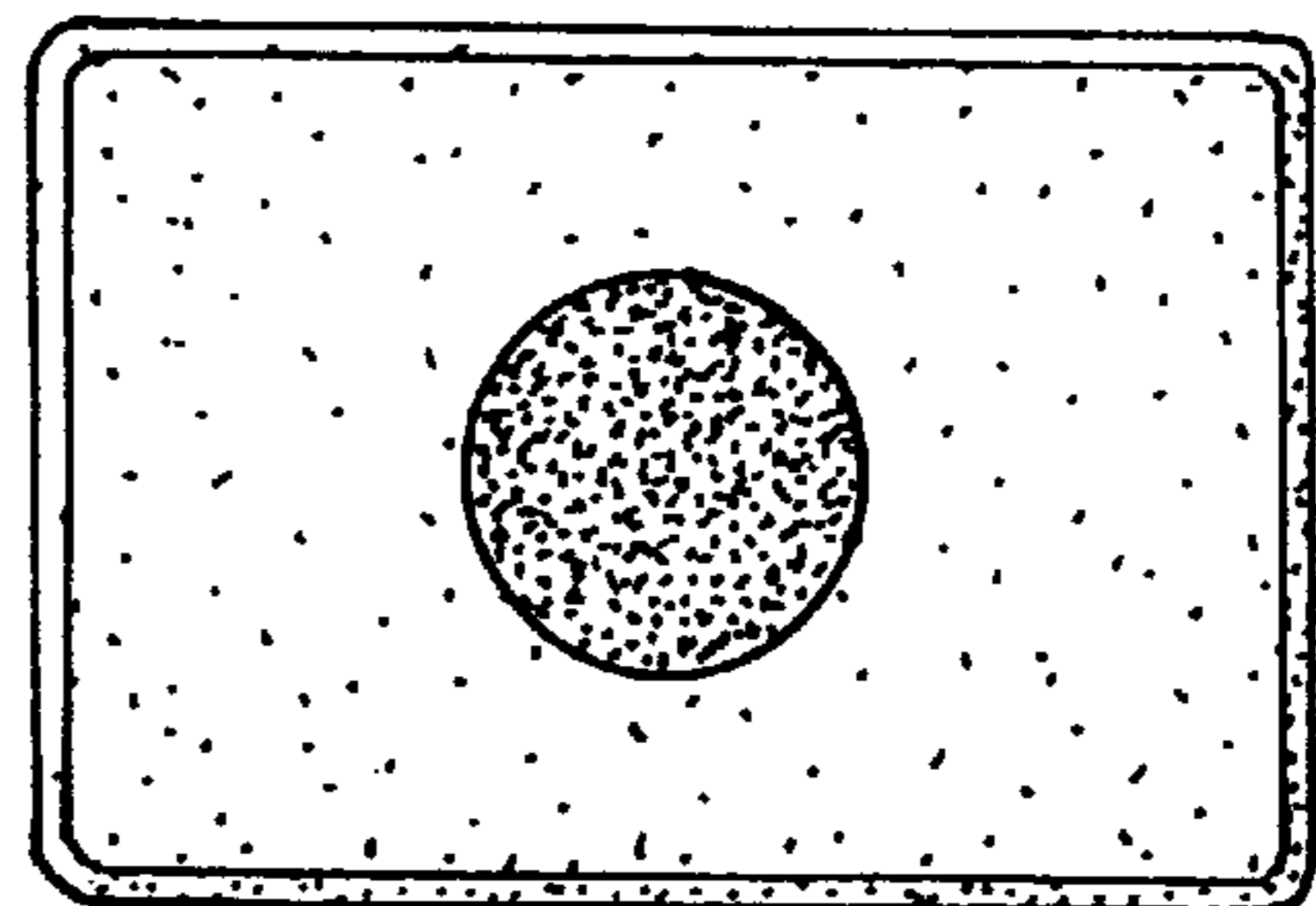
