(57) **CLAIM**

The ornamental design for a self-standing toothbrush handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a self-standing toothbrush handle of our new design;

FIG. 2 is a left side elevation view thereof; the right side elevation being a mirror image of the left side elevation as shown herein in FIG. 2;

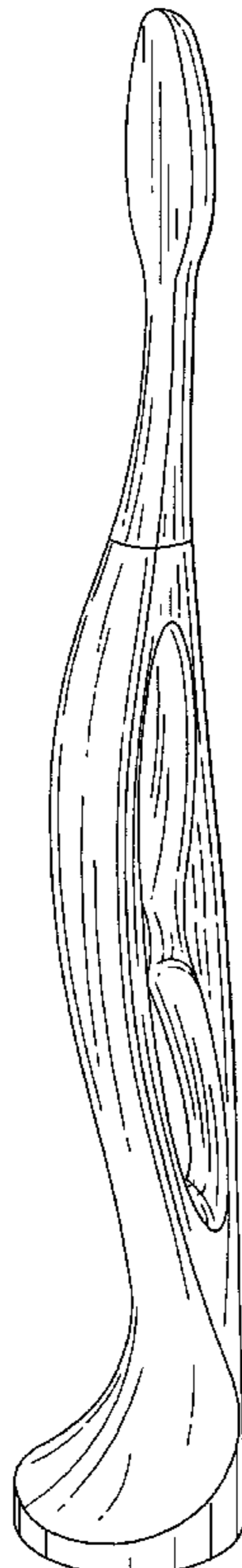
FIG. 3 is a front elevation view thereof;

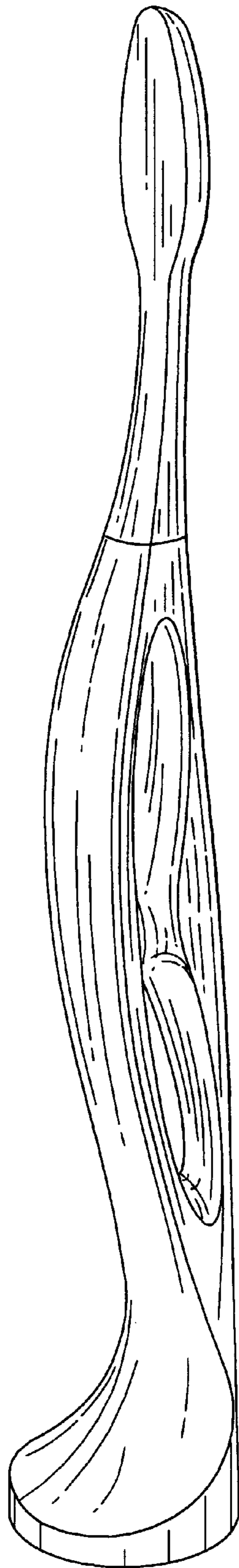

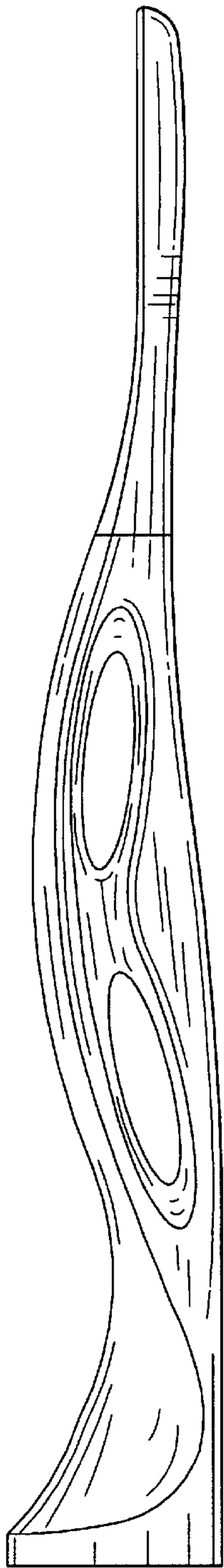

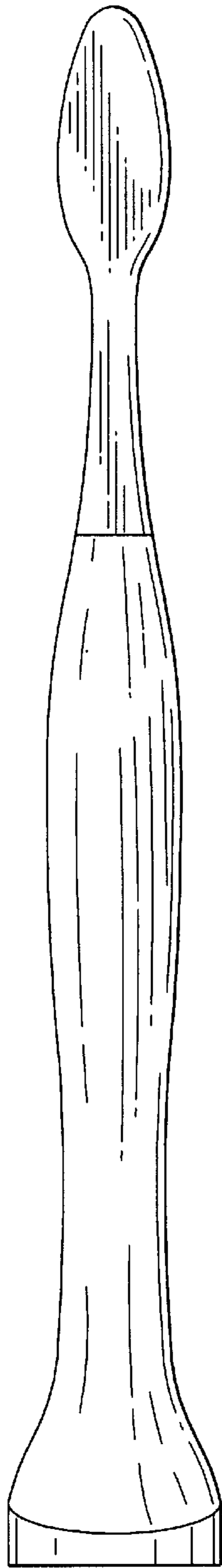

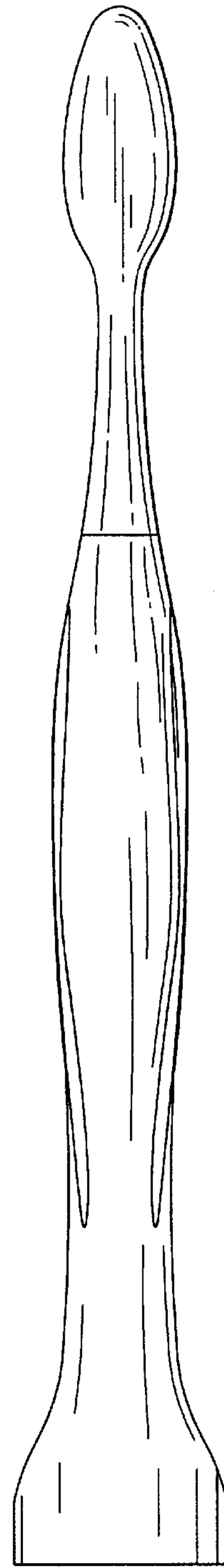

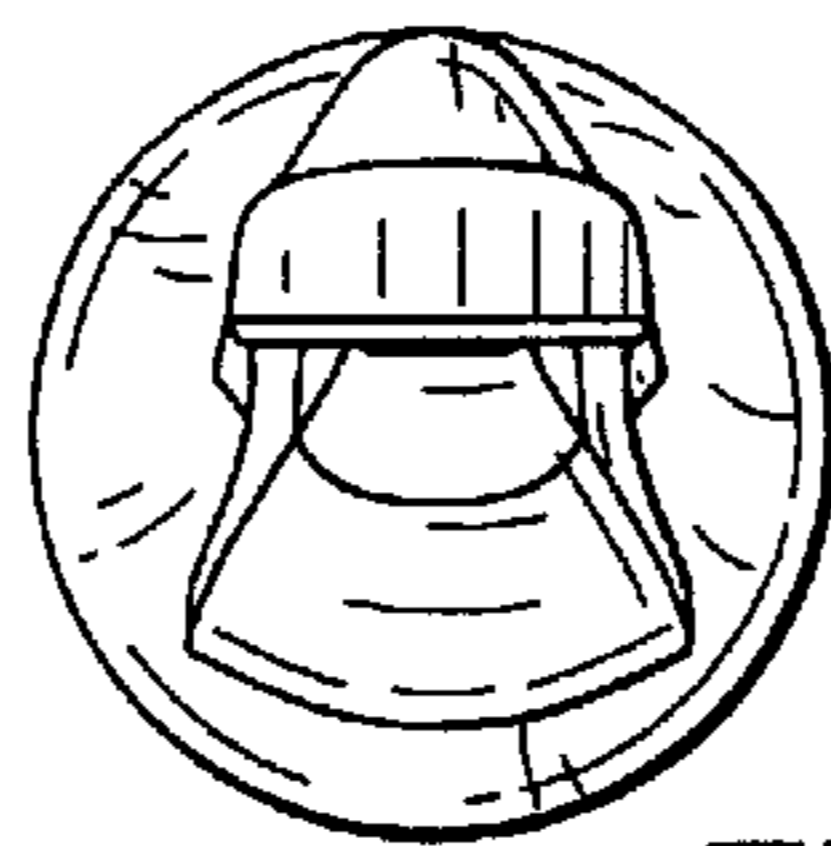
