**DESCRIPTION**

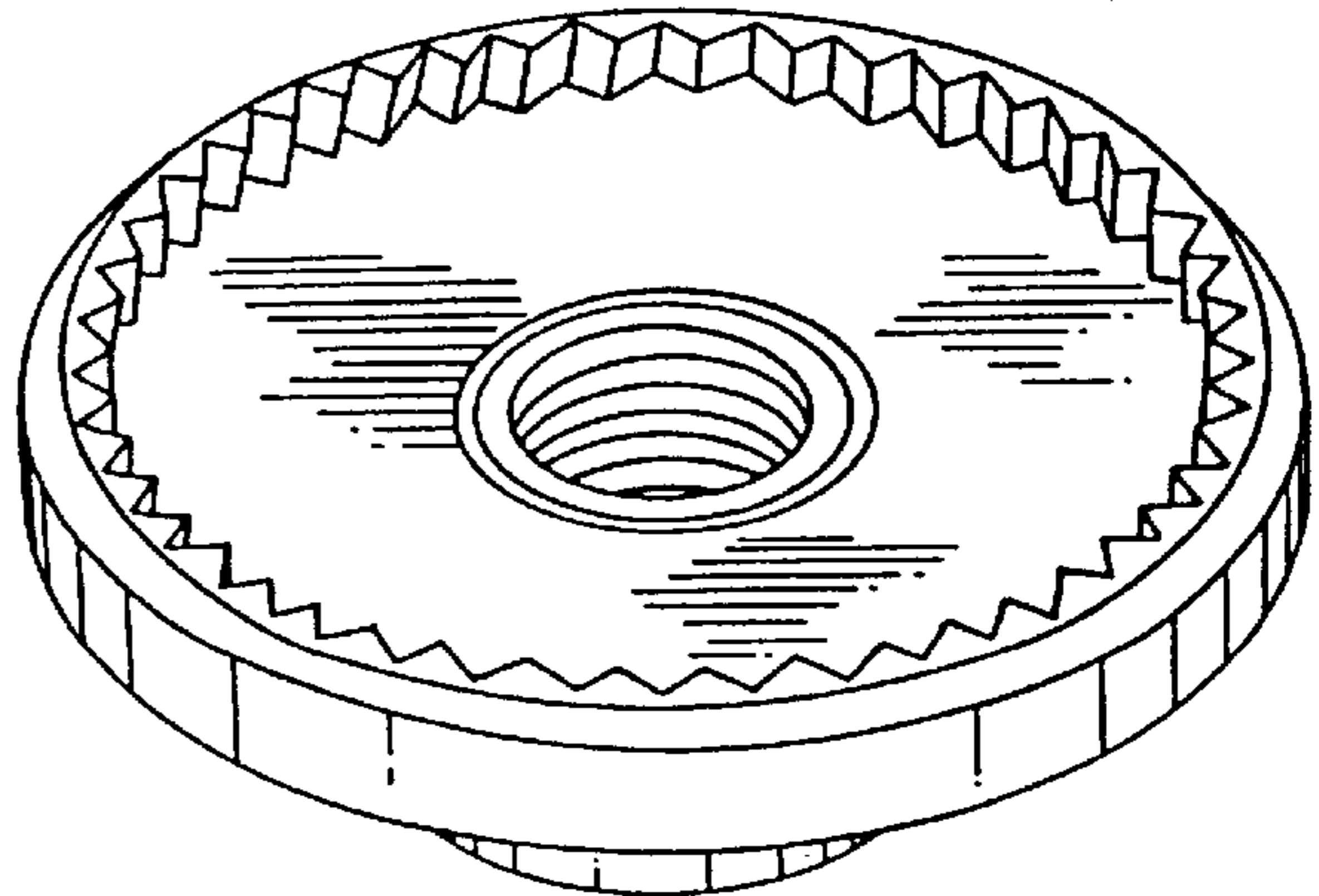
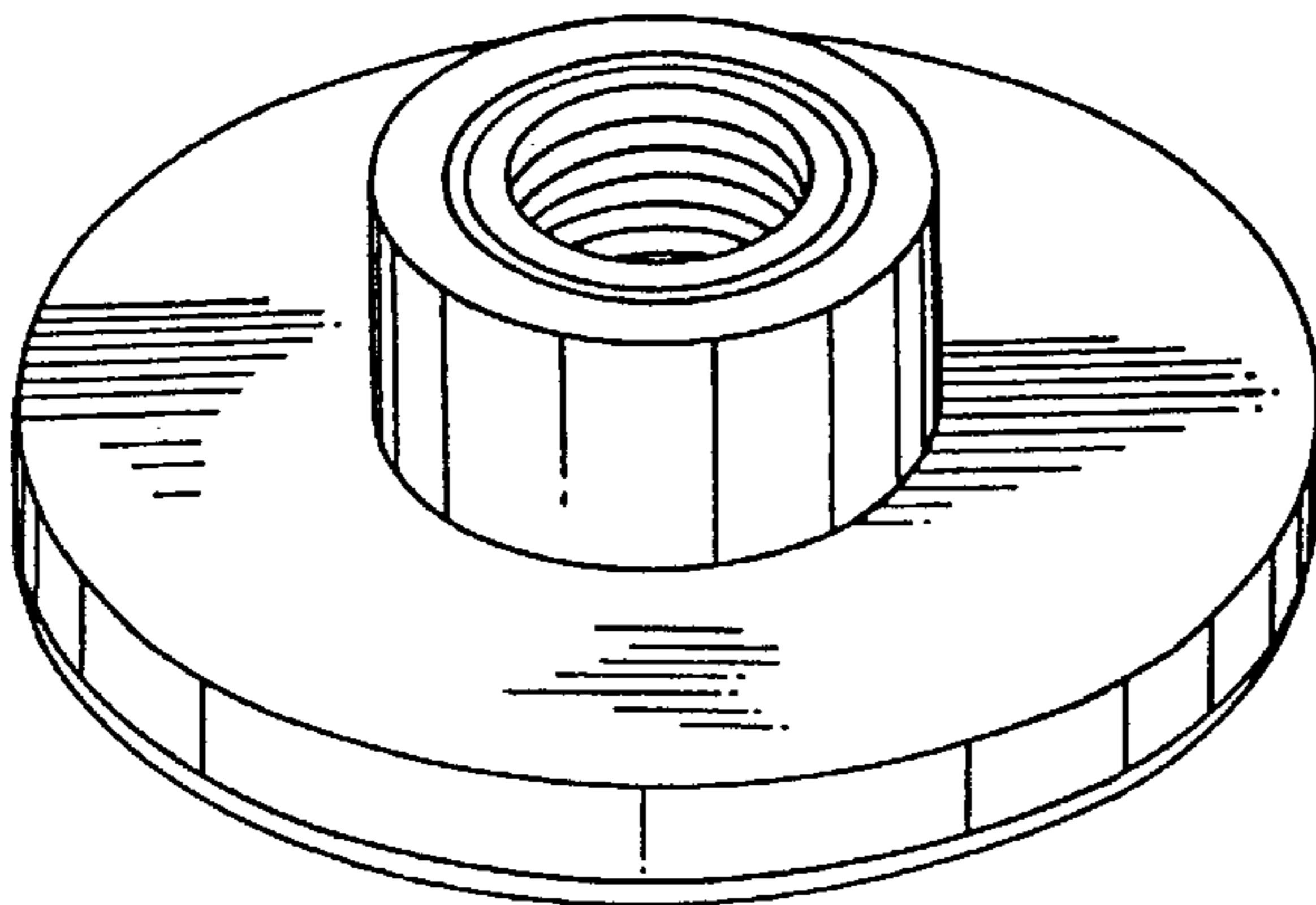

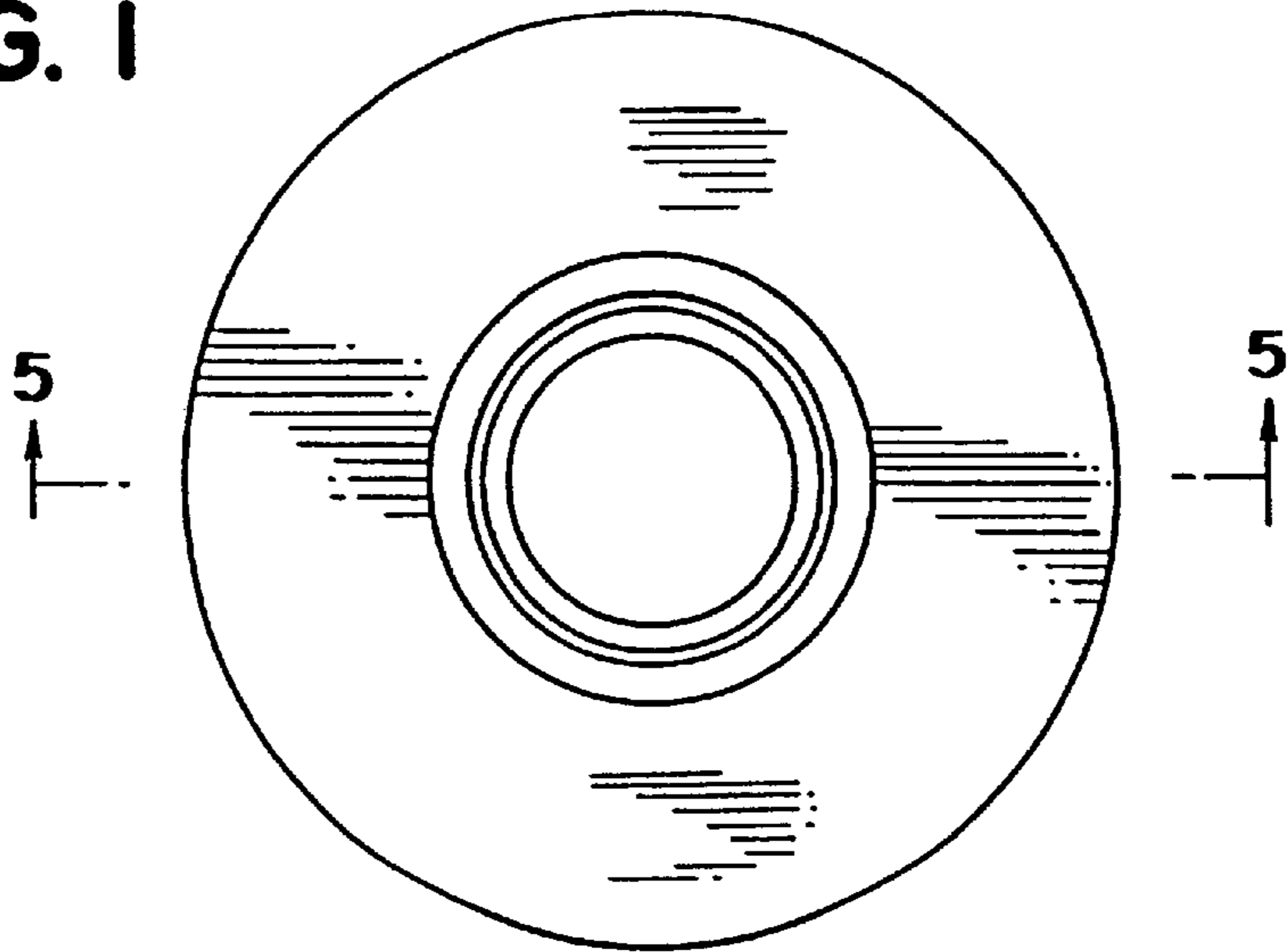

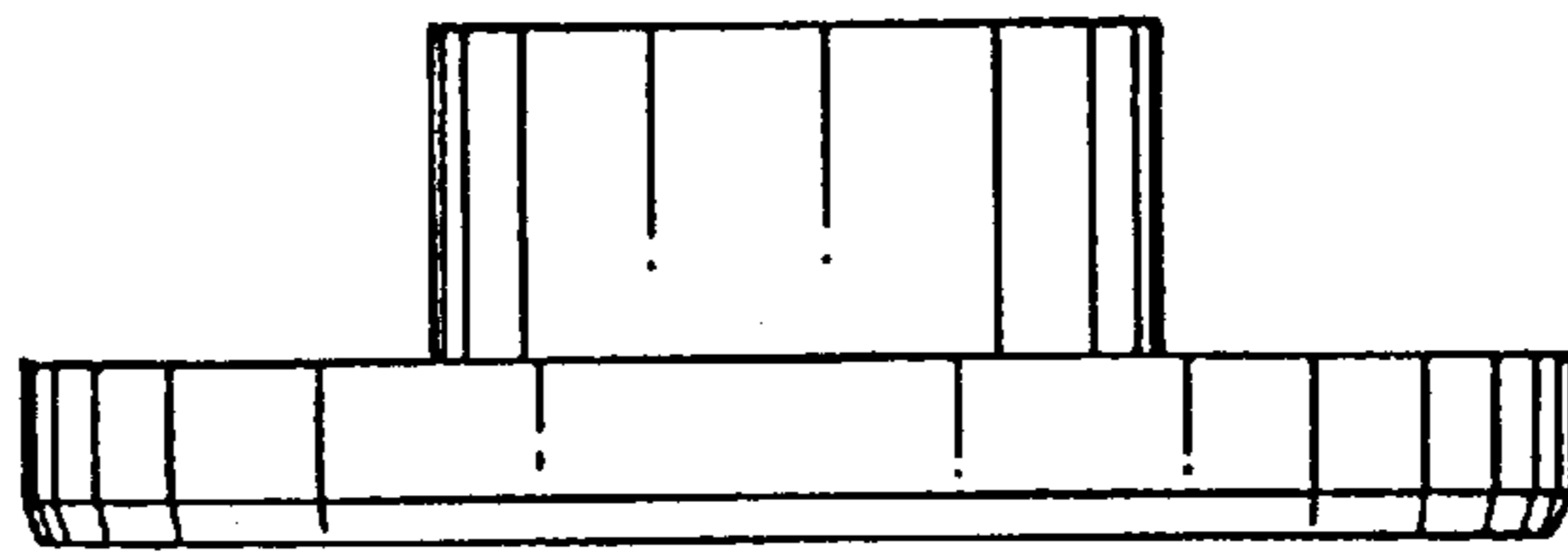
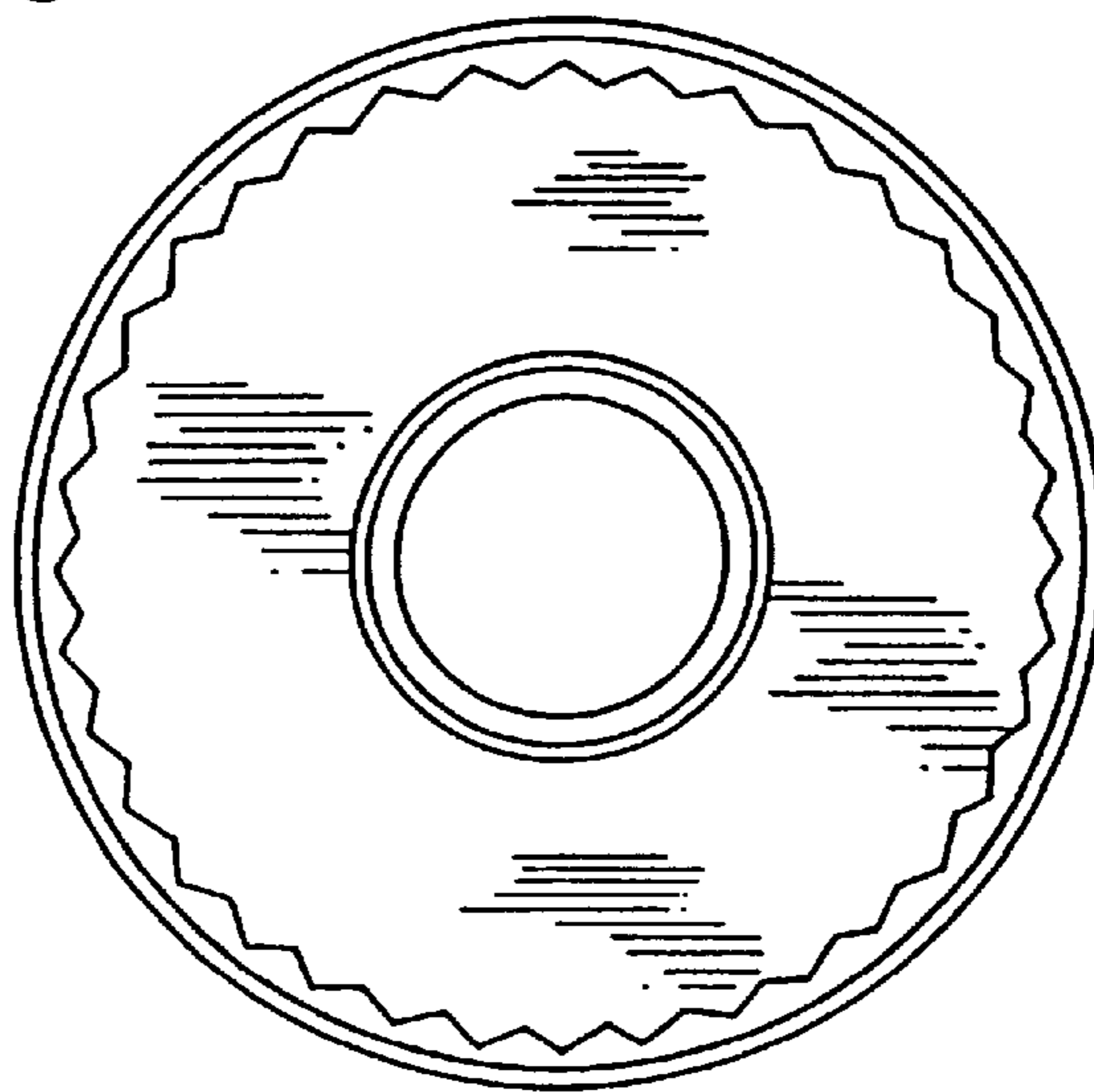
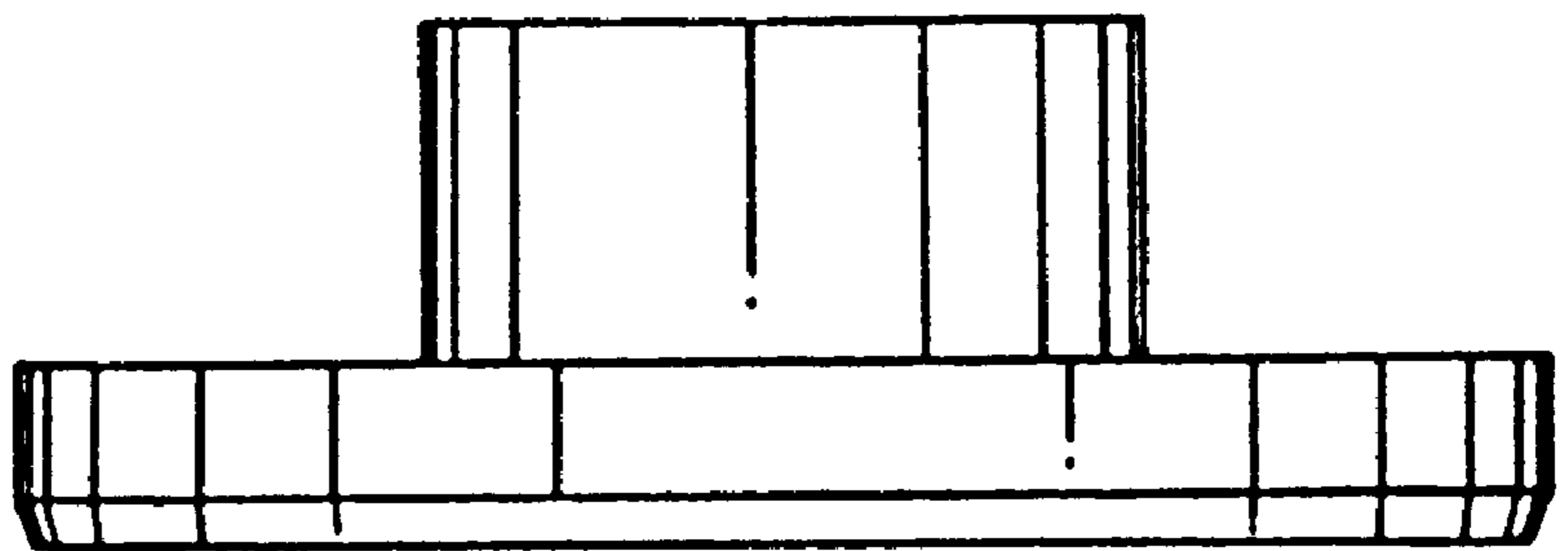


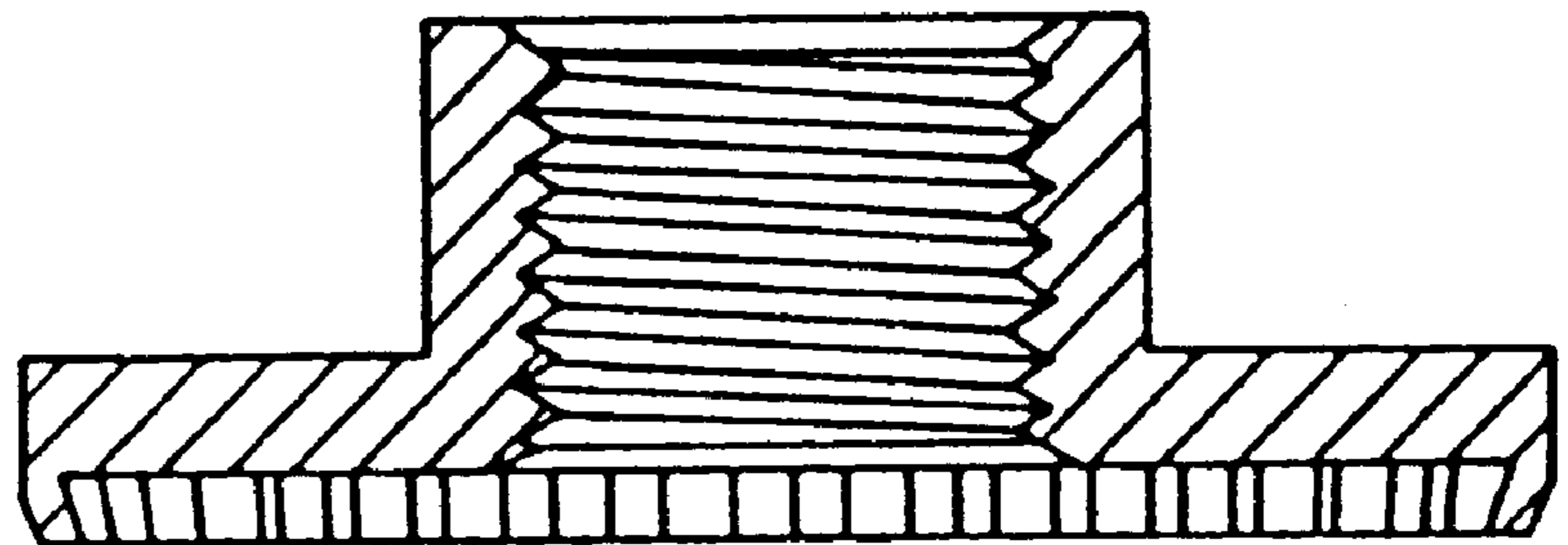

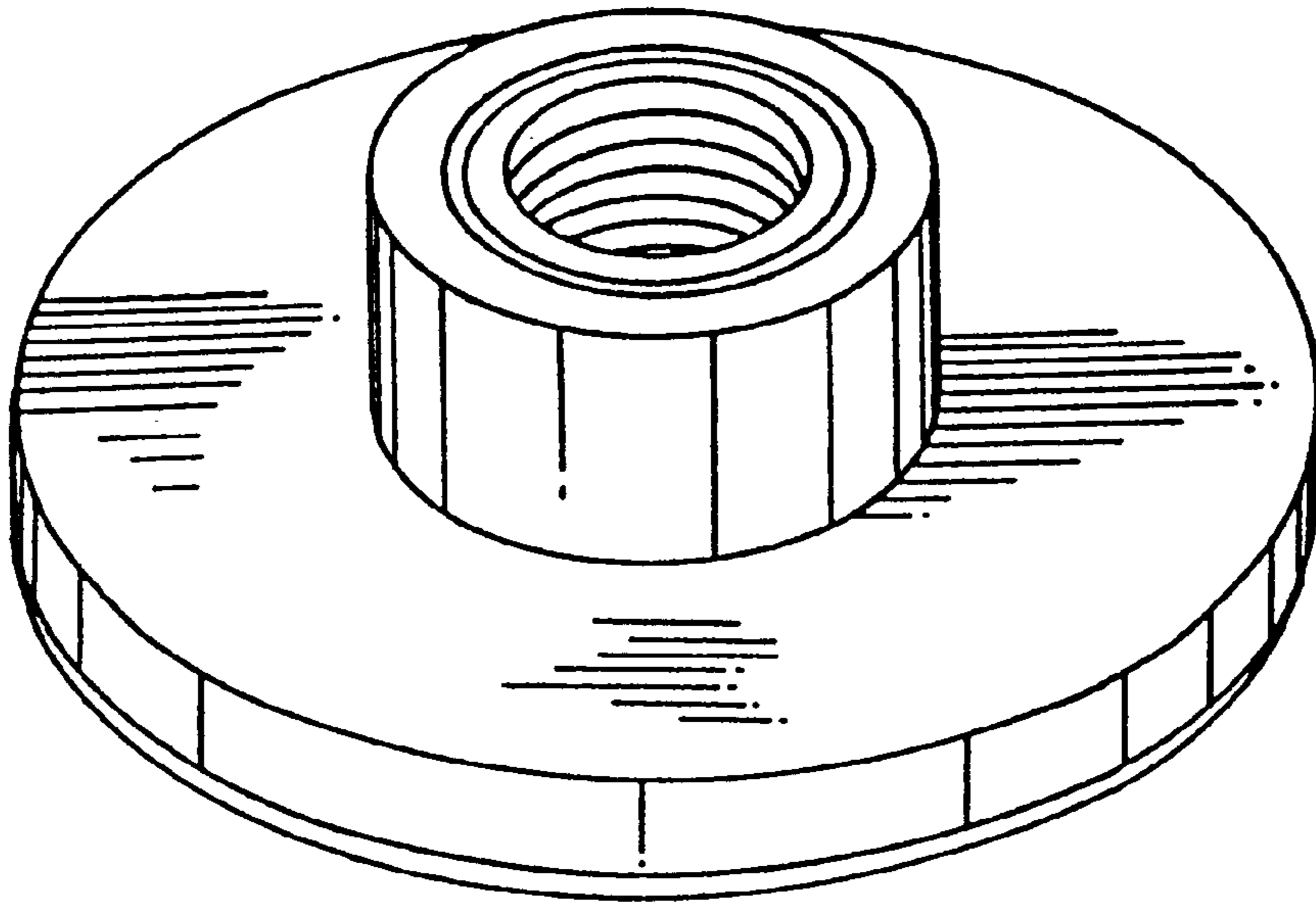
