**DESCRIPTION**

FIG. 1 is a perspective view of a hat box with the cover removed and with a hat shown in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

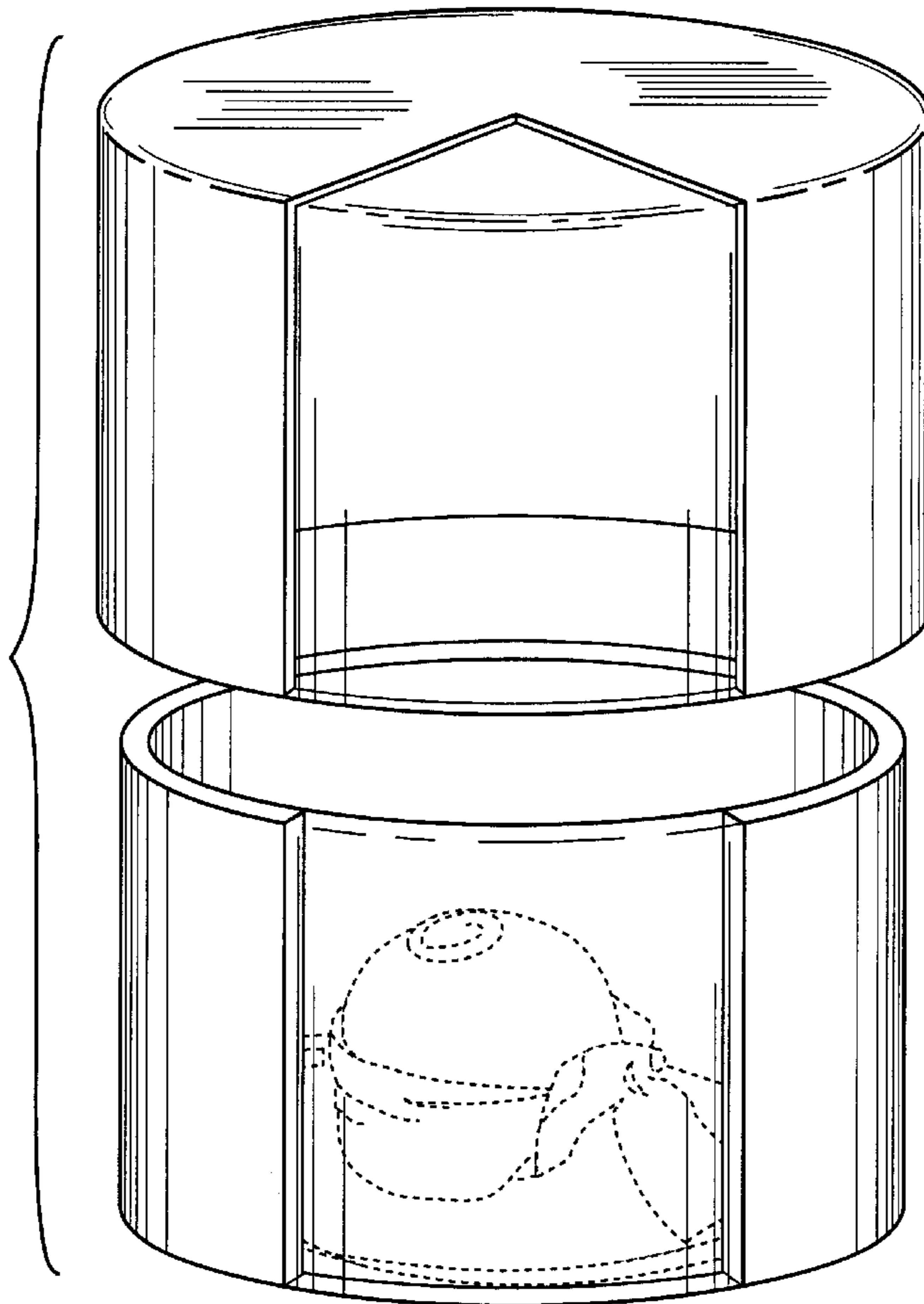
FIG. 4 is a right side elevational view thereof.

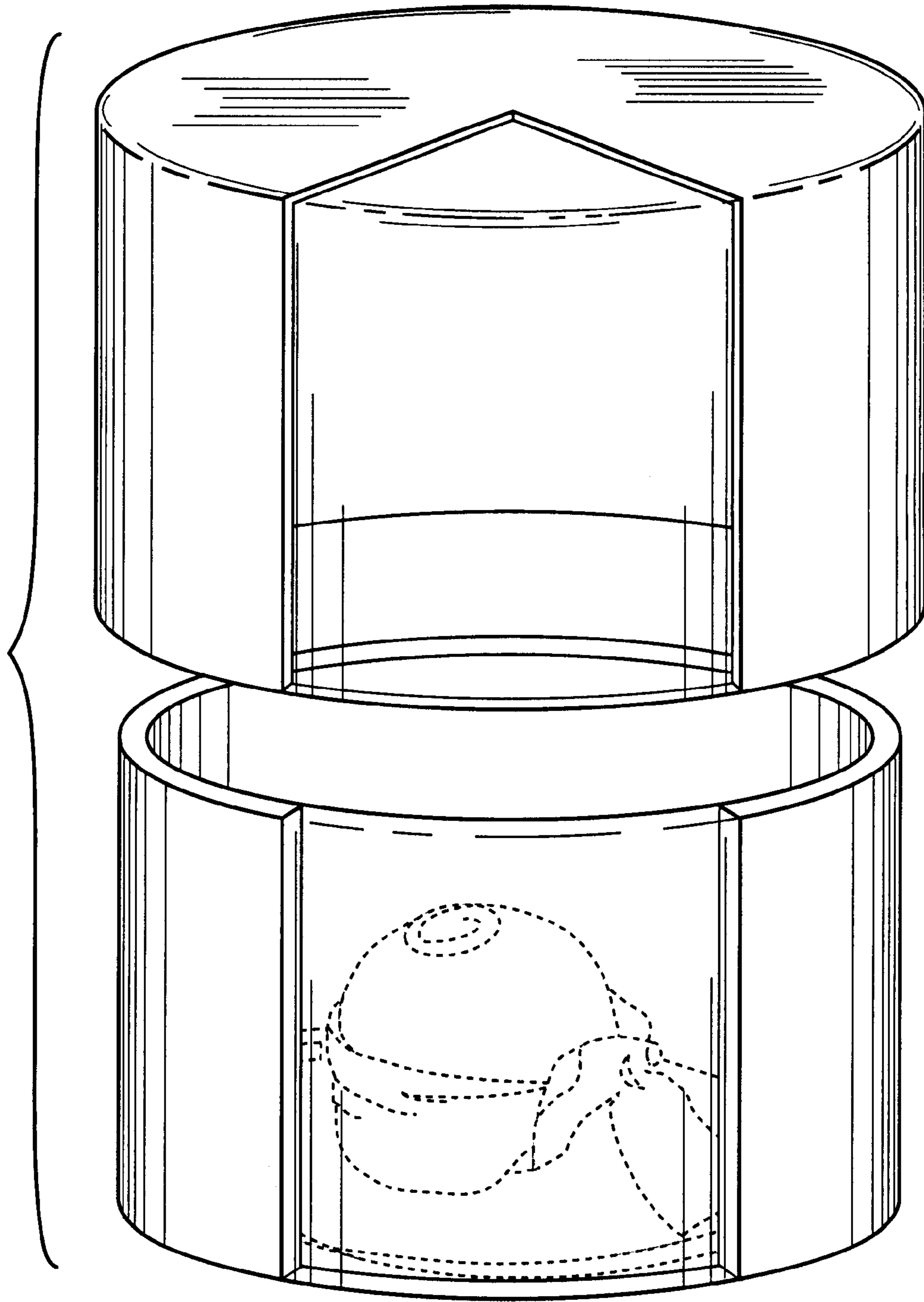

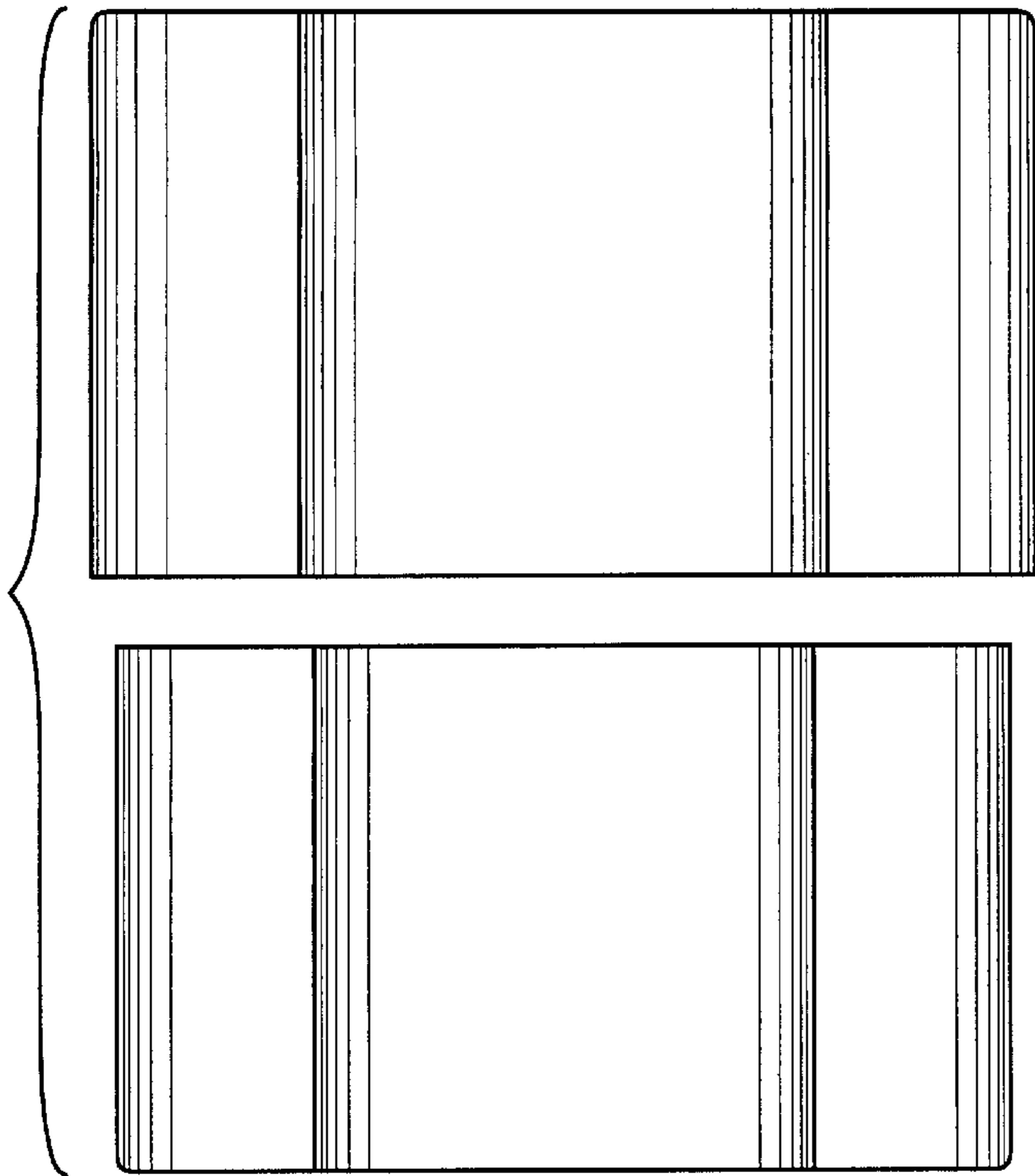

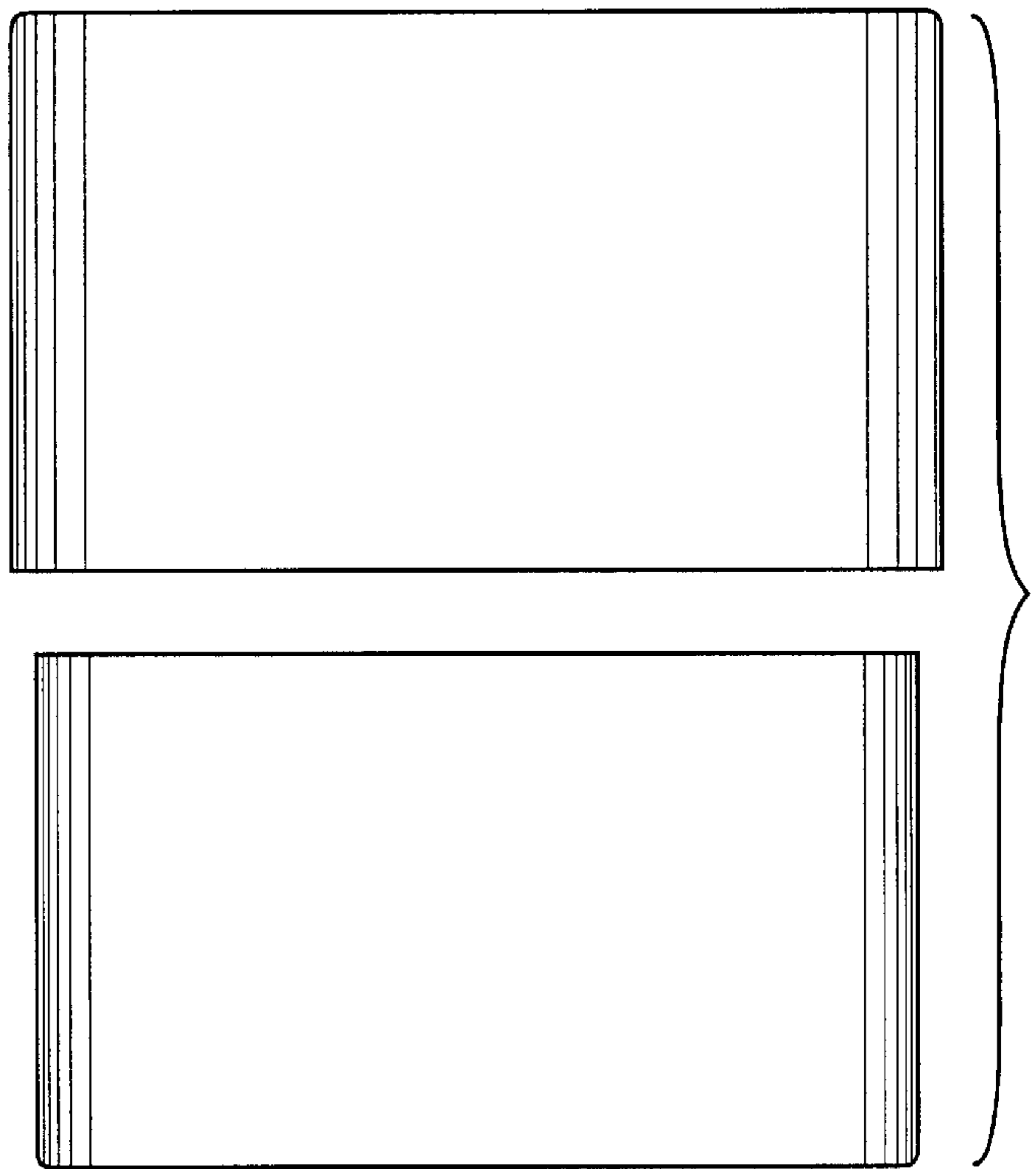

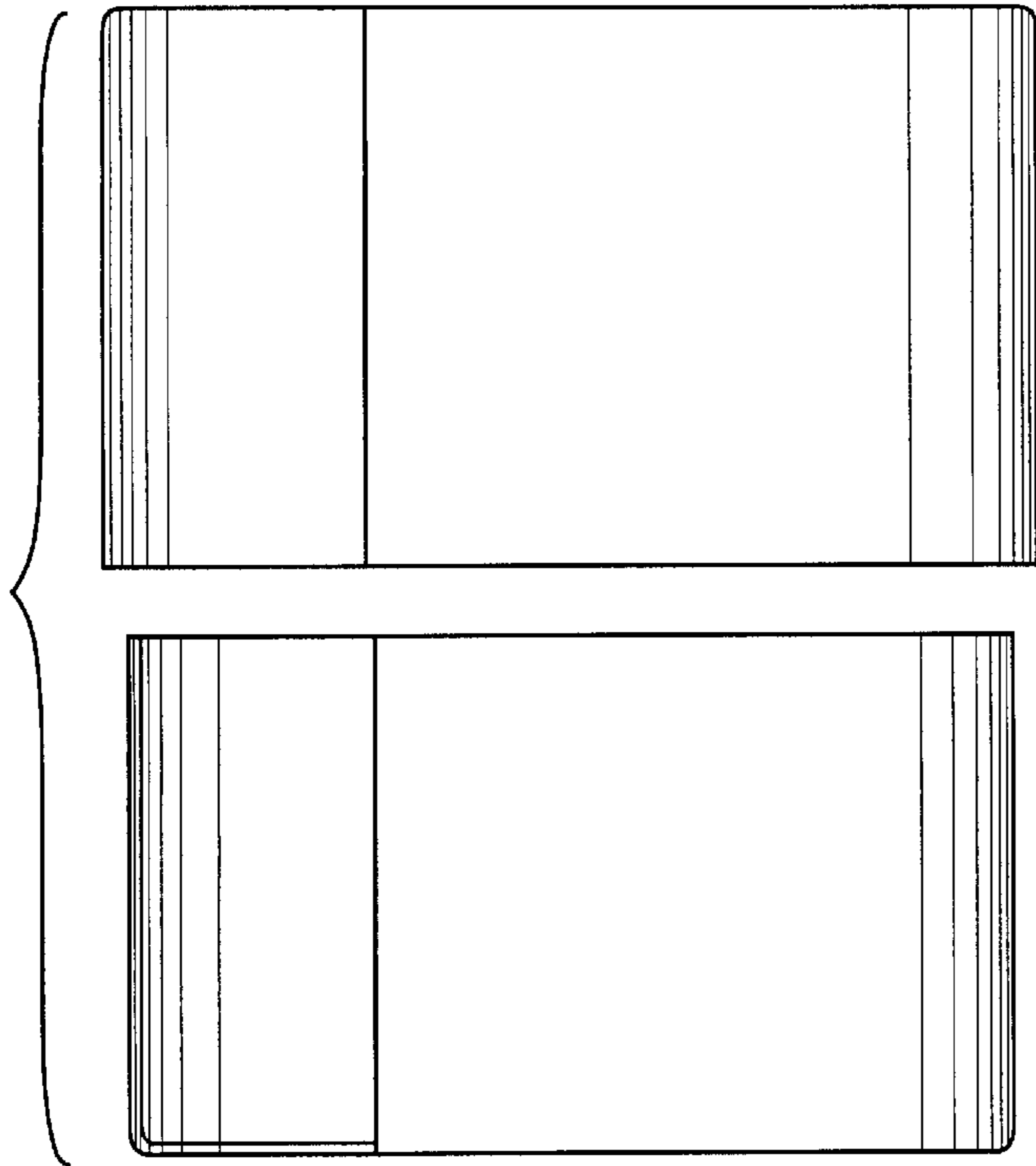

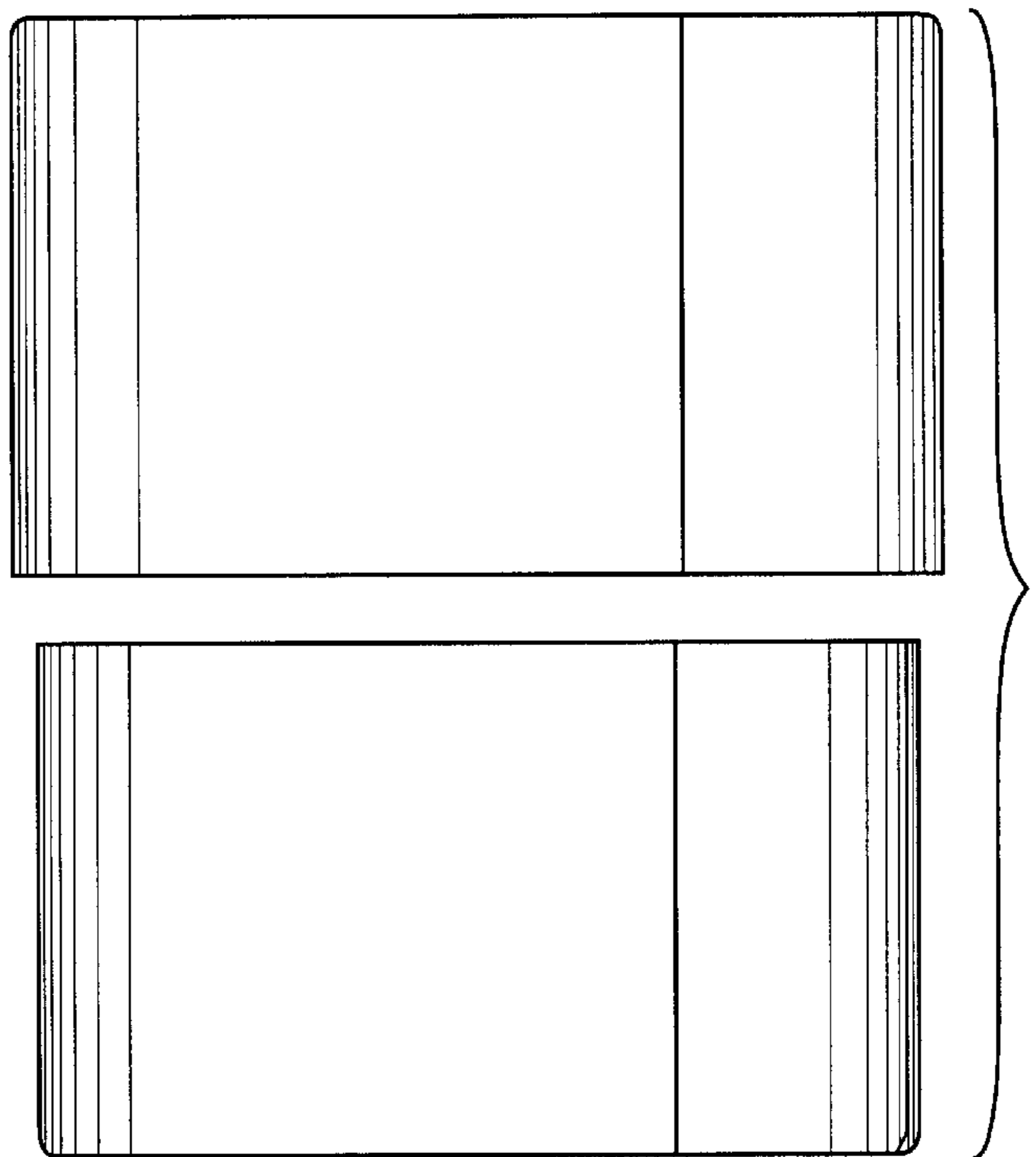

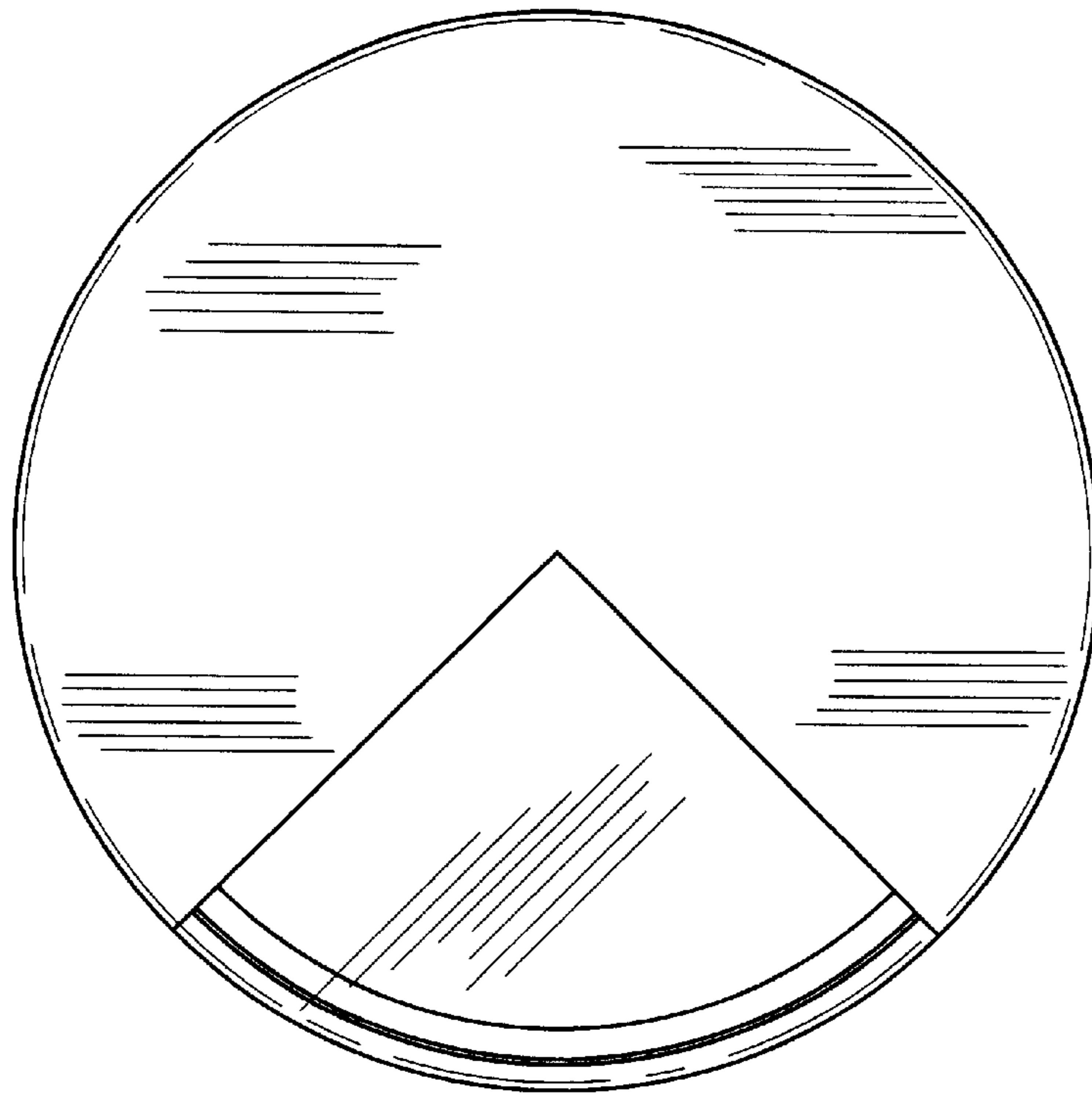

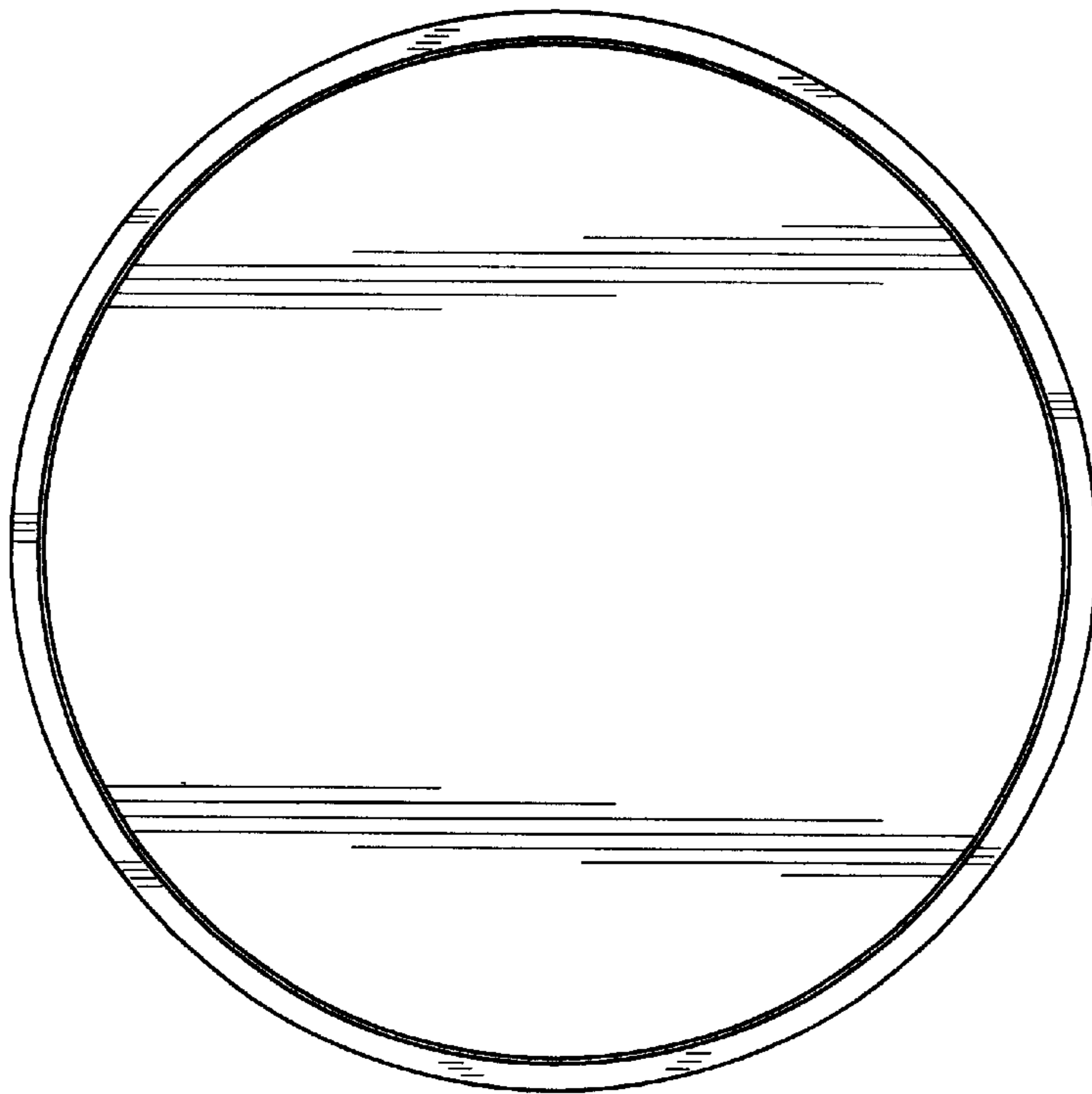
