DESCRIPTION

FIG. 1 is a top plan view of the audio device of the present invention;

FIG. 2 is a front-side elevation view of the audio device of FIG. 1;

FIG. 3 is a back-side elevation view of the audio device of FIG. 1;

FIG. 4 is a bottom plan view of the audio device of FIG. 1;

FIG. 5 is a right side elevation view of the audio device of FIG. 1; and,

FIG. 6 is a left side elevation view of the audio device of FIG. 1.

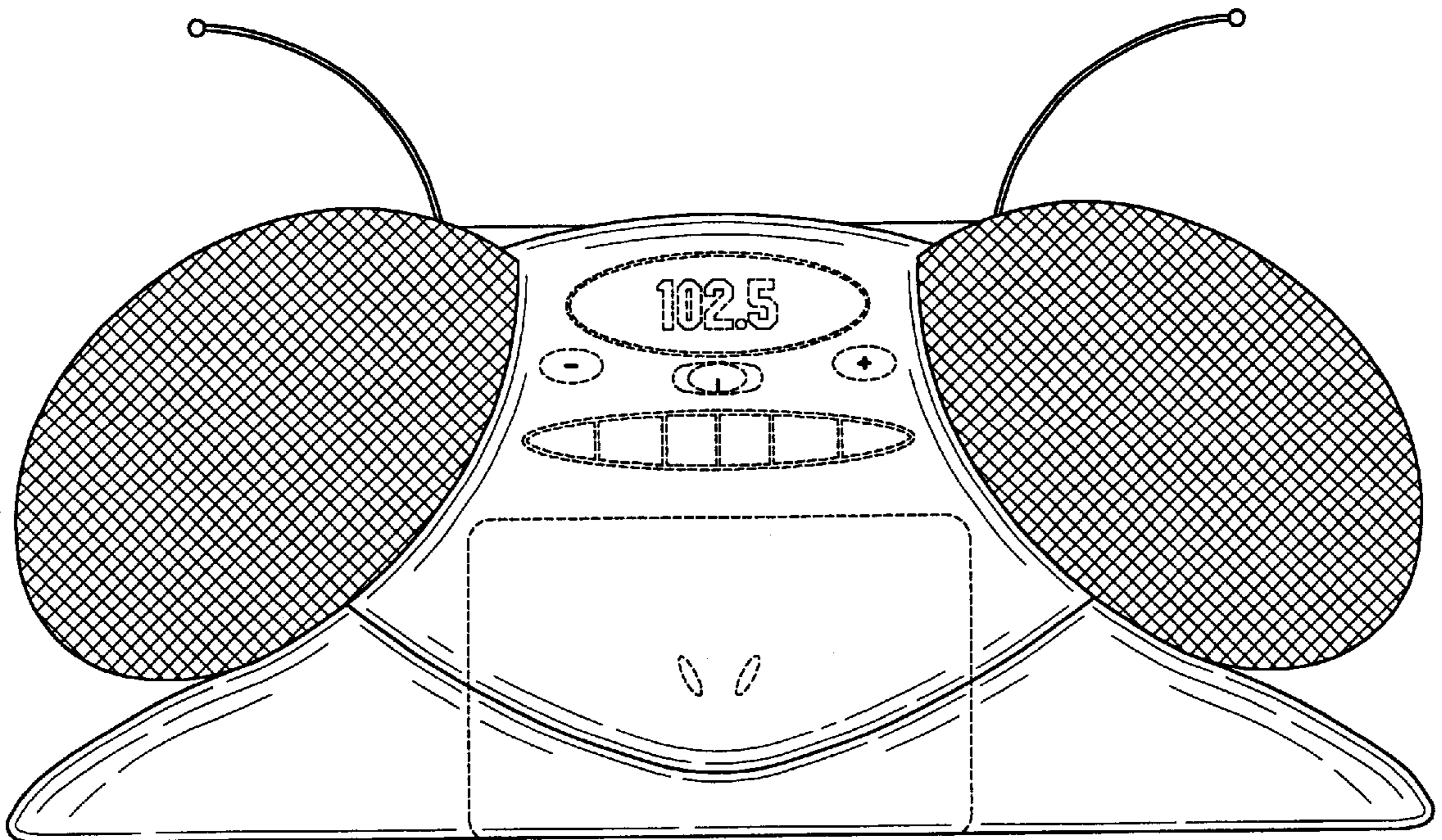
In FIGS. 1 and 2 the broken line showing is for illustrative purposes only and forms no part of the claimed design.

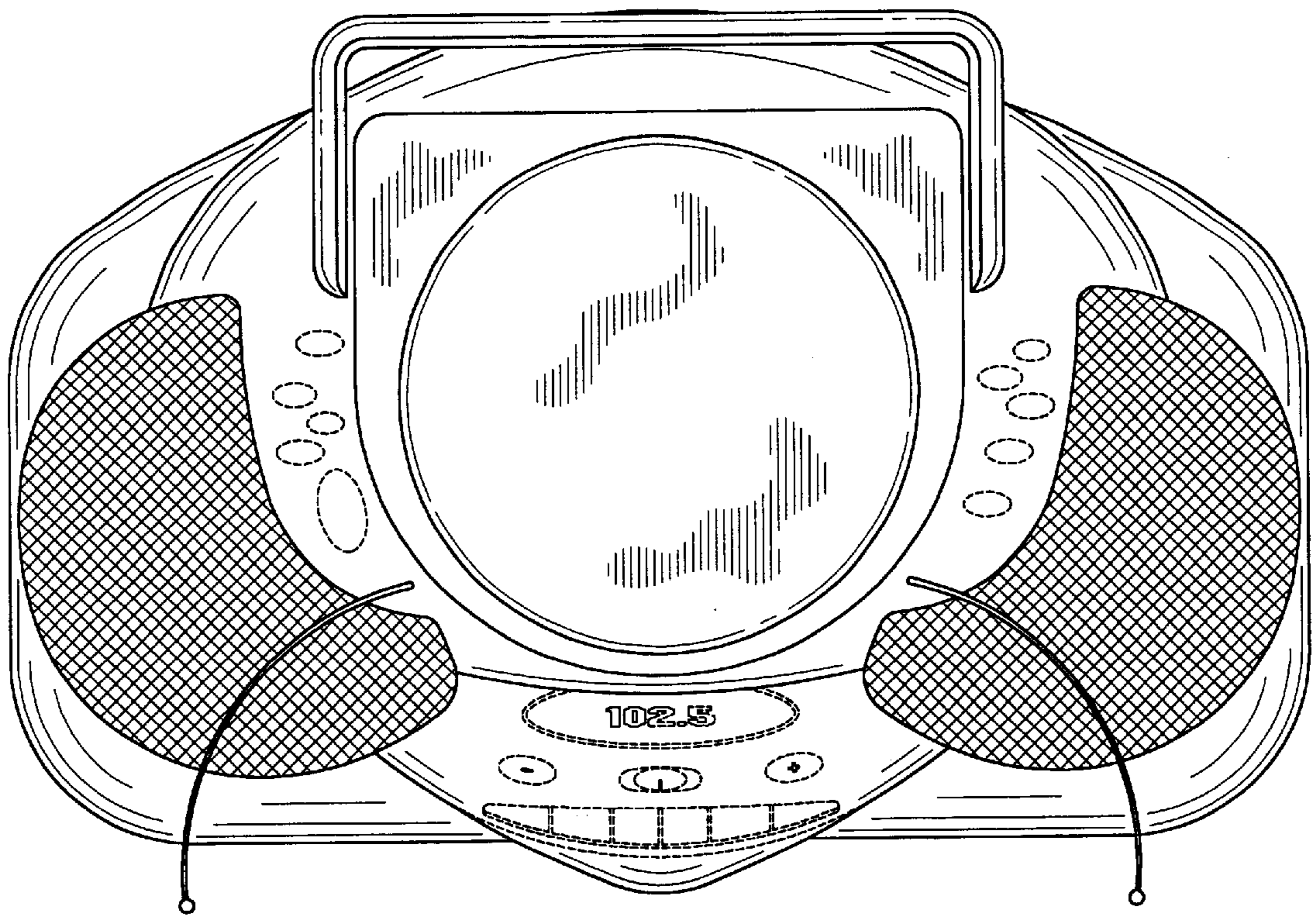

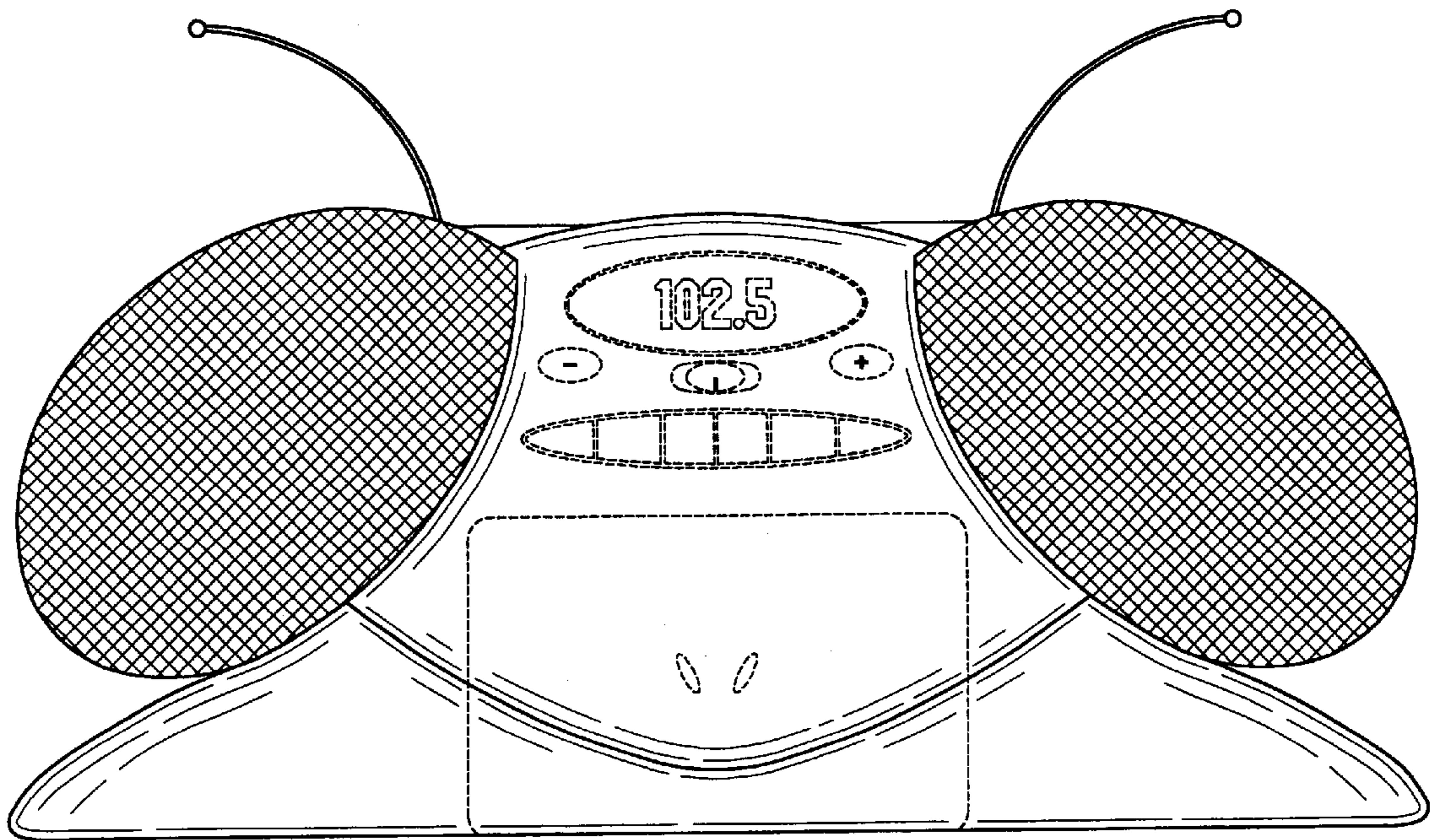

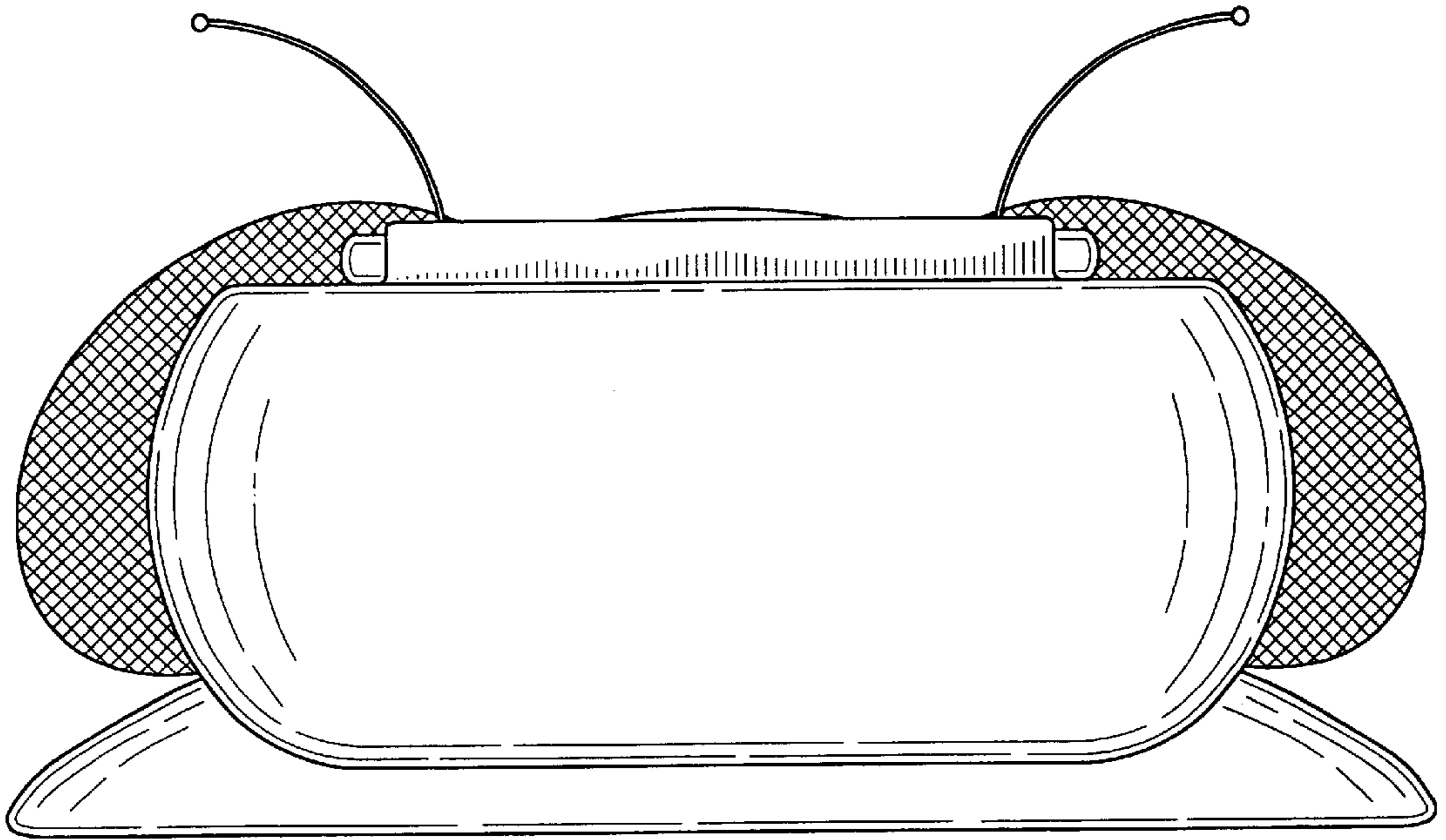

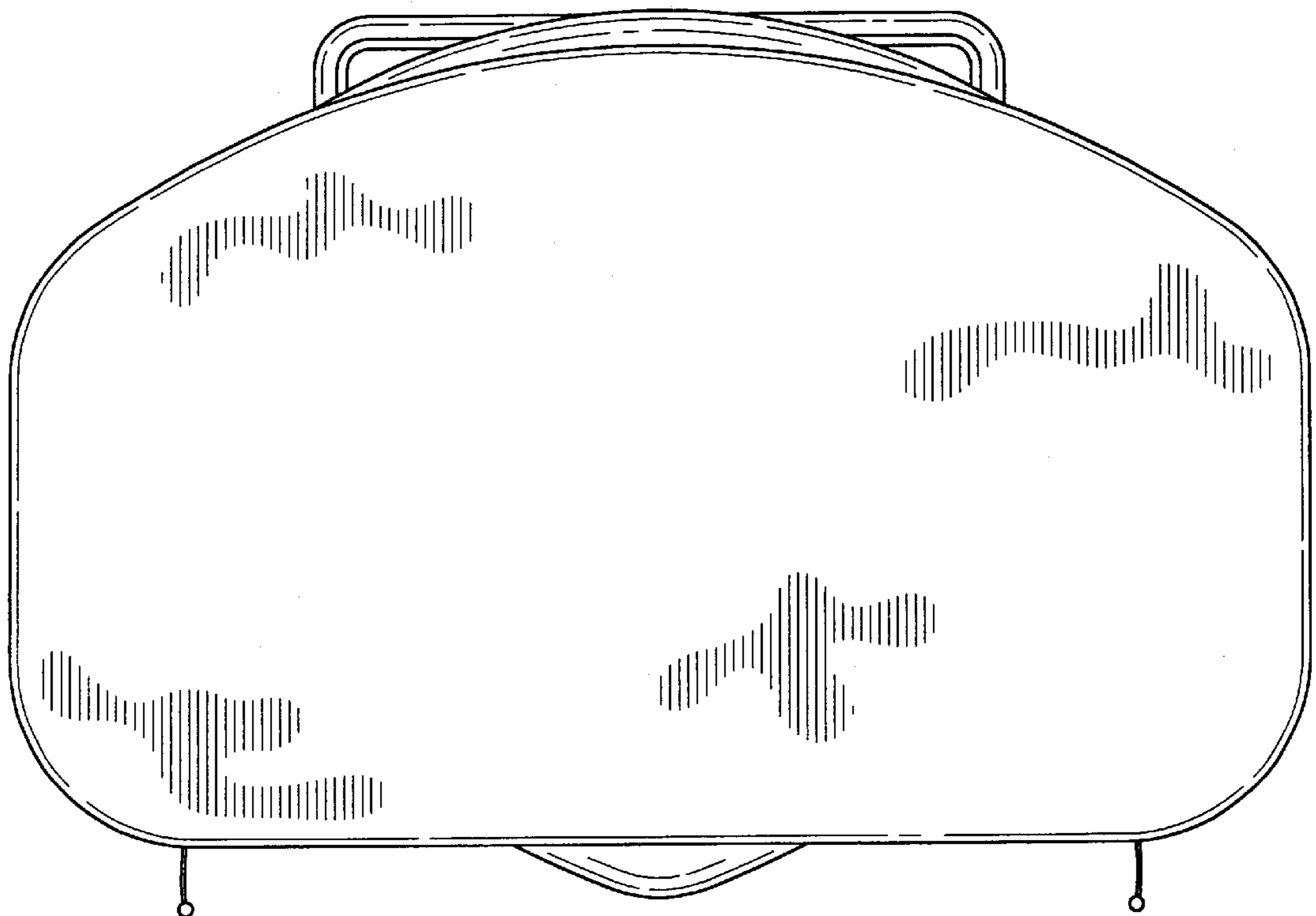

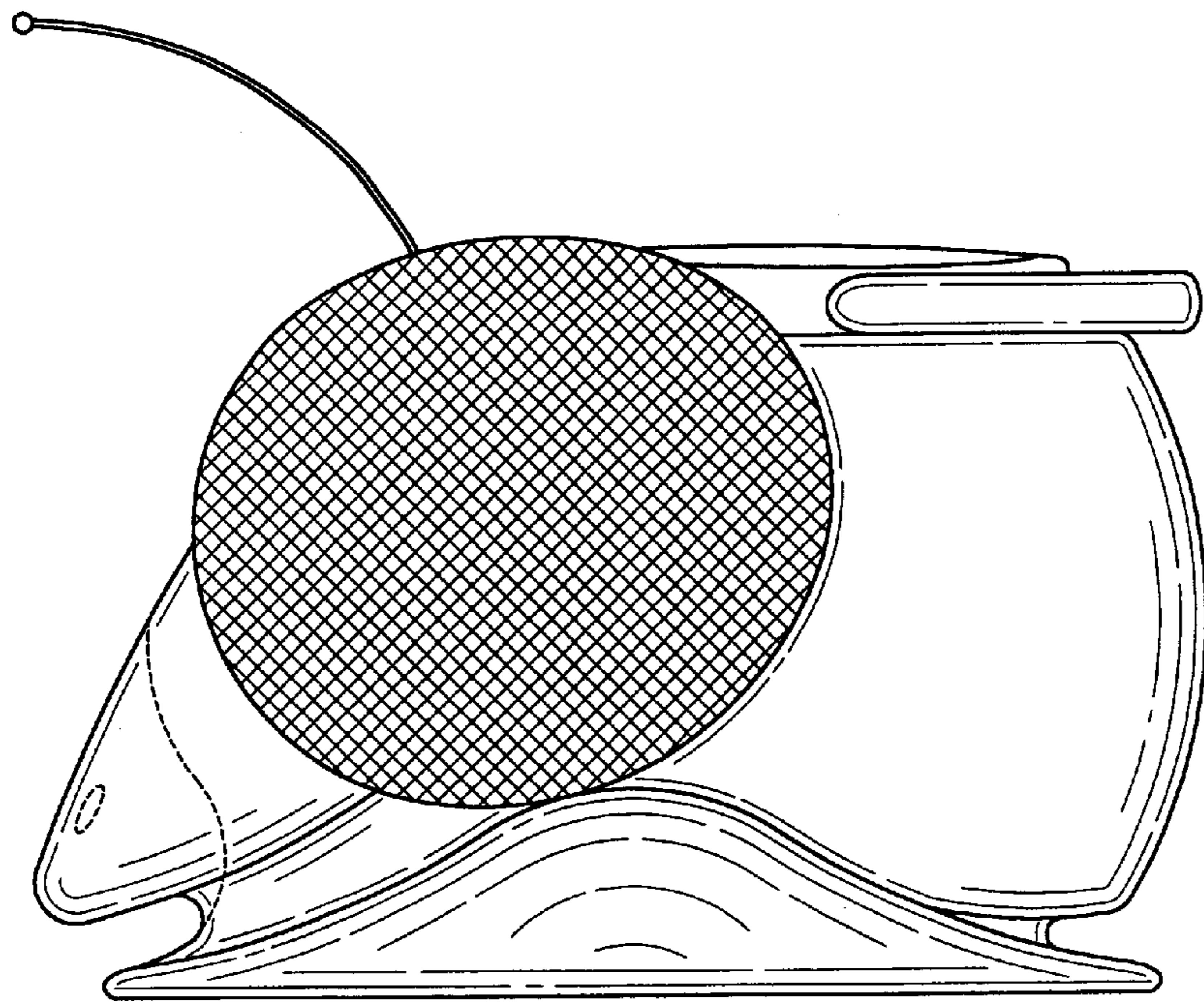

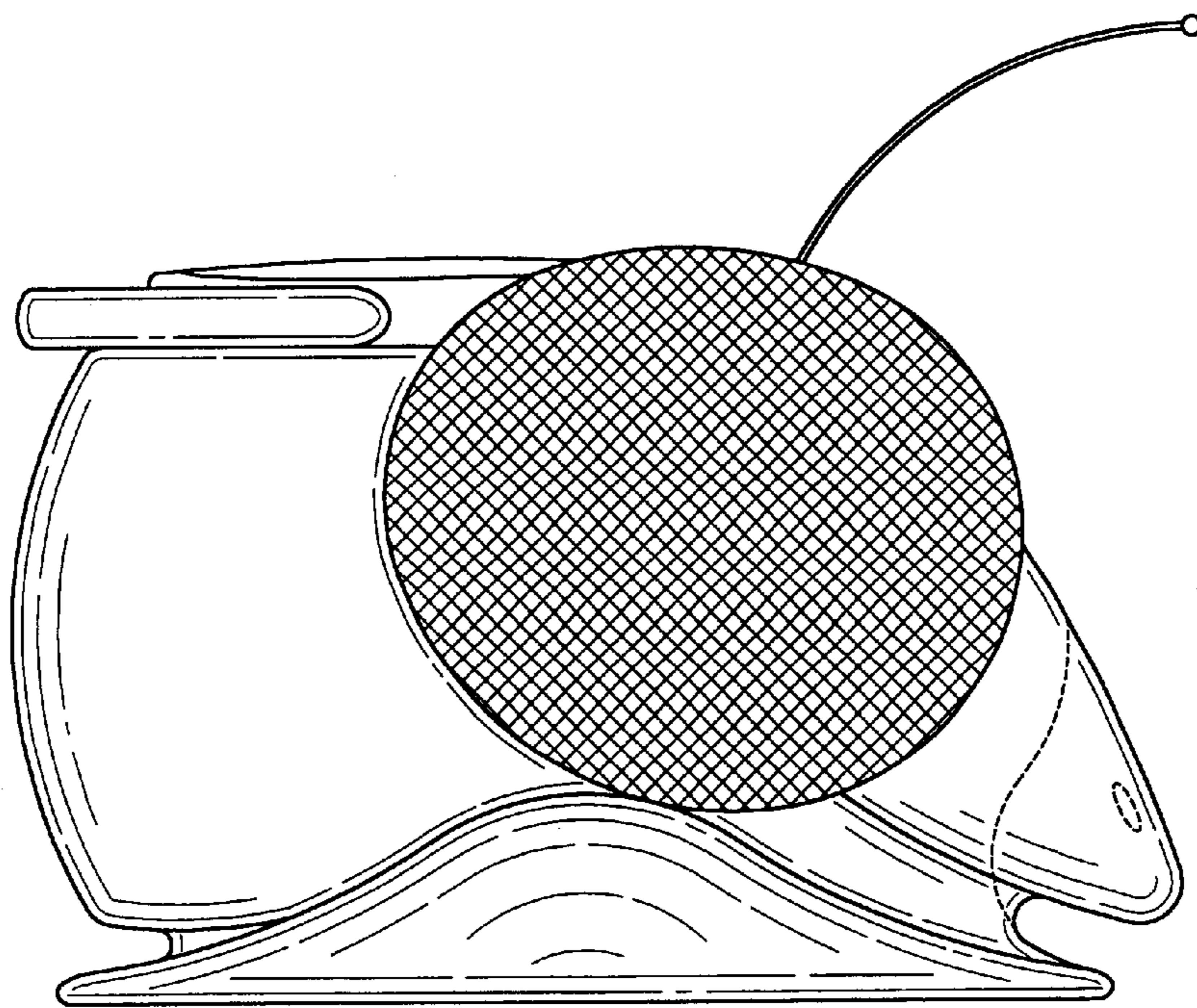
