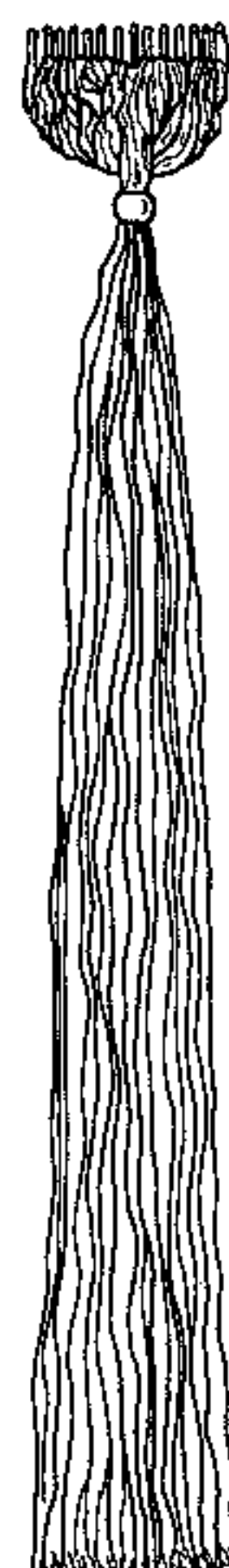
(57) **CLAIM**

The ornamental design for a hair adornment, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the hair adornment of the invention.
FIG. 2 is an enlarged front elevational view thereof, the hair is drawn broken away for ease of illustration;
FIG. 3 is an enlarged end elevational view thereof, the hair is drawn broken away for ease of illustration;
FIG. 4 is an enlarged opposite end elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

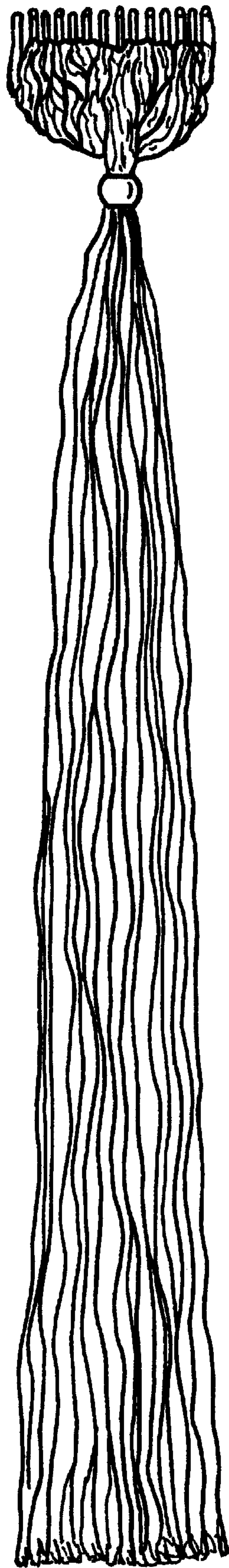

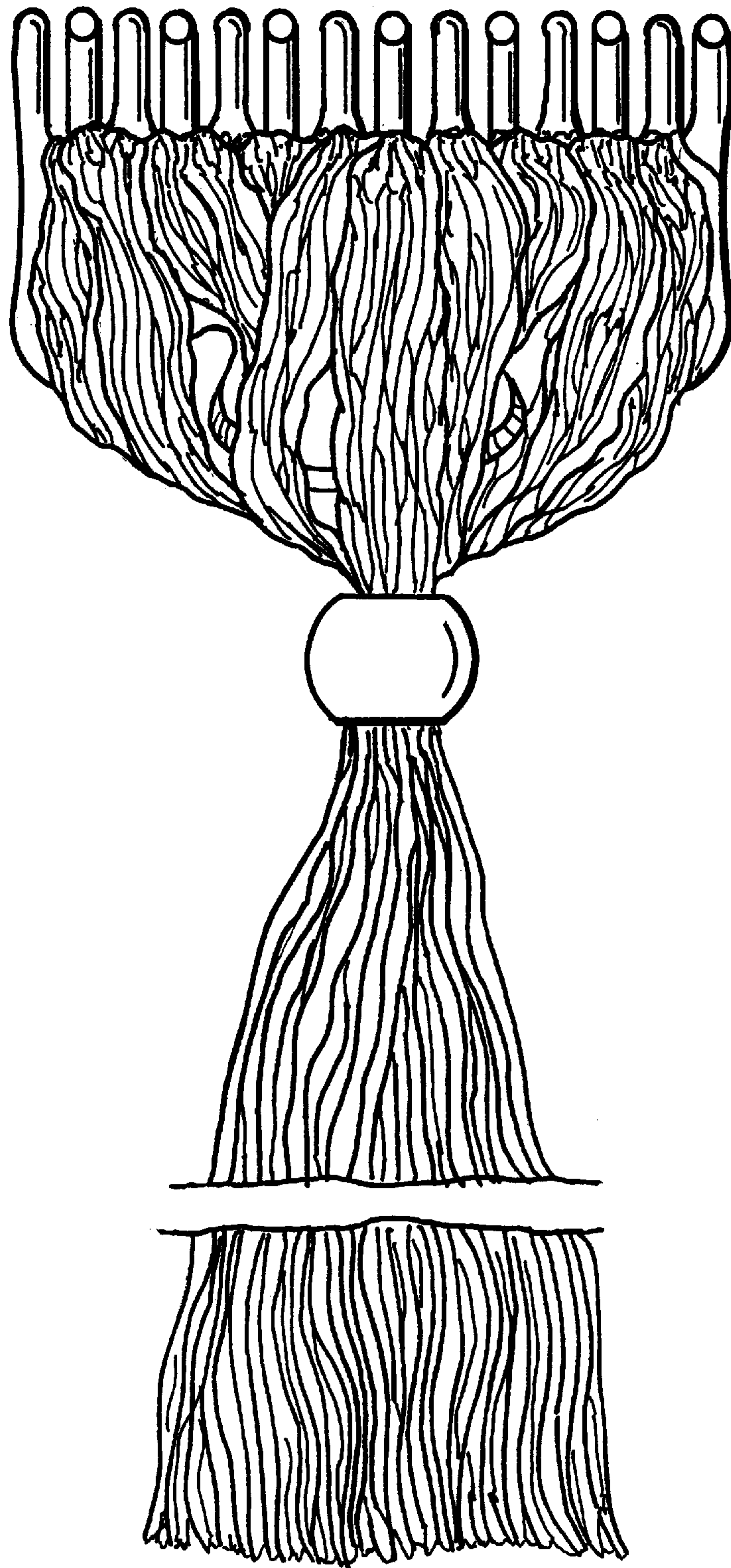

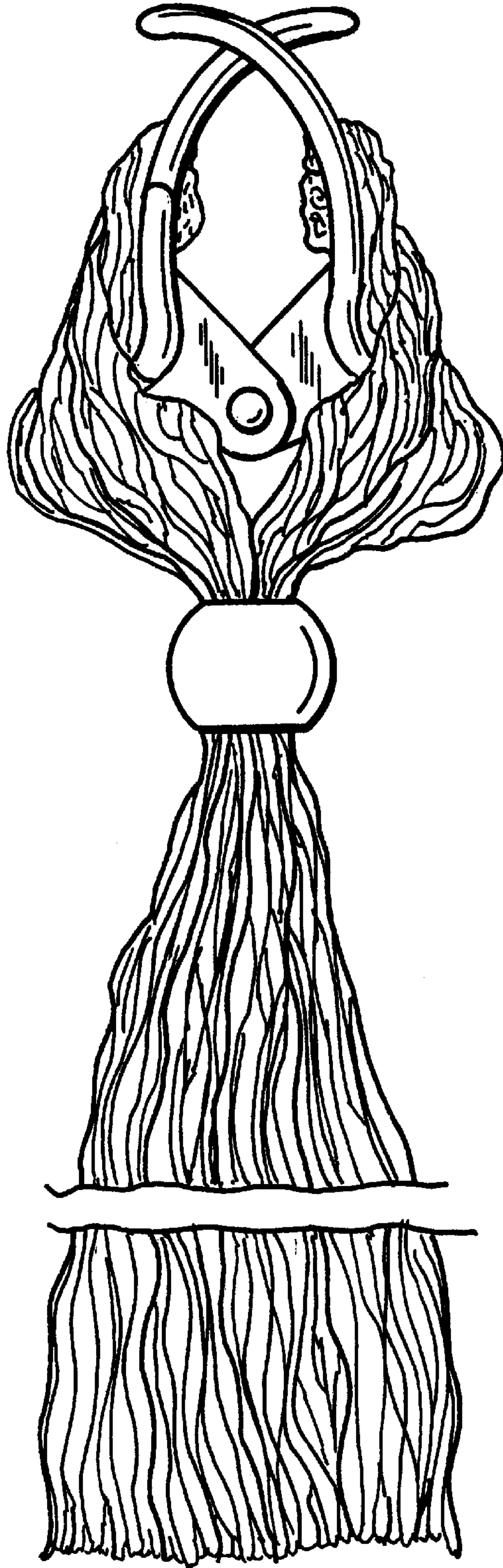

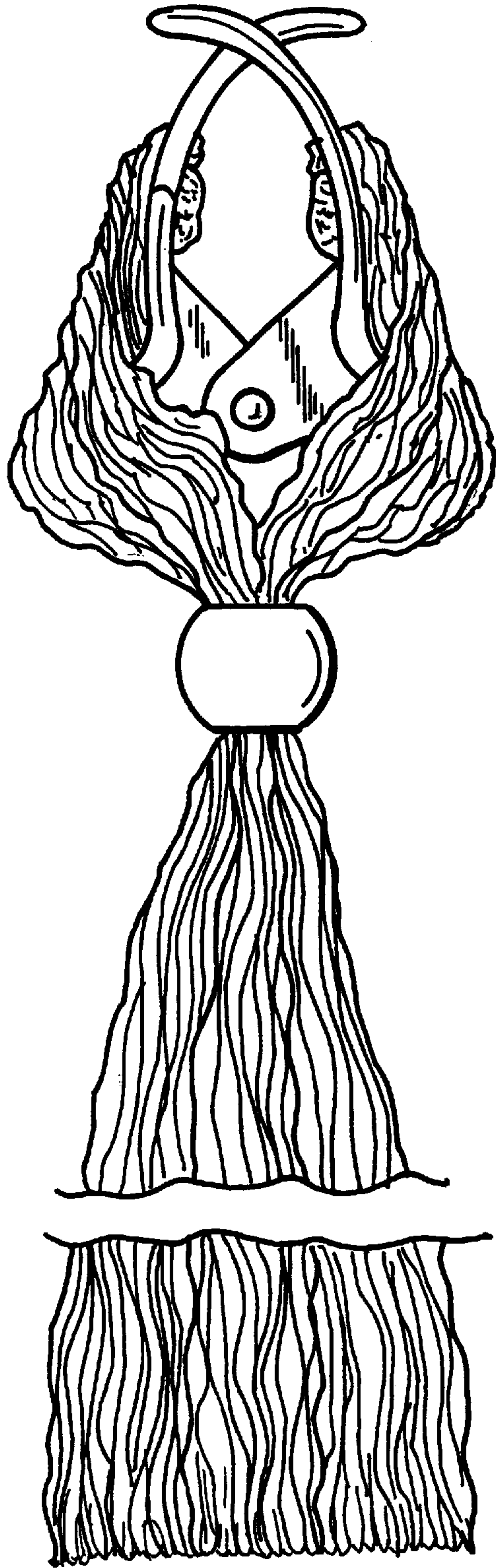

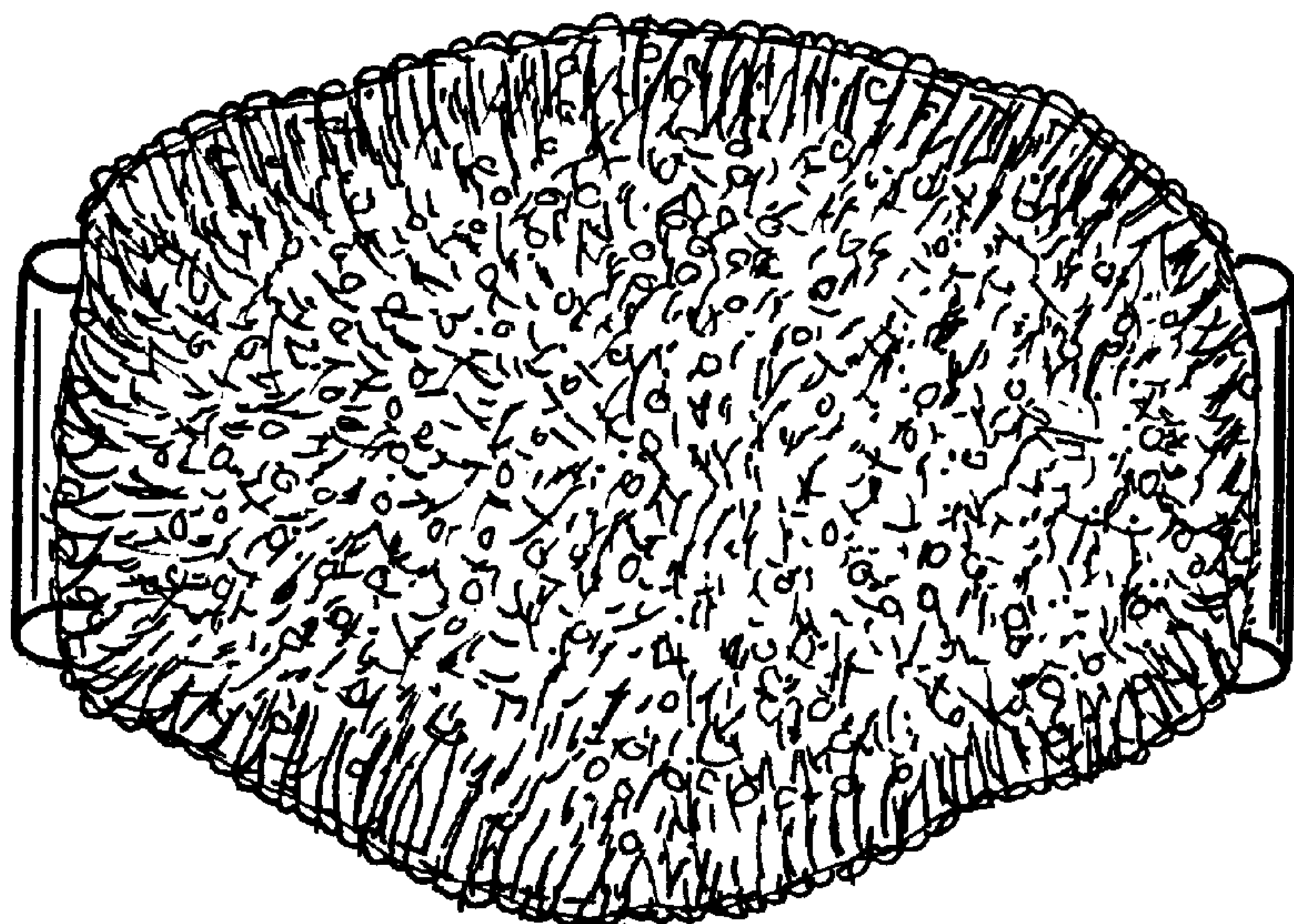
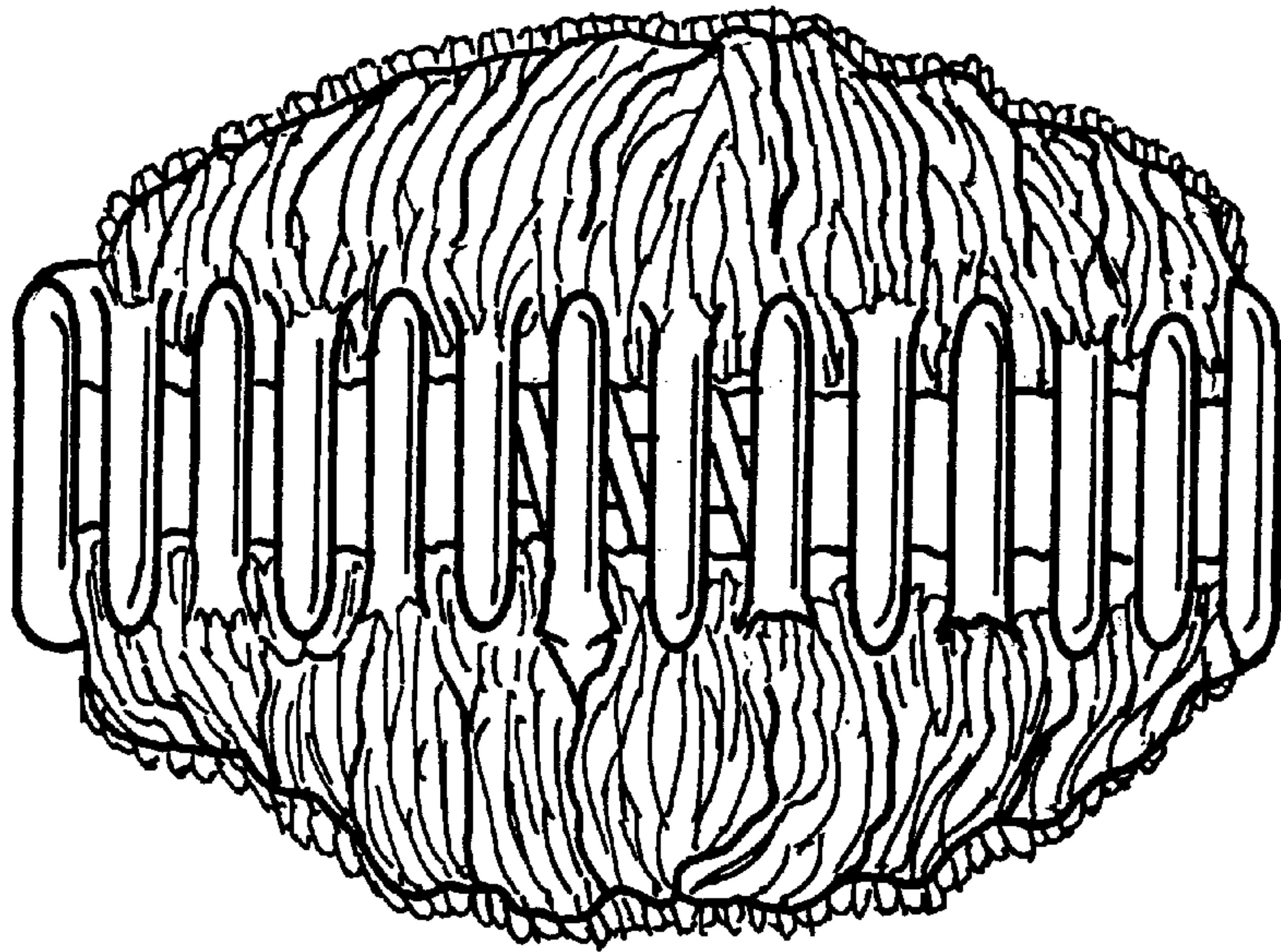
