The ornamental design for combined chair seat/backrest, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined chair seat/backrest showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a left elevational view thereof; the opposite side being a mirror image of the shown.  
 FIG. 5 is a top plan view thereof; and,

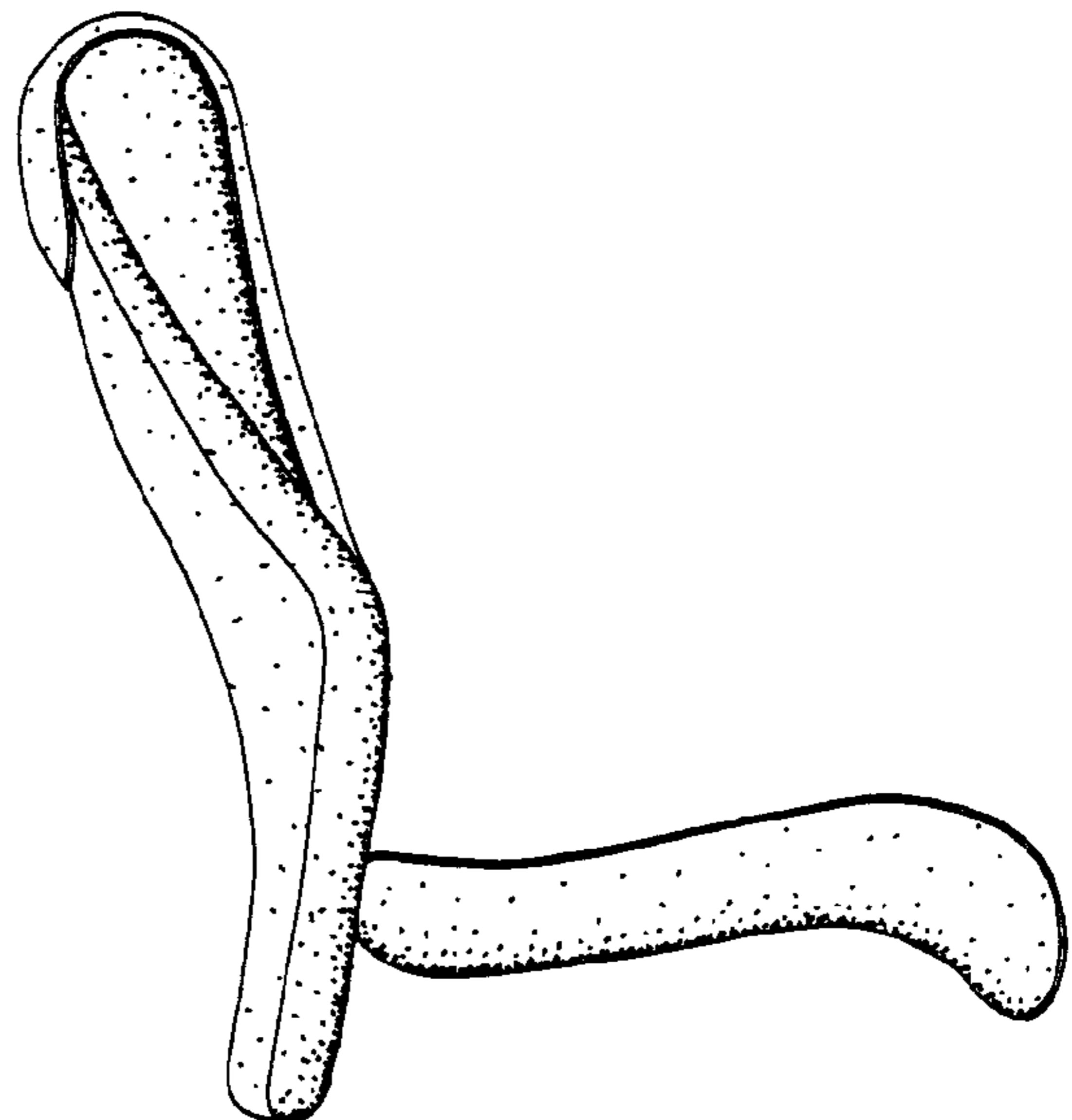
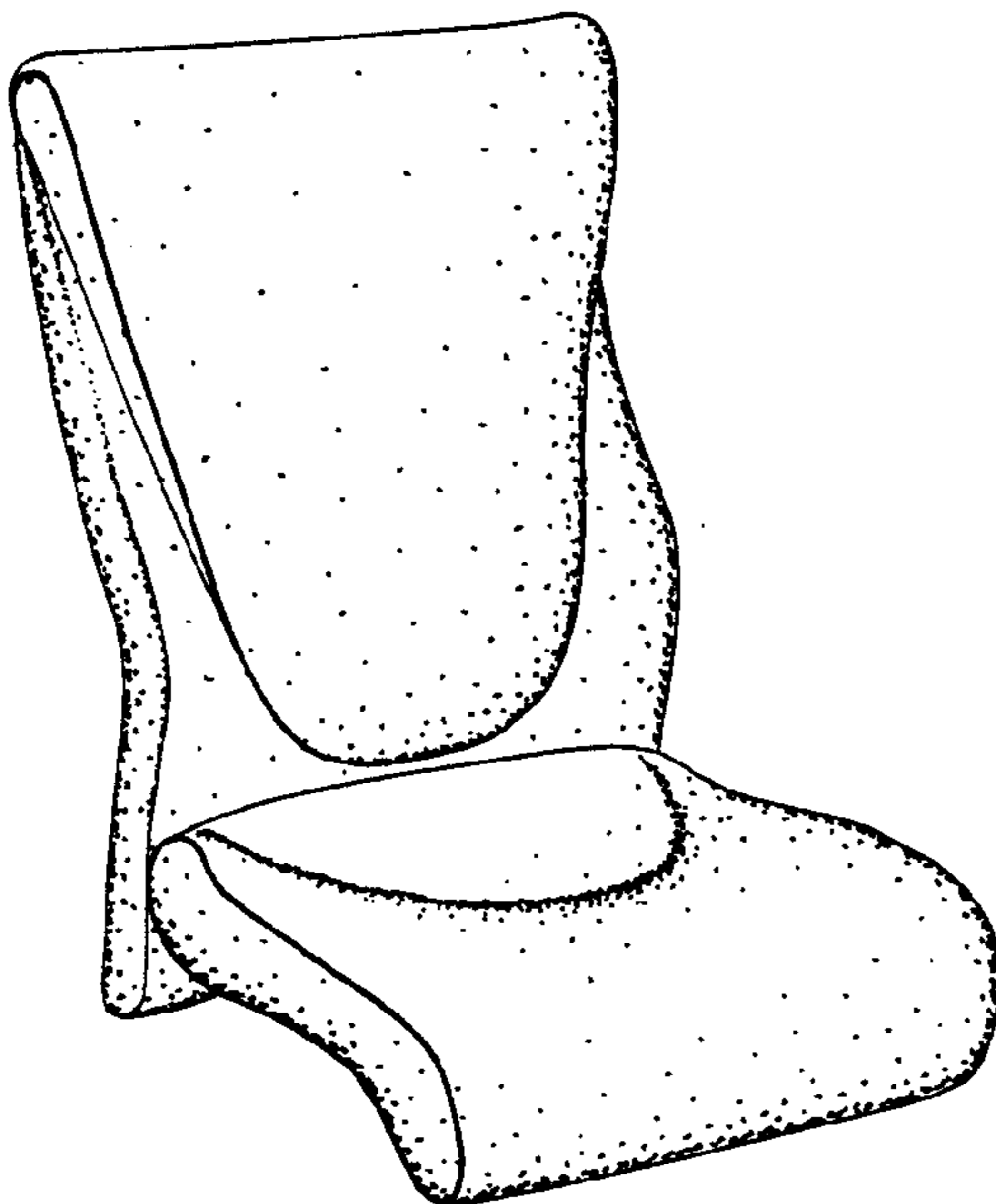

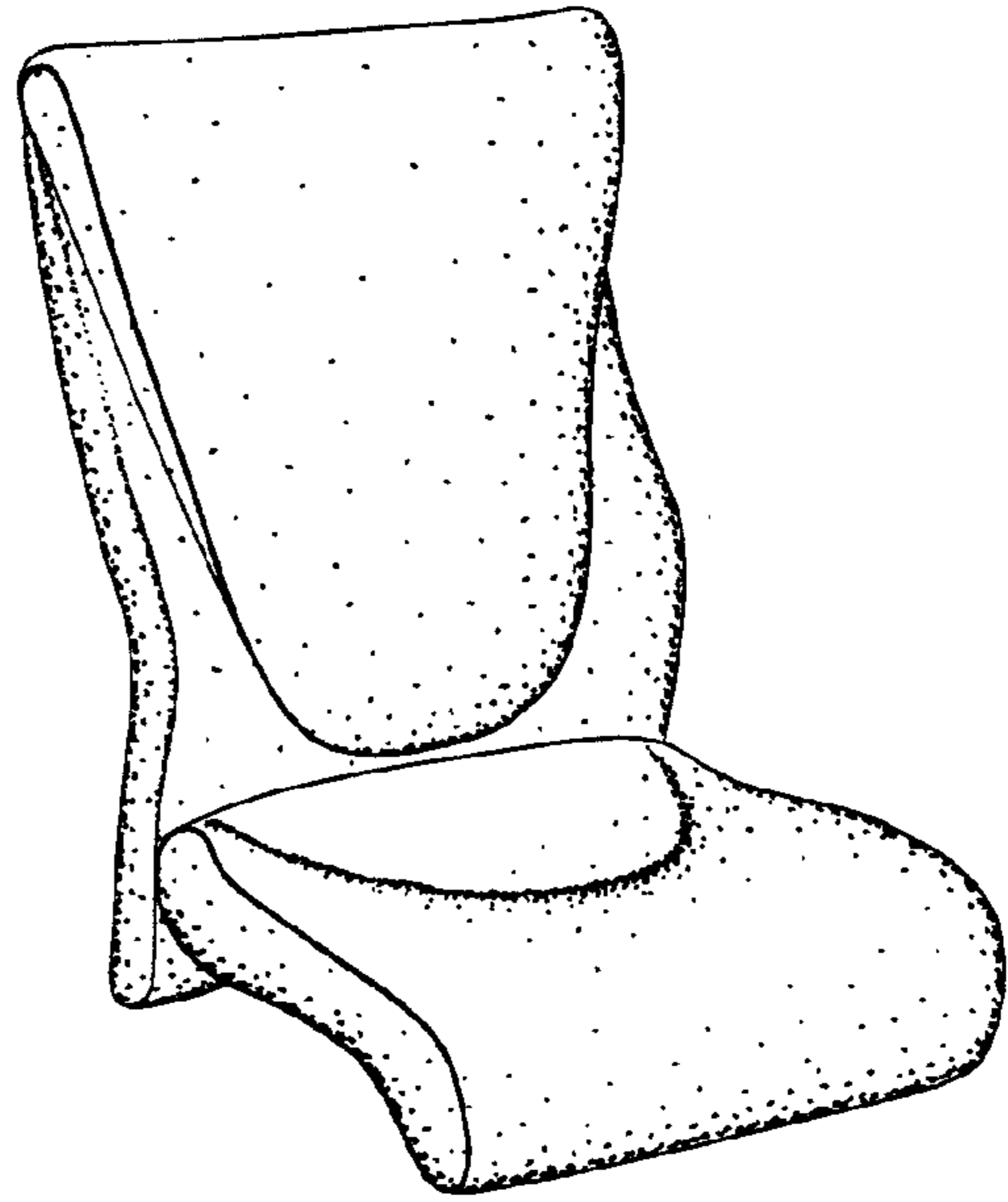

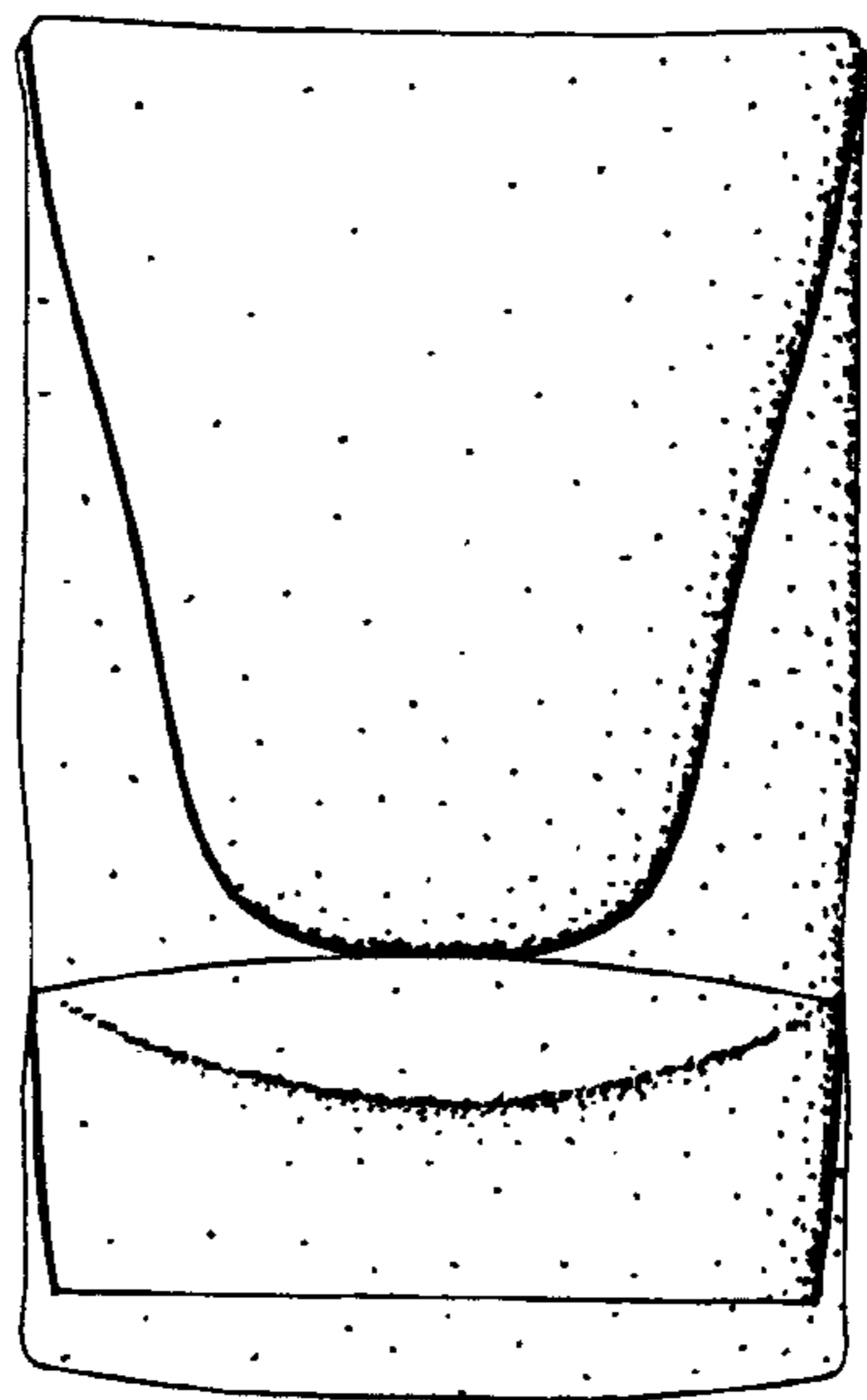

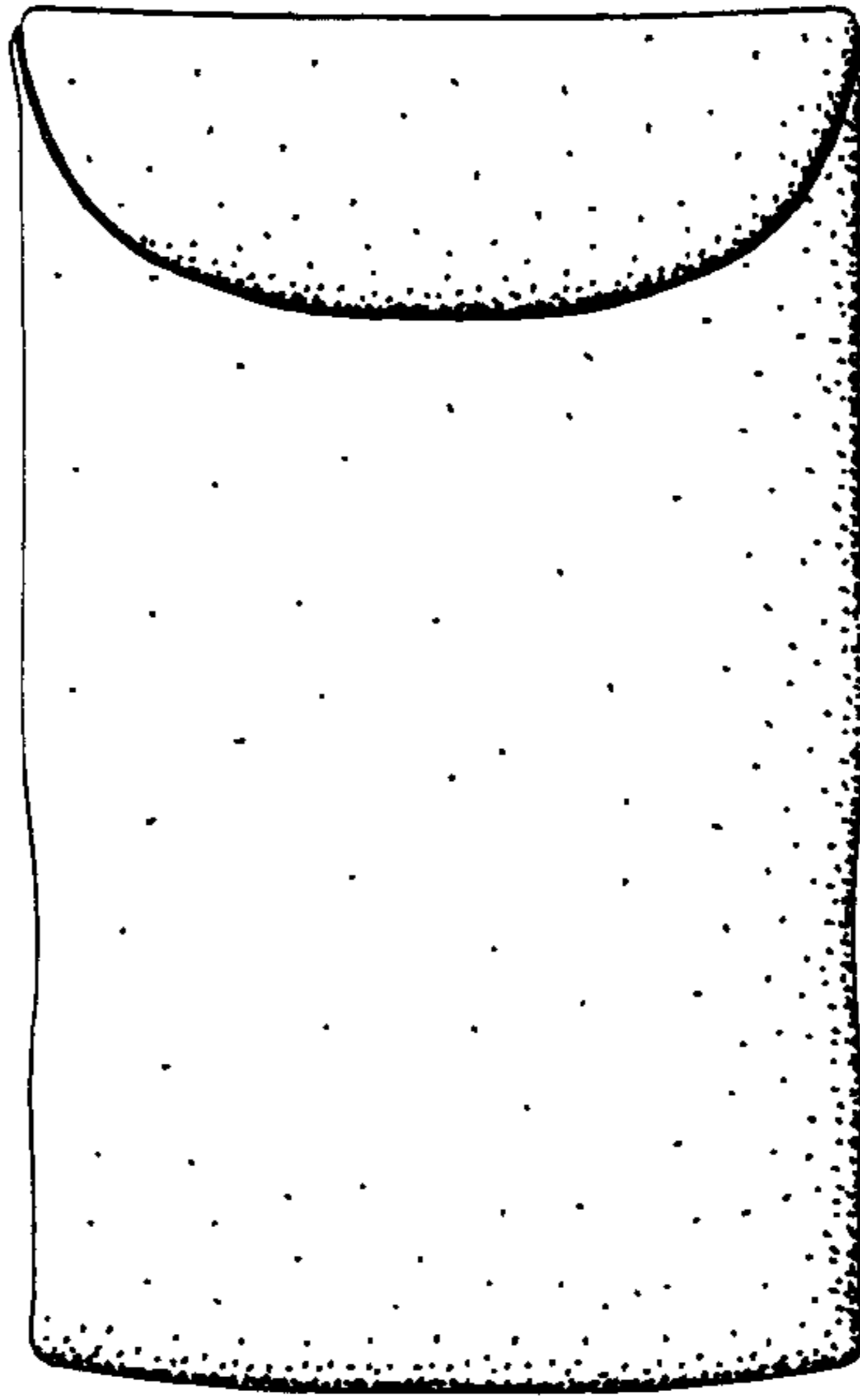

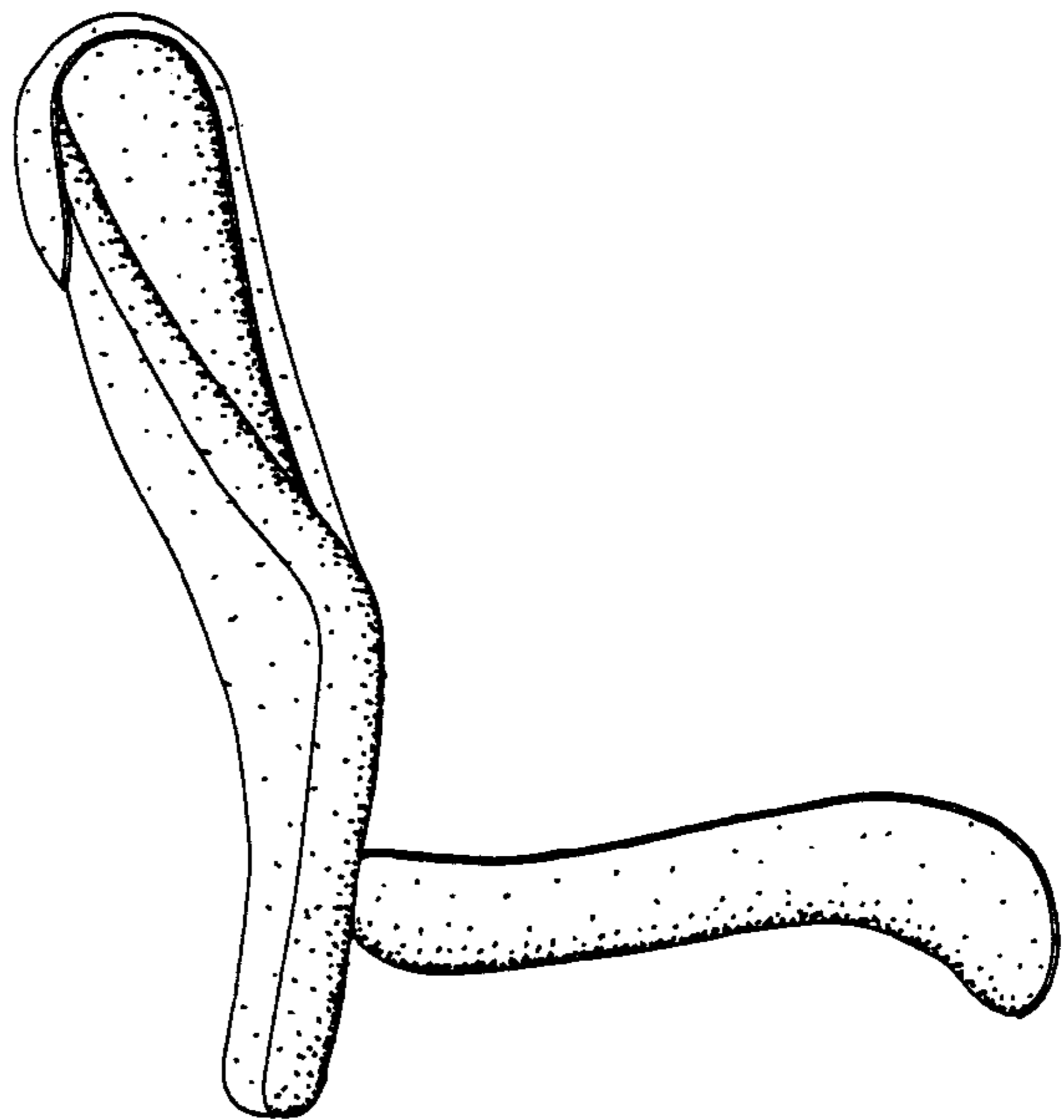

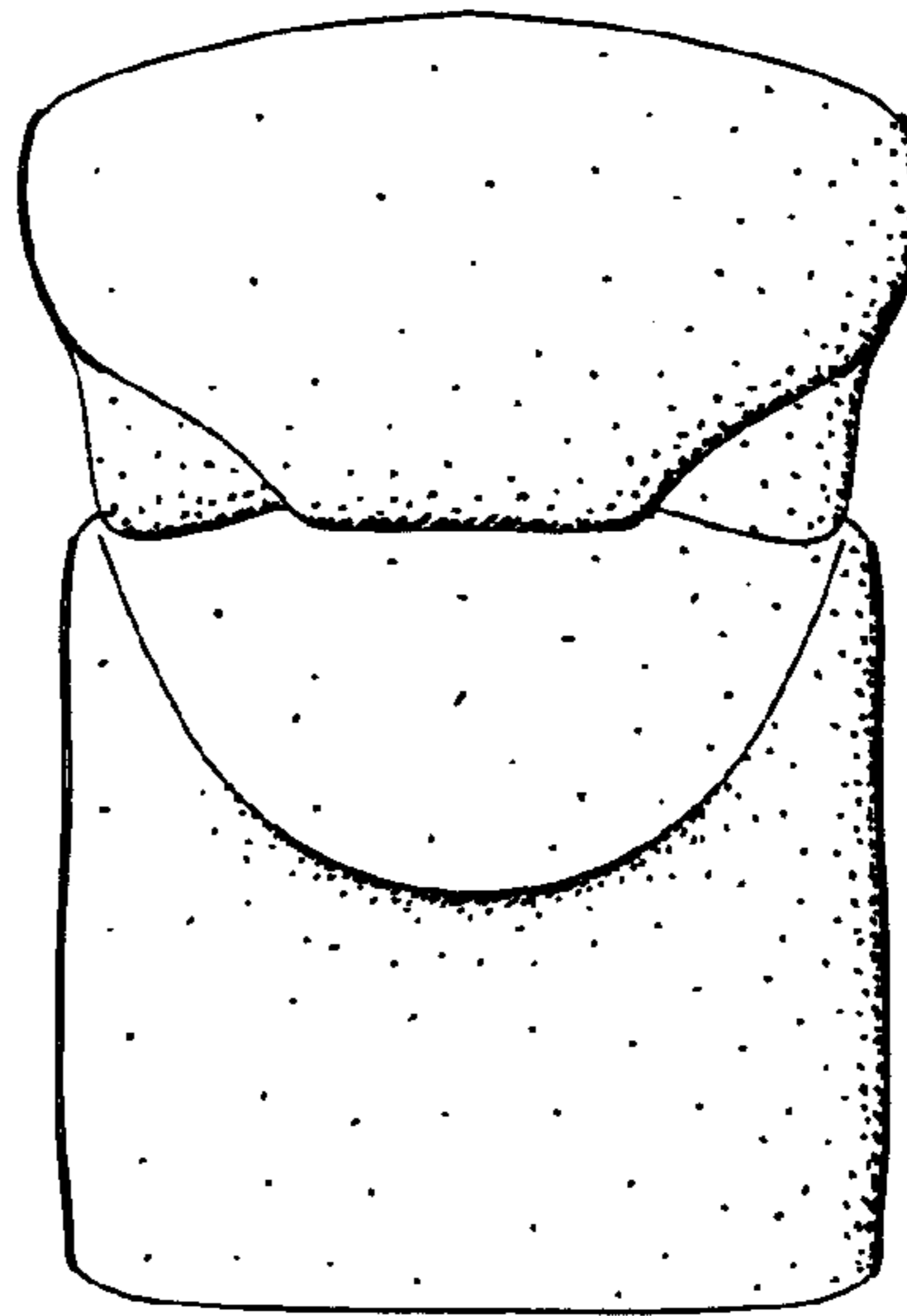
